Traders can run shops in the open

DSCC to make temporary arrangements before Eid

Traders of the burnt-down Bangabazar Shopping Complex will erect makeshift shops on the ground to resume their business ahead of Eid.

The traders want to erect a marquee on the 21,250 square feet ground and set up shops on mats or papers as soon as the city corporation removes the charred remains of the wood-and-corrugated-iron-sheet building that was burnt to the ground on Tuesday.

The shop owners association leaders will meet officials of Dhaka South City Corporation on Sunday to decide how the arrangements can be made, said Jahirul Islam, president of Bangabazar Complex.

Ashikul Islam, another leader, said the traders now want to recover from the losses as much as possible ahead of the holidays and look forward to being rehabilitated.

The shop owners, who have always been averse to the city corporation's plan to make a 10-storey shopping mall in the place, are now more open to the idea, he added.

The association may even withdraw a writ petition it filed with the High Court to halt the city corporation initiative, he said.

But the process has to be fair, he added.

Mohammad Rony, shop owner who suffered a significant loss, said, "Clothes worth Tk 25 lakh were completely burnt. If the government lends a hand, we may be able to start over."

Rakon Uddin, who owned two shops and two warehouses, said, "I have been running the business for 20 years. During Eids, I used to help poor people. But after losing about Tk 30 lakh, I am the one seeking handouts

Meanwhile, Salman F Rahman, the prime minister's private industries and investment adviser, visited the site yesterday and said the place would be cleaned.

"Traders will be able to temporarily open their businesses, following laws and regulations," he said.

He added that the traders listed by the city corporation will be compensated within three to four days.

A DSCC committee making the list with the help of the owners' association was asked to submit its report by

Jail, fine for 'illegal' strike

Says bill placed in JS

A bill was placed in parliament yesterday with a provision of punishment for enforcing "illegal" strikes that affect essential services.

The Essential Services Bill-2023 proposed a maximum one-year jail and a fine of Tk 1 lakh for violation of the law.

Once the bill is passed by the Jatiya Sangsad, the government will be able to declare any service essential for a maximum of six months whenever necessary, according to the proposed law.

After the declaration, enforcement of strike or shutting off and announcement of layoff in that service would be illegal and those would be

Chief Election Commissioner Habibul Awal has said if the major political parties do not participate in the next general election, there will

be no crisis over the election's legality, but legitimacy down to zero".

"Use of EVMs or ballot papers is not a challenge for the election. The biggest challenge is the political crisis. Whether the major parties will take part or not is a big challenge," he said

at his office yesterday.
The BNP and some political parties have announced that they would not join the next parliamentary polls, due by late December, if it is held under the incumbent

Habibul called upon the political parties to resolve the current crisis through discussions.

About the EC's decision to not use electronic voting machines in the next general election, the CEC said it is not possible to ensure 100 percent free and fair elections regardless of the use of EVMs or ballot papers.

"But if the election is conducted using EVMs, it is safer."

He said that the EC decided to use ballot papers in the election and there was no pressure from anyone in this regard.

"It is entirely decision. It has not been done under pressure from anyone. The decision was not taken to make the BNP interested in the election

Adani Power chapter begins in Bangladesh

Bangladesh has started to receive about 750 megawatts of electricity from the Adani power plant in India yesterday, putting to bed the suspense surrounding the start of the cross-border transmission.

Commercial production at the power plant, located in an Indian village about 100km from the Bangladesh border, began after a successful 14-day reliability test that ended yesterday, The Daily Star has learnt from top officials

and natural resources and Adani Group. They spoke on the condition of anonymity.

Reliability test is the continuous uninterrupted operation of the entire facility for 72 hours at maximum load.

The reliability test was conducted in presence of a technical committee of the Bangladesh Power Development Board (PDB).

"They [Adani Power] are eligible to announce the commercial operation date," Power Secretary

of the ministry of power, energy Habibur Rahman told The Daily

However, some procedures need to be completed before an official start date is announced, he added.

Power Grid Company of Bangladesh data showed that Jharkhand's Godda power plant was supplying about 750 megawatts of electricity on average since April 1.

Rana Plaza owner gets HC bail

No bar for his release in murder case

High Court yesterday granted bail Sohel Rana,



owner Rana Plaza, Sohel Rana which collapsed in April 2013, claiming at least 1,136

The bench of Justice Md Akram Hossain Chowdhury and Justice Mohammad Ali passed the bail order in a murder case against Sohel and many other, after a hearing on a rule questioning why he should not be granted bail.

Speaking to The Daily Star, Sohel's lawyer Md Qamrul Islam said there is, as of now, no legal bar to his client's release from jail following the HC order.

"If the government files an appeal with the Supreme Court's Appellate Division challenging the bail order, and if the apex court stays the HC verdict that granted the bail, Sohel cannot walk out from jail."

He added Sohel is not the owner of Rana Plaza. His father Abdul Khaleq, who purchased the land and got the plan for constructing the building from Rajdhani Unnayan Kartripakkha (Rajuk), was the owner.

Students alleged that the government formulated the DSA for giving protection to corrupt people and suppress dissenting voices.

No question of scrapping DSA Says info minister

UNB, Dhaka

Comparing the Digital Security Act with the ones in the US and Australia, Information Minister Hasan Mahmud yesterday said that Bangladesh's DSA is better than that of those countries.

He also ruled out any possibility of scrapping the DSA despite demands from many rights and journalists' groups and civil society.

"There is no question of scrapping the DSA," he said.

The minister came up with the remarks while talking to representatives of Crime Reporters Association in a views-exchange meeting at his ministry in the capital.

He said, "The law ministry is working so that journalists are not subjected to harassment due to the DSA, and our law is easier compared to the US.

Hasan informed that the DSA of the US allows a maximum punishment of 20 years of jail sentence while there is no such long sentence in the DSA in Bangladesh.

Comparing the DSA with the one in the US, the information minister said there is a provision of life imprisonment in the US if someone dies for any digital crime, but the DSA in Bangladesh is easier for similar crimes.

'To provide digital security to people the Act was enacted, and every country has such law. Australia's Cyber Act is rougher," he said.

The information minister said they are more vigilant to protect journalists so that they are not subjected to harassment under the DSA.

He said that media people are now being less harassed compared to the

Replying to a question, he said the journalists will have to work with outside while discharging duties.

Revised budget up 2.5pc amid austerity

The finance ministry has already finalised the revised budget for this fiscal year and the concerned ministries are informed about it but it will not be made public until

But as per section 12 of the Public Money and Budget Management Act 2009, the finance ministry is supposed to place the revised budget before the parliament by March and only after approval would the concerned ministries learn of their new allocations.

The government has not been following this for 13 years now: the revised budget is placed along with the new budget in June and the supplementary budget is passed within a few days.

As in previous years, the finance division informed the revised allocation to the respective ministries in the last week of March, The Daily Star has learnt from officials involved with the proceedings.

When the revised budget was first placed in the parliament as per the law, former lawmaker Suranjit Sengupta opposed it saying it was unconstitutional.

A Cumilla court sentenced five people to death in the 2017 murder case filed over the killing of an expatriate worker.

On August 1, 2017, the body of Akbar Hossain Babul was recovered from a roadside ditch in the Mudafforgonj area of the Cumilla-Noakhali highway.

Sheikh Milton Rahman, the then sub-inspector of Laksham Police Station, filed the case accusing five people as per the victim's wife's statement.

Of them, four confessed in court under Section 164 of the Code of Criminal Procedure.

Macron tells Xi during talks in Beijing

French President Emmanuel Macron yesterday urged Chinese President Xi Jinping to reason with close ally Russia and help end the Ukraine war, while Xi responded by saying he hoped the two sides could hold peace negotiations as soon as possible. In closely-watched talks in Beijing,

which also involve EU chief Ursula von der Leyen, Macron said the West must engage Beijing to help end the crisis and prevent "spiralling" tensions that could split global powers into warring "The Russian aggression in Ukraine

has dealt a blow to (international) stability," Macron told Xi, standing alongside the Chinese president outside the Great Hall of the People at the start of their meeting.

"I know I can count on you to bring back Russia to reason and everyone back to the negotiating table.'

In comments after his meeting with Macron, Xi called for Ukraine and Russia to resume peace talks and find a political solution to the conflict.

France said the discussions between the leaders were "frank and constructive," while China described

them as "friendly" and "in-depth". Macron also asked Xi to press

Dark days ahead for traders of Bangabazar

Business unlikely to bounce back, they fear

Nur Alam, 60, a seasoned trader of Bangabazar, is still traumatised by the fire that took place there 28 years ago, in the same way as the recent one. During that time, it took him only a year to bounce back. However, this time he is doubtful whether that can happen.

"I lost everything in the 1995 fire. But the market came back to business in just two months and I was able to recover from the losses," he said.

Amir Hossen, 65, another trader running his business in the market for years, echoed the same.

On Tuesday, a massive fire razed the Bangabazar clothing market to the ground, gutting thousands of shops and driving the traders towards a financial

Traders say that back in 1995, business was small in scale, so it was easier for the businesspeople to bounce back, but now, the trade in Bangabazar has proliferated to such an extent that they fear it will take a long time to get back to the previous situation.

For example, Zakir Hossain, who started out small but now is a big supplier to Bangabazar, is in significant financial trouble.

Gausia market at risk of catching fire Says fire service

Gausia market in the capital's New Market area is at risk of witnessing a fire incident, said fire service officials after visiting the market for a survey yesterday.

A mock drill in 2020 identified risk factors at the market, and those aspects have been improved only slightly, Md Bazlur Rashid, assistant director of Fire Service and Civil Defence, told reporters on the spot, adding that the present fire-fighting system is not sufficient.

Bazlur also said there is insufficient water in the market's water reservoirs.

"There are extinguishers market but fire-fighting equipment like hydrants, hose reels on every floor, landing valves,

'Pay some, get so much more'

Couple embezzled Tk 39 crore through fraudulent schemes, finds CID

Taking a deposit of Tk 3 lakh, he first gave the depositor an appointment for the post of an assistant teacher in a school with a monthly salary of Tk

After appointing the teachers, he used to seek funds to set up the school.

All these moves were made under the banner of "Rajshahi Digital Business Plus Limited". Formed on July 14, 2010, the institute's target was taking up projects to address basic rights like food, clothing, education, medical care, and employment.

Its founder Md Ahsanul Azim, now 44, established a school in Rajshahi named "Rajshahi Digital Plus Model School" from grade one to six on January 11.

However, the school's operations stopped within a short time.

On September 18, 2012, Ahsanul founded a hospital named "Rajshahi Digital Plus Model Hospital" under a healthcare project in Rajshahi. This hospital, too, stopped its operations after some days.

Ahsanul used to allure people by saying if they invest in education or health projects, they would get back double the benefits after a certain period.

Following the strategy, Ahsanul and his wife Zinnat Fatema, now 38, embezzled around Tk 39 crore from different people through their fraudulent schemes.

The financial crime unit of Criminal Investigation Department (CID) claimed to have found evidence of the couple embezzling a huge sum, after their three-year-long investigation.

A charge sheet was also submitted against the couple to a Rajshahi court yesterday, in a case filed with Rajpara

charges against the couple as they transferred the sum from the said institute's account to other accounts. With the money, they bought properties and shares in the stock market,

Inspector Md Moniruzzaman of CID's financial crime unit confirmed the development to The Daily Star yesterday. "We have confiscated two four-storey buildings and seized 30 bank accounts from the accused," he said.

Although the institute's activities were suspended, investigators found that Ahsanul built a three-storey building in Rajshahi's Bilsimla area on a sevendecimal land with the embezzled money. The couple also bought fourstorey buildings on five acres of land in the same area

He mentioned that Ahsanul is wanted in at least 20 to 25 other cases related to fraudulence. He was arrested earlier in 2020 and was in Rajshahi jail, said

Bogura jail and got bailed out from there, said the official.

As a huge number of people were looking for Ahsanul to get their money back, he went into hiding immediately

The Appellate Division of the Supreme Court yesterday cleared way for the High Court to hear and dispose of nearly 100 pending writ petitions centring the imposition of 15-percent income tax on private universities.

The apex court dismissed five separate review petitions against its observation that earlier said HC will individually hear and dispose of the writ petitions that challenged the decisions of then caretaker government and elected governments regarding collection of income tax from private institutions.

Banana cultivation shows bright prospect

Agriculture in Tangail region has changed a lot in the last three decades.

Once the land of this region was unfit for any cultivation. Back then, it wasn't possible to grow crops due to uneven land surface and lack of irrigation facilities.

In the early 80s, the topography of Tangail's Sakhipur, Ghatail, Basail and Madhupur upazila were almost the same.

But nowadays, a great variety of fruits has reached the region. Alongside pineapple, banana has now become a cash crop for many local farmers.

Different varieties of bananas like Sagar, Chinichampa, Shabri and Bangla Kabri are now being cultivated in different upazilas of the district.

Meanwhile, Kutubpur Banana Bazaar, located in Sakhipur upazila, has become a famous banana market for both the buyers and sellers in the region.

While visiting the banana market, one can see a different kind of busyness around the market area in the morning.

Farmers are seen bringing

bananas on bicycles or rickshaw-vans while rows of bicycles, full of bunches of bananas, are parked at different

One of the banana farmers said it costs Tk 180 to Tk 200 to produce a bunch of bananas. They sell each bunch of bananas to the wholesalers for Tk 400 and make a profit of Tk

It has been calculated that about 500 banana trees can be planted in 35 decimals of land and growers can make a profit up to Tk 1 lakh from those trees.

Although banana cultivation started on a small scale in Tangail, Sakhipur has now become one of the major regions of banana farming due to proper irrigation facilities.

Farmers across the country follow various techniques as they have their own sustainable methods of ripening and marketing this fruit. Banana farmers and traders at

Kutubpur Banana Bazar said they grow bananas keeping people's health in mind. The good news is that many

getting involved in banana farming nowadays. I got the chance to go to Kutubpur Banana Bazar again after a long time.

Farmers said some of them sold the bananas directly from their orchard, while most of them sell their produces at Kutubpur Bazar.

Each bunch contains at least 100 to 120 bananas and local wholesalers pay Tk 400 to Tk 450 for each bunch. On an average each banana costs

Tk 3.5 to Tk 4, but the retail price of each banana is not less than Tk 8 to Banana farmers in Tangail region

Pak parliament rejects SC order

Pakistan's parliament yesterday rejected a Supreme Court order to conduct provincial snap polls, in the latest move in a power struggle between the government and the top court amid political and economic

The top court had on Tuesday ruled illegal the government's move to delay the snap polls in two provinces where former prime minister Imran Khan had dissolved his local governments earlier this year.

The Speaker, in a live broadcast, said a motion was adopted by a majority of lawmakers to reject the court decision by a three-member panel headed by the chief justice and to demand a full court panel consisting of all judges hear the case.

The court's Tuesday order said elections in two provinces should go ahead despite government reluctance to hold the votes now as it struggles with an economic crisis and a political challenge from the opposition.

It gave a date of May 14 for voting in Punjab province, and a pending date for voting in Khyber Pakkhtunkhawa province due to some technical issues.

Israel intercepts rocket fired from Lebanon Retaliates with strikes

The Israeli army said it intercepted rocket fire from Lebanon yesterday, a day after clashes between Israeli police and Palestinians inside Islam's third-holiest site drew warnings of retaliation from around the region.

"A rocket was fired from Lebanon into Israeli territory and was successfully intercepted," an army statement said as Israeli media reported a "salvo" of projectiles had been fired.

There was no immediate claim of responsibility for the attack, which came amid heightened tensions after Israeli police clashed with Palestinians inside Jerusalem's Al-Aqsa mosque before dawn Wednesday and again in the evening.

In response to the rocket fire, Israel struck targets in southern Lebanon, said Lebanon's National News Agency without reporting any casualties. According to the report, Israeli artillery fired "several shells from its positions on the border" towards the outskirts of two villages.

Israeli PM Benjamin Netanyahu was "receiving continuous updates about the security situation and will conduct an assessment with the heads of the security establishment," his office said.

China deploys warships near Taiwan

AFP, Taipei

China deployed warships through waters around Taiwan yesterday as it vowed a "firm and forceful" response to the island's president meeting US House Speaker Kevin McCarthy.

Taiwan leader Tsai Ing-wen held talks with McCarthy in Los Angeles on Wednesday, expressing gratitude afterwards for the meeting that included other US lawmakers.

"Their presence and unwavering support reassure the people of Taiwan that we are not isolated and we are not alone," Tsai told reporters.

China had repeatedly warned both sides the meeting should not take place, and deployed an aircraft carrier through waters southeast of Taiwan hours before

Three additional warships were the island. detected in waters separating the island from mainland China, Taiwan's Ministry of National Defence said yesterday

An anti-submarine helicopter had also crossed the island's air defence identification zone, according to the

And China deployed coastguard vessels for unusual patrols that sparked a protest from Taiwan.

Despite Taiwan having been ruled separately for more than 70 years, China views it as part of its territory and has vowed to one day seize it, by force if

China carried out its largest-ever air and sea exercises around Taiwan following a visit in August last year by McCarthy's predecessor, Nancy Pelosi, to

China then deployed warships, missiles and fighter jets into the waters and skies around Taiwan.

Its response to the McCarthy meeting has so far been on a much lower level, but still left Taiwan on high alert.

Taiwan's defence minister described the timing of the deployment of the Shandong, one of just two Chinese aircraft carriers, as "sensitive".

"When an aircraft carrier comes out, there are usually takeoffs and landings for aircraft but we have not found any takeoff or landing. We will keep watching," Chiu Kuo-cheng told reporters.

When asked if Shandong's deployment was a prelude to Chinese military exercises, Chiu said: "We are not ruling

India, China spar over visas for their journalists

India and China broke into fresh diplomatic sparring yesterday, accusing each other of creating visa hassles for their journalists posted in New Delhi and Beijing. The exchange came days after India objected to China renaming or "standardizing" names of 11 locations in the eastern state of Arunchal Pradesh, which China calls southern Tibet and claims as its territory. Indian newspapers reported this week that two Indian journalists posted in Beijing were barred from returning to their jobs in the Chinese capital from India. Correspondents for The Hindu newspaper and state broadcaster Prasar Bharati were told on Tuesday that their visas have been frozen, an Indian source familiar with the issue told Reuters. Asked about the visa suspensions, Chinese foreign ministry spokeswoman Mao Ning said yesterday that Chinese journalists have received unfair and discriminatory treatment in India for a long time, and a Xinhua journalist was recently asked to leave India by March 31. "China has always treated Indian journalists well," Mao said. Chinese authorities have been in touch with the Indian government, which did not respond "nor correct the mistake", she said.

DENGUE, CHIKUNGUNYA Climate change spurring surge

The World Health Organization warned Wednesday that dengue and other diseases caused by mosquito-borne arboviruses were spreading far faster and further amid climate change, warning global outbreaks could be looming. Experts with the United Nations health agency sounded the alarm over swelling numbers of cases of dengue and chikungunya, and warned new epidemics of zika could also be expected. All three are caused by arboviruses carried by Aedes aegypti mosquitos, which have been spreading into new territory as the planet warms. "Climate change has played a key role in facilitating the spread of the vector mosquitoes," said Raman Velayudhan, who coordinates WHO's dengue and arbovirus

Drastic action a must to reduce fire risks

Bangabazar fire a reminder that many markets and buildings remain at risk

Tuesday's devastating fire at Bangabazar was not the first such incident recorded there, nor was it the only one of this scale. But it serves as a reminder – if new reminders were at all needed - that safety risks are built into the very model of urbanisation followed by Bangladesh, where building codes and fire safety regulations are seldom enforced. For example, before the Bangabazar market fire, which gutted nearly 3,000 shops full of clothes, building authorities were sent notices on 10 occasions over the last four years. The fire safety department also put up a banner there with warnings of fire risks. But business interests triumphed over safety requirements, to disturbing consequences.

In 2019, the fire service department carried out a survey on 3,786 institutions and establishments across the country, and found that 541 shopping complexes and markets were at high risk. Bangabazar was one of them. It is not just markets and commercial establishments, but a large number of residential buildings in major cities are also believed to be at high risk of accidents because of their lack of structural and electrical safety – either they were not constructed following buildings code, or are poorly maintained, or have no fire safety system in place. The possibility of building fires or collapses literally lurks at every corner, as some of the recent incidents have shown.

The Bangabazar incident serves up several other lessons as well. For example, the risk of dilapidated buildings. Reportedly, a six-year-old city corporation initiative to build a 10-storey shopping mall at Bangabazar never saw the light of day because of disagreements over rehabilitation of traders for the duration of the construction work. The Dhaka South City Corporation had apparently finalised the design and even hired a contractor. But construction couldn't begin because of a stay order from the High Court. Had this issue been resolved and traders been rehabilitated to make way for the new building, Tuesday's tragedy could have been certainly averted.

Another issue brought forth by the Bangabazar fire is the declining number of ponds and wetlands in major cities, especially in Dhaka. While urban water bodies are filled to construct buildings and marketplaces, their absence is most acutely felt when there is a fire in one of those buildings and there is no water nearby to douse it, as it happened in case of Bangabazar. The irony of the situation is inescapable. Ponds not only play a vital role in dousing flames but also create a healthy atmosphere and ease waterlogging. Unfortunately, there are few ponds left in central Dhaka, which is an issue that will continue to put us in trouble if not addressed urgently.

Having witnessed the consequence of inaction or delaying action in case of fire safety, we really have no alternative but to act immediately. We urge the authorities to prepare a comprehensive work plan to address the safety of buildings and markets identified as risky by Rajuk and the fire department. They must try to find a way to overcome legal and logistical issues that are working as impediments. The safety of citizens must be prioritised.

Ensure road safety before Eid holiday

Govt must fully implement road safety act, prevent crashes and deaths

When it comes to the frequency of road crashes in Bangladesh, things only seem to be going downhill. Last month, according to a just released estimate by Road Safety Foundation (RSF), 564 people died in 486 road crashes. This is quite similar to what the situation was a year ago, when the RSF reported the deaths of 589 people in 458 crashes, meaning that there has been no progress during this time. And if we take into account the 2022 casualties – 7,713 deaths in total – we can see that an average of 21 people die on our roads every day. Many of these victims are children and young people, whose lives have been rudely cut short because of the prevalence of unfit vehicles and reckless drivers.

In this column, we have repeatedly highlighted the sad plight of our roads and the endless suffering of travellers. Yet, there has been little action, beyond the occasional lip service and cosmetic changes, to reverse this scenario. This is most clearly illustrated by the total lack of effect of the Road Transport Act 2018, which even after over four years remains trapped in a legal quagmire. The question is, why is the government doing nothing to fully implement it? Why are frequent interruptions being allowed to get in the way of its being effective? Why are the demands of transport leaders (for less strict regulations and reduced penalties) being entertained? While this is happening, unfit vehicles and unlicensed drivers continue to create a havoc on our roads.

This is certainly not the kind of situation we want to see going into another Eid holiday in about two weeks. Historically, this has been the time of the year when, with many thousands of people travelling across the country, most road crashes occur, and consequently most deaths. According to RSF data, last year, highway travels during the extended Eid-ul-Fitr holiday between April 25 and May 8 resulted in the deaths of 376, with about 1,500 people injured, which is really shocking. Given that motorcycle accidents made up 41.48 percent of the total fatalities in 2022, this should be an area for the government to work on with priority ahead of the upcoming Eid journey. We don't want to see a repeat of what happened during past Eid holidays. Any tragedy is certainly avoidable if the authorities are sincere and proactive in preventing it.

To that end, we urge the government to fully implement the Road Transport Act. They must ensure that the rules are properly enforced, and that those found in breach of them are held accountable as per the law. The failure of the relevant authorities, including Bangladesh Road Transport Authority (BRTA) or the ministry governing it, has already set us back as a country, dealing a huge blow to thousands of families. This must stop.

On an average, the legacy media – others may do less - publishes nearly 250-300 reports every 24 hours. If we include photographs, cartoons (political types are conspicuously absent these days, leading to the question as to why), infographics, photo captions, etc, the number reaches nearly 350. If we add multimedia content to that, we climb to an even higher figure. To tackle such a huge number of items – from gathering facts, writing, editing, to page setting, inserting photos, caption writing, audio recording, filming – is a Himalayan task, to say the least. It is to the enormous credit of our journalist colleagues that mistakes occur only very rarely. If "to err is human," then mistakes will occur however hard we try. And hence, we must address it urgently.

There are, however, tried and tested and universally accepted laid down rules to handle mistakes made by media outlets. These have come after

followed while castigating Prothom Alo? Would we be wrong to further conclude that it was not *Prothom Alo* that had an agenda, but others - and the agenda was to intimidate an independent voice and force it towards greater self-censorship?

The case in hand is as follows. The editor of Prothom Alo was sued under the anti-media Digital Security Act (DSA). The newspaper's Savar correspondent was literally kidnapped when, at dawn, law enforcement members mostly in plain clothes descended in a gang-like fashion on his house. They picked him up without a warrant, did not tell the victim or his family why he was being taken in, and where he was being taken to. He was kept incommunicado for the next 30 hours. He was then produced before a court and sent to jail.

The question before the journalists should have been: what was his crime? Misreporting? Which part of his report was false? The whole controversy centred around the use of a photo of a their longstanding "agenda," which is to destabilise our "independence and make controversial role on issues relating our Liberation War questionable." A quote from one day-labourer juxtaposed on a photo of a child can do all that? Are the claims based on facts or any content analysis of the paper? Where is this coming from? If the accusers are correct, then we must be reading different newspapers. According to Prothom Alo critics, after 50 years of establishment of our state, our Liberation War and our independence remain so fragile, so weak, so full of doubt that one report sets these foundational pillars tottering? Are they not making a mockery of everything we stand for? This is when we are about to graduate into the Developing Country status. Who is damaging Bangladesh's

reputation? On the other side, what is the longterm track record of *Prothom Alo?* Ever since its inception, it has been a staunch supporter of everything Bangladesh stands for – our Language Movement, the movements of the 50s, 60s and 70s, our Liberation War, Bangabandhu's seminal role, secularism, democracy, political, economic and cultural rights of the people, etc. Its role against extremism is second to none. It celebrates our economic growth and every other success far more enthusiastically than many of its critics.

The government, the ruling party, and those who have issued the recent

All the talk of Prothom Alo's so-called to our Liberation War, independence struggle and Bangladesh's economic success has no basis in facts. Whatever critical reporting the paper did and does fall within its moral and professional role of keeping power accountable. It is not for nothing that Prothom Alo has gained such public acceptance and adulation both at home and among Bangladeshis abroad.

As the heading of my piece states, only we journalists can protect our profession. Everybody else, in the name of helping journalism, wants to use us. When the government extends a helping hand, it wants journalists to toe its line. When the business community offers help, the price is to overlook their bending of the law. When law enforcers act friendly, they want us to soften our reports on their circumvention of the rules. When politicians praise us, it is only because they are not, at that moment, on the buttered side of the bread and are certain to sing the opposite tune once in power. And the story goes on. Nobody wants us to be independent, to be objective and say the truth. And that's where our challenge lies. And that's why we must be together in spite of our differences.

That does not mean we will not differ. sometimes even vigorously so on social, cultural and, most importantly, political

many trials and errors and on the basis of decades of experience from across the world. Do we follow them? If not, should we not? And shouldn't we, the journalists, be at the forefront to demand adherence to said rules? Are we doing so? Or are we busy demonising our fellow journalists for mistakes that are easily explainable journalistically?

That should lead the journalists to this question: what triggered such frenzied activism among some of us to denigrate our most prestigious Bangla daily? Was the coverage of the "mistake" of *Prothom Alo* done journalistically? Was the search for Prothom Alo's socalled "motives" factually founded? Why did "opinions" start to be treated like "facts"? Why was a newspaper not judged by its long track record, but only by one or two mistakes, which were then interpreted according to the views of the critics without reference to facts? Would it be totally illogical on our part to conclude that no journalistic norms were

statements have forgotten the role Prothom Alo played during BNP's rule in highlighting corruption and exposing the excesses committed by Tareque Zia and Hawa Bhaban. issues. As journalists, we may hold diametrically opposite political views, but we can never allow those differences to affect our journalism. As Daniel Patrick Moynihan, a US senator from New York, once said, "You are entitled to your opinion, but you are not entitled to your own facts.'

Iam in my twilight years of journalism. Perhaps only a few years of it are still left. I started with The Bangladesh Observer in April 1972, immediately on return from the most glorious phase of my life when, with millions of others, it was my proud privilege to be a member of the Mukti Bahini. After co-founding it, I have spent the last 32 years with The Daily Star. So I can claim to have a modicum of experience as a journalist.

Since my time is limited, it is my younger colleagues who will face the future, and it is to them I have addressed this piece. I unreservedly and unequivocally say that journalism is one of the noblest of professions there is. Like education, a society needs journalism to grow intellectually, democratically, equitably, and justly. 
The answer to it will determine the future of our journalism. Please remember: only journalists can protect journalism.

Let's fix primary healthcare first

Day, "Health for All," aligns with the World Health Organization's (WHO) overarching mission and holds particular significance for countries like Bangladesh which are striving towards achieving the Sustainable Development Goals (SDGs), including the crucial goal of ensuring health and well-being for all by 2030.

Bangladesh has made remarkable strides in improving the health and well-being of its citizens, with life expectancy increasing from 52 years in 1971 to 72 years at present. One key contributor to this achievement has been the growth of the healthcare services sector, which now operates on a three-tiered system.

(PHC) is provided at the grassroots level, through the upazila health complex (UHC), union health and family welfare centre (UHFWC), and community clinic, located at subdistrict, union, and village levels,

service provision, secondary- and tertiary-level facilities are major providers, despite only comprising 20 percent of the country's healthcare infrastructure. They even offer basic services that could effectively be provided at the PHC facilities. Consequently, people tend to rely on urban healthcare services, resulting in overcrowding, long wait times, and increased healthcare costs for

healthcare due to transportation challenges and associated costs. on secondary- and tertiary-level

This year's theme for World Health facilities often hinders access to specialised care for those in need.

> To address this issue, Bangladesh must prioritise the development of PHC facilities to ensure that the majority of healthcare services are available there, and people only need to move to secondary- or tertiary-level facilities, as well as the urban areas, for specialised care only. Achieving this goal will require addressing structural challenges and changing the current

The first improvement should address the challenges in PHC facilities that hinder access to services from the UHC, UHFWC, and community clinics. Insufficient funding is a major issue leading to a At the top level of this system, shortage of essential medicines and specialised care is available in large diagnostic tools. PHC facilities also urban centres. At the secondary level, suffer from insufficient infrastructure, district-level care is provided mainly including a lack of reliable electricity in cities, while primary healthcare supply and inadequate space to provide services to patients. Staff shortages are also common at these facilities, with only 43 percent having adequate staffing. These existing challenges are often accompanied by the availability of infrastructure that is not aligned with the field-level But when it comes to healthcare needs, or healthcare facilities are unable to use them due to a lack of other necessary infrastructure and/or skilled manpower.

These challenges faced by PHC facilities often lead to healthcare personnel opting to work in urban healthcare centres. Added to that is the lack of interest among healthcare personnel in working at these facilities, which are located in rural areas, due to the lack of basic amenities such as electricity, safe Those living in the rural areas face water, and accessible transportation, respond accordingly to ensure that even greater difficulties accessing which can make living and working conditions challenging. Lack of career growth opportunities in upazila Furthermore, the increased pressure and rural areas, as well as concerns this priority is mostly absent at policy about personal safety and security,


also contribute to the reluctance of healthcare professionals to work there. As a result, these facilities often face understaffing issues, although the government has taken strong initiatives to ensure the presence of healthcare personnel by providing permanent postings for two years to every newly recruited healthcare personnel.

Along with these structural challenges, the focus on PHC facilities is also problematic, contributing to a major population movement to urban areas to access services. The current focus of these institutions is to provide curative maternal, child, and neonatal healthcare, as it was before the 2000s. However, this focus is less relevant nowadays as Bangladesh has achieved significant progress in improving maternal and child health, particularly during the Millennium Development Goals (MDGs) period from 2000 to 2015 (although it is still nportant).

On the other hand, we are now facing a rapid increase in noncommunicable diseases. According to the most recent estimates, around one in every 10 people in Bangladesh is diabetic, and around one in three is hypertensive. Most importantly, around half of them are undiagnosed, and they are usually diagnosed at a very later stage when healthcare professionals have limited treatment options. The prevalence of these diseases is rising rapidly in both rural and urban areas, and among people of all age groups. These noncurable conditions require longterm care, which most people do not have, making preventive care (which should be ensured through PHC facilities as they are located close to homes) crucial in addressing these challenges. But this is not evident in the services provided by primary healthcare facilities, though the country officially acknowledged its importance in the 1990s.

After 52 years of independence, the country's health profile has changed significantly. The government needs to understand this change and health services are available as per citizens' current needs, rather than following a usual trend. Unfortunately, and programme levels.

ChatGPT and Writing: A Deadly Combination!



Someone of Indian origin emailed me in 2014 with some queries from Saudi Arabia, where he was a PhD candidate at a university in Christchurch, New Zealand. He was interested in a PhD programme at the same university and needed further information. I sent him a detailed response, addressing all his queries to the best of my knowledge. I bumped into someone several months later in the corridor of our college compound. He said that he was the one who emailed me from Saudi Arabia. He thanked me for the detailed response and said, "I've not met a non-native speaker yet writing so well in English." Flattered, I said smugly, "I'm a composition professional." He burst my bubble immediately, "Why do you need to learn to write? Machines will do that soon." I laughed it out. Writing is inherently a human attribute. Machines can't write.

Neither can ChatGPT (Generative Pre-Trained Transformers). While grammar is a non-negotiable requirement, a piece of writing is not a syntactic structure. It's, instead, a semantic sculpture. There's always something elegantly unusual with an authentic piece of writing. Language and grammar are the two pieces of the big puzzle that writing is. Writing is the generation of thoughts - filtered through vision, imagination, and intuition - that touch and transform. Writing that endures doesn't replicate any model of thought and language. It renews language to create a new model of thought. Since the last week of November this past year, when OpenAI launched ChatGPT, writing seemed re-defined. Flaccid prose that is clinically precise is being passed off as writing. And writing ability is attributed to machines without cognition and sensation. That's an egregious error as to what it takes to accomplish a piece of writing. There's nothing magical or mysterious about writing.

sentence is an experiential entity given its Latin root, sententia, which means sentimental thinking. teaching at a university. I was then The generation of a sentence presupposes an understanding of and engagement with the physical world. Plonking down words in a formulaic fashion severely falls short of the definition of a sentence, because one must understand the meaning behind those words. ChatGPT doesn't. It generates words based on a given input. Besides, Joe Moran claims in First You Write a Sentence that a sentence is more than its meaning. It's also a metrical structure, where logic and lyric as well as sense and sound meet. A sentence is music created by thyme, rhythm, and pausing. That music is heard only in the head, though. ChatGPT is a language model that has nothing to do with sound (and image). As such, what ChatGPT regurgitates is not writing per se. It's just a tantalising transcription.


So, it snares. As they claim, ChatGPT is a deep-learning tool. Essentially, though, it's a toy for deep-faking, for Ian Bogost argues in his article, "ChatGPT Is Dumber Than You Think," in The Atlantic, that it's less about persuasive writing and more about superb bullshitting. It's logically dysfunctional and is terrible at maths. It cites false quotations and references. It's a halfbaked app. Fixing it to the precision seems apparently unlikely, because the software is already a juggernaut. Even its creators don't know how it works and why. That's what Ian Bogost and Steven Pinker believe. ChatGPT, then, is a carefully crafted confusion. DeepMind CEO and cofounder Demis Hassabis, one of the pioneers of artificial intelligence, urges caution against artificial intelligence in his interview with Time this past January. He warns, "We are the guinea pigs." We're both addicted to and imprisoned by technology. Crises mount.

Compromising with the skill and quality of writing is indeed

Anderson argues that good prose has never been in infinite supply in that good prose is one of the most challenging things to produce in the known universe. For the large language model that ChatGPT is, the generation of quality prose is contingent upon ingesting quality prose, which are books written by better writers. Anderson cites the finding of a research team led by Pablo Villalobos at Epoch AI that claims that ChatGPT will run out of reading quality material by 2027. Since the emergence of the printing press in the 15th century, humans have published approximately 125 million titles, as the researchers at Google Books find. The Epoch team estimates that approximately 10 million to 30 million of these books are digitalised to be machinereadable. When AI has read all the books ever produced - and our reliance on and obsession with ChatGPT becomes a routine - it can't ingest quality prose anymore. As such, ChatGPT will recycle the same patterns of prose created by itself. We're off to a prose wasteland. That sounds dystopic, but that's apparently likely.

Noam Chomsky, Ian Roberts, and Jeffrey Watumull, in their recent pitch in The New York Times, disqualify ChatGPT as an authentic tool for generating quality prose as such. They claim that the crux of machine learning is description and prediction. The mark of true intelligence, however, is an explanation. Intelligence also consists of creative conjectures, creative criticism, and moral thinking. Any A1-powered system critically lacks these attributes. Language - and the ability to use language in a creative and ethical fashion – is genetically endowed. Because machines can't understand and utilise the sophisticated principles and parameters of creating an infinite number of sentences with a finite means of rules of syntax and word formation (that's grammar!), software like ChatGPT is built on the "fundamentally flawed conception of language and knowledge," they claim. When, then,

ChatGPT succeeds, we fail. Therefore, the popularity of ChatGPT worries sceptics and scholars alike. It's a disruptive discovery. Banning it doesn't end it. because we can no longer uninvent it. Writing is a high-stake activity. It critically determines professional success and intellectual excellence.

ChatGPT seems both magical an existential crisis. Writing is not and mysterious. Writing has never been instant and progressive. It has always been intermittent and recursive. With ChatGPT, which is a Large Language Model (LLM), writing is instant and progressive. The human language repertoire seems infinitesimal compared to the infinite source that this software draws from. Experts estimate that the human brain can process approximately 70,000 thoughts a day. The software ChatGPT, however, draws from 175 billion parameters, which are lexical chunks and units of thought. The software is fed on a massive amount of text - books, Wikipedia pages, newspapers, and social media posts - amounting to half a trillion words of text, as Steven Pinker claims in his recent The Harvard Gazette interview. It predicts patterns based on the parameters it is built on. Plausible prose emerges. The generation of prose, then, is reduced to looking for, locating, and enacting collocations. This is unqualified naivety!

Steven Pinker claims in The

a single skill manifested. Writing is a cluster of skills deployed. Writing presupposes immersive reading, deep thinking, and deft languaging. These are not the skills suddenly discovered. These skills are gradually developed. With ChatGPT around, no one needs to cultivate these skills. Writing is reduced to prompting. One even doesn't need to write a prompt. One can buy prompt. Prompt engineering is already a side hustle for some people, as Charlie Warzel claims in his essay, "The Most Important Job Skill of This Century," in The Atlantic. And it will be a booming cottage industry in the times ahead. Commodifying writing is akin to cannibalism. Writing is the metric of intelligence that sustains our civilisation. Francis Bacon, the 16thcentury English philosopher, claims that writing makes an "exact man" (and, of course, woman). People armed with the ability to write are going to be in short supply because of ChatGPT.

So is quality prose. In his article in Sense of Style that there's no The Atlantic, "What Happens When algorithm to write a sentence. A AI Has Read Everything?" Ross

Any quality prose implies knowledge internalised, and creativity excelled. Serious writing as such is exhausting. Now that there's a quick fix out there, people, students in particular, will gladly outsource the struggle of writing to machines. Countermeasures are emerging apace to watermark AI-generated prose. That perhaps means nothing. When we preach celibacy to a group of young adults, can we expect them to behave? ChatGPT, as it appears, is irresistible.

When, however, it comes to writing, ChatGPT is a BIG nothing. Writing is not a revelation. It's not taking dictation, either. It's an intellectual achievement that takes a lifetime of preparation to develop. William Faulkner, who received the Nobel Prize in literature in 1949, said in his Paris Review interview that a writer needs three things: experience, observation, and imagination. Which one of these attributes does ChatGPT have? None! It's a passing fad, as all technologies are these days. The sooner we get disillusioned with ChatGPT, the better. Why? Because it has nothing to do with writing!

A case against the Digital Security Act 2018

Some of the recent DSA cases show a bizarre pattern: the accused is first forcibly disappeared, and then shown arrested under the Act, which is a clear violation of the directives given by the Supreme **Court of Bangladesh** in the BLAST and Others v Bangladesh & Others case (decided on 24 May 2016) and the Torture and Custodial Death (Prevention)

The Digital Security Act (DSA) of 2018 was preceded by the controversial Information and Communication Technology Act 2006 (later amended in 2013). Even though the DSA was enacted to ensure digital security and identification, suppression and trial of offences committed through digital devices, various provisions of the Act are being used to suppress the freedom of expression of the

Freedom of expression has been guaranteed as a fundamental right under article 39 of the Constitution of the People's Republic of Bangladesh. Even though the provision imposes several restrictions, such restrictions must be reasonable and subjected to judicial review. The right to freedom of expression has also been guaranteed under article 19 of the International Covenant on Civil and Political Rights (ICCPR), which Bangladesh has acceded to in 2000.

Section 8 of the DSA empowers the Director General of the Digital Security Agency and law enforcement agencies to block or remove information in digital media if it threatens 'digital security'. This extremely vague provision creates scope for censorship for the independent press. Section 21 of the DSA states that if any person is involved in making any kind of propaganda or campaign against our liberation war of 1971, the spirit of liberation, the national

anthem or the national flag, such person shall $\;\;$ the BLAST and Others v Bangladesh & Others be punished with imprisonment for a term not exceeding 10 years and if it is done repeatedly, shall be punished with imprisonment for life or a fine of Tk 3 crore. Such provisions are not only vague in terms of imposing contentbased restrictions but also in providing disproportionate penalties.

Section 25 of the DSA criminalises the transmission and publication of any offensive, false or threatening information with an intention to affect the image or reputation of the country or to spread confusion, which again is too wide to be justified by any domestic or international standard. Section 31 again criminalises the intentional publishing or broadcasting of any digital format, which will destroy 'communal harmony'. These vague and wide terms bring a chilling effect on the freedom of expression on matters of public

Section 53 provides that offences specified in sections 17, 19, 21, 22, 23, 24, 26, 27, 28, 30, 31, 32, 33 and 34 shall be cognizable and nonbailable. This gross criminalisation violates the right to liberty guaranteed under article 9 of the ICCPR which protects the right to liberty and security of a person and provides that 'it shall not be a general rule that persons awaiting trial shall be kept in custody.' At the same time, section 53 undermines one of the cardinal principles of criminal law, i.e., the presumption of innocence. Article 9(3) of the ICCPR allows pre-trial detention as an


case (decided on 24 May 2016) and the Torture and Custodial Death (Prevention) Act 2013. In Douglas v Jeanette 319 US 157 case, the Supreme Court of the United States opined

that freedom of speech and expression is not confined to any particular field of human interest but guarantees the broadest exercise of the right for religious, political, economic, scientific or informational ends. In Schacht v US 398 US 58, the court found that the right to discuss public affairs includes the right to criticise the government including its defence policy and the conduct of the armed forces. In Hector v AG of Antigua and Barbuda (1990) 2 All ER 103, 106, in the words of Lord Bridge of Harwich, '[i]n a free democratic society, it is almost too obvious to need stating that those who hold office in government, and who are responsible for public administration must always be open to criticism. Any attempt to stifle or fetter such criticism amounts to political censorship of the most insidious and objectionable kind.'

Lastly, in the case of State of Bihar v Sailabala AIR (1952) SC 329, it is mentioned that advocacy of a certain political ideology cannot be restricted on the ground of security of state unless it is accompanied by the use, or threat, of violence. Such cases show that the current trend in democratic societies all around the world is to expand the ambit of freedom of expression as much as possible.

The DSA is not only limited to criminal charges and detentions but also hinders the implementation of many fundamental rights, including freedom of movement, freedom of thought, conscience, and opinion, right to life, and freedom of religion and belief. It is high time we made necessary reforms to the DSA.

In both civil and criminal aspects of any justice system, witness evidence of evidence, in leading to a conviction. and witnesses. But there are no unified witness of sexual harassment. Some unanswered questions in SULTANA **JASMINE'S**

Custodial torture and death continue to be infamy in the criminal justice system of Bangladesh. Despite the presence of constitutional safeguards and legislative provisions, this gross violation of human rights persists to cover headlines. As per a report of Ain o Shalish Kendra (ASK), 1,426 incidents of custodial deaths took place from January 2017 to July 2020. A recent addition to this grim statistics is the death of Sultana Jasmine, an employee of Naogaon Union Land Office, allegedly in the custody of Rapid Action Battalion (RAB) on March 24.

Starting from Sultana's arrest, there has been a perpetual violation of due process rights. According to media reports, she was picked up on March 22 by RAB officials. One of the pieces published on 30 March in The Daily Star titled "How did Sultana Jasmine die?" unravels that she was sued under the Digital Security Act 2018 more than 31 hours following her detention by RAB. In a writ petition filed seeking judicial inquiry into the matter, the High Court Division questioned under what authority she was picked up without her being an accused at the time, who interrogated her, and whether she sustained any fresh wounds after she was being detained. The Court also questioned the jurisdiction of RAB to pick anyone up without any formal complaints. The director of Rajshahi Medical College Hospital stated that Sultana was brought in critical condition on March 24, and she died with her already deteriorating health. Multiple intracranial bleeds and external injuries were found on her head. However, RAB officials claimed that Sultana died from a stroke. On the contrary, her family members have repeatedly asserted that Sultana was in perfect health prior to her arrest. The autopsy report handed over on April 3 divulged that she died of shock due to excessive brain hemorrhage.

Articles 33 and 35 of the Constitution lay down the safeguards regarding arrest and detention, and trial and punishment. Bangladesh enacted the Torture and Custodial Death (Prevention) Act 2013 in compliance with the Convention against Torture and Other, Cruel, Inhuman or Degrading Treatment or Punishment 1984. The Act mentions two core offences, firstly, torture by a law enforcement officer, and secondly, custodial death due to torture. Section 2(6) of the Act defines torture as physical or psychological torture that hurts and mentions specific criteria like extorting confession, punishing or intimidating any suspected person, etc. It covers the death of a person in custody of a public officer, the death of any person during illegal detention, or death during arrest or interrogation as custodial death. Though the Act provides easy avenues of complaint and investigation, victims or their relations still fear seeking remedies against law enforcement agencies.

The Act mentions in section 5(5) that the investigation will be conducted by a police officer superior to the accused officer. The proviso of section 5(2) states that the court may authorise a iudicial inquiry upon satisfaction of an application by an aggrieved person that a fair investigation is not possible by the police. The sole verdict till now under this Act has been against three police officials for the death of Ishtiaque Hossain Jonny. It is pertinent to mention that the victim's family was able to secure a judicial inquiry.

The higher judiciary of Bangladesh has provided many landmark judgments concerning the issue of arbitrary arrest, custodial torture, and death. In BLAST v Bangladesh (2003) 55 DLR 363, the Hight Court Division issued 15 directives to be followed in the arrest, detention, remand, investigation, and treatment of suspects. The Court also suggested shifting the burden of proof in custodial death cases to law enforcement agencies. The Appellate Division upheld the decision of the Hight Court Division on 24 May 2016. In the case of Human Rights and Peace for Bangladesh (HRPB) v Government of Bangladesh, the High Court Division directed RAB to comply with the provisions of the Code of Criminal Procedure 1898 while arresting any citizen and to ensure the safety of persons detained in their custody.

Custodial torture contravenes due process of law. The breach of procedural requirements in Sultana's arrest and the imputations raised by her family remain to be answered. Sultana's death has also made us ask some questions which are vet to be answered by the concerned stakeholders. When will citizens be protected from oppression at the hands of law enforcement agencies? When will the judicial directives pertaining to custodial protection be strictly complied with? It reminisces the empathetic observation by the High Court Division in AHM Abdullah v State and others (2005) 25 BLD 384 that ordinary citizens often lack the resources and ability to protest against police excesses and to seek court's redress.

Indo-Pak relations cloud WC build up

Six months out from the likely start of the Cricket World Cup in India, the match schedule for the tournament is still under wraps as geopolitics cloud the buildup to the

showpiece event.

The delay is in stark contrast to the 2019 event, when the dates and venues for the tournament in England and Wales were announced more than a year out in keeping with usual practice for major sporting events.

The Board of Control for Cricket in India (BCCI) has previously co-hosted three ODI World Cups and organising the 10-team event in October-November should present no major difficulties for the world's richest

However, soured political relations between India and Pakistan have complicated matters and cricket finds itself caught in the geopolitical crossfire between the feuding neighbours, who play each other only in multi-team

India have ruled out travelling to Pakistan for the Asia Cup in September and are likely to play their matches at a neutral venue after organisers agreed on a 'hybrid' model a move that looks likely to prompt a tit-for-tat response.

The Pakistan Cricket Board (PCB) denied media reports that it had made a similar demand at the ICC board meetings in Dubai last month but in a statement last week said it may push for the hybrid model "at the proper ICC forum at the right time".

Should Pakistan agree to travel to India, the BCCI would have to secure visa clearance from the Indian government.

A source with direct knowledge of the deliberations told Reuters that moving matches out of India had not even been discussed and the fixtures would be announced in "due course".

Cricket news website cricinfo.com has reported that the BCCI has yet to obtain a tax exemption for the tournament from the Indian government, which is part of the hosting agreement it signed with the ICC

Should it fail to obtain the exemption the BCCI has said the amount could be deducted from its share of the ICC's central revenue pool.

'It was a pretty easy decision'

Frank Lampard insisted it was an "easy decision" to make his surprise return to Chelsea as caretaker manager until the end of the season on Thursday, just over two years after he was sacked by the Premier League club.

Lampard, Chelsea's record goalscorer, previously managed the Blues from July 2019 until January 2021, when he was replaced by Thomas Tuchel.


The 44-year-old's unexpected move back to Stamford Bridge came after Tuchel's successor Graham Potter was dismissed on Sunday with the club in the bottom half of the Premier League.

"We are delighted to welcome Frank back to Stamford Bridge," Chelsea co-controlling owners Todd Boehly and Behdad Eghbali said in a statement. "Frank is a Premier League Hall of Famer and a legend at this club.

"As we continue our thorough and exhaustive process for a permanent head coach, we want to provide the club and our fans with a clear and stable plan for the remainder of the season."

Former England midfielder Lampard had been out of a job since January when he was sacked by relegationthreatened Everton after less than a year in charge.

Lampard claimed he did not have to swallow his pride to return to Chelsea despite his brutal exit during Roman Abramovich's reign as owner. "It's a pretty easy decision for me. This is my club. I have a lot of emotions and feelings," Lampard told a press conference minutes after his appointment was announced.

"It has been the greatest day in Ireland's Test history," international commentator Andrew Leonard told this reporter when talking about what transpired on the third day of the one-off Test, which saw Ireland take a 131-run lead against hosts Bangladesh.

While the Irish commentator was ecstatic, his companion, South African Deon Ackerman, was pondering a more menacing query of his own related to Bangladesh skipper Shakib Al Hasan. "What happened to Shakib? Is he injured?" he inquired.

When told no injury concerns had been reported, he seemed a bit perplexed. Shakib had bowled just three overs in Ireland's first innings, so that question was very much the proverbial elephant in the room.

Taijul Islam had bagged five wickets in the first innings and it had been apparent that spin held sway on the second day. But given that Bangladesh had five specialist bowlers in the line-up excluding Shakib, the argument that could be developed was that the skipper was gauging the strength of the rest of the bowlers.

Shakib took the ball from the very beginning on the second day during Ireland's second innings and bowled seven overs, inciting a top-order collapse as he produced two wickets with the new ball and Ireland slumped to 13 for four before reaching 27 for four at the close of play.

Coming into the third day, Shakib bowled three more overs on

the trot. That turned out to be his biggest spell in the second innings, with the visitors managing to play out 107 overs with a majority of their batters getting starts. Taijul bowled 38 of those and the pace trio managed 27.

Lorcan Tucker struck a hundred during two big partnerships and, have done what he does best.

Argentina go top after 6 years

World champions Argentina dethroned Brazil and returned to the top of the FIFA rankings on Thursday after a six-year gap.

Argentina, who won last year's World Cup in Qatar by beating France in the final, achieved the No. 1 spot after Lionel Scaloni's side beat Panama 2-0 and Curacao 7-0 in friendlies.

France moved up one place to second after a 4-0 win over the Netherlands and 1-0 victory in Ireland in Euro 2024 qualifiers, while Brazil slipped to third after losing 2-1 away to Morocco in a friendly. Belgium remained fourth, England were fifth

followed by the Netherlands in sixth, Croatia seventh and Italy eighth. Portugal and Spain completed the top 10.

A second-half hat-trick from star forward Karim Benzema saw Real Madrid bounce back from a one-goal semifinal first leg deficit to beat archrivals Barcelona 4-0 in the second leg at their home and reach the Copa del Rey final in stunning fashion on Wednesday.

Benzema became the first Real player to score a hattrick in a Clasico at the Nou Camp since Ferenc Puskas in 1963.

With 16 goals to his name in 43 appearances, Benzema has now become the 4th-highest scorer in El Clasico after Lionel Messi, Alfredo Di Stefano and Cristiano Ronaldo.

Benzema also became the first Real Madrid player to score a hattrick in El Clasico against Barca since Ivan Zamorano in 1995.

Benzema (25 goals in 48 matches) also surpassed Cristiano Ronaldo (22 goals in 30 games) to become the top scorer for Real Madrid in Copa del Rey.

Having netted thrice in a La Liga encounter with Real Valladolid in his previous game, Benzema's hat-trick on Wednesday saw him score consecutive trebles for the first time in his career.

More records on Kings' agenda

Bashundhara Kings will look to make history by winning the professional football league four times in a row as the Bangladesh Premier League resumes today following a six-week midseason

break for the transfer window and international engagements. At the end of the first-phase, leaders Kings are nine points clear of closest rivals Abahani, which is a record gap since the inception of the professional football league in 2007.

When Kings entered the top flight in the 2018-19 season, the biggest gap between first and second place at the midseason point in any prior season was four points. Abahani had led Sheikh Jamal by that margin in 2009-10 while Muktijoddha Sangsad had four more points than

Mohammedan in 2010-11. Interestingly, Kings maintained that gap by going four points clear of nearest rivals Abahani at the midseason mark in their debut season before widening that gap to eight points against nearest rivals Sheikh Jamal in their second season at the same point of the season. In that second season, they ultimately finished 13 points clear of runners-up

However, Kings were challenged in their third season as Abahani refused to go away. They were leading by four points at the midway point, but their lead against second-placed Abahani ballooned to 10 points by the end of the season, securing a hattrick of titles

In the past, only two teams have overcome a deficit to lift the title. Abahani have done so thrice, overcoming gaps of one or two points, while Sheikh Jamal once recovered from a four-point deficit to win the title. But this time, six-time champions Abahani and three-time champions Sheikh Jamal are a long way away from the unstoppable Kings, who are on a roll with 10 straight wins. They have 30 points followed by Abahani's 21, Bangladesh Police's 16 and Sheikh Jamal's 14.

Today, Kings will meet newcomers Azampur FC Uttar at the Rofiqe Uddin Bhuiyan Staidium in Mymensingh.

Birds long dead, money meant for their feed 'embezzled'

Forest department officials have shown dead exotic birds of an aviary in Chattogram as alive in documents allegedly for six years embezzling the money meant for bird feed. The Sheikh Russel Aviary and Eco Park was inaugurated

in 2013 with 740 exotic and 199 native birds in Rangunia upazila. But a committee formed in February this year to count

the birds found only 183, most of which are mallards and ducks, according to Shitol Pal, assistant conservator of forest, who was the member secretary of the committee. On paper, the park had 30 species of exotic birds, but

in reality, the committee found only five: pelican, jandaya parakeet, bar-headed goose, and blue and gold macaw. There were also 169 turtles in the lake.

According to records obtained by The Daily Star, the park spent about Tk 3.08 lakh to feed 740 birds for just 18 days in January and the park authority allocated Tk 50 lakh for bird feed in

the 2022-2023 fiscal vear.

An employee of the park, who feeds the birds, said the feed mostly contains grain husks and a small amount of bananas, sunflower seeds and eggs that doesn't cost more than Tk 80,000 a month.

Employees of the park on 520 acres of hilly area said most of the birds died during a 2016 cyclone that damaged all the cages. But the losses were not recorded on

The birds listed by the committee include mallards and ducks 78, quail 26, local parrot 17, common peafowl 17 and turkey 11.

Contacted, Rangunia Range Officer Masum Kabir, who was in-charge of the park at different times from 2020 to January 2023, did not give a direct answer when asked why there was such a discrepancy between the number of birds found by the committee and the number shown on food ration documents.

He claimed the birds died at different times and the list was revised regularly.

When he was reminded about the January diet chart that mentioned 740 birds, he said ducks were bought to restore the stock. He didn't directly answer when asked

about the mention of exotic birds on documents. A day after the committee counted the birds, the contractor supplied the ducks, he said, adding that the park now has the number of birds mentioned on paper.

According to records, M/S Meem Traders has been supplying feed to the park since it was established. Asked how many birds his firm has been supplying the feed for, Babul, the proprietor, said he would not answer

the question and told this reporter never to call him again. Alimul Raji, the veterinarian of the aviary, said it was difficult for the exotic birds to cope with the climate.

Most of the birds flew away or died during cyclone Roanu in 2016. Besides, a landslide coupled with heavy downpour damaged four cages, but no list was prepared of the remaining birds, he added.




