Airports getting ready for more flyers, planes

Govt spending Tk 32,605cr on 8 airfields to meet growing demand

The government is spending around Tk 32,605 crore to upgrade the eight commercial airports in the country and these facilities may start delivering dividends from as soon as this October.

The amount being spent is more than the cost of the Padma Bridge. The work involves constructing a third terminal at Hazrat Shahjalal International Airport (HSIA), laying the country's longest runway in

Cox's Bazar, expanding and strengthening the runways at six airports, increasing the cargo handling capacities, and improving basic amenities

These should result in improved service and capacity for domestic and international air traffic and passengers.

The country's airports, including the HSIA, have been struggling to provide the service the flyers expect. They have been complaining about sub-par ground handling and other services.

Civil Aviation Authority of Bangladesh (CAAB) Chairman Air Vice Marshal M Mafidur Rahman told The Daily Star that the eight airports were being upgraded under 15 projects.

The biggest project by far is the third terminal at HSIA being built for Tk 21,399 crore. Japan International Cooperation Agency (Jica) is funding 70 percent of the cost.

Adding 1,700 feet to the Cox's Bazar Airport's 9,000 feet runway for Tk 1,568 crore is another major project. Once complete, the airport will be able to handle aircraft like the Boeing 777s.

Mafidur said at least seven of the projects, including the third terminal air traffic management system at the HSIA, development of Cox's Bazar Airport, reinforcement of the runway and taxiways of Sylhet airport, and capacity building of CAAB are set to be complete by the

Aviation expert ATM Nazrul Islam said improved capacity and infrastructure facilities at the airports are necessary to tackle the growing air traffic.

He said in 1991, the number of passengers on domestic routes was around three lakh which has now increased to 25 lakh. For international routes, the number has increased from 11 lakh to 86 lakh.

Says Fakhrul

UNB, Dhaka

BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday said the government will have to accept the demands of the opposition parties if it wants to avoid violence and conflict ahead of the next general election.

He made the remark during a press briefing at the BNP Chairperson's Gulshan office after a meeting with the liaison committee of Jatiyatabadi Samamona Jote.

"If the government wants to avoid conflict and move forward, then the first thing it needs to do is to meet the demands of the opposition parties."

The BNP leader said their party has long been urging the government to step down and take steps for talks on the polls-time caretaker government to ensure a credible national election in the country.

Lawmakers from the Jatiya Party, Workers Party and Jatiya Samajtantrik Dal (JSD) said this in parliament yesterday while taking part in the discussion on a proposal.

Workers Party and the JSD are components of the ruling Awami League-led grand alliance. Prime Minister Sheikh Hasina on Friday

placed the proposal in the House, which is now in a special session on the occasion of its golden jubilee.

Taking part in the discussion, the MPs also said it is necessary to assess how much

the Jatiya Sangsad has been able to hold the government accountable. However, AL lawmakers highly lauded

the PM for advancing the country towards development and prosperity.

All 8 victims from Bawm community

All eight people, killed in a "shootout" between two armed groups in Bandarban's Rowangchhari on Thursday night, belong to the Bawm community.

Six of them were from Zurvarawng village, one from Raunin Para and another from Pangkhyang Para, a leader of Bawm Social Council (BSC), seeking anonymity, told The Daily Star yesterday.

Bandarban police, on the other hand, said they were yet to identify the dead.

Abdul Mannan, officer-in-charge Police Rowangchhari Station, said the United People's Democratic Front (Democratic) and Kuki-Chin National Army, the military wing of Kuki-Chin National Front (KNF), were engaged in the gunfight on Thursday night to establish supremacy in the hills of Khamtang Para and nearby

areas. On information, police recovered the eight bulletridden bodies near the Ruma-Rowangchhari link road around 12:30pm on

Traders want support to get back on their feet

Bangabazar shop owners are looking forward to today's meeting between their association and the city corporation in which decisions will be made about how the shop owners will run their businesses in a makeshift arrangement before Eid.

The meeting will also decide on compensation for the thousands of traders who lost everything in the April-4 fire.

The traders want to start over and want to know what assistance the government will provide.

"We had expected a brisk business ahead of the Eid. But the fire ruined everything," said trader Rakib Uddin.

Like Rakib, around 3,000 traders

want to start the business on the ground where the three-storey Bangabazar Shopping Complex stood. Representatives of Bangladesh Shop

Owners' Association are to sit with Dhaka South City Corporation Mayor Sheikh Fazle Noor Taposh.

Dhaka district administration is making a list of affected traders. A long queue of shop owners was seen at the information centre of the administration yesterday.

Names of the shops and shop owners, details of the NID cards and trade licences, and business cards were being recorded at the centre.

Those who lost their trade licences to the fire brought their NID and business cards. SEE PAGE 2 COL 2



BNP'S SIT-INS

Foiled by attacks, arrests in many places

Party leaders blame law enforcers, ruling party men

While observing sit-ins in thanas and upazilas across the country yesterday, BNP leaders alleged they were obstructed and attacked in many places by law enforcers and ruling Awami League activists.

In several than as in the capital, the opposition party held its programmes defying police barriers.

The sit-ins, held from 2:00pm to 4:00pm, were to protest the increase in prices of electricity and gas and the corruption of the Awami League government, and to push for the 10-point demand for the restoration of democracy, including resignation of the government.

BNP central leader Anisur Rahman Talukder Khokon was arrested during the programme in Madaripur's Kalkini upazila, while Altaf Hossain Chowdhury, another party central leader and former minister, came under attack when he was going to join the programme in Patuakhali's Mirzaganj.

At least 15 people were injured when activists and leaders of AL and BNP

leaders clashed in Laxmipur's Ramganj. In Sylhet, BNP chairperson's advisor Ábdul Muktadir was arrested from the airport area, but was

released after an hour.

BNP Secretary General Mirza Fakhrul Islam Alamgir condemned and protested the attacks and arrests.

"The government is instigating the BNP to take a different path by obstructing the peaceful programme. There were sit-in programmes at the thana-upazila level, but police put up barricades everywhere. In Dhaka city, most of the programmes were not allowed at the designated places, and so had to be held elsewhere, he said while addressing an iftar party organised by Association of Engineers, Bangladesh, at the Ladies Club in the capital.

In Natore, Jubo League and Chhatra League activists have been accused of attacking BNP leaders and activists when they came to join the sit-in

LEAK OF DOCUMENTS ON UKRAINE WAR

Russia likely behind it

US officials say; Moscow charges US reporter with spying; Missile fired from Ukrainian-held territory downed over Crimea

Russia or pro-Russian elements are likely behind the leak of several classified US military documents posted on social media that offer a partial, month-old snapshot of the war in Ukraine, three US officials told Reuters on Friday.

A leak of such sensitive documents is highly unusual.

Meanwhile, Russian Federal Security Service investigators have formally charged Evan Gershkovich with espionage but the Wall Street Journal reporter denied the charges and said he was working as a journalist.

In Russian-controlled Crimea, a missile fired from Ukrainian-held territory was shot down over the Black Sea town of Feodosia, the Moscow-installed head of Crimea's administration said vesterday.

"A missile launched from Ukraine was shot down over Feodosia," Sergei Aksyonov said on Telegram, without providing any detail on the kind of projectile in question.

Russia's TASS news agency quoted an adviser to Aksyonov, Oleg Kryuchkov, as saying that debris had fallen in a Crimean town, but no damage or casualties had been reported.

On the leaked US military documents, Kremlin and Russia's embassy in Washington did not immediately respond to requests for comment.

The documents appear to have been altered to lower the number of casualties suffered by Russian forces, said US officials seeking anonymity, adding their assessments were informal and separate from the investigation into the leak

The Kremlin and Russia's embassy in Washington did not immediately respond to requests for comment.

An initial batch of documents circulated on sites including Twitter and Telegram, dated March 1 and bearing markings showing them classified as Secret" and "Top Secret."

Later on Friday, an additional batch appearing to detail US national security secrets pertaining to areas including Ukraine, the Middle East and China surfaced on social media, the New York Times reported.

A CIA spokesperson said the agency was also aware of the posts and was looking into the claims.

One document posted on social media said 16,000 to 17,500 Russian forces had been killed since Russia's February 24, 2022, invasion of Ukraine.

The United States believes the actual figure is much higher, at around 200,000 Russians killed and wounded, officials have said.

A Ukrainian presidential official said on Friday that the leak contained a "very large amount of fictitious information" and looked like a Russian disinformation

CU students dies 'by suicide'

A student of Chattogram University died reportedly by suicide yesterday evening.

Mochhammad Rokeya Khatun, fourthsemester student of management department, was staying in Shamsunnahar Hall.

According to her classmates, she was found hanging from the ventilator of her dormitory room around 4:00pm.

"I heard the student was rushed to the medical centre on the university campus. Doctors there referred her to Chattogram Medical College Hospital," said CU Assistant Proctor Arup Barua. Doctors of CMCH declared her dead around

7:00pm when she was taken to the hospital, said Nurul Alam, in-charge of CMCH police outpost.

"After receiving the autopsy report we will be able to tell if this was a suicide," said CU Proctor Nurul Azim Sikder.

31 Ukrainian children returned from Russia

4 dead in Thailand shooting: police

At least four people were killed in a shooting in southern Thailand yesterday, police said, with local media reporting that officers were still searching for the suspect.

The attack started at about 5:00 pm (1100 GMT), in Khiri Rat Nikhom district in Surat Thani province roughly 600 km (370 miles) south of the capital Bangkok.

"Four people died," local head of police Kriangkrai Kraikaew told AFP, declining to give further details.

The shooting happened near the home of a former village head, local media reported.

Thailand has high rates of gun ownership and there has been a steady trickle of violent incidents in the past 12 months, including one of the deadliest attacks in recent history.

"As it came to the media, we also suspect that the deceased might be KNF members," the SP said.

The BSC leader, however, could not confirm whether the deceased were KNF members.

According to the list provided by the BSC, six people from Zurvarawng village are -- Lal Tha Zar Bawm, 27, Sang Khum Bawm, 45, Vanlal duh Bawm, 35, Sun Thir Thang Bawm, 22, Bawi Rem Bawm, 17, and Lal Lian Ngak Bawm, 44.

Among them, Lal Tha Zar Bawm is an office assistant at Zurvarawng Government Primary School.

Jahim Bawm, 40, is from Pangkhyang Para while Bawm Ram Than Bawm is from Raunin Para.

OSMANI INT'L AIRPORT, SYLHET

The load-bearing capacity of the runway and taxiways will be improved to allow large planes to land with a full load in Sylhet, CAAB officials

Besides, under the joint finance of the government and CAAB, another project at a cost of Tk 2,309 crore was taken to improve the passenger and cargo handling capacity at the

Under the project, a 34,919 square metre terminal, a 6,892 square metre cargo complex, a control tower, a fire station, a maintenance building and a car park will be built.

The CAAB chairman, however, said due to a fault in the design, the work on the project is stalled.

COX'S BAZAR AIRPORT Extending the runway was supposed

to be complete by May, 2024, but steps have been taken to complete it by the end this year, said the CAAB chairman.

The terminal building of Saidpur Airport is being modernised. The project is nearing completion, and when done, the terminal will be able to accommodate 670 people, up from the current capacity of 310.

Besides, a cargo building with some level of automation, an operations building with apron, taxiways, and a control tower will be built.

The runway of Barishal airport is also being extended from 6,000 to 7,500 feet at a cost of Tk 370 crore. The width of the runway is being increased from 100 to 150 feet.

Rajshahi Terminal Building Expansion Project being is implemented at a cost of Tk 76 crore. This will increase the passenger accommodation from 260 to 850.

The Jashore Terminal Building Expansion Project will increase passenger accommodation from 300 to 600 people. Ninety-nine percent work of the project has been completed.

Another project, costing Tk 566 crore, has been taken up to ease landing and take off of aircraft at Jashore, Saidpur, and Rajshahi

Traders want support to get back on their feet

the spot, traders opened some 50 makeshift shops on a nearby road. Lt Col Tajul Islam, director

(operations) at Fire Service and Civil Defense, said, "The smoke is coming

out from the clothes buried under the debris and burnt corrugated iron sheets. But there is nothing to be afraid of."

The shop owners' association sold the damaged iron rods and corrugated iron sheets to a contractor named Omar Faruk for Tk 40 lakh. Employees of the contractor were seen taking those away on trucks.

Nazmul Huda, president of Bangabazar Complex Shop Owners' Association, said the money will go to a welfare fund of the affected traders.

He told a press conference that goods worth Tk 1,000 crore were lost

Meanwhile, Dhaka Metropolitan Police Commissioner Khandaker Golam Faruq yesterday said police were investigating whether the fire was the result of a conflict between groups of traders over the construction of a multi-storey at the site.

He said there was a dispute among the businessmen of Bangabazar over building a multi-storeyed building at the complex.

Hossain Khan claimed that there were no issues with the online ticket purchases. "People bought tickets faster today Saturday] than they could yesterday

Friday]," he told The Daily Star vesterday. Meanwhile, tickets for April 19, 20, and 21 will go on sale today,

tomorrow, and the day after tomorrow, respectively with more people likely to

visit the website on these dates. Eid-ul-Fitr is expected to fall on April 22 or 23.

Culture, like rivers, is drying up

Say speakers at event marking Abul Mansur Ahmad's death anniv

Cultural practice in the country has reached a very low point. It's drying up like the way our rivers have, Prof Emeritus Serajul Islam Choudhury said yesterday.

"We are moving towards individual ownership of culture. Today, the practice of collective culture in Bangladesh is steadily narrowing. There is no collective practice," said Prof Serajul, while addressing a prize-giving event of a book review competition on -Bangladesher Culture -- written by writer-journalist-politician Abul Mansur Ahmad marking his 44th death anniversary at The Daily Star Centre in the capital.

The eminent thinker and writer said, in today's world, human civilisation has come to a turning point, where the question of whether this civilisation will survive or not has come to the fore.

"If social ownership cannot be established, civilisation will fall into an abyss. And today's crisis is created due to the private ownership of culture."

Noting that the practice of history has reduced, he said, "That's why we have to go to Abul Mansur Ahmad to study history. There is a debate on history in class six and seven books. The reason for the controversy is that history has been written hastily."

Organised by Abul Mansur Ahmad Smiriti Parishad, writers, litterateurs, and readers from different institutions spoke at the event.

Speaking at the event, Prof Mohammad Azam of Dhaka University's Bangla department, said, "In this book [Bangladehser Culture], the concept of culture is different."

'Prioritise fire safety in semi-formal markets'

Experts tell seminar STAFF CORRESPONDENT

City planners have called for prioritising overall safety issues, including fire safety in semi-formal markets in different urban areas, including Dhaka, in light of the massive fire at Bangabazar Market in the capital recently.

They made the call at an event, titled "Fire Hazards in Bangabazar and Sub-Formal Market Fire Risk: IPD's Observation". organised by the Institute for Planning and Development (IPD) vesterday.

IPD's Executive Director Prof Adil Muhammad said, "Although Khan Bangabazar market has been identified as vulnerable to fire, the state institutions as well as the city corporation and fire service are relieved of responsibility only by issuing notice. As the owner of the market, it was the responsibility of the city corporation to take full measures for fire safety to avoid the loss of life and property.'

IPD Ádvisor Prof Akhter Mahmud said through a detailed survey of informal markets across the country, the steps to reduce fire hazards according to the fire code and building code should be specified.

Planner Abu said for markets such as Bangabazar, it's necessary improve the prevention and detection system along with electrical safety auditing.

"It's also important to have a fire safety and emergency exit plan, in addition to setting up a fire control room in every market," he added.

Rakib Hossain, owner of Mashallah Enterprise, was one of the affected shopkeepers who was forced to move his business to the street.

"We did not imagine such a big loss before Eid. There were Tk 15 lakh worth of clothes in the shop, all of which were burned down," said Rakib.

Although Rakib is a wholesale trader, he is now among the many affected shopkeepers selling goods on the road due to an urgent need for money.

Shopkeepers like Bacchu Miah are also facing the challenge of selling their remaining stock of clothes at lower prices due to the urgent need for money.

"The fire has caused wholesalers to offer Tk 200-250 less per piece of Panjabi, which is affecting their earnings," he said.

Shop owner Jahangir Hossain expressed his despair at the loss of his shop's inventory, including pyjamas, pants, panjabi, and sarees, worth Tk 15 lakh. With no means to recover the loss, he has resorted to selling his remaining stock at a lower price on the road.

GOLD SMUGGLING

Syndicates at Indo-Bangla border remain unidentified

Gold smuggling continues to be a persistent issue at the Bangladesh-India border, particularly through the routes of Chawratari in Moghalhat union of Lalmonirhat Sadar Upazila and Baniatari in Durgapur union of Aditmari Upazila.

On January 31 of this year, the Border Guard Bangladesh (BGB) arrested Azizar Rahman, a resident of Baniatari village in Durgapur union, with 45 gold bars weighing 5 kg and 248 grams worth Tk 4 crore and 5 lakh.

A case has been filed with Aditmari Police Station in connection with the incident. Police are currently investigating the issue.

Despite the arrest, the gold smuggling syndicate remains unidentified and has yet to be brought under the law. While a case has been filed, the police have not been successful in tracing the syndicate. Azizar Rahman, who is believed to be a part of the syndicate, has not cooperated with the investigation and only stated that he was handed a bag to deliver to India's Daribas

According to sources at the border, Azizar Rahman has been involved in the gold smuggling syndicate for a long time and used to smuggle gold from Bangladesh to India in exchange for a contract. Both countries are said to have syndicates involved in gold smuggling. These syndicates are powerful and have political involvement, they added.

Rafigul Islam, investigating officer and OC (investigation) of Aditmari Police Station, said they are working to uncover the syndicate, but Azizar Rahman has not provided any information.

Construction materials dumped on **OLD BRAHMAPUTRA BANK**

A section of vested quarters has been dumping concrete waste and keeping construction materials near the Old Brahmaputra River at Mymensingh city's Kachari Ferry Ghat area for months.

Neither Mymensingh City Corporation (MCC) nor the local Water Development Board (WDB) has taken any initiative against them yet, alleged locals.

Locals also alleged that these unscrupulous activities are mainly done at night. But it's a serious concern as no action has been taken yet.

The 283-kilometre Old Brahmaputra from Jamalpur's Dewanganj upazila to the Meghna in Bhairab of Kishoreganj is one of the longest rivers in the country. Many tributaries and small rivers depending on the Brahmaputra are also in crisis due to siltation, alleged environmental activists.

Not only this, contractors keep their materials for days on the river bed in the same area.



When this correspondent visited the area on Thursday, a huge pile of concrete waste, broken bricks and its mixture with sand was seen.

Shamsul Mia, a resident of the adjacent Char Gobindapur area said after the monsoon begins, the dry river bed goes under water within days. If the concrete rubbish and other construction materials aren't cleaned up immediately, it will mix with the

of Jonouddyog, a civil society forum, alleged this menace wouldn't exist if there was proper monitoring.

Pointing fingers at the municipal authorities and WDB, he added that waste disposal into the Old Brahmaputra River at Kalibari Puran Gudaraghat

Memorandums to the Mymensingh deputy commissioner and MCC mayor were submitted on various occasions urging the stopping of any kind of dumping into the river but no fruitful action has been taken yet, lamented the leaders.

Admitting to dumping concrete waste onto the river bed, Mohabbat Ali, conservation inspector of MCC, said no one can use the river land for keeping construction materials to dump waste. He also said they will look into the matter seriously to find out those involved in such an act.

Commuters' suffering inevitable on Sirajganj highway during Eid

Authorities unlikely to complete renovation within revised deadline

Commuters visiting their homes in the country's North for Eid will face much suffering as the Bangabandhu Bridge west link road in Siraganj is in bad shape due to the ongoing widening and renovation

This road is the gateway to northern districts. Vehicles from 22 districts, including 16 from northern districts, travel through this highway daily. Around 20,000 to 25,000 vehicles travel during normal times, but this number increases two to three times during Eid.

Transport workers and passengers said even the highway gets clogged with vehicles during Eid due to the slow progress of the road's renovation work, causing immense suffering to homebound passengers.

Raoshan Yazdani, officer-in-charge of Bangabandhu Bridge West Police Station, said work to renovate 20 points of the highway, along with a 50-kilometre stretch from Bangabandhu Bridge west to Chandaikona highway via Hatikumrul is currently ongoing. Of this, at least 14

vulnerable places have a risk of traffic congestion, he said.

Under such circumstances, the road development project officials said the highway from Bangabandhu Bridge's west end to Chandaikona has been identified as risky for smooth traffic. Contractors have been directed to renovate these places within the 20th of Ramadan (three days from today).

During a recent visit, this correspondent saw potholes in various parts of the 50-km highway from the west end of the bridge to Chandaikona through Hatikumrul. Several lanes were not in good condition.

The highway at different places, including Konabari, Jhaail, Golchattar Food Village, Nalka, Pachlia, Mulibari, Syedabad, Chandaikona Bridge, Zamzam Hotel, Hatikumrul, Bhuyagati and Sahebganj, was in a bad shape.

Meanwhile, although the northern lane of the newly constructed Nalka bridge has been opened, the Dhaka-bound lane has been kept closed. Due to the closure of the Dhaka-bound lane, vehicles are moving

ATTACK ON CTG JOURNO Main accused still at large

After a brutal attack on a journalist in Chandanaish upazila of Chattogram, the police have been unable to arrest the main accused even after four days of the incident.

Ayub Miaji, a local journalist, was allegedly beaten and pushed off the roof of a two-storey building on Tuesday afternoon. The attack was reportedly carried out by a group of individuals, who were angry about Miaji's news reports on hill cutting and providing information to the administration.

Miaji works as the Chandanaish upazila correspondent for the national daily Janobani and the local daily Sangu. He is now receiving treatment at Chattogram Medical College Hospital for his critical injuries. The victim's father filed a case with the local

police station accusing two named individuals and several unnamed persons. The named accused are -- Md Alauddin, 35, and Md Faruk, 26, both residents of the same upazila. However, the police have been unable to arrest

either of them yet. Several locals have alleged that Alauddin is involved with Jubo League politics but the local Awami League lawmaker Nazrul Islam Chowdhury has denied this.

"The criminals attacked my son for reporting on their misdeeds," said Abdus Shukkur, the victim's father. "But police could not arrest them till now. Meanwhile, influential quarters are pressuring us to withdraw the case. We are passing days amid insecurity. Now they (influential people) are trying to implicate me in a false case," he claimed.

Sensing the presence of mobile courts, the sand lifters, however, managed to flee.



4 brick kilns eating away farmland

ZAHANGIR SHAH, Manikganj

Four brick kilns set up side by side on farmland have been badly affecting the agricultural production in Manikganj's Singair upazila as the soil of the adjacent croplands are sold to feed the brick kilns for long.

Local farmers alleged that they are often forced to sell their valuable topsoil to the brick kiln owners. A section of soil traders is

cutting off the soil from the

farmlands after buying the top layer from the land owners. Later, the syndicate has been selling the earth to the brick kiln

owners. Despite submitting repeated complaints to the local administration and public representatives, the aggrieved

land owners are yet to get any

They also formed a human chain recently to press for their demand.

During a visit to the area this correspondent saw four brick kilns, set up side by side at Baudipara village under Jamirta Union, have been running their operations in full swing.

It was seen that the syndicate members have been cutting soil, using excavators, from the surrounding cropland at Baudipara, Ramchandrapur and it to GH Bricks, AMCO Bricks, DMC Bricks and TS Bricks.



including Nazimuddin, Danez, Fazal, Parbat, Barkat and Salam have already cut soil from several hundred bighas of farmland and sold it to the brick kilns.

Local farmers alleged that if Hamed said. anyone dares to protest the illegal soil cutting the syndicate men either beat them up or threatened them with dire consequences.

Farmer Mohammad Rahiz of Hatani village said he has 18 decimals of land only a few hundred yards from the brick kilns and used to get three crops from the land in a year.

"Last year I got 20 tonnes of IRRI paddy from my land, but it lies uncultivated this year," Rahiz

He was unable to irrigate his land this year due to removal of soil from both sides of his land, he added.

Hamed Ali of Farmer Bhaudipara village said, "I have 115 decimals land on the east side of the brick kilns. Last year I got Degreechar village and supplying 70 maunds of IRRI, 12 maunds of Aman paddy

Some local influential men and 24 maunds of mustard from my land."

"Although I have planted IRRI paddy this year, my land has been on the verge of collapse due to cutting of soil from both sides,"

Abu Bakar, another farmer of the village, said many trees of the village are dying and fruits are getting damaged due to emission of toxic smoke from the four brick

ATM Rashed Mehdi, an income tax lawyer from Ramchandrapur village, said despite repeated pleas the authorities are yet to take any action against the brick kilns.

Jamirta Union Parishad (UP) Chairman Abul Hossain said although he has informed the parishad chairman, upazila upazila nirbahi officer and other concerned people about the ill practice, but yet to get any result in this regard.

Manikganj Commissioner Muhammad Abdul Latif said nothing can be achieved by destroying agricultural land. Local administration will take necessary action in this regard soon, he added.

71 Chinese planes crossed Taiwan Strait median line

Seventy-one Chinese military aircraft crossed the sensitive median line of the Taiwan Strait yesterday as China began drills around Taiwan in anger at President Tsai Ing-wen's meeting with the speaker of the US House of Representatives.

The three-day drills, announced a statement. the day after Tsai returned from the United States, had been widely expected after Beijing condemned her Wednesday meeting with Speaker Kevin McCarthy in Los

The People's Liberation Army said it had started the combat readiness patrols and "Joint Sword" exercises around Taiwan, having said earlier it would be holding them in the Taiwan Strait and to the north, south and east of Taiwan "as planned".

"This is a serious warning to the Taiwan independence separatist forces and external forces' collusion and provocation, and it is a necessary action to defend national sovereignty and drills, set to stirring martial music territorial integrity," the Chinese and showing warships at sea and army's Eastern Theatre Command

aircraft, including fighter jets and bombers, crossing the median line that normally serves as an unofficial barrier between the two

sides, as well as nine Chinese ships. China was using Tsai's US visit "as an excuse to carry out military exercises, which has seriously damaged regional peace, stability and security", the ministry said in

There was no broader sense of alarm in Taiwan about the drills, where people are long accustomed to Chinese threats.

A senior Taiwan official familiar with security planning in the region told Reuters the aircraft involved in the morning missions had only crossed the median line briefly.

The situation was "as expected" and manageable, and Taiwan's government has rehearsed various scenarios for its response, the person said on condition of anonymity, as they were not authorised to speak to the media.

Writing on her Facebook page, Tsai said she was briefed about the security situation and that the military was at its post around the

N Korea conducts another test

North Korea claimed vesterday it had tested another underwater nuclear attack drone, its latest response to joint US-South Korea military drills, though analysts have questioned whether Pyongyang has such a weapon.

In recent weeks, North Korea has tested what state media have described as an underwater nuclearcapable drone and also carried out the launch of an intercontinental ballistic missile.

"A national defence science research institute in the DPRK carried out a test of underwater strategic weapon system from April 4 to 7," the official Korean Central News

"The underwater nuclear attack drone 'Haeil-2'... cruised 1,000 km of simulated underwater distance."

KCNA added that "the test warhead accurately detonated underwater. The test perfectly proved the reliability of the underwater strategic weapon system and its fatal attack ability."

On March 23, North Korea claimed it tested an underwater nuclear attack drone able to unleash a "radioactive tsunami", as it blamed US-South Korea exercises for a deteriorating regional security situation.

Satellite imagery has also indicated a high level of activity at North Korea's main nuclear complex after leader Kim Jong Un ordered that production of weaponsgrade nuclear material be ramped up.

Last year, North Korea declared itself an "irreversible" nuclear power, while Kim has told the North Korean military to intensify drills in preparation for a "real war".

South Korea and the United States on Wednesday staged joint air drills, Seoul's military said.

US Navy sends guided-missile sub to Middle East

The US Navy yesterday said a nuclear-powered guided-missile submarine was operating in the Middle East in support of the Bahrain-based US Fifth Fleet. The USS Florida entered the region on Thursday and began transiting the Suez Canal on Friday, Commander Timothy Hawkins said in a statement. "It is capable of carrying up to 154 Tomahawk land-attack cruise missiles and is deployed to US 5th Fleet to help ensure regional maritime security and stability," Hawkins said.

Gunmen kidnap 80 in Nigeria

Gunmen abducted at least 80 people, mostly women and children, in Nigeria's Zamfara state, a hotspot for kidnappings for ransom by armed gangs targeting remote villages, residents said

Gangs of armed men have attacked hundreds of local communities across northwestern Nigeria in recent years, while Islamist militants continue to stage attacks in the northeast.

The latest kidnapping took place on Friday in Wanzamai village in Tsafe local government area in Zamfara, three residents said. Zamfara is one of the states most affected by kidnappings.

Musa Usman, whose 14-year-old son Ibrahim was among those abducted, said children and women from the village were clearing land for farming and collecting firewood when they were taken by gunmen and marched into a nearby

"The children from different households went to collect firewood and few of them were going to farms in search of manual jobs when they were abducted," Usman told Reuters by phone.

Zamfara police confirmed the incident in a statement but did not say how many people were abducted. The police were working with the military and community security guards to rescue the victims, he said.

Haruna Noma, another parent, said some of those taken were from two nearby villages of Kucheri and Danwuri who had gone to Wanzamai to clear land to farm.

Why the president's speech is so relevant

Politics of confrontation must end

President Abdul Hamid's speech at the Jatiya Sangsad is more than just a ceremonial address on the occasion of the parliament's 50th anniversary. It is significant because it comes at a crucial time for Bangladesh when it prepares for the 12th national elections. In an atmosphere of extreme acrimony between the ruling party and the opposition which dominates our politics, it is a speech worth listening to.

The president's reiteration on shunning conflict and reaching a consensus through dialogue reflects the public's frustration over a political environment driven by vitriolic hatred of political rivals. He has mentioned the need for a "tolerant" democratic system as well as practices that align with democratic norms and the constitution. He pointed out that without democracy, development could never be universal; rather, it would be individual or group-centric.

The president aptly referred to Bangabandhu's role in 1973 during the first parliamentary assembly in talking to the speaker to facilitate opportunities for the opposition parties to speak when they wanted to. What the president was referring to was the courteousness and willingness to listen to opposition parties, no matter how different their ideologies may be. Constructive criticism ensures overall public welfare, which is the main goal of any parliament. Making democratic institutions stronger, ensuring that only democratically elected leaders represent the people in parliament, and guaranteeing its accountability to them are the other salient points of his speech.

The president, being a former speaker himself, has the experience and moral authority to make such statements that may seem standard remarks appropriate for a golden jubilee. But they are meaningful as they are cautionary in our current volatile, uncertain political environment. It is also an attempt to awaken the lawmakers to the jarring reality of just how weak and dysfunctional the parliament has become.

With virtually no real representation of the opposition, the parliament has become a one-sided forum where a large part of the session is devoted to laudatory iterations of the ruling party's achievements or tirades against opposition parties. In those rare moments when an opposition member has raised a contentious point that alludes to the accountability of certain government agencies and institutions, there has hardly been a debate on the issue, least of all any consensus regarding an investigation into the allegations.

The president's appeal to shun conflict and embrace dialogue is crucial not only within the parliament but outside it, too. For an effective parliament, many reforms are needed, such as an end to opposition boycott of the assembly (as practiced by both AL and BNP lawmakers on different occasions), allowing debate and consensus building among treasury and opposition benches, an empowered opposition bench, more representation of women MPs through direct election, a neutral speaker, empowered standing committees, a well-staffed secretariat, and so on. But the first step towards a functional parliament is unquestioningly a free and fair election, which will bring about lawmakers who truly represent the people in the house.

Each district hospital must have an ICU

Govt should address lack of progress in project on setting up district-level ICUs

It is disheartening to know that a project undertaken to set up Intensive Care Units (ICU) in district hospitals has seen little progress even as it nears its deadline three years on. If executed with the same zeal that it was initiated with in April 2020, the Tk 512 crore initiative would have delivered 10-bed ICUs in 43 district hospitals and 10 medical college hospitals by now. Instead, as per our report, not one of the facilities earmarked under the project yet have a functional ICU. This is totally

Government projects missing deadlines at the expense of inflated bills may have been normalised in Bangladesh, but not all projects can be treated similarly. The ICU initiative was meant to fill a big void in Bangladesh's health sector where district hospitals hardly have any ICU, forcing patients to seek life-saving treatment in faraway hospitals braving an arduous journey. Often, we come across reports of critically ill patients dying in ambulances while on their way to Dhaka or other divisional centres. So when the PM ordered setting up an ICU in every district hospital in early 2020, it was seen as a response as much to the then-raging pandemic as to a crisis that long predated it, and one had hoped that project officials would be sincere in following it through given its huge potential impact.

The extent of their failure becomes clear when you consider that only facilities that already had the infrastructure suitable for ICUs had been chosen under the project. The ground was already prepared. Why the long delay then? When approached for comments, the project authorities conveniently cited difficulties in opening letters of credit (LC), the devaluation of taka against the dollar, and supply-chain issues caused by Russia-Ukraine war. These problems alone cannot account for the fact that they couldn't operationalise a single ICU in three years. Experts say that ICUs are not difficult to set up. The most crucial aspect of it is the oxygen bank, which can be created within months. Overall, it shouldn't take more than two to three months to launch the operation of an ICU.

The only plausible explanation for the delay then is negligence and indifference to public suffering. One cannot also rule out corruption in procurement and other aspects of the work, with the project authorities now asking for an additional Tk 301 crore fund to complete it. The question is, how long must citizens suffer for the indifference, incompetence and corruption of officials and those associated with our largely unaccountable government projects?

We urge the planning ministry to investigate the failure of the ICU project before any request for deadline/budget revision is entertained. Those responsible for its lack of progress must be held accountable. For critical patients, an ICU makes the difference between life and death. So the government must take urgent steps to get the project back on track, and ensure that all 64 district hospitals are properly equipped to serve critical patients.



The importance of learning in one's mother tongue

Language is not only important for communication, it is also a tool for intellectual and mental development. Research shows that education in one's mother tongue is a key factor in improvement of learning outcomes and academic performance. This is crucial, especially in primary school, to avoid knowledge gaps and increase the speed of learning and

comprehension. On the other hand, research has shown that children getting education in a language other than their mother tongue suffer from a disadvantage. The benefits of mother tongue in education are so great that the World Bank, when it measures "poverty in education", uses the percentage of recent primary school graduates who can read and learn at a specified level in their mother tongue as a measuring stick.

Conversely, the medium of instruction being any language besides the mother tongue fails to offer the beneficial effects of learning and child development. Unesco says that large segments of the world population suffer from a lack of opportunity for schooling in their mother tongue. Unesco estimates that about 400 million children all over the world are disadvantaged because barrier to learning wherever possible. In Bangladesh, in recognition of this hindrance, communities like the Chakma, Garo, and others use their mother tongue up to the primary level. The government already has a curriculum approved and supplied for these communities.

In Bangladesh, we are fortunate that the mother tongue of most people is Bangla, a well-developed language spoken by over 300 million people all over the world. Yet, our country has a peculiarity in its education system, with English being a prioritised medium of instruction.

We do not have any estimates of how many Bangladeshi Banglaspeaking children are undergoing education with English as a medium of instruction. But whatever the number, do their parents know that they are putting these children at a disadvantage in terms of learning and development?

English in our country has the legacy of a colonial past. The British introduced English in colonised India with the explicit intention of making the people of the region anglophones and even anglophiles. The British colonial past has not only imposed the language on us, it has also spawned a "mindset" which has been lethal. We could not shake off English after independence from British rule in 1947.

After Bangladesh's independence in 1971, the government decided to have Bangla medium education at all levels, including the tertiary

of this. That is why attempts are level. It was an emotional moment being made worldwide to redress this in the history of Bangladesh, and also a period of turmoil when education plunged into disarray. The consequent disruption to the public education system caused alarm in the country. In the absence of a definite plan by the government, the competent enough for an English intelligentsia failed to come out with its own action plan to mitigate the shortages of suitable books in Bangla for tertiary education.

In the meantime, the privileged classes of society moved towards setting up private institutions. This tendency rapidly evolved into the promotion of English medium schools. The government remained unresponsive to the rise of a private system of education and allowed it to grow uncontrolled. English medium schools, with the patronage of the elite and privileged, grew rapidly in Dhaka and other metropolitan areas. Even middle-class parents started sending their children to private English medium schools, at costs they could ill afford.

Then, regrettably, the government joined the English bandwagon by having the national curriculum and textbooks translated into English and encouraging yet another stream of school education.

What is prompting this rush towards English medium education? What is the rationale behind this? What are the benefits?

The rush comes from a societal perception wrongly created by equating the benefits of English language skills with the medium


English if a student follows the public education system in Bangla is totally overlooked. English introduced in Class V, followed by seven years of English learning between Class VI and Class XII, should be enough to make the student capable and education at the tertiary level. This is not a myth. This was true in the 1960s: there is no reason why, with far more opportunities for learning English today, students will not become proficient in the language.

What is happening to the children getting their education in English medium institutions? In actuality, parents are putting these children in great difficulty, making them learn through a language that is not their own. A segment of children educated in English medium may catch up in learning over time, but this likely will not happen for all students, putting them in jeopardy for future opportunities in life.

If we look at the outcome in tertiary education, we do not see a large presence of English medium students in public universities that by far maintain a higher standard of learning than the private universities in Bangladesh. English medium students prefer to go to private universities where admission is easier and competition for high grades is lower. Middle-class and poor parents continue to go through financial miseries because of the high costs of English medium schools and private universities. By confusing English proficiency with English as a medium of instruction. The fact that it is of instruction, parents are doing a entirely possible to be adept in disservice to their children.

In search of a happier Bangladesh

the Great met the great philosopher Diogenes and asked if he could do anything for the sage. Diogenes didn't ask anything of the king; rather he tartly told the commander not to block the sunlight which the philosopher was basking in. The hermit conveyed to the ruler that he shouldn't take away anything from the public which he can't deliver to his citizens.

Enjoying basic natural rights is the first principle of happiness, and that instantly justifies why Afghanistan turned out to be the unhappiest nation on the planet. It also tells us why Finland, Denmark, and Iceland – the three most reputed welfare states occupied the first three places in the happiness index devised by a pool of experts under the guidelines of the United Nations.

The World Happiness Report 2023 has placed Bangladesh in the 118th position out of 137 countries. Surprisingly, Bangladesh's ranking was 94 in last year's report and has been corruption. downgraded by as many as 24 places, sparking both curiosity and concern unhappy, a conclusion we can make as to why it happened. Some critics by comparing the World Happiness are labelling it as the government's Report 2023 and the Corruption failure, while some others are trashing the report outright as "a Western plot to malign Bangladesh."

Some discard it by arguing that happiness is a personal aspect and it can't be measured as a social indicator. That's not true. The price behaviour, which is measured at the individual level in microeconomics. can also be quantified at the state level in macroeconomics. We measure social psychology while it is initially studied at the individual level.

That is why the UN panel of experts has outlined six criteria to measure happiness at the national level: 1) per capita income; 2) social support; 3) healthy life expectancy; 4) freedom to make life choices; 5) generosity; and 6) corruption. Hence, the yardstick is the combination of both quantitative and qualitative aspects. For example, income and health indicators can be expressed in numbers, while elements like freedom, social connectedness, generosity, and corruption are perception-based, leaving some room for argument. But the UN

Once, the Greek conqueror Alexander social scientists have explained the methodology of how they handled each of the qualitative factors. Yet, blaming the ranking as an act of conspiracy against any nation won't convince the audience by any chance.

> Of course, some rankings may seem anomalous to some readers. Seeing Pakistan (108th) ahead of Bangladesh (118th) in the World Happiness Report at a time when Pakistan is grappling with an acute reserve shortage as well as food and fuel crises may seem odd to many. But these recent phenomena are likely to be reflected in the next report. In last year's report, Pakistan ranked much below at 121st, while Bangladesh's position was 94th, creating no doubt to any critics or sceptics. This year's positions for these two countries are not statistically too different. Any position beyond 100 requires the respective governments to address why social happiness scores are so poor. And the single most dominant factor is the level of

> Highly corrupt nations are highly Perception Index 2022, where Pakistan ranked 140th and Bangladesh 147th. The happiest countries like Denmark, Finland, and Iceland have the least amount of corruption as they rank 1st, 2nd, and 14th in the Corruption Perception Index. So, it would be a wake-up call for the government to crusade against those public officials involved in rent-seeking tasks, lawmakers engaged in bribes, police members involved in unethical practices, businessmen wilful defaulters, high-scale money launderers, and political pollutants. The outgoing president acknowledged corruption as the main obstacle to progress.

> The government is engaged in development projects one after another. But the positive sentiment is outweighed when people can sense the presence of massive corruption in most public works. People feel unhappy when they see that no big-scale money launderers and wilful defaulters have even been touched at all. The criminals who victimise children, girls, women

or minorities are sometimes arrested. but rarely followed up with exemplary punishments. The drivers with fake permits and unfit vehicles keep on committing murders on the streets and highways, but are rarely caught or sent behind bars.

The spectacle of the tardiest possible judiciary, the drought of law enforcement, and the culture of massive impunity for the powerful make the helpless majority frustrated, demoralised, and disdainful. In this situation, the enthusiastic claim of a spike in per capita income by the finance ministry can't make the ordinary people cheer at this creditworthy message. That's why economic achievements on the one hand and the ever-growing financial turpitude on the other hand can't make people smile unconditionally. If a UN official approach them by asking, "Are you happy?" they say, "No." Corruption damages any gain in happiness, throwing the country into a lower rung of the ladder, and thus defaming the nation.

Some may argue that Bangladesh's position at 118th seems to be a mistake while Nepal's position in happiness is 78th, because Bangladesh is more prosperous than Nepal. Herein comes the question of rational expectations originally proposed in the early 1960s by the American economist John Muth. Given the differences in historical perspectives, geopolitical settings, and economic advancements between them, the level of expectations by Bangladeshi people are likely to be higher than that in Nepal, whose per capita income is less than half of Bangladesh's. Also, the low level of corruption in Nepal is a factor why it's happier than Bangladesh.

The Bangladesh government has to devise ways to make the country advance on the ladder of happiness because it is the ultimate objective of any ruler serving the country. Bangabandhu embarked on his second revolution in search for a happier Bangladesh. Anyone believing in his ideals must be serious to research on how to make citizens happier. The unemployment rate is now higher than at any time in the past. Megacities like Dhaka and Chattogram are simply unliveable. They are surcharged with sound pollution, toxic air, uncouth landscape cluttered by political posters, and one of the highest levels of congestion in the world. When the residents of these cities are interviewed on happiness by surveyors, saying that "they are happy" would be a parody of truth and travesty of justice. Those in power can do a lot to address these issues towards the task of making a happier Bangladesh.

Trump's arrest adds fuel to fire in hyperpolarised US

It's not just the Democrats in the US who are looking longingly at former US President Donald Trump's arrest. A substantial number of Republican Party supporters are also hoping Manhattan District Attorney Alvin Bragg will be able to do what everybody else has been unable to do till now: Put the flamboyant former president behind bars and remove his disruptive and destructive presence from US politics once and for all.

Well, good luck with that.

Trump's arrest, ironically, has added rocket fuel to his incendiary campaign to win the Republican nomination for the 2024 presidential elections. Trump is playing the victim card for all it's worth, and his detractors are beginning to realise that Trump isn't going anywhere soon.

Heavens knows there is a great deal to dislike about arguably one of the most outrè political figures in the Western world. Most politicians play fast and loose with facts, but Trump is in a class all by himself. What is far worse, Trump's uninhibited race-baiting, xenophobia and all-round coarse, pugilistic fact-free diatribes have done permanent damage to US political discourse. Racism, meanspirited demonisation of political opponents, once implicit in dog whistles, are now bandied about with a bullhorn.

Porn star, hush money payment through thuggish hatchet man and felon Michael Cohen, covering up of salacious stories in the gaudy periodical National Enquirer the case against Trump has all the hallmarks of a tawdry tabloid scandal. Herein lies the case's

The arrest and attempted conviction of a prominent political figure is a portentous, serious matter. The case against Trump is sordid, but does it rise to the level of a crime? Some legal analysts not all of them Trump supporters – appropriately be a misdemeanour.

There are several consequences that follow from this. The first, evident from the cries of outrage of Republicans, is that all of this can be presented as a political witch-hunt. Trump has forced the US to confront a fraught political dilemma: How to balance the need togoafter an ex-president suspected of serious legal malfeasance against the risk of opening up a Pandora's box of frivolous lawsuits against political enemies. The Republican of congressional attempts investigations against Democratic enemies provide a foretaste of that though the fact that they are not making much headway provides some measure of assurance that frivolous attempts will often fall by

The immediate aftermath of Trump's arrest brings the former president back to the place he likes best – the centre of all attention. Now, doubtless to his utter delight, it's all about Trump.

As the campaign for US presidential elections is about to begin in earnest, we are back to square one. As the US baseball star Yogi Berra once said: "It's déjà vu all over again."

In 2015, when Trump stepped down the escalator of Trump Tower in Manhattan to announce his presidential campaign, Democrats

his star shone brightly for a while. Polls of Republican voters showed him outperforming Trump. Soon, however, Trump's double-digit lead reasserted itself and Trump now rules supreme.

For decades, the Republican Party has championed the politics of white grievance and outrage, casting political differences not so much as matters of policy rather than an existential battle against the evil Democrats

Media mogul Rupert Murdoch, the éminence grise of parts of right-wing US media, has soured on Trump, but the ratings gods demand he change his mind fast - and signs are that Fox News is doing exactly that.

For decades, the Republicans style of take-no-prisoners, hatefilled partisan politics vielded considerable political dividends. Then Trump came along and made this politics his very own. The result has been an even more toxic brand of partisan politics that has given rise to a party too driven by hatred of the perceived control of the liberal establishment to engage substantively in policy or governance.

Republicans are locked in a Faustian embrace with Trump, and the arrest is likely to make that embrace tighter.

DID YOU KNOW? Flu can trigger a heart attack, Dutch study suggests

STAR HEALTH DESK

Individuals diagnosed with flu are six times more likely to have a heart attack in the week after testing positive for the virus, according to a Dutch study published in The New England Journal of Medicine (NEJM) and being presented at the European Congress of Clinical Microbiology & Infectious Diseases (ECCMID 2023, Copenhagen, 15-18 April), underline the importance of vaccination and awareness of heart attack symptoms among flu patients and those treating them.

The study used results from 16 laboratories across the Netherlands and death and hospital records to produce a more complete picture. Of the 419 heart attacks, 25 were in the first seven days after flu diagnosis, 217 within the year before diagnosis and 177 in the year after flu diagnosis (not including the first seven days). Around a third of the individuals (139/401) died, of any cause, within a year of being diagnosed with flu. The researchers calculated that the individuals studied were 6.16 times more likely to have a heart attack in the seven days following a flu diagnosis than in the year before or after.

The influenza virus is known to increase the coagulation of blood and weaken fatty plaques that have built up in the arteries. If a plaque ruptures, a blood clot can form, blocking the blood supply to the heart and causing a heart attack. The researchers recommend strategies to prevent influenza infection, including vaccination, as well as advocating for a raised awareness among physicians and hospitalized flu patients for symptoms of heart attacks.

The World Health Organisation (WHO) was founded on April 7, 1948 with a mission to promote global health and ensure the highest level of health and wellbeing for everyone. This is why April 7 is observed World Health Day every year. WHO has achieved significant milestones over the years, such as the discovery of antibiotics, the development of vaccines for polio, and the establishment of the first International Health Regulations.

In the early years, WHO focused on mass campaigns against diseases like tuberculosis, malaria, yaws, syphilis, smallpox, and leprosy. WHO also created special programs like the Special Programme of Research, Development, and Research Training in Human Reproduction and the Special Programme for Research and Training in Tropical Diseases, which contributed significantly to the elimination of several diseases.

In 1978, the International Conference on Primary Health Care set the goal of "Health for All," paving the way for WHO's call for universal health coverage. WHO launched Global Diarrhoeal Diseases Programme with Oral rehydration salts (ORS) in the same year, reducing annual deaths from diarrhoea in children under five from 4.6 million to under 365,000 by 2019.

WHO successfully eradicated smallpox in 1980 and endorsed the International Code of Marketing Breastmilk Substitutes in 1981 to promote breastfeeding. By 2022, 75% of countries had adopted legal measures to implement the Code's provisions, leading to a 50% increase in the percentage of exclusively breastfed

In 1988, the Global Polio Eradication Initiative was launched, reducing polio incidence by over 99% by 2022. WHO's priorities shifted with the discovery of the Human immunodeficiency virus (HIV) in 1983 and the licensing of the first

antiretroviral medication in 1987.

The Integrated Management of Childhood Illness (IMCI) strategy was launched in 1995 to reduce global child mortality by 15%, and levonorgestrel emergency contraception was approved in over 100 countries in 1998.

The Global Alliance for Vaccines and Immunisation (now Gavi) was established in 1999 to improve access to vaccines, and the Millennium Development Goals (MDGs) aimed to reduce extreme poverty and included specific health goals.

In 2020, the Access to COVID-19 Tools Accelerator (ACT-Accelerator) partnership was launched to accelerate the development, production, and equitable access to COVID-19 tests, treatments, and vaccines.

In 2021, HIV treatment coverage reached 28.7 million people, a ground breaking malaria vaccine for children was recommended, and tuberculosis prevention and care saved over 74 million lives since 2000. A study has unveiled this personality type that shares similarities with even psychopaths or may prove to be even more dangerous. Dark empaths may be further dangerous as they can control and manipulate others by using their feelings against them. The victim may be left questioning their own feelings, thoughts, and behaviours while believing they are at fault. Dark empaths may also be even harder to identify than a narcissist.

A dark empath can be someone who uses cognitive empathy at the expense of others, often for individual gain. Cognitive empathy is one of three types of empathy outlined by psychologists. By definition, dark empathy is a trait describing someone who understands another's emotions but can not feel them. People with dark empathy could use gaslighting and charm to manipulate the people close to them.

We need to distinctly clarify the differences between empathy and loving kindness - they are two separate notions. Empathy is the ability to understand and relate to another person's feelings, while loving-kindness is an active wish for the well-being of others. Undesirably, for those who have never heard of dark empathy, according to a study, it is more common than we may think. Some suggest that it is related to narcissism as a part of the "dark triad" (narcissism, Machiavellianism, and psychopathy).

Arsenal hope to end 10-YEAR ANFIELD CURSE

Arsenal manager Mikel Arteta is preparing his players to take their Premier League title charge to the Anfield "jungle" as they look to end a marathon winless run at the home of Liverpool.

Arsenal have not won at Anfield in the Premier League since their 2-0 victory in the 2012-13 season - a game in which Arteta himself played for the north London club. Since then they have suffered heavy defeats, including two 5-1 losses.

The north London club were in the contest last year before Arteta's touchline spat with Liverpool boss Juergen Klopp fired up the home side who ran out 4-0 winners. Before that game in November 2021, Arteta used a quirky method to try to prepare his players for the atmosphere at Liverpool by playing 'You'll Never Walk Alone' - the Reds' supporter anthem - on a sound system at the training

"You cannot train the players in the zoo and then go to the jungle on Sunday," Arteta told



reporters on Friday.

"It's impossible. You have to expose yourself. You have to prepare the players. You have to tell them what they're going to be facing and you have to recognise that.'

Despite Liverpool's inconsistent form this season, which has kept them eighth in the league standings, the Merseyside club still have an excellent record at home - Leeds United are the only side to beat them there so far in the this season.



Arteta said his side are enthusiastic ahead

of Sunday's clash with Liverpool as Arsenal look to maintain their eight-point lead over Manchester City in the title race. "We know that we have a big challenge, but

I see a big opportunity to go to Anfield and do something that we haven't done for many vears." Arteta said. "That's what is driving the team in the last few days.'

"We've been in a few grounds that we haven't won in 17, 22 years and we've managed to do that. So we're capable of doing it."

We have to fully embrace it and go for it, it's a chance to go to Anfield and do something we haven't done for many years... It's a different group coming from a different position. What we need to have is courage - on Sunday we'll try to be that team."

Arsenal have struggled to score at Anfield on their last few visits and Arteta said he was glad to have January signing Leandro Trossard in the side, with the Belgian netting a hat-trick for Brighton & Hove Albion at Liverpool earlier



PUBLIC UNIVERSITIES

Racked by ragging

UGC yet to formulate any policy to stop the menace

In the absence of a policy to act as a deterrent, ragging goes on unchecked at some public universities, as the authorities concerned seem indifferent to the need for curbing the

"Ragging" is a term used for the socalled "initiation ritual" practised at higher educational institutions. It involves humiliation and harassment -- of freshers or room are". juniors by senior students, and takes a heavy toll on the victims.

Academics and rights activists have long been calling for an anti-ragging policy for the universities with a clear definition of the word "ragging" and strict punishment for the offenders. This will help the university authorities to act quickly in case of such incidents.

However, the University Commission (UGC) is vet to formulate any such policy. As a result, offenders, mostly from pro-ruling party student body Chhatra League, continue to rag freshers at different

The UGC is the apex body of all the affiliated public, private and international universities in Bangladesh. It is meant to ensure the quality of higher education throughout the

Taking advantage of seat crises at halls, university BCL activists "arrange" seats for freshers at "gono rooms", where they rag the entrants. According to students and teachers, the offenders do the same thing in the "guest

Gono rooms are run by the pro-ruling pro-ruling party student body."

party student body to accommodate mostly freshers who could not get a seat at the hall. As a result, 30-35 students are crammed together in a room big enough for only eight

Meanwhile, the guest room is officially meant to be a waiting room for visitors. However, at various public universities, BCL activists have been forcing freshers to come to the respective guest rooms, where seniors "teach the juniors how to honour them, and psychological and physical torture -- abuse, where their places at the dining hall or TV

> In many cases, those who would fail to follow their diktats or are absent at political

> programmes, are punished in the guest room. Mohammad Tanzimuddin Khan, professor of international relations at Dhaka University, said the issues of seat crisis and violence, bullying, ragging, sexual harassment, and other crimes by pro-ruling party student podies on campuses are all linked.

> "As the hall authorities do not play their due roles, students don't get seats [at halls] based on needs or even merit. As a result, they [freshers] become hostage to the whims of the

According to the UGC, 55 percent of the students at Dhaka University do not have access to hall facilities due to seat crisis. The situation is the same for 76 percent of the students at Islamic university, 78 percent at Shahjalal University (SUST), and 68 percent at Hajee Mohammad Danesh Science and Technology University (HSTU).

In all these four universities, freshers have had to face ragging even recently.

The issue of ragging came back to the fore after Phulpori Khatun, a first-year student, was tortured by some BCL leaders and activists at the Deshratna Sheikh Hasina Hall at Islamic University.

Phulpori on February 14 alleged that BCL leaders, including Sanjida Chowdhury and Tabassum Islam, tortured her on the night of February 12 for staying at the hall without their "permission".

This is no isolated incident.

On January 26, a first-year non-residential student of DU's Bijoy Ekattor Hall was physically tortured for being absent at BCL's guest room meeting. Following a written complaint by the

victim, Akhtarul Islam, the hall authorities suspended three students from the dormitory for their involvement in the incident.

Rivad Hasan, a fresher at the architecture department, left HSTU on February 22, two weeks after submitting a written complaint to the university administration about being

Just two days before that, some seniors of the business administration department of SUST ragged around 10 to 13 freshers at Syed Mujtaba Ali Hall.

Runaway black hole creating trail of new stars **Scientists say**

A huge black hole is tearing through space, leaving behind a 200,000-light-year-long trail of newborn stars, space scientists said.

The supermassive monster -- likely born of a bizarre game of intergalactic billiards - is rampaging through the blackness and plowing into gas clouds in its path.

The incredible forces at play mean this gas is being forged into a contrail of new stars, which have been captured on camera by NASA's powerful Hubble Space Telescope.

"We think we're seeing a wake behind the black hole where the gas cools and is able to form stars," said Pieter van Dokkum of Yale University.

"What we're seeing is the aftermath. Like the wake behind a ship, we're seeing the wake behind the black hole."

Researchers believe gas is probably being blasted and warmed by the motion of the black

"Gas in front of it gets shocked because of this

supersonic, very high-velocity impact of the black hole moving through the gas," said van Dokkum.

The black hole weighs about the same as 20 million of our Suns.

Israel mobilises reserves after deadly attacks

EU condemns attacks, urges restrain

Israel began calling up police and army reservists yesterday separate attacks killed three including people, an Italian tourist, in Tel Aviv and the occupied West Bank. The European

Union condemned the attacks in Israel and a barrage of rockets fired from Lebanon that triggered Israeli strikes and called for "restraint".

"The EU expresses its total condemnation of these acts of violence. This must cease," the bloc's foreign policy chief Josep Borrell said in a statement vesterday

Borrell condemned

"indiscriminate" rocket fire from the Gaza Strip and Lebanon. Despite appeals restraint,

including EU, violence has surged since Israeli clashed police Palestinians with inside Jerusalem's

flashpoint Al-Aqsa mosque on Wednesday, with Israel bombarding both Gaza and Lebanon in response to rocket fire by Palestinian militants.

The Italian was killed and seven other tourists wounded when an Israeli Arab ploughed a car into pedestrians on the Tel Aviv seafront on Friday evening and flipped over before being shot dead, police and emergency services said.
