Roadworks, bottlenecks, breakdowns can ruin it

STAFF CORRESPONDENT

Ongoing road development work may lead to severe congestion between Dhaka and Gazipur on Dhaka-Mymensingh highway and Elenga and Hatikumrul on Dhaka-Rangpur highway during the Eid rush.

On top of this, nonautomated toll collection at Padma, Meghna, and Bangabandhu bridges and the Dhaka-Mawa-Bhanga expressway could cause long queues.

Traffic could grind to a halt due to breakdowns of rickety, unfit vehicles and crashes caused by the large number of motorbikes that will be on the highways.

Unlike the last Eid-ul-Azha, the government will allow bikes on highways, but not on the Padma

AL to go for fresh picks in Gazipur, Sylhet

Undecided on Barishal; incumbent mayors of Rajshahi, Khulna likely to get AL tickets

The mayors of Khulna and Rajshahi cities are likely to get Awami League nominations to run for mayor in the coming elections.

In Gazipur, Azmat Ullah Khan, the city AL president, may be nominated by the party, while in Sylhet, Anwaruzzaman Chowdhury, who recently returned from the UK, may get the AL ticket to run for

In Barishal city, Mayor Serniabat Sadiq Abdullah has recently been asking people for blessings. But the AL may not nominate him this time around, sources in the party say.

His uncle Abul Khair Abdullah collected a nomination form, and he has a greater chance of getting the party ticket, they add.

Current Rajshahi city Mayor AHM Khairuzzaman Liton told The Daily Star vesterday that he met AL President Sheikh Hasina at her Sangsad Bhaban office and got the green light from her.

"I will collect the nomination paper tomorrow [today]," he added. It is common knowledge in political

circles that Khulna Mayor Talukder

Abdul Khaleque is going to get the AL nomination again.

Sheikh Salahuddin Jewel, lawmaker of Khulna-2, recently named Khaleque as the party candidate. Khaleque's nomination form was collected from the AL chief's political office in the capital's Dhanmondi by AL Organising Secretary (central) SM Kamal Hossain. As of yesterday, no one else from Khulna has collected the form.

In Sylhet, Anwaruzzaman, AL general secretary in the UK, has been meeting people and asking for "blessings' in the race for mayor.

He also met the prime minister yesterday, and later said the AL "highcommand asked me to work for Sylhet".

AL sources say the party is in a dilemma over who to choose for Gazipur City Corporation.

Suspended Gazipur Mohammad Zahangir Alam, acting mayor Ashadur Rahman Kiran and Gazipur City AL President Azmat Ullah Khan are in a race to get the nomination.

But none of them collected the nomination form after the AL started selling nomination forms yesterday.

One hundred and twenty eminent citizens yesterday said that the demand for cancellation of the Prothom Alo declaration is an attack on freedom of the media and journalism.

The statement goes on to highlight that the charges against Prothom Alo and its reporter Samsuzzaman Shams are still

sub-judice and unproven. No group that respects democracy, human rights, and free thought can support such an attack on the media, the

They called upon people from all professions to be vocal for ensuring freedom of the media.

BANGABAZAR FIRE Burning cigarette or mosquito coil possible cause Says DSCC probe body

Investigators of Dhaka South City Corporation suspect a burning cigarette or a mosquito repellent coil caused the devastating fire at Bangabazar Shopping Complex in the

They also said the fire might have started somewhere between Adarsha and Mahanagar markets of the complex on April 4. The investigators, however, ruled out an electric short circuit as a cause of the fire.

The fire destroyed around 3,000 shops and readymade garments stored in them to ashes. Shop owners' leaders claimed that goods worth around Tk 1,0 $\hat{0}$ 0 crore were lost.

The eight-member probe committee of DSCC was supposed to file its initial report vesterday after talking to security guards, traders, shop owners, employees of the markets, and witnesses.

Several members of the committee, seeking anonymity, said the fire broke out in an embroidery factory on the second floor of Adarsha Market, adjacent to the Mahanagar Market.

They added that there was no electricity distribution box near the factory.

Except for a few places, the entire complex's power supply was turned off, they said, adding that electricity supply of the two markets was also out from 11:00pm to 7:00am.

Heatwave sweeps parts of country

UNB, Dhaka

People in different parts of the country are experiencing a sweltering heatwave with the mercury soaring to 37.4 degrees Celsius in Dhaka yesterday.

The country's highest temperature 38.5 degrees celsius was recorded in Chuadanga.

Day labourers, rickshaw pullers, farmers, and others who generally work outdoors are finding it challenging to continue working under the intense heat of the sun.

Animals and birds are also restless and struggling in the scorching heat.

According to a Met office bulletin, mild to moderate heatwave is sweeping over Dhaka, Khulna, Barishal divisions and Rajshahi, Bogura, Pabna, Moulvibazar, Chattogram, Rangamati, Chandpur, Noakhali, Feni, Cox's Bazar and Bandarban districts.

Day and night temperatures may rise slightly over the country, it said.

Meanwhile, the Khulna region is currently experiencing temperatures between 37 and 38 degrees Celsius, which is causing great discomfort to workers and animals alike.

As the day progresses, the temperature keeps rising, making it unbearable for people to move around in the scorching heat.

Three killed in truck-pickup collision

Three people were killed in a collision between a pickup and a truck in Jamalpur's Melandah upazila last morning.

The deceased were identified as Shah Alam, 35, Chanchal, 32, and Kajol, said Delwar Hossain, officer-incharge of Melandah Police Station.

Police and locals told The Daily Star that the driver of the Dewanganjbound pickup van lost control over the vehicle and collided head-on with a Jamalpur-bound truck in Malancha on the Jamalpur-Dewanganj highway around 7:30am.

Two people died on the spot while another was declared dead on arrival at the Melandah Upazila Health Complex, said the OC. Among the deceased, two were

Russian missiles hit southeast Ukraine

France denies presence of its soldiers in Ukraine

50-year-old man and his 11-year-old daughter were killed after Russian missiles a house in the southeastern Ukrainian city of Zaporizhzhia, officials said yesterday.

The girl died in an ambulance, said the head of Zaporizhzhia City Council, Anatoliy Kurtiev.

Rescue workers pulled the girl's 46-yearold mother alive from under the rubble.

Her elder daughter was not at home when the Russians struck at night, the State Emergency Service said.

Kurtiev said two Russian missiles struck a residential building, adding that windows and roofs were damaged in dozens of neighbouring houses, reports AFP.

EMBASSY REOPENING Delegation set to visit KSA: Iran

Iran's foreign ministry said yesterday a delegation will visit Saudi Arabia by Friday to pave the way for reopening its diplomatic missions there following a similar move by Riyadh.

The announcement comes a day after a Saudi delegation arrived in Tehran on a similar diplomatic trip, and follows a historic meeting between the two Gulf countries' foreign ministers in China.

"We are expecting a foreign ministry delegation to visit Saudi Arabia" by Friday, Deputy Foreign Minister Alireza Enavati said in an interview with state television.

"Two separate delegations will go to Riyadh and Jeddah", ahead of reopening Iran's embassy and consulate respectively.

Saudi Arabia severed relations with Iran in January 2016, after its embassy in Tehran and consulate in the northwestern city of Mashhad were attacked by protesters demonstrating over Riyadh's execution of opposition Shia cleric Nimr al-Nimr.

BNP leader Dulu indicted in tax evasion case

A Dhaka court yesterday framed charges against BNP leader and former deputy minister for land Ruhul Kuddus Talukder Dulu in a case filed for dodging Tk 10 lakh in income taxes.

Dulu, now on bail, pleaded not guilty after Md Akhtaruzzaman of Dhaka Special Judge Court-2 read out the charges to him.

Earlier, the judge dismissed the petition submitted for discharging the accused from the charges of the case, said Dulu's lawyer Taherul Islam Tauhid.

The judge fixed May 14 for starting the trial of

On August 3, 2008, the National Board of Revenue (NBR) Assistant Tax Commissioner Hafiz Al Asad filed a case against the BNP leader.

NBR said Dulu evaded more than Tk 10 lakh in income taxes from his income of Tk 23,437,501 he earned since 1983.

Dulu gave false information about his real income and expenditure to the income tax department, the complainant added.

Experts for repealing DSA to salvage press freedom

Experts at a workshop yesterday demanded the annulment of the Digital Security Act to ensure press freedom and human rights.

News Network organised the programme with the support of Internews and EngageMedia at the NGO Forum's Training Hall in the city's Lalmatia

At the programme, Rezaur Rahman Lenin, a researcher, human rights activist and legal expert, said a total of 1,129 cases were filed under the DSA from October 9, 2018, to August 2022.

Of them, he said 301 cases were filed against politicians while 280 were against journalists and 157 against teachers and students.

Though the abuse of the DSA is growing alarmingly, he said the government is not serious about amending this law. Besides, amending the law alone will not suffice to deal with the issues it raises.

Pabna constable suspended for assault

A police constable was suspended yesterday for assaulting a man with an iron rod over a trivial matter in Pabna's Chatmohar upazila.

The victim Mokbul Hossain Pramanik, 35, of the upazila's Haripur union, was admitted to the upazila health complex with a head injury.

Sirajul Islam, a constable of Chatmohar Police Station, rents a house from Sobed Ali of village Chowdhuripara.

Mokbul, Sobed's brother, oversaw construction work that was being done around the house.

On Saturday, Mokbul asked Sirajul to move his bike from the construction area, which enraged Sirajul and at one point he attacked Mokbul.

Additional Superintendent of Police Masud Alom said a departmental inquiry was underway in connection to this incident.

The government is turning the 190km Gazipur-Elenga-Hatikumrul-Rangpur highway into a four-lane highway. The Bangabandhu Bridge approach road in the east has two lanes, which could become a bottleneck.

Project Director Waliur Rahman said vehicles heading north will use the main road while Dhaka-bound vehicles will use a bypass from Bangabandhu Bridge.

"We got good results with this initiative during the last Eid-ul-Fitr rush. But a large number of unfit vehicles breaking down blocked the road before Eid-ul-Azha," he told The Daily Star vesterday.

Proper traffic management is the key, he said, adding that 14km out of the 19km Bangabandhu Bridge approach road in the west is already

Cumilla Deputy Commissioner Mohammad Shamim Alam said the

server for Daudkandi Toll Plaza goes offline occasionally. "If such an event occurs during the rush, it will create a huge problem. I request preparations so that the toll can be collected manually if needed," he said.

Ílias Kanchan, chairman of Nirapad Sarak Chai, a platform working on road safety, said, "It is possible to curb road crashes if the number of unfit vehicles can be reduced.'

Jativa Press Club President Farida Yesmin also said road crashes would not reduce until the authorities pay more attention to the fitness of vehicles. A record 5.42 lakh registered

vehicles, which should have renewed their fitness certificates, did not do so as of October 15 last year. Khandaker Enayet Ullah, secretary

general of the Bangladesh Road Transport Owners' Association, said it was not possible for the association to track unfit vehicles. He requested the BRTA to give the

local administration and the police a list of such vehicles for taking action. He said many garment workers hire buses to go home during the holidays

Quoting security guards of the complex, the investigators said there was electricity in only the living spaces for the guards, the mosque, and the office of the complex. Wi-Fi access points were on, they added.

Investigators said there was a room for security personnel to stay on the roof of the Adarsha Market. The embroidery factory and a warehouse were beneath the room.

Politics devoid of passion now

JP lawmaker tells parliament

Jatiya Party lawmaker Kazi Firoz Rashid yesterday told parliament that politics is now just a profession, not a result of passion, as it was in the past.

"Before, people used to do politics for the passion, but it has just become a profession now," he said.

Firoz mentioned that politics is the only way to change one's life overnight. "Earlier, people risked their lives to do politics, because of passion." During the Pakistan era, he recalled that if a man was involved in politics, he could not marry, because he would not get any job.

Besides, he claimed that the parliament has many achievements along with weaknesses.

Till date, it has not been able to form a commission [on Bangabandhu's murder]. If the nation cannot know who was involved, there is no point in keeping a fragment of history. Bangabandhu was killed through a huge conspiracy; it's not like Dalim, Farooq and Rashid just went and did it [assassinated Bangabandhu]," he said.

Aside from this, Firoz Rashid mentioned that the nation is now divided into two parts. "There is no neutral person. Teachers, doctors, intellectuals, journalists are all

DESIRE FOR FREEDOM LARGELY ABSENT IN JS

Gonoforum lawmaker Mokabbir Khan, in his speech, said the philosophy of the Father of the Nation, spirit of the Liberation War, and the desire for freedom are largely absent in today's parliament.

"Sadly, even today, parliament passes indemnity laws for the corrupt, money launderers, looters. It's a shame," he remarked.

The financial struggle of mess residents

Rising cost of essentials makes life harder for bachelors

Living in a mess, an accommodation arrangement where individuals share their living space with others, has been a common practice for bachelors in Bangladesh, particularly for those living in urban areas.

The messes have been an affordable option for many, especially for those **DEFICIENCY** who are students or job aspirants with Habibur Rahman, a private-university limited income. However, with the rise in the prices of all essentials, including food, housing, and utilities, bachelors residing in messes are struggling to make ends meet.

Joy Banik, a resident of Monipuripara in the capital, shared his struggles with The Daily Star.

Joy said that just three years ago, he could cover his monthly food expenses with Tk 2,500. However, now, even after spending Tk 4,000 a month, he struggles to manage. Members of the mess he lives in are forced to cut their consumption of protein due to the rise in food prices.

Just a year ago, they used to consume chicken and fish on every alternate day with meal prices averaging around Tk 40-45. However, now, they have been forced to modify their diet, limiting their meat and fish intake to only two davs a week.

Despite the changes in diet, the cost of each meal has gone up to Tk 60-65. As Joy is still jobless, he is dependent on financial support from his acquaintances, but it is becoming increasingly difficult for him.

Nuruzzaman, who lives in a mess on Dilu Road, shared similar experiences, saying that there has been a significant

shift in dietary habits over the past few years. Previously, they used to consume beef or mutton twice a week. However, now, they do not dare to think of consuming beef or mutton even once a month. Nuruzzaman added that they often eat potato, pulse, and eggs as the price of vegetables is also very high. FALLING ILL FOR PROTEIN

Locals protest 'hotel's attempt to grab land'

Over 700 locals of Naikhongchhari upazila in Bandarban staged a demonstration yesterday against authorities of a renowned private hotel that allegedly is attempting to encroach upon some 150 acres of land.

They formed a human chain around 9:00am in front of the upazila parishad, claiming that the authorities tried to encroach their land in the name of setting up a private school and boarding.

While speaking, Swee Thowi Ching Marma said some 300 Marma families have been living on this land for many years, but a private hotel based in Cox's Bazar encroached on the land.

"If the hotel authority is allowed to start its construction work, then many Marma families, who have lived on the land for years, will be evicted and turned into refugees,"

Mongching Chak, another demonstrator, said the land in question has been encroached upon by various companies and establishments in Naikhongchhari in the

As a result, the families of eight Chak communities and eight Marma communities, who were evicted between 2006 and 2014, still live a life of uncertainty, he said.

Reviving Moulvibazar's 'dead canal'

Re-excavation brings hope for an end to waterlogging

MINTU DESHWARA

The Gogalichara canal in Kulaura municipality of Moulvibazar, the only means to drain water, has been a victim of filling and encroachment for many years. As a result, even a little rain causes waterlogging on the roads in the area, creating public nuisance.

The encroachment made the canal so narrow that locals now call it "Mora Gogalichara", which can be translated as "the dead canal".

However, there is renewed hope as the Water Development Board (WDB) recently started reexcavating the canal under the "River, Canal and Beel Re-dredging Program in 64 Districts (Phase 1)".

The job was given to M/s M Rahman, a contracting firm from Mymensingh, with an estimated cost of about Tk 64 lakh. The work began on February 19 and is expected to be completed by June

According Kulaura municipality authorities, the Gogalichara canal originates from the hills of Gazipur area of Moulvibazar Sadar upazila, passes through various areas of the municipality, and joins Fanai river at Kadipur union.

haor. During a visit to the site, it was found that re-excavation is underway with excavators in Sonapur, Uchlapara, and Dakshin Magura parts of the canal. However, some people have built culverts and boundary walls on both sides of

Al Amin Sarkar, Deputy Assistant Engineer of WDB Kulaura Region, who is supervising the reexcavation work of the canal, said that about 80 percent of the work has already been completed and is expected to be finished within the stipulated time.

OC, SI on leave to avoid action?

Two Chattogram police officers, accused in a case filed for torturing a youth in custody, have been on "sick leave" for more than 45 days, raising questions about whether they are trying to avoid arrest or departmental action. Following a court order, Md

Shahnewaz Khaled, superintendent of police of Criminal Investigation Department (CID) in Chattogram, filed the case with Panchlaish Police Station on February 22, accusing its officer-incharge Nazim Uddin and sub-inspector Abdul Aziz.

On February 20, OC Nazim arrested one Syed Mohammad Mustakim during a protest against the price hike of kidney dialysis at Chattogram Medical College Hospital.

Police filed a case with the station, accusing Mustakim of assaulting the law enforcers.

Later, he received bail from a Chattogram court and on February 21 filed a complaint with a Chattogram court, alleging that after his arrest, he was brutally tortured inside the police

The court took the case filed by

the CID to investigate it and submit a report, and also file a case against the OC and SI over custodial torture.

Meanwhile, the police officers went on "sick leave", said Chattogram Metropolitan Police Deputy Commissioner (DC-North) Mokhlesur Rahman.

They are yet to join office, said police. Several senior police officers, seeking anonymity, said OC Nazim is doing it to fend off his arrest in the case with the help of some colleagues in the high-ups.

DC Mokhlesur Rahman told The Daily Star, "OC Nazim submitted some prescriptions and hospital documents and applied for medical leave."

When asked what kind of health problem Nazim mentioned in the leave application, the DC said, "I don't know. His medical leave was granted as he had valid reasons, that's it.

Asked why the OC has not been suspended although he has been made accused in a case, the DC said, "I don't want to tell the details. CID is investigating it."

ROCKET FIRE Israeli army launches strikes in Syria

AFP, Jerusalem

Israel launched artillery strikes on Syria vesterday morning, the Israeli army announced, after several rockets were fired from there and landed in the Israeli-occupied Golan Heights.

Israel's retaliatory strike to rocket attacks from Syria -- which no one has claimed -- is the latest episode in escalating violence in the region.

"In response to the rockets fired from Syria at Israel earlier today, IDF Artillery is currently striking in Syrian territory," the military tweeted.

A drone was also "currently striking the launchers in Syria from which rockets were launched into Israeli territory".

Six rockets were launched towards Israel Saturday night, with two landing in the Golan Heights, the army said. At least one was intercepted by the Israeli air-defence system.



The 1,200 square kilometre (460 square mile) region by Israeli soldiers and bordering Lebanon -- was seized from Syria in the 1967 Six-Day War. Israel later annexed it in a move that was never recognised by the international community.

Syrian state news agency SANA said the Israeli strikes took place around 5:00 am. Citing an unnamed military source, SANA said Syria's military had "intercepted the rockets... and brought down some of them".

On Wednesday, Israeli police stormed the prayer hall of Al-Aqsa mosque in a pre-dawn raid aimed at dislodging "law-breaking youths masked agitators" they said had barricaded themselves inside. The next day, more than 30 rockets were fired from Lebanese soil into Israel

China simulates Taiwan strikes

US says watching military drills closely

China's military simulated precision strikes against Taiwan in a second day of drills around the island yesterday, with the island's defence ministry reporting multiple air force sorties and that it was monitoring China's missile forces.

China, which claims democratically governed Taiwan as its own territory, began three days of military exercises around the island on Saturday, the day after Taiwan President Tsai Ing-wen returned from a brief visit to the United States.

Chinese state television reported that the combat readiness patrols and drills around Taiwan were continuing.

"Under the unified command of the theatre joint operations command

out simulated joint precision strikes on key targets on Taiwan island and the surrounding sea areas, and continue to maintain an offensive posture around the island," it said.

The de facto US embassy in Taiwan said yesterday the United States was monitoring China's drills around Taiwan closely and is "comfortable and confident" it has sufficient resources and capabilities regionally to ensure peace and stability.

A source familiar with the security situation in the region told Reuters that China had been conducting simulated air and sea attacks on "foreign military targets" in the waters off Taiwan's southwestern coast.

"Taiwan is not their only target," the

centre, multiple types of units carried source said, speaking on condition of anonymity as they were not authorised to speak to the media. "It's very provocative."

Taiwan's defence ministry said that as of yesterday midday they had spotted 58 Chinese aircraft, including Su-30 fighters and H-6 bombers, as well as nine ships, around Taiwan.

The ministry said they were paying particular attention to the PLA's Rocket Force which is in charge of China's landbased missile system.

"Regarding the movements of the Chinese communists' Rocket Force, the nation's military also has a close grasp through the joint intelligence, surveillance and reconnaissance system, and air defence forces remain on high alert," the ministry said.

Saudi, Omani envoys arrive in Yemen

Saudi and Omani delegations arrived in Yemen's capital Sanaa, Houthi-run media said yesterday, to negotiate a permanent ceasefire deal with Houthi officials and end Riyadh's military involvement in the country's long-running war. The visit indicates progress in the Oman-mediated consultations between Riyadh and Sanaa, which run in parallel to UN peace efforts. Peace efforts have also gained momentum after arch-rivals Saudi Arabia and Iran agreed to re-establish ties in a deal brokered by China. The envoys, who landed late on Saturday, will meet with the head of Houthi Supreme Political Council, Mahdi al-Mashat, to hold talks on ending hostilities and lifting a Saudi-led "blockade" on Yemeni ports, Houthi news agency SABA reported. Sources have told Reuters that the Saudi-Houthi talks are focused on a full reopening of Houthi-controlled ports and Sanaa airport, payment of wages for public servants, rebuilding efforts and a timeline for foreign forces to exit the country. Yemen's war is seen as one of several proxy battles between Iran and Saudi Arabia. The Houthis, aligned with Iran said they are rising up against a corrupt system and foreign aggression.

RAPID SURGE IN CASES Covid curbs back in 3 Indian states

With most parts of India witnessing a significant rise in Covid-19 cases over the last few days, three states - Haryana, Kerala, Puducherry -- have made masks mandatory again, while others advised to observe caution. Union Health Minister Mansukh Mandaviya earlier this week held a review meeting and asked states to stay alert and review the preparedness of health facilities. A nationwide mock drill is planned today and tomorrow to assess emergency preparedness of both public and private hospitals, reports NDTV. On a possible fourth wave of the Covid pandemic, the health minister said there's a need to be alert. The last Covid mutation was BF.7 sub-variant of Omicron, and now XBB1.16 sub-variant is causing the surge in infections, he said, adding that in the ministry's experience, sub-variants are not too dangerous.

India's tiger population rises above 3,000

India's wild tiger population - by four years, using camera traps far the largest in the world -- has and computer programmes to to a census released yesterday, boosting efforts to conserve the endangered species.

The largest of all cats, tigers once roamed throughout central, eastern and southern Asia.

But in the past 100 years the tiger has lost more than 93 percent of its historic range and now only survives in scattered populations in 13 countries, according to the International Union for Conservation of Nature (IUCN).

The Indian census estimated there were 3,167 tigers in the wild across the country, up from 2,967 reported in the last such exercise. Surveys are conducted every



Ragging is nothing but abuse

UGC must hurry up with an anti-ragging policy

We are dismayed that despite all the reports in the media about the cruel ragging in public universities - a practice that can only be described as abuse - no policy has been formulated yet to ban it. Academics and rights activists have for long been demanding an anti-ragging policy with a clear definition of the term "ragging" so that offenders can be given strict punishment. So why has the University Grants Commission (UGC) still not been able to come up with this much-needed policy?

The extent of the physical and mental abuse in the name of ragging has come to the limelight, once again, after a female student in her first year was tortured by some women BCL leaders and activists in a residential hall of Islamic University in Kushtia because she stayed at the hall without their "permission". A recent report in this paper has found that it is mainly pro-ruling party students who are very active in "ragging" freshers at different campuses, although "regular" students in some universities have kept up this cruel tradition of initiation, too. Ragging, considered for far too long a frivolous and harmless activity, includes all kinds of psychological and physical torture. The consequences of such abuse are, of course, devastating for victims and may cause post-traumatic stress disorder, depression, dropout and, in the worst cases, suicide. Despite knowing how harmful this practice is, why is it still being allowed?

The problem of ragging, however, is largely related to the way the residential halls have been practically "taken over" by ruling party cadres. Moreover, with the seating crisis in public university dorms, BCL members "arrange" seats for freshers in common rooms and guest rooms when they can't get seats. These are also the places where the entrants are tortured in the name of ragging. In most cases, victims are too afraid to complain to the authorities, fearing retaliation; in the few cases that complaints are filed, they inevitably fall on deaf ears. The power and implicit impunity of the BCL render the hall authorities virtually disempowered to put a stop to this senseless abuse.

An anti-ragging policy, though much needed, can only eliminate this practice if it is properly enforced by the university authorities. The UGC, the apex body of all the affiliated public, private, and international universities in Bangladesh, must play a more active role in ensuring compliance of the university authorities in establishing safe campuses where critical thought and learning are prioritised over ruthless exercise of power. We urge it to finalise a policy, after consultation with relevant stakeholders, without any more delay, and engage with the government to ensure its



We already know that the Bangladesh Bank approved emergency loans for Islamic Bank Bangladesh, Social Islami Bank Limited, First Security Islami Bank, Global Islami Bank, and Union Bank worth Tk 14,790 crore in December last year. Such emergency funds are usually taken during extraordinary circumstances. And the Shariah-based banks, which do not borrow money by offering interest, had to borrow from the Bangladesh Bank at 8.75 percent interest as their cash reserve ratio (CRR) fell short of the central bank-stipulated rate for an acute liquidity crisis.

Islami Bank, which is currently under investigation by the central bank for gross irregularities over the disbursement of loans amounting to Tk 7,246 crore among nine companies, took the highest amount from the emergency fund. Reports about the investigation apparently led to a confidence crisis among depositors of the five banks, all of which have Chattogram-based business conglomerate S Alam Group wellrepresented in their boards.

By now, it is relatively well-known what has been happening at these banks. The massive irregularities surrounding them sums up, to an extent, the sorry state of our banking sector as a whole. The sharp rise in defaulted loans, scams, irregularities, mismanagement, lack of good governance, and the regulator's willingness to bend the rules for some supposedly under pressure from influential quarters - at the cost of many have made it one of the most troubled sectors in the country that,

The downgrading by Moody's will only add to our economic woes. As confidence of investors and foreign institutions in the sector further erodes, it will become harder for Bangladesh to attract foreign investment - which is already one of the lowest in Asia and make obtaining loans costlier for businesses and banks operating in the country. This may result in stressed assets for banks to rise, as businesses (to which banks have large exposure) are facing slowing external demand due to inflation in many of their key markets and rising costs due to higher import

The downgrade also reflects the government's decreased capacity to provide the same unconditional - and often questionable – support for banks because of its worsening external position. This comes at a time when systemwide loan-loss reserves as a proportion of non-performing loans (NPLs) is hovering at a pretty low level of 56 percent as of September last year, which is inadequate to provide sufficient buffers against rising loan

We are alarmed that the once mighty Old Brahmaputra River has been allowed to turn into a dumping zone, without any concern about how such reckless trashing of a vital waterbody would affect the environment, the community at large and people's livelihoods which depend upon it. According to a report by this daily, some powerful quarters in the locality have been dumping concrete waste and storing construction materials near the river at Mymensingh city's Kachari Ferry Ghat area for months. Locals allege that the Mymensingh City Corporation (MCC) and local Water Development Board (WDB) have refused to take any initiative against those partaking in such illegal activities, despite repeated reminders and memorandums submitted to the Mymensingh deputy commissioner and MCC mayor urging them to take action. A recent study by the Rivers and Delta Research Centre (RDRC) confirmed that at least 56 major rivers in the country are dying a slow but painful death due to extreme pollution, with little to no concrete measures taken to save them, despite rivers being granted the legal

committed to sustainability and to doing the right thing by the planet. The same owner spent many years preparing to develop science-based targets (SBTs). All seemed to be going according to plan until they took a closer look at some of the targets. At that point, it became apparent that the targets were simply unattainable, provided that the business wished to continue growing. As a consequence, they chose not to set SBTs and are now in the process of reconsidering how best to approach this pressing issue.

I've been thinking about this subject a lot lately. Recently, I watched an interesting debate unfold on social media. One person was arguing that companies need to consider "degrowth" or "no growth" business strategies. Degrowth is a radical economic theory that broadly means shrinking rather than growing economies to use less of the world's dwindling resources. A second person was saying that this is simply not realistic, because it would essentially be tantamount to financial suicide. For instance, if a major global retailer announced a degrowth strategy, investors would likely pull out of it while shareholders would become extremely nervous.

To me, the degrowth movement seems to be gaining traction as concerns about the climate grow. Even organisations as prestigious as the World Economic Forum are openly

> On the one hand, I see a scenario where SBTs are, in some circumstances, extremely difficult – if not impossible to achieve without making decisions that could affect the long-term financial ability of a company. This could be for many reasons. In some cases, a company might be involved in the sourcing of raw materials with very high environmental footprints. In other circumstances, a company could be sourcing from a country where the national grid has been slow to shift to renewable energy, and so their Scope 3 (supply chain) emissions remain stubbornly high. If there is no adequate alternative sourcing destination, what s that business supposed to do?

Meanwhile, I see many of the world's largest fashion retailers struggling to get Scope 3 emissions under control. In fact, the only time Scope 3 emissions have fallen by any significant extent during the past decade was during the pandemic. But this was inevitable because supply chains were shut down for extended periods at that time.

In the meantime, major fashion retailers report in their annual results

There has to be a third way as the alternative is too dark to contemplate. It's time for us all to sit down and decide what this third way might entail.

DIGITAL SECURITY ACT

Govt stubbornness sends ominous signal

United Nations High Commissioner repealing two recommended sections and amending eight Act (DSA) is not surprising. These sections and many other provisions of the draconian law were already criticised by human rights activists of Bangladesh since the law was in the making in early 2018. The two sections the OHCHR recommended to be repealed are sections 21 and 28, and the ones that have been recommended to be amended are sections 8, 25, 27, 29, 31, 32, 43 and

It may be recalled that when the government took the initiative to pass this law in the wake of the 2018 elections, there were extensive $discussions \, and \, protests \, from \, various$ quarters about these provisions. On September 29, 2018, the Editors' Council issued a statement explaining its concerns over the DSA, identifying some fundamental flaws in nine sections (8, 21, 25, 28, 29, 31, 32, 43 and 53) of the act. In the last four and a half years, those who have followed the state of human rights, right to expression of the citizens, and freedom of the press in Bangladesh have repeatedly said this law as a whole and some sections in particular are unacceptable, and are inconsistent with the international conventions signed by the country.

The two sections the OHCHR has asked to repeal were widely discussed because they are opaque, include vague concepts, and are deemed to have a large scope for political use. Section 21 states, "If any person, by means of digital medium, makes or instigates to make any propaganda or campaign against the liberation war of Bangladesh, spirit of liberation war, father of the nation, national anthem or national flag, then such act of the person shall be an offence," and that he or she will be punished with imprisonment for a term not exceeding 10 years, or with a fine not exceeding Tk 1 crore, or both. A second time or repeated offence will land the offender with imprisonment for life, or with a fine of Tk 3 crore, or both.

Section 28 of the DSA says, "If any person or group willingly or knowingly publishes or broadcasts or causes to publish or broadcast anything in website or any format which hurts electronic religious sentiment or values, with an intention to hurt or provoke the religious values or sentiments, then such act of the person shall be an offence." The punishments have been set at imprisonment for a term not exceeding five years, or with a fine not exceeding Tk 10 lakh, or both. Repeat of such offence will lead to imprisonment for a term not exceeding 10 years, or with a fine not exceeding Tk 20 lakh, or both.

The scope of such a law is so wide that any person can accuse anyone of violating this law, and therefore they can be arrested, imprisoned or even be pronounced guilty. In research conducted since January 2020 by

In my research on the use of the DSA since it came into effect, the four sections sections of the Digital Security we found to have been most widely used were sections 25, 29, 31 and 35. Three of our published reports (April 2021, April 2022, and January 2023) highlighted different aspects of it.

bail, many are under trial. Writer Mushtaq Ahmed died in jail while in custody. Mushtaq was languishing in jail for more than 10 months and courts had repeatedly denied his bail applications. We don't know how many are facing the same situation as the government is unwilling to share the information.

The information we have gathered shows that 18 cases have been filed under Section 21, in which 242 people have been accused and 19 have been detained. The information we could gather about the professional background of the accused was of 112 people, of whom politicians were the largest victims (81), followed by lawyers (11). Forty-four cases have been filed under Section 28. A total of 118 have been accused and 25 have been arrested. We were able to gather professional identities of 34 people, which showed that most of the accused are journalists and teachers, with six cases each; two and three people were arrested, respectively. Politicians follow them to be accused and detained. An analysis of the statistics shows that 21.19 percent of

the accused were arrested. The use of the sections for

BLACK, WHITE AND GREY which the OHCHR has called for amendments (8, 25, 27, 29, 31, 32) are quite concerning. Section 25 is a case in point. Our research shows that 212 cases have been filed, 688 have been accused and 141 have been detained. There is a similar trend in the application of Section 29; under this section, 211 cases have been filed and 677 people have been accused. Section 29 states, "If any person publishes or transmits any defamatory information as described in section 499 of the Penal Code (Act XLV of 1860) on a website or in any other electronic format, he shall be punished with imprisonment for a term not exceeding 3 (three) years, or with a fine not exceeding Taka 5 (five) lac, or both." Penal Code 500 through 501 have dealt with defamation and have the provision of punishment of up to two years of imprisonment.

But it has been found that after DSA's introduction in 2018, cases are being filed under this law instead of the Penal Code. This is in large measure due to the police's prompt action if a case is filed under the DSA. This is particularly true when a case is filed by the government or an activist of the ruling party. Besides, since most of the sections of the DSA are non-bailable, the persons arrested under the law remain in jail as pretrial detainees for a long period almost for an indefinite period. In our study, we have also found that the period of imprisonment becomes long and uncertain due to the police not filing the investigation report within the maximum stipulated period of 75 days. As such, various provisions of the DSA have become a tool for harassing rivals, particularly political opponents.

The government and the leaders and activists of the ruling party are filing cases against their opponents almost every day somewhere in the country, and the accused are being detained without delay. These are signs that this trend will increase before the elections. Law Minister Anisul Huq told reporters last week that the law cannot be repealed in any way. Harsher words came from Information Minister Hasan Mahmud, who said in unequivocal terms that there was "no possibility of repealing the Digital Security although the UN High Commissioner for Human Rights Volker Turk on March 31 called for an immediate suspension of the law.

Despite the data showing a clear pattern of the DSA being used as a tool to instil fear in society, protests of civil society members against the wanton use of the law, demand human rights organisations to repeal the law altogether, and the OHCHR recommendations to suspend it, the government is doubling down. This only indicates that the law is likely to be used far more widely by the government and its supporters ahead of the elections. This is an ominous signal.



What they want, however, is not public debate, but rather an agreement among governments and tech corporations to keep power where it belongs.

A massive expansion of AI capabilities is a serious threat to those in power – including those who develop, own, and control AI. It points to nothing less than the end of capitalism as we know it, manifested in the prospect of a selfreproducing AI system that will

Were we not already controlled much more than we realised? Instead of complaining about the threat to our freedom and dignity in the future, perhaps we should first consider what freedom means now. Until we do this, we will act like hysterics who, according to the French psychoanalyst Jacques Lacan, are desperate for a master, but only one that we can dominate.

The futurist Ray Kurzweil predicts that, owing to the exponential nature of technological progress, we will soon be dealing with "spiritual" machines that will not only display all the signs of self-awareness, but also far surpass human intelligence. But one should not confuse this "post-human" stance for the paradigmatically modern preoccupation with achieving total technological domination over nature. What we are witnessing, instead, is a dialectical reversal of this process.

Honouring André Malraux's Legacy A Look Back at His Visit to Bangladesh

Malraux also wrote a letter to the American **President:** "When the most powerful army of the world could not destroy the barefooted people of Vietnam, then how do you think that from a distance of twelve hundred miles, the army of Islamabad could get back a country desperate to achieve its independence?"

During the middle of the past century, two Frenchmen were known and admired around the world. They were General de Gaulle and André Malraux.

Malraux became a celebrity in the 1930s as a writer, adventurer, and orientalist. He was also a freedom fighter who fought for the liberation of Spain and France and advocated for most non-self-governing territories. We, the students in France during the 1960s, had great admiration for him.

In 1971, the first diplomatic mission for Arab countries was formed with Mollah Jalal, an MNA, and me. But before leaving Delhi, I had the chance to suggest several Frenchmen's names for the Bangladesh conference, including his name. However, in September, Malraux made a declaration that he would not join the conference.

It was in April 1973 that André Malraux (1901-1976), France's most legendary living figure in the domain of arts and letters, politics, and philosophy, came to Bangladesh for a short visit. Since his early youth, Malraux traveled around the four corners of the world, but the four days he spent here just 50 years ago were indeed an extraordinarily memorable voyage for him as well as for the country he visited. Why? Because he

the side of the people who had been fields?" capable of saying 'No'." The people of Bangladesh dared to say 'No' to the oppressors and usurpers of their sovereignty. But for this, they had to pay too much in the form of misery, and death.

On 18th September 1971, Malraux made a declaration to the media that instantly became a world event. He said that he would not participate in the conference called to support

Bangladesh in Delhi. Rather, he would come to fight in a company of tanks as he had some experience in it, provided the governments of Bangladesh and India permit him. He also wrote a letter to the American President: "When the most powerful army of the world could not destroy the barefooted people of Vietnam, then how do you think that from a distance of twelve hundred miles, the army of Islamabad could get back a country desperate to achieve its independence?" (Le Figaro. 17th Dec. 1971)

By mid-December, the fate of the war was decided in favour of Bangladesh. Even before things got totally settled, the intellectuals of the newly born nation wanted to greet this distant friend, and Malraux received an invitation from Prime Minister Bangabandhu Sheikh Mujibur Rahman.

April, accompanied by Madame Sophie de Vilmorin, his last companion, Mr. Garofalo, photographer of the Paris-Match and two journalists of the French television, alighted at the old airport of Tejgaon. Foreign Minister Dr. Kamal Hossain with Mr. Arshad Uzzaman, the chief of protocol on the one hand and two renowned members of Bangladesh intelligentsia, Begum Sufia Kamal, poet and social worker, and Prof. Syed Ali Ahsan, Vice-Chancellor of Jahangirnagar

advanced amidst the lined-up school children who cried 'Vive Malraux' in lieu of the usual words of slogans 'Joy' or 'Zindabad'. Malraux lifted a boy from the ground and said, "As I cannot embrace everyone, so by doing this on this lone face, I wish to kiss Bangladesh". Instantly, he was taken to the Presidential Palace, where he was to stay during his visit and to meet the Prime Minister, Bangabandhu Sheikh Mujibur Rahman. When asked what he might expect from Monsieur Malraux, Bangabandhu Sheikh Muiibur Rahman replied: "All that I want is the love, the affection and the respect that one should offer to my people. Have not you seen my beautiful people, my magnificent country, and my green

After the brief meeting, Malraux was brought to the Dhaka University campus, where he had an exclusive meeting with the Deans and senior teachers. Dr. Abdul Matin Chowdhury, the Vice Chancellor, offered him tea with 'poneer'- the Bengali cheese, which he seemed to have relished but did not forget to tell his host that there are 236 varieties of cheese in his country. Then, on arrival at the Teacher-Students' Center, he was offered by the Vice Chancellor a silver boat, a symbol of the riverside of Bangladesh, as a token of love. Malraux made a very emotional speech while addressing the students: "For the first time, I speak in this University where there are more dead than living. Students of France know that your teachers and your friends embraced death for liberty, and they know that nowhere else ever before, students and teachers paid such a heavy price for liberty. They also know that among so many of the students who fought, there is one place where the students would rightfully tell those who would come later: 'We have fought with our bare hands' ... Your dead have rendezvous with the fate of Bangladesh, but now it is up to you to make the nation."

Then after the official luncheon offered by the Prime Minister, Malraux was taken to visit the National Mausoleum at Savar. He placed a wreath while the army bugle was being played. Suddenly there was a brief but torrential rain, and the former freedom fighter entered the hospital for war victims. As everyone there knew who the visitor was, he was profusely garlanded, but Malraux took a garland from his neck and put it on a young man who had lost one hand and one leg. He also visited the monument for the martyrs of the 21st February Language Movement and placed a wreath there. In the evening, there was a grand reception for him at the Alliance Française de Dacca. Malraux made a speech by highlighting the nobility of French culture that showed the world courage, justice, and thought for action

At 7:30 P.M., a sumptuous dinner was offered by the President of Bangladesh, in which artists, intellectuals, and personalities took part. No formal speech was delivered in the course of the discussion. Malraux opined that he knew that Bengali literature had a rich tradition, but he had only read Tagore. About Kazi Nazrul Islam, the National Poet of Bangladesh, he could learn while traveling from Delhi to Dhaka and was attracted by his personality. An interesting cultural show was presented to end up the first day's programs.

The following day was also a very special day as André Malraux was going to be awarded a doctorate Honoris Causa in a special Convocation at the University of Rajshahi. After two salutatory addresses by Vice-Chancellor Dr. Khan Sarwar Morshed and Justice Abu Sayeed Chowdhury, the President of Bangladesh, André Malraux accepted the honor with a passionate speech.

Following the famous inscription of antiquity to honor them, Malraux advised, "On any of the graveyards of your freedom fighters, in the ditches filled with the dead bodies of your intellectuals, write in large letters: You, who shall pass later on, go tell all of ours that those who fell here were dead because during the nine months of suffering they accepted to fight with bare hands. Salute the dead of the surrounding forest! You have

shown the world that one can never Alliance in those years. assassinate enough to kill the soul of a person who would not surrender.

"On the roads of the Orient, there are tombs of French knights; on all the roads of the Occident, there are tombs of the soldiers of WWII... And on your tombs, there are perhaps memories of the words of justice and of liberty with which the generals of the Revolution had set Europe on fire. Your culture holds to you in one lone and big word: Spirituality. Your liberation has attempted to unite the language of eternal Bengal with that of our Revolution."

After lunch at the Vice-Chancellor's residence, Malraux visited Varendra Research Museum in the town, three miles away from the campus. This was an extraordinary scene as he seemed to be in his own world with all the statues and the icons around, and he started a very elaborate explanation of the significance of their existence to Madame Sophie de Vilmorin in

Returning to Dhaka, a quiet lunch with the President and his family took place at Bangabhaban. Justice Chowdhury and Malraux discussed the problems of family planning, as well as of China. In the afternoon, he visited the National Museum at Neemtoli (the old site) and then came to the Art College (now the Institute of Fine Arts of the University of Dhaka), where he discussed with the students and teachers. There was also an exhibition of paintings which he watched with care. Then he joined a small cocktail party in the hotel suite of the French Ambassador to celebrate the Easter festival. A sumptuous dinner followed by a musical soiree was arranged at the Foreign Minister's residence. Malraux seemed to have liked the Bengali songs with revolutionary themes and rhythm. He even asked to repeat a song twice.

The third day's visit was at Chittagong, where a festive reception was accorded at the airport. Then Malraux was taken to see the dilapidated war-torn port. A grand civic reception was held at the Chittagong Club. He was presented with an old manuscript, considered the most precious gift to be offered. His speech was very much appreciated, but it was the same as that of Rajshahi, with two excerpts, one in the beginning and one in the conclusion, where he lauded the role of Chittagong for her special contribution to the war of liberation. He reminded that an extraordinary effort of the people was needed to reconstruct the country, in which he would initiate the program of aid as an advisor to the Government of France.

As the ceremony was over, a grand lunch was awaited in the house of Mr. A. K. Khan, industrialist and a former minister. It was indeed an international festival there. Malraux enjoyed it very much and had an exchange of ideas with many. He also made his admirers happy by giving autographs according to their demand, and as per the advice of the ambassador of France, he had an exclusive discussion session on the economic situation of Bangladesh with his host for fifty minutes, along with the present writer as interpreter.

There were two more programs for the afternoon. A quick visit to the Alliance Française de Chittagong. There he liked the 'dab' (green coconut) water with ice cubes on a silver plate. Mr. Juned Chowdhury offered him a copy of the Etude sur l'évolution intellectuelle chez les musulmans du Bengale 1857–1947, which was written by his interpreter (Mahmud Shah Qureshi) who was also the President of

Malraux also had a look at the painting exhibition of the teachers and students of the University of Chittagong there. Then he rushed to inaugurate Chittagong Art Gallery and Folk Museum at Mehdibag, where another exhibition was installed. He was offered a painting of Shilpacharya Zainul Abedin, which he accepted with great admiration and respect. In a short speech, Malraux called upon the artists to draw scenes of the local culture on their canvas. He was also moved by the gift of a painting from young Nayak, son of artist Sabih-ul

Then by helicopter, he was flown to Kaptai, where the houseboat of M.A.K. Khan was ready to show him the beauty of the lake in the middle of Chittagong Hill Tracts. Madame Sophie de Vilmorin, his companion, enjoyed it to the fullest, as she described vividly in her book 'Aimer Encore'. There was another surprise from a few sampan-loaded people who cried "Vive Malraux" (Long live Malraux). The present writer got some exclusive minutes from one of the most famous intellectuals in the world to answer his questions. In the Kaptai Guest House, Malraux left his suit and his tie. He wore a red shirt and enjoyed his dinner with Ruhi fish of the lake.

The next morning he reached Dhaka and faced a very energetic press conference. He insisted on more foreign help for Bangladesh as the actual loss of the country was unaccountable. He also lauded the role of the freedom fighters in liberating the country.

Before leaving Dhaka on a plane at 12.25 pm, he met the President and the Prime Minister. But he also got time to write his best wishes in two books as a gift to his interpreters. From Paris, he wrote an extraordinary letter on May 8, 1973 to this author.

"My dear Professor,

On return to Paris (with the book which you have so kindly presented me), I wish to tell you about the friendly memory that I conserve to our collaboration. You have helped me much, and without you, my relationship with my listeners in Chittagong would not have been what it was. The intelligence, the rapidity, and the tonality of your translations established a communication and sometimes a communion for which I am grateful to you. Let us hope that we can now put into realizing what we have undertaken for your country, which has become a little mine, and trust, my dear professor, to my sympathetic memory.'

Here is not the end of the story. Shortly after his return to Paris, he appeared before the court to save the voung man who wanted to hijack a plane for sending medicine to Bangladesh. I also met him after four months in his residence. He told me that he had done what he promised. He talked to the Education Minister of France not to disturb the teaching of Bengali as it was apprehended and to the Chinese Ambassador in favour of the recognition of Bangladesh to be a member of the United Nations. And needless to say that France would continue to help Bangladesh in a massive way, at least as was expected by the optimist humanist André Malraux.

Dr Mahmud Shah Qureshi is an eminent Bangladeshi scholar. He has been honoured with numerous accolades, including Ekushey Padak and France's Légion d'honneur.

Russel lambasts BFF for depriving SAFF champions

The Kazi Salahuddin-led Bangladesh Football Federation (BFF) continues to receive backlash from different quarters for their failure in sending the national women's team to the Paris Olympics women's qualifiers, and the latest attack came from Zahid Ahsan Russel, the state minister for Youth and Sports.

"I think they [BFF] intentionally didn't send the women's team to the [Olympics] qualifiers ... and [as a result] had tarnished the country's image," Russel told the reporters after the National Sports Council (NSC) executive meeting at the NSC conference room yesterday.

"We need to look into the matter ... and the Prime Minister will be made aware of it. The fact that a small amount of money prevented the women from taking part in the event, there is something behind it for sure," added Russel, who recently returned home after having undergone treatment aboard.

Earlier on March 29, BFF general secretary Abu Nayeem Shohag informed that the women's team were pulled out of the Olympics qualifiers in Myanmar due to financial constraints, especially after failing to get the necessary response in time from the Youth and Sports ministry.
