\$4.7B IMF LOAN

On course to meet most of **March targets**

Bangladesh is poised to meet five of the six targets set by the International Monetary Fund for March as part of the \$4.7 billion loan programme.

There is uncertainty about whether the condition of maintaining a minimum net international reserves (NIR) of \$22.95 billion at the end of March could be met, according to Bangladesh Bank and finance ministry officials familiar with the issue.

The IMF will do the calculation for NIR at the end of March, so it is not possible to say whether the target will be achieved, they said.

"There is uncertainty on just this. The rest of the conditions will be met easily," said a finance ministry official on the condition of anonymity.

All six targets for March are not mandatory for the release of the next tranche of about \$476.27 million; it will be based on how Bangladesh fares with the targets for

The first review of the programme will take place in the second half of 2023, when the IMF staff team will assess the programme's quantitative targets and progress of

IMF maintains 5.5pc growth forecast for Bangladesh

At this point, it is becoming apparent that GDP growth this year would not be hitting 6 percent, a feature in pre-pandemic years under the current Awami League-led government.

Yesterday, in its flagship World Economic Outlook, the International Monetary Fund maintained that growth would be at best $\bar{5}.5$ percent in 2023 and 6.5 percent next year.

This comes after the World Bank and the Asian Development Bank last week made growth forecasts of 5.2 percent and 5.3 percent respectively for this fiscal year, which ends on June 30.

The government though is maintaining the growth this fiscal year would be 6.5 percent.



The first time I saw Dr Zafrullah Chowdhury was in 2007, for a story in our weekend magazine in The Daily Star, on his Nagar Hospital on Mirpur Road, where anyone, no matter how poor could get medical care at subisidised costs. I was not expecting to see a clean, organised, fully-equipped, seven-storey hospital where

patients could see a doctor for a mere Tk 20. The place was busy but organised, not chaotic like our understaffed, overcrowded public hospitals. Strikingly apparent was the presence of mostly female staffers -- the receptionist, paramedics, pathologists, nurses, on-duty doctors, and even the drivers of the hospital vehicles. Among

Govt makes U-turn on fertiliser price

Hikes it by Tk 5 per kg citing global market situation

The government has increased fertiliser prices by Tk 5 per kg just a week after the National Coordination and Advisory Committee on Fertiliser announced it has no plan to hike the prices for the sake of agriculture production.

Expressing concerns, farmers said the vegetable cultivation expenditure will shoot up and so will the risk of loss.

"Fertiliser is widely used in vegetable production. This year, I incurred a loss cultivating cauliflower, cabbage and legumes as there was bumper production and the market was flooded with vegetables," said Moslem Uddin of Deol village in Shyamnagar of Satkhira.

Replying to a question, he said, "The risk of loss will increase ... I may shrink from vegetable cultivation and expand rice cultivation where the chance of loss is low as the rice price is fixed by the government."
Experts suggest the government should readjust the fertiliser price in line

with the drop in price in the international market and take measures to protect both farmers and consumers.

Dealers and farmers will have to pay an additional Tk 5 per kg as the government has increased the prices of urea, DAP, TSP and MOP fertilisers.

An order, signed by Sheikh Badiul Alam, deputy chief for fertiliser management and monitoring at the Ministry of Agriculture, came into effect from Monday.

"The sale price of fertiliser has been revised to keep the import of fertiliser at a reasonable level and ensure its best use because of the increase in the fertiliser prices in the international market amid the ongoing economic situation," reads the order.

At dealers' end, urea fertiliser will have to be purchased at Tk 25 per kg, DAP at Tk 19, TSP at Tk 25 and MOP at Tk 18 per kg. Farmers will buy urea at Tk 27 per kg, DAP Tk 21, TSP Tk 27 and MOP Tk 20 per kg.

On April 3, Agriculture Minister Muhammad Abdur Razzaque mentioned that the government has no plan to raise the prices of fertiliser so that agriculture production is not hampered.

"In the last four years, Prime Minister Sheikh Hasina did not increase fertiliser prices. The finance ministry keeps pressuring us to increase the fertiliser prices ... The prime minister is strict and will not hike fertilise prices by any means,' he said following a meeting of National Coordination and Advisory Committee on Fertiliser at the Secretariat.

Talking to journalists at a briefing the same day, he also said, "Against this backdrop, we had a discussion. I want to tell you that we do not have any plan to increase fertiliser prices. Fertiliser prices will not be increased.

AL wants to use DSA to win nat'l polls **Alleges Fakhrul**

The Awami League wants to overcome the hurdle of national election using the Digital Security Act, the BNP said vesterday.

"This government is not an elected one. As the election is nearing, the government is using the Digital Security Act to gag voices of dissent. They [the ruling party] want to win keeping their opponents completely out of the election," said BNP Secretary General Mirza Fakhrul Islam Alamgir.

Addressing a seminar titled "Digital Security Act, democracy and constitutional scheme" organised by the party at a city hotel, he demanded repeal of all "black laws" and the DSA.

Fakhrul said that the main goal of the government now is gagging the people and the DSA is the tool to do that. The only way is to oust the government. There is no alternative to it," he said.

BNP standing committee member Khandaker Mosharraf Hossain said the DSA is contradictory to the constitution, democracy, and the Universal Declaration

of Human Rights. He said that the UN human rights commission chief asked the government to suspend the DSA and the people

5 rules set for importing Hindi films

The information and broadcasting ministry on Monday green-lighted the import of 10 Hindi films this year under certain conditions.

In a notice, it also stated that around eight more Hindi films would be imported next year.

Based on the positive response from the Ministry of Commerce, in compliance with certain conditions of the existing Import Policy Order 2021-2024, the import of films from South Asian Free Trade Area (SAFTA) countries has been granted on an experimental basis.

The conditions are: Legitimate film producers and distributors of Bangladesh will have the opportunity to import films made sub-continental languages; films produced in sub-continental languages with subtitles shall be allowed to be imported against export, only on an experimental basis for two years; producers may import 10 foreign films against the export of 10 Bangladeshi films in the first year; imported subcontinental language films must obtain a certificate from the Bangladesh Film Censor Board, prior to screening; and films imported under this order cannot be screened during the week of Eid-ul-Fitr, Eid-ul-Azha and Durga Puja.

For the next two years, these regulations will have to be strictly adhered to in order for a subcontinental language film to be imported to Bangladesh.

At the same time, all the cinema halls where Hindi movies will be screened will have to run an e-ticketing system.

Many artistes have opposed the release of Hindi movies in the country,

Monowar Hossain Dipjol, producer and actor, said the consequences of the decision will be detrimental while giving the example of Nepal, whose film industry has been on the brink of destruction after allowing Hindi films to be released in their country.

50 killed in Myanmar military's attack on rebel gathering

At least 50 people were killed in central Myanmar yesterday in an air strike by the military on an event attended by opponents to its rule, according to media and members of a local resistance movement.

Citing residents in the Sagaing region, BBC Burmese, Radio Free Asia (RFA), and the Irrawaddy news portal reported between 50 and 100 people, including civilians, had died in the attack.

Myanmar has been in turmoil since a 2021 coup, with attacks by ethnic minority armies and resistance fighters challenging the rule of the military, which has responded with air strikes and heavy weapons, including in civilian areas.

A member of the local People's Defence Force (PDF), an anti-junta militia, told Reuters fighter jets had fired on a ceremony held to open their local office.

"So far, the exact number of casualties is still unknown. We cannot retrieve all the bodies yet," said the PDF member, who declined to be identified.

At least 1.2 million people have been

displaced by post-coup fighting, according to the United Nations.

Yesterday's incident could be one of the deadliest among a string of air strikes since a jet attacked a concert in October, killing at least 50 civilians, local singers and members of an armed ethnic minority group in Kachin State.

Myanmar's pro-democracy governmentin-exile, the National Unity Government, condemned the attack, calling it "yet another example of (the military's) indiscriminate use of extreme force against civilians".

Last month, at least eight civilians including children were killed in an air strike on a village in northwest Myanmar, according to a human rights group, ethnic minority rebels and media.

The military has denied international allegations it has committed atrocities against civilians and says it is fighting "terrorists" determined to destabilise the country.

Western countries have imposed sanctions on the junta and its vast business network to try to choke off its revenue and access to arms from key suppliers like

But that is what Zafrullah Chowdhury is -- a larger than life figure who had the vision to realise that it was the lack of access to affordable healthcare that condemned the poor to a life of continuous ill health. His fierce determination to break this vicious cycle led to the creation of an institution like Gonoshasthava that has made revolutionary changes not only in healthcare but in public perception of women as vital nation builders.

When my team and I went to interview him at the hospital, I was a little taken aback by his appearance; longish white hair and clad in a batik Hawaiian shirt and khaki trousers, sandals half worn, he looked more like an eccentric artist than the founder of a mammoth development organisation. It was hard to gauge his mood as he went on his inspection of the wards, blasting the nervous staff at the top of his voice for some inefficiency and then suddenly cracking a joke to make them laugh, his hawkish eyes twinkling. His staff called him Boro Bhai, no "sir" or "doctor"for this no-nonsense man. But the respect and love he evoked among patients, paramedics, doctors and the staff, was obvious.

And when he met patients, he was extremely gentle and kind.

At present, Nagar Hospital has among other facilities, a burn and plastic surgery unit, cardiac unit, dental unit, surgery, counselling, physiotherapy, Ayurveda, Yoga and of course 24 hour emergency services.

So how did a vascular surgeon looking towards an ascending medical career in the UK end up being the founder of a multidisciplinary organisation in his home country that wouldbe committed to the welfare of the poor and marginalised? The Liberation War of 1971 changed the trajectory of his life. He and his

in London to join the resistance by treating wounded freedom fighters. It was pure patriotism that laid Kendra. Zafrullah and his fellow doctors set up a 480-bed field girls and young women in the refugee camps were invited to learn first aid and assist in operations.

"I realised that it was not the amount of training that was important in this context but the access to training," he said during the interview. When the war was over, the Field Hospital was renamed Gonoshasthaya Kendra (GK) which relocated to Savar with sub centres in surrounding areas and other districts. From his experience at the Field Hospital, Zafrullah knew how he could build a team of paramedics. GK started training girls and women who had completed their SSC (Secondary School Certificate). Soon it was a common sight to see these young women in the villages, going on foot or bicycle to visit households, telling them about basic healthcare, sometimes giving vaccines, even assisting in deliveries. The presence of these female paramedics gave women a new status. Villagers began to realise their importance and appreciate their work. GK's involvement with the community had a major role in the success of national family planning, immunisation and ORS campaigns.

Gonoshasthaya Kendra (GK), which is a multidimensional development programme, involves the community as a whole. It includes projects ranging from primary healthcare centres and hospitals, community schools, agricultural cooperatives, women's vocational training centres, training women drivers, to economic enterprises to help finance GK Trust activities. But GK's most obvious success is its primary healthcare programme (mainly in the villages) that benefits over a million people.

GK has proved that primary healthcare can be a successful, sustainable system. In 1982, GK's pioneering effort in forming a National Drugs Policy allowed local companies to produce essential drugs at much lower prices than multinationals did. GK itself produces essential drugs at subsidised prices. GK's Gono Bishwabidyalaya (People's University) trains doctors, paramedics and physiotherapists who will provide primary and tertiary care to poor

The accolades he has received are

Commendation' for his contributions during the Liberation War in 1971, the Swedish Youth Peace Prize, Sweden for founding Gonoshashthaya Kendra providing primary healthcare to rural communities, Maulana Bhashani Award, Ramon Magsaysay Award, The Right to Livelihood Award, Sweden, One World Action Award, UK, Public health Heroes Award, UK, Fr.Tong Memorial Award, India, Doctor of Humanitarian Sciences Award. Canada. His undeterred commitment to

the welfare of the disadvantaged was probably because of upbringing. unconventional mother, Hasina Begum, a courageous, self-educated woman, who believed in the equal rights of women and men, taught him the value of sharing with the less fortunate. His father, Humavan Murshed Chowdhury, was an honest police officer and instilled in him love for one's motherland. Zafrullah found his perfect match in his life partner Shireen Huq, a professor of English, a passionate human rights activist and one of the founders of Naripokkho, a women's rights organisation. Their children are Brishti and Bareesh.

The basic philosophy that Zafrullah modelled all his endeavours on was to come up with indigenous solutions for all problems. Thus Gonoshasthya's mission was to 'go to the village and build the village'. The GK Savar hospital serves the community and provides all the medical services as well as alternative medical treatment such as ayurveda and acupuncture.

In fact, he has been unequivocally, an advocate of local medical expertise. In 2019, GK inaugurated its second dialysis centre in the Savar hospital, the largest such centre in the country. During the pandemic, he tried to popularise a locally made antigen testing kit and was ready to help set up a 2,000 bed Covid hospital which did not receive the support it warranted during the most challenging moments of the crisis. For his own treatments which included regular dialysis he would come to his hospital even when he was on life support. There are few individuals who can display such conviction of their own principles.

Considered at times a controversial figure for his incendiary remarks in public, he remained unapologetic and brutally frank all throughout, a fighter till the end. Battling with formidable ailments, waging a war against crippling poverty and ill health of people, to bring some solace to the most vulnerable and neglected, his contributions to this country cannot be listed within the confines of this article.

"The authorities are taking steps to meet programme objectives, such as reducing un-targeted subsidies by raising electricity and natural gas prices and gradually moving toward a unified market-determined exchange rate. An IMF staff team will visit Bangladesh from April 25 to May 2 to discuss recent economic developments and policy implementation under the IMF-supported programme, an IMF spokesperson told The Daily Star. To this end, March's performance

will lend the IMF staff team an indication of how the authorities are faring with the programme objectives.

"We will be close to the March's floor for net reserves," Md. Mezbaul Haque, BB's spokesman, told The Daily Star. NIR is calculated as

international reserves minus shortterm foreign currency drains. Shortterm foreign currency drains include impending import bills and loan repayments.

As of March, gross international reserves (GIR) stand at \$31.14 billion, according to data from the BB.

But going by the IMF's balance of

payments and investment position manual (BPM6), which is followed faithfully by central banks around the world, GIR calculation does not include the various funds that the Bangladesh Bank has formed from the reserves as well as the loan guarantees provided for Biman, the currency swap with Sri Lanka, the loan to Payra Port Authority, deposits with the Islamic Development bank, cannot be more than Tk 357,500 Bank and the below-investment-grade crore.

So Bangladesh's GIR at the end of March was about \$24 billion, Haque added.

People's doctor no more

Khondoker,

vice-principal Gonoshasthaya Samaj Vittik Medical College, told The Daily Star.

Doctors said his liver and kidneys suffered much since he was infected with Covid-19. Zafrullah was alive with almost two dysfunctional kidneys and had to go through dialysis thrice a week.

On April 7, a medical board, led by Mamun, was formed with the renowned doctors of the country for his treatment. On April 10, he was put on life support. Defying his fragile health, Zafrullah

remained active -- participating in seminars, and political and social events. His condition worsened several times, yet he bounced back. But this time this brave man lost

Born in Raozan upazila of

Chattogram on December 27, 1941, Zafrullah was the eldest among 10 siblings. He passed matriculation from Nabakumar Institution in the capital's Bakshibazar and intermediate exams from Dhaka College.

He completed MBBS from Dhaka

Medical College in 1964 and went Field Hospital, which primarily to London to study FRCS. When the four-year FRCS course was about to be completed, the Liberation War broke out in Bangladesh.

He chose to abort the exams and dedicated himself in mobilising the people for the independence of the nation, setting an example of unparalleled patriotism.

Zafrullah also tore apart the Pakistani passport during a rally in London, protesting the massacre of Bangalees by the Pakistan occupation army. In May 1971, without any passport, Zafrullah and Dr MA Mobin decided to fly to Kolkata.

They collected travel permits and started for Kolkata on a Syrian Airlines flight. Damuscus was their stopover. The Pakistan government was watching their every step and tried to arrest them with the help of the Syrian government.

All the passengers left the aircraft. However, sensing the danger, the duo did not move as they knew the police cannot arrest anyone from an international flight.

At the end of May, they reached Agartola. There, he built Bangladesh took shape in Bisramganj village of Agartola, India. It was the seed of Gonoshasthava

Kendra, which would revolutionise the public health sector after independence. During the war, freedom fighters

wounded in battle were treated in that field hospital -- a structure made of bamboo and grass that had 480 beds and an operation theatre. Zafrullah and Mobin provided

paramedical training to a group of volunteers who worked as nurses for the hospital. In a heavily conservative society,

Another heritage site to bite the dust

125-year-old Railway Hospital being demolished

HELEMUL ALAM

After the demolition of century-old Neelam Ghar and Jahajbari, another heritage building -- the old Railway Hospital, which was established 125 years ago -- is set to be demolished.

A significant part of the Railway Hospital's west side, now known Shorkari Karmachari Hospital (Government Staffers Hospital) building, has already been demolished. The rest will crumble soon, as work has been ongoing for around 15 days.

The authorities have gone ahead with the decision despite the High Court's directive in 2018 ordering them not to change, modify or demolish 2,200 British-era heritage buildings in Old Dhaka, which includes the old Railway Hospital.

The two-storey building in Fulbaria remained functional as a hospital till

March this year. After that, hospital authorities issued a notice to empty all its wards and move them to an adjacent new building from March 19 to March 28. This newspaper has obtained a copy of the eviction notice.

Mamoon Mahbub, assistant secretary of Shorkari Karmachari Hospital, said they will construct a reservoir and green space at the site, as the old building has become fragile.

When asked about the HC directive, he said he was not aware of it.

Taimur Islam, chief executive of conservation organisation Urban Study Group, said this building was constructed as part of the new civil station from Fulbaria to Farmgate to make Dhaka the capital of the Eastern Bengal and Assam province during Bangabhanga (the first partition of Bengal) in 1905.

She is in her mid-fifties. Sombrely dressed in a white-green sari, hair parted in the middle and tied in a bun, Aleya Hijra has a betel leafstained smile. She lives at Diabari. Uttara in a rented house with her disciples; she is their "Guruma" or leader.

"I take from the public and give back to society. The general people are like my father-mother; they're my guardian, my sole source of living. I salute the fact that they give us charity and in turn, we try to make contributions when the need arises. Kindness is the cycle of life," said Aleya.

Recently, she came into the limelight after donating her hajj savings to stand beside the calamity-stricken traders Dhaka's Bangabazar. Her gesture made the headlines because she thought about the traders who were empowered only a few days ago and are now on the streets with the stroke of bad luck.

"If Allah wishes, I'll go to hajj someday, but for now, this is my haji. Deep down, I feel happy and proud that I could do something for them. If I had more, I would've happily shared my savings with them. This is my Eid," she says.

Aleya is active in charity work. She donates to mosques and madrasas, and gives air conditioners to local mosques. During Eid, she pays her zakat and fitra. Aleya recently bought lungis and saris to be distributed among the needy.

Following the death of her parents, Aleya came to Dhaka at the and embraced their Guruma as a tender age of nine from her village in Mymensingh. It was during the 1988 flood that she started working as a household help in an MP's house. Her friends and family used to always tease Aleya for her feminine mannerisms, calling her a hijra. So, she decided to leave a particular way of life and join a hijra

About 25 years ago, she joined Rahela hijra's group in Uttara, and

since then, she has been dancing on occasions like childbirth and weddings and collecting donations from shops.

"Everyone knows me in the Uttara sectors. I'm even invited to a cup of tea at police stations," she says, smiling.

Straightforward and law-abiding Aleya feels obligated to stand against evil; she cannot be part of any misgivings.

"People are scared of us. It's natural. They don't know us and some hijras are undisciplined and disruptive; they take money from people on the streets but do not belong to any of our groups. There is good and bad in every community. We are also afraid of reporters

'It's creating an environment of terror'

Experts tell webinar, urge govt to repeal it

Eminent jurists, academicians, and journalists yesterday underscored the need to come together and raise voice to make the government repeal the Digital Security Act (DSA).

In a webinar organised by Forum for Bangladesh Studies, they said any amendment to the law could exacerbate the already stifling situation in the

Ali Riaz, a distinguished professor of Illinois University, said DSA was enacted for immediate political gain. It serves as a protection tool for individuals and groups in power, and the ruling party.

Over the last four and half years, since the enactment of the law, citizens' rights and hurting anyone's sentiment were terror has been established, he said. "DSA

has set the stage for vigilante justice, where anyone can sue anybody. The situation has reached a point where no lawsuit is required to pick up anyone, and this is going to be severe in the coming

Badiul Alam Majumdar, secretary of Shujan, a citizens' platform, said DSA is a repressive law. The law itself is the problem. "DSA is hanging like a sword over our heads. It's being used to create an environment of terror."

He observed that the government will use the proposed three laws -- including those centring OTT platforms and data protection -- ahead of the election.

Journalist orgs condemn attempt to attack Prothom Alo office

Various journalist organisations condemned expressed concern over the attempt to attack Bangla daily Prothom Alo's office, demanding the perpetrators be brought to book.

In a joint statement, Awami Leaguesupported Bangladesh Federal Union of Journalists and Dhaka (BFUJ) Union of Journalists (DUJ) expressed their shock and concern.

On Monday, a few miscreants infiltrated the Prothom Alo office in the capital's Karwan Bazar and attempted to mount an attack, threatening security staff. They fled before police arrived at the

"This type of action triggers terror within the journalist community. There are recognised norms for protest... There is no scope to flex muscle," the statement read.

The statement urged the government to bring perpetrators to book and ensure safety and security of journalists and employees Prothom Alo.

Who will save Karatoya?

Even the district admin pollutes the river, allege environmentalists

Environmentalists and residents of Bogura have demanded that the government take action to save the Karatoya river from influential grabbers who are slowly killing it.

At a public meeting, organised jointly by the Bangladesh Environmental Lawyers Association (Bela), Association for Land Reform and Development (ALRD), Nijera Kori, and Water Rights Forum Bangladesh yesterday, people from all walks of life urged the government to punish those responsible for the river's condition. Officials from various organisations, including the local Water Development Board (WDB), district administration, district police, and Department of Environment, were present at the meeting.

Abdul Khalek, a local, claimed that even the municipality was polluting the river. "Although the court and local administration desired a pollution-free river, nothing much has changed."

Nitanando Das, president of Bogura's Shajahanpur upazila Fishermen Association, said in the past, people used to catch fish from the Karatoya and sell them in Bogura, but today there are no fish in the river as the water is polluted.

During the meeting, Tuhin Wadud, director of the Riverine People, reported that he visited the Bogura DC (Deputy Commissioner) office yesterday morning and found that the office itself was dumping garbage into the Karatoya river. He questioned who would save the river if the DC office itself pollutes it.

Rizwana Hasan, chief executive of Bela, said the High Court ordered WDB to remove the Khulsi Three-Vent Regulator over the river in Gobinaganj and take steps to prevent encroachment and pollution of the river in Gaibandha and Bogura. The court had also ordered the authorities to demarcate the riverbank according to CS maps and water-flow during monsoon, but none of these

85pc inland vessels running without licence Says JS body on shipping ministry

Eighty-five percent of the country's inland waterway vessels are running without licence. Although there are currently over 1 lakh of such vessels in the country, only 15.850 of them have come under registration. As a result, security remains lax, while the government keeps losing revenue.

Inland vessels are those that mainly operate in waterways within the country, not the ocean.

The information was obtained from the minutes of a meeting of the parliamentary standing committee on the shipping ministry.

The minutes of the previous meeting were approved in vesterday's meeting held at Jatiya Sangsad Bhaban.

Director General of the Department of Shipping Commodore Md Nizamul Haque said the department is struggling to enforce shipping laws as all vessels have not come under registration.

"If these vessels are included in the registration, it will be possible to ensure safety. Besides, the government's revenue will also increase," said the DG.

He also informed about the initiative to take up the project of registration of

Abdus Salam, a Boro farmer in Malanchi village of Pabna, said minimum 50kg of fertiliser is needed while planting crop on one bigha of land and another 40 to 50kg during the rest of the cultivation.

"The fertiliser price is now up by Tk 5 per kg, but we will have to buy each kg at a price of Tk 7 to Tk 8 higher. The production cost on one bigha of land will increase by Tk 1,000 to Tk 1,200,"

Tarani Chandra Sarkar, a farmer of Narayanpur village in Nawabganj upazila of Dinajpur, is cultivating maize.

"Still, I have to apply around 150kg fertiliser on the maize land. If the price increases by Tk 5 per kg, I will need another Tk 750," he said.

Quazi Shahabuddin, former director general of Bangladesh Institute of Development Studies (BIDS), said the government has to increase the fertiliser prices in line with the international market.

"Otherwise, the government would need to increase the subsidy. There is a limit of providing subsidy," he said.

"My personal opinion is if I had resources, I would increase the subsidy rather than the price. If you do a comparative analysis, you will see farmers are being jailed for defaulting Tk 1,000 loan but there is no action against big loan defaulters. This is unfair."

Replying to a question, he suggested the government carry out survey to monitor the rise in production cost.

Shahabuddin also said the farmers will pass on the burden of extra

Meanwhile, Communist Party of Bangladesh has vehemently protested the price hike of fertiliser.

Terming it an anti-people decision, the CPB said the government should have increased subsidy to ensure food security. But the government has increased the price instead for the benefit of middlemen and businessmen.

It will pose threat to the country's agricultural sector, said the left party in a statement.

The findings highlight significant improvements needed in maternal and child healthcare over the past five years. One of the achievements highlighted

in the 2022 survey was the decline in the childhood mortality rate.

The under-5 mortality rate decreased from 43 to 31 per 1,000 live births, and neonatal mortality rate declined from 27/1,000 to 20/1,000 live births between 2017 and 2022, reflecting a commendable 12 percent decrease. This decline can be attributed to increased access to quality health services, including facility deliveries and skilled birth attendance.

The BDHS-2022 also showed a decrease stunting among children under five from 31 percent to 24 percent between 2017 and 2022, indicating improvements in child nutrition.

However, the rate of underweight children remained unchanged at percent, highlighting the need continued efforts to address malnutrition.

The survey also revealed positive trends in facility deliveries, with an increase from 51 percent in 2017 to 65 in

Furthermore, the survey showed an improvement in equity in the use facilities for delivery care among different economic groups.

Some 88 percent of pregnant women are also receiving at least one antenatal care session from a trained provider -- up from 2017's 82 percent.

However, the proportion of women receiving ANC4+ (four sessions of antenatal care) declined from 47 percent in 2017 to 41, due to the Covid-19

According to the survey, the Total Fertility Rate (TFR)-- the average number of children a woman would have by the end of her childbearing agehas remained static at 2.3 as same as the TFRs in the previous three BDHS.

The third condition is having a functional central office, offices in at least one-third of the districts and offices in at least 100 upazilas or metropolitans. And the party must have a minimum of 200 members who are voters in each upazila.

Since 2008, a total of 44 political parties got registration and registrations of five political parties were cancelled.

Oikyabaddho Nagarik Andolan, Jatiya Ganatantrik Party lost their registrations as they failed to comply with the conditions of getting registration since 2018.

Besides, registration of the Freedom Party was cancelled in 2009 as it failed to provide the party charter.

Jamaat's registration as a political party was declared illegal by the High Court in 2013.

Following the verdict, the EC cancelled the party's registration in October 2018.

Chinese aircraft, ships remain around Taiwan

Says the island's defence ministry after drills end



Chinese warplanes and navy ships were still in the waters around Taiwan, the island's defence ministry said yesterday after the end of three days of war games, as Taiwan President Tsai Ing-wen criticised Beijing for its "irresponsible" behaviour.

China began the exercises on Saturday after Tsai returned to Taipei following a meeting in Los Angeles with US House of Representatives Speaker Kevin McCarthy.

China, which warned the US not to allow Tsai to visit or meet McCarthy, has never renounced the use of force to bring the democratically governed island under Beijing's control. Taiwan's government strongly disputes

Although China said on Monday night the drills had



ended, Taiwan's defence ministry said it had spotted nine Chinese ships and 26 aircraft, including J-16 and Su-30 fighters, carrying out combat readiness patrols around the island yesterday morning.

Taiwan's air force, navy and shore-based missile crews are closely monitoring and responding, it added. Taiwan's government has repeatedly denounced the drills, but said it will not escalate or provoke.

Writing on her Facebook page shortly before midnight on Monday, Tsai said that as president, "I represent my county to the world", and that her visits abroad, including stops in the United States, are not new and what Taiwan's people expect.

"However, China used this to launch military exercises, causing instability in Taiwan and the region. This is not a responsible attitude for a major country in the region," she said. China simulated precision attacks and blockades of Taiwan during the drills, sending up dozens of fighter jets and bombers.

Taiwan's defence ministry said that on Monday, 91 Chinese military aircraft flew in missions around the island.

OCCUPIED WEST BANK Israeli soldiers kill two Palestinians

Israeli soldiers shot dead two Palestinian gunmen who opened fire at a military post near a Jewish settlement in the occupied West Bank yesterday, Israel's Defence Minister said. "Their successful operation prevented an attack against Israeli citizens," Defence Minister Gallant said in a statement. Earlier, the military had said its forces "neutralised" two gunmen and found rifles and handguns at the scene. There was no immediate comment from Palestinian officials. Israeli-Palestinian violence has surged this year, with frequent military raids amid a spate of Palestinian attacks. More than 90 Palestinians, most of them fighters in militant groups but some of them civilians, have been killed and at least 19 Israelis and foreigners have died since January. Tensions are running especially high as the Muslim holy month of Ramadan and the Jewish Passover coincide. An Israeli police raid on the Al-Aqsa mosque compound in Jerusalem last week triggered rocket attacks on Israel.

Govt must improve road crash data

Reliable official data key to preventing crashes on our roads

Despite fatal road accidents becoming a regular phenomenon in the country, it is disturbing to see how casually this is being treated, with government agencies themselves having no uniform road crash data. Until January, Bangladesh Road Transport Authority (BRTA) used police data on road crashes, but then it started publishing its own. And according to its data, 636 people were killed and 752 others were injured in 630 road accidents in January and February. But this does not match with police data, which says that 542 people were killed and 420 others were injured in 557 road crashes during the

Aside from contradicting each other, these numbers are also much lower than that provided by independent organisations, which puts a question mark on the former's initiatives. Lack of reliable official data could derail the government's plan to implement the National Road Safety Strategic Action Plan 2021-2024 to reduce 20 to 25 percent of casualties by 2024, and to halve the casualty number by 2030. But what number will that be? Besides road safety campaigners, different international organisations have also raised questions about the veracity of our accident data.

The World Bank, for example, which already approved a loan for a Tk 4,988.14 crore project on road safety – under which a road accident database will be developed, among other targets - said that the "poor quality and unreliable data on crashes, deaths, and injuries impede proper road safety management." One may recall that, according to a World Health Organization's report published in 2018, at least 24,954 people were killed in road crashes in the country in 2016. According to the police, however, only 2,463 people were killed in 2016. The huge discrepancy between these figures shows how confusing policy-making can be in the absence of

The reason given by the BRTA chairman for the difference between BRTA and police data is that the latter is based on the cases filed over accidents, but many injured died in hospitals later. Since the BRTA also includes hospital data, its number may be higher. But how will it explain the discrepancy between the numbers of accidents recorded? Either way, the data has to be accurate, which requires developing a uniform system of documentation. In the absence of that, it will be more difficult for the authorities to take proper measures to reduce road crashes.

It doesn't boost confidence when the authorities, far from seeing the error of their ways, criticise road safety campaigners for publishing "fabricated" reports on crashes, as the Road Transport and Highways Division secretary did early this year. Using the classic diversion tactic to cover up their own failure, he said such reports were "tarnishing the image" of the country. But what about the fact that responsible agencies have repeatedly failed to prevent loss of life due to road accidents? Why is it that the same government agencies that criticise data provided by safety campaigners are themselves failing to prepare accurate data? The government must hold them accountable for their failures so they can show better results.

Law alone cannot stop food hoarding

But it's a vital first step, and needs to be implemented regularly

It is heartening to know that the cabinet on Monday finally approved the draft of an act to tackle hoarding of food, among other illegal practices, which has been often responsible for destabilising the market. According to the proposed law, if a person stores more than the amount of food fixed by the government, or breaches any government instruction regarding stocking, it will be considered a criminal offence. The punishment for that will be life imprisonment or a maximum of 14 years' rigorous imprisonment as well as fines. Other crimes related to the production, storage, transfer, transportation, supply, distribution and marketing of food grains such as paddy, rice, wheat, flour and corn have also been brought under the purview of the law, and the punishment for those will vary depending on the magnitude of the crimes.

The development comes a year after the bill was approved in principle by the cabinet on April 19, 2022. We are told that it has been drafted by combining the Food (Special Court) Act-1956 and the Food Grains Supply (Prevention of Prejudicial Activity) Ordinance-1979. Admirably, the government has resisted the urge to introduce capital punishment for hoarding food, which was in the initial draft. This is important because capital punishment, while being something that we cannot condone from an ethical point of view, has also been known to be more of a distraction than a deterrent. In any case, there is already a provision of death penalty for hoarding food in the controversial Special Powers Act, 1974. In case of hoarding, as in case of any other crime, even the strictest punishment

doesn't work if the law is not implemented properly. This is where the challenge will be going forward: enforcement of the bill, when it is passed into law. We have often seen how mobile court drives have been conducted against hoarders, and fines slapped on them, but to little effect eventually. These drives are conducted so sparingly that any effect fizzles out before those could be meaningful. Also, lack of coordination among different government agencies - one of the main reasons why joint public-sector interventions have such poor track records – often gets in the way of those efforts. As well as ensuring regular drives and monitoring in every stage of food supplies, the influence exercised by powerful syndicates and market manipulators also needs to be checked for any law to be effective.

The food sector is going through a critical phase at the moment, with concerns about high prices of production and consumption taking centre stage in national discussion. Although the influence of external factors like the Russia-Ukraine war cannot be denied, poor policy and pre-existing governance issues have also been responsible for the present crisis in the market. We, therefore, urge the government to ensure that the proposed law doesn't meet the same fate as so many other ineffective laws in Bangladesh because of its failure to enforce it properly and evenly.

Can journalists still afford to remain divided on the question of their rights? It's a slippery slope that can take anything, and anyone, downhill. And it's shocking how easily the whole legal infrastructure can be exploited to punish a journalist if enough "reactions" and interpretations can be manufactured.

Facts, once the prerogative of the media, used to be sacred. Now, they are just fodder in an increasingly hostile war of narratives. This is why journalists must support and protect each other. The fundamental issues plaguing our higher education

In recent years, most public and private universities in Bangladesh have been facing blistering criticism for producing unskilled graduates, accentuating grade inflation, and aggravating graduate unemployment. While public universities have regularly been in the news for political unrest, private universities have been under the spotlight for their poor education quality. Overall, our higher education sector seems to be headed in the wrong direction - for many reasons.

First, our curricula for honours and master's heavily rely on Western knowledge. A closer analysis reveals that our education system is either a mimicry of Western education or a tool for developing awareness among our students of scientific inventions and discoveries in the West. Our teachers and students follow Western scholars in every field of knowledge like science and technology, business, agriculture, sociology, psychology, philosophy, arts, and literature. Western knowledge and innovations are certainly the most advanced in the contemporary world. But while learning from western systems can be a positive, mimicking them debases the dignity of local knowledge and the significance of contextual approaches.

No nation can grow without cultivating contextual knowledge, research, and innovations. Our graduates find it difficult to relate their hard-earned knowledge to our context. And our education system fails to train them to solve problems in the context of our business, culture, and society. So, they either find themselves misfits or want to settle in Western countries.

Second, our universities have been promoting educational inflation. Consequently, our employers have been demanding credentialism. In this scenario, the young generation is caught in a maze of higher education in which they are compelled to pursue overqualification. They spend their money, time, and energy on degrees that they hardly get opportunities to use in practical life. A survey done by the Bangladesh Institute for Development Studies (BIDS) found that 66 percent of National University graduates are unemployed. Though 21 percent managed to get jobs, they were underpaid. Only three percent became entrepreneurs. The rest of them were still pursuing postgraduation.

Third, there is a gap between graduates' skills and employers' requirements. Though millions of graduates are searching for suitable jobs, employers claim a shortage of skilled employees. And there seems to be no efficient entity to address this gap. Similarly, policymakers at universities usually show more interest in building infrastructures than in addressing skill gaps and investing in faculty development, research, and innovation. So, the purpose of higher education remains and appreciation from academic ignored, and graduates fail to contribute effectively to our national economy.

Fourth, our universities are well known for producing innumerable graduates in certain popular fields like computer science and business administration. But we do not have any proper study on how many engineers. scientists, and business graduates will be essential in the upcoming years. In addition, our curricula are designed to focus heavily on theoretical and abstract elements, concentrating less on practical application. Students thus end up completing higher studies either in the nonessential fields or with irrelevant skills.

Fifth, we have a lack of research universities, research funds, and an overall lack of appreciation for researchers. Most of our universities offer course-based honours and master's programmes. These coursebased programmes require students to complete only courses and sit for semester-end exams without a thesis or any research work. Though course-based programmes may sound promising for employability, they practically become devalued in actual jobs as most programmes are designed around theories and not based on practical aspects.

Regarding research funding, our universities fail to provide necessary funds and lack collaborations with potential fund providers. So, they neither offer research opportunities nor facilitate job-specific learning.

Worst of all, our researchers and scientists do not receive due respect institutions and policymakers. Many Bangladeshi researchers and scholars perform outstandingly their stay in developed countries, but they hardly get opportunities or respect here. In Bangladesh, government employees seem to be more appreciated and receive more opportunities than researchers. philosophers, and scholars.

The biggest asset of our country is its human assets. The number of students getting admission to universities is increasing impressively every year. But the country's policies seem to prioritise short-term success in business and remittance. We produced thousands of unskilled labourers abroad but are failing to strengthen our backbone through effective higher education, research, and innovation.

Universities must promote research and innovations. They prioritise should researchers innovators, and scholars administrators. They collaborate with relevant industries for research funds and, at the same time, provide job-specific skills and contextual knowledge to students through internships and externships. They should also consider teaching generic skills that are useful for jobs through induction training and short courses. Our universities must generate knowledge that applies to our context, and our graduates must contribute to our society, culture, and economy. They should neither have to find themselves as misfits here nor seek an opportunity to settle in developed countries.

Counselling: An urgent need for university students



Open discussion on mental health is largely ignored in Bangladesh primarily because of the stigma surrounding it. Most people still view mental illness as a taboo; those who are suffering are asked to simply "get over it" or told "it's all in their head." As a result, the burden of mental health continues to increase in the country.

As per the Directorate General of Health Services (DGHS), suicides are on an alarming rise and clearly represents a sign of deteriorating mental health. To focus on this growing crisis in academia, a nationwide study was conducted on students from higher educational institutions – both public and private. Three-fourth of the students were found to be suffering from varying degrees of depression. Using a globally validated scale (Beck's Inventory – BDI III), 21 percent were found to have severe depression. Another 25 percent were suffering from moderate to severe depression, while 26 percent were showing symptoms of mild to moderate depression.

Students reported their daily struggle with issues such as interpersonal relationships and financial concerns. A majority of the students also seem anxious and uncertain regarding the future and added responsibilities of adulthood. "I don't think I am prepared for the world of increased responsibilities," one student wrote. Other students were struggling to find the right purpose in life.

On the academic front, dissatisfaction with their academic programmes and faculty members as well as increased academic pressure were also reported. Many worried about their employment, being stuck in a programme lacking decent job prospects. While the fear of unemployment is common for students nearing graduation, students in



their early years reported their transition to university life as intimidating or exhausting and "often contradictory to what I expected." A number of students stated that the academic programme or career they were pursuing did not fit their personal interests or passion, but they had little choice in the matter.

The Covid pandemic exacerbated their situation. The limited scope for social interactions and on-campus activities was a frustrating experience for most students, leading to a life of loneliness and silent

suffering. Besides, the possibility of delayed graduation and increased unemployment prospects only added to their woes.

While depression takes a serious toll on students, the one aspect that needs our immediate attention is students' suicidal inclinations, a condition said to be the second leading cause of death among the youth around the world, as per World Health Organization (WHO) reports. And major depression is often the factor behind suicidal attempts

As per our study, at least 32 percent of the students reported that they had had suicidal thoughts at some point in their lives. But there's more to be concerned about: 29 students (or about five percent) stated that they would have killed themselves if they could.

This leads us to suggest the importance of mental health counselling and having honest conversations with students about what they are experiencing.

Discussing mental health with family and near ones is not easy, especially in this part of

the world where mental illness is still viewed disparagingly. There are plenty of people who see mental illness and depression as an individual's lacking; some probably even reject its existence – a primary reason why many feel discouraged to talk openly about their suffering and to seek help.

According to our study, 65 percent of the students felt a constant need to be able to discuss their mental health situation with someone. This is where educational institutions can play an important role. Establishing a counselling centre in the university and ensuring easy access is a desperate need of the hour. Some of the universities offer counselling sessions; however, one may argue about their functionality. A majority of the students who reported the need to have a healthy discussion regarding their mental health, in spite of being aware of these opportunities available in their respective campuses, stayed away from taking help. A trust gap was evident.

The way universities address students' mental health needs serious attention. Professional counselling should be made available round the clock, and the staff and faculty members should be educated on this issue. Open classroom discussions also need to be considered to break the stigma, to make the students stay connected to each other, and help out their peers when needed, leading to the students' overall well-being.

Mental health is vitally important but grossly ignored in the university space. The kind of indifference and apathy with which it is treated is appalling and poses a great threat to the future of our students. Thanks to social media, we learn about students' mental health struggles, but surely this is not enough. The youth, our university students, are our future. Failure to recognise their mental health needs will diminish and even suffocate much of their potential. The sooner we realise this, the better. The sooner we act on it, even better.

India's democracy in detention

The sentencing of Rahul Gandhi, the leader of the opposition Indian National Congress, to two years in prison, and his disqualification as a lawmaker in the Lok Sabha (the lower house), has sent shockwaves through India's political system. Beyond reverberating through both houses of parliament, the episode has opened a new and sorry chapter in India's political history, and cast serious doubt on the future of its democracy.

Gandhi was targeted over comments he made during a 2019 campaign speech in the southern Indian state of Karnataka. After discussing India's economic travails, Gandhi named six "thieves" who had contributed to them: Nirav Modi, Mehul Choksi, Vijay Mallya, Lalit Modi, Anil Ambani, and Prime Minister Narendra Modi. "One small question," Gandhi quipped, "how are the names of all these thieves 'Modi, Modi, Modi? Nirav Modi, Lalit Modi, Narendra Modi, and if you search a little more, many more Modis will emerge"

It is obvious that Gandhi was calling out specific individuals for allegedly looting India's economy, before delivering an offhand observation that three of them happen to share a surname. You might say that there was no need for Gandhi to comment on their name at all. But politicians, including many from the ruling Bharatiya Janata Party (BJP), have said far worse in election speeches about all sorts of groups – from rival politicians to minorities – with no criminal case brought against them.

To claim, as BJP lawmaker Purnesh Modi did, that Gandhi's quip defamed the entire "Modi community" as thieves is, at best, a stretch. And to rule, as a court in Surat in the western state of Gujarat did, that it constitutes criminal defamation meriting the maximum possible punishment is worse than suspicious.

The story gets murkier. The judge who first heard the complaint in 2019 mused aloud that it did not seem to have much substance. Rather than risk having his case dismissed, Purnesh Modi rushed off to the High Court to secure a stay of his own petition. Then, two years later, Gandhi made a speech in parliament (largely expunged from the records) accusing the prime minister of crony capitalism, and Modi scurried back to the High Court to get his stay lifted.

How convenient that the judge in Surat was replaced just before Modi's arrival, and the new judge was willing not only to revive the case, but also to deliver a guilty verdict in under three weeks. And how convenient that the two-year sentence the judge imposed is the minimum required to disqualify a lawmaker from parliament for an

additional six years. The BJP was all

The BJP was all too eager to implement the verdict: within 24 hours, the Lok Sabha Secretariat declared that Gandhi was no longer an MP, and on the next working day, he received a letter instructing him to vacate his government bungalow. But Congress politicians smell a rat, with many suggesting that the verdict resulted not from due process but from a deliberate decision, taken at the highest levels, to silence him until well after the next general election.

Gandhi has, of course, filed an appeal, and if the court should grant him a stay of conviction, even the disqualification will have to be reversed. In that case, he could return to the fray, on the streets and in parliament, with his image burnished as the stalwart the government tried to silence. Buoyed by public sympathy and enjoying the enthusiastic support of an energised Congress, Gandhi could prove a much bigger thorn in the BJP's side than he was just a few weeks ago.

Already, the judgment has galvanised India's opposition. Regional parties that traditionally oppose Congress in their states – including the Aam Aadmi Party in Delhi, the All India Trinamool Congress in West Bengal, Samajwadi in Uttar Pradesh, Bharat Rashtra Samithi in Telangana, and the Communist Party of India (Marxist) in Kerala – have expressed support for Gandhi. They seem to have realised that they, too, could find themselves being picked off by a vengeful government. As the adage goes, "United we stand; divided we fall."

A more united opposition would be bad news for the BJP, which holds 60 percent of seats in parliament, but won just 37 percent of the vote in the 2019 elections. If a majority of the 35 other parties in parliament decided to work together, rather than divide the vote, the BJP would find it much harder to win a majority in 2024.


Some cynics suggest that none of this scares the BJP, because it is playing its own elaborate game to push Gandhi to the forefront of the opposition for the next election. A "Modi versus Gandhi" race, the logic goes, is one the BJP is sure it can win. But building up a major rival is an extremely high-risk strategy, which a party that is comfortably ahead in the polls – as the BJP currently is – is unlikely to pursue. The Gandhi debacle looks, instead, like a political own-goal.

But the stakes are far higher than one man, one party, or even one election. As we wait for the curtain to open on the next act in this political drama, Indians should be asking themselves whether democracy benefits when the principal leader of the main opposition party is jailed and denied a voice in parliament for anything less than truly criminal malfeasance? The answer for many – even those who do not like Gandhi or support Congress – is that it does not.

Safeguarding democracy requires ensuring a level playing field for all. What happens to Gandhi, thus, has important implications for India's future. One can only hope that Indians' commitment to representative government will prevail.





"Is it? No, I didn't know," Shakib joked when reminded he is in the team for Ireland series.

should not have been necessary to be in cheaply as well.

Mohammedan had failed to make the Super League last season despite having star players such as Shakib, Taskin Ahmed, Mushfiqur Rahim and Mehedi Hasan Miraz in the squad. Mohammedan officials informed that they hoped Shakib would be available till the April 17, the date of the final round of the first league phase. But if him staying increases their chance of making the Super League, there is concern regarding

what happens afterwards. The DPL has been a major testing ground for players harbouring hopes of making it to the national team. Soumya and Riyad are two looking to make a return and

their performances will not only be vital for Mohammedan but their futures too.

However, Soumya has clearly not impressed selectors. "Not getting what is expected of Soumya. He is still in our thoughts. If he does well in domestic cricket, our pool of players will be bigger. There is no doubt about his ability but also a little disappointed," selector Habibul Bashar told the media yesterday at Fatullah.

"Everyone is talking to him. He is being given the mental support he needs but sometimes, a cricketer has to save himself," the selector said.

Soumya and Mahmudullah have scored a few runs this DPL, but the impact has not been felt. Bashar believed Soumya's batting plan needed to improve. "He has to decide on his batting plan. There is nothing to tell him, he will have to get it himself," Bashar

That plan will have to come through for others if the pool of players for the national team is to get bigger. Afif Hossain has been amongst the runs for Abahani, another looking to return after being dropped.

"Afif is doing what was asked of him. When someone is outside national team, the expectation is they will score runs in domestic cricket and return with confidence," Bashar said.

Soumya too needs to take the cue and score big runs to change his fortune and Mohammedan will be hoping it comes when Shakib will not be there to inspire. But first, they still need to make the Super League. They are currently sixth in the table, with their last title coming in 2009-

Augusto steers Abahani to semifinals

Brothers return to BPL after two seasons

Traditional outfits Brothers Union returned to top-flight football after two seasons with a 1-0 win over Uttara Football Club in a Bangladesh Championship League (BCL) fixture in Kamalapur yesterday.

With two matches in hand, Brothers Union ensured a top-two spot and thus confirmed their Bangladesh Premier League (BPL) berth. Brothers' 45 points from 18 matches now place them two and nine points ahead of BFF Elite Academy and Gopalganj Sporting Club, respectively. However, BFF Elite Academy will not be advancing to BPL.

After getting promoted to the first division in 1975, Brothers Union stayed at the top-flight for 45 years before being relegated from BPL to BCL in the 2020-21 season. Once hailed as the country's third force in football, Brothers had skipped the last season by citing financial crisi before resuming action this season in the BCL.

"The journey was challenging and difficult because of a lack of training facilities and injury problems. However, I was hopeful to take Brothers to the premier division," said head coach Zahidul Islam Milon yesterday.

"A different motivation worked inside me as I once played for Brothers Union for five to seven years to earn bread and butter, so it was an opportunity for me to give back something to Brothers Union.

"I'm really happy to take Brothers Union to the Bangladesh Premier League," said Milon, who had guided Fortis FC to become the BCL champions last season, adding that his ultimate target is to see his charges finish on top of the

Real hope for 'another magical night at Bernabeu'

For the third consecutive season, Real Madrid and Chelsea are facing off in the knockout stages of the UEFA Champions League. And defending champions Real Madrid will have a point to prove against The Blues in Wednesday's quarterfinal first leg at the Santiago Bernabeu.

Despite Chelsea's poor run of form in the Premier League, Real Madrid must be wary of the English club, who have faced Real in the knockout stages of the last two Champions League seasons and beaten them twice in four games.

It was Chelsea who landed the first blow at the semifinal stage in 2020-21, before Real responded in the quarterfinals last season. But Real lost the second leg of last season's quarterfinal at home and progressed only on aggregate following two late goals from Rodrygo and Benzema. Another interesting thing from the two sides' Champions League ties is that in the last two seasons, both times the side that progressed went on to win the UCL title.

Chelsea have only lost one of



and seem to have taken great pleasure on their trips to Spain, having lost one of their last nine UEFA Champions League knockout-stage matches away to Spanish opposition (W3 D5).

And it seemed logical that Real Madrid coach Carlo Ancelotti hoped for another magical night at the Bernabeu against Chelsea, who have dropped to 11th in the Premier League after a run of poor results, motivated to return to the

their seven games against Real of the FA Cup and League Cup, Madrid in European competition despite spending almost 300 million pounds (\$373 million) on new players in January. "We suffered a lot last year," Ancelotti told reporters on Monday.

"We have to respect the team and the club, they have very good players and even if they are not in a good moment they have great motivation and will bring out the best. It's a squad of a very high level.

"The team is excited and and have also been knocked out Champions League and experience

C-sections now 45pc of all deliveries

Shows govt survey

The number of C-sections performed in the country has increased to at least 45 percent in the two years preceding

According to a key indicator report of Bangladesh Health and Demographic Survey (BDHS) published yesterday, the percentage of caesareans, mostly unnecessary, was 34 in 2017-2018 and 18 in 2011.

Since 1985, the international healthcare community has considered the "ideal rate" for C-sections to be between 10 to 15 percent, according to the World Health Organization.

Of the C-sections performed, private facilities accounted for around 84 percent, according to the survey, unveiled at an event in a hotel in the capital.

83 % of child birth at private facilities were C-section followed by 36% in public and NGO facilities each; Of all C-sections, 84% happen in private facilities

"Unnecessary C-sections put both the mothers and the children at unnecessary health risks. But it is booming uncontrollably in the country every day," Dr Setara Rahman, a gynecologist and Country Director of Johns Hopkins Program for International Education in Gynecology and Obstetrics, told The Daily Star.

In the two years preceding the 2022 survey, a total of 36.03 lakh children were born.

Conducted by the National Institute of Population Research and Training, with technical assistance from partners, the survey provides crucial data on key health SEE PAGE 6 COL 3

Tk 303cr lost in Bangabazar fire

Says DSCC probe body in report; 3,845 shops gutted

The fire at Bangabazar Shopping Complex and adjacent markets burnt down 3,845 shops and caused an estimated loss of Tk 303 crore, said the probe committee of Dhaka South City Corporation.

The report of the body, formed to identify the cause of the fire and estimate the loss, said the fire might have started from a burning cigarette or a mosquito repellent

It also dismissed the possibilities of an electric short circuit sparking the fire or arson.

The report added that there was no firefighting system in the markets although they were at risk of fire as they were full of flammable items.

DSCC spokesperson Abu Naser said Marina Nazneen, the probe committee chief and executive officer of DSCC Zone-1, handed over the report to Mayor Sheikh Fazle Noor Taposh yesterday afternoon.

The fire broke out on April 4 and on that day the DSCC formed the eight-member body and asked it to submit the report in three working days.

The probe report said that according to calculations of DSCC's engineers and information from its revenue department and market construction cell, the structural damage to five markets is estimated at about Tk 14.70

The affected shops at Bangabazar Complex Market are 2,961 and the estimated loss is Tk 222 crore, 791 shops were damaged at Mahanagar Market and the loss is Tk 59.30 crore, 59 shops were gutted at Banga Islamia Market and the loss is Tk 4.42 crore, 34 shops are burnt at Banga Homeo Complex and the loss is Tk 2.55 crore, according to the report.

Shops at Anexco Tower, which was partially damaged by the fire, were not included as its traders have insurance. But the structural loss to the market could be Tk 1 crore, the report said.

Helal Uddin, president of Bangladesh Dokan Malik Samity, earlier said the loss caused by the fire could be Tk

UV LIGHT STUDY

Long-hidden ancient Bible chapter found

Scientists have found a longlost "hidden chapter" of Biblical text nearly 1,500 years after it was first written.

The lost section represents one of the earliest translations of the Gospels, according to the study published recently in the journal New Testament Studies. Ultraviolet photography was

used to find the chapter hidden underneath three layers of text by researchers, including Grigory Kessel from the Austrian Academy of Sciences.

"Until recently, only two manuscripts were known to contain the Old Syriac translation of the gospels," Dr Kessel said. One of these is in the British Library in London

and another was discovered in St Catherine's Monastery at Mount Sinai. Researchers said the newly discovered text is

an interpretation of the Bible's Matthew chapter 12 that was originally translated as part of the Old Syriac translations about 1,500 years ago.

They said the fragment is so far the only known remnant of the fourth manuscript that attests to the Old Syriac version, offering a "unique gateway" to the early phase in the history of the textual transmission of the Gospels.
