However, he said that he will clear his position about participating in the upcoming June 21 election.

Six classmates sued for student's murder

Six classmates have been sued for the murder of SSC candidate Mehedi Hasan Sajib of Bhulta School and College in Rugganj, Narayanganj.

Police said the deceased's father Shafikul Islam filed the case with Rugganj Police Station against six named and three to four unnamed persons on Saturday night. All the named accused are the victim's classmates.

Mehedi Hasan Sajib, 16, was hacked to death and his three friends were injured in a clash between two groups of students in front of Bhulta School and College around 12:30pm on Saturday.

Inspector Ataur Rahman of Rugganj Police Station said there was a row between two groups of students over a girl and they locked in a clash. Police are trying to arrest the accused, he said.

Abdul Awal Molla, principal of Bhulta School and College, said Mehedi was supposed to sit for the SSC examination this year.

"The gang would be outfitted with Rab uniforms, walkie-talkies, handcuffs, toy pistols, and other law enforcement equipment. When the first group signalled, the second one arrested the target, seized the cash, and threw them in a secluded location. In most cases,

the victim was subjected to physical abuse, and in some cases, even death," he said.

Harun said Jalal Uddin identified himself as retired captain Jalal, but in reality, he is a sacked army member. The robbers also admitted to two previous robberies, one in Narayanganj and the another in Cumilla.

Masudur Rahman, in-charge of Dhambar police outpost, said the accident happened when the auto-rickshaw was travelling from Laxmankhola stand to Madanpurbus stand and collided with a speeding truck coming from the opposite direction.

The bodies of the deceased were handed over to their relatives without an autopsy on their request. Police seized the truck immediately after the incident, but the driver and his helper fled the scene. A case is under process of being filed, he added.

A month ago, at the same place, in the same way, they killed another rickshaw-puller and stole his rickshaw.

The arrestees gave their confessional statements before a Dhaka court admitting their involvement in the two murders.

Demra Zone Assistant Commissioner Madhusudan Das said they identified the gang in Demra Staff Quarter area. Nayeem joined the group six months back, while Zahid, based in Chonpara of Narayanganj, has been doing this for two years. He is also accused in several narcotics cases.
