Outages intensify despite record power generation

Rural areas experience more load-shedding than cities

Frequent power cuts outside the cities have been making people's lives miserable for a week amid the heatwave.

Keeping in mind the surge in demand during the hottest days of summer, the government planned to produce 16,000 megawatts of electricity during peak hours in April and June.

On Monday, Bangladesh Power development Board (PDB) produced a record-setting 15,604MW, but it still fell short of meeting the peak demand of 16,221MW.

At peak hours over the last one week, the country witnessed a shortage of 1,000MW to 1,500MW, according to PDB data released on its website. Power distribution companies say the power cuts are happening mostly in the rural areas. This means that the people not only suffer from the

sweltering heat, but also fail to properly irrigate their Boro paddy fields. Hundreds of protesters in Feni and Mymensingh demanded uninterrupted electricity in the last few days.

Alarmed by the people's "discontent and anger", Mohammad Abul Kalam Azad, general manager at Mymensingh Palli Biddut Samity-3,

"Intolerable load shedding during extremely hot weather is making consumers suffer, and irrigation is being hampered," he wrote.

Over 50 people in 23 districts told The Daily Star that they were experiencing 10-19 outages a day and the total time they spent without electricity ranged from three to six hours.

They are particularly frustrated because the outages are unpredictable. Last year, the companies published power outage schedules in advance. Officials at Palli Bidyut Samity (PBS), which provides electricity to rural

areas, said the electricity supply was 20-50 percent less than the demand. For the first three weeks of Ramadan, the government had ensured uninterrupted electricity in Dhaka city and other urban areas. People in the capital have yet to suffer any serious power cuts. But as the days got hotter, people in the other cities also began to feel the pinch.

Yesterday, Nasrul Hamid, the state minister for power, expressed regret on his verified Facebook page.

"We had preparations to generate record levels of electricity. But temperature in the country broke 50-year records, and this has increased demand... beyond our imagination," reads the post.

He also apologised to the people, especially the children and elderly. "The Power Division is trying to overcome the situation," he wrote.

The PDB yesterday generated 15,626MW of electricity, setting yet another record.

The country's total power generation capacity is 22,566MW. But several plants remain shut most of the time due to maintenance work, technical glitches, and fuel shortage, said PDB spokesperson Shameem Hasan.

"Because of the weather, the demand is more than what we had predicted... If it rains for only half an hour, the demand will drastically SEE PAGE 2 COL 4

Patients have mostly praised the afternoon outpatient services initiated at some public hospitals on a pilot basis though concerns remain about its long-term sustainability due to the severe shortage of physicians and other healthcare staffers.

When the 3:00pm-6:00pm services in 12 district hospitals and 39 upazila health complexes began on March 30, the government step was welcomed by patients.

But it is far from fulfilling the expectations as almost 40 percent of the posts of physicians -- from ninth-grade medical officer to fifth-grade

NEW SUPER MARKET FIRE Short circuit might have caused it

Say investigators of fire service, DSCC; cops suspect sabotage

An electric short circuit might have caused the fire at Dhaka New Super Market on Saturday, say investigators. Investigators of Fire Service and Civil Defence and Dhaka South City Corporation disclosed the findings

while talking to The Daily Star yesterday. Police, however, smell a deep conspiracy behind the recent fires in the capital. They said an investigation is going on to find who are the conspirators and what their intentions are. They added that militants might be linked

to the blazes. Marina Nazneen, executive officer at DSCC Zone-1, said, "We are suspecting short circuits behind the fire." Two incidents of short circuits took place at Dhaka

New Super Market within a month, said Marina, who is leading the nine-member probe committee of the city corporation.

The committee was formed to investigate the cause of the fire and estimate the loss, and asked to submit the report within seven working days.

The investigators of the fire service department echoed the views of the DSCC.

Wahidul Islam, director (admin and finance) of the fire service, said an electric short circuit might have caused the fire at Dhaka New Super Market.

ASHRAYAN PROJECT It's helping Bangladesh eradicate poverty

Indian magazine lauds PM's initiative

UNB, Dhaka

Prime Minister Sheikh Hasina's 'Ashrayan" project has played a key role in achieving the goals of poverty and hunger eradication, gender equality and women's empowerment, among others, wrote India Today.

Her innovative project, to transform Bangladesh into a developed and prosperous country by 2041, has been able to bring about positive changes in inclusive development by aiming to provide houses for landless, homeless, and marginalised people across the country, the leading English-language magazine of India wrote in its April 15

Whereas examples of low-interest loans for land purchase are found in several countries around the world, Bangladesh becomes the first country to offer free land ownership with houses to its marginalised citizens in order to bring its backward communities into the mainstream, read the report.

"Beneficiaries under this scheme are not only provided with accommodation, but they are also provided with various training, daily allowances during training, and loans after training to make them economically self-reliant.

"The scheme includes empowering women by giving them half ownership of land and houses, providing free electricity connection, providing clean water by installing one shallow tube well for every 10 families, and providing food assistance under three months of VGF to the resettled families initially," the report added.

The magazine article also lauded Hasina's development, known as the 'Sheikh Hasina model"

The "Ashrayan" project is a unique example of how a house can be a major tool for overall family welfare and social development.

The report highlighted the experience of two beneficiaries of the project.

For 30 long years, Moksedul, a brick kiln labourer, waited for a house that he could call his own.

His long-held desire has been granted, as he has been assigned a semi-furnished

house in his own name. Moksedul told India Today that he could live very well with his family now.

The "Ashrayan" project was taken up in 1997 under the leadership of Prime Minister Hasina. And since its inception, approximately 5,07,244 landless and homeless families have been rehabilitated at various stages under this shelter initiative.

Through this initiative, the society's backward community has been given access to semi-finished nousing and two decimals of land.

Heavy gunfire quickly shatters Sudan truce deal pushed by US

Heavy gunfire shattered a 24-hour truce deal in Sudan yesterday shortly after it was due to take effect under US pressure on warring military factions to pause fighting that has touched off a humanitarian crisis

Loud shooting reverberated in the background of live feeds by Arab television news channels in the Khartoum capital region minutes after the agreed 6:00pm (1600 GMT) onset of the ceasefire deal.

Warplanes were roaring in the skies above Khartoum and several witnesses reported a large army ground force entering the city from the east.

"We have not received any indications here that there's been a halt in the fighting," Nations spokesman Stephane Dujarric told a news briefing in New York.

The conflict between Sudan's military leader and his deputy on Sudan's ruling council broke out four days ago, derailing an internationally backed plan for a transition to civilian democratic rule four years after the fall of Islamist autocrat Omar al-Bashir to a popular uprising and two years after a

US Secretary of State Antony Blinken, speaking in Japan, said yesterday that he had telephoned both army chief General Abdel Fattah al-Burhan and paramilitary leader General Mohamed Hamdan Dagalo of the Rapid Support Forces (RSF), appealing for their rival forces to cease fire "to allow the Sudanese to be safely reunited with families" and to provide them with relief.

The ceasefire deal will not extend beyond the agreed 24 hours, Army General Shams El Din Kabbashi, a member of Sudan's ruling military council, said earlier on al Arabiya

A Reuters reporter in Khartoum said he heard tanks firing shortly after the truce was due to take hold.

It was unclear in the chaotic din who was behind the various bouts of gunfire, though the RSF issued a Facebook statement shortly after the truce was to take effect blaming the army for violations.

One resident told Reuters they had heard an air strike being carried out in Omdurman, Khartoum's sister city on the opposite bank of the Nile river.

Four people, including former BNP lawmaker Habibul Islam Habib, were sentenced to life imprisonment yesterday in two cases filed over the 2002 attack on the motorcade of Prime Minister Sheikh Hasina, who was opposition leader at the time, in Satkhira.

Forty-four others were sentenced to seven years in jail in the cases filed under arms and explosive substances acts.

Satkhira Special Tribunal-3 Judge Biswanath Mondal pronounced the verdict around 10:15am, said Satkhira Judge's Court lawyer Faizul Haque.

The three others sentenced to life imprisonment in the two cases are: Upazila Jubo Dal President Kader Bachchu, Kalaroa Municipal Jubo Dal President Arifur Rahman Ronju and former Chhatra Dal president Ripon,

Thirty-seven of the 48 accused are in jail. Of them, 34, including Habib, were present in the court yesterday, the lawyer said, adding that three of the accused could not be produced before the court as they were ill.

Fox News on trial in \$1.6b defamation case

Opening arguments began yesterday in a major defamation trial against Fox News that tests the extent of free speech rights for media in America even when broadcasting election falsehoods.

Dominion Voting Systems is suing Fox News for \$1.6 billion, alleging the conservative network promoted Donald Trump's baseless claim that its machines were used to rig the 2020 presidential election that he lost to Joe Biden.

Dominion argues that Fox News aired the falsehoods while knowing they were untrue.

The highly anticipated trial, the start of which was postponed by a day amid reports the network is seeking a settlement, could become one of the most consequential libel cases ever heard in the United States.

The Daily Star can estimate that the nine hospitals don't have around 70 percent of the manpower required by proposed "standard set-up" of the DGHS.

The Manikganj District Hospital has been struggling to ensure quality service to the patients during the morning shift with 42 physicians. The facility needs around 150 physicians as per the DGHS standard.

"We do not even have an adequate number of physicians and other staffers to run even a 100-bed hospital. But it is now a 250-bed hospital. So, it is very difficult to serve outpatients in the afternoon," Dr Mohammad Bahauddin, the hospital superintendent, told The Daily Star.

Zahid Nazrul Chowdhury, the superintendent of Naogan District Hospital, where afternoon service is available two days a week, shared a similar view.

"We have only one pathologist and one lab technician. It is not possible for anyone to work 8:00am to 6:00pm

The Thakurgaon hospital authorities also provide the service only two days a week as they were already struggling to operate the morning shift.

Despite this, The Daily Star received mostly positive feedback from the patients after visiting half a dozen district hospitals and two upazila health complexes recently.

Forty-three-year-old Mizanur Rahman from Moheshkhali was very happy after consulting an otolaryngologist during an afternoon service hour at Cox's Bazar Sadar Hospital.

He had to pay Tk 300 for the consultation service. The same consultant charged Tk 800 at a private diagnostic centre where he had taken

"This is impressive. If the government strengthens the service, it will greatly help people," said Mizanur Rahman.

On the other hand, a patient who came to show his diagnosis report had to go back as his physician was not present on the second day

District hospitals in Rajbari, Feni and Jamalpur served 15-20 patients daily in the first week of the service.

Officials at the district hospitals in Khagrachhari, Bhola and Jhenaidah had almost a similar experience while the patient rush was low in Manikganj, Naogaon and Thakurgaon.

"The majority of people still don't know about the new service. When

they know, the rush will increase," Dr Monirul Islam, superintendent of the Bhola District Hospital, told The Daily



Traders trying to get back on their feet

Three days after a devastating fire that ravaged Dhaka New Super Market, traders started reopening their shops

During a visit, traders were seen removing burnt clothes and debris, cleaning and sorting goods, and decorating their shops.

The shop owners had to depend on generators to use electric fans and lights, as there was no electricity connection in the market till filing this report at 7:30pm yesterday.

Many who did not have generator connections were seen using charger lights, candles, and cell-phone lights to illuminate their shops.

Around 250 shops on the ground floor, 200 on the second floor, and 50 on the third floor were reopened for business after permission was granted to do so, though most of them had little owner of Himel Fashion on the second

The massive fire that broke out just a week prior to Eid-ul-Fitr, left the market, which was usually abuzz with buyers and sellers, in a devastating state.

Alamin Hossain, an employee of a shop on the third floor of the market, had decorated the shop with new jeans for the upcoming Eid.

But his joy turned into tears as he sat alone in front of his shop, watching everything get burnt to ashes.

"Everything changed for the worse in an instant," said Alamin.

Many traders like Iliyas Akanda are struggling to get back to their previous stream of business

Akanda, an employee of Bismillah Spice Shop on the ground floor, said that the shop was open for four hours and made only Tk 600 in sales, a tiny fraction of the average of Tk 8,000 of sales per day during Eid season.

Another trader, Kamal Hossain,

They emphasised that such incidents could be prevented with the goodwill of the government. They called upon government agencies concerned and city corporations to play a responsible role in this regard.

The statement also urged the government to increase citizens' awareness, ensure accountability, and increase the capacity of the relevant agencies to prevent such accidents.

Expressing their doubts on whether the incidents were accidents or the doings of several vested quarters, they called for a fair and impartial investigation to uncover the true causes behind the fires.

A Dhaka court yesterday granted ad-interim bail to three accused in the murder case filed over the deaths of Awami League leader Jahidul Islam Tipu and college student Samia Afran Jamal Prity in Dhaka on March 24 last year.

The accused are Md Maruf Khan, Mahbubur Rahman Titu, a former local Chhatra League leader, and Maruf Reza Sagor.

Judge Md Asaduzzaman of Dhaka Metropolitan Sessions Judge's Court passed the order after their lawyer submitted an appeal against the rejection orders of the lower court.

In the order, the judge said their bail will remain valid till May 3, said the Dhaka Metropolitan Additional Public Prosecutor Tapash Kumar Pal.

During yesterday's hearing, the defendants' advocate Pran Nath told the court that their clients had been languishing in jail for over 13 months. The IO was asked to appear before it with the progress report on the investigation but they failed.

In the meantime, four of the accused got bail from the High Court on different dates.





A cause worth fighting for

Delhi-based social worker raises awareness on blood donation

Kiran Verma, a youth from Delhi, has walked 12,000 kilometres and reached Bangladesh to raise awareness about blood donation.

He started from Kerala on December 28, 2021 and walked across 169 districts in 12 states in India and reached Bangladesh through the Benapole border on foot on March 11, 2023.

He conducted sessions in Bangladesh at Chattogram Medical College Hospital, Sylhet MAG Osmani Medical College Hospital and in front of Jatiya Press Club. He also worked with local blood banks, voluntary organisations and blood donors to enhance their capacities and motivate people for blood donation.

Kiran's dedication for this noble cause started with an extremely tragic incident.

On December 26, 2016, he got a call in which he was informed that a poor family from Raipur, Chhattisgarh in India needs blood. Kiran went to the hospital to donate to that family.

After donating, he went to meet the family and got to know that the person who called Kiran took Rs 1,500 for the blood which he donated

He got to know that the lady who paid for his blood got into prostitution to pay medical bills for her terminally-ill husband.

Kiran was shocked to his core. On the same day, he left his job and vowed to help people who need blood in case of emergencies. With this motto, Kiran founded a virtual platform to connect blood donors and seekers named "Simply Blood".

The app works like Uber or Pathao, and connects the right donors with seekers without charging anything to anyone.

Travellers suffer without direct bus service

As Eid approaches, several lakh travellers from four upazilas of Patuakhali are facing severe inconvenience, as direct bus service between these upazilas and Dhaka have been suspended.

This disruption sticks out since Padma Bridge's inauguration last year was supposed to make transportation on these routes more efficient and convenient. However, since the bus owners' association of Patuakhali discontinued their service, citing issues with route permits, ordinary passengers and businesses alike have been left in the lurch.

Deputy Commissioner Shariful Islam assured the public of resolving the issue, but with Eid fast approaching, no such steps have

According to sources, bus service between Baufal, Galachipa, Dashmina, and Dumki upazilas in Patuakhali and Dhaka began in 2000. Although such a service had been operational for the past 23 years on this route, the bus association discontinued it in August last year, claiming that the owners do not have permits from authorities concerned to continue operation.

However, the bus owners could not come up with satisfactory answers when asked how other upazilas of the same district have operational bus service.

Apart from ordinary passengers, these buses were also used to transport various agricultural products and fish.

In October 2021, the launch of Payra Bridge in Patuakhali and Padma Bridge inauguration in June last year have made transportation on these routes more efficient, resulting in a

significant increase in passenger and goods transport on these routes compared to ferry services.

Locals said at least 2,000 passengers from the upazilas travel to Dhaka every day.

Rashid, who works in Dhaka, said, "I can't get a direct bus to go home [Galachipa] during Eid. Last year, I went to my village directly from Dhaka by bus, but this year, I don't understand why buses are not operating.

Echoing the same, another individual, Anwar, said, "We are being deprived of the

Curse of load shedding grips Sylhet city

Sylhet residents are suffering due to excessive, unscheduled load shedding, only a couple of days after the country saw record electricity production

Bangladesh Power Development Board (BPDB), claimed that heatwaves and increased demand are responsible for the situation.

It also claimed that electricity production drastically collapsed as Rampal 500-MW thermal power plant, Ashuganj 900-MW plant and Chattogram 210-MW plant are closed due to 'technical glitches'. Besides, Hathazari 132/33-KV grid substation's power transmitter recently exploded.

Abdur Rahim, a resident of Sylhet city's Baluchar area, said, "We are facing an hour of load shedding every two hours, sometimes even less. And it happens even at night, making it difficult

Nahid Tarana, a resident of Madina Market area, said, "Since Friday, unscheduled load shedding is making our lives harder, as it occurred during sehri and iftar. This is unacceptable when they claimed to have produced record-high electricity only a couple of days ago."

On April 12, BPDB claimed to have produced a record 14,932 MW of electricity in a day till 9:00pm (peak hour) while the production was 14,800 MW the previous day.

According to BPDB and Palli Bidyut Samity (PBS), Sylhet division's electricity demand for April 16 was 497.47 MW, while the national power grid allotted a supply of 310 MW with a deficit of SEE PAGE 4 COL 2



Town protection embankment, riverside villages face erosion threat

Illegal sand lifting from the Poulee river, a branch of Jamuna, in Tangail's Kalihati upazila has been continued unabated. Moreover, the sand carrying trucks are using the embankment-cum-road to supply the sand in different areas, leaving many riverside villages and the embankment under erosion threat in the

Locals alleged that an influential quarter has been lifting sand illegally from west side of the Poulee Bridge and the eastern part of the Poulee Railway Bridge on Dhaka-Tangail highway for long.

The ill practice was stopped from only a few days after the local administration launched mobile court drives against the perpetrators.

But, recently they got back into the business once again.

The sand traders, however, claimed that they have been lifting sand from their own lands after taking permission from the authorities concerned.

They said alongside the riverside villages, the Tangail Town Protection Embankment, also known as Silimpurerosion threat as the sand traders are

the lifted sand on large trucks.

Villagers said frequent movement of the trucks on the earth-filled embankment is also causing severe dust pollution, resulting respiratory problems among many residents of nearby villages.

They do not even dare to protest the illegal act as the syndicate men are quite powerful and many of them have political

Several small and large cracks already developed at different places of the embankment, which was constructed under Compartmentalization Pilot Project (CPP), spending Tk 120 crore in 2000.ro

If the embankment breaks during the monsoon, vast areas in Tangail town, Gala and Gharinda unions in Sadar upazila, and adjacent Basail upazila could be flooded.

Mohammad Sazzad Hossain, executive engineer of Water Development Board (WDB) in Tangail, said concerned upazila and district administrations have been informed of the matter.

It is important to take action and protect the embankment, he said. Kalihati Karatia Embankment, is facing serious Upazila Nirbahi Officer Nazmul Hossain said they were conducting drives to stop using the embank as a road to transport the illegal sand lifting and sale.

34m Afghans in poverty under Taliban rule: UN

AFP, Kabul

The number of Afghans in poverty nearly doubled to 34 million as the nation was racked by the collapse of the US-backed government and the Taliban takeover, the UN said yesterday.

After the US-backed republic fell in 2021, vast foreign subsidies were halted and aid programmes dramatically cut back as many countries refused to deal with the Taliban.

In December last year, those NGOs still providing vital help were dealt a further blow by a Taliban government order barring Afghan women working for them.

This month, curb was extended to UN's Afghan female employees and the organisation said it faces an "appalling choice" over whether to continue aid schemes. Yesterday, UNDP released data estimating 34 million Afghans were living below the poverty line.

Saudi FM meets Syria's Assad in Damascus

Svrian President Bashar al-Assad met with Saudi Arabia's top diplomat in Damascus yesterday, state media reported, ending more than a decade of diplomatic deep-freeze between the two countries.

G7 ministers stress unity

Promise to intensify sanctions on Moscow for

The Group of Seven industrial powers drew together yesterday to criticise China's coercion of Taiwan and Russia's threat to station nuclear weapons in Belarus, promising to intensify sanctions on Moscow for its war on neighbouring Ukraine.

"The strength of the solidarity between the G7 foreign ministers is at a level not seen before," Japan's Foreign Minister Yoshimasa Hayashi told a news conference after hosting a meeting of the group in the Japanese resort town of Karuizawa.

The show of unity comes after French President Emmanuel Macron this month said the European Union should reduce its dependency on the United States and cautioned against being drawn into a Taiwan crisis.

Beijing, which views Taiwan as Chinese territory and has not renounced the use of force to take the democratically governed island, rebuffed the G7 comments as gross interference in its internal affairs, however.

Russia steps up assault

Detained US reporter denied bail in Moscow

Russian forces stepped up heavy artillery bombardments and air strikes on the devastated eastern Ukrainian city of Bakhmut, while President Vladimir Putin has met his commanders in two regions of Ukraine that Moscow claims to have annexed.

The Kremlin said Putin had attended a military command meeting in Ukraine's southern Kherson region and visited a national guard headquarters in eastern Luhansk. It did not say when the visits took place.

Putin heard reports from commanders of the airborne forces and the Dnieper army group as well as other senior officers who briefed him on the situation in the Kherson and Zaporizhzhia regions in the south.

"It is important for me to hear your opinion on how the situation is developing, to listen to you, to exchange information," Putin, 70, told the commanders.

In Moscow, US journalist Evan Gershkovich's appeal against his pre-trial detention in a Moscow prison was rejected by a Russian court yesterday.

Gershkovich has been ordered to be held at least until May 29 on espionage charges. Before the hearing got underway, Gershkovich turned around when one of the Russian reporters in the courtroom told him to "Stay Strong!" and relayed to him that everyone said "Hi". A masked man with "FSB" written on his black uniform stood beside the cage as the judge rejected the appeal.

US man charged with shooting Black teen

Prosecutors in the US state of Missouri announced felony charges on Monday against an 85-year-old white man after he allegedly shot and severely wounded a Black teenager who mistakenly rang his doorbell. Ralph Paul Yarl, 16, was in critical condition after he was shot twice, once in the head, last Thursday night when he rang the doorbell at the wrong house while trying to pick up his twin brothers from a friend's home nearby. Outrage rose over the case throughout the weekend, after it was revealed that the homeowner had been released without charges following 24 hours in

Mexico president slams US 'spying'

Mexico's president said Monday that his country would not tolerate spying by US on its security institutions, as an intelligence leak sparked new diplomatic tensions between the neighbours. "Acts of spying cannot be used to find out what our security institutions are doing and, furthermore, with the arrogance of leaking the information to The Washington Post," Andres Manuel Lopez Obrador said. He was referring to a report citing a leaked US classified document on tensions between branches of Mexico's armed forces.

EU Parliament adopts sweeping reforms

The European Parliament yesterday approved sweeping reforms to make EU climate change policies more ambitious, including an upgrade of the bloc's carbon market that is set to hike the cost of polluting in Europe.

Europe's carbon market forces power plants and factories to buy CO2 permits when they pollute. It has slashed those sectors' emissions by 43 percent since 2005, but is facing a revamp to hit more

ambitious EU climate change targets. a large majority, a deal agreed last year by negotiators from EU countries and Parliament, to reform the carbon market to cut emissions by 62 percent from 2005 levels by 2030.

Under the upgrade, factories will lose the free CO2 permits they currently receive by 2034, and shipping emissions will be added to the CO2 market from

Lawmakers also backed the EU's world-first plan to phase in a levy on imports of high-carbon goods from 2026, targeting imports of Parliament voted to approve, with steel, cement, aluminium, fertilisers, electricity and hydrogen.

Toxic alcohol kills at least 27 in Bihar

Toxic hooch has killed at least 27 people in the eastern Indian state of Bihar where alcohol is banned, officials said vesterday, with unconfirmed reports putting the death toll at 40.

Selling and consuming liquor is prohibited in several parts of India, driving a thriving black for potent market and sometimes lethal backstreet moonshine that kills hundreds every year.

Initial investigations into the latest tragedy showed that poisonous methyl alcohol was mixed with spirit that proved deadly.

Police official Jitender Kumar told AFP that 27 deaths had been reported since Saturday.

Kumar said most of the victims were from poor families and used to consume locally made cheap tipple known as "Desi Daru".

Some local media put the toll at 40. Police have arrested 174 people in connection with illegal manufacturing, sale and supply of liquor over the last three days.

They have also seized and destroyed over 900 litres (240 gallons) of toxic liquor during raids.

How can abuse of privacy be legal?

Govt must address concerns about the draft data protection act

Data is knowledge and knowledge is power. This is why protecting data is so vital, but some of the provisions in the draft act that Bangladesh is considering in this regard are something that we can do without. The invasive nature of the bill is neither respectful of citizens' privacy nor democratic in spirit. It is certainly not in step with international data protection standards. A recent assessment by the Transparency International Bangladesh (TIB) - that it will "put the entire society under surveillance" - shows that there is more at stake here. At a time when concerns are being raised over such attempts by the government, the length to which this bill, if passed into law as it is, could be potentially used is certainly

One of the reasons behind this assessment is the bill's strict data localisation requirements. It makes it mandatory for every person or organisation dealing with data to enrol in a "data protection register", where they must state what type of data they are collecting and processing and why. Not only is this logistically impractical, it also adds a layer of bureaucracy at odds with how the internet functions. Furthermore, according to the TIB, even though stakeholders have been demanding that an independent commission be formed to oversee the implementation of the law, the bill puts a governmentcontrolled agency in charge, giving it "unlimited powers" to access data without citizens' permission or explicit knowledge, and even without any judicial oversight. Ideally, along with operational independence, any institution in charge should have in-built provisions to check abuse of authority. The bill ensures neither.

Although recent changes to the draft sought to allay some concerns about data localisation requirements - creating scope for transferring data in case of international trade and international relations - the Data Protection Act (DPA) is still too restrictive, invasive and vague, just like its ideological cousin Digital Security Act (DSA). For example, there is no clear, detailed definition of data, and no mention of the definition and standard of privacy. All this has led to legitimate fears that it will "allow deep government surveillance in the guise of data governance and interference with individuals' privacy rights, not to mention increase the space for abuse of power," as one of our columnists put it. Thanks to the DSA, we now know that it is mostly political rivals and critical voices who will be subjected to such abuse, all in the name of state interests.

This is totally unacceptable. We urge the government to immediately revise the draft in light of the concerns raised by experts, human rights defenders and our international partners. Personal data shared on various online platforms must be protected at all costs from any kind of breach and abuse, particularly from government agencies and law enforcement forces. The law must clearly address all potential loopholes, and provide for an independent data oversight authority which can be trusted to check any breach of privacy. Otherwise, there will be no point at all for a data protection act.

Drop in life expectancy an ominous sign

It shows the overall quality of people's lives has deteriorated

It is disheartening to know that the average life expectancy of Bangladeshis went down by six months to 72.3 years in 2021. Even though it might not be a big drop statistically, it illustrates that people's living conditions have deteriorated in recent times. According to a former chairperson of Dhaka University's population sciences department, the impact of Covid-19 and its post-effects, including reduced access to healthcare facilities, poverty, reduced intake of notorious food, and lifestyle, could be the reasons for the decline in life expectancy and the simultaneous rise in crude death rate, which increased from 5.1 per thousand people to 5.7.


According to data, men's life expectancy declined more than women's. In 2021, men's life expectancy came down to 70.6 years from 71.2 years, and women's from 74.5 years to 74.1 years. The study also revealed an increase in the maternal mortality rate in 2021, with 168 maternal mortalities reported per lakh childbirths. Since the beginning of Covid until now, life has gotten harder for most people in the country due to numerous disruptions to essential services. Prices have continually kept on rising, with inflation hitting record highs at various times. This has forced many people to change their daily diets, including by cutting down on protein and other nutritious food.

The inability of people to afford the same quality of diet they once did is surely going to have a significant effect on their long-term health. Additionally, the mental stress that they are experiencing due to the rising cost of living and from various uncertainties, as well as increased unemployment post-Covid, could also be factors affecting their life expectancy. Another reason which is likely contributing to it is the quality of air that those living in places like Dhaka are having to breathe day in and day out. A few recent studies have also confirmed this.

High levels of depression, a sense of hopelessness and stress are all known reasons that lead to a decline in people's life expectancy. According to the 2022 Global Emotions Report, Bangladesh ranked seventh among the world's angriest, saddest and most stressed nations. In the World Happiness Report 2023, Bangladesh slipped 24 notches to rank 118th out of 137 countries, which shows Bangladeshis have become less happy in recent times. All of these are connected factors that are affecting people's life expectancy.

The increased uncertainty and a sense of overall injustice in the country, decreased security – including financial security amidst rising inflation and declining savings and sources of incomes - coupled with greater squalor and other poor environmental factors are all leading our citizens to become more miserable, stressed, unhealthy and likely to live shorter lives than a few years ago. All this shows that the country is, in large parts, heading in the wrong direction. We urge the authorities to address the underlying reasons behind it and rectify them for the sake of a happier and longer life for citizens.

Who will be AL's main challengers in the city polls?



Amid the rising mercury that has brought hardship to many across the country, the heat has been slowly and surely rising in our political sphere as well, with the potential to bring about a different kind of turmoil. In this context, the upcoming elections to five city corporations, scheduled to be held between May 23 and June 29, will act as catalysts for the political heatwave. And political commentators believe that this wave may continue all the way to the parliamentary elections, which are slated to be held between December this year and January next

Although a month away from the city elections, the ruling Awami League has already nominated its candidates, two of whom are new faces while two others are experienced and tested leaders. The exception is Azmat Ullah Khan, who ran in the 2013 elections but lost, and was not given the party ticket in the 2018 city polls.


Judging by the nominations, the Awami League is telling its leaders and activists that those who were expelled from the party can return, but there is no guarantee of getting the party ticket. It is also sending out the message that if its leaders can demonstrate that they are still popular among the electorate, then party blessings will follow in the form of a nomination. But perhaps most importantly, those who tarnish the image of the party with controversial activities will not win the nomination, no matter who they are.

Analysts agree that the upcoming general elections are crucial for the ruling party as, this time, it might not be a repeat of 2014, when the BNP boycotted the polls and the ruling party contenders were elected uncontested in 153 constituencies, or of 2018, when THE STREET VIEW to those of 2013 and 2018. In 2013, a winning mayoral candidate; and the BNP-backed contenders won all five city polls, but in 2018, except in Sylhet, the BNP-nominated candidates lost. In 2018, there were allegations of vote-rigging and forced occupation of polling centres. But this year, as the BNP will not nominate any candidates, the election will be predictably less

competitive.

second, there is a lack of confidence about the fairness of elections. However, they are contemplating participating in the polls to show their presence.

On the other hand, Islami Andolan will file its nominations for all five city corporations. The party has been contesting all the local government elections and have gotten some good

the BNP joined the polls but ballotstuffing allegedly took place the night before. The party may face a huge challenge from the opposition parties, although the BNP still maintains that it won't participate in the polls under the Awami League government.

It would be risky for the ruling party to bank on controversial leaders to form the next parliament. Thus, it is perhaps through this round of nominations that it is conveying to the aspirants that this policy is likely to remain for the general elections too. That means we might see a good number of new faces in the general elections as MP contenders with Awami League tickets.

The upcoming city elections are likely to be less challenging compared

As the BNP and its like-minded political parties are likely to boycott the city polls as part of their ongoing campaign demanding elections under a non-partisan interim government, who will be the main contender against the ruling party? Though it is not confirmed yet, it is assumed that the main opposition in parliament, Jatiya Party, and the right-wing Islami Andolan Bangladesh may participate in the city polls. Jatiya Party is yet to finalise its candidates, and it is still uncertain whether it will file nominations for all five city corporations. According to media reports, Jatiya Party leaders said their top leadership was not interested in city corporation elections for various reasons: first, the party does not have

results: in Rangpur city polls, the party's candidate managed to bag the second place with around 50,000 votes.

If any BNP leader contests the elections violating their party position, the current state of complacency within the ruling party will be severely disrupted. And if any ruling party candidate contests as an independent candidate, the situation may become all the more interesting.

But the question still remains: who will be the main challengers against the ruling party candidates in the city polls? We have to wait a few more days to find out. As the nation waits for a heavy downpour to cool down, it seems politically things are about to

At the same time, we need to raise the level of awareness among the general public as well as the relevant agencies, so they can take measures to protect themselves from heat stress during peak temperatures.

Finally, we need to learn from our neighbouring countries like India and Pakistan, who have much more experience of dealing with severe heatwaves. In fact, the International Centre for Climate Change and Development (ICCCAD) recently joined with a leading Indian research institute to develop a heat action plan for the city of Rajshahi in northern

the hottest weather in over six decades, and this is likely to become the new normal going forward.

While Bangladesh has a lot of positive knowledge and experience in tackling cyclone and floods, we have not taken heat stress into consideration until now. In fact, we don't even maintain statistics of heatrelated deaths.

Hence, we need to rapidly start to find ways to deal with heat stress, including providing training to doctors so they are able to diagnose

vulnerable – and hence need to be prioritised - are farmers working in the fields, as well as day labourers and rickshaw pullers. The protective measures can range from simply staying out of the sun to ensuring plenty of water intake and knowing where to get medical treatment for heat-related health issues if needed.

People also need to be made aware of how to keep themselves cool at home; this is particularly relevant for slum residents in major cities like Dhaka.

Among those who are most Bangladesh. Similar heat action plans need to be developed quickly for other cities and towns as well as for the rural parts of the country.

The scientific community has made it crystal clear that the whole world has entered the era of loss and damage from human-induced climate change, and that no country is prepared for what is to come. While this is certainly bad news, Bangladesh can lead the world in tackling the climate change impacts in coming years.

It's impossible not to feel the heat these days. Even if you are riding this out in the comfort of privilege, you must surely know your country is in the throes of one of the worst heatwaves in decades. The nation has been sizzling as the mercury rises, breaking old records over the last few weeks. Even our memes the internet's conduit for the latest cultural conversation – are hot on the heels of "THE BIG HEATWAVE OF

conversations start with an acknowledgment of the overwhelming heat: "I wore my lightest outfit to survive this heat"; "I showered three times today, but then water has run out in our building"; "We have one AC in our house, but I worry about using it because I cannot cope with the bills, and I have recently started sharing the electricity bill with my parents"; "I came to work because there is at least AC here... in my house, the walls are hot, the floor is hot, and water is in short supply; there really is no way out."


The pages of our newspapers and the hourly news on TVs and radios are all highlighting different angles of the heatwave. A photograph published in this daily captured rows of devotees lying around the floor of the national mosque, reluctant to leave the premises even after the afternoon prayers ended. Owing to the heatwave, the Bangladesh Railway authorities asked trains to lower their speed, nearly halving it from the usual. This is because the temperature of railway tracks is always higher than the general environment, and there an AC - in essence protecting you the likelihood of extreme events,

melting or expansion of the tracks due to extreme temperature. Health experts have recommended that children and older people stay home, and have also requested people to stay safe from heat strokes. The jail authorities, too, have taken measures to ensure that inmates are protected from the heatwave.

But here is something else to consider: do we all feel this heat similarly? The answer is obviously no. It is no secret that if you are among the well-off in this not-so-well-off nation, you are better equipped to deal with this heatwave. There is a deep running inequality as to how the heat

Imagine having to take the bus, or having to ply a rickshaw, or operating a roadside stall in this ominous, oppressive heat that you know "really feels" like 50 degrees.

This year, Dhaka has experienced its hottest day in 58 years. Extreme weather events have become the norm owing to climate change. And yet again, it is putting the disparities between the rich and poor under a magnifying glass. The city's well-off (the numbered few) have been riding out the heatwave blissfully hunkered down in their cool homes, offices, cars and shopping malls.

If you are a slave to statistics, then let me apprise you on some harrowing data. Human-induced climate change is exacerbating heatwaves. And who is most affected by these intensified heatwaves? Poorer nations – nations that have had very little contribution towards climate change in the first place. A report published in the journal Science Advances last year confirmed this matter: periods of extreme heat cost the global economy about \$16 trillion between 1992 and 2013. But while the richest countries lost about 1.5 percent of their annual per capita GDPs dealing with heatwaves, poorer countries lost about 6.7 percent of their annual per capita GDPs. Another report published early last year said the lower-income population around the world faced a 40 percent higher exposure to heatwaves than people with higher incomes. Do

change also means hotter and longer you see the tragedy? The cost of extreme heat from climate change is disproportionately borne by those least culpable.

There is more. Dhaka and other major cities in Bangladesh are especially ill-equipped to deal with this rising temperature. Rapid and unplanned urbanisation, coupled with extreme population density and the loss of water bodies and open natural spaces, compounds the effects of the heat. Where will a tired rickshaw puller take respite when there is no shade from the old ficus tree anymore? It's not like the rich will allow them to walk into a shopping mall and let them breathe in the cool conditioned air, will they? A study published in the PNAS journal has found that Dhaka is among the worst-affected by urban

heat in the world.

Research has confirmed that many areas in Dhaka, Chattogram, and Khulna are turning into "urban heat islands." When cities replace natural land cover with dense concentrations of pavement, buildings, and other surfaces that absorb and retain heat, they end up creating "urban heat islands." This in turn increases energy costs, air pollution levels (God knows Dhaka does not need any more of that), heat-related illnesses, and mortality. Do you see the vicious cycle we are stuck in?

To fight this, we need global action. Wealthy countries, the ones disproportionately responsible for the climate crisis, have a double responsibility: cut emissions at home, and support the developing nations with the costs of replanting crops, rebuilding homes after storms, and moving from dirty energy to cleaner, lower-carbon ones. We need national actions to combat the effects of climate change: implementation of the National Adaptation Plan (NAP) as well as the Mujib Climate Prosperity Plan (MCPP), and increased investment in climate-resilient infrastructure, emissions mitigation, protection of the remaining water bodies, and decentralisation of our

There are no two ways but to improve our cities to better fit the current weather patterns. In the interim, the authorities need to help people cope. Localised solutions for immediate relief have borne fruit in other countries. Why can't Dhaka try and implement some of those? The solutions include bringing back trees, allowing those remaining to flourish, reclaiming wetlands and water bodies, painting roofs white especially in cramped housing where heat gets trapped easily, placing water dispensers across the city, incentivising rooftop gardens, and lastly, for immediate relief, allowing more people to benefit from the cooling systems in the existing

When academic institutions elsewhere are striving to bring out

educationists, etc who devote and using knowledge, how do our academics measure up? As numerous transgressions of ethical norms in academia go unheeded, it is imperative to revisit the question of ethical conduct and appropriate guidelines for our educators.

Such a concern stems primarily from the realisation that it is the teachers who will be in primary contact with the next generation. If their values and behaviours are compromised, what does the future portend? With the education system in peril - and with that the society itself - where are the guidelines?

How are they enforced? For teaching to be considered a noble profession, Bangladesh needs a strong and ethically driven education system today. If we have to educate our educators on ethical practices, we must collectively start working now to produce/prepare the next generation who will not need a programme on ethics for teachers. Until then, to shape appropriate academic behaviour, we must figure out essential ethical guidelines and the ramifications for any transgression. We know quite a bit about the transgressions, but very little about how they are confronted and addressed. Without consequences, as BF Skinner - the proponent of operant conditioning theory - would say, repetition of unethical behaviour will only recur.

To be fair, the question of ethics goes far beyond the borders of educators and the education system. Not a day goes by without being accosted by some ethical confrontation with the gatekeepers and power brokers who scorn ethical norms – in healthcare, law and justice, bureaucracy, banking, business transactions, etc. The waft of moral decay is already palpable; some sense that it is poised to worsen. When a nation's moral structure crumbles, society will also crumble with far-reaching consequences. Showcasing the economy with spectacular physical infrastructure development has its limits; combined with a steel frame of moral strength, the potential of

The curious case of nonexistent water supply

CWasa billing residents in exchange for no service

CWasa is defrauding residents by collecting bills without providing them with water. It is

Rokeya Begum, a resident of Mokbul Ahmed Society in the port city's Patenga area, has been paying bills to Chattogram Water Supply and Sewerage Authority (CWasa) for the last three years. However, she has not gotten any water since 2019.

"We got a connection from CWasa in 2019, but we are yet to get any water from them. And yet, I'm paying around Tk 600 every month," said Rokeya.

Following complaints from the city's residents, CWasa's revenue department listed the names of many such clients who have been paying bills in exchange for no service.

According to the list, more than 400 clients in different areas of Chattogram city are suffering from the same problem.

Iftekhar Ullah Mamun, executive engineer of CWasa, admitted that many clients in different areas, including Patenga, Katgor and Halishahar, are not getting water even though they are paying their bills regularly.

"Our supply lines remained ineffe while the production also decreased due to the increasing salinity of the river water," said

Speaking at a workshop recently, Kafil Uddin Khan, a councillor of Chattogram City Corporation and resident of port city's Muradpur area, said, "Even as a public representative, I'm not getting any water from CWasa despite paying bills every month. I only wonder -- what are the common people going through?"

CWasa officials admitted that they have not developed an effective water-supply system in the port city in the last 59 years due to various complications.

According to CWasa documents, the organisation currently supplies water to around 80,000 households, while the rest get water from deep tube wells.

CWasa produces more than 45 crore litres of water per day and supplies water through a 1,000-kilometre supply pipeline to the port

However, it counts Tk 50 crore in losses annually, as 28 to 30 percent of the water produced does not generate any revenue, resulting in a "system loss".

SM Nazar Hossain, vice president of the Consumers Association of Bangladesh (CAB), said, "CWasa is defrauding residents by collecting bills without providing them with water. It is absolutely unethical."

"CWasa is a state organisation, and therefore, its officials need to be held accountable for such fraudulence," he added.

Meanwhile, the water scarcity has compelled port city residents to collect drinking water from unsafe and unhygienic sources, resulting in various health complications.

Shemanta Waddadar, a consultant of Chattogram Medical College Hospital, told The Daily Star that a community's lack of access to clean water is a major factor in the spread of waterborne diseases.

During a recent visit to Patenga, this correspondent found that residents, who have water connections in their houses, are forced

to buy water from vans for drinking.

Ali Akbar, a local, said, "CWasa provided us with a supply line on an emergency basis. However, despite repeated complaints to its authorities, we are yet to get any water from the line. It has been three years."

"We are now forced to buy water at exorbitant prices and drink contaminated water," he claimed.

Following an acute water shortage, a waterselling syndicate has also formed in the area.

Faruk Hossain, a resident of Mokbul Ahmed Society in Patenga, told The Daily Star that 10 families live in his building, who buy water at a rate of Tk 20 per drum.

Trader Mohammad Shakeel said, "We make a profit of Tk 5 for selling a drum of water."

"We're struggling to make ends meet due to this added cost, at a time when prices of all daily essentials are on the rise," said Tofazzal Hossain, a resident of Mills area in Patenga.

"Even CWasa's field staffers are not responding to our urgent calls amid such a crisis," he added.

Residents of the port city have been demanding a steady supply of water for quite some time now. They have demanded a waiver of line charges if that is not ensured.

Maksud Alam, chief engineer of CWasa, said, "We will waive the line charges for those who are paying the minimum bill without getting water. We have already asked them to contact us."

"We are working on the issue. Hopefully, we will solve the crisis soon," he added.

People seeking fresh notes ahead of Eid

With Eid-ul-Fitr knocking at the door, people of the port city have been demanding for fresh currency to make the occasion more special. Taking the advantage of a reported crisis of fresh notes in the banks, sellers have raised the "price" compared to the previous year.

Although currency trading is illegal, buyers and sellers were found trading notes in New Market, Agrabad, and Court Building areas displaying bundles of fresh notes of different denominations.

During a recent visit to New Market CDA Biponi Bitan area, this correspondent saw people of different professions gathering to trade old notes in exchange for fresh ones, where sellers bargained for extra.

Buyers claimed that when they went to get fresh notes from banks, they were told banks do not have them as many have already collected them beforehand considering Eid. As a result, they could not get their desired notes in the required

amount and resorted to these marketplaces to get

Sellers said this year, the demand for Tk 2, 5 and 10 notes is higher as the prices of Tk 50 and Tk 100 notes have increased compared to the previous

To buy a bundle of Tk 2 and Tk 5 containing 100 notes, a buyer has to pay Tk 220 and 520, respectively, they said. A bundle of Tk 10 containing 100 notes was being sold at Tk 1,100, while a bundle of Tk 20 was being sold at Tk 2,150, a bundle of Tk 50 at Tk 5,250, and a bundle of Tk 100 was being sold at Tk 10,400 to Tk 10,500.

Md Abdul Jalil, a fresh note trader, told The Daily Star, "This year, business is not going well. However, the demand for Tk 2 and Tk 5 notes is high as people are taking them for children's 'salami' on Eid Day."

Wishing anonymity, a Bangladesh Bank official said, "Bangladesh Bank has been providing iresn notes worth a maximum of Tk 18,000 per person, including Tk 10, Tk 20 and Tk 50 notes, after verifying the note seeker's identification and other information during the banking hours."

However, failing to collect fresh notes from banks, Rashedul Parvez, a university official, came to New Market.

"Fresh notes can work as a source of joy during Eid, especially for children. I couldn't collect them from the bank, so I came here to get them," he said.

With Eid-ul-Fitr right around the corner, shopping at footpaths in Chatogram city is gaining momentum and small roadside vendors are passing a busy time now.

According to vendors, mostly people from low and lower-middle-income groups are the customers of the footpath shops.

While visiting different areas of the city, including Chawkbazar, Anderkilla, New Market, Sholashahar Gate 2, Agrabad, CEPZ, Jubilee Road, Station Road and Bahaddarhat areas, this correspondent witnessed huge crowds of people buying shirts, t-shirts, pants, panjabis and kids' attires from the makeshift

shops and rickshaw vans along the pavement. Abdul Hamid, hailing from Noakhali, was seen selling kids' attires in

Chawkbazar area. He said, "Vendors eagerly wait for the month of Ramadan as sales shoot up at this time of the year."

"My usual daily sale is about Tk 3,000 to Tk 5,000 per day. But during Ramadan, especially 10 days ahead of Eidul-Fitr, the sale increases up to Tk

Md Khaled, a jeans pant seller in Jubilee Road area, expressed his satisfaction with the sales so far and hoped for some great escalation in sales a few days ahead of Eid as the number of customers is increasing day-by-day.

Contacted, Miran Hossain, president of Chattogram Sammilito Hawkers' Federation, said about 25,000 hawkers sell clothes on the footpath in Chattogram city.

"Eid sales in footpath shops usually gain momentum in the last 10 days of Ramadan," he said, adding, mainly people from low and lower-middle-income groups are the customers of footpath shops.

Middling finish for Pushpita, Ashikuzzaman



Ashikuzzaman, the lone male compound archer from Bangladesh, scored 586, 13 behind top-placed Mathias Fullerton of Denmark.

Pushpita Zaman, the lone women's compound archer from Bangladesh, scored 570 to finish 48th among 65 competitors. India's Jvothi Surekha Vennam topped the table with 593 points.

The elimination round of both the men's and women's compound events will be held on Thursday while the qualification rounds of men's and women's recurve events are scheduled to take place today, with Hakim Ahmed Rubel, Sagor Islam, Ram Krishna Shaha and Abdur Rahman Alif taking part in the men's event and Diya Siddique featuring in the women's recurve event.



Are we destined only to watch the downfall?

Nowadays, hardly anybody shows interest in Bangladesh's declining football scene unless the women's or girls' teams deliver something special.

However, Bangladesh football took centre stage and dominated headlines for the last few weeks, but for all the wrong

It all started at the end of March, when the Bangladesh Football Federation (BFF), citing financial constraints, pulled its team from the 2024 AFC Women's Olympic Football Qualifying Tournament.

Following that, a FIFA-imposed suspension on BFF general secretary Abu Nayeem Shohag "for having used false and/or falsified documents to justify payments made by the BFF with FIFA funds" triggered intense criticism from every nook and cranny and lay bare the lack of proper governance under the leadership of federation president Kazi Salahuddin.

Yet, the Salahuddin-led committee appeared indifferent to any criticism and the way they washed their hands of the Shohag controversy after an executive meeting on Monday led many to question if they were destined to simply watch the downfall of the nation's once most popular

During a 20-minute press meet, BFF senior vice-president and finance committee chairman Abdus Salam Murshedy was in an even more dismissive mood than his president regarding their

He not only said that "if there is forgery, he [Shohag] did it individually" and that

'the finance committee would not take any blame". But he also reminded reporters a bus [for the women's football team] about the difficulties of taking any decision against this elected body due to FIFA's strict supervision.

The BFF came to the conclusion that any wrongdoing happened on account of Shohag, as if the general secretary rather than the all-powerful BFF president was calling the shots. Still, they formed an inquiry committee with their own men to unearth, in their words, "what happened and why it happened".

An idea of what happened can be gleaned from FIFA's exhaustive 51-page findings, but for the greater interest of the game, there is a need to know why it happened and who was responsible.

The BFF, as a professional body, must have procedures in place to deal with any financial issue. One man cannot be solely responsible for everything.

Salahuddin also did not deny that there were faults in the system.

So how then can those involved in the system unearth the truth? If the BFF was sincere, they could have invited an independent inquiry committee to unearth

"I didn't even know that they bought because it was purchased by the purchase committee. The cheque is signed by any two of three and I sign after Murshedy signs," Salahuddin told The Daily Star last Saturday when asked about the irregularities in repairing and installing water pipes at the BFF House.

"Everybody in the BFF knows everything hundred per cent," he added.

The statements clearly indicated that BFF followed a procedure when it came to handling such things and a professional like Murshedy, who is the managing director of a big corporate house, must know in detail how things happen in an organisation of such magnitude.

Instead, the BFF executive committee has decided that Shohag will not get any opportunities to work with the federation in the future. But should they have first allowed him to give his explanations to an independent inquiry committee?

There was a lot of hope when Salahuddin came to the helm of the BFF as many believed the champion striker would be able to restore the game to its previous stature. Now serving his fourth consecutive term since 2008, he brought more misery than glory to the game.

Now the question is whether he further damages his image by sweeping the issue under the rug or shows bravery and clears the air by taking responsibility for the mess in Bangladesh football.

MSC storm into semis

Falling giants Mohammedan SC stormed into the semifinals of the Federation Cup with an emphatic 4-1 win over Chittagong Abahani in their quarterfinal clash at the Shaheed Dhirendranath Datta Stadium in Cumilla yesterday.

Souleymane Diabate, captain of the Black and Whites, struck twice after Nigerian Emanuel Sunday and Uzbek Muzaffarjon Muzaffarov netted one apiece in the scorching heat to set a semifinal clash against Bashundhara Kings.

Nigerian Candy Augustine netted the consolation strike from the spot for former Fed Cup runners-up Ctg Abahani, who made it to the semis of the competition once in the last four

Shrugging off their disappointing 1-1 draw against Bangladesh Police FC in the previous encounter in the Bangladesh Premier League, 10time Fed Cup champions Mohammedan bounced back strongly against Chittagong Abahani to take the lead in 20th minute through a nice strike from Emanuel inside the box, capitalising on a superb cut-back from Emon Shahriar.

The motijheel-based outfit kept creating chances before Muzaffarov doubled the margin from a corner kick which took a slight deflection off Ctg Abahani defender Imran Hossain Rimon before finding it's way back into the net.

After resumption, Mohammedan widened the margin three minutes into the second half with a nice build-up through the wings. Spaniard Daniel Ricardo whipped a cross from the left flank and right-back Mehedi Hasan squared it to unmarked Diabate, who did not make a mistake to tap it into the near post. He struck from outside the box in the 70th minute to kill the match.

'Criticism helps us work more'

Inter Milan coach Simone Inzaghi said he had no qualms being a lightning rod for criticism after their Serie A form nosedived as long as his players are protected ahead of a Champions League quarterfinal that could define their season.

Inter have not won in their last five league games, suffering four defeats to fall out of the top four and sit two points behind fourth-placed AC Milan, leading to reports Inzaghi could be sacked.

However, they have done well in the Champions League, advancing from the group stage at the expense of LaLiga leaders Barcelona before eliminating Porto in the last 16.

Inter have a 2-0 lead over Benfica ahead of the second leg at the San Siro on Wednesday as they look to reach the semifinals for the first time since they were crowned European champions in 2010.

Before Barcelona, as before Porto, it (the criticism) was the same, personally I am used to it. Better they criticise me than the players," Inzaghi told reporters on Tuesday.

"Criticism helps us to work more and more. In the league we have made insufficient progress. Like other teams we had problems.

"Now we have to focus on giving our fans an important night that would allow us to finish among the top four in Europe and that would be an important milestone."

chances, but failed to put any away. Then, in a six-minute period, the brutally efficient Haaland showed what Bayern were missing up front, setting up a goal and then scoring another to put City on course for the semifinals.

While Haaland's flurry likely sunk Bayern's Champions League hopes then and there, the seeds for their struggles were planted late last season, when the German champions

tried and failed to sign the Norwegian. Bayern sporting director Hasan



Salihamidzic was not alone in his desire to sign Haaland, but his open courting of the Norwegian put noses out of joint, particularly that of star striker Robert Lewandowski.

In 2021, a clip emerged of Salihamidzic on the sidelines of a Bayern-Dortmund clash, speaking with an assistant coach after Haaland scored twice in seven minutes.

"How good is Haaland? He's a machine. I'll call his agent tomorrow."

In that match, Haaland had given Dortmund a 2-0 lead, Bayern fought back to win 4-2 -- thanks to a Lewandowski hat-trick.

Bayern were willing to tear up their carefully constructed salary structure match against a wilting Dortmund.

to sign the Norwegian in the summer of 2022.

Lewandowski's camp said the striker felt slighted by the German club's failure to offer him a longerterm deal, with Bayern seemingly distracted by their pursuit of Haaland.

Lewandowski had scored more than 40 goals for Bayern in seven straight seasons, scoring a remarkable 344 goals in 375 appearances.

Ultimately, Bayern's wandering eye cost them both Haaland and Lewandowski.

Despite a history of scoring against Bayern -- Haaland has six goals and two assists in eight games against the Bavarians -- Tuesday's 3-0 victory was the striker's first win against the German champions. He lost seven from seven with Dortmund.

Since moving to City, Haaland has been spectacular, smashing records on the way to scoring 47 goals in 40 appearances.

Coming into Wednesday's clash, the Norwegian has somehow managed to up his form, with a scarcely believable 14 goals in his past six games.

Bayern have eight across the same period, four of which came in one

Home-goers start leaving the capital

With the public holiday beginning today, thousands of people have already started leaving the capital yesterday for their village homes to celebrate Eid-ul-Fitr.

Bus terminals, railway stations and launch terminals started seeing hordes of homebound people in the afternoon as many service-holders left work early on the last working day before the five-day Eid holidays.

The rush, however, is expected to intensify today and is expected to reach its peak two days from Friday.

Eid is likely to be celebrated on April 22 or 23. Holidays will be extended by a day if there are 30 days of Ramadan and Eid-ul-Fitr is celebrated on April 23, making it a sixday break

Thousands of people left Dhaka vesterday through Kamalapur Railway Station, the largest railway in the

The station saw relatively less crowd this year as railway authorities allowed only the passengers with tickets at the platform and erected a strong bamboo fence to prevent illegal entry. Until 7:30pm, a total of 38 including 28 intercity trains

left Dhaka for different destinations. A total of 53 trains were supposed to leave Dhaka yesterday.

Chattogram-bound Mohanagar Pravati Express and Sonar Bangla Express left

Dhaka an hour behind schedule, said a Bangladesh Railway official.

On the other hand, Chilahati-bound Nilsagar Express and Rajshahi-bound Dhumketu Express were delayed by 50 minutes and 40 minutes respectively, he said.

A huge number of passengers started gathering at Gabtoli Terminal in the afternoon, said Mosharref Hossain, general manager of Hanif Paribahan. The number was increasing when the correspondent spoke with him around 7:30pm.

Meanwhile, Sadarghat Launch Terminal also saw a good number of passengers in the evening, said Alamgir Kabir, joint director of Bangladesh Water Transport

Until 7:00pm, a total of 55 launches left Dhaka with passengers, he said, adding that the number of passengers will increase from today and will reach a peak when the garment factories break off for the Eid holidays.

Trattic pressure has increased on the Dhaka-Tangail highway. However, no traffic congestion was reported on the highway, reports our Tangail Correspondent.


According to the Bangabandhu Bridge Authority, a total of 22,485 small and big vehicles crossed the bridge in

the 24 hours to 6:00 am yesterday, fetching Tk 2.9 crore. Special arrangements have been made for the smooth passage of vehicles through the bridge on Eid, said Ahsanul Kabir Pavel, executive engineer of Bangladesh

Bridge Authority. Furthermore, two additional toll booths have been added for motorcycles, he added.

The government is determined to ensure the smooth return of people to their villages during Eid, said Jasim Uddin Haider, deputy commissioner in Tangail, adding that various measures have been taken to this end.

From April 16, ten mobile teams are working under the leadership of executive magistrates. Three control rooms have been set up on the highway.

Dhaka airport to get better eyes in the skies

New radar to make airspace safer, stop unseen overflights

Shahjalal International Airport will have a new radar system that will cover the entire airspace of the country.

Sources at the airport said the country's airspace is now controlled with a 38-year-old radar system and sometimes it is difficult to detect planes flying over Bangladesh.

With the installation of the sophisticated radar system at a cost of Tk 730.13 crore, such problems will be over, said officials of Civil Aviation Authority of Bangladesh. The existing radar cannot detect

all planes making overflights in Bangladesh's airspace, especially Bay of Bengal. The International Court of Arbitration awarded Bangladesh the rights to an area of about 19,000 square kilometres in the Bay. As a result, Bangladesh cannot

collect overflight fees properly, said CAAB officials. Bangladesh charges a minimum of \$500 in overflight fees.

"The country's airspace will be more secure, aviation will be safer, and revenues from our aviation sector will go up with the setting up of the new radar and ATC [air traffic control] towers," said CAAB being set up by Thales LAS, a French Chairman Air Vice Marshal M radar-manufacturing company. Mafidur Rahman.

He said 87 percent of the radar installation work has been completed. "We have a plan to open the radar system in October this

Mafidur, however, said it may another year to make the system fully operational as software integration work will continue and the whole project will be done by the middle of 2024. The system is

radar-manufacturing company.

When the radar system will be fully operational, Bangladesh will have full control over its airspace, the CAAB chief said.

Mafidur said, "The existing system is very old. There are many complaints about it."

The CAAB boss said officials were sent to France for training on the radar operations.

He added that the base has already been completed where the radar system will be set up. The tower construction work is going on and it will be finished on time.

State Minster for Civil Aviation M Mahbub Ali said the new sophisticated radar would bring the entire airspace of the country under surveillance.

On October, 2021, CAAB signed an agreement with Thales LAS.

Asked, aviation expert ATM Nazrul Islam said installation of the new radar will enhance the capacity of air traffic management system and smooth air space management within the coverage and expedite traffic movement.

He added that within territorial airspace, the new radar will help reduce traffic violations as well.

Coastal shellfish 'colonise' ocean plastic: study

Scientists have found coastal species of shellfish and anemones living and breeding on floating islands of garbage in the Pacific thousands of miles from home.

Environmentalists have for years been eyeing what they call the "Great Pacific Garbage Patch" masses of plastic rubbish combining bottles, fishing nets and much more.

US researchers who sampled rubbish from the northeastern Pacific between California and Hawaii said they found 37 kinds of invertebrates

that originated from coastal areas, mostly from countries such as Japan on the other side of the ocean. "The high seas are

colonized by a diverse array

of coastal species, which survive and reproduce in the open ocean," they wrote in the study, published in Nature Ecology and Evolution

on Monday. "Coastal species persist now in the open ocean as a substantial component of a neopelagic (new, sea-dwelling) community sustained by the vast and expanding sea of plastic debris," the study

More than two-thirds of the items examined had coastal species on them, including crustaceans, sea anemones and moss-like creatures called

China took a 'good initiative'

Momen says Chinese special envoy met him, they talked way of quick Rohingya return

Chinese Special Envoy Deng Xijun had a meeting with Foreign Minister AK Abdul Momen on Rohingya repatriation on April 6, two days before the latter flew to Washington to hold a bilateral meeting with US Secretary of State Antony Blinken.

"I had a courtesy call with him and we discussed how to quickly repatriate the Rohingyas to Myanmar," Momen told journalists after attending an event marking the Foreign Service Day at the

Foreign Service Academy yesterday. There was, however, no public announcement of the Chinese special

envoy's visit to Dhaka. Meanwhile, Foreign Secretary Masud Bin Momen flew to China on Monday and is likely to return today, said sources. They could not say details of his schedule while in China.

Foreign Minister Momen also did not respond to a question when asked about the purpose of the foreign secretary's China visit.

GLOBAL TERRORISM INDEX Bangladesh 2nd most improved country in S Asia

Bangladesh was the second most improved country in terms of terrorism impact in South Asia as it has jumped down two notches to the 43rd rank among 163 countries, according to the latest edition of the Global Terrorism

Bangladesh received a score of 3.827 on the GTI index. The calculation of the score takes into account the deaths, incidents, hostages, and injuries caused by terrorism, weighted over a five-year period.

Afghanistan was on top of the list as the country with the highest impact of terrorism as it received a score of

The GTI report is produced by the Institute for Economics & Peace (IEP) using data from Terrorism Tracker and other sources. Terrorism Tracker provides event records on terrorist attacks since January 1, 2007.

Among the South Asian countries, Pakistan received a score of 8.16, India 7.173 while Nepal received a score of

"Bangladesh was the second most improved country in regards to the impact of terrorism, followed closely by Nepal, with both countries recording two attacks and no deaths in 2022," said the report.

The South Asia region is home to two of the 10 countries with the worst GTI scores -- Afghanistan and Pakistan. Of
