
Rahima Wadud, mother of Education Minister Dipu Moni, passed away yesterday.

# Fodder price hike hinders cattle rearing

livestock farmers in Khulna district have been rearing cattle for the upcoming Eid-ul-Azha and earn some profit, but now price hike of feed and fodder.

Some farmers claimed that the price of cattle feed is increasing every week, making it difficult for the farmers to cope with it.

During a recent visit to the local market, the news agency found that one sack of wheat husk, weighing 37kg, is being sold at Tk 1,950 while a sack of paddy husk, weighing 50kg, is being sold at Tk 850-900.

Besides, one sack of mustard oil cake, weighing 37kg, is being sold at Tk 1.450-1.500 while one sack of granular feed, weighing 25kg, is being sold at Tk 1.380-1.400.

One kg of soybean oil Eid-ul-Azha as day by day

cake is being sold at Tk 85 it is becoming difficult for while a fist of straw is being sold at Tk 8.

Asaduzzaman, a local farmer who was busy cutting grass for his cattle on Shaheed Sheikh Abu Naser Hospital field, said, "It is difficult to find long grass for cattle and we are farmers to survive in this business due to the high price of cattle feed." The prices of milk and

beef have increased, but the farmers are hardly making any profit. If this continues, small cattle farms may disappear at some point,

Rab has claimed to have arrested six members of a kidnapping gang in Cox's

A total of 12 firearms including a foreign pistol, ammunition, and some sharp weapons were seized from their procession, said Commander Khandaker Al Moin, director of Rab's legal and media wing, at a press conference at its Cox's Bazar office yesterday.

The arrestees were identified as Saleh, 30, the kingpin of the armed group; Nurul Alam Nuru, 40; Kamal alias Sohel, 37; Nurul Alam Lalu, 24; Harunur Rashid, 23; and Riaz Uddin Bappi.

The gang adducted around 50 people at different times and released them after taking Tk 5-12 lakh from each of them as ransom, said the Rab official. A case was filed in this regard and the arrestees were handed over to police.

On April 16, 2005, a Dhaka court handed death sentences to 22 people and life terms to six others. A decade later, on June 15, 2016, the HC confirmed death penalty of six persons, including Nurul Islam.

It, however, commuted punishment capital of seven others to life imprisonment, upheld life term of two and acquitted 11 accused of charges.

The HC on September 7, 2016 released the full text of the verdict observing that the killing of Ahsanullah reflected the Master criminalisation of politics.


