BUYING AIRBUS PLANES

Biman's move puzzling

Experts say purchase of freighters, operation of mixed fleet will hurt flag carrier

Biman last year carried a little over 28,000 tonnes of freight in the cargo hold of planes making international flights when it had the capacity to transport over 4.98 lakh tonnes.

This is about 6 percent utilisation of the capacity, and yet Biman is planning to buy two new Airbus freighters.

An audit by the Civil Aviation Authority of Bangladesh (CAAB) also shows that in the same year, Biman carried 20.58 lakh passengers on international flights and had around 7 lakh seats vacant, which is just under 76 percent utilisation.

This happened after the national flag carrier bought 12 Boeing planes spending around Tk 19,000 crore between 2011 and 2019. The aircraft purchased include multiple huge Boeing 777-300ERs, efficient Boeing 787-8s and -9s, and workhorse Boeing 737-800s.

But the planes are not properly utilised largely due to shortages of pilots and cabin crew members, and poor planning and management, experts have said. Biman failed to launch adequate number of new routes for the planes' best use, they added.

They questioned why the Biman Board of Directors on May 3 approved in principle the purchase of 10 Airbus planes, including the two freighters. Biman's top management believes the company will make money ferrying cargo in the freighters and the new Airbus planes will help

economically viable at all.

"First of all, airfreight is a seasonal business in Bangladesh. For five or six months of the year, there is almost no demand," aviation expert Kazi Wahidul Alam told The Daily Star.

The season is dependent on garment products and vegetable exports. Secondly, most outbound freight goes to the West, and the items Bangladesh imports largely come from China, Hong Kong and Japan. So, the inbound cargo flights from the West and the outbound flights to the East would be virtually empty, he said.

"Therefore, we can say that the cargo business here is mainly one-way. You can never survive doing one-way cargo business," said Alam, the editor of Bangladesh Monitor, an aviation and tourism magazine.

He said some foreign carriers operate cargo flights in Bangladesh but they operate flights only when there is demand in the peak season.

For example, since Dhaka has no inbound demand, Emirates Skycargo planes usually fly first to Bangkok or Singapore carrying goods and then make a stopover in Dhaka during the return flight to Dubai to pick up freight that they deliver to the West, he said.

"The large carriers operate this way to be able to carry cargo both ways. But we won't be able to do that as we never made the strategic plan," he said. A cargo division official of Biman said, "We couldn't even utilise the full capacity of our cargo hold in passenger flights. Then What is the point of

buying brand new freighters without proper marketing and planning?" Airlines do not often buy brand new freighters. They usually buy old and used freighters because new ones are rarely commercially viable, he said, requesting anonymity.

Forex reserves, revenue measures lacking

Finds IMF staff mission on conclusion of 13-day tour

The International Monetary Fund staff mission yesterday expressed reservations about the likelihood of Bangladesh meeting the minimum reserve requirements for the second tranche of the \$4.7 billion

As per the terms agreed with the Washington-based multilateral lender for the loan programme, the country would maintain a minimum net international reserves (NIR) of \$22.95 billion at

the end of March and \$24.46 billion at June's end. So far, the government has failed to meet the floor set for March, which was meant to give an indication of how the authorities are faring with the programme objectives. The NIR

was less than \$22 billion. While March's target is not mandatory for the release of the second instalment of about \$476.27 million, June's target is. In fact, it is one of the three mandatory conditions.

Instead of building a buffer, the reserves continue to drain from the Bangladesh Bank's

coffers despite the strict import control measures taken, said the IMF staff mission, The Daily Star has learnt from officials involved with the proceedings.

The 13-day staff visit, led by Bangladesh

Mission Chief Rahul Anand, to discuss recent macroeconomic developments and implementation of the IMF supported programme wrapped

up yesterday. "However, persistent inflationary pressures, elevated volatility of global financial conditions and slowdown in major advanced trading partners continue

to weigh on growth, foreign currency reserves and the Taka," Anand said in a statement.

When the 42-month loan programme was approved by the IMF executive board, the official gross reserves, as per BB's methodology, stood at \$32.2 billion. On May 2, it was \$30.99

NATIONAL ELECTION EU monitoring team likely to visit in July

The development comes following EC's written invitation

The European Union will send an exploratory election monitoring mission in July as the Bangladesh Election Commission has welcomed it in a written invitation.

EU Ambassador to Bangladesh Charles Whiteley confirmed the development to The Daily Star in an exclusive interview yesterday.

"I am very pleased to say that we now have a written invitation. They [the EC] have confirmed that the observers will be welcome.

He said he recently called on Chief Election Commissioner Kazi Habibul Awal and had a positive conversation.

"I welcome the Bangladesh government's stance of welcoming the international observers. It [the written

invitation] has made it very clear." Earlier in February, the EU mission in Dhaka had written to the foreign ministry, seeking written confirmation that

Bangladesh would welcome EU election observers. While meeting the government ministers and opposition leaders in the recent months, Whiteley said that while they would send observers, the election has to be participatory.

BNP leader's house comes under attack

Miscreants carried out an attack on the house of one BNP leader in Khulna city on Saturday night.

The incident took place around 11:30pm in the city's Customs Ghat area when perpetrators threw stones and vandalised one portion of the house belonging to Md Mahbub Kaiser, a former councillor of ward 22, and a member of BNP city unit, said the victim.

Kaiser, who was out of home at the time, told The Daily Star quoting his wife that unidentified armed miscreants riding 14-15 motorcycles arrived at his house and tried to enter it breaking the main gate.

The miscreants then threatened him, telling him not to participate in the upcoming city corporation elections, Kaiser said quoting his wife.

When locals came forward hearing the commotion, the miscreants fled the scene.

"I have immediately informed Khulna city Mayor Talukder Abdul Khaleque, who assured me that he would look into the incident, and the Sadar Police Station," he said.

"Ever since the incident, my family members are in panic," he added.

Kaiser said he has no idea who was behind the attack. Shafiqul Alom Mona, convenor of Khulna city unit BNP said, the

Taking the love for music to next level

Music is an art, some of us take it to an idolatry rank, with no compromise on sound quality. This is a complicated speciality and is appreciated by a group called, Audiophile Friends, in Dhaka. For them, music is the crux of their existence; it is an expression of emotions and they delve into the depths of it to understand the musician's performance

A general listener does not get much into the finer nuances of music, as an audience they are superficial, while an audiophile can connect themselves with the musicians.

"Audiophiles simply love to listen to music on a good system. We are a non-commercial group, and listening to good music is our hobby," says Sayedur Rahim Bappi, CEO, Noise Digital Audio and HiFi Digital

"Audiophiles are an exceptional breed of people who are fascinated by pure audio, motivated by sound quality, and addicted to audio gadgets. They take their passion for music one step further. They're curious about how songs are recorded and the science behind how sounds are reproduced," says Saveed Siddiqui, an audiophile himself looking for purity of sound.

Audiophile Friends is a group of 12 like-minded people and recently they celebrated Record Store Day in Dhaka for the first time. It was organised by Harun Al Rashid, one of the members.

It is quite surprising for laymen that audiophiles prefer vinyl records over CDs because the record's sound has depth where the bass frequencies and

Sound quality is still unbeatable and it has a magnetic wave imprint compared to digital recordings. As a result of this love, the collection of the turntable is becoming a vogue within the audiophile cult-like groups in

The demand for the use of nostalgic vinyl records has recently increased in Dhaka and there is a robust long play collectors and sellers, all closely knit to Audiophile Friends.

"There is a music lover in all of us. In my case, while growing up in Old Town, a gramophone played



78-rpm records made me fall in love with Rafi, Mukesh,

Lata, etc," Siddiqui recollects. He adds, "Later on, a Phillips record player with much clearer audio introduced us to the 33-rpm vinyl. Tom Jones, Engelbert Humperdinck, Elvis, and the Beatles became part of our lives. With only one TV channel and limited hours of transmission, music became an obsession. And while more companies were bringing systems catering to music lovers, we kept chasing after better and better sound."

Being an audiophile is an expensive hobby, very few can appreciate the frequency ranges of the system and how perfectly and accurately you can listen to a song.

"With streaming audio companies using MP3, compressed audio, and system manufacturers making wireless players, most people shall be satisfied with the sound but audiophiles, with very fine-tuned hearing, are even capable of catching the tiniest of sound in the background, and their choice will be the high-end systems. Just the wiring might cost thousands of dollars," Siddiqui relates.

"Passionate listeners like to create the perfect ambiance for music and to do it they try to set a sophisticated sound system. What machine you

buy, how your room is equipped to handle the sound, and the interiors -- all matter; a single amplifier's character can vary from room to room," Bappi relates.

After the sixty's music revolution, musicians had the chance to record more harmony, ambiance, and synthetic elements, which were not possible to record earlier because of the lack of technology. Traditional music has simple

arrangements whereas modern music after the sixties is layered music. Layering is the process of combining multiple individual sounds to create a cohesive sound that is more complex and interesting. There is a pleasure in listening to layering of multiple synth sounds that creates a richer tone in long plays. This passion demands a sophisticated sound system, that the audiophile of Dhaka appreciates.

ARSA man beaten to death by Rohingyas

A member of the armed insurgent group Arakan Rohingya Salvation Army was beaten to death at a Rohingya camp in Ukhiya upazila of Cox's Bazar early yesterday.

He was apprehended and killed by camp residents following a shooting incident that left three refugees injured at Block G-1 of Camp 13 in Palongkhali union, police said.

The deceased was identified as an Arsa man, but his name could not be known immediately, said Sheikh Mohammad Ali, officer-in-charge of Ukhiya Police Station.

The injured are Ramida Khatun, 55, and her two sons, Md Rafique and Jubair.

A group of 25-30 people arrived at the camp to attack Sub-Majhi Syed Hossain, leader of block G-1, around 3:00am, said Ameer Jafar, commanding officer of APBn-8, reports UNB.

"At that time, residents of the block got out of their homes and tried to resist them," he said.

Meanwhile, the OC said that while fleeing, the criminals opened fire at the refugees, leaving the three injured.

Following the shooting incident, one of the criminals was apprehended and killed on the spot by locals, he added.

He said the body was sent to the Cox's Bazar General Hospital morgue for an autopsy, while the injured were sent to an NGO-run hospital for

2 women killed after run over by trains

Two women were killed after they were run over by two different trains between Bogura's Sonatola and Dupchachia Talora rail stations.

The deceased are Kohinur Begum, 50, and Tanjila Akter, 35.

SI Aminul Islam of Bogura Railway Station Police Outpost said Tanjila was crushed under a train around 9:00am in the Stadium field area.

Meanwhile, Kohinur slipped and fell on the tracks while attempting to board a running train.

Say police on Tejgaon College student murder

A day after recovering the body of Ikram Hossain Molla -- a first-vear student of Tejgaon College -- in the capital's Khilkhet, police said he was murdered by his friends over money-related



After killing Ikram, 22, his friends wanted to cover up the murder by dumping the body in a ditch and covering it with water hyacinth, said police.

Iftekharul Islam, additional deputy commissioner (Cantonment Zone) of DMP's Gulshan Division, told The Daily Star that Ikram went missing on Thursday night. His family reported the matter to Khilkhet Police Station and filed a general diary on Friday afternoon.

On Saturday, locals found the body in a ditch adjacent to the Dumni's Baluchar area and informed police. Ikram's family later identified the body, the ADC said.

Kabir Hossain Molla, father of the deceased, then filed a murder case with Khilkhet Police Station.

After going through his mobile phone, police first arrested Ikram's friend Shanto from his house. During interrogation, he told the police about the involvement of another suspect, Abu Siddique, in the murder.

Ikram lived with his family in Khilkhet's Dumni area. Police said Ikram managed to secure Tk 2 lakh from his

4 of drug syndicate held with 24kg crystal meth

Applying innovative techniques, narcotics dealers are smuggling crystal meth -- popularly known as ice -- into Bangladesh from Myanmar.

Along with the notorious drug dealers, a suspended policeman was found joining hands with the smugglers to smuggle the biggest haul of meth consignment in the country.

The syndicate first brought the meth from Myanmar through Ghumdhum border in Bandarban. The consignment was preserved at the border point first. Then the consignment was transferred to the Rohingya camps, divided into small portions and preserved in the remote hilly areas.

This is the largest haul of crystal meth in the country, worth around Tk 120 crore, said Commander Khandaker Al Moin, director of Rab's legal and media wing.

They were finally transferred to Dhaka and other districts of the country based on demands. For smuggling the drugs from the Rohingya camp to the capital, the dealers tied the meth with the body of the carriers or stuffed

them inside tea bags to avoid any suspicion. They even used code words like "tea leaves" to talk about the consignments on the online messenger app imo.

Rapid Action Battalion disclosed the findings yesterday after the arrest of four narcotics smuggling syndicate members, with 24.2 kilos of meth on Saturday night.

This is the largest haul of crystal meth in the country, worth around Tk 120 crore, said Commander Khandaker Al Moin, director of Rab's legal and media wing.

The arrestees are -- Iran Majhi alias Mohammad Imran, 33, the kingpin of the syndicate, his brother Mohammad Rubel alias Dakat Rubel, 26, and associates Md Alauddin, 35, an expelled member of the police and Joynal Abedin, 37.

Led by Imran, the syndicate of 12 members was involved in ice smuggling for a long time.

They used to smuggle ice in 15-day intervals from Myanmar and preserve it under the mud by using construction materials as a cover, Moin told The Daily Star.

On information, a team of Rab-15 conducted a drive at an under-construction house in Cox's Bazar's Ukhiya upazila on Saturday night and arrested the four. Seven to eight other members of the syndicate managed to escape, he added.

Demand steel mills workers following N'ganj factory blast

Demanding adequate compensation and workplace safety, workers formed a human chain in Narayanganj yesterday following a blast at a steel mill in the area

At least seven workers were injured in an explosion that took place at the mill in Rupganj upazila when they were melting iron. Six workers have died of injuries and one is battling for life at a hospital.

The incident took place around 4:00pm at Rahima Industrial Complex Ltd Steel Mill in Gausia Saughat area.

Yesterday, the workers' leaders demanded arrest of the factory owner, stating that the casualty occurred due to negligence in strengthening the security system at the factory.

The human chain was formed under the banner of Re-rolling Steel Mills Workers Front in front of Narayangani Press Club. The speakers said the steel mill workers work with high risk but they don't get minimum safety equipment.

Jamal Hossain, president of the organisation, presided over the programme. Its general secretary SM Kadir was also present among others.

Meanwhile, four days have passed since the explosion in the iron smelting furnace of Rahima Industrial Complex Limited, but no case has been filed yet.

Golam Mostofa Russel, superintendent of police in Narayanganj, said victims usually filed such cases.

"We are in constant contact with the victim families. The owner has assured them of paying compensation. That's why, they don't want to file case. In such a situation, police can file a case. Since it is an accident, it is necessary to investigate first... Government inspection officials concerned are also looking into it," he said.

Earlier on April 26, Border Guard Bangladesh (BGB) recovered 21.09 kilos of crystal meth from Ukhiya's Palangkhali area.

According to data, the seizure of crystal meth increased by three times from 2021 to 2022.

Annual Report of Bangladesh 2022 mentions that around 104 kilos of crystal meth were seized by all law enforcement agencies last year, while the figure was 36 kilos in 2021.

Tanvir Momtaz, director (operation & intelligence) of the Department of Narcotics Control (DNC), said the ice smuggling has increased as demand always remains high for new drugs among substance abusers.

Sources in the DNC said there are at least over a hundred ice traders in the capital, and the majority of them are young.

Ice is mainly known as a "party drug" and the main target groups mostly live in the posh areas of the

Mehedi Hasan, Md assistant director (north) of DNC, told The Daily Star that they held around 70 to 80 people with ice in their possession in the last one and a half years.

"All the arrestees are aged between 18 to 35 and belong to high strata of society," he said.

"The buyers mainly turn into dealers. For instance, a buyer living in a posh area first buys 50 grammes of ice for Tk 5,000 per gram and then carries it to a party. Once the drug enters the party, the buyer sells per gram of ice for Tk 12,000 to others," he said.

Mehedi said they are on high alert regarding the issue and are conducting drives to arrest the dealers and smugglers.

TAGORE'S 162ND BIRTH ANNIVERSARY

Tagore's legacy fading away

Around a century ago, Rabindranath Tagore visited Mymensingh. Despite such historical significance, his memories are yet to be

It's also astonishing that no programmes are held to commemorate the bard's legacy, said

Tagore is a part of Mymensingh's history and culture. His memories should be preserved for the generations to come and for the sake of the country's history, said Mamunul Islam, exsecretary of Jatiya Rabindra Sangeet Sammilon Parishad, Mymensingh.

"The government should take immediate steps in this regard," said Dr Monjurul Alam, current president of the same organisation.

The places of Tagore's visit include Alexander Castle, also popularly known as "Luhar Kuthir" or "Rang Mohol"; "Shashi Lodge"; Bidhyamoyee Girls School; Mohakali Girls School, City College School in Mymensingh city and Atharabari zaminder palace in Ishwarganj.

Tagore arrived in Mymensingh by train from Dhaka on February 15, 1926, on a four-day visit. The then zaminders of Muktagacha arranged special programmes under a banyan tree on the castle premises, now known as "Rabindra Batamul" to welcome the poet.

The poet was accorded several receptions during his stay by Mymensingh Municipality, Mymensingh Sarswato Samity, Mymensingh Nagorik Samaj, Bidhyamoyee Girls' School, City Collegiate School and Mahila Samity.

Archeological department contacted the college authorities with a proposal to renovate Alexander Castle a few years ago but there was no follow up.

On invitation of Promod Chandra Roy Chowdhury, the then zaminder of Atharabari and also a student of Shantiniketan, Tagore visited Roy's palace on February 19 in 1926.

Shahzadpur Kacharibari in Sirajganj is bustling with activity as the Rabindra festival, commemorating the fond memory of Nobel laureate poet Rabindranath Tagore, is set to kick off on May 8, marking his 162nd birth anniversary.

The three-day festival is being organised by the Sirajganj district administration and will be inaugurated by Deputy Speaker Advocate Samsul Haque Tuku, with national and local artists set to perform.

Tagore had a deep connection with Shahzadpur Kacharibari, making the Rabindra festival a traditional festivity in this region, says Abu Sayeed Enam Tanvirul, the custodian of Shahzadpur Rabindra Kacharibari.

Tagore's grandfather, Prince Dwarkanath, had purchased the estate in Shahzadpur from Zaminder Rani Bhabani of Natore in 1840, and the poet took on the responsibility of maintaining the estate, making frequent visits to the region between 1890 to 1897.

The natural beauty, purity, simplicity, and innocence of the people in this region had a profound impact on Tagore, which is widely reflected in his writings.

Prof Abdul Alim, a teacher of Bangla department at Pabna University of Science and Technology and Tagore researcher, said Tagore was particularly inspired by the natural beauty of the region and mentioned that in one of his books. The characters of many of his works, such as "Postmaster" and "Sonar Tori", were inspired by his experiences in Shahzadpur, he added.

Tagore's love for Shahzadpur is evident in his letters, where he states that he found more inspiration for his writing in Shahzadpur than in any other area.

Today, the historic Shahzadpur Kacharibari has been preserved as an archaeological site, and the museum on the premises holds 331 artefacts, including 148 items used by the poet, such as a couch, chairs, tables, a mirror, a piano, and a palanquin. The museum also houses 20 rare paintings of Tagore, including depictions of trees, nature, and women, and over 3,000 precious books.

RAJSHAHI CITY POLLS Smooth sailing for Liton?

Collects nomination paper amid BNP boycotting polls; no rebel candidates

The upcoming mayoral election in Rajshahi City Corporation is likely to be a smooth sailing for the incumbent mayor AHM Khairuzzaman Liton. This is due to the fact that the opposition party BNP has announced a boycott of the polls and no rebel candidates of the ruling Awami League are expected to participate.

Liton collected nomination papers from the returning office yesterday as the lone candidate from the Awami League for the mayoral elections. He is also a presidium member of the party.

The election is scheduled to take place on June 21. Electioneering will begin from June 2. According to the election schedule, possible candidates would have to collect and submit the nomination documents within May 21.

The AL leaders of the city expressed their support for Liton by being present when the city AL acting president Mohammad Ali Kamal collected the nomination paper on behalf of the incumbent mayor.

Local voters believe that Liton's electoral race might be smooth, although a former joint secretary of Rajshahi city BNP, Sayeed Hasan, has expressed his intention to participate as an independent candidate. "I am considering the possibilities, but I am yet to take

any final decision (regarding contesting)," Saveed Hasan, who currently doesn't have any party portfolio, told The Daily Star.

Tk 2.5cr bridge remains useless for 2 years

Locals suffer due to absence of approach roads

A road without approach roads is like a book without pages -- utterly useless. Yet, that's exactly what has happened with the bridge over Dwipasha Khal in Patuakhali's Bauphal, built at a cost of Tk 2.5 crore by the Local Government Engineering Department.

For two long years, the bridge has remained unused as the approach roads were never built, causing immense suffering to locals who risk their lives daily by using a wooden ladder to cross the canal.

It is a clear case of wastage of public money, and the authorities concerned must take immediate action to resolve the issue, demand locals.

The status quo has been causing great inconvenience to students and many others who have to cross the canal regularly.

Over 500 students of nearby educational institutions such as Sonamuddin Mridha Secondary School, Dwipasha Government Primary School, Konakdia SS School, and College are facing difficulties to cross the canal due to the absence of an approach road.

Kalam Khan, a local resident, said they had made wooden ladders on both ends of the bridge to help people get in and out of the bridge.

Another resident named Tahmina Begum said that they had to use the bridge every day to go to the other side of the canal to do agricultural work, and climbing up the bridge with ladders is risky.

Asma Akhter, a 10th-grader of Sonamuddin Mridha Secondary School, said she had faced several accidents during the process. A few people were also injured as they fell off the stairs while climbing down through the ladder.

Despite repeated complaints, officials concerned have not taken any action to resolve the issue, alleged locals.

Golam Mostafa, chairman of

Madanpura Union Parishad, said the issue of public suffering regarding the bridge was raised several times at meetings in the presence of officials concerned, but to no avail.

Contacted, Gias Uddin, the project's contractor, admitted that the delay in constructing the approach roads. He said the road would be

constructed very soon, and he hoped that they would be able to start the work within a day or two.

Upazila LGED Engineer Sultan Hossain said, "After discussing the issue with the contractor, arrangements would be made for the construction of an approach road."

8 killed by gunman at Texas mall

7 hurt; shooter killed by police

A gunman shot and killed eight people and wounded at least seven others at a busy mall north of Dallas on Saturday, police said.

The gunman, whom authorities said they think acted alone and whose motive was not yet known, was killed by a police officer after he began firing outside of the Allen Premium Outlets mall in Allen, Texas, the city's police chief Brian Harvey said at a press conference.

Allen fire department chief Jon Boyd told the same press conference that his department took at least nine victims with gunshot wounds to area hospitals.

Two of those people died at the hospital, Boyd said at a second press conference Saturday night. Three of the victims were in critical condition and four others were stable.

Medical City Healthcare, which runs 16 hospitals in the area, said in a statement that its trauma centers were treating eight of the wounded victims, who ranged in age from 5 to

Collin County Judge Chris Hill, the top elected official in the county where Allen sits, praised police and other first responders at a press conference, but expressed deep anger with "those that would do evil in our community, in our backyard."

Separately, police in the nearby city of Frisco, Texas, said they had evacuated the Stonebriar mall late Saturday after receiving reports of shots fired there. It was not yet clear if a shooting had actually taken place.

TV aerial images showed hundreds of people calmly walking out of the mall after the violence unfolded.

23,000 flee violence in India's Manipur

Says army; no new 'major violence' reported, curfew lifted

Some 23,000 people have fled ethnic violence in northeast India that has reportedly killed at least 54, the army said yesterday, although there was no new "major violence" overnight.

The unrest in Manipur state erupted after a protest march by a tribal group last week sparked clashes, with vehicles and houses set on fire and authorities firing tear gas.

The military has deployed thousands of troops to the state bordering Myanmar, issued "shoot-at-sight" orders in "extreme cases", imposed curfews and cut the

The army said yesterday no major flare-ups were reported overnight and that a curfew was lifted between 7-10 am in Churachandpur district, one of the main flashpoint areas.

"Past 24 hrs also witnessed Army significantly enhancing surveillance efforts through aerial surveillance, movement of UAVs & redeployment of Army Helicopters within Imphal Valley," it said, referring to unmanned aerial vehicles or drones.

23000 civilians "Total have been rescued till now & were moved to own operating bases/ military Garrisons," the statement said.

Authorities have not given an official death toll but hospital morgues in the state capital Imphal and Churachandpur had reported a combined total of 54 dead, according to local

Tribal groups including the Kukis are unhappy about the prospect of the state's majority Meitei community being recognised under a "Scheduled Tribe" category.

This designation would give them a certain quota of government jobs and college admissions in a form of affirmative action aimed at

addressing structural inequality and discrimination.

L. Sanglun Simte, 29, a Kuki who has been camping outside the airport in state capital Imphal with 11 of his family members since Saturday, recounted the horror as violence broke out.

"We fled for safety. Things are not okay. They are just attacking us Kukis," he told AFP.

Simte said his 49-year-old cousin, Siemcha Gangte, was killed by a mob on Thursday and his house was set on fire.

"The attackers say we are outsiders and need to leave Imphal. When they attacked us, the local police didn't help."

Simte, who has booked a flight for Agartala, the capital of neighbouring Tripura state, said he would return only if security improved.

"We don't feel safe right now," he said.

Lalpu Suantak, 45, who works with a state-owned bank in Imphal and is also from the Kuki community, said he fled his house with 12 family members after some homes and a neighbourhood church were set on fire.

> "My house hasn't been touched yet but there was fear when a mob burnt one house in our area," he told

India's northeast has seen decades of unrest among ethnic and separatist seeking groups autonomy or even secession from India, with at least 50,000 people killed in Manipur since the 1950s.

These conflicts had waned over the years, with many groups striking deals with New Delhi for more powers.

Manipur Director General of Police P. Doungel said orders have been given to take strict action against anyone found involved in acts of violence, reports Reuters.

"We have asked army to stage flag marches in violence hit areas and instructed the forces to take stringent action against anyone involved in violence," Doungel told journalists.

US-BOUND MIGRANTS Mexican authorities rescue 113 AFP, Mexico City

Authorities in northwest Mexico rescued 113 kidnapped migrants of different nationalities from a building along the border with the United States, the state prosecutor's office said.

Thousands of migrants fleeing violence and poverty risk abduction and exploitation at the hands of criminal gangs while crossing Mexico on the way to the US border.

The latest discovery in San Luis Rio Colorado, which borders the US state of Arizona, arose from follow-up investigations by authorities who found on Friday 10 Colombian citizens presumed to have been kidnapped.

Arab League readmits Syria

foreign League adopted ministers readmit Syria after more than a decade of suspension yesterday, a spokesperson for the League said, consolidating a regional push to normalise ties with President Bashar al-Assad.

The decision was taken at a closed meeting of Arab foreign ministers at the Arab League's headquarters in Cairo, said Gamal Roshdy, spokesman for the Arab League's secretary general.

Syria's membership of the Arab League was suspended in 2011 after a bloody crackdown on street protests against Assad that led to a devastating civil war, and many Arab states pulled their envoys out of Damascus.

Recently, several Arab states including Saudi Arabia and Egypt, have reengaged with Syria in highlevel visits and meetings.

Vietnam posts record-high temperature

Vietnam has reported a record-high temperature, climate warning such extreme weather events would continue.

The country's scientists have warned that global warming is exacerbating adverse weather, with the region sweltering under a heatwave in April -- when neighbouring countries also registered record

temperatures. temperature 44.1 degrees Celcius was measured in Vietnam Saturday, National Centre Hydro Meteorological Forecasting said, breaking the 2019 record of 43.4 degrees Celsius. Farmer Nguyen Thi Lan said that temperatures in the central city of Danang had been increasingly hot, forcing workers to earlier than ever.

Moscow promised more ammo

Says Wagner chief after Bakhmut pull-out threat; Russian jet intercepts Polish plane over Black Sea

Russian paramilitary leader Yevgeny Prigozhin said yesterday he had received "a promise" of more ammunition from the Russian army, after he threatened to pull his frontline Wagner troops out of Bakhmut.

"They promised to give us all the ammunition and armaments we need to continue the operations," said Prigozhin, following his blistering attack on military chiefs over the situation in Bakhmut, the epicentre of Ukraine's fight against Moscow's forces.

He said they had been assured "that everything necessary will be provided" to fighters around Bakhmut.

Prigozhin's Wagner group has spearheaded the grinding, months-long Russian assault on Bakhmut, almost capturing the city in the longest and bloodiest battle of the campaign.

Prigozhin however threatened to leave his positions in Bakhmut on May 10 due to a lack of weapons, which he blamed on Russian army

He warned that he would "pull out Wagner units from Bakhmut because in the absence of

ammunition they are facing a senseless death".



in Friday's video statement and the scathing personal criticism of the leaders of Russia's campaign in Ukraine were unprecedented.

The rivalry between his private military group and the conventional army have come to the surface during the battle for Bakhmut.

Man lynched for 'blasphemy'

A man was beaten to death by a mob after being accused of blasphemy at a rally for former Pakistan prime minister Imran Khan's party, officials said yesterday. Blasphemy is a hugely sensitive issue in Muslim-majority Pakistan, where even unproven allegations can stir mobs and violence. Video of the lynching has been shared widely on social media, with police seen vainly trying to stop a frenzied mob from beating the alleged blasphemer. The incident took place on Saturday in the Sawal Dher area of Mardan city in the country's ultraconservative northwestern Khyber Pakhtunkhwa province bordering Afghanistan. Police said a man identified as Nigar Alam was asked to deliver the concluding prayer at a rally organised by Khan's Pakistan Tehreek-e-Insaf (PTI) party when the crowd took offence to his comments. He managed to flee the scene, police said, but a mob tracked him down to a relative's house. "A group of individuals climbed over the wall, barged inside, and beat him to death with sticks and batons," said district police chief Najeeb-ur-Rehman. "The mob was so agitated that it became extremely challenging for the police to even recover the body," he told AFP. Another local police official, Umair Khan, confirmed the incident. PTI leader Khan was not present at the rally and party officials had no immediate comment on the incident. Few issues in Pakistan are as galvanising as blasphemy, and even the slightest suggestion of an insult to Islam can supercharge protests and incite lynchings.

Japanese Prime Minister Fumio Kishida said yesterday that his "heart aches" over South Korea's colonial-era suffering, as he hailed fresh efforts to mend Tokyo's longstrained ties with Seoul at a landmark summit. "My heart aches as many people went through a very

difficult and sad experience in

the harsh environment at that time," Kishida said, speaking after a summit with South Korean President Yoon Suk Yeol. The East Asian neighbours, both crucial security allies of the United States, have long been at odds over historic issues linked to Japan's 1910 to 1945 colonial occupation of Korean peninsula, including sexual slavery. The two countries have been locked in a tit-for-tat economic dispute since 2018, when South Korea's Supreme Court ordered Japanese firms to compensate the wartime victims of forced labour, enraging Tokyo. But Yoon has sought to bury the historical hatchet, earlier announcing a plan to compensate victims.

Israel repatriates gun running Jordanian MP

Israel yesterday transferred a Jordanian member of parliament to Amman's authorities, weeks after arresting him for attempting to smuggle pistols, rifles and gold into the occupied West Bank, officials said.

Imad Adwan was detained at the Israel-administered Allenby (King Hussein) crossing between Jordan and the West Bank on April 22 with Israeli security forces finding 12 rifles and 194 pistols in his car, the Shin Bet internal security agency said.

The parliamentarian was not charged by Israel but was handed over to Jordanian authorities "for his continued investigation and legal proceedings," the

Shin Bet said in a statement. Jordan's official Petra news agency confirmed the

transfer, saying Adwan will appear before prosecutors at the country's State Security Court after "other defendants admitted to trading and smuggling weapons, gold and e-cigarettes in association" with

Ahmad Safadi, speaker of the Jordanian parliament's lower house, told local media that after Adwan's release by Israel, the legislature had voted to strip him of immunity from prosecution, following a court request.

Since February 2022, Adwan had used his diplomatic passport 12 times to smuggle various goods, the Shin Bet statement said. From the beginning of 2023, he began smuggling weapons across the border "out of greed, and received large sums of money", the statement added.

Loco crisis can cripple the railway

Govt should urgently find a way to address engine shortages

The way those in charge of the railway have been going about addressing its longstanding locomotive crisis is alarming. At a time when the railway is going through a severe shortage of engines threatening to derail its operation, the authorities have been moving at a snail's pace to fix it. That is, if they are moving at all. As per a new report, two projects - which, if executed as planned, would have added 70 new metergauge (MG) locomotives to its fleet and overhauled 21 old locomotives - are now at risk of being cancelled. Reason? Because of zero progress achieved in the projects despite years spent in preparation. It shows how, instead of fixing the engine crisis, the relevant authorities are allowing it to continue which can only mean public suffering down the

Getting into the details of these long-delayed projects serves up useful lessons. Bangladesh Railway (BR) took up the first project to procure 70 MG locomotives in August 2011. But despite three deadline extensions since then, punctuated by a major revision in 2018, when the project budget was increased from Tk 1,946 crore to Tk 2,659.33 crore, things are yet to pass the preliminary stage. The second project, taken up in July 2019, also suffered more or less the same fate. Reportedly, the project authority floated tender thrice over the last four years, but still failed to get it off the ground. The delay that has been witnessed in both cases is anything but usual, even by government standards. These projects have been evidently undone by the mismanagement, poor planning and incompetence of those involved. The question is, who will answer for that?

Even if these projects are now cancelled and replaced by fresh initiatives to procure and overhaul locomotives, it will be merely a bureaucratic formality with no guarantee that the same problems will not recur to haunt them. And the fact remains that we wouldn't have to deal with this situation had the higher authorities been remotely sincere about addressing the dire engine crisis. According to the latest estimate, the state-run BR has only 171 MG locomotives, of which a whopping 82 percent are old or "overaged", requiring urgent overhauling. Of the 92 broad-gauge (BG) locomotives under the BR fleet, 55 percent are also overaged. Clearly, the BR is headed toward a crisis point even if it may not publicly acknowledge it.

Unfortunately, the problems that derailed the locomotive projects have been the hallmarks of most railway projects over the last decade or so. We have frequently seen how, in the absence of any functional institutional accountability, expensive projects have been taken up and frequently revised to allow for inflated bills, only for them to add little to the railway service in the long run. How long will such mismanagement, irregularities and corruption be allowed? How long will taxpayers have to see their hard-earned money go down the drain like this? We urge the government to immediately address this issue. The locomotive crisis must not be allowed to continue any longer.

Clean up the canals before monsoon

And before waterlogging disrupts everyday life once again

Canals becoming blocked due to encroachment and pollution is hardly surprising news. But it never fails to leave us with a sense of helplessness anyway. It foreshadows the suffering of the residents when the roads stay flooded as a result. The state of four major canals in Dhaka as reported by Prothom Alo - being clogged with garbage, impeding their ability to drain out flood waters – is a case in point.

On paper, the Jirani Khal, for example, is almost 20 feet wide in some places and 50 feet in others. It goes through major points in the city such as Shantingar, Motijheel, Naya Paltan, Kamalapur and Khilgaon, carrying rain water and eventually pouring into the Balu River. But the reality is, it remains clogged with garbage and vegetation as it has not been dredged since the last rainy season. Three other canals – Manda, Shyampur and Kalunagar – are in the same condition. With these four canals being blocked, major areas under the Dhaka South City Corporation (DSCC) will fail to clear rain water during the upcoming monsoon season.

According to a city corporation official, dredging of these canals will begin within two months. This means, actual dredging will start during the rainy season. But how will that be carried out with the continuous downpour? In 2022, the government approved the project to revive the four canals – the total length of which is 19.78 km – to reduce the city's waterlogging problems. The main aim was to free them from encroachers and pollution. In addition, the project included boundary walls, 36 pedestrian bridges, 10 public toilets, walkways, plazas, bicycle lanes, and so on. It is supposed to be completed by 2024.

But as we know from past experience, many development projects are intended to make life easier for city-dwellers but end up getting unnecessarily delayed because of bureaucratic inertia. The result is continued misery of the people whose everyday lives are hampered, in this case by waterlogging. We have seen on many occasions how mayors have vowed to solve the waterlogging problem. But somehow, after each heavy rain, the roads of many parts of the city become flooded, with water stagnating for hours on

We, therefore, urge the government to take all necessary steps to make sure that the two city corporations of Dhaka prioritise dredging and cleaning of clogged canals as soon as possible. Although cleaning up the four canals in question is being prioritised, we hope such activities would be a routine function of the relevant authorities all year round. The government should also ensure that the city corporations have the capacity and resources to carry out such crucial work, and hold them responsible when they fail to do so on time. Awareness campaigns to dissuade people from throwing garbage in the canals also have to be conducted regularly. Keeping our drains, canals, and other water bodies clean and free-flowing is the responsibility of both the government and the city-dwellers.

While focusing his attention on climate crises, there is no scope for the new World Bank president to shy away from other difficult issues such as fighting poverty, tackling inequality, and reducing the debt burden of lowand middle-income countries. New and additional resources should be generated to confront the existing and new challenges. The mounting debt crisis in several countries must be addressed, too. Debt as a percentage of countries' gross national income (GNI) has increased significantly during the last decade. Countries in Sub-Saharan Africa, Latin America, the Caribbean, the Middle East, and North Africa have experienced a sharp increase of their debt-GNI ratio during 2010-2021. And though South Asia has seen only a two percent average increase of its debt-GNI during this period, countries such as Pakistan and Sri Lanka are facing

difficulty due to high debt. The G20's "Independent Review of MDBs' Capital Adequacy Frameworks" launched last year called for improving the balance sheets of multilateral development banks and making lending restrictions flexible and affordable for lower-income countries so that they can recover from the pandemic and achieve the Sustainable Development Goals. To match this, the WB needs to mobilise private-sector finance to meet both developmental and climate goals.

As part of its reform, the efficiency of the WB itself needs to be invigorated. The processing time for projects is lengthy as bureaucratic requirements are high and so are the transaction costs. This may discourage countries from borrowing from the WB to invest in infrastructure. The institution has to find ways to eliminate such limitations without compromising on the standards and quality of the bureaucratic process. Coordination with other multilateral institutions is critical for priority-setting so that resources are allocated and used efficiently, without duplication of programmes. Such collaboration has to be initiated from the top levels, which can help overcome institutional

Therefore, the new president of the World Bank will be settling into the hot seat during a turbulent period in a new world. His task is not only to consolidate what has been achieved so far, but to also help the institution evolve into one that await to see how well Ajay Banga can

What are we to make of this? Are these criticisms unreasonable or do the authors make a decent point? Should fashion brands be under scrutiny for their failure to address this issue?

I think it is right and proper that we should use the 10th anniversary of the Rana Plaza collapse to pause and reflect on the progress made by our industry. Garment worker remuneration is clearly a part of this, and the challenges faced by workers has been in the spotlight in the run up to this anniversary.

While on one hand I would always want the best for garment workers and will continue to campaign on social issues, we all need to understand that the subject of living wages is complex. Better wages cannot be introduced by any one actor alone. A leading fashion brand attempted to do this a few years ago and found that it was impossible widespread without collaboration.

It is perhaps worth asking, why are people paid the wage that they are? Why does a person making clothing in Bangladesh make, say, \$100 per month while one in China makes \$1,000 per month? In fact, workers in China's textile industry also do not receive "living wages" as their living standards are higher than that of their counterparts in Bangladesh.

For one, China's economy is more advanced and sophisticated than that of Bangladesh. Garment factories in Bangladesh are now competing with many other, higher paid industries which add more value. This has created an upward pressure on wages across the board and garment workers have been beneficiaries.

By contrast, in countries such as Bangladesh - and also India and Pakistan – the pace of economic development has been slower and

Similarly, we need to look at the clothing being produced, its quality, and the relation to wages. If lots of low-value items are being produced, profit margins will be small and this will impact wages. By way of contrast, in the world's most sophisticated industries, where barriers to entry are significant due to the unique nature of the product being produced, skilled labour is in sharp demand and wages are high.

Despite all these structural challenges, I do believe it is possible to raise wages for workers, who are the most important aspect of the fashion supply chain. And we must continue to strive to do so.

In the broadest sense, the biggest factor is taking into consideration the price we pay for clothing. This is a challenge for retailers as they are

retailer is going to reduce their prices in isolation. That would be commercial

suicide. But could we do more as an industry to educate end consumers about the lives of garment workers? Could we do more to help them understand that the price they pay for clothing ultimately has an impact on the wages paid to workers? Of course we can. Storytelling is a vital component of a modern, transparent fashion supply chain. Why not do more to tell the stories of the workers who produce our clothing?

There are a few more aspects of this issue that are worth exploring. Firstly, how does one calculate what a living wage is? I would argue that this is a nearly impossible task, with rents varying across locations, the number of dependents per person being different, and so on. To reiterate, living standards have risen in Bangladesh, with many garment workers now, for instance, having smartphones. We are not some third-world country, as occasionally portrayed by Western media.

There is also a concern that, if we ever do get anywhere near a fair wage, many brands and customers might simply decide to move production elsewhere.

A publicly listed company has to post increasingly good results, or investors will diversify their portfolio. How can a brand post both increasing margins and also pay fair prices to factories to enable fair living wages? Or is this the Holy Grail?



What will it take for our next election to be credible and acceptable to all?

Under pressure from many directions, both national and international, the government has been promising that the 12th parliamentary election will be free and fair. Our constitutional scheme also mandates fair elections. International laws and covenants, such as The Universal Declaration of Human Rights and International Covenant on Civil and Political Rights, too, obligate us to hold such elections. Thus, if we are to abide by our Constitution as well as will have to ensure that the next election is free and fair.

It must be noted that free and fair election necessarily means competitive election, where not participate, but each of them will also have an equal opportunity to win. Now the question is: what will it take for our next election to be credible and acceptable to all?

process is transparent, and credible. It must be recognised that the election is not a one-day phenomenon – it is a process involving multiple interrelated steps. They include the conditions that: (1) All eligible citizens can become voters; (2) All aspiring contestants can become candidates; (3) Voters have credible alternative candidates to choose from; (4) Scrutiny of the eligibility of candidates is fair; (5) Constituencies are delimited on the basis of a set of fair criteria; (6) Political parties and candidates can carry out their campaigns freely; (7) Antecedents of candidates are available for voters to make an informed choice in polling booths; (8) Candidates can field their agents in polling booths; (9) Voters are able to cast their vote without pressure or fear; (10) Influence of money and muscle on the election are effectively controlled; (11) Vote counting is transparent and accurate; (12) Election is monitored by credible election observers; and (13) Election disputes are settled speedily and impartially.

The above steps, it must be noted, are laid out in the body of election laws, such the Representation of the People Order, 1972 and The National Voter Registration Act, 1993, which elections is the constitutional

Another important requirement for free and fair elections is the neutrality of certain critical institutions responsible for carrying out the above steps. Most important of these institutions are: the Election Commission (EC), the bureaucracy, law enforcement agencies, and the international laws, the government higher judiciary. The EC plays the most pivotal role and is constitutionally mandated to ensure credible elections.

Considering its importance, Article 118 of our Constitution mandates the creation of an independent only will the major political parties EC. The Constitution also gives its members necessary protection so that they can act independently and impartially. The credibility of the EC has also been under serious question because of all the actions and utterances of its members.

Although the Awami League-led Grand Alliance came to power in 2009 with a commitment to depoliticise the bureaucracy and law enforcement agencies, these institutions have been made subservient in many respects to the interest of the ruling party over the past decade. In fact, the partisan behaviour of these two institutions was instrumental in the questionable election of 2018. There are also allegations from the opposition of the court's undue interference in the scrutiny of candidates in the last election. Furthermore, not a single election petition filed after the 11th parliamentary election, to our knowledge, has so far reached its election and any law which stifles finality, creating the prospect of them ultimately becoming infructuous.

Another, and perhaps the most important, requirement of credible

framework, which must be conducive to free, fair, and competitive election.

Our original Constitution provided for holding elections under the party in power and none of the parliamentary elections held under constitutional framework was fair and credible. To remedy that situation, the 13th amendment of the Constitution was enacted by the BNP in response to a vigorous movement by an AL-led alliance, to create a neutral caretaker government (NCG), representing a consensus among major political parties. The seventh, eighth, and ninth parliamentary elections, held under the NCG, were considered to be credible by all neutral observers. In fact, the NCG was a settled matter and the Special Parliament Committee (formed to amend the Constitution by the ninth parliament), on May 29, 2011, unanimously recommended to amend the Constitution retaining the NCG, which unfortunately was changed after they met the Prime Minister the next day.

Subsequently, the Grand Alliance, in a majoritarian manner, unilaterally passed the 15th amendment to abolish the NCG and hold future elections under the party in power. The amendment was passed by taking advantage of the Supreme

The amendment essentially tilted the electoral field in favour of the ruling party, which will prevent the EC from meeting its constitutional mandate to hold credible elections. Thus, unless a new political settlement is reached to amend the Constitution to create a neutral election-time government, the hope for a free, fair, and competitive next election would clearly be a mere pipe dream.

For the 12th parliament election to be free, fair, and credible to meet the demands of all concerned, the electoral process not only needs to be fair but all relevant institutions must also act neutrally. More importantly, the prevailing constitutional scheme must create a level playing field and provide equal opportunity to all political parties. In fact, our Constitution, according to constitutional expert Mahmudul Islam, "does not envisage anything else than free and fair the hands of the Commission in ensuring free and fair election will not pass the test of constitutionality" (Constitutional Law of Bangladesh, 3rd Edition, p. 973).

Challenges in US-Bangladesh relations

Joe Biden greeted Prime Minister Sheikh Hasina on the occasion of Bangladesh's Independence Day. Biden also reminded Hasina to hold free and fair elections in December 2023. "As Bangladesh approaches its next election. I am reminded of the deep value both of our nations' people place on democracy, equality, respect for human rights, and free and fair elections," he said.

The United States has placed a strong emphasis on human rights and democracy in its foreign relations. The promotion of these values has been a key part of US foreign policy, and has been pursued through a variety of means, including diplomatic efforts, economic incentives and sanctions, and military intervention in some with some authoritarian states put question marks on its declared policy of upholding democracy and human rights. The US under human rights has definitely angered

On March 26, 2023, US President and economic growth. The US and Bangladesh also work together to combat terrorism and promote regional stability through joint military exercises and training for Bangladesh's security forces.

The US-Bangladesh relationship has had some tensions due to human rights concerns. The US has criticised Bangladesh's government for cracking down on political opposition, and limiting freedom of speech and assembly. The US has imposed sanctions on the Rapid Action Battalion (Rab) for violating human rights. The US human rights reports of 2021 and 2022 have highlighted issues of enforced disappearances, extrajudicial killings, political marginalisation, and election rigging. As a result, Bangladesh was not invited to cases - even though its relations the Biden Democracy Summit, signalling a shift in US policy towards Bangladesh.

US' push for democracy and

Pacific Strategy). China responded by warning that Bangladesh's relations with China would be harmed if it joined the Quad, while also offering Bangladesh the chance to join its Global Development Initiative and Global Security Initiative. The US and Russia have also engaged in a war of words over Bangladesh, with the Russian Foreign Ministry accusing the US ambassador in Dhaka of trying to influence the domestic process of the country, and the Russian Embassy in Dhaka criticising countries with "hegemonic ambitions" that interfere in the internal affairs of others under the pretext of protecting democratic values.

The ongoing Ukraine-Russia conflict has resulted in a surge of high-level visits from China and the United States to Bangladesh, highlighting Bangladesh's growing importance in the Indo-Pacific region. This geopolitical reality is crucial for Bangladesh's future trajectory. For the first time, Bangladesh has articulated its distinct objectives in the Indo-Pacific region, aligning with the conceptual framework advocated by India, the US, Japan, and Australia. While Bangladesh has traditionally pursued a non-aligned foreign policy, recent developments suggest a potential shift towards

the Biden Presidency has also been focusing on these two values to deal with Bangladesh, which was partially absent during the Trump administration.

Since 2014, Bangladesh has been grappling with the challenges of upholding democratic values and human rights, which have been exacerbated in recent times. The two most recent elections, which were held under the Awami League government in 2014 and 2018, were heavily criticised by the international community, with widespread human rights violations occurring during this period. The regime has employed various means to suppress dissent, including the Digital Security Act (DSA).

The United States Bangladesh have had diplomatic relations since 1972. The US has become one of Bangladesh's largest trading partners, with over \$8 billion in bilateral trade in 2021, and has provided development assistance in areas such as education, health,

the Bangladesh government. Its bottled rage has bubbled up in various ways. Prime Minister Sheikh Hasina considers US sanctions on Russia as a form of human rights violations. "I don't really know what rationale there is for making people suffer like this. In a way, this is another violation of human rights. Depriving people of what they are owed... I hope the US sees the necessity of stepping aside from that decision [of putting Russia under sanctions]. We hope they prefer to punish a single country instead of the people of the world and see that everyone wants it withdrawn." Recently, Hasina commented in the parliament that, "It (US) has the power to topple the government in any country and particularly the Muslim countries."

Liberation War Affairs Minister AKM Mozammel Haque blamed the US for not recognising the genocide against Bangladesh in 1971. He said that the United States has recognised the genocide of the Rohingya in Myanmar. But it did not recognise the genocide that took place in Bangladesh, because it had direct involvement in it. At that time, the governments of the US and UK were not in favour of our Liberation War. But the people of those countries and the world were

on our side. That said, Bangladesh's apathy towards the US is quite clear. Meanwhile, China and Russia have extended their hands with "baskets of money", while Bangladesh is facing serious economic crises. Geopolitical interests for both US and China-Russia are well noted in the Indo-Pacific region.

The US invited Bangladesh to join the Quad in October 2020, citing the country as a key partner in the Indo-Pacific region, and later invited it to the US-led IPS (Indo-

aligning more closely with the IPS promoted by the United States and its regional allies. However, it remains to be seen how China and Russia will react to this shift and how Bangladesh will navigate its relationships with them.

It is unclear how successful Bangladesh's "pleasing all" strategy has been. An agreement has been reached between Bangladesh and Russia to use the Chinese yuan to pay for a nuclear power plant, but the United States has raised objections to this arrangement. Amid this situation, Bangladesh is attempting to manage the US through other Quad members like India and Japan. On April 26, 2023, under the agreement for the use of Chittagong and Mongla ports for the transportation of goods to and from India, the National Board of Revenue (NBR) released a standing order pertaining to the transhipment of Indian goods. During her visit to Japan in April 2023, Prime Minister Sheikh Hasina said that, "We are happy that Bangladesh and Japan have successfully elevated the bilateral relations to a 'Strategic Partnership' from the existing 'Comprehensive Partnership'."

It appears that the relationship between the United States and Bangladesh is going through some strain. Bangladesh is endeavouring to handle its relations with the US in the lead-up to the next election. Navigatingthisdynamicgeopolitical situation will require astute diplomatic strategies and judicious decision-making on Bangladesh's part. While attempting to maintain relationships with China, Russia, and the US, Bangladesh will also need to prioritise human rights and democratic principles, particularly in the context of potentially embracing the IPS.

Permanent structures on govt land

Why Sampadak Parishad opposes the Digital Security Act

Reprint of what we published on 29th September, 2018

After the enactment of the Digital Security Act (DSA) in 2018, the Sampadak Parishad published an elaborate Section by Section analysis of the objectionable parts and gave a detailed response as to how this law impinged on the operation of free and independent media and why DSA should be repealed or fundamentally amended.

The experience of the last four and half years proves the correctness of our initial concerns and strengthens our demand for repealing the Act.

Originally, we reproduced the Bangla versions of the Act along with our translation as the official English translation of the DSA was not available. In the present reprint below we have replaced the Bangla text (and translation) with the official English version of DSA. For the sake of brevity and improved readability, we have also made some modifications. (Please refer to the original article through this link: https://www.thedailystar.net/frontpage/ news/why-sampadak-parishad-opposes-thedigital-security-act-1640269)

1. The Act ends up policing media operations, censoring content and controlling media freedom and freedom of speech and expression as guaranteed by our constitution.

2. The Act gives unlimited power to the police to arrest without warrant, enter premises, search offices, bodily search persons, seize computers, computer networks, servers, and everything related to the digital platforms.

3. The Act suffers from vagueness and uses many terms that can be misinterpreted and used against the media. Laws must be clear, specific and meticulously defined. A vague law is a weapon of misuse and as such oppression of the media.

4. DSA will create an atmosphere of fear and intimidation which will make journalism and especially investigative journalism virtually impossible.

5. The law will not only create panic among media professionals, but also among all users of computers, computer networks, and related

6. The purpose of the law as mentioned in its preamble is "ensuring digital security and identification, prevention, suppression and trial of offences committed through digital device and for matters ancillary thereto". However, its use over the last four and half years provide irrefutable proof that its purpose has been to curb freedom of the media, freedom of expression and all related freedoms.

7. The law goes against the very nature and practice of independent journalism that stands to protect people's right to know and exposes abuse of power and corruption.

8. While other fields, like cyber security, may require "regulations" media needs "freedom". The DSA is focused only on the "regulation" and totally neglects the "freedom" aspect that the media needs.

9. A frightening aspect of the DSA is the enormous arbitrary power given to the police who may arrest, without warrant, a journalist just on suspicion of a so-called crime that police think may be committed in the future. In practical terms, this will bring journalism under police control.

10. It is alarming that out of the 20 or so provisions of the law that deal with offences and punishments, 14 are NON-BAILABLE. Five are bailable and one can be negotiated. The lowest punishment is 1 year in prison and the highest life-term but mostly in the range of between 4 and 7 years. This will inevitably create an atmosphere of FEAR and INTIMIDATION under which normal functioning of journalism will become extremely risky if not impossible.

11 Another flaw of the DSA is the level of punishment meted out to "offenders". Let's take the case of the Road Safety Act which was passed along with the DSA. The former provides for a maximum punishment of 5 vears for killing people in road accidents while a journalist can be punished up to life-term for violating the colonial era Official Secrets Act

SECTION BY SECTION ANALYSIS AND OUR **OBSERVATIONS**

Below we present a detailed analysis as to why Sampadak Parishad (Editors' Council) considers this law to be anti-free press, against freedom of speech and antithetical to democracy. To ensure the accuracy of our analysis, we have referred to the official English text of the Act, which was published on October 6, 2019."

SECTION 8

Power to remove or block some data**information.** (1) If any data-information related to any matter under the jurisdiction of the Director General, being published or propagated in digital media, creates threat to digital security, the Director General may request the Bangladesh Telecommunications and Regulatory Commission, hereinafter referred to as BTRC, to remove or, as the case may be, block the said data-information.

(2) If it appears to the law and order enforcing force that any data-information published or propagated in digital media hampers the solidarity, financial activities, security, defence, religious values or public discipline of the country or any part thereof, or incites racial hostility and hatred, the law and order enforcing force may request BTRC to remove or block the data-information through

the Director General. (3) If BTRC is requested under sub-sections

"You often say that freedom of speech means freedom of the press. Do you know that editors of East Bengal are summoned and told that you cannot print this or that. "This must be clearly written [in the constitution] that freedom of the press will exist and they [editors] can write as they wish and they can create public opinion."

SAMPADAK PARISHAD'S COMMENT

There are two issues of concern here -- the power of the Director General and the power of the law enforcement agencies. The power to block contents will hit the heart of publication either in print or online. Any report may be blocked or a photograph may be confiscated that may lead to disruption of any media outlet.

The justifications needed to remove or block content are too vague and subject to individual interpretation, leaving room for the abuse of the law. For example, if a journalist exposes corruption in a project, and this leads to the project's financing being stopped by a donor or private investor, the journalist can be accused of "disrupting financial activities" under this law, which can then lead to the blocking or removal of their content.

Punishment for making any kind of propaganda or campaign against liberation war, spirit of liberation war, father of the nation, national anthem or national flag. (1) If any person, by means of digital medium, makes or instigates to make any propaganda or campaign against the liberation war of Bangladesh, spirit of liberation war, father of the nation, national anthem or national flag, then such act of the person shall be an offence. SAMPADAK PARISHAD'S COMMENT

We are fully committed to the preservation of the dignity and correct history of our Liberation War and given the past experience of attempts at its distortion we understand the need to do something in this regard. However, "Spirit of Liberation War" is a rather vague term. Without further defining the "crimes" under this section and clearly specifying what constitutes a "crime", we run the risk of serious abuse of this law and harassment of journalists and the punishment is up to life-term or (and) Tk 3 crore in fine or both.

"Mukti Juddher Chetona" (Spirit of Liberation War) is a vague term and is very subjective and cases can be brought against journalists as interpretations can vary.

We reiterate that we are in favour of protecting the great legacy of our Liberation War for the future generations. However, when laws are being framed, we need to be very clear and specific. Given its present form, not only journalists but historians, researchers and even creative writers like novelists will also suffer. It may even result in people not writing or researching much on our Liberation War fearing misinterpretation and the possibility of punishment.

SECTION 25

Transmission, publication, etc. of offensive, false or threatening data-information. (1) If any person, through any website or any other digital medium, (a) intentionally or knowingly transmits, publishes or propagates any datainformation which he knows to be offensive, false or threatening in order to annoy, insult, humiliate or malign a person; or (b) publishes or propagates or abets to publish or propagate

any information, as a whole or partly, which he knows to be propaganda or false, with an intention to affect the image or reputation of the country, or to spread confusion, then such act of the person shall be an offence.

SAMPADAK PARISHAD'S COMMENT

This will directly affect all investigative reporting in the media. Such reports are usually about some irregularities performed by institutions and individuals. Corrupt people will use this law to intimidate journalists and media organizations and try to prevent publication of such stories on the pretext that the reports have attacked or intimidated them. Actually, every such report can be said to fall under one or more of the above categories and can be used to harass the media.

Any investigative report that reveals corruption about a person or an institution is bound to "irritate", "embarrass" or "humiliate" someone. This provision will make it impossible to publish any negative report about any corrupt person. This will reduce newspapers to PR outfits. Journalism of even the most rudimentary investigative nature will become impossible.

The second part of this provision talks about "spreading confusion". Without specifying the meaning of "confusion", it may become a weapon of media harassment. What is confusing to one may not be confusing to another. This will surely create a new avenue to intimidate the media.

Then again, what constitutes damaging the "image or reputation" of the State? Recently we have reported about the corruption in the banking sector by unscrupulous business groups. We have reported that the banks face grim crisis. Does it constitute damaging the "image or reputation"? We have reported corruption in the law enforcement agencies.

digital media than for print media. SECTION 31

Offence and punishment for deteriorating law and order, etc. (1) If any person intentionally publishes or transmits anything in website or digital layout that creates enmity, hatred or hostility among different classes or communities of the society, or destroys communal harmony, or creates unrest or disorder, or deteriorates or advances to deteriorate the law and order situation, then

such act of the person shall be an offence. SAMPADAK PARISHAD'S COMMENT

A news concerning discrimination of Dalits, or ethnic groups and exploitation of disadvantaged groups may be interpreted as causing disaffection between different sections of the society. Any news highlighting plights of the people of Chittagong Hill Tracts may be interpreted as "creating unrest" among different communities. Similarly, news about possible labour unrest, impending hartal or demonstration can be construed as reports that are "creating law and order situation" and thus bring action under this law. There could be a story that a person has died in a demonstration which may later prove to be untrue. Will the media be "guilty of spreading rumour"? Such errors regularly occur in reporting which are corrected immediately. In Bangladesh death figures from floods, cyclones or even roads accidents vary. Government figures are always at variance with privately gathered figures. In such cases according to the DSA, media can be sued for "spreading rumour". Sometimes reports may forecast certain developments which may not exactly happen later. That also can be considered as "spreading rumour". Thus, we find this section as seriously jeopardizing freedom of journalism.

Offence and punishment for breaching secrecy of the Government. (1) If any person commits or abets to commit an offence under the Official Secrets Act, 1923 (Act No. XIX of 1923) by means of computer, digital device,



We have reported on "custodial deaths" "disappearances", and "extra-judicial killings". If someone interprets all these reports as damaging to the "image" of the State then this law legalises punishment of journalists and newspapers for making such reports, as all newspapers have websites.

Publication, broadcast, etc. of information in website or in any electronic format that hurts the religious values or sentiment. (1) If any person or group willingly or knowingly publishes or broadcasts or causes to publish or broadcast anything in website or any electronic format which hurts religious sentiment or values, with an intention to hurt or provoke the religious values or sentiments, then such act of the person shall be an offence.

SAMPADAK PARISHAD'S COMMENT

The term "religious sentiment" is an undefined term. How can a reporter know how and when religious sentiment has been hurt? This term lends itself to diverse interpretations and no iournalist will feel comfortable about reporting on such issues. This will prevent journalistic scrutiny over a large area of the society. The recent reporting on the sexual harassment by catholic priests would not have been possible if those countries had a law preventing reporting that "hurts" religious sentiments. Criticizing unlawful fatwa or women's property rights may be interpreted by some as "hurting" their religious values. This section can lead to widespread harassment of journalists.

SECTION 29

Publication, transmission, etc. **defamatory information.** (1) If any person publishes or transmits any defamatory information as described in section 499 of the Penal Code (Act XLV of 1860) in website or in any other electronic format, he shall be punished with imprisonment for a term not exceeding 3 (three) years, or with fine not exceeding Taka 5 (five) lac, or with both.

SAMPADAK PARISHAD'S COMMENT

A law already exists to deal with defamation and so a separate law for digital media is not needed. Furthermore, there is no justification for imposing harsher penalties for the same offense committed through

any other digital means, he shall be punished with imprisonment for a term not exceeding 14 (fourteen) years, or with fine not exceeding Taka 25 (twenty-five) lac, or with both. (2) If any person commits the offence referred to in subsection (1) for the second time or repeatedly, he shall be punished with imprisonment for life, or with fine not exceeding Taka 1 (one) crore,

or with both. SAMPADAK PARISHAD'S COMMENT

This is a sweeping restrictive law from the colonial times that was promulgated to protect the British administration from any sort of accountability. It is shocking to see it being incorporated for digital platforms. Anything that is not made public by the government is deemed an "official secret". Let us take one example. We have published dozens of reports about bank defaults based on Bangladesh Bank's findings. All such reports can be said to have violated the Official Secrets Act. All government reports which have not been made public, say, on pollution or child nutrition, are a part of the Official Secrets Act. Is journalism of any worth possible without the use of such official reports? And why should using them be a "crime" as people have a "Right to Know" under the RTI Act, especially when all such reports are funded by public money.

Could we have done any of the reporting on default loans, gross irregularities in Farmers' Bank or Basic Bank without Bangladesh Bank or government departments' reports which were yet to be made public? And our reporters often use their mobile phones to take pictures of such documents. So, under this law, journalists can be thrown in jail up to life-term?

SECTION 43

Search, seizure and arrest without warrant. (1) If any police officer has reasons to believe that an offence under this Act has been or is being committed, or is likely to be committed in any place, or any evidence is likely to be lost, destroyed, deleted or altered or made unavailable in any way, then he may, for reasons of such belief to be recorded in writing, proceed with the following measures, namely: (a) to enter and search the place, and if obstructed, to take necessary measures in accordance with the Code of Criminal

Procedure:

(b) to seize the computer, computer system, computer network, data-information or other materials used in committing the offence or any document supportive to prove the offence;

(c) to search the body of any person present in the place:

(d) to arrest any person present in the place if the person is suspected to have committed or be committing an offence under this Act.

(2) After concluding search under subsection (1), the police officer shall submit a report on such search to the Tribunal.

SAMPADAK PARISHAD'S COMMENT

This is by far the most dangerous of the provisions of the law. This empowers the police to enter any

premises, search any computer system, seize any computer network and its servers, bodily search any body and also ARREST anybody on suspicion.

First, the threat of arrest without warrant will naturally prevent a journalist from doing their work. When police get the power to arrest without warrant, and on mere SUSPICION then media freedom will be buried under this law. Given the fact that 14 out of 20 provisions of punishment are NON-BAILABLE the threat of arrest becomes like the "Damocles' Sword" constantly hanging over the head of every journalist, causing mental stress. This will prevent all forms of real journalism and make our media nothing more than public relations and propaganda outlets.

Even if the law is not implemented (and why not if the law exists?) the environment of fear will prevent journalists from doing their job. The fear of arrest will become a regular part of the "mental environment" and desist a journalist from taking legitimate risks that he or she regularly take to file their stories. The "emotional stress" that it will create should not be underestimated. It can easily be expected that people in power will abuse this law, provoke or "manage" law enforcers to threaten or even arrest journalists for any story that will reveal something that the rich and powerful will want to hide.

The most dangerous side of this law is that since every newspaper and TV station works on digital system, by giving the power to confiscate a computer, a network of computers including servers, the law enforcing agencies have been given, in effect, the power to shut down a newspaper or TV station or a news portal by confiscating its computers, computer system, computer network and other equipment. Thus, without closing down a media outlet, this clause opens up the possibility of stopping the publication of a newspaper or the operation of a TV station by the law enforcing agencies.

SECTION 53

Offences to be cognizable and bailable. -- In

(a) the offences specified in sections 17, 19, 21, 22, 23, 24, 26, 27, 28, 30, 31, 32, 33 and 34 shall be cognizable and non-bailable;

(b) the offences specified in clause (b) of sub-section (1) of section 18, sections 20, 25, 29 and sub-section (3) of section 47 shall be noncognizable and bailable:

(c) the offences specified in clause (a) of subsection (1) of section 18 shall be non-cognizable. bailable and subject to the permission of the court, be compoundable; and

(d) the offences, if committed by a person for the second time or more, shall be cognizable and non-bailable.

SAMPADAK PARISHAD'S COMMENT

Under this law out of the 20 or so provisions dealing with crimes and punishment,14 are cognizable and NON-BAILABLE. Given the fact that police have the power to arbitrarily arrest without warrant and on mere suspicion, this law presents a real threat to media freedom as so many offences have been made cognizable

CONCLUSION

1. The Digital Security Act (DSA) clearly violates the citizens' Constitutional Right to freedom of speech and expression and freedom of the press, guaranteed in our most sacred document, the Constitution, with reasonable

2. This law violates the spirit of our Liberation War and the high ideals of freedom that our martyrs laid down their lives for.

3. This law is against the fundamentals of democracy, democratic governance and all the rights that our people fought for repeatedly during our struggle against the Pakistani rule and against all martial law regimes after 1971.

4. The Digital Security Act is against all the fundamental values of ethical and independent journalism.

5. The Digital Security Act is in contradiction with the Right to Information Act.

We have explained in detail and made a section-by-section analysis as to why the Digital Security Act is against our Constitution, against our fundamental fights, against freedom of speech and freedom of press and as such against democracy.

It is thus that the Sampadak Parishad is forced to reject this law.

The quotation from the Father of the Nation, Bangabandhu Sheikh Mujibur Rahman (published in the highlighted box), must guide us in the matter of protecting the freedom of the press.



Gazipur city a jinx for mayors?

None so far completed their terms

None of the Gazipur mayors, whether from the Awami League or the BNP, could serve the city corporation for the entirety of their five-year terms.

Since the city corporation was formed in 2013, it was run for a considerable period by acting mayors. Civil society members of the city say the absence of an

actual mayor was partly to blame for the poor amenities

Senior BNP leader Abdul Mannan, the first elected mayor of Gazipur, took charge on August 18, 2013. But in less than two years, councillor Asadur Rahman Kiron became the acting mayor on March 8, 2015, and continued to hold the position until June 18, 2017, when Mannan could resume his role as mayor.

During this period, he was either in jail or facing suspension. After his return, he continued to be the mayor until the end of his tenure on September 4, 2018.

When ruling Awami League leader Zahangir Alam

AMJAD HOSSAIN, PRESIDENT OF SHUJAN IN GAZIPUR

became the mayor in 2018, the city dwellers expected that he would be able to complete his tenure in office.

But the AL expelled him from the party November 19 last year after he was seen in a viral video footage making controversial comments on Bangabandhu Sheikh Mujibur Rahman and the Liberation War.

In less than a week, the local government ministry suspended him from the post of mayor.

Asadur Rahman Kiron, who was a panel mayor at the time, became the acting mayor again.

Jalal Uddin, president of Gazipur Nagorik Forum, said when elected mayors fail to properly discharge their duties, the people of the city suffer a lot.

"It is unfortunate that the city dwellers were deprived of the development they expected from the mayors," he told The Daily Star yesterday.

Some 30 lakh people live in Gazipur city, an area of

329.90 square kilometres. The city dwellers complain that even after almost 10 years of the formation of the city corporation, civic

amenities have not improved. Delwar Hossain, a resident of Joydebpur area, said there is a difference between an actual elected representative

and someone who is filling in. "It is natural that the citizens of that area are deprived

Rare butterflies named after Sauron in Lord of the Rings

A new group of butterflies with distinctive orange wings and dark eyespots has been named after

Lord of The Rings villain Sauron. The rings on the vivid orange wings of

the flying insects are reminiscent of the all-seeing eye described in JRR Tolkien's books, and depicted in the movie series. Scientists, including

Blanca Huertas, senior curator of butterflies at the Natural History Museum, have given the new genus the name Saurona. While there are currently only two members of

this new group - Saurona triangula and Saurona aurigera – many more as-yet-undescribed species are thought to exist.

Saurona is one of several new butterfly groups described by an international team of researchers in a new paper, and one of two named by Dr

Dr Huertas and a fellow researcher named the second genus Argenteria, which translates into English as silver mine, on account of the silver scales on the wings.

"Naming a genus is not something that happens very often, and it's even more rare to be able to name two at once," she added.

STRIFE-TORN SUDAN UN aid chief in KSA for talks as fighting flares

The UN's top humanitarian official arrived in Saudi Arabia yesterday for ceasefire talks between Sudan's warring generals, as gun battles and air strikes flared in the Sudanese capital at the start of a fourth week of fighting.

Multiple truce deals have been declared and quickly violated since battles erupted between army and paramilitary forces on April 15 in the poverty-stricken country with a history of political instability.

Fierce combat since then has killed hundreds of people, most of them civilians, wounded thousands and sparked multiple warnings of a potential "catastrophic" humanitarian crisis. More than 100,000 people have already fled the

country. In embattled Khartoum, fighter jets have bombed positions as terrified residents stay barricaded indoors trying to cope with dire shortages of water, food, medicines and other staples. Across the Red Sea in the Saudi city of Jeddah, talks were

underway aiming for a ceasefire that could push efforts to bring humanitarian aid to the besieged population

The generals leading the warring parties have said little about the talks being held in Jeddah since Saturday.

Army spokesman Brigadier General Nabil Ábdalla said the talks were on how a truce "can be correctly implemented to serve the humanitarian side", while Mohamed Hamdan Daglo, who heads the Rapid Support Forces (RSF), only said on Twitter that he welcomed the technical discussions.

Heatwave likely to continue for next few days
