Some parts of Dhaka north to see gas supply disruption

Households and businesses in Khilkhet, Joarshahara, Namapara, Baridhara, Gulshan and Basundhara residential area will face low pressure in gas supply tomorrow for 16 hours starting from 8:00am today due to emergency works in a pipeline.

During that time, the gas supply will remain suspended in areas on both sides of the Kuril Bishwa Road.

According to Gas Transmission and Distribution Company Limited, there will be no gas supply in two of the CNG refuelling stations there, North-South University, the US embassy, catering services of Pan Pacific Sonargaon, and Evercare Hospital.

2 children drown in Jamalpur

Two children drowned in a pond in Jamalpur yesterday.

Simanto Islam, 7, son of Ibrahim Khalil of Sirajabad area of Islampur upazila, and Minal Mia, 8, son of Shukkar Ali of the same

Both are first graders of Sirajabad Government Primary School, said OC Majedur Rahman of Islampur Police Station.

Quoting locals and family members, he said the children were playing on the bank of the pond near the house around noon.

Suddenly they fell into the pond and drowned as they didn't know how to swim, he added

Later, locals rescued and took them to the Upazila Health Complex where the doctor declared them dead.

A Dhaka court vesterday again asked the Anti-Corruption Commission to submit by July 13 the probe report in a graft case filed against former chief justice Surendra Kumar Sinha for amassing illegal wealth.

Judge Md Asaduzzaman of Dhaka Metropolitan Senior Special Judge's Court passed the order as ACC failed to submit any probe report. ACC has now taken eight dates to complete the probe.

On October 10 of 2021, ACC filed the case against SK Sinha with its integrated Dhaka District Office-1 for allegedly amassing Tk 7.14 crore in his brother's and relative's names by misusing power and transferring the amount.

during his tenure took a plot from Rajuk in Uttara residential area and by misusing power, he took another three-katha plot in his brother's name in the Rajuk Purbachal Project.

He later elevated the three-katha plot to a fivekatha, shifted the plot from Purbachal to Uttara sector-4 and gave power of attorney to a relative.

ACC, in its investigation, found that the former chief justice paid Tk 75 lakh to Rajuk against the plot and built a nine-floor apartment complex on it at a cost of Tk 6.31 crore.

On November 9 of 2021 SK Sinha was sentenced to 11 years in prison in a case filed on charge of laundering Tk 4 crore.

It is estimated that six out of every 100 Bangladeshis carry the gene responsible for the disorder, according to a health bulletin of the Directorate General Health Services (DGHS).

A recent survey in 20 districts by the BSHI revealed that 10 percent of high school and college students are carriers of the thalassaemia gene.

Prof According Belayet, there is a 25 percent chance that a newborn will suffer from lifelong thalassaemia if both parents have the gene.

In 50 percent of cases, the newborn will be a carrier of the gene like the parents, but will not suffer from thalassaemia, and in 25 percent of cases, the newborn will neither be a carrier nor suffer from the
