No gas in Ctg for 2 days

Situation may improve today, to normalise within a week

Gas supply has been suspended in Chattogram's residential areas, filling stations, and industries for two consecutive days, causing significant sufferings to city dwellers.

Many people have been forced to buy food from restaurants due to the crisis, while some have resorted to buying alternative kitchen items such as gas cylinders, kerosene, and induction stoves, which are being sold at higher prices.

The gas crisis was caused by the suspension of gas supply from two floating LNG terminals at Maheshkhali in Cox's Bazar since 11:00pm on Friday due to Cyclone Mocha.

State Minister for Power, Energy, and Mineral Resources Nasrul Hamid said it may take 12 to 15 days to start LNG supply, but gas distribution officials have announced that residential customers in Chattogram

Gas supply to the filling station and industry was stopped from 6:00am on Saturday, while residential customers received gas till Saturday evening, although the gas pressure was low. Supply to the residential sector was completely stopped from Sunday morning.

However, gas supply to the residential sector was completely stopped from Sunday morning.

KGDCL has announced that it may take 6/7 days to normalise the supply, and many residents have reported difficulties in finding kerosene stoves or induction cookers in the markets.

Besides, gas supply has remained suspended at all CNG pumps and filling stations in the city since Saturday morning, resulting in a decrease in the number of vehicles on the roads.

Aminur Rahman, general manager (Marketing-North Division) of KGDCL, said they expect to resume NLG supply by Monday evening and that gas supply will return to normal within a week.

Woman killed, 60 shanties gutted in fire

A woman was burnt to death and 60 shanties were gutted in a fire at a slum at Chattogram city's Bahaddarhat Ek Kilometre area yesterday morning.

The deceased is Hasina Begum, 55.

A firefighter -- Md Ibrahim -- was injured while trying to douse the blaze, said Bahar Uddin, senior station officer of Kalurghat Fire Station. He was given primary treatment, said the officer.

The fire originated from the leak of gas cylinder in the slum around 10:05am, said Bahar Uddin. Four firefighting units doused the blaze around 11:45am.

250 families evicted from port city hills

Chattogram District Administration yesterday evicted 100 families who are living at the foot of the hills with great risk of landslide in port city's Lalkhan Bazar area.

With the latest eviction, a total of 250 families have been evicted since Saturday night from Akbarshah and Lalkhan Bazar areas.

According to DC office, the families have been taken to temporary shelters.

Senior Executive Magistrate and NDC of Ctg district administration Md Towhidul Islam said, "We conducted the eviction drive in Moti Jharna and Batali Hill areas and evacuated 100 families. Despite the threat of cyclone,

they did not shift to save themselves so we launched the drive."

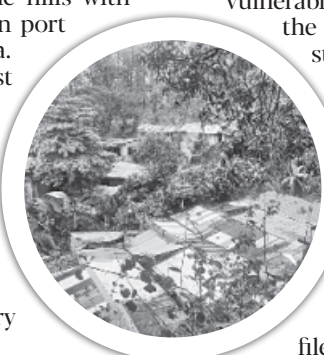
"We have also identified 50 to 60 illegal establishments which are very vulnerable to landslide. We asked the local councillor to take steps," he added.

Fire service and police assisted the drive.

Assistant Commissioner (Land) Bakalia Circle Jamiul Hiqma said, "A school has been set up by cutting down the hill in Mati Jharna. We have learned that a case filed by the Department of Environment is now under trial."

Around 170 people died in massive landslides in June 2017 in Chattogram, Rangamati and Bandarban districts, disconnecting regional communication for days.

ZAHANGIR'S SUSPENSION HC defers verdict for 4th time

The High Court yesterday for the fourth time deferred the delivery of its verdict till May 28 on the petition that challenged the legality of the government's action to suspend Mohammad Zahangir Alam from Gazipur City Corporation mayoral office. Justice Zafar Ahmed and Justice Md Bashir Ullah was scheduled to deliver order yesterday.

The bench deferred it after Zahangir's lawyer prayed for adjournment. On November 25, 2021, Zahangir was expelled from Awami League for making derogatory comments on Liberation War martyrs.

He was also suspended from the mayor post.
