Polls-time govt a possibility but without BNP

PM again rules out dialogue

- Govt has no objection to BNP's movement but violence won't be tolerated
- Age limit for entering govt jobs won't rise
- Not too many reasons to be worried about forex reserves

Prime Minister Sheikh Hasina has said an election-time government can be formed with the parties having representation in parliament, although the next general election will be held following the Westminster-style of democracy in Britain.

"We will hold the election like it is conducted in Britain We can show our generosity if any MP from the political parties having representation in parliament expresses the desire to join the election-time government. We are ready to welcome them," she said.

Hasina was addressing a press conference at the Gono Bhaban yesterday afternoon. The event was organised to brief the media about the outcome of her recent visits to Japan, the US, and the UK, reports BSS.

Mentioning that the Awami League showed such generosity previously, the premier said BNP Chairperson Khaleda Zia was asked to give the name of her party's representative for the polls-time government ahead of the 2014 national election, but the BNP did not.

"They [BNP] are not in parliament now. There is nothing to think about,"

All seven BNP MPs resigned from the Jatiya Sangsad in December last year as part of the party's anti-government movement.

Asked if the government would hold any talks with those political parties who are now waging an anti-government movement, the premier said, "Why would we call them to talks? Their demands are not clear."

Talking about the US dollar crisis, Hasina said the crisis is not only in

Govt calls off addl security for 6 envoys

The government has withdrawn additional security given to the ambassadors and high commissioners of India, China, Australia, Saudi Arabia and the US and UK, saying that the security situation in the country is "very satisfactory" and that there is a shortage of police personnel.

"Recently, a number of embassies have demanded additional security. We have decided not to extend this service to any," Foreign Minister AK Abdul Momen told The Daily Star

AL expels Zahangir

Suspended mayor of Gazipur City Corporation Zahangir Alam has been permanently expelled from the ruling Awami League, said a party press release yesterday.

"Awami League's central executive committee expelled Zahangir permanently as per the party charter. It will come into effect immediately," read the release signed by Biplab Barua, AL office secretary.

The decision came a day after a secretary-level meeting of the ruling with Secretary Obaidul Quader in the chair, recommended expelling Zahangir from the party.

Zahangir, who was elected Gazipur mayor in 2018 on AL ticket, also became the general secretary of the party's Gazipur city unit.

On November 19, 2021, he was expelled from the party after he was heard in a viral footage making derogatory remarks on Sheikh Bangabandhu Mujibur Rahman and questioning the number of the Liberation War martyrs. SEE PAGE 2 COL 3

Two held for rape attempt on JU student

Two men were arrested on charge of attempting to rape a Jahangirnagar University student at her house near the campus early yesterday.

The victim filed a case against them with Ashulia Police Station in this connection, SM Kamruzzaman, officer-in-charge of the police station, told The Daily Star.

The arrestees are Rakib Hossain, a resident of Pallabi area in Dhaka, and Mezbah Uddin, of the capital's Baridhara area. They are under 30 years old and are not students of the university, police said.

The incident took place around 12:30am at the student's rented flat near the university campus, according to the case statement.

Rakib and Mezbah had earlier been introduced to the victim by another student, and they were at her flat on Sunday night, said statement.

As the victim was sleeping in her room, Rakib tried to rape her with the help of Mezbah. The victim over phone called students at the university who rushed there and rescued her. They also held the two and took them to the campus, the statement added.

The JU proctorial team then handed them over to Ashulia police. Mohibur Rouf, an assistant proctor, said the incident took place outside the campus.

A Dhaka court sent the two to jail.

IMRAN KHAN'S RELEASE Govt supporters call for Pak top judge to quit

Several thousand pro-government protesters yesterday demanded the resignation of Pakistan's top judge for releasing Imran Khan last week, as the former prime minister went back to court facing yet more legal cases.

Khan, who was ousted from power last April, was arrested last Tuesday following months of simmering political crisis, prompting his voters to rampage through cities.

His arrest was declared unlawful by the Supreme Court's chief justice and Khan was later released and granted various bail applications, reports AFP.

"The chief justice and a few of his cronies are disgracing the judiciary like never before. Their justice seems to be serving one leader only," said Malik Hassam Mehmood, a 36-yearold trader and supporter of Prime Minister Shehbaz Sharif's party.

Canberra lauds Dhaka

Australian assistant minister says his country eyes int'l rule-based Indo-Pacific

Australia said it wants an Indo-Pacific region where "no country dominates or is dominated" by others.

Tim Watts, assistant minister for foreign affairs of Australia, lauded Bangladesh's Indo-Pacific Outlook, saying that he particularly liked Dhaka's argument for an "inclusive region", a concept he said is also shared by Australia.

"Australia's vision in the Indo-Pacific is having a prosperous and resilient region governed by international rules, strategic equilibrium, sovereignty and where ... no country dominates or is dominated," said Watts.

He made the comments while in discussion with a select group of journalists on Sunday after attending the Indian Ocean Conference on May 12-13. On the sidelines, he also held a bilateral meeting with State Minister for Foreign Affairs Shahriar Alam.

Asked, he said Australia is eager to enhance security cooperation with Bangladesh, adding that Australia has recently sent a defence adviser to Dhaka as part of its goal to enhance maritime security cooperation.

The bilateral trade between Bangladesh said.

and Australia is \$3.6 billion and the signing of the Trade and Investment Framework Agreement last year means the Australian investment in Bangladesh will grow in the coming days, Watts said.

He said potential areas of growth are agriculture, education, vocational training and energy. Bangladesh also imports cotton from Australia, which supports the RMG sector in Bangladesh.

Watts said Australia is a "trusted and reliable" energy supplier to many countries around the world. Amid the global green economy and clean energy push, Australia is aiming to become a renewable energy superpower, he said.

Watts said they believe that Australia has the required solar and wind power resources and space to generate enormous renewable energy that can be exported to Bangladesh and other countries in the Indo-Pacific region.

"We are aiming to help Bangladesh meet its green energy needs."

Prime Minister's Energy Adviser Tawfiqe-Elahi Chowdhury has recently visited Australia to evaluate the potential for exports of renewable energy and green hydrogen.

US won't comment on participatory polls in Bangladesh

The US is not concerned about participation of any particular party in Bangladesh's next elections but it wants the polls to be fair and held in a congenial environment, a senior visiting State Department official said.

"We are not making a comment on whether or not elections are participatory, more we are focused on electoral environment (in Bangladesh)," Assistant Secretary US Deputy Afreen Akhter told BSS diplomatic correspondent Tanzim Anwar on Saturday in the capital.

She added, "Ultimately it is up to (political) parties themselves to decide" if they would participate in the elections and "again we are not commenting whether it (requires to be) participatory".

The senior US diplomat said her country was not interfering or weighing in with any particular party or candidate though they were working to support the electoral environment here.

Akhter's comments came as asked if BNP or any other particular party's election participation would concern

"Let me emphasize that the US does not support any political party, any candidate, any individual," Akhter said adding that they were not seeking to mediate the election either.

Police recovered the hanging bodies of a woman and her three-year-old son from their residence in Bhairab upazila of Kishoreganj yesterday.

Jonaki Akter, 35, was the wife of an expatriate working in Italy Farhad Mia, and Alif Hossain was their only child, police said.

Bhairab Police Station OC Shah Alam Mollah said the bodies were sent to Kishoreganj General Hospital for autopsy.

Jonaki's family alleged that her in-laws put her through psychological abuse for dowry. Her inlaws fled the house after the incident.

Hearing on charge framing against Khaleda on June 15

A Dhaka court yesterday set June 15 for the hearing on charge framing against BNP Chairperson Khaleda Zia in 11 cases filed in 2015. Md Asaduzzaman of Metropolitan Sessions Judge's Court adjourned the hearing and fixed the new date, said Additional Public Prosecutor Tapash Kumar Pal.

The adjournment came following petitions submitted by the defence citing different reasons. Khaleda, who is out of jail following an executive order from the government, is now

unwell and staying at her Gulshan residence. Ten of the 11 cases were filed in the first three months of 2015 over arson attacks, while the other one was filed with a Dhaka court on a charge of making seditious comments on freedom fighters and martyrs of the Liberation War.

recommended flexible interest rates targeting monetary policy modernisation, which we are also in favour of."

But specialised and subsidised credit schemes for the disadvantaged such as those involved in agriculture and MCSMEs, and women and vouth should be continued.

Besides, the IMF's loan conditions call for a reduction in tax exemption. But tax exemption rationalisation should be done through an open and transparent process and with consultations with stakeholders so that industries, particularly Small and Medium Enterprises, do not suffer, he added.

According to the noted economist, inequality in rural areas declined slightly because of the positive impact of non-farm activities, agricultural output, and social safety net programmes.

"On the other hand, urban inequality increased significantly...,

Urban inequality has been fuelled by rural-urban migration, said Debapriya.

He suggested that the government IMF implement programmestipulated reforms and policy steps by taking the inequality concerns into cognisance and in consultation with the disadvantaged.

"When the IMF goes to a country with their programme, it establishes a singular authority over economic management," he said.

SC on case filed over ownership of abandoned property worth Tk 300cr in Dhanmondi

The Appellate Division of the Supreme Court vesterday quashed a case filed by one S Nehal Ahmed who sought ownership of an abandoned property in Dhanmondi worth around Tk 300 crore.

Upholding an HC verdict which ruled that the government is the owner of the property, the court said it found forgery in documents submitted in support of the

The property is located at House-29 of Road-2 in Dhanmondi.

A three-member bench of the Appellate Division headed by Chief Justice Hasan Foez Siddique delivered the order after hearing four petitions filed by Nehal Ahmed, a claimant of the property, and the government.

"It is being found from the documents that different signatures of the same person have been put in the papers prepared and submitted in one day to the court in connection with this case," the CJ told the lawyers for Nehal Ahmed during the hearing.

"The documents over the date of birth are also seen tampered. There is no signature and seal of the court of settlement in the relevant papers of the case. Why did such forgery take place? There must be a syndicate behind this," he added.

The apex court also affirmed the HC order that fined Tk 10,000 to journalist Abed Khan for claiming

Dhaka facing over 600 MW of load shedding during daytime

Dhaka alone been experiencing more than 600 MW of load shedding during daytime.

According to official sources, like the previous few days, the country has been seeing over 2,000 MW of power shortage. As a result, consumers across the country are facing power outages for 6 to 7 hours at different times of the day.

"After evening, the situation will be deteriorating with the increase in demand," said a top official of the Bangladesh Power Development Board (BPDB). He pointed at gas shortage for the reason behind the lack in power supply.

"We have been getting a lower supply of gas that forced us to keep at least 25 generation units across the country shut," he said. BPDB receives a normal supply of gas. It can produce 6,500 MW of electricity from its gas-fired plants. "We're now producing 4,667 MW because of gas

shortage," he noted. Meanwhile, Managing Director of Dhaka Electric Supply Company (Desco), Md Kausar Ameer Ali, said the area under them was experiencing 308 MW of load shedding during daytime. "Desco is receiving about 800

MW against a demand of 1,111 MW," he said. Desco is entrusted with the distribution of electricity in Dhaka's north, north-west and eastern parts, while Dhaka Power Distribution Company (DPDC) is responsible for power supply in the south, south-east and central parts.

DPDC Managing Director Bikash Dewan said areas under DPDC has been experiencing a shortage of about 340 MW which might be up after the evening. DPDC has a demand of more than 1,600 MW and receiving 1,250 MW.

Meanwhile, State Minister for Power, Energy and Mineral Resources, Nasrul Hamid yesterday said that it will take two days to improve the power and gas supply situation in the country.

He also highlighted importance of wide roads and open spaces where people could seek shelter during the earthquake.

to earthquake, so even minor flaws during construction can result in a disaster."

Regarding unplanned development and infrastructure construction, the minister held everyone accountable and called for stronger roles from institutions responsible overseeing for structures to ensure compliance

with the National Building Code. He criticised companies that

Polls code violations rampant in Sylhet

Mayoral candidates defy EC warning, campaign ahead of time

The Sylhet City Corporation election is scheduled for June 21, and despite warnings from the Election Commission, mayoral candidates have been continuously violating electoral rules by running campaigns in the city ahead of schedule.

The City Corporation (Election Code of Conduct) Rules 2016 state that candidates or their supporters can organise street rallies and indoor meetings only after informing the local law enforcement authorities 24 hours in advance.

Additionally, no candidate can start campaigning using any electoral symbol before the official allotment, which is scheduled for June 2 in this case.

But the supporters of the ruling Awami League nominated candidate Anwaruzzaman Chowdhury, have been organising multiple meetings and campaigns daily, using the party's electoral symbol, boat', which is a clear violation of the electoral rules.

Candidates from other parties, such as Nazrul Islam Babul of Jatiya Party (JP) and Mahmudul Hasan of Islami Andolon Bangladesh (IAB), have also been found violating the rules in a similar manner.

They have been distributing leaflets in different parts of the city, featuring their respective electoral symbols - "plough" and "hand fan".

Besides, the present mayor, Ariful Haque Choudhury, who has not yet declared his candidacy, has been appearing in meetings throughout the city, indirectly discussing the upcoming election. This is seen as an attempt to seek votes, which is also against the electoral code of conduct.

Returning Officer Faysal Kader issued letters to all mayoral aspirants warning them about the consequences of violating the polls code. The letter emphasised that the EC would

Suspended Gazipur mayor Zahangir Alam, seemingly undeterred by his permanent expulsion from the Awami League, expressed his determination to continue his political journey alongside his mother, Zaida Khatun, who is vying for the mayoral position in the Gazipur City polls.

When asked about the possibility of withdrawing from the race if requested by AL leaders, Zahangir affirmed, "My mother and I will be in the electoral race till the end. I have to stand by her."

The former mayor has been expelled permanently from AL, said a press release of the party. The press release, signed by office

secretary of the party Biplab Barua vesterday, states that the expulsion order will come into effect immediately

Despite learning about his expulsion through the media, Zahangir disclosed that he had not yet been contacted by anyone from AL regarding the decision.

Zahangir, who was previously expelled from AL for violating party discipline, received a pardon in January on the condition that any future breaches of organisational rules would be considered unforgivable. Four months later, Zahangir decided to run for the upcoming GCC polls after AL nominated Azamat Ullah Khan, the Gazipur city

Engage private sector to combat 'modern slavery' Speakers tell conference

Speakers at a conference yesterday said the country's private sector, especially small and medium enterprises, need to be engaged in fighting and creating awareness against "modern slavery" and human trafficking.

They said despite having the scope, the country's private sector has not been engaged in this fight effectively. USAID's Fight Slavery and Traffickingin-Persons (FSTIP) Activity, implemented by Winrock International, organised the conference on "Private Sector Engagement in Counter Trafficking Initiatives" at the capital's Brac Centre Inn.

According to the UN, although modern slavery is not defined in law, it is used as an umbrella term for covering practices such as forced labour, debt bondage, forced marriage, and human trafficking.

Key presenter at the conference, Matthew Scott Friedman, chief executive officer of Hong Kong-based Mekong Club and an internationally renowned expert on the issue, said according to the "Global Slavery Index-2018", over 40 million people are victims of modern slavery, 55 percent of whom are in Asia.

"SMEs need to know what is happening with the people they are buying materials from or people within the supply chain," he said.

Nazrul Islam, deputy chief of party of FSTIP, said in different countries NGOs and civil society organisations are joining hands with governments to combat human trafficking.

However, the private sector which has the capacity and scope to play a big part in the fight has not been engaged effectively so far, he said.

Mirza Nurul Ghani Shovon, president of Central Board of Directors, National Association of Small and Cottage Industries in Bangladesh, echoed the same. The conference was presided over by Susan Stamper, chief of party at USAID's FSTIP Activity.



80 days of 'sick leave' and CID's clean chit

Accused of custodial torture, 2 Ctg police officials re-join force as final report finds them innocent

After 80 days of "sick leave", two Chattogram police officers, who were accused of torturing a person in custody, returned to work yesterday as the Criminal Investigation Department did not find proof of their involvement in the alleged incident.

The officials are officer-in-charge Nazim Uddin and sub-inspector Abdul Aziz of Panchlaish Police Station.

On January 10, OC Nazim arrested one Syed Mohammad Mustakim during a at Chattogram Medical College Hospital. Police filed a case with the station, accusing Mustakim of assaulting law enforcers.

Later, Mustakim received bail from following that. a Chattogram court and on February 21, filed a complaint with a court, said there have been some "mistakes'



MOULVIBAZAR POWER SUB-STATION Construction work goes on at snail's pace

Construction work of Moulvibazar 132/33 KV Grid Substation sees very slow progress, much to the inconvenience of the consumers.

Meanwhile, the earth filling work of the project has not been completed since the project started three years ago. Construction of other infrastructures

like control room and installation

of transformers will be done after completion of the earth filling work. According to the sources at the project site, the government decided to construct Moulvibazar 132/33 KV Grid Substation to provide uninterrupted power supply to Moulvibazar town and

Srihatta Economic Zone and reduce load shedding. In 2019, a total of over 5 acres of land was acquired at Raishree village in Sadar upazila for construction of the power substation, under the supervision of the ministry of power, energy and mineral

Jointly funded by the governments of Bangladesh and China, the project

completed by June 2025.

Local people said although the earth filling work of project started in 2021, only half of the work has been done so

According to Moulvibazar Electricity Development Board, there are about 30,000 electricity consumers in Moulvibazar town and its suburb areas while the demand of electricity is 14 MW.

Imran recalls Bangladesh liberation to slam Pak army

Former Pakistan prime minister and PTI chief Imran Khan while addressing the nation on Saturday night said people should understand atrocities committed in East Pakistan (now Bangladesh).

Thai Senate could hold the key

Thailand's Move Forward party announced yesterday that it had sufficient votes to form a coalition government but a militaryappointed Senate, the party's position on a royal insult law and a complaint against its leader may stand in the way.

Pita Limjareonrat, 42, led the Move Forward party to a stunning victory in Sunday's general election, winning the highest number of seats, ahead of another opposition party, the political heavyweight Pheu Thai.

The victory of the two opposition parties may pave the way to ending nearly 10 years of military-backed governments led by a former army chief, Prime Minister Prayuth Chan-ocha, whose newly formed party won a small fraction of the seats that the opposition parties did.

prime minister," Pita declared, explaining that his party and its five prospective coalition partners, including Pheu Thai, would secure 309 seats in the 500-seat lower house of parliament.

However, to be indisputably in a position to become prime minister he needs to be able to command a majority in a joint sitting of the bicameral legislature, which includes 250 members of a militaryappointed Senate.

So he needs 376 members of a joint session to vote for him.

Reuters spoke to six senators to try to gauge the mood of the upper house. Some of them suggested they would not necessarily vote with the majority in parliament, even though that reflected the will of the people as expressed on Sunday.

Senator Somchai Sawangkarn said

"I am ready to become Thailand's 30th his vote for who becomes prime minister would based on his criteria and a lowerhouse majority alone was not sufficient.

"The person must be honest and not cause problems in the country," Somchai "Hitler was elected in a majority but

A polarising issue for Move Forward is its position on amending a strict royal insult law, which sets out a sentence of up to 15 years for defaming the monarchy.

Critics says conservative governments have used the law to stifle dissent but conservatives are fiercely opposed to any suggestion of amending it.

Time to rebuild life in St Martin

With the worst averted, relief, rehabilitation are priority in Mocha-hit areas

We are relieved that the extremely severe cyclonic storm Mocha did not cause as much damage in Bangladesh as initially feared. The hardest hit regions in the country were Cox's Bazar and Saint Martin's Island, where around 13,500 houses were affected. Among them, around 1,200 houses were destroyed on St Martin's Island, and more than 2,800 shanties were affected in the Rohingya refugee camps of Cox's Bazar.

Apart from a change in the direction of the storm – away from Bangladesh and toward Myanmar - a low tide at the time of landfall further helped in minimising damage in Bangladesh. Early evacuation of more than a million people also played a big part. Nevertheless, thousands of people have been left homeless, leaving them open to huge suffering. This makes it vital that urgent assistance is provided by the government, which should coordinate with humanitarian organisations to ensure that aid reaches victims on time and in an organised manner.

Aside from financial assistance, the government and others should provide medical and food assistance as well. It is important to remember that the chance of diseases breaking out post-disaster is always high. Therefore, there should be no delay in providing medical assistance in the affected coastal areas. Removing the remnants of uprooted trees and damaged houses is also a challenging task. Rebuilding efforts are particularly needed on Saint Martin's Island, which took a massive battering even though there was no reported loss of life.

Although it is early to estimate the full extent of the damage caused by Mocha, there is no doubt that it has caused significant harm to local industries and businesses. Movement of goods at the Chattogram Port has had to be halted since Friday, which is going to be costly for the economy, particularly for many of our exporters. So, the government should take special measures to ensure that operational activities at our main seaport resume without further hindrance.

Ultimately, the nation was spared from much greater damage due to good fortunate. At the same time, our strong disaster preparedness also played a part in that. Since we cannot bet on luck to save us from future disasters, after helping people to recover from the fallouts of Cyclone Mocha, the government should continue to focus on its disaster preparedness, including by fortifying compromised embankments.

We must restore trust in e-commerce

Authorities should ensure full repayment to defrauded

customers

It is difficult to buy into the promise of a Smart Bangladesh when justice continues to elude many victims of e-commerce scams. Over the past few years, thousands of customers have lost money to such scams. As per a new report, as many as 19,623 complaints against 50 e-commerce companies – filed with the Directorate of National Consumer Rights Protection – remain unresolved, with Tk 600 crore yet to be paid to complainants. This points to a desperate need for safeguarding the interests of customers and strengthening the legal framework related to e-commerce platforms.

Many of the companies that have been accused of scams are practically defunct now. In the absence of adequate mechanisms to hold them accountable, the commerce ministry is paying victims from the Tk 525 crore (of 27 e-commerce companies) stuck in payment gateways. One would think that the priority would be recovering money from the companies themselves. But owners of fraudulent companies seem to be out of reach, some being unresponsive presently (such as the bosses at Evaly) and others having fled the country. How did we get to this point? Why haven't systems been put into place to protect e-commerce consumers? They certainly do not deserve the uncertainty that has been created. Against this backdrop, one hopes that the Central Complaint Management System (CCMS) launched by the ministry on February 19 will be helpful in addressing some of the concerns.

As e-commerce thrives around the globe, we sincerely hope that Bangladesh will be able to keep up by establishing a foolproof digital infrastructure and ensuring best service for customers. The scams carried out in recent years must not result in citizens losing faith in the sector altogether. We urge the relevant authorities to prioritise the formulation and implementation of proper laws and regulations that protect consumers' best interests. More importantly, those companies accused of scams must face justice for public trust to be fully restored. They must be made to clear the dues owed to complainants, so that no other companies dare to commit fraud in the future.

Therefore, policymakers must focus on creating sufficient fiscal space by implementing strategies for domestic resource mobilisation. Understandably, reduction of taxes on essential items will subsequently lower import taxes. To compensate for the potential revenue loss, higher taxes on luxury goods can be imposed. The government is already imposing higher taxes on many luxury items. However, while this may serve as an immediate solution to generate additional revenue and meet the increased financial requirements, the ultimate objective should be to enhance revenue through the collection of income tax. Reforming the existing revenue collection system is the pre-condition for achieving this objective. The government should prioritise the establishment of an independent and fully automated tax Consequently, the annual budget is system, supported by adequate and efficient human resources.

Fourth, the government should exercise caution while attempting to reduce expenditure, ensuring that it focus on long-term goals. The budget does not result in a drastic decline in should be formulated keeping these government spending, a contraction

When this spin of the political merry-go-round pauses, one image will linger: a young man, veiled by his blue surgical mask, clinging to a bewildered peacock.

The peacock had been looted from the Lahore corps commander's house in the wake of Imran Khan's arrest, an ill-thought-out gesture to reclaim what rightfully belonged to the people. One wonders what became of that peacock, and one fears for its welfare. Its fate is an apt metaphor for the prospect of a mass political mobilisation in Pakistan.

The unprecedented events of recent days have again stirred the question: is a revolution coming? Social media is flooded with videos of angry young men pillaging the corps commander's house, smashing candelabras and burning furniture, disgusted to find frozen strawberries in an elite kitchen in the same country where food inflation is running well over 40 percent and most people are struggling to eat two square meals a day.

That unthinkable moment when people pushed through the gates of GHQ has raised tantalising prospects

that the status quo might yet be challenged.

Indeed, there are several revolutionary ingredients in the mix: soaring inflation, polarised politics, a weaponised society with nothing to lose, and a new ability to smash the sacred cows of previously untouchable elite institutions. But despite the unrest and white smoke plumes of tear gas, a mass reckoning remains unlikely.

This is because public agitation continues to be reactionary and aimed at destroying, rather than visionary and aimed at creating (a new paradigm, a new society, a new status quo). If there is a mass movement brewing, it's all "anti" and not enough "pro." And history has taught us that

you can't build anything from hate. lack of The issue-based mobilisation - even at this critical time - is a reflection of Pakistan's paucity of issue-based politics. In an authoritarian state that has been under military rule for much of its history, politics has always been a game of survival, rather than a public service. The resulting distortions in the country's political discourse are all aimed at weakening opponents and appeasing puppet masters.

These distortions are now reflected in Pakistan's mass mobilisations: there is rage and rejection, but little in the way of grassroots activism. We know what we don't want, but we have never dared to ask for what we could have.

Many of the key ingredients of a successful revolution remain missing: credible leadership (beyond a cult personality), a free media that can support and disseminate a movement's messaging, and a population that understands the need for structural change and is ready to participate based on perceived benefits.

Pakistan's young, urban population should fulfil this last criteria, but the prevalence of misinformation, conspiracy theories, and the shambles that is our public education sector has limited the critical requirement for understanding.

Ironically, the closest we have come to mass reform movements in recent vears is in the form of the TTP or other similar religio-political movements. These comprised a rejection of the status quo and offered an alternative vision as articulated in concrete demands (for example, regarding the

imposition of Shariah law). It is not surprising that the TTP despite killing tens of thousands of Pakistanis – enjoyed some traction (albeit ambivalent) with the public for over a decade. That itself is a testament to Pakistanis' hunger for issue-based politics.

There have, of course, also been recent attempts at mass movements

without a violent extremist bent Think of the PTM or the Haq Do Tehreek in Gwadar, which offered progressive politics and a specific people-oriented agenda.

Unfortunately, beneficiaries in Pakistan know a meaningful mass movement threat when they see one; they managed to nullify these groups' leadership through extended jail terms and contain them with media blackouts.

The comparison between the imprisonment tenures of Imran Khan and Ali Wazir offers a clue as to which movement has more potential to actually effect change.

In the West, there is a growing recognition that mass mobilisations that challenge the status quo will only occur - and succeed - if they can offer a political alternative that is rooted in specific pro-people demands. Climate change activists, for example, are increasingly seeking to align with labour movements or minority rights' movements in order to embed abstract net-zero demands into a progressive vision that privileges equality, human rights, and security.

The number of issues around which Pakistanis should be coalescing is staggering: food security, safety, dignity of work, free speech, minority rights, welfare protections, healthcare provisions, climate resilience. Until we can craft a politics that champions for the people rather than against their overlords, our future will be riot, not

Why the US dollar is an optimal reserve currency for Bangladesh

Bangladesh received an infamous rupee or the renminbi in exchange and inappropriate coverage in the global press that the country was planning to use Indian rupee or Chinese renminbi for international payment settlements. In other words, the argument was that the Bangladesh Bank, the country's central bank, would be diversifying its foreign exchange reserves away from the US dollar to include more renminbi and rupee instead. It is infamous and inappropriate because the country's forex reserves continue to consist mostly of the US

dollar-denominated assets. and India over the past decade, central bank had to sell more than particularly since July 1, 2021. Note that most of the country's bilateral trades with China and India are market continued nonetheless. The invoiced in US dollars, and so the resultant international payment obligations are settled in US dollars. The idea of settling accrued payment obligations using either the Indian rupee or the renminbi instead of the US dollar is without substance, because their payment settlement is predetermined. In addition, the prevailing forex market really doesn't have access to those alternative currencies at any reasonable costs.

Now, considering that exports from China or India to Bangladesh are invoiced by their national currencies instead of the dollar, one would expect that Bangladeshi importers would be required to settle their international payment obligations in the same currencies. Given that Bangladesh incurred bilateral trade deficits of \$23.5 billion against China and \$15 billion against India in FY2021-22, the Bangladesh Bank would be obliged to act as the marketmaker for a forex market in the renminbi or rupee. But such a forex market will be dysfunctional, because supply and demand for either of the two currencies are wildly unequal. So the forex market will never clear unless the central bank intervenes as a marketmaker and fills in the gap between demand and supply.

This market-making operation of the central bank will be uneconomical for two reasons. One, the Bangladesh Bank will have to significantly diversify its forex reserves into rupee-denominated or renminbi-denominated assets. The central bank will therefore be susceptible to significant exchange losses every time either of the of the global over-the-counter (OTC) forex transactions are denominated in the US dollars. As most of the country's international trade and financial transactions have been denominated in the US dollar, bilateral imbalance in the supply and demand for foreign exchange never caused market failure. Until recent times, the OTC market of foreign exchange always cleared without substantial interventions of the central bank. Bangladesh has experienced Over the last two financial years, the persistent and increasing bilateral private flows of foreign exchange trade imbalances against both China didn't clear the market, and so the \$20 billion dollars of its net forex reserves. Disequilibrium in the forex taka has depreciated by more than 30 percent against the US dollar over the last couple of years. As the US dollar is still trading with significant premium in the kerb market, the home currency has remained under devaluation pressure.

Central banks, institutions, corporations and currency speculators invoice their international trade and financial transactions in terms of the US dollar because it has been the norm in the international monetary order after World War II. Accordingly, the Bangladesh Bank has maintained a growing volume of forex reserves mostly in the US dollar since its independence in 1971. So the forex market in Bangladesh is characterised by demand for and supply of US dollars. This OTC market in foreign exchange is highly liquid and very efficient, meaning that bid-ask spread is less than 50 basis points for large-size payment settlements. The forex market is also globally integrated.

The proposition that Bangladesh will move away from the US dollarbased payment settlement to a new international payment settlement, which will involve either the rupee or the renminbi as the invoice currency, is of no economic substance. It will produce a number of unintended consequences. Firstly, It will cause inefficient fragmentation of the prevailing forex market, which is dollar-based and globally integrated. Secondly, the Bangladesh Bank will need to diversify its portfolio of forex reserves giving significantly larger weights to the rupee and renminbi. currencies depreciates against the That will complicate monetary dollar. It is because of the prohibitive exchange rate uncertainty of those currencies and the lack of instantaneous liquidity of financial assets denominated by those currencies. In fact, the market for government securities or AAArated corporate bonds, which are denominated by either the Indian rupee or Chinese renminbi, is mostly localised. Their weight in the global financial market is insignificant. A perilous implication is that corporations will incur prohibitive transaction costs (broadly defined) in settlement of their international payment obligations in this proposed scenario.

Consider this example, if the rupee depreciates by 10 percent against the US dollar over a period of six months, which is the typical credit period of an export, the Indian exporter would lose 10 percent value of his exports in terms of the US dollar because of a rupee-invoicing. The counterparties in Bangladesh, that is, the importers, will face a dysfunctional forex market in the rupee. As I explained previously those markets will be very illiquid and costly. So all parties to trade will incur larger costs and uncertainties. International trade and finance will surely decline in this case. A natural hedge of any company is to invoice their international trade or financial transactions in a few major currencies including the US dollar notably. A political decision to force international trade and payment settlement away from the US dollar to any non-major currencies will be disruptive, risky and costly.

Think of a scenario where a government-owned corporation in Dhaka will have a Chinese renminbi loan due for settlement on June 30, 2023. The OTC market for foreign exchange in renminbi will not work. because there is already a disequilibrium between demand for and supply of it. It shows that the Bangladesh Bank will be forced to convert their US dollar reserves into renminbi and supply the same to the local forex market in renminbi. Ultimately, the Bangladesh Bank is committing itself into a selfdefeating strategy that it will micromanage a forex market in an unimportant currency, incurring private costs and unforeseen exchange risks.

Finally, a fragmented forex market in some peripheral currencies will prove unforgiving for managing external debt of both public and private sectors of a developing country. As of June 30, 2022, more than 90 percent of public sector external debt, which is approximately \$75 billion, is dollardenominated. Almost 100 percent of private sector external debt, which is approximately \$25 billion, is also dollar-denominated. While the external indebtedness of the public sector is long-term and of low cost, that of the private sector is mostly short-term, variable-rated of forex reserves into peripheral risks and downgrade the global rating of the country. It's time we talked about menopause

When I was in my 20s, my mother was going through a physical and mental transition that her family took lightly, unknowingly. In fact, my father was lost as to how to suddenly deal with a depressed wife. She was an emotional bomb about to burst for no reason; those mood swings were the worst besides her lack of sleep and hot flashes.

The family was not supportive of her newfound indifference towards her everyday normal routine, and could not take the cue as a sign of some sort of health crisis. Later, we realised she was going through menopause. She faced a bad spell

hormonal changes throughout her life. These are all part of natural reproductive health. However, these stages have their nuances that need to be sorted.

In my mother's time, a woman's health – and that, too, her menstrual health - was not something to speak about even within her family boundaries. "Periods are normal and hormonal changes are natural, so deal with it" this was our attitude towards her monthly cycles.

Even women did not know how to address these changes in them until recently, when they can freely talk about taboo health topics. Thus, our mothers aged quickly and were sad most of the time, while we modern women try to learn and make adjustments as our body demands.

I made sure my husband is aware of my severe, monthly premenstrual

and a while later you are in socks and layers of clothing. You feel hot and then cold in the middle of the night, a very common phenomenon in women. The constant brain fog because of lack of sleep affects your daily productivity.

Facing difficulty in sleeping, emotional changes, irritability, mood swings or mild depression are normal for menopausal women, along with racing hearts, headaches, joint and muscle aches and pains, weight gain, hair loss or thinning, and sagging of skin. These experiences are all part of your body adjusting to ageing, and this can last for five to ten years.

Women need not suffer for these and they must learn to seek medical help. It's also the people around them who need to be empathetic to their mental and physical changes and well-being.

You need to learn how to regulate



of hormonal changes, which might not be the case for others as the symptoms vary.

The physiological age for menopause is between 45 and 55 years; many women go through surgical menopause caused by hysterectomy for other health With menopause reasons. comes various bodily irritability, because the production of the female hormone oestrogen and progesterone, at the time, decreases. It is the big drop in oestrogen levels that causes most of the symptoms of menopause.

A woman, from her puberty or menarche to pregnancy and lactation period to perimenopause, menopause, and finally postmenopause stages, lives with and adapts to different levels of

syndrome (PMS). Now, when I am going through menopause, he is more patient towards my transition. I cannot help my depressive spells or mood swings and hot flashes, but I am definitely aware of my triggers and the reason why it is happening.

I am better equipped to handle the stress. I meditate, take long hot showers, do some brisk walking or gardening to release the pressure of coping with menopausal hormonal changes. I believe setting some time for myself and doing the things want helps me adjust to such changes mentally.

The reason I am pointing this out is because, until recently, we as a society were not mindful of a woman's hormonal fluctuations that she deals with daily. You feel hot at one point of the night and have the air conditioner at full blast,

your diet and the foods that trigger certain reactions. The sudden onset of multi-joint pain will force you to start exercising regularly. The adjustments you need to make are mostly about food and exercise, listening to your body, and trying to learn as much as possible about this stage of your life.

The initial physical changes will be scary, but a supportive husband/partner can be extremely helpful in learning to deal with bad tempers, mood swings, and other elements of this natural transition.

It is only right to address these symptoms of hormonal changes with tender loving care. It is vital to talk about and listen to her; she needs support and to feel loved and taken care of through this phase of life.



'Very real possibility' of Pakistan boycotting WC

There is a "very real possibility" that Pakistan will boycott this year's World Cup in India if they lose hosting rights to the Asia Cup, the chairman of the country's cricket board Najam Sethi told Reuters.

India, citing safety concerns, have ruled out travelling to Pakistan for the Asia Cup in September and the Pakistan Cricket Board (PCB) has offered to let them play their matches in the UAE in what has been dubbed a "hybrid model".

While the BCCI has yet to deliver a formal response to the offer, Sethi said India wanted the entire tournament moved out of Pakistan. That could have serious ramifications for the 50-overs World Cup in India this year as well as the 2025 Champions Trophy in Pakistan,

"India should not be looking at a situation where we end up boycotting the Asia Cup and also the World Cup, and then India ends up boycotting the Champions Trophy. That will be a huge mess," he said in a zoom interview.

Sri Lanka and Bangladesh have also come out against playing in the UAE, heightening speculation that the ACC may look to move the entire tournament out of Pakistan.

Sethi said that was "not acceptable" and reaffirmed that Pakistan may boycott the World Cup if that happened.

"That's a very real possibility, of course," he added.

The International Cricket Council has announced changes to its playing conditions after the Chief Executives' Committee ratified recommendations from the Men's Cricket Committee, with the changes slated to come into effect on 1 June 2023 with the Lord's Test between England and Ireland.

SOFT SIGNAL: Umpires will no longer be required to give a soft signal while referring decisions to the TV umpires.

HELMETS: Helmet protection will be mandatory in international cricket for the following high injury risk positions: (i) when batters are facing fast bowlers, (ii) when wicketkeepers are standing up to the stumps, and (iii) when fielders are close to the batter in front of the wicket.

RUNS OFF A FREE HIT: Any runs scored off a Free Hit when the ball hits the stumps will count as runs scored.

HC directs ACC to probe allegations against BFF officials

The High Court yesterday directed the Anti-Corruption Commission (ACC) to conduct an inquiry in to the corruption allegations raised against the officials concerned of Bangladesh Football Federation (BFF) and to submit the probe report in four months.

The court also issued a rule asking the respondents to explain why their inaction to conduct the inquiry into these allegations should not be declared illegal.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Khizir Hayat Lizu issued the order and rule following a writ petition filed seeking its directive on the

Syed Sayedul Haque Suman, a Supreme Court lawyer, submitted the petition as public interest litigation to the HC on Sunday requesting it to order the ACC to probe the allegation against BFF officials including its president Kazi Salahuddin, senior vicepresident and finance committee chairman Abdus Salam Murshedy and former general secretary Abu Nayeem Shohag of committing "corruption", "money laundering", "forgery" and "embezzlement of money".

Secretary at the Ministry of Youth and Sports; Bangladesh Bank governor; ACC chairman: head of Bangladesh Financial Intelligence Unit (BFIU); National Board of Revenue chairman; Salahuddin; Murshedy and Shohag have been made respondents to the required rule.

But obviously its challenging and wait patiently rather not become disappointed if things doesn't go well at the start and focus on the process. So patience is very important after recovering from the

DS: What are the aspects you work with your personal mind trainer?

TA: Well we all have different mindset and emotions as a person and the topic of work is very confidential with the mind trainer. Basically it's a confidential thing it will eventually help our team. In world but yes this is very helpful aspect of a cricket if you notice most the tail enders

DS: Apart from your bowling skills the young pacers in the team are also following your footsteps to improve their batting skills.

TA: Well the main skill of the bowlers is bowling but if we can improve our batting sportsman and maybe it is not as regular are now contributing and we have been

talking about this among the bowling group. There is no hard if we can work on our batting a little bit and we get the help from our batting coaches and players. So this is the main aim to contribute if there is any early collapse and support the set batsman at the crease. I am trying that and but still I have a lot to learn and I think keeping the modern day cricket in mind it is important for the bowling unit to also be able to bat.

DS: Since the ODI World Cup scheduled later this year do you have any personal target for the flagship event?

TA: I am not going to share about my world cup plan at the moment but I will tell once it's the right time. But the main target is to play the final of the World Cup if the almighty keeps us healthy.

DS: Since you are now one of the experienced bowler in the Tigers side what are your expectation from the pace bowling unit in India for the World Cup? **TA:** I have played a T20 World Cup and a Test match in India. India has always got sporting wickets however there are few grounds which is batting friendly so its going to be challenging for the pacers. But at the same time the bowling unit we have if we can execute properly we will be able to give a tough fight against any team. We are improving and we still have four-five months before the world cup so we will try to take our skill levels one step further and I have big hopes to do something extraordinary in the World Cup.

Can Pioli conjure '11 lions'?

AC Milan will come into the second leg of their Champions League semifinal against Inter Milan tonight nursing the bruises from a 2-0 loss in the first leg, the woes of which were only worsened after an embarrassing defeat at lowly Spezia on Saturday which ended with team and coach Stefano Pioli gathering in front of the away crowd and having an animated discussion.

Pioli and his players had their heads bowed in remorse while Milan's hardcore ultras bellowed encouragement in the hope that their words might add something which was missing in the first leg. The Milan squad then headed to the dressing room as the Curva Sud chanted "we want 11 lions" in their native Italian.

While this season's progress in Europe has been better than their previous 15 campaigns, Milan's are at risk of missing out on Champions League football next season due to their slide in Serie A. There are real fears that there could be a repeat of the 3-0 Supercoppa final loss against Inter.

Pioli remained optimistic, especially after the news that Rafael Leao would be fit



to the return to the side. Leao assisted both of Milan's goals in the two ties against Napoli in the quarterfinal to secure a 2-1 win on aggregate and without him last week the seven-time European champions were painfully short of cutting edge.

"We're playing a match which could

make history for us, we need to believe that we can beat Inter," said Pioli on Saturday. "We haven't been good enough in our last two matches, but we can play much better."

However, Inter remain better-placed to become the first Italian finalist since Juventus faced Real Madrid six years ago, with the Nerazzuri having won seven in a

Simone Inzaghi would not allow room for complacency, underlining the significance of the second leg by saying it would be 'one of the most important matches' in the club's history.

"As a coach I treat every game in the same way. Tomorrow we know it's one of the most important matches in Inter's history. Tomorrow we know we have a well-deserved advantage, but we won't just have to manage it, we'll have to play the Inter way, knowing that we have a strong team up

"Tomorrow I have no doubts, the supporters have always been with us in the bad times and the good."

"We know who we're going to face, but we also know that we're in an excellent run of form. We're ready for a match of this magnitude."

Turkey faces election runoff

Erdogan leads the first round of voting, seen with momentum ahead of the second round


Turkish President Recep Tayyip Erdogan yesterday emerged from his toughest election test unbowed and in a strong position to extend two decades of his Islamic-rooted rule by another five years in a historic May 28 runoff.

Turkish assets weakened on the news, which showed Erdogan just below the 50 percent threshold needed to avoid sending the Nato-member country to a second round of a presidential election viewed as passing judgment on his autocratic rule.

Erdogan's People's Alliance, comprising his Islamistrooted AK Party and its nationalist partners, also appeared set to win a majority in the new parliament with 321 of the 600 seats, further boosting his chances in the presidential runoff.

"The winner has undoubtedly been our country," Erdogan said in a speech to cheering supporters at the AKP headquarters in the capital Ankara overnight.

With 99 percent of ballot boxes counted in the presidential vote, Erdogan led with 49.4 percent and his main opposition rival Kemal Kilicdaroglu had 44.96

reporters. Turnout was 88.8 percent.

Further boosting Erdogan's hopes, nationalist candidate Sinan Ogan, who placed third in Sunday's election, yesterday told Reuters in an interview that he would only endorse Kilicdaroglu in the runoff if the latter ruled out any concessions to a pro-Kurdish party, parliament's third largest.

That party backs Kilicdaroglu but is accused of ties to Kurdish militants, which it denies.

The 2.8 million voters who backed Ogan in the first round will be crucial for Kilicdaroglu if he is to defeat

Opinion polls had shown Erdogan trailing Kilicdaroglu, but the outcome suggested that the president and his AK Party were able to rally conservative voters despite a costof-living crisis and soaring inflation.

Kilicdaroglu, head of a six-party alliance, vowed to prevail in the runoff and accused Erdogan's party of interfering with the counting and reporting of results. He called on his supporters to be patient.

The prospect of five more years of Erdogan's rule will upset civil rights activists campaigning for reforms to undo the damage they say he has done to Turkey's

The election has been closely watched in Europe, Washington, Moscow, and across the region, where Erdogan has asserted Turkish power while strengthening ties to Russia and putting strain on Ankara's traditional alliance with the United States.

The opposition had expected to benefit from voter anger at economic woes after an unorthodox policy of low interest rates triggered a lira crisis and soaring inflation. A slow government response to earthquakes that killed 50,000 people in February had also been expected to influence voters.

Cyclone Mocha ravages around 12,000 houses Shahporir Dwip faces drinking water crisis

Around 12,000 homes have been damaged by Cyclone Mocha in Saint Martin's Island and Cox's Bazar, Enamur Rahman, state minister for disaster management and relief, said yesterday.

Of these, some 2,000 were completely damaged and the rest partially damaged.

"Some people were injured by falling trees and were given treatment at local hospitals," he told journalists at the secretariat.

"We were able to bring all people from risky areas to the shelter centers. That's why there are no reported deaths."

The authorities concerned have been instructed to distribute tin sheets and cash assistance for rehabilitation of those affected by the storm, Enamur said.

"A list of the cyclone victims is being prepared. They will be given assistance according to their needs.

Meanwhile, around 100 people are living out in the open in Shahporir Dwip, after Cyclone Mocha decimated their
