Quick-witted decision saves girl from child marriage Father jailed for 10 days

A quick-witted decision has saved a seventh grader in Thakurgaon municipality from child marriage.

The girl was about to be married to a twenty-year-old of Thakurgaon Sadar Upazila Sunday night, but her resolve and the help from a classmate's family prevented the illegal nuptial.

Finding no other options, the 15-year-old student of a local girls' high school on Sunday morning told one of her classmates about the marriage which she didn't agree to for the sake of continuing her education.

classmate immediately informed her mother Nazma Begum, a district unit member of Bangladesh Mahila Parishad, who later shared the information with Sucharita Dev, another member of the organisation.

Later that day, both activists went to the office of Thakurgaon's Deputy Commissioner Md Mahbubur Rahman and informed him about the girl's situation. The DC promptly

directed the Upazila Nirbahi Officer Abu Taher Mohammad Samsuzzaman to take necessary steps in this regard.

The UNO along with the activists of Bangladesh Mohila Parishad and members of the police went to the girl's house at 11:45 last night and stopped the child marriage.

As the underage bride's father was found guilty, the mobile court led by the UNO, who is also an executive magistrate, sentenced him to ten-day non-rigorous imprisonment.

The court also handed the girl to Bangladesh Mahila Parishad's custody for her safety.

Suchorita Dev said Bangladesh Mohila Parishad will take the next course of action as per the direction of the central committee of the organisation.

In Bangladesh, at least 11,000 school children were married off by their families between March 17, 2020, and September 12, 2021, according to data The Daily Star gathered from different districts.

This means all these children are victims of what is now a crime as per the Child Marriage Restraint Act 2017, which stipulates that girls must marriage and boys 21.

Meta hit with record 1.2b euro fine

Facebook owner Meta has been fined a record 1.2 billion euros (\$1.3 billion) for transferring EU user data to the United States in breach of a previous court ruling, Ireland's regulator announced yesterday.

The Irish Data Protection Commission (DPC), which acts on behalf of the European Union, said the European Data Protection Board (EDPB) had ordered it to collect "an administrative fine in the amount of 1.2 billion euros".

The DPC has been investigating Meta Ireland's transfer of personal data from the EU to the United States since 2020.

It found that Meta, which has its European headquarters in Dublin, failed to "address the risks to the fundamental rights and freedoms of data subjects" that were identified in a previous ruling by the Court of Justice of the European Union

The CJEU interprets EU law to make sure it is applied in the same way in all member

In response, Meta said it was "disappointed to have been singled out" sets a dangerous precedent for the countless other companies".

"We intend to appeal both the decision's substance and its orders including the fine, and will seek a stay through the courts to pause the implementation deadlines," Meta president of global affairs Nick Clegg and chief legal officer Jennifer Newstead said in

"There is no immediate disruption to Facebook in Europe," they added.

EU regulators have already hit Meta with fines of hundreds of millions of euros over data breaches by its Instagram, WhatsApp and Facebook services.

It is the third fine imposed on social media giant so far this year in the EU and the fourth in six months.

In January, the DPC fined Meta 390 million euros for breaking data rules in its use of targeted advertising on its apps.

In March, Meta was made to pay 5.5 million euros for breaching the GDPR with its WhatsApp messaging service.

In 2021, online trader Amazon was fined 746 million euros in Luxembourg for infringing the EU's General Data Protection Regulation (GDPR).

Following the previous fines, Meta said it was committed to changing its terms of and the ruling was "flawed, unjustified use in Europe so that it can continue to collect and process the personal data of its European users.

ROHINGYA REFUGEES WFP to cut their rations once again

The United Nations food agency yesterday said lack of funding has forced it to cut food aid for around one million Rohingya refugees living in camps in Bangladesh for the second time in three months.

Rations would be cut from \$10 per person per month to \$8 from June 1, World Food Programme (WFP) spokesperson Kun Li told AFP in an

The full ration of \$12 had already been cut in March. "The reasons for the ration cuts are lack of funding. We need urgently \$56 million to restore the full ration (\$12)," Kun Li

Aid groups said the cut in March caused hardship in the overcrowded camps, where malnutrition was already rampant.

Khin Maung, who heads the Rohingya Youth Association inside the camps, told AFP the new food cut decision came as a surprise to the refugees and that it would lead to hunger.

BGB protests BSF's killing of Bangladeshi stone quarry worker

Border Guard Bangladesh (BGB) yesterday protested the killing of a Bangladeshi worker allegedly by the Indian Border Security Force (BSF) in Panchagarh's Tetulia upazila.

The protest was made at a battalion commander-level flag meeting held between BGB and BSF at the Zero Line on Bhutipukur border in Tentulia upazila in the afternoon.

Panchagarh BGB 18 Commanding Officer Lt Col Jobayed Hasan led the 12-member BGB team while Sunil Kumar, commander of BSF Battalion-195, represented the BSF side.

The meeting started around 1:00pm and lasted for half an hour.

However, BSF denied the allegation of shooting the stone quarry worker, Lt Col Jobayed Hasan told The Daily Star.

On Sunday, a BSF team reportedly shot dead a Bangladeshi stone quarry worker at Baguladangi village along the border in Tetulia upazila.

7th-grader hacked to death in Mirpur

A seventh-grader was hacked to death in the capital's Darussalam on Sunday night.

Siam, 14, a student of Kabi Nazrul High School in Mirpur, was attacked in the Basupara area of Lalkuthi around 8:30pm by unknown assailants. He was rushed to Shaheed Suhrawardy Medical

College, where on duty-doctors declared him dead. "My son went out to have snacks in the evening. Later, we were informed he was killed," Siam's mother Swapna Begum told The Daily Star.

She demanded that the killers be brought to justice, in the hope that it would deter such crimes

Contacted, Aminul Bashar, officer-in-charge of Darussalam Police Station, said the victim's mother filed a case over her son's murder.
"Police collected CCTV footage from the scene

of the crime and are trying to arrest the culprits.'

Lightning strikes kill 2 schoolboys

Two schoolboys were killed and two other children were injured in separate lightning strike incidents in Mymensingh's Gafargaon and Trishal upazila Sunday evening.

Md Asif, 15, son of Johir Uddin of village Talli, was a ninth-grader; and Md Junayed, 9, son of Abul Farazi of Coatpara village, was a third-grader. Raju Ahmed, officer-in-charge of Pagla Police

Station in Gafargaon, said Asif died on the spot after being struck by lightning when he along with other boys were playing football at a local field.

Junayed also died on the spot and two other children sustained critical injuries when they were struck by lightning while picking fallen mangoes during a nor'wester at Coatpara village, said Md Mainuddin, officer-in-charge of Trishal Police The injured children were admitted to

Mymensingh Medical College Hospital.

Backlog at PSC eating away precious years

Implementing the automation process in the preliminary exam is yielding a positive result as the results of the 44th BCS preliminary test were published 26 days after the test was held.

Also, the PSC has the plan to set up a printing press of its own to reduce the dependency on others for printing question papers.

"You ask them why they did so. No one is shooting people in the meetings. It may happen if you have enmity with someone," he said. There is no reason why the US

citizens will be targeted here, the minister said, adding that the Americans are not doing anything wrong and the law and order is much improved.

"Rather, there should be an alert that if you go to America, you should be careful about going to malls, schools and bars. That seems to be more relevant," Momen said.

Meanwhile, Information Hasan Broadcasting Minister Mahmud yesterday said the US alert was the result of the BNP's "evil politics", reports BSS. Replying to a question from a

journalist at his ministry, he said, "It

is very simple for the US embassy to

do this. The US has warned its citizens

after seeing the BNP vandalising vehicles and setting those on fire. "If the BNP and its alliance continue such arson, many [countries] would issue warnings," he said.
