

## SC stays HC verdict on sentencing hearing

The Supreme Court chamber judge yesterday stayed till July 10 a High Court verdict that directed the trial courts and tribunals across the country to hold separate hearings on sentencing before delivery or pronouncement of judgements in criminal cases.

Chamber judge of the Appellate Division of the SC Justice M Enayetur Rahim passed the stay order following a petition filed by the state challenging the HC directive.

Appearing for the state, Attorney General AM Amin Uddin told the apex court chamber judge that the Appellate Division needs to examine whether the HC can deliver such a verdict for holding separate hearing on sentencing in criminal cases and therefore, the HC verdict should be stayed.

Contacted, Attorney General AM Amin Uddin told The Daily Star that the state will move a leave to appeal before the Appellate Division challenging the HC verdict.

In the full text of a verdict in a murder case, the HC has said the trial courts must hold separate hearings on sentencing in criminal cases.

# 6 ‘hackers’ held in Dhaka, Gazipur

Rab on Sunday arrested six people on charges of hacking the server of CNS Bangladesh Limited, a software firm that provided technological support to Bangladesh Road Transport Authority (BRTA), and embezzling Tk 1.2 crore from their possession.

Shahriar Islam, a computer engineer, and his accomplices Azim Hossain, Shimul Bhuiyan, Rubel Mahmud, Faysal Ahmad and Anisur Rahman were arrested during raids at different places in Gazipur and the capital's Mirpur and Kafrul.

A CPU, mobile phones, SIM cards, pen drives, cheque books of various banks, and Tk 1.9 lakh in cash, alongside other equipment used in the fraudulence, were recovered from the possession of the arrestees, said Rab officials at a press conference held in the capital's Karwan Bazar yesterday.

"CNS has been collecting fees for ownership change of vehicles, fitness,

tax token, vehicle registration and other such government services through different online banking systems, which they later transferred to BRTA."

"The arrestees generated 389 money receipts using fake codes between April 12 and May 10 and embezzled Tk 1.2 crore by hacking into the payment gateway of the firm," said Khandaker Al Moin, legal and media wing director of Rab.

Thus, the payment status of the aforementioned transactions were shown as paid though no money was deposited into the firm's account, he added.

Shahriar admitted to the charges during primary investigation. He also admitted that he and his associates hacked into Desco's website last year and misappropriated Tk 1.5 crore through mobile banking.

Following the incident, Desco authorities had to further secure their website while the citizens had to repay their bills, Moin said.

Dhanmondi and six apartments in Uttara.

Besides, he also owns 10 tola gold received as gift, electronics of Tk 3.25 lakh, furniture worth Tk 2.54 lakh and 20 lakh in shares (of different organizations).

His wife also owns a car worth Tk 49 lakh, furniture of Tk 2.50 lakh, electronic goods of Tk 50 thousand and 20 tola gold received as a gift.

Meanwhile, Iqbal Hossain has Tk 2.35 crore in his own name in different banks. Apart from this, he has 60 tola gold. His wife also has Tk 10 lakh in different banks.

In the affidavit, Abul Khair Abdullah mentioned business as his occupation. He is also the managing director and a shareholder of Khulna Union Enterprise. He stated in the affidavit that there is no case filed against him. As educational qualifications, Abul Khair mentioned that he is self-educated. He did not mention any of his agricultural or non-agricultural land in the affidavit.

JP candidate Iqbal Hossain mentioned that his educational qualification

is BSc. He mentioned that there are 2 criminal cases pending against him in the High Court.

He also mentioned business as his profession. He has 2.27 acres of agricultural land and 0.0098 acre of non-agricultural land.

On the other hand, educational qualifications of IAB candidate Syed Md Foyzul Karim is Kamil Fiqah (equivalent to master's).

requests by Bangladesh Railway.

The neighbouring country had sent 10 "slightly used" locomotives in July 2020 as grant following a proposal from BR to "hire" or "get as courtesy" 20 railway engines.

According to a latest document from BR, the state-run transport agency has 171 metre gauge locomotives, of which 82 percent are old or "overaged".

Meanwhile, of its 92 broad-gauge locomotives, 55 percent are "overaged".

were associated with hysterectomy, and five with laparoscopy. Among them, 477 patients were operated on with 17 days of hospitalisation on average.

More than 94.5 percent of the surgeries were successful while around 5.3 percent of the patients failed to completely recover, according to the report.

Dr Md Azizul Alim, program manager (maternal health) at the health directorate told The Daily Star yesterday, "Ensuring at least four-time antenatal checkups for pregnant women to any qualified doctors or facility is urgent to avoid such health problems."

Preventing child marriage is also important since young girls are not physically mature for pregnancy, he added.

Prof Dr Rowshan Ara Begum, meanwhile, stressed training the surgeons to avoid errors during cesarean section or uterus surgery.

subscription fees ranging from Tk 1,000 to Tk 2,000.

A breakthrough in the case came when CID received a complaint filed by one of the victims under the Pornography and Digital Security Act.

CID officials revealed that the explicit content submitted to the groups often originated from the victims' former partners.

CID estimates that the groups and channels amassed 400,000 subscribers, containing approximately 20,000 videos and 30,000 photos. Around 750 individuals from both local and international locations are subscribers of their premium group.

Myanmar, Afghanistan, or elsewhere, is crucial for economic development and global peace and criticised these countries for harbouring collaborators.

Tawheed Reza Noor, genocide researcher and founding secretary of Projonmo 71, emphasised the importance of acknowledging historical injustices in all countries.

Retired Lt Col Sazzad Jahir, a Bir Protik Gallantry awardee, called for a formal international apology, compensation for victims' families, and the return of wealth taken from Bangladesh during the war.

Mofidul Haq, Liberation War Museum trustee, stressed the need for global

collaboration to intensify the demand for recognition.
