



Want to tie the knot again? pay tax first

DSCC plans to slap levy from next fiscal

Life for those who are planning to get married in the southern side of Dhaka city is about to get a little more difficult than it usually is. Though those who will marry for the first time can relax, the ones who will marry for the second or third or fourth time have got something to worry about.

Dhaka South City Corporation (DSCC) is planning to levy a tax on marriage, in a move to boost revenue collection. The tax will be imposed according to the Municipal Corporations (Taxation) Rules 1986.

The tax is likely to be introduced from the next financial year, said Ariful Haque, chief revenue officer of DSCC.

"This move will be implemented under the 1986 Act. Although the act empowers the city corporation to impose this tax, it could not be implemented due to various reasons. Now we are moving towards implementing it," he said.

Rule 50 of Municipal Corporations (Taxation) Rules 1986 says, "When it has been decided with the previous sanction of the Government that a tax on marriage be imposed, the City Corporation shall, at a meeting, determine the rate of tax not exceeding the amount specified in the Model Tax Schedules."

Man gets 10 years in jail in ICT case
He hurt religious sentiment thru' FB post

Rangpur Cyber Tribunal yesterday sentenced a man to 10 years in prison in a case filed under Section 57 of the ICT Act for hurting religious sentiment via a Facebook post back in 2017.

The convict Titu Roy, 45, of Rangpur Sadar upazila's Thakurpara village, was also fined Tk 50,000, in default of which, he will have to spend five additional months in jail.

Dr Abdul Mazid, the tribunal judge, delivered the judgement with Titu present in court in the afternoon.

Subsequently, the convict was sent to the Rangpur Central Jail, said the tribunal's Public Prosecutor (PP) Ruhul Amin Talukdar.

According to the prosecution, Titu uploaded

Saudi Arabia offers large investments

2 KSA ministers tell Hasina that they want Bangladesh turned into a regional hub

Saudi Arabia has offered to make a large investments in various sectors of Bangladesh, as the country has a stable government and tremendous record of economic growth.

Saudi Arabian Minister of Investment Khalid A Al Falih and Minister of Economy and Planning Faisal Alibrahim came up with the offer when they jointly called on Prime Minister Sheikh Hasina in Doha yesterday.

While briefing reporters, after the meeting, Foreign Minister AK Abdul Momen quoted the two ministers as saying, "We see few issues as investors. Firstly, the stability [of the country], businessmen see whether it is stable, the future of investment. Present and future of Bangladesh is very good, and that is why we've taken the decision to strengthen relations with Bangladesh."

"Bangladesh's leadership is very good, vision is good and their commitments are very good," they said, adding that the country has a stable government and good economic growth.

Saudi Arabia wants to establish Bangladesh as a regional hub considering its geographical location as the country is between South and South East Asia. If we make it a hub, we can



cover Indonesia, Malaysia, more..." they added. The two ministers said they want to do business of petrochemical, diesel, jet fuel, fertiliser and major distribution centres as well as shipping lines.

In reply, Hasina said that she has given permission and urged them to start immediately. She also offered Matarbari and Payra ports and economic zones to Saudi Arabia.

In this regard, she directed the authorities concerned to take necessary measures for removing obstacles to Saudi investment in Bangladesh.

Saudi Arabia also wants to develop a partnership with Bangladesh through cooperation in various sectors including agriculture.

In this regard, they assured the prime minister of providing necessary financial and technical assistance to Bangladesh.

While discussing the issues of Hajj, both the ministers requested Bangladesh for making investment to build housing and hospitals in Saudi Arabia.

The two ministers of Saudi Arabia requested the prime minister to establish pharmaceuticals, beverage and real estate industries in Saudi Arabia for the benefits of the people of the two countries.

Removal of Dhaka Wasa chairman worrying: TIB

Transparency International Bangladesh has said the authorities have set a worrying example of protecting the accused by removing the Dhaka Wasa chairman who raised allegations of arbitrariness against Managing Director Taqsem A Khan and irregularities and corruption in the agency.

The graft watchdog in a press release yesterday said such a move brought into question the government's announcement of "zero tolerance" against corruption.

It is also contradictory to the legal obligations about giving protection to whistle blowers, the statement added.

The TIB called upon the authorities to take into consideration the allegations, conduct a fair and clear investigation, and hold the accused accountable.

On Sunday, the local government ministry removed Gholam Mostofa as Dhaka Wasa chairman and made Sujit Kumar Bala, a member of the Wasa board of directors, the chairman.

The move came three days after Mostofa wrote to the secretary of the Local Government Division alleging that Taqsem turned the state-run agency into "a den of corruption."

Fossils reveal ancient beast's epic journey to oblivion

It was a dire moment for life on Earth. Runaway global warming triggered by calamitous volcanism in Siberia inflicted the worst mass extinction on record -- dooming perhaps 90 percent of species -- roughly 252 million years ago at the end of the Permian Period.

Unlike the asteroid 66 million years ago that ravaged the dinosaurs, this extinction event unfolded over a protracted time span, with species perishing one by one as conditions worsened. Scientists said on Monday fossils unearthed in South Africa provide a peek into this drama, telling the tale of an apex predator that over multiple generations migrated halfway around the world in a desperate, and ultimately failed, bid to survive.

This beast, a tiger-sized, sabre-toothed mammal forerunner called Inostrancevia, had been known only from fossils excavated in Russia's northwestern corner bordering the Arctic Sea until new remains were discovered at a farm in central South Africa.

Russia crushes border incursion

Blames Kyiv; Ukraine denies responsibility

Russia said yesterday it had routed fighters who crossed the border from Ukraine after two days of combat, in what appeared to be one of the biggest incursions of its kind of the 15-month-old war.

There was no immediate independent confirmation that the fighting had ended, although one of two groups claiming to be behind the raid said in a post on social media: "One day we will return to stay."

The two days of fighting had forced Russia to evacuate towns along the Ukrainian border. Russia has blamed Ukraine for the attack, which Kyiv denied. The two groups that claimed responsibility describe themselves as Russian armed dissidents.

The Russian military said it had killed more than 70 "Ukrainian nationalists" and destroyed four armoured vehicles. There was no independent confirmation of those losses.

Russian forces had surrounded the enemy fighters and defeated them with "air strikes, artillery fire and active action by border units", the defence ministry said.

SEIZING WEAPONS, DRUGS Joint drive to be carried out in Rohingya camps

Home minister says if necessary, army members may join it

A joint operation will be conducted at Rohingya camps to prevent criminal activities and recover weapons and narcotics, said Home Minister Asaduzzaman Khan yesterday.

If necessary, the army will be present during the drive, he said.

He made the comments after attending a meeting with the National Committee on Coordination, Management, and Law and Order of Forcefully Displaced Myanmar Citizens [Rohingyas] at the Secretariat.

To prevent any mischief inside the camp, the authorities will increase patrolling, check posts, and intelligence surveillance, he said.

"We will take measures so that no one of the ARSA or the Arakan Army can enter Rohingya camps. The army will be present during the drive if necessary," said the home boss.
