On May 28, 1999, Shakib Khan stepped into the Bangladeshi entertainment industry and since then, he never looked back. He started his journey 24 years ago with the film Ononto Bhalobasa and later on acted in 247 films. The 4-time National Film Award winning actor's last film, *Leader Amie Bangladesh* broke records, setting a new wave across cinema halls country-wide.

Awaiting its release this Eid-ul-Azha, Shakib's *Priyotoma* has already caused an exciting murmur among the audiences. On that note, the star sat down with The Daily

Star to discuss his two decades long career, and everything that came with it.

You're one of the leading heroes of the country now, what's your takeaway from the last 24 years?

On May 28, the day I stepped into the 24th year of my career, I was on the set of *Priyotoma*. What else can an actor

part of the want? I am happy to be a film industry, and I am grateful to my fans, audiences, reporters, and everyone involved. I am who I am, because of them. Nothing comes above people's love. I want to move forward with the lessons of the past, doing what I do now.

You have never disappointed your fans and neither have they ever let you down. That is quite clear whenever one of your films are released.

I act for my fans, so my films are for them. None of them watch my films for free, they buy tickets with their own hard-earned money. The film being a hit or a flop is also

in the hands of the fans. No matter what, my fans travel miles to see my films and I am nothing without them.

Despite rumours that your career is over, you have proved otherwise by delivering hit after hit. What do you think about that?

I have been hearing such things for the last 16 years, ever since I got a platform in the industry. Every time I was held back, I moved forward even stronger with people's love. When I have their love, I don't pay heed to such rumours. These rumours will remain,

we just simply have to move forward regardless.

Why do you think people conspire against you?

I have observed for quite some time that a particular group of selfserving people tend to do that. If I listened to them, I would have

stopped a long time back. Even if ten people want to harm me, millions of people want the opposite. It's not possible to make everyone in the world happy

How much do you invest behind getting into a character?

I always try to make my characters dynamic. Whatever time I get, I spend it by creating a get-up and look, while also trying to embody the character. If we're playing the long game, struggle is not an option. My fans keep me inspired to work through everything, they help me become who I

Collapsed bridge not repaired in 3 years

An iron structure bridge over a canal in Dumki upazila, collapsed more than three years ago, still lies without repair, much to the sufferings of people of several villages.

Besides, over 500 students of nearby Habibullah Government Secondary School are the worst sufferers as they have to cross the canal on small boats amid risk to go and from their institution every day.

Otherwise, the school children are compel to travel an additional four kilometres, using the alternative route.

Local people said Local Government Engineering Department (LGED) built the iron structure bridge over Varani Canal in Lebukhali area in 2009.

In 2015, a portion of the iron bridge was badly damaged, but then the LGED authorities repaired the damaged part within a few months.

In January 2020, a major part of the important bridge completely collapsed after being hit by a sand-laden cargo.

Since then, most of the villagers including school going children use small boats to cross the canal as the authorities concerned are yet take necessary step to repair the bridge.

Atiqul Islam, head teacher of Habibullah Government Secondary School, said the institution, nationalized in 2018, was established in 1961.

Currently the school has nearly 1,000

Of them, over 500 students either have to come to the school by crossing the canal on small boats, or walking an additional four kilometres through an alternative route, the headmaster said.

However, the number of students at the institution has been decreasing alarmingly as the bridge is lying unrepaired for long, he added.

Abdus Salam, acting chairman of Lebukhali Union Parishad (UP), said he has sent several letters to different concerned departments, including the LGED, urging them to repair the bridge immediately, but they are yet to take any step in this regard.

There are many other important establishments including the union land office, post office and two weekly markets on either side of the bridge, he

Contacted, Patuakhali Executive Engineer Latif Hossain said they have taken up a plan to remove the damaged bridge and build a new one

per its agreement with the Grameen Telecom Sramik Karmachari Union.

The Grameen Telecom MD and the president and the secretary of employees' union, Kamruzzmaan and Firoz Mahmud, signed agreement on April 27 last year and the account was opened on May 8 with the Dhaka Bank's Gulshan branch.

"Since the bank account was opened after the signing of the agreement, the account number was not supposed to be mentioned in the agreement. But the account number was mentioned in it, meaning the agreement was fake," reads the case statement.

"The Grameen Telecom chairman and the board members in association with each other produced the fake agreement as an authentic one to help misappropriate money

and thus committed a was misappropriated. employees as crime under the money laundering prevention act," it adds.

Meanwhile, the High Court yesterday ordered "a six-month status quo" on the judgement of the Labour Appellate Tribunal that justified the demand of profit sharing by 106 former workers of Grameen Kalyan, another non-profitable and charitable company established by Prof Yunus.

The HC also issued a rule asking the Labour Appellate Tribunal and the 106 workers to explain why the tribunal's verdict should not be declared illegal.

The HC bench of Justice Zafar Ahmed and Justice Md Bashir Ullah came up with the order and rule following a writ petition filed by the Grameen Kalyan challenging the legality of the tribunal's verdict, Golam Rabbani Sharif, a lawyer for the workers, told The Daily Star.

An expressway worker, who was about 100 yards away from the spot where the boy was fatally hit, said, "No one was there to keep people away from the place where the work was going

only restrict people's movement when girder segments or viaducts are lifted... The authorities usually do not take adequate measures when doing regular tasks."

Meanwhile, First Dhaka Elevated Expressway Company Ltd in a statement last night said its construction sites conformed to the local and international guidelines and met the standards.

However, it was an "incident of thievery" that led to the boy's death. "The deceased was involved in thievery. He was assisting

a syndicate of workers who were trying to steal the project's steel rod. They were throwing rods from the top of the Elevated Expressway. Unfortunately, one of the steel rods fell and hit his head," read the statement.

'We are committed supporting investigation and fully cooperating with the relevant authorities..."

Rights activist Nur Khan Liton said the case filed by the authorities against a worker is an attempt to shift the blame.

'Anything can accidentally fall. But one has to check whether there are adequate safety to prevent measures tragedies. I think one single worker should not be blamed," he told The Daily Star.

Contacted, Hasib, the

manager who filed the case, said the worker was accused because the rod fell from his hand.

There was no negligence on the part of the authorities, he added.

Sub-inspector Sekandar Ali of Dhaka Railway Police Station, who is investigating the case, said, "We are trying to identify the boy. No one has claimed the body at the Dhaka Medical College morgue."

On August 15 last year, five people were killed after a segment of a box girder of the BRT project fell on a car at the Jasimuddin Road intersection on Dhaka-Mymensingh highway.

Officials of construction firm, China Gezhouba Group Co Ltd, and a crane operator were sued for the deaths. Rab later arrested nine people.

exploitation discrimination by West Pakistan was on the rise. Bangalee technicians and workers in the film industry were becoming disillusioned with the Pakistani film industry. Kolkata, having become the centre of the Bangalee film industry due to partition, was progressing in film production at the time.

Finding female artistes for such a project was a challenge in the 1950s. Initially, director Abdul contemplated Jabbar having a man dressed as a woman for the film, a common practice in stage plays at the time.

Later, Abdul Jabbar Khan placed an advertisement in the newspaper to find "Mukh actress for Mukhosh". Pyari

Begum, an intermediate among Bengalis regarding student at Eden and her friend Zahrat Ara responded to the advertisement published in Chitrali magazine. They would go to the office of Iqbal Films in Nawab Katra. Thus, the journey of Pyari Begum in the Bangla film industry began.

Pyari Begum's demise follows the passing of Zahrat Ara, her co-actress in "Mukh O Mukhosh", on July 19, 2021.

İn her final interview with The Daily Star in 2021, Pyari Begum spoke about the loss of her friend and co-artiste Zahrat Ara, "My close friend and co-actor Zahrat Ara has passed away. I am quite old now. There are a lot of things I do not remember. Even then, I am glad to have been an actor in the first ever Bangla feature film."

not possible to shed the load in some areas, such as the PMO, the secretariat and the coal-based power plants hospitals. We can keep the situation under control if we have a shortage of around 200 MW, but the shortage is way more than that now," said Bikash Dewan, managing director of DPDC.

Talking about the between demand production, Desco Managing Director Kausar Ameer Ali said, "Due to the increasing gap, we need to shed the load at least twice a day."

Interestingly, power sector is getting the highest gas supply ever, over 1,100 million cubic feet a day, which seems to be inadequate as around 4,818 MW gas-fired power generation capacity remains unutilised on average against the capacity of 11,039 MW.

From May 24 to May 29, furnace oil and diesel-fired power plants produced

around 3,800 MW of electricity against the capacity of 7,122 MW while produced around 2,226 MW of electricity against the capacity of 3,360 MW, PGCB sources said. Bangladesh imports around 1,065MW electricity from India against the capacity of 1,160 MW, they added. Both the coal-based Payra

and Rampal power plants produced only around 300 to 350MW of electricity for the last few days, which increased power cuts in different districts in Khulna.

Power generation shortage has forced Bangladesh Rural Electrification Board (BREB), which supplies electricity to 55 percent of consumers across the country, to shed

load in all of its areas. As of May 29, the highest average of power cuts occurred in Khulna zone, followed by Mymensingh, Rajshahi, Dhaka, Rangpur, Cumilla, Sylhet and Barishal.
