

Bracing for budget of self-preservation

In 2019, when AHM Mustafa Kamal took charge as the finance minister, the Bangladesh economy was taxing for take-off for its long-haul flight to the developed country club.

Four years later, it failed to fly into the air, as Kamal refrained from opening the throttle to increase the engine power needed for the economy to take off.

For the Bangladesh economy, the throttle is the tax revenue collection, which would enable the government to make the expenditure needed to level up GDP growth in an equitable manner.

As per the original flight schedule, the budget for fiscal 2023-24 would have been the one priming the Bangladesh economy for cruise control in the

But Kamal's bolting for the auto-pilot mode from the onset has left the economy ill-positioned to withstand the adverse conditions of the global coronavirus pandemic and the Ukraine war -- even while on the runway

Subsequently, the budget that he is set to unveil today, his fifth as the finance minister, has become one of survival amid spiralling inflation, depleting reserves, rising poverty and slowing economic

And whether he manages to succeed in barely

that is also in question given the narrow fiscal space, which got narrower during his term.

When he took charge, Bangladesh's tax-GDP ratio was in the neighbourhood of 10 percent. Now, it is about 7.5 percent is the lowest in South Asia, and on average, almost 5 percent less than lower middle-income countries, according to a

study by the International Growth Centre. It is for this reason that he did not go for an expansionary budget amid the pandemic, when most countries in the world were going for one to prevent a hard landing of their economies from the worst global economic and public health crisis in recent memory.

And it is for this reason, he is unable to provide the funds needed to extend adequate cash support to the poor and the low-income people to cushion themselves from the vagaries of inflation, which averaged 8.85 percent in the first ten months of the fiscal year and way above the budgetary target of 5.6 percent.

What he can manage at best is a token amount that would not be of much help to this demographic amid the high prices of essentials.

This would unravel the decades of gains made in poverty alleviation - and would be stepping back in time. Already there are signs of this SEE PAGE 2 COL 2

Foreign debt servicing likely to soar by 45pc

The government's foreign debt servicing burden may rise by as much as 45 percent in the next fiscal year due to the devaluation of taka and higher utilisation of foreign loans in recent years.

About Tk 24,700 crore would be set aside in fiscal 2023-24's budget for foreign loan repayment, according to finance ministry officials.

It is about \$2.42 billion considering the current exchange rate of Tk 102 for a dollar.

In the outgoing fiscal year, Tk 17,000 crore was initially allocated for this overhead, which was later revised upwards to Tk 18,150 crore. The revised allocation is about \$1.78 billion considering the current exchange rate.

The higher allocation is due to the slide in the value of taka in recent times, said a finance ministry official.

Taka has depreciated by about 23 percent against the dollar in the past year. Besides, Bangladesh's use of foreign funding has

increased in recent years, hitting a peak of \$10 billion in fiscal 2021-22.

This fiscal year, the government is projected to utilise foreign assistance of around \$12 billion.

Different mega projects including the Dhaka metro rail, Matarbari port and coal-fired power project, are being implemented in full swing and with it, more foreign funds are being used.

SAFETY NET PROGRAMMES

Slice for the poor only gets thinner

Although budgetary allocation for social safety net programmes has increased over the past 13 years, the share of compatible programmes has declined significantly.

Compatible social safety net programmes (SSNPs) mean such programmes that actually provide protection to poor and vulnerable people. For example, old age allowance; allowances for the widowed, deserted and destitute women; and allowances for people with disability who are financially insolvent.

Over the years, the list of safety net programmes, however, has included loosely related or completely unrelated programmes that do not have much to do with protection of vulnerable groups of people. Examples include pension for retired government officials, agriculture subsidies, and various credit programmes and infrastructure projects.

The Centre for Policy Dialogue has made these observations in its review report titled "State of the Bangladesh Economy in FY2022-23". Citing the government's allocation of Tk 1.13 lakh crore for 115 social security programmes in the current fiscal, the report says that Tk 33,966 crore or only 29.7 percent of the total allocation is used for compatible safety net programmes.

In the 2009-10 fiscal year, the share of

compatible SSNPs was as high as 62.2 percent, says the CPD report.

Terming the completely unrelated programmes non-compatible, the report says that the share of such programmes has risen to 65.5 percent of total allocation in the current fiscal, which was only 25.5 percent in FY 2010.

The list of safety net programmes has included over the years loosely related or completely unrelated programmes that don't have much to do with protection of vulnerable groups of people.

"While it can be argued that fringe elements need to be included to make a comprehensive list, the inclusion of completely unrelated programmes raises questions as to whether the intention was to inflate the statistics in the first place," says the report.

In the current fiscal, Tk 28,037 crore is allocated for the pension of retired government officials, Tk 12,500 crore for agricultural subsidies, and Tk 7,907 crore for savings certificate interest assistance.

28 arrested in DSA cases last month

Almost all BNP activists; the number was eight in April, says rights body

At least 28 people were arrested under the Digital Security Act across the country in May, and only one of them was not a BNP activist, according to a report by Manabadhikar Shongskriti Foundation.

In April, eight people, including a journalist, a teen, and a BNP activist, were arrested in seven cases filed under the act, said the report signed by its founding president Sultana Kamal.

The report released yesterday was based on reports published by 18 media outlets. The news reports were verified by rights activists, it said.

The rights body strongly condemns the government's failure to address the violations of human rights.

According to the report, the misuse of the DSA persisted in May when six of the DSA cases were filed for "tarnishing the images" of either the country or Bangabandhu Sheikh Mujibur Rahman, Prime Minister Sheikh Hasina, highranking government officials and members of the ruling party on social media.

Two DSA cases were filed in Faridpur and Rajbari, against BNP activists and leaders.

Besides, a Narayanganj court issued an arrest warrant for a journalist for publishing an article about Narayanganj-4 MP AKM Shamim Osman.

The DSA is being abused to keep people from expressing their opinions and to intimidate and silence them, it said, adding that at least 45 journalists were humiliated, harassed, and tortured in May.

PASSENGER'S HEART ATTACK

Biman fires captain for negligence

Biman has fired Capt Dildar Ahmed Tufail for negligence in duty while captaining a flight on January 15.

He was reportedly napping in the crew rest area, leaving the cockpit of the Boeing 777-300ER technically unmanned.

A passenger had a heart attack during the overnight flight to Dhaka from Jeddah.

Capt Tufail did not declare medical emergency and landed the plane in Dhaka four hours after the incident.

The passenger, Kabir Ahmed, a migrant worker from Noakhali, was pronounced dead on arrival at a city hospital.

Aviation rules allow captains to take rest on flights longer than 8 hours, but only when a relief crew, which is usually on standby, takes

There was no relief crew as this was only a six-hour flight.

The cockpit is supposed to be manned by two pilots capable of flying the plane independently if required.

On this particular flight, Capt Tufail was the pilot in command. He had Irfan Ul Hag beside him who was under training and not qualified to fly the plane. The flight was actually Irfan's test flight.

Capt Fariduzzaman, a retired pilot, was evaluating Irfan from the jump seat in the cockpit. He also didn't have a pilot's licence as he was well over the age limit of 65 for being a

According to sources, when Capt Tufail went into the rest area, he left the plane in the hands of people who are not authorised to fly the plane.

Following an announcement by the cabin crew, a doctor on board, ABM Haroon, managing director of Samorita Hospital, advised emergency landing.

According to aviation rules, in such cases, a "medical emergency" is to be raised by the pilot, which notifies every nearby airport of a possible arrival with the need for emergency medical support.

However, Tufail did not divert or raise the alarm, confirmed civil aviation insiders looking into the event. The mandatory air safety report was also not filed after the

Following an investigation, Biman authorities found evidence of Capt Tufail's negligence and served him a show-cause notice.

As the authorities were not onvinced by his reply, Biman fired him.

Russia reports attacks on oil refineries, town

Ukrainian shelling kills five in Russian-occupied Luhansk; four hurt in a town in Belgorod border region

Russia said Ukrainian artillery hit a Russian town for a third time this week and drones struck two oil refineries in an uptick in attacks on Russian territory as Ukraine prepares a Western-backed push to end Russia's invasion.

Inside Ukraine, Russian-installed officials said five people had been killed in Ukrainian army shelling of a Russianoccupied village in eastern Luhansk region, where Russia has fought months of bloody and inconclusive battles to try to seize more territory.

There was no immediate comment from Ukraine on the Russian reports, in a week when the two countries accused each other of spreading terror in their capitals with air strikes.

Thousands of civilians have been killed in Ukraine and towns and cities laid to waste since Moscow's forces invaded 15 months ago, but Tuesday marked only the second time Moscow had come under direct fire - from a flurry of drones although oil and military facilities elsewhere in Russia have been hit.

In the Russian town of Shebekino in Belgorod border region, two of four wounded people were hospitalised and

shells damaged an apartment building, four homes and a school as well as power lines, regional governor Vyacheslav Gladkov said.

Gladkov said on Saturday that he had come under artillery fire when trying to enter the town, about 7 km north of the border with Ukraine, and that two industrial facilities were hit there on

Both sides say they are targeting the buildup of each other's forces and military equipment ahead of Ukraine's counteroffensive, which it says will come in days or weeks, to try to drive Russian forces out of its east and south.

Germany, once Russia's biggest energy market, reiterated that it deemed such Ukrainian attacks on Russian soil legitimate in terms of international law, and announced a sharp downgrading of diplomatic representation in both Russia and Germany.

Ukraine's general staff said its forces had fended off 22 Russian attacks in eastern Ukraine over the past day and Ukrainian aircraft had carried out 11 strikes on Russian personnel and military equipment, without specifying

Noab demands withdrawal of tax, duties on newsprint

The Newspaper Owners Association of Bangladesh has demanded the withdrawal of taxes and duties on newsprint in the budget for the fiscal year 2023-24.

In a press release yesterday, Noab said it made the demands during a pre-budget discussion with the National Board of Revenue. The release mentioned that NBR Chairman Abu Hena Md Rahmatul Muneem promised to consider the demands.

The release, signed by Noab President AK Azad, said newspapers have become a struggling industry in the era of globalisation and digital media. Due to the pandemic, there has been a significant decline in newspaper circulation and advertisements, making it impossible to cover production costs with advertising income.

The statement mentioned that even a year and a half ago, the price of foreign newsprint was \$570 a tonne when a dollar was worth Tk 85, but now it has risen to over \$700 and a dollar is

It will provide a forum for participants to share their vision of, and priorities for, social justice and to showcase the actions they are taking and they commit to take to advance social justice.

He then fell down and seriously hurt himself, they added.

The CU students and locals took him to a nearby clinic, but doctors there referred him to Chattogram Medical College Hospital.

The debt servicing cost is increasing as the interest payment for these project's loans is gradually rising, according to an Economic Relations Division (ERD) official.

Heatwave likely to continue for a week

Mild to moderate heatwave that the country is experiencing currently will likely to continue for a week, said Meteorological Department.

On Wednesday, Rajshahi saw the highest temperature 38.6 degree Celsius while Dhaka's mercury was 37.2 as per daily bulletin of the Met Department. The lowest temperature 23.3 degree Celsius was recorded in Tetulia,

Abul Kalam Mollik, a meteorologist, told The Daily Star that sunshine duration increased in absence of cloud and there is less pace in the air.

"The heatwave is likely to continue for a week. The temperature could vary from 36 to 40 degree Celsius. The moisture content in the air is less than 60 percent which turned the air dry resulting in no sweating...," he

Mohammed Ibrahim who sells clothes on a rickshawvan at the capital's Panthapath told The Daily Star that the rising temperature is making their job difficult as he has to spend most of his days on the street.

"Although the temperature is mild in the morning, it gets hotter as the day progresses," he added.

Pay Tk 12cr tax on gifts to 3 charitable trusts

HC asks Yunus

mad Yunus will have to pay Tk 12 crore as tax on the money he gifted to his three charitable trusts

The bench of Justice Muhammad Khurshid Alam Sarkar and Justice Sardar Md Rashed Jahangir gave the verdict dismissing three applications filed by Yunus challenging the tax liability imposed on the money gifted by him to the trusts.

Details of the verdict could not be known as its full text has not been released yet.

According case documents. Yunus donated Tk 76.73 crore to "Professor three trusts Muhammad Yunus Trust". "Yunus Family Trust" and "Yunus Centre" -- in the tax years 2011-2012 and 2013-2014.

The commissioner of taxes imposed a "gift tax" worth Tk 15.4 crore on the donated money.

Yunus filed appeals with the Tax Appellate Tribunal challenging the imposition of taxes on the donated money. However, the Tax Appellate Tribunal upheld the decision of the Deputy Commissioner of Taxes (DCT). Before filling the appeals, he deposited over Tk 3 crore to the tax office.

hearing applications, the HC on April 2, 2015 stayed the operation of the government notifications issued for realising the demanded tax. Recently the attorney general's office took an initiative for holding hearing on the applications.

Accordingly, the HC held hearing on the matters yesterday.

Cases cross 1,000 mark in May, breaking previous records

The number of dengue patients crossed the 1,000 mark in May this year, which is five times higher than the same month in 2019. In 2019, the country saw over 1,00,000 dengue patients, the highest in the country since its first outbreak in Bangladesh in

According to the DGHS, the number of dengue cases in May was 163, 273, 10, 193, 52 and 114 in 2022, 2021, 2020, 2019, 2018 and 2017 respectively. This year, the number rose to 1,036. A total of 13 patients have died after being infected with the mosquito-borne disease.

Stressing the need for hot spot management, entomologist Prof Kabirul Bashar of Jahangirnagar a second time must be University said the authorities will have to conduct drives in the areas from where dengue patients are coming. Killing adult mosquitoes is now very important as mosquitoes in those areas are infected with dengue virus, he



confirmed Jakariya, additional divisional commissioner (revenue) and director of local government.


The mayor candidate Md Shahjahan Miah regained his candidacy.







Magura litchi growers, traders eye good profit

Local litchi growers said the yield is quite high this year due to favourable weather condition and hope to earn a good profit then the previous years. Harvesting of the mouth-watering

fruit started from April 15 and will continue till mid-June.

Currently they are passing busy time in harvesting the Bombay variety,

According to Magura Department of Agriculture Extension (DAE), around 640 hectares of land in four upazilas of the district have been brought under litchi cultivation this year, while the target was around 8,975 tonnes.

Alongside the Bombay variety, different local varieties of litchis are being produced at Hazrapur, Sachani, Lautara, Baromile, Ramnagar, Dariapur and Nandalalpur villages in Magura Sadar upazila.

A number of farmers said as the soil of the district is suitable for litchi cultivation litchi orchards need little care all the year

They applied compost fertilizer and phosphate and got a good production

due to favourable weather this year.

Farmer Moslem Sardar of Hazrapur Litchi growers and traders in Magura are village said he has a total of 125 litchi trees in his orchard.

> Fortunately, as there was no natural disaster like storm or untimely rainfall this season he got about 14,000 to 15,000 litchis from each tree, which was only 6,000 to 6,500 last year, Moslem

> Ohid Hossain, a litchi trader from Sachani village said Magura's litchi is very tasty and it has a good demand in other parts of the country, especially in the capital.

> Every year, wholesalers from different districts across the country come to the district to buy litchi and sale those to different markets, Ohid said, adding that he bought four separate orchards at Sachini and Hazrapur villages for Tk

> Rokeya Khatun, a female worker, said she earns Tk 500 daily by sorting litchi at a local orchard.

> Magura DAE Deputy Director Sufi Mohammad Rafikuzzaman said farmers got good yield of litchi as there was no storm or pest attack this season.

> He said harvesting of litchi and its trade creates a short-term job opportunity for nearly 25,000 workers, including girls and housewives.

Noab demands withdrawal of tax

Currently, newsprint is subject to a 5 percent import duty, along with an additional 15 percent VAT, 5 percent Advance Income Tax, and 5 percent Advance Tax and with costs of insurance, bank charges, transportation fees added, the cost of newsprint becomes 30 percent more.

Given the state of the newspaper industry, it is crucial that these duties are withdrawn.

Noab also demanded that corporate tax on newspapers be set between 10 and 15 percent, and that raw materials be exempted from being taxed at source.

Congress leader Rahul Gandhi has accused India's BJP government of "threatening" the people and "misusing" the country's probe agencies, and attacked the Indian media for projecting a narrative that suits the saffron party.

Speaking at an Indian diaspora event in Santa Clara, California, on Tuesday, Gandhi claimed the BJP and the RSS are controlling all the instruments of politics in India.

"The BJP is threatening people and misusing government agencies. The Bharat Jodo Yatra started because all the instruments that we needed to connect with the people were controlled by the BJP-RSS," he said.

"We were also finding that in some way, it had become quite difficult to act politically. And that's why we decided to walk from the southernmost tip of India to Srinagar," he

Rahul Gandhi alleged India is not what is being shown in the media which likes to promote a political narrative that is far from reality, claiming there is a "huge distortion".

"It was very clear to me in the Yatra that it's in the media's interest to project these things, it helps the BJP. So, don't think that everything you see in the media is the truth." he said.

EXPULSION OF INDIAN JOURNOS China says it took

China said yesterday it had taken "appropriate" action in response to India's unfair treatment of Chinese journalists, in the latest episode to highlight tense relations between the big Asian neighbours.

The Wall Street Journal reported on Tuesday that China and India had ejected nearly all of each other's journalists in recent weeks.

Citing people familiar with the matter, the newspaper said India had this month declined to renew the visas of the last two Chinese state media journalists in India.

Meanwhile, at least two Indian reporters had not been granted visas to return to China and a third was told that his accreditation had been revoked. A Chinese foreign ministry spokesperson, asked about the report, said Chinese reporters had been treated unfairly in India for

"What I can tell you is that for a long time, Chinese journalists have suffered unfair and discriminatory treatment in India, and in 2017, the Indian side shortened the visa validity of Chinese journalists to three months or even one month for no reason," the spokesperson, Mao Ning, told a briefing.

Beijing blames US 'provocation'

yesterday blamed US "provocation" for an incident last week in which a Chinese plane crossed in front of an American surveillance aircraft over the South China Sea.

The incident comes at a time of frayed ties between Washington and Beijing over issues including Taiwan, which China regards as its territory, and the shooting down of an alleged Chinese spy balloon that flew over the United States this year.

"The United States' long-term and frequent sending of ships and planes to conduct close surveillance on China seriously harms China's national sovereignty and security," foreign ministry spokeswoman Mao Ning said

when asked about the latest incident. "This kind of provocative, dangerous

activity is the cause of the security issues on the seas," Mao said, calling on Washington to "immediately stop this form of dangerous provocation".

"China will continue to take all necessary steps to resolutely protect its own sovereignty and security," she said.

US military said on Tuesday a Chinese fighter pilot performed an "unnecessarily aggressive maneuver" near an American surveillance aircraft operating over South China Sea last

Video footage released by US military shows a Chinese fighter plane crossing in front of American aircraft.

The Chinese plane "flew directly in front of and within 400 feet of the nose of the RC-135, forcing the US aircraft to fly through its wake turbulence" on Friday, the Indo-Pacific Command said in a statement.

Bail for ex-Pak PM extended until June 19

The bail for Pakistan's former prime minister Imran Khan has been extended until June 19 in the Al Qadir Trust graft case, his lawyer said yesterday.

Khan's May 9 arrest sparked widespread protests by his supporters, raising fresh worries about the stability of the nuclear-armed country as it struggles with its worst economic crisis in decades. He has denied any wrongdoing.

He was freed on bail on May 12 for an initial two weeks. Yesterday, he got a three-day bail extension from a high court and later a further extension from trial court until June 19.

COOPERATION TALKS Top Chinese intel official visits Myanmar

AFP, Yangon

A top Chinese intelligence official has visited Myanmar to discuss military "cooperation" with the junta, Myanmar state media reported yesterday, the latest high-profile delegation sent by Beijing to its internationally isolated ally. Myanmar has been in turmoil since a 2021 coup that sparked renewed clashes with ethnic rebels and the formation of dozens of "People's Defence Forces" now battling the junta. It is the first publicly reported visit by a military official from China, a major ally and arms supplier of the junta, since the coup. Major General Yang Yang, acting director-general of the Intelligence Bureau of the Joint Staff Department of China's Central Military Commission, met the junta's number two official, Soe Win, for talks on "cooperation between the two armies", state media said. The two also discussed "cooperation in peace, tranquillity and development programmes for border areas" at the Tuesday meeting, according to state-run newspaper Global New Light of Myanmar.

North Korea 'spy satellite' crashes into sea

North Korea attempted to launch a spy satellite yesterday but it crashed into the sea after a rocket failure, with the South Korean military retrieving part of the likely wreckage in a potential intelligence bonanza. North Korea does not have a functioning satellite in space and leader Kim Jong Un has

made developing a military spy satellite a top priority for his regime, despite UN resolutions banning its use of such technology. Pyongyang had said in the build-up to the launch attempt that the satellite would be vital to monitoring the military movements of the United States and its allies. But the rocket lost thrust and plunged into the sea with its satellite payload, the official Korean Central News Agency reported. It added that authorities would investigate the "serious defects" revealed by the launch and conduct another test as soon as possible.

UN COURT VERDICT Milosevic aides handed longer iail terms

A UN court sentenced two Slobodan Milosevic's spy chiefs to 15 years in jail on appeal yesterday in the last major Hague war crimes trial from the 1990s Bosnian conflict.

EVEREST 'DEATH ZONE' RESCUE

Nepali sherpa saves Malaysian climber

A Malaysian climber narrowly survived after a Nepali sherpa guide hauled him down from below the summit of Mount Everest in a "very rare" high altitude rescue, a government official said yesterday.

Gelje Sherpa, 30, was guiding a Chinese client to the 8,849 metre (29,032 feet) Everest summit on May 18 when he saw the Malaysian climber clinging to a rope and shivering from extreme cold in the area called the "death zone", where temperatures can dip to minus 30 degrees Celsius (86F) or lower.

Gelje hauled the climber 600 metres (1,900 feet) down from the Balcony area

to the South Col, over a period of about six hours, where Nima Tahi Sherpa, another guide, joined the rescue.

"We wrapped the climber in a sleeping mat, dragged him on the snow or carried him in turns on our backs to camp III," Gelje said.

A helicopter using a long line then lifted him from the 7,162-metre (23,500 feet) high Camp III down to base camp.

"It is almost impossible to rescue climbers at that altitude," Department of Tourism official Bigyan Koirala told Reuters. "It is a very rare operation."

Gelje said he convinced his Chinese client to give up his summit attempt and descend the mountain, saying it was important for him to rescue the climber.

A huge blow for our economy

Govt must critically examine Moody's credit downgrade and respond properly

We're alarmed to learn that the US-based global credit rating agency Moody's Investors Service has downgraded Bangladesh's sovereign rating by one notch from Ba3 to B1. The disclosure, coming as it does just before the unveiling of Bangladesh's national budget for FY23-24, represents a huge threat to its post-Covid economic aspirations with the experts calling it "one of the worst incidents" in the recent history of our economy. And it couldn't have come at a worse time.

In simple terms, the downgrade – the first since Moody's began rating Bangladesh in 2010 - means a blow to our creditworthiness. Not only will it tarnish the country's image abroad but it will also have tangible effects on local businesses. Businesses will likely face higher borrowing costs for loans from foreign sources, while foreign investors may be wary of the increased credit risk associated with investing in Bangladesh. The fallout may extend beyond loans and investments as well. The cost of doing business may go up as banks may increase charges for import payments, known as letters of credit (LCs). Moreover, local banks may face tougher negotiations with global lenders regarding commissions and charges for settling foreign exchange transactions.

The question is, what prompted the downgrade? Reportedly, Moody's assessment is that Bangladesh's heightened external vulnerability and liquidity risks are persistent, as are its institutional weaknesses. "Despite some easing, ongoing dollar scarcity and deterioration in foreign exchange reserves indicate continued pressures on Bangladesh's external position, exacerbating imports constraints and as a result energy shortages," it said. Additionally, the government's failure to fully reverse import control measures and unconventional policies, such as a multiple exchange rate regime and interest rate caps, is contributing to market distortions, according to a report issued by the agency. Persistently low revenue generation and rising interest payments have also resulted in weakening fiscal metrics, especially debt affordability.

In the coming days, there will be a lot of discussion about the downgrade and its implications. But as things stand, this is indeed a wake-up call for Bangladesh. To get back up from the downgrade or prevent further downgrades, it is imperative that the government takes this seriously and restores confidence by addressing our economic vulnerabilities through effective policy measures. The future trajectory of our economy will hinge a lot on how it responds to this latest threat.

What's the point of having hajj teams?

Govt must prevent selection of unqualified staff for hajj operations

It is astonishing how corrupt practices continue to mar just about any government operation. As a report by this daily has revealed, of the 218 officials that the religious affairs ministry is sending to Saudi Arabia to assist Bangladeshi medical and technical teams during the upcoming hajj, at least 200 have neither any technical training nor a background in medicine. Instead, you have cooks, cleaners, chauffeurs, bodyguards, staff connected with high-up officials, office assistants, and administrative officers. Clearly, they are unqualified to perform the listed roles of their respective teams: to provide assistance at health clinics, ensure prompt services for patients, assist the hajj technical team, and find missing

Unfortunately, government programmes for hajj have been repeatedly subjected to such corruption and favouritism in the past. For instance, under the government's subsidised hajj programme last year, more than half of the 254 pilgrims were found to be associated with the ruling party. How fair is it to spend a huge chunk of public money for the hajj of solvent, politically connected people? This year, Biman is reportedly set to spend crores to send 100 of its officials to Saudi Arabia in the name of assisting pilgrims, as it did before too. Again, we cannot help but ask: is such a delegation at all necessary when Biman already has several fully-fledged offices in Saudi

In light of the latest report, it is clear that the selection of hajj delegates was not done based on their capability to serve pilgrims. It is more than likely that they bought or powered their way into the teams, and it is the ordinary pilgrims and taxpaying citizens who will have to bear the cost of their transgressions and that of ministry high-ups. This is totally unacceptable. We urge the government to hold to account those overseeing hajj operations for their mismanagement and irregularities. It must properly investigate all such cases of corrupt selection and recruitment as well as the role of ministry officials behind it.

The State of Tax Justice 2020 report calculated that Bangladesh is losing more than \$703 million every year because of tax abuses committed by multinational corporations and private individuals. Multinational corporations alone cost the country \$674 million annually. This year, the Centre for Policy Dialogue (CPD) estimated that Bangladesh was losing potential taxes from as low as Tk 41,800 crore to as high as Tk 223,000 crore yearly because of tax evasion. A number of studies over the years have uncovered how nepotism, corruption, and political bias in enlistment have weakened the safety net plans intended to help the poor and other vulnerable groups. For instance, a World Bank report in 2016 found that about 60 percent of safety net programme beneficiaries did not qualify as being vulnerable.

More recently, a CPD survey found that almost 30 percent of old-age allowance beneficiaries and 33 percent of widows allowance beneficiaries were not eligible for the grant. And this is happening while 3.3 million elderly people and 2.5 million widows who are eligible for the benefits remain outside of the programme. Thus, about Tk 1,500 crore is wasted in only two schemes. What is even more reprehensible is the fact that eligible beneficiaries are made to pay Tk 2,653 on average in bribes for the benefits. The survey further alleged that the authorities, despite knowing about the irregularities, have done nothing to stop them.

Can a city be smart without adequate finance?

Although Dhaka and Kolkata, two maior South Asian cities, are just 240 kilometres apart and share a common history and culture, not many comparative studies on these cities have been undertaken so far. Kolkata is the second largest city in India, while Dhaka is the largest city in Bangladesh. A book titled How Smart are Cities without Adequate Finances? attempted to improve our understanding about financing patterns of these two South Asian cities. Three university professors from Bangladesh and India – Simanti Bandyopadhyay, Firdousi Naher and Aishna Sharma – have compared recent city-level financial trends in Dhaka and Kolkata, which is not only refreshing, but can also lead to further research in the future. Bangladesh and India's West Bengal share a common history, heritage, socio-cultural norms and environment. Both Dhaka and Kolkata are densely populated and face similar challenges in delivering civic services to its citizens. Therefore, comparing the two local governments' financial situations makes perfect sense.

A city needs to meet a number of fundamentalcriteriatobecome "smart," the catchword used internationally these days to characterise urban areas in terms of their use of information and communication technology, operational efficiency, financial

prudency, cost-effective service delivery, time-saving public transportation system, and aesthetic and environmentfriendly development, all done under a progressive urban planning philosophy. Smart cities should also aim to promote social inclusion and community engagement to ensure poverty alleviation, gender equality and resilient societies.

The authors of the book made an effort to look at the "smartness" of cities through the lens of financial sufficiency. The urban development context in both Bangladesh and India are truly comparable due to their poor basic services like housing, water supply, sanitation, waste management, roads and drains, etc, and therefore, according to the authors, "ensuring a sound infrastructure is the foundation for any smart urban agglomeration to emerge and this, in turn, hinges on the financial health of urban local bodies." Both in Dhaka and Kolkata, air and water pollution levels are alarming, and water supply, sanitation and solid waste management are poor.

While we recognise the importance of smart cities, there is very little empirical evidence on how they function. As such, the book raises a pertinent question on development of sustainable cities in South Asia. The authors point out that "most urban local bodies in developing economies

of revenues and/or lack of financial power to invest in even the basic infrastructure.'

The financial health of Dhaka North City Corporation (DNCC), Dhaka South City Corporation (DSCC) and Kolkata Municipal Corporation (KMC) are compared in the book. The urban local government bodies have legally defined areas of revenue generation, budgeting and expenditure for development of infrastructure and services, operation and maintenance. It also includes detailed historical, demographic and socioeconomic background of both Dhaka and Kolkata and the evolution of the local government structure in the two countries.

The comparative analysis of the two cities in terms of legal mandates for revenue generation and expenditure decisions, tax and non-tax collection situation, and urban economic strength are the most noteworthy

aspects of the book. The book argues that low revenue collection in Dhaka and Kolkata affect their level of expenditure, which is less than one percent of GDP, despite both cities contributing highly to their respective economies. Data from DNCC and DSCC shows that own revenue constitutes the bulk of total resources - 87 percent in DNCC and 79 percent in DSCC between 2012-13 and 2018-19. The government grant is relatively low, which comes from the Annual Development Programme (ADP). Property tax, called "holding tax" in Bangladesh, constitutes about 45 percent of total own revenues from both city corporations. There are some variations in per capita own revenue between the two city corporations, with DNCC doing better than DSCC.

suffer from insufficient generation is not possible to say what causes this variation – whether it is due to high tax effort of the DNCC or due its higher property value.

In Kolkata Municipal Corporation, own revenue constitutes 51 percent of total resources which comes from government grant, compared to DNCC and DSCC. But compared to Dhaka, Kolkata's per capita own revenue and property tax revenue collection are higher. Again, KMC's per person expenditure is \$70 higher than the per person average expenditures in DNCC and DSCC.


The book tried to estimate own revenue to Gross City Product (GCP) ratios in both DNCC and DSCC. Using own revenue generated in 2017-18 in DNCC and DSCC at current prices, the own revenue to GCP ratio turned out to be only 0.3 percent in DNCC and 0.28 percent in DSCC. On the other hand, the GCP ratio in KMC has been 1.3 percent or higher in recent years. This implies that compared to the KMC, the DNCC and DSCC have higher potential for own revenue generation in future if property tax assessment can be improved, assessment to collection efficiency is raised, and non-tax revenue sources fully exploited.

If the DNCC and DSCC take note of the book's findings and make sincere efforts, they can increase tax revenue and utilise additional resources for better public service delivery. This will encourage city dwellers to pay taxes regularly and at higher rates. The book makes an excellent contribution towards filling an information gap in local resource mobilisation in the two most resourceful metropolitan cities in South Asia.

The nation is engrossed in politics during the budgetary season, perhaps with the understanding that the course of politics shapes economic outcomes. Since the budget is a political process, the rules of the budgetary game are set within that continuum. Nonetheless, the new budget begs three questions which are dominating public parleys.

Will the cost of living go down?

People have been suffering greatly in recent times due to the soaring prices of all kinds of food and non-food items - be it oil, soap, clothing, educational materials or transportation. As a result, the majority of the population in low- and limitedincome brackets are having to cut down on expenses to run their families.

The government said prices had to be "adjusted" due to the global situation against the backdrop of the pandemic and the Russia-Ukraine war, and that the prices would be revised as the situation "normalised." For example, the government at one go hiked the prices of all types of fuels by 42.5-51.7 percent in August last year. But when oil prices were hovering between \$70 and \$80 per barrel in the international market for a long time, there was no sign of downward price adjustment in the domestic market as the government had promised. In fact, prices of major commodities – soybean oil, palm oil, sugar, wheat flour, onion, lentils, etc - fell significantly in the international market, but there has been no relief for consumers in Bangladesh. In addition, we are also hostage to price-fixing by a powerful rentier nexus of intermediaries who enforce exorbitant differences between the farm gate and the retail prices in absence of regulatory oversight.

If the budgetary proposals raise taxes on essentials, how would the ordinary people, who are already plagued by the cost-of-living crisis, bear the burden? Rather than increasing the base and reducing the loopholes of income tax, if higher value-added tax (VAT), which applies across the board, is imposed on daily items, how would most people survive? Besides, if the import duty on food items is raised, would the next budget not make the cost of living more excruciating?

Businesses, particularly small and microenterprises, too are adversely impacted by price hikes. For example, domestic yarn has become costlier due to the rise in gas and electricity prices. On the advice of the Bangladesh Bank, banks have fixed the exchange rate, yet the price of the US dollar is rising against the taka every day, though within that stipulated range, escalating the cost of commodities.

If the proposed budget imposes further tax on, say, construction materials like rod, cement, bricks, etc, which saw a 40 percent increase already, how would that impact the existing stagnant private investment? According to the Bangladesh Bureau of Statistics (BBS), private investment has fallen by 0.88 percentage points to 23.64 percent of GDP in FY2022-23, after remaining almost stagnant for at least seven years. Investment also fell due to negative growth in imports of capital equipment, stemming from the inability to open letters of credit (LCs) due to the dollar crisis. If the situation does not improve quickly, new job creation will stall, and inflationary pressure will not let up either.

Will the budget stave off cash shortage?

Low-income households are in shortage of money. According to the BBS, wages have grown at a lower rate than inflation every month for over a year. The wage growth rate was 7.23 percent in April this year, against the inflation rate of 9.24 percent. The weighted wage rate is determined by 145 low skill occupations of the poor and lower middle class, illustrating the pressure being put on these income groups. Savings, income and employment of the lower-middle and middle classes have been hit hard, pushing them into poverty. About nine percent (i.e. more than 15 million) of the people below the poverty line in Bangladesh are newly poor, per Bangladesh Institute of Development Studies (BIDS) data. In the

absence of employment in the formal sector, they were forced into self-employment; the rate of selfemployment among the poor grew to 38.56 percent in 2022 from 33.60 percent in 2019.

Similarly, the pace of poverty reduction has slowed down, despite questions about the BBS definition of poverty used in the survey. According to the BBS, poverty has decreased by an average of 0.93 percentage points per annum over the last six years (2016-2022). Between 2010 and 2016, poverty declined by 1.3 percentage points, on average, every

Biased policies are the main cause of inequality of income and wealth. The Gini coefficient reached 0.499 in 2022 from 0.482 in 2016 and 0.458 in 2010, demonstrating a continuous upward trend over the last 12 years.

Would the government bring any change in its faulty and fragmented social safety net programmes, marred by inclusion and exclusion errors, to institute a life cycle-based universal social security system to supply cash to the people in need, adhering to the constitutional mandate?

The shortage of dollar and central bank restrictions to reduce pressure on the dollar have reduced imports of key raw materials. As a result, during July-March, LCs for the import of industrial capital machinery shrunk by 56 percent and imports of industrial raw materials dropped by 30 percent.

If the budgetary proposals raise taxes on essentials, how would the ordinary people, who are already plagued by the cost-ofliving crisis, bear the burden? Rather than increasing the base and reducing the loopholes of income tax, if higher value-added tax (VAT), which applies across the board, is imposed on daily items, how would most people survive?

How would the budgetary proposals be harmonised with the monetary policy for setting up industries, business expansion and renovation initiatives, which have also dwindled due to want of cash?

The government is in dearth of money. For example, only 41.65 percent of the Annual Development Programme (ADP) was implemented in the first nine months of FY2023. The government is struggling to pay for imported fuel due to the dollar crisis, while the forex reserves are also dangerously low. The Bangladesh Power Development Board is under pressure to reduce the cost, including the huge capacity charges, which resulted from collusive contracts. While the budgetary question of shoring up cash for not defaulting on payments remains, there are fears that the clientele may intensify bargains for budgetary resources with the banking resources increasingly drying out, amid the banking sector exhibiting the highest rate of default after the crisis-ridden Sri Lanka.

What about the runaway debt?

The government's loan from the central bank is increasing at an abnormal rate. In the last five years, the government's borrowing from the central bank has grown by 927 percent. In just seven years, the total foreign debt more than doubled to reach \$95.23 billion, rising from \$41.17 billion in 2015-16. Foreign debt in the private sector also peaked to around \$26 billion till June 2022. Forex reserves may continue to shrink in the near future due to the large deficit in the financial account of balance of payments. Would the budgetary proposals be prudent enough to make a dent in the payment of principal and interest, which is almost 20 percent of the operating expenditure?

The only option is to increase income tax and reduce tax exemptions and tax avoidance. The nation is eagerly waiting for actions on tax evasion and exemptions, including import duty, as research has shown that most money is laundered through import and export. Or will the government opt out for the easiest route of taxing the voiceless, lowincome groups, while giving concessions to the rich, as has been speculated by the media?

John Maynard Keynes, in his 1923 essay "A Tract on Monetary Reform," wrote, "The long run is a misleading guide to current affairs. In the long run, we are all dead." Perhaps he had in mind the adage, "A stitch in time saves nine."

To the best of my knowledge, no novel has ever been written or a movie made whose central theme was a flower, except perhaps the Black Tulip, which was based on a book with the same name written by Alexandre Dumas.

Orchid enthusiasm in the modern era began in England in the early 19th century, when British naturalist William John Swainson sent a bunch of orchid tubers from Brazil which he had used as weeds to package other plant specimens. But to everybody's utter surprise, these tubers grew and blossomed with beautiful flowers unknown to everyone at the time. This was also an era when colonialism was at its peak, providing colonial powers rights to the natural resources of their colonies to which they had easy and exclusive access. Queen Victoria appointed Frederick Sander as the official Royal Orchid Grower. This proves that even the royalty supported the plundering of the natural resources of their colonies which included their plants.

In some cases, owning and growing rare orchids in the personal greenhouses became an obsession. Consequently, rare species still remain prized and pricey.

In order to stop illegal international trade of wildlife, the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), became effective in July 1975. CITES is a global agreement among governments to regulate or ban international trade in threatened flora and fauna. Unfortunately, CITES could not stop some orchid sellers and enthusiasts from collecting the native orchids from the wild and endangering their future.

In developed countries, native orchids are protected by appropriate laws and can be sold only by the government designated nurseries. But uprooting the native orchids is a regular event in the developing countries where these plants are not adequately protected by the relevant authorities. Bangladesh is no exception in this regard. Currently, Bangladesh has approximately 150 or so orchid species that naturally grow in the wild. According to research published some three years ago, in the International Journal of Ecology and Environmental Sciences, 32 orchid species native to Bangladesh have become unavailable within its borders. In addition, some orchids are listed as endangered species and if not protected, there is a chance they may become extinct in the near future. There are two main reasons for this situation. First is rampant deforestation. Most orchids grow on bigger trees and simply cannot survive when the host trees are cut down. Second, there is widespread poaching of native and rare orchids.

Our native orchids are amazingly beautiful and they thrive in their natural habitat, where they get adequate sunlight, rain, and air. It is very difficult to grow orchid species in the artificial environment at home and there is a strong possibility that these orchid species would eventually perish. The sooner we understand that uprooting our orchids from their natural habitat is a direct threat to their future existence, the better it is for our native orchids.

We need awareness among people and stricter laws to avoid these dire consequences and save our native water pollution. But we must not our animals and, most importantly, our forests and native plants. This is a collective responsibility that we



Will the spark reignite Mohammedan?

Mohammedan have done the seemingly beating heavily-favoured Abahani in the final of the Federation Cup on Tuesday to end a barren run stretching nine years. It has evoked widespread euphoria among the club's supporters and former players, with some referring to the success as a turning point in the fortunes of the most decorated football club in the country.

Ever since Kamrul Islam scored the winning spot-kick at the Shaheed Dhirendranath Dutta Stadium in Cumilla, a festive vibe has engulfed the club. Players and coaching staff returned to the capital late that night to a heroes' welcome from the club officials, who arranged a small party, which continued well into Wednesday afternoon.

Despite the financial trouble dragging Mohammedan back in recent times, the club's management announced a Tk 40 lakh bonus for the team while its football committee chairman Ghulam Mohammad Alamgir announced an added bonus of Tk five lakh for captain Souleymane Diabate and Tk two lakh each for the two goalkeepers -- Sujon Hossain and Ahsan Habib.

Imtiaz Sultan Jonny, a famed defender for the Black and Whites in the '80s, reflected on how big the achievement is, after the victory. "We ended Bashundhara

Kings' unbeaten streak and then became ahead step by step." champions by beating Abahani, so it's a big deal," Jonny told reporters. "We will have to win the league now and this title will surely motivate.

The victory is evidence of the progress that the club has made under the new committee following the casino scandal in 2019. Rumman Bin Wali Sabbir, a magical playmaker during the '80s and '90s, recalled the resurgence: "After the casino scandal, the ex-players have taken the responsibility of the club under late Badal Roy's leadership and we are moving

While Alfaz Ahmed has turned the tide since taking over as coach midway through the season, continuing the good work may prove to be a far more difficult task.

It may be noted that although Mohammedan failed to win a single league title since the start of the professional league in 2007, they won a number of cup titles, including two out of the three Super Cups between 2007 and 2014. Even lesser clubs like Arambagh and Farashganj have won Independence Cup during that time, but a league triumph is a different ball game altogether.

To challenge for the league title against big-spenders such as Bashundhara Kings and Abahani, the team will need long-term investment, depth and quality in its squad, a good environment and other facilities, many of which Mohammedan may be lacking at present.

Alfaz, who has steered the team to fourth position in the league with four games remaining, said he needed reinforcements to turn this team into a force that could challenge for the league title next year.

"I haven't signed a new contract with the club yet. If the club wants to keep me and if I stay with the club, I'll definitely want to have a squad capable of putting up a title fight," the former national forward told The Daily Star yesterday.

"I hope the club management realises that too and forms a strong squad for next season. There will need to be more investment and planning and I will need a few new players too," the 49-year-old added.

Despite losing much of its relevance in the recent past, the latest Abahani-Mohammedan derby showed that it can still reignite the passion among fans like the good old days. And fans of both clubs along with the neutrals will hope that Mohammedan do return as a force in domestic football once again to bring back the appeal of domestic football.

Hosts in disarray against Windies A

Bangladesh A were in a state of disarray in Sylhet as they slumped to 157 for seven at the close of the second day in the third four-day game against West Indies A in response to the visitors' firstinnings total of 445.

From there, the slump began. Mominul departed after scoring five before Zakir was run out for 29. Saif Hassan's innings lasted 68 deliveries during a team-high 32 while Sohan produced 28.

It took some rear-guard action from pacer Tanzim Hasan Sakib and Nasum, unbeaten on 17 and seven respectively, to get through to the end of play with the A side now staring a defeat, still 228 runs behind.

"We haven't batted well at all. The wicket is good and did not offer much help [to the bowlers] with little seam movement on offer. We just didn't bat well," selector Habibul Bashar told The Daily Star yesterday.

AA: I made decisions independently, but I want to thank manager Imtiaz Ahmed Nakib and goalkeeping coach Sayed Hasan Kanon bhai, who provided me with good observations. The inclusion of assistant coach Abdul Kaiyum Sentu ahead of the second leg also boosted the coaching staff.

DS: What are your future plans?

AA: I am Mohammedan's coach for now, but I haven't been promised anything about next season. If I am given the responsibility, then I will place my plan to the management.

According to locals, despite warnings, the contractor kept piles of soil on the banks of the canal. Due to rain, some of the soil slid back into the canal hampering the piling work.

The accident happened when the soil on the banks fell on the workers who were removing it from the canal bed, the

The injured were taken to a local hospital for treatment, he added.

Some workers and locals said they have urged the contractor to move the soil from the bank fearing an accident. But the contractor didn't pay hid.

The UN Human Rights Council has included the demand for international recognition of genocide committed by the Pakistani forces and their associates against the Bangalees during the Liberation War of Bangladesh.

The demand has been included as agenda item 3 of the UN Human Rights Council's 53rd session from June 19 to

ÚN Secretary General Antonio Guterres received the statement issued by the Bangladeshi diaspora organisation, Stichting BASUG (Bangladesh Support Group), with special consultative status of the Economic and Social Council (ECOSOC) of the UN along with Aamra Ekattor, Projonmo '71, European Bangladesh Forum, and Seraji Foundation.

The statement, which reiterated the demand for the "International Recognition of the 1971 genocide", was circulated in accordance with ECOSOC resolution 1996/31 on May 29.

Not EC's job to make anyone win or lose

CEC tells election officials in Khulna city

Chief Election Commissioner Kazi Habibul Awal yesterday said it is not the responsibility of the commission to make any candidates win or lose.

While briefing officials of Khulna City Corporation polls, he said the EC's job is to ensure that voters can cast their votes

"Who is winning or losing the polls is never an issue of

the commission. We will need to ensure that no voters face obstruction while he or she is exercising voting rights," the CEC said at the event at Khulna Government Girls' College auditorium ahead of the city polls on June

He asked police and the local administration to make sure that every voter can go to the polling centres and vote without fear.

The CEC said elections should be held in a way that there remains no distrust among people. People have to believe polls will be free and fair.

He said the biggest responsibility of elections is on presiding officers. "You should take necessary steps so that things like scuffles cannot break out at polling centres and law and order remains under control.' You have the legal power if any such situation arises.

When you think voters cannot exercise their voting rights properly, you can stop the voting at polling centres temporarily and permanently," he said.

Sadiq's men on campaign trail, but only barely

AL nominee getting half-hearted support from them

Awami League central leaders' bid to get the current Barishal mayor's men to join the campaign trail of the party's mayor nominee Abul Khair Abdullah is not delivering the desired outcome.

Amid pressure from party high-ups, supporters of Mayor Serniabat Sadiq Abdullah began a half-hearted and disunited campaign for Abul Khair, who is Sadiq's uncle, on Tuesday, the fifth day of electioneering.

The city goes to polls on June 12.
The way Sadiq's followers have been acting at the campaign for Khair has been is uninspiring

and disjointed. They even printed and distributed their own leaflets just for show, said sources in both factions. Locals and party insiders said Sadiq's followers campaigned for just about

an hour yesterday. On Tuesday, they distributed leaflets that were different from the ones from Khair's camp. On Tuesday and yesterday, Sadiq's

followers campaigned for the sake of campaigning, they said. Khair's lovalists alleged that the faction

loyal to Sadiq was electioneering because their arms have been twisted. Afzalaul Karim, chief polling agent of

Khair, told The Daily Star, "It took around a month and a half to hold the extended meeting [for making the factions work together]. Why? Thanks to them [supporters of Sadiq] for finally joining the campaign. They only distributed leaflets in Sadar Road area but they had no activity in the wards."

During a views-exchange meeting with Jubo League leaders on Tuesday, Khair said, "Forty days have passed but still I have not gotten cooperation from many ... got resistance from many. Ignoring the instructions of our leader Sheikh Hasina would be suicidal [for them]."

Faizul Haque Faiz, the Sadiq-led faction's point

person for Khair's campaign, said they campaigned in areas close to their offices and could not go far due to the hot and humid weather.

Echoing Faiz, Sadiq's ally Talukdar Mohammad Yunus, general secretary of Barishal district AL, said, We have already given leaflets for distribution in the

According to locals, banners asking for votes for "boat", the AL's electoral symbol, could not be seen in wards that have pro-Sadiq councillors.

Kohinur Begum, a councillor aspirant for wards 7, 8, and 9 reserved for women, even alleged that Sadiq

loyalists wearing badges of the "boat" were seeking votes for the Islami Andolon Bangladesh mayor nominee.

During a visit to wards 2, 7, 8, and 17, activists belonging to the Sadiq-led faction were hardly seen campaigning.

Sources in Khair's camp told this newspaper that they do not expect Sadiq's followers to campaign wholeheartedly and they have already taken up an alternative campaign strategy. "We have formed ward-based

monitoring committees to see if the activists are carrying out their responsibilities properly," said Afzalul. Leaders and workers of Barishal AL fear

disaster on election day as the two factions are not working together.

Ever since the AL on April 15 picked Khair, Mayor Sadiq has been trying to keep his firm grip on Barishal as Khair has been gaining strength, locals and AL insiders said.

107m-year-old Pterosaur bones found in Australia

Pterosaurs, the world's oldest flying reptiles once flew in Australia's skies as far back as 107 million years ago, according to a study published

Palaeontologists came to that conclusion after examining two pieces of prehistoric bone extracted from Dinosaur Cove - a fossil-bearing site in the Australian state of Victoria – more than three decades ago.

The samples turned out to be the oldest remains of pterosaurs ever recovered from the country, according to the study published in science journal History Biology yesterday. The giant creature was the first vertebrate to

evolve the ability of flight and lived alongside dinosaurs during the Mesozoic Era which started 252 million years ago.

Experts from the Perth-based Curtin University and Museums Victoria, in Melbourne, examined bones from two individuals, including a wing bone belonging to the first juvenile pterosaur ever reported in Australia.

A piece of pelvis bone was found to have come from a pterosaur with a wingspan exceeding two metres (6.5 ft). Some pterosaurs had wingspans of more than 10 metres (33 ft).

Army suspends ceasefire talks with rival force

Sudan's army suspended talks with a rival paramilitary force yesterday over a ceasefire and aid access, raising fears the six-week-old conflict will push Africa's third largest nation deeper into a humanitarian crisis.

The general command of the armed forces said in a statement it suspended talks in the Saudi city of Jeddah, accusing the other side of a lack of commitment in implementing any terms of the agreement and a continuous violation of the ceasefire.

The negotiations with the Rapid Support Forces (RSF), which began in early May, had produced a declaration of commitments to protect civilians and two short-term ceasefire deals, although those deals were repeatedly violated.

Residents had reported heavy clashes in southern Khartoum and in Omdurman across the River Nile until late on Tuesday.

The army, which relies on airpower and artillery, and the RSF, a more lightly armed force but a tough adversary in Khartoum street battles, had agreed to extend a week-long ceasefire deal by five days just before its Monday expiry.

Army chief Abdel Fattah al-Burhan, a career military officer, and RSF General Mohamed Hamdan Dagalo, a former militia commander known as Hemedti, have been locked in a battle for power since April 15. Neither side seems to have an edge.

"We do not want to use lethal force. We still haven't used our maximum strength .. We don't want to destroy the country," Burhan said in a military video released on Tuesday, speaking to cheering forces at a military base with a gun slung on his

"But if the enemy does not obey and does not respond we will be forced to use the strongest force we have." he said.

The RSF said in a statement late on Tuesday it was committed to the ceasefire SEE PAGE 6 COL 4
