## Relief for rich, burden on low-income people

The minimum tax will be a burden for low-income people and it contradicts the concept of tax-free income, said Muntaseer Kamal, a research fellow at the Centre for Policy Dialogue.

People already have to spend money while submitting the income and expenditure statements because they have to hire someone to handle the complicated paperwork, he said.

He, however, welcomed the decision to raise the annual tax-free income threshold. "This will provide some much-needed comfort to the low- and limited-income people amid the soaring prices of essentials."

The government should rather raise taxes for the highest earners. "It must be remembered that this rate was lowered to 25 percent from 30 percent in 2021... Doing this will promote the cause of tax equity."

He is also of the opinion that the proposed surcharge-exempt wealth may reduce the number of taxpayers.

"The surcharge is calculated based on the purchase price of an asset, not its current market price, which tends to be significantly higher. This implies that the asset owners are already paying less in taxes than they should be. Given

## Global swoop nets more than 200 suspected traffickers

A huge operation targeting human traffickers across 44 countries has netted 212 suspects and identified almost 1,500 victims, many of them children, EU policing agency Europol said yesterday.

The Austrian and Romanianled Operation Global Chain took place between May 8 and 15 and included police, immigration, and border authorities as well as child and social protection services, Europol said.

The operation focused on "organised crime groups involved in trafficking in human beings, in particular child trafficking, sexual exploitation, forced criminality and forced begging," it said in a statement.

The swoop, in which some 1.6 million people were checked, 25,400 locations and 153,500 vehicles were searched, looked at traffickers exploiting victims from South America, Asia, Africa, the western Balkans and

# President of ex-Pak PM's party arrested

The president of former Pakistani prime minister Imran Khan's party was arrested in the eastern city of Lahore yesterday on charges of corruption, a government official said.

Pakistan is beset by political turmoil as Khan's party has faced a countrywide crackdown since his own arrest on May 9 for suspected graft sparked widespread protests that saw mobs ransacking state installations, including military

Pervez Elahi, president of Khan's Tehreek-e-Insaf party, joins a long list of key PTI leaders arrested in the security swoop to halt turmoil that has threatened to worsen instability in a country reeling from a crippling financial crisis.

"Pervez Elahi is wanted in several corruption cases," Amir Mir, caretaker information minister in the eastern province of Punjab, told

Reuters. He added that Punjab's anti-corruption department had been looking for Elahi for several

Elahi previously accusations of corruption.

Khan was freed on bail on May 12 for an initial two weeks, obtained a three-day bail extension from a high court and later a further extension from the trial court until June 19.

Dozens of top and mid-tier leaders in the PTI have been arrested alongside hundreds of Khan supporters since the violent protests of May 9. Many have quit the party after being released while other leaders remain on the run to avoid arrest.

Khan, who denies wrongdoing, says the arrests are part of a campaign to dismantle his party and that the state is using pressure tactics to force out his aides. The government denies this and savs his aides were leaving of their own

### Rise far from enough

Echoing Sen, economist Rizwanul Islam, said the coverage, even after the proposed increase of its size, is small considering the total number of eligible beneficiaries.

"The amounts allocated per beneficiary are woefully inadequate," said Islam, former special advisor, Employment Sector, International Labour Office, Geneva.

"They think that the poor people have been reduced to a great extent and ultra-poor people have almost not existed in the country," he said adding that the budgetary allocation for social security programmes
