# Unfit buses rule city streets

22pc of them running without fitness clearance

More than one in five buses of private operators running in the capital have no valid fitness certificates.

According to the data from the Bangladesh Road Transport Authority,

3,974 buses of 75 companies have the required route permits for operating in Dhaka city, but 871 of the buses, 21.92 percent, do not have fitness clearances.

The Daily Star has obtained a document, containing the data, that was placed before a meeting at the headquarters of Bangladesh Road Transport Authority (BRTA) on May 5 where many bus owners were present.

In reality, over 120 operators run more than 5,000 buses in the capital. And many of the vehicles do not have route permits and they ply the city streets allegedly by bribing, say transport sector insiders. On October 13 last year, Dhaka South City Corporation Mayor Sheikh

Fazle Noor Taposh said over 1,600 unauthorised buses were operating in the city despite an ongoing drive against such buses. The issue of unauthorised buses was discussed last month at

the meeting of the coordination committee tasked with bus route rationalisation and operating buses under companies. The government in 2019 formed a committee to rationalise bus routes

and have a limited number of bus service providers. So far it has managed to launch the system in three of the 42 reshaped routes. Member secretary of the committee, Shabiha Pervin, also executive director of Dhaka Transport Coordination Authority, said Hanif Paribahan, which was supposed to operate on route-23, expressed

disinterest as many unauthorised buses were running there, meeting

Route-23 starts from Ghatarchar and ends at Chattogram Road via Shyamoli, College Gate, Asad Gate, Kalabagan, Science Lab, Shahbagh, Jatiya Press Club, Gulistan, Dainik Bangla, Kamalapur, Dhalpur, Jatrabari, Shanir Akhra, Raverbagh, Matuail, and Signboard.

Transport expert Prof Hadiuzzaman said unfit vehicles are risky for

other fit vehicles too. The former director of the Accident Research Institute at Buet said pedestrians in Dhaka are more vulnerable and such unfit vehicles increase their risk. The vehicles are causing serious environmental pollution, he told The Daily Star yesterday.

He said drivers of unauthorised vehicles know that they have a strong clout that allows them to run illegal vehicles and that is why they drive

Khondaker Enayet Ullah, general secretary of the Dhaka Road Transport Owners' Association, admitted that there were buses on the streets without fitness certificates.

"But how will the association know which buses have no fitness clearances? The BRTA has the data and it can take action against those,' he told this newspaper.

## **LOAD SHEDDING** Situation improves as mercury falls Electricity demand drops;

rain brings relief from heat

People had a bit of relief yesterday after light rain in places across the country, including the capital, brought down temperatures amid the heatwave leading to lower electricity demand and less frequent power cuts.

There was no improvement in power generation. As of 9.00pm yesterday, the average load shedding was 1,500MW per hour against the demand of 15,200MW. The highest generation per hour was 14,655MW.

There was no load shedding in Dhaka after day peak at noon

The average load shedding was between 2,500MW and 3,000MW over the last couple of weeks.

At least 51 power plants are facing fuel shortages.

Power supply from India's Adani Power Plant was disrupted for at least 13 hours after a part of its transmission line in Chapainawabganj tripped and caused more power cuts between Wednesday afternoon and early yesterday

# **Income tax bill** targets wealth stashed abroad

People with properties abroad stand to face a penalty equal to their fair market value if the tax office can detect those, as per the Income Tax Bill 2023.

Drafted in Bangla, the bill, which was placed in the parliament vesterday by Finance Minister AHM Mustafa Kamal, will replace the existing Income Tax Ordinance 1984.

The tax officials will also be able to run enquiries at home and abroad if they have logical grounds to believe that the individuals are stashing their wealth outside of Bangladesh.

Not just that, the National Board of Revenue will be able to realise unpaid taxes by selling the properties abroad even if the assets are owned by another person on behalf of the taxpayer.

The proposed law authorises the NBR to take appropriate actions as it thinks fit and makes it mandatory for those with properties abroad to file assets and liabilities statements.

On paper, the proposed law can deter money laundering. Whether it succeeds depends on the supporting measures taken to make the law robust.

The law has been framed to ease the process of doing business and cut the number of returns that companies need to file from 29 to 12, Kamal said.

"The bill seeks to reduce the discretionary powers of tax officials as

much as possible.' The proposed law has incorporated international best practices to ease tax compliance and file tax returns, Kamal said, adding that it will also thwart prevent tax avoidance from taking place through various types of arrangement.

Filing tax returns and proof of submission would become mandatory for availing 43 government services, up from 38 at present.

The draft law has expanded the scope of submission of income tax returns under self-assessment.

Taxpayers will not need to seek additional time should they fail to file returns beyond November 30. But they will face a penalty, said a senior official of the NBR.

The simplified refund process will enhance trust in the tax system since the tax refund will be credited directly SEE PAGE 2 COL 6

## **PESTICIDE POISONING** No one should lose children this way

Says father of 2 victims; MD, chairman of pest control firm remanded

STAFF CORRESPONDENT

"I want exemplary punishment of the people who are responsible," said Mobarak Hossain yesterday, who lost his two sons allegedly from pesticide poisoning.

The boys died after a pest control service provider used unauthorised pesticides in their house in Bashundhara Residential Area on Friday, Mobarak said.

Shayan Mobarrat Zahin, 15, a student of class-VIII, and Shahir Mobarrat Zayan, 9, a class-III student, died while undergoing treatment at a city hospital on Sunday.

'No parents should lose their children this way," he said with his voice choking.

"I just want to make sure that the criminals are not spared," Mobarak said, blaming the owners of DCS Organisation Ltd, the pest control service, for the deaths.

"The owners are responsible, not the workers. We always see workers being made scapegoats," he said.

# EC to make nat'l polls free, fair

It'll ensure no govt agency will file any case to harass anyone, law minister tells JS

In a bid to hold the upcoming general election in a free and fair manner, the Election Commission has decided to ensure that no government agency will file any case to harass anyone, Law Minister Anisul Huq said yesterday.

The commission will send a proposal to the government so that all the political parties can carry out election campaigns unhindered. Besides, immediate actions will be taken as per the law if a candidate or their supporters launch attacks on rival

candidates and their followers, or their homes and businesses, he said. In reply to a question from

Gonoforum MP Mukabbir Khan from Sylhet-2, the minister said, "The Election Commission has taken up the challenge to hold the election in a transparent, free, fair and peaceful manner."

In his scripted Mukabbir asked the minister whether the EC has any special plan to hold the 12th national polls in a

free, neutral and acceptable atmosphere, without "showing allegiance to the government like the previous commissions did".

Anisul Huq, in his scripted answer, said since there is an obligation to hold the national election by January next year, the EC has taken up an action plan to this end.

The minister talked about measures that the EC has decided to take to overcome the challenges of holding a free and fair election.

Illegal arms will be recovered and legal arms will have to be deposited to the authorities concerned before the polls, he said while describing the measures.

Stage protests at Cox's Bazar refugee camps


Tens of thousands of Rohingya refugees in Cox's Bazar protested demanding to repatriated to Myanmar, so that they could leave the squalid camps they have lived in since fleeing a brutal military crackdown in their homeland in 2017.

More than a million Rohingyas have been crammed into the camps in southeastern Bangladesh, the world's largest refugee settlement. Most fled the crackdown by Myanmar's military almost six years ago, although some have been there for longer.

## Bangladesh avoids being 'red-listed' by Saudi Arabia

Bangladesh avoided being put on the "red list" by Saudi Arabia as private hajj agencies completed visa processing of 85 percent hajj pilgrims before the June 7 deadline set by Riyadh.

Saudi Arabia also said the Bangladesh Hajj Office will have to bear all the responsibilities if it fails to meet the target.

The religious affairs ministry on June 6 in a notice informed all 603 private hajj agencies about it and instructed them to take necessary measures.

In a notice released yesterday, the religious affairs ministry said 85 percent visas of hajj pilgrims have been completed within the deadline.

Hajj Agencies Association of Bangladesh (HAAB) President M Shahadat Hossain Taslim said there was no more complication regarding the issuance of visas.

## UN probes Israel expulsion of human rights lawyer

## EC to make

The EC will implement the recommendations--which go in line with the constitution and electoral laws--that the majority of eminent citizens and political parties have made in view-exchanging meetings, according to the minister.

Adequate members of law enforcement agencies will be deployed to maintain a normal atmosphere in polling centres and constituencies while executive and judicial magistrates will be appointed to strictly enforce the electoral code of conduct and take legal action against any violators, he said.

The EC will treat all candidates equally, he said, adding that necessary amendments will be made to the Representation of the People Order and also the electoral code of

The other measures include holding meetings with the heads of various ministries, divisions, departments and law enforcement agencies, which are involved in holding the election, and giving directives so that they carry out their responsibilities sincerely and impartially during the election.

In order to keep the election process transparent, the commission has decided to publish all the activities related to the election on its website for everyone and to invite local and foreign observers.

The EC has decided to provide scopes for electronic and print media to gather information freely, he said.

The law minister said the EC is determined to ensure that the election results are acceptable to all voters and most of the political

The EC will appoint qualified officers from the commission as returning officers and presiding officers.

Besides, it will take action against election officers if there are proofs of their bias, the minister said.

# Unfit buses rule city streets

He said owners of some 1,500 buses sought route permits a few years ago and the regional transport committee had even recommended the permits be issued.

But the coordination committee in 2019 decided not to issue route permits anymore, which made the 1,500 buses illegal, he said.

He refused to comment on the allegation that the illegal buses were running by paying bribes.

Most city buses operate on "trip system", in which the owners receive a certain amount of money for a set number of trips the drivers make. The drivers and their helpers get to keep all money earned from any trips beyond the set number. This system promotes racing on the streets, one bus cutting off another, buses blocking streets to

prevent being overtaken by another bus, and picking up of passengers here and there, experts said.

This is why transport experts had recommended rationalisation of bus routes and bringing all public buses under a fixed number of companies for better regulation.

Late DNCC Mayor Annisul Huq had taken the initiative. Later, the government in September 2018 formed a committee, led by the DSCC mayor, to introduce the system and rationalise the routes.

preliminarily The authorities decided to have 22 companies running 42 routes.

On December 26, 2021, the new system was launched with Nagar Paribahan on one route. In October last year, Nagar Paribahan started operating on two more routes.

# **Traders still** reluctant to move

Traders of Karwan Bazar are reluctant to shift to Jatrabari and Gabtali as they believe the areas are unsuitable for running their business.

They made the comments at a discussion yesterday held at TCB auditorium, demanding that authorities concerned ensure better facilities at the Karwan Bazar instead of shifting them to the new

However, Dhaka North City Corporation Mayor Md Atiqul Islam, who chaired the discussion, said the kitchen market must be shifted to the new locations, which will soon turn into a safe, modern market.

"It cannot be run in the middle of the capital, it should remain at the city's periphery," he said.

"No one will be jobless, rather their security will improve if they go there where there is sufficient space," he said.

The mayor formed an 11-member committee, incorporating three councillors, traders, and city corporation officials, to present the status quo regarding the issue within the next 15 days.

He said it's his obligation to shift the market as it's the prime minister's directive and the project was approved by Ecnec.

"Karwan Bazar market is risky, it may collapse anytime, and you will have to take responsibility," he added.

Atiqul said his office received a letter from the Dhaka divisional commissioner's office to remove eight risky markets immediately and following this they put up signboards there. But those were removed.

"Who will take responsibility if any accident occurs?" he asked. "It is important to give security of life and goods to both sellers and customers and we will have to work together for this," the mayor said.

"You may say its design is faulty but sit with me and give me your suggestions. We will address it. However, the buildings have already been constructed," he said.

historical facts are being distorted under the guise of religious education in many institutions, which is unacceptable.' "However, enforcing the national curriculum on Qawmi madrasas

is not the solution. We need to discuss the issues with the Qawmi madrasa authorities and make proper changes to the curriculum, if they demand," she added.

The minister also said it is the responsibility of the state to support and ensure that the madrasas are not left behind.

Author and educationist Prof Muhammed Zafar Iqbal said all educational streams must be brought under the watch of the government. "Qawmi graduates are yet to be the perfect human resources, as we cannot utilise them in job sectors. They should be taken under the mainstream education," he added.

Speaking at the programme, educationist Shyamoli Nasrin Chowdhury said, "We need to prepare a proper education system to include madrasa students to a skilled population."

# Facebook now a market for fake notes

Say police; dealers take to social media platform to advertise, sell counterfeit currency

"We have original, glazing print and a perfect product with security thread and watermarks that are almost undetectable in bare eyes," reads a part of an advertisement recently posted on Facebook to sell fake notes.

A Facebook user named "Jal Takar Dealer", in the same post also mentioned they deliver counterfeit notes across the country.

However, this user is not a lone "dealer".

Law enforcers said they have identified at least 50 Facebook users, pages or groups, where such advertisements are frequent, namely Jal Taka, Jal Taka Bikrir Dealer, Jal Taka Asol Dealer, A great-(Jal Taka), Jal Taka Bikri Kori, Jal Takar Babossa.

On June 4, a potential buyer of fake notes, Mohammod Rokibul Ahmed Rakib (according to his Facebook ID) commented on the said post and asked for a contact number, to which, the dealer replied with a number.

This correspondent called the number on Sunday night when the seller brazenly said he would supply fake notes anywhere in Dhaka or other districts without any hassle

"You can pay cash on delivery. However, you don't need to pay in advance. Just the delivery charge would do -- Tk 180 inside Dhaka and Tk 300 for elsewhere," he said. Other advertisers often take 50 percent of the

payment in advance. They ask the potential buyers to contact them on Facebook Messenger or the WhatsApp number shared with their posts. Some of these accounts have several thousand friends. The pages have over 2,000

followers, while there are over 3,000 members in a Facebook group used for selling fake notes. The sellers share photos and videos of the fake notes in their posts. They also share screenshots,

featuring satisfied customers, thanking them

for delivering the package without any hassle.

When this correspondent went undercover to contact these dealers on messenger apps, one of them claimed that he used the notes himself and confirmed that it cannot be detected without machines.

The seller also shared a screenshot of his communication with other customers. He demanded 50 percent of the payment in advance before sending the fake notes via courier service.





There are countless profiles on Facebook like this one that claim to sell fake notes.

The sellers advertise selling 1,00,000 fake notes of Tk 1,000 -- ranging from Tk 12,000 to Tk 20,000 -- based on the quality. The same amount of Tk 500 notes was being sold at a range from Tk 14,000 to Tk 20,000. Several were seen advertising fake notes of Tk 20, saying this note is easy to inject into the market as people usually do not bother to check it.

Law enforcers said that most of the online fake note sellers are frauds, as after getting the delivery charge or partial payment, they stop all communication with potential buyers on multiple occasions.

Police arrested at least five people involved with the online sale of fake notes.

"If the offline fake note sellers join hands with the online sellers, the situation may turn alarming," said a mid-ranked official of Dhaka Metropolitan Police, seeking anonymity.

# AL trying to mislead people Alleges Fakhrul on dialogue over election

# NID correction to be made easy

The Election Commission has moved to ease the hassle for people in correcting information on National ID Cards.

EC officials prepared a draft Standard Operating Procedure (SOP) which will make it easier for fixing NID corrections. It has re-designated officers' jobs and proposed increasing the powers of field officers of the EC to correct NID information.

The SOP also made the jobs of officials specific.

The draft SOP was placed before a meeting of election commissioners chaired by Chief Election Commissioner Kazi Habibul Awal yesterday.

"The meeting in principle approved the SOP, and they would finalise it after holding further discussions," NID Wing Director General A K M Humayun Kabir said after the meeting.

Earlier in late May, the draft of the SOP was finalised proposing 20 additional regional officers should be given the authority to categorise the applications for correcting NID cards.

At present, the process is done centrally. The draft of the SOP also proposed

that district election officers will be able to correct the mistakes of names of parents of NID card holders. Currently, regional election officers are authorised to bring such changes.

District election officers will be able to take decisions about applications seeking a change of date of birth for a maximum of seven years, while additional district election officers will be able to settle applications seeking a change of date of birth for a maximum of five years.

Additional district election officers will be able to take decisions about applications regarding change of marital status, names of spouses as well as religion. Till now, additional district election officers had no authority regarding the correction of NID cards.

The SOP proposed that the regional election officer will be able to take decisions regarding applications seeking a change of the full name of the national identity card holder. Currently, the Director General of the NID wing can take such a decision.

## HC justifies three sections of Vested Property Return Act

The High Court yesterday justified three sections of the Vested Property Return Act, 2001 regarding government's authority to prepare list of vested property, relevant tribunals' jurisdiction to dispose of cases relating to such properties and deputy commissioners' power to maintain and leasing those properties.

The court said the sections 9, 13, and 14 of the act are not contradictory to the constitution and fundamental rights of the citizens.

However, locals and civil society members do not consider the 2018 election valid due to massive irregularities that marred the election.


Independent mayoral candidate Md Kamrul Ahsan Rupan, son of former

## Non-govt post graduate trainee physicians demand Tk 50,000 stipend

Non-government postgraduate resident trainee physicians yesterday demanded an increase in their monthly stipend from Tk 20,000 to Tk 50,000, since they believe their current salary is insufficient to cover their living expenses.

They presented their demands at a press conference held in the capital's Jatiya Press Club.

'Government physicians, with the same qualification receive a monthly salary of Tk 42,000, more than twice the salary we receive for the same duties," said Dr Habibur Rahman Suhag, a non-government resident surgeon at Chattogram Medical College.

By default, Bangabandhu Sheikh Mujib Medical College (BSMMU)

pays the allowance on behalf of the government.

We did not receive any response from BSMMU authorities in the last two days. We will enforce a strike if the demands are not met by June 12," Suhag added.



Now he is earning several lakhs of taka every year.

Moreover, his success is inspiring many youths of the area to start Sharifa farming on commercial basis.

Shafique said demand for the tasty and nutritious fruit Sharif is increasing day by day.

While talking, a college teacher, who came to see the orchard, said being inspired by Shafique's success he has prepared two bighas of land for Sharifa farming.

The Argentine has been reportedly also offered a share of the revenue generated by new subscribers to MLS Season Pass, the league's streaming package, and entered a profit-sharing agreement with Adidas which would involve the player receiving a cut of any increase in Adidas' profits resulting from his involvement in

Barcelona had been forced to let Messi go in 2021 due to financial constraints stemming from their inflated wage bill and those same issues kept the Catalan club from securing a fairytale return by giving Messi the assurances that he sought.

Any move to Catalonia would have taken a lot longer, considering that the club were about 200 million euros over La Liga's salary cap and remain unable to register new contracts. Barcelona would have to sell several players just to get their books balanced well enough to offer Messi a contract that would likely pay him a fraction of what he stands to earn now. Whether they would have been able to do so remains up for debate, although started making thev headway by announcing several departures.

"I really wanted and was very excited about being able to return [to Barcelona]. But on the other hand, after experiencing what I experienced and the way I left, I didn't want to be in the same situation again: waiting to see what would happen and leaving my future in someone else's

hands," Messi admitted. "I was accused of a lot of

things during my career at Monday of his decision to Barcelona and I was a little bit tired of it, I didn't want to go through all of that again. When the time came when I had to leave, La Liga had agreed for the club to register me but in the end, it wasn't to be. I was afraid that the same thing might happen, and I would be left in the lurch.

"I wanted to make my own decision and that was partly why I decided against going back to Barça. I would have been delighted to if it had been possible, but it wasn't," he continued.

The Inter move dealt a great blow to Barcelona fans in Bangladesh as well. who hoped that Messi, following his 2022 World Cup triumph, would finish his career at what the player himself described as 'the

club of his life'. Barcelona president Joan Laporta gauged the public's pulse and decided to play to the same tune. On several occasions, he catered to the dream return for Messi, but would always leave out the details of how the club would manage the Argentine's signing.

"After winning the World Cup and not being able to go to Barca, it was time to go to the U.S. league to experience football in a different way and enjoy the day-to-day," Messi said.

"Obviously with the same responsibility and desire to want to win and to always do things well. But with more peace of mind."

"If it had been a question of money, I would have gone to Saudi Arabia or elsewhere where they offered me a lot of money," Messi said.

Barcelona said in a statement that Messi's father and agent had informed the club on move to America instead of

returning to Spain. "Barcelona president (Joan) Laporta understood and respected Messi's decision to want to compete in a league with fewer demands, further away from the spotlight and the pressure he has been subject to in recent years," the La Liga side said.

Barcelona coach Xavi Hernandez said Thursday he understood Lionel Messi's desire to avoid the "pressure" of a return to the Catalan giants this summer. "He hasn't had a good time in these two years (in Paris) and now he doesn't want that type of pressure," Xavi said on Twitch.

# 37 Chinese warplanes cross into Taiwan's ADIZ

## Taipei activates air defence systems

Taiwan yesterday activated its defence systems after reporting 37 Chinese military aircraft flying into the island's air defence zone, some of which then flew into the western Pacific, in Beijing's latest mass air incursion.

China, which views democratically governed Taiwan as its own territory, has over the past three years regularly flown its air force into the skies near the island, though not into Taiwan's territorial air

Taiwan's defence ministry said that from 5:00 am it had detected 37 Chinese air force planes, including J-11 and J-16 fighters as well as nuclear-capable H-6 bombers, flying into the southwestern corner of its air defence identification zone, or

The ADIZ is a broader area Taiwan monitors and patrols to give its forces more time to respond to threats.

Some of the Chinese aircraft flew to Taiwan's southeast and crossed into the western Pacific to perform "air surveillance and long distance navigation training", the ministry said in a statement.

Taiwan sent its aircraft and ships to keep watch and activated land-based missile systems, it added, using its standard wording for how it responds to such Chinese activity.

China's defence ministry did not immediately respond to a request for comment.

China completed a second phase of joint air patrols with Russia over the Western Pacific on Wednesday, following flights on the

previous day over the Sea of Japan and East China Sea, prompting concern in Japan over its national security.

Laura Rosenberger, chair of the American Institute in Taiwan, which manages the unofficial relationship between Washington and Taipei, is visiting Taiwan this week.

On Monday, she told Taiwan media that the United States had an enduring interest in preserving stability in the Taiwan Strait and the United States would continue to arm the island, a source of constant friction in Sino-U.S. ties.

In April, China held war games around Taiwan following a trip to the United States by Taiwan President Tsai Ing-wen.

# FRENCH ALPS Four children hurt in knife attack Suspect, a Syrian asylum seeker,

A man armed with a knife stabbed four preschool children and injured two adults by a lake in the French Alps yesterday in an attack that sent shock waves through the country.

A police spokesman said the attacker was a 31-year old Syrian asylum seeker who carried Swedish identity documents and a Swedish driving license. He entered France legally and was not known to security agencies.

Video of him taken by a bystander in Annecy, a town 30 kilometres (20 miles) south of the Swiss city of Geneva, shows him dressed in a black long-sleeved shirt and shorts while holding a small blade.

Witnesses described the knifeman running around a public park on the banks of Lake Annecy in a frenzy, apparently attacking people at random, before he was shot by police.

"He wanted to attack everyone. I moved away and he lunged at an old man and woman and stabbed the old man," former footballer Anthony Le Tallec, who was running in the park, told the Dauphine Libere newspaper.

The suspect did not appear to have a "terrorist motive", the local prosecutor said.

Line Bonnet-Mathis also said that of the four children injured in the assault, one was aged just 22 months, two were two-year-olds, and the eldest was three.

# World warming at record 0.2C per decade

50 top scientists warn in a sweeping climate science update

Record-high greenhouse gas emissions and diminishing air pollution have caused an unparalleled acceleration in global warming, 50 top scientists warned yesterday in a sweeping climate science update.

From 2013 to 2022, "human-induced warming has been increasing at an unprecedented rate of over 0.2 degrees Celsius per decade," they reported in a peer-reviewed study aimed at policymakers.

Average annual emissions over the same period hit an all-time high of 54 billion tonnes of CO2 or its equivalent in other gases -- about 1,700 tonnes every second.

World leaders will be confronted with the new data at the critical COP28 climate summit later this year in Dubai, where a "Global Stocktake" at the UN talks will assess progress toward the 2015 Paris Agreement's temperature goals.

The findings would appear to close the door on capping global warming under the Paris treaty's more ambitious 1.5C target, long identified as a guard rail for a relatively climate-safe world, albeit one still roiled by severe impacts.

"Even though we are not yet at 1.5C warming, the carbon budget" -- the amount of greenhouse gases humanity can emit without exceeding that limit

- "will likely be exhausted in only a few years," said lead author Piers Forster, a physics professor at the University of

That budget has shrunk by half since the UN's climate science advisory body, the Intergovernmental Panel on

Climate Change (IPCC), gathered data for its most recent benchmark report in 2021, according to the Forster and colleagues, many of whom were core IPCC contributors.

To have even a coin-toss chance of staying under the 1.5C threshold, emissions of carbon dioxide, methane and other drivers of warming generated mostly by burning fossil fuels must not exceed 250 billion tonnes (Gt), they reported.



Bettering the odds to two-thirds or four-fifths would reduce that carbon allowance to only 150 Gt and 100 Gt, respectively — a two- or three-year lifeline at the current rate of emissions.

Keeping the Paris temperature targets in play would require slashing CO2 pollution at least 40 percent by 2030, and eliminating it entirely by mid-century, the IPCC has calculated.

Ironically, one of the big climate success stories of the last decade has inadvertently hastened the pace of global warming, the new data reveal

A gradual drop in the use of coal -significantly more carbon intensive than oil or gas -- to produce power has slowed the increase in carbon emissions.

But it has also reduced the air pollution that shields Earth from the full force of the Sun's rays.

Particle pollution from all sources dampens warming by about half-a-degree Celsius, which means — at least in the short term — more of that heat will reach the planet's surface as the air becomes cleaner.

Published in the peer-reviewed journal Earth System Science Data, the new study is the first in a series of periodic assessments that will help fill the gaps between IPCC reports, released on average every six years since 1988.

"An annual update of key indicators of global change is critical in helping the international community and countries to keep the urgency of addressing the climate change crisis at the top of the agenda," said co-author and scientist Maisa Rojas Corradi, who is also the environment minister of Chile.

Co-author Valerie Masson-Delmotte, a co-chair of the 2021 IPCC report, said the new data should be a "wake-up call" ahead of the COP28 summit, even if there is evidence that the increase in greenhouse gases has slowed.

"The pace and scale of climate action is not sufficient to limit the escalation of climate related risks," she said.

Researchers also reported a startling rise in temperature increases over land areas -- excluding oceans -- since 2000.

"Land average annual maximum temperatures have warmed by more than half a degree Celsius in the last ten years (1.72C above preindustrial conditions) compared to the first decade of the millennium (1.22C)," the study reported.

# Ex-Pak PM gets bail on murder charges

Ousted Pakistani prime minister Imran Khan yesterday secured bail from the Islamabad High Court over new murder charges, blocking his arrest in that case for 14 days, his lawyer said. The ousted prime minister had been arrested on May 9 and held for three days, triggering violent protests by his followers. He is now free on bail in a range of other criminal cases. He had travelled to the capital from his Lahore home to seek bail in the murder case and extend his bail in over a dozen other crases, to avoid a new arrest, said Barrister Gohar Khan. The 70-year-old former cricket hero who become prime minister in 2018 has been embroiled in a confrontation with military since he was ousted in a no-confidence vote last year.

## Rohingyas testify on Myanmar crackdown

Members of Myanmar's Rohingya Muslim minority testified in person for the first time on Wednesday in Buenos Aires, as part of an Argentinian judicial investigation into alleged crimes by the Myanmar military, an activist told AFP. The hearing, behind closed doors, was "a historic day for everyone in Burma," as Myanmar is also known, said Maung Tun Khin, president of the British-based Burmese Rohingya Organisation UK. Meanwhile, Myanmar lawyers defending political detainees in juntarun courts are being harassed and even jailed by military authorities, HRW said yesterday.

# SUDAN CONFLICT Fighting rages at military site facility

Sudanese army soldiers and paramilitaries yesterday fought for control of a military facility in Khartoum where a fire raged at an oil and gas facility, witnesses said. The battles came a day after the powerful paramilitary Rapid Support Forces (RSF) announced in a statement they had wrestled "full control" of the Yarmouk weapons manufacturing and arms depot complex. Witnesses speaking to AFP from southern Khartoum said they heard the "sound of gunfire and clashes" around the complex, the most important military industrial facility in the country. # Trump target of classified docs probe

US prosecutors have told Donald Trump's lawyers that he is the target of a probe into his handling of classified documents after leaving the presidency, in a sign he might be indicted, US media reported Wednesday night. The notice came from the office of special counsel Jack Smith and gives clearest sign yet that prosecutors are moving closer to charging the former president, who has already been indicted in a separate case. The Times, citing "two people" said it was not clear when Trump's team had been told he was a target.

### India rebukes Canada over parade float showing Indira Gandhi assassination

India's foreign minister yesterday hit out at Canada for allowing a float in a parade depicting the 1984 assassination of Indian prime minister Indira Gandhi by her bodyguards, perceived to be glorification of

violence by Sikh separatists.
"I think there is a larger underlying issue about the space which is given to separatists, to extremists, to people who advocate violence," S. Jaishankar told reporters in New Delhi while commenting about the tableau in a parade.

"I think it is not good for relationships, not good for Canada," he said. Canada's High Commissioner for India also condemned the incident at a parade by Sikh activists in the Canadian city of Brampton.

Video circulated in recent days on the internet showed a tableau from the parade featuring Gandhi wearing a blood-stained white saree with her hands up as turban-clad men pointed guns at her.

## **Development must** be people-centred

Tangail bridge left in ruins for five vears requires urgent attention

The sorry state of affairs surrounding a bridge in Tangail serves as yet another reminder of the mismanagement and irregularities plaguing our development projects in general, and the negligence in ensuring quality control measures during construction in particular. According to a report, the 60-foot-long bridge, built five years ago, tilted under pressure from floodwaters just before its inauguration, and has been unusable ever since. This happened because of the use of substandard materials, poor workmanship and the lack of follow-through by both the contractor and the Ministry of Disaster Management and Relief, which had it built as part of a district wide bridge development project during FY 2016-2017.

The question is, why hasn't it been reconstructed in all these years? Reportedly, after partially demolishing the structure, the contractor abandoned the work, citing the end of the project period. It also received only a fraction of the payment owed, indicating financial irregularities and potential corruption. Whatever happened to prolong the wait for a functional bridge, for the local communities, its consequences have been dire. The lack of a bridge has forced them to undertake longer journeys to reach crucial facilities such as the upazila health complex. Farmers in the area are unable to transport their agricultural produce efficiently, resulting in financial losses. Students are facing difficulties commuting to and from educational institutions, especially during the rainy season.

It was only a matter of logic that the project authorities would finish what they had set out to do, but they chose to ignore it in the absence of any institutional accountability. This is totally unacceptable. In the past, we also have had reports of such infrastructure development projects being stalled halfway due to flawed designs and other reasons. These cases exemplify a broader pattern of development policy characterised by poor planning and execution as well as lack of accountability. This has to change. A development policy cannot be solely focused on short-term gains or political expediency. It must strive for long-term sustainability, with the safety and welfare of citizens at the centre of its focus.

We, therefore, urge the Ministry of Disaster Management and Relief to immediately undertake repairs to make the Tangail bridge operational. There is also an urgent need for a comprehensive system of checks and balances in all development projects to ensure that public money is utilised efficiently. Effective supervision is a must for the timely and successful completion of all projects.

## Our workers in Maldives deserve better

RMMRU survey reveals cases of poor pay, abuse and discrimination

While the sufferings of Bangladeshi migrant workers abroad are nothing new, a recent study by the Refugee and Migratory Movements Research Unit (RMMRU) has revealed a picture of hardship for those in the Maldives. Of the 120 current and 250 returnee migrants surveyed by RMMRU, 36 percent reported not being paid for overtime work. Documented workers earn an average monthly income of Tk 37,066 while undocumented ones earn Tk 25,650 - which might come as a surprise to those with a rosy vision of overseas earnings. On top of this, workers faced discrimination and abuse in multiple forms. For instance, around 38 percent of respondents said their employers had taken away their passports, while about half of both undocumented and documented workers faced workplace discrimination. Perhaps the most dehumanising treatment that they reported is physical or verbal abuse, which at least 18 percent of respondents suffered at one point.

Unfortunately, Maldives is not an exception – the plight of low-skilled Bangladeshi workers is quite similar in other destination countries, including Middle East, too. Wage theft, withholding of passports, discrimination, abuse of various kinds, and even threats of deaths are vulnerabilities that workers must contend with on a regular basis. Such injustices taking place in other countries may pose a challenge for us to address them. However, the onus is still on the government to ensure that our workers abroad are not abused or exploited. These people often have to pay a hefty sum to intermediaries (who make up an insidiously corrupt system) to get jobs there. Once there, they often work for inhumane hours for a relatively small amount, and then send whatever they can save back home. Through this uncompromising process, they give a boost to our economy.

It is, therefore, crucial that the government takes better care of our migrant workers, including those in the Maldives. It must ensure regular collaboration with the authorities of destination countries to ensure full compliance of labour rights, so that our workers can be protected from abuse and exploitation.

Diplomatic niceties aside, clouds have been gathering over our bilateral relations for a while. Over the years, through its annual State Department reports on human rights, the US has been indicating its rising unease with the rights conditions in Bangladesh. The situation came to a head with the issue of forced disappearances and extrajudicial killings that have

peaceful demonstrators, etc., many of which are grounded on facts.

But many are not. The allegations that "Since Sheikh Hasina's rise to power, the Hindu population has been halved. Looting and burning of households, destruction of temples and religious idols, murder, rape, and forced religious conversions are causing Hindus to flee Bangladesh.

Honestly, I find the latest visa policy of the United States for Bangladesh to be insulting. Free and fair elections are something we should ensure from our own sense of self-respect. Unfortunately, the truth is we have not done so on the past two occasions. Now we have been bracketed with

Nigeria - a perennially corrupt country whose elite have syphoned off billions for decades, neglecting their poor, which can be termed as "economic crimes against humanity" (a section of our elites have started doing so, too). The country is ethnically in shambles, with the terrorist group Boko Haram perpetrating the most heinous of crimes for years.

On the contrary, we nipped terrorism in the bud after the Holey Artisan tragedy. Our record in fighting poverty has opened many of our critics' eyes, and even US President Joe Biden has termed our economic progress exemplary.

The truth is, we have made a shambles of our elections and have weakened most of the accountability structures like the parliament, statutory bodies, legal infrastructure, etc. To ensure loyalty, we have filled vital institutions with political sycophants, and a section of the administration with careerists to whom competence is never a factor and integrity is only a feature of the fools. We have practically handed over the business world to loan defaulters, money launderers, and opportunists. Only deliberate and criminal neglect could have permitted a select few to loot our banks as they have. There are some honourable exceptions, and it is they who have held up our economy.

In no way can the government be accused of committing these "crimes." We urge the authors of the letters to acknowledge the factual errors and correct them.

However, the main question raised by the US visa policy remains on hand - making the upcoming general election free and fair, which is the universal demand of our people.

Regardless of what the world may duty to hold free and fair elections. This we must do for our own sake. for our people, and for our future. Let us admit that we made a farce of the process earlier, and our people will not accept a repeat of the past. We must do everything to correct our past mistakes. Let us also understand that we live in a globalised world where interdependencies rule, and finer economic calibrations must make space for other considerations.

We must also internalise the meaning of our own slogan "Digital Bangladesh." As we digitise, the world does too, and often much faster. This means that what we do is known to the world instantly. Just as a slight tremor in some remote corner of the world is known within a second, the slightest vote-rigging in some remote part of Bangladesh, too, becomes global knowledge in no time. Yes, we can shut down social and other media, but information will flow regardless, and all our claims will be tested against facts and our credibility will stand or fall against what that comparison brings out.

So we cannot hide, and we only fool ourselves by thinking that we can. We must truly and sincerely go for free and fair elections. Our future depends on it. We still have time to do so.

# The IEPMP serves Japan's interest over Bangladesh'

In light of widespread discussions to overcome the ongoing power crisis, **Hasan Mehedi**, chief executive at Coastal Livelihood and Environmental Action Network (CLEAN) and member secretary of Bangladesh Working Group on Ecology and Development (BWGED), speaks to **Ramisa Rob** of **The Daily Star** regarding the proposed Integrated Energy and Power Master Plan (IEPMP), and why it's a step in the wrong direction in terms of Bangladesh's renewable energy goals.

#### What is the IEPMP and what are the which will take Tk 269 per kg nowadays. fuels. But there is also strong interest main concerns about it?

The Institute of Energy Economics, Japan (IEEJ) is currently formulating the Integrated Energy and Power Master Plan (IEPMP) for Bangladesh with assistance from the Japan International Cooperation Agency (Jica). With the ongoing power crisis caused by the dependency on fossil fuels, it is crucial that we prioritise energy from renewables. The makers of this plan claim it to be a "long-term plan for affordable and stable fuel supply, and to promote low-carbon energy supply and demand systems," but in reality, it's a climate-conscious facade. Due to the lack of transparency, the stakeholders don't know much about it or understand how problematic it is. We, at CLEAN and BGWED, recently sent a policy brief to the state minister of power and the parliamentary standing committees that we are against the approval of this plan. We have not heard back from them, but this plan is a huge step backwards, and it must be halted.

There are four main concerns about the IEPMP. First, no Bangladeshi experts are involved in it. The Japanese experts overestimated the demand with a linear analysis, calculating it against the GDP. It is a misguided approach as the main consumers of power are the informal sectors of Bangladesh's economy. There has also been no consultation with different sides and sectors of energy users at the regional level. Of the installed capacity in the power sector, the plan proposed 30.7 percent to be fossil fuels (coal and LNG) and 32.8 percent to be the so-called Advanced Technology (liquid hydrogen, ammonia, and carbon capture and storage) by 2050. This will further ensure that Bangladesh remains fully dependent on other nations. Our energy self-sufficiency will be violated if we go through with this. And most importantly, the IEPMP completely contradicts the approved Mujib Climate Prosperity Plan (MCCP), which targets achieving 100 percent of energy from renewables by 2050. The prime minister echoed the target of 40 percent by 2041, during the UN Climate Conference (COP26) in December 2021. But the IEPMP claims to target only 17.1 percent renewables by 2050 - which is overtly unaligned with the MCCP.

#### What is this "Advanced Technology" that the IEPMP promotes, and why is it not a positive shift away from the dependency on coal-based power

The Advanced Technology is what we call "greenwashing." It uses liquid hydrogen, ammonia and CCS, which, taken together, have not been proven to reduce carbon emissions. In fact, developed nations, namely the US, Canada and the UK, rejected purchasing this unproven technology. We are still a Least Developed Country and we have to think about the affordability of power and energy. This technology will be three to four times more expensive than coal. We will also need a lot of electricity to produce hydrogen itself,

So counterproductively, we will be extending the life of coal and fossil gas, and over time, it will cost \$180 billion to import this technology till 2050, which is completely unrealistic.

We have more viable options of transitioning to solar and wind energy, which are proven and significantly cheaper. But it seems that the government is more interested in supporting the Japanese firm Jica, which also funded the 2016 Power System Master Plan, which called for

in the ruling party to shift towards renewable energy, and I personally witnessed it from various members of parliament, too.

Bangladesh has a high capacity for solar power generation, of 20,000-40,000MW of solar power, as stated in the 2021 draft of the National Solar Energy Roadmap. It has not been approved yet due to the powerful fossil fuel lobby. The US-based National Renewable Energy Laboratory performed a recent study, which found a major rollout of power stations to be that Bangladesh also has a capacity for

fuelled by imported coal and liquefied natural gas (LNG). Interestingly, LNG and coal energy-fired generation were technologies that Japan was keen to sell. Japan is our largest bilateral partner and Bangladesh is an easy target for Japan to sell the technology that no other developed nation is willing to purchase. The IEPMP is totally business-oriented, does not promote environmental sustainability, and serves the interests of Japan, though it is wrongly projected to be a "national plan" for us. This is why Bangladesh should cancel this unfeasible and harmful plan and put a better policy in place, a plan that is in harmony with the Mujib Climate Prosperity Plan.

#### When formulating a new viable policy, what are the challenges that we have to overcome, and where

should the focus be? Bangladesh is facing a serious overcapacity problem in the power sector. We should urgently look to replace and phase out fossil-fuel-fired power plants and transition to solar and wind energy, which most importantly do not have capacity charges. We all know the financial burden that capacity charges pose on the economy. Bangladesh has not been able to prioritise the renewable energy targets that have been announced because, in my opinion, there is a lobby among policymakers who want to maintain the 18th-19th century technology of fossil

30,000MW of onshore wind energy. So the question we should be asking to guide our future plans is quite clear: do we really need LNG and coal?

Not only is it climate-friendly, but solar energy is also very economically feasible. So for example, if we allocate Tk 24,000 crore only for the power sector each year, and just allocate Tk 3,500 crore of that allocation to solar, we can reach the target in the MCCP by 2050. On the other hand, if we allocate the entire Tk 24,000 crore to solar, we can implement a whopping 3,000MW of solar power each year. Solar panel price is going down by 10 percent every year and the battery price is decreasing by 15 percent every year due to technological advancement. We don't have to think about the "base load" of batteries until 2035, and we can start thinking about battery storage through research and modelling. For now, we have to find a way to use the idle power plants that the government has invested in to implement our renewable energy goals. This way, we can phase out the dependency on fossil-fuel-based power plants as well. And we do have to phase them out, as I see that around four to five power plants will reach the end of their lifetimes this year. So when that happens, we need to replace them with solar plants, and by continuing that process, we can gradually progress towards our renewable energy target.



# Mediation at the instance of the court

In the social context of Bangladesh, it turns to be more serious when a party drags his opponent to the premises of courts. In most cases, the mindset of the parties becomes so confrontational that they prefer to continue with legal battle in courts to secure win at any cost. Therefore, mediation hardly works as it is not a mandatory first step before

litigation.

Dispute resolution through Alternative Dispute Resolution (ADR) methods received massive legislative support and recognition in Bangladesh in the last two decades. The amendments made in 2003 to the Code of Civil Procedure 1908 created scope for dispute resolution through the process of mediation and arbitration in sections 89A-89E.

In the similar vein, the legislature has introduced amendments to the Money Loan Court Act 2003. By an amendment in 2010, sections 22-23 were inserted providing scope for mediation in money-loan cases at two stages. First, after filing a case and upon submission of written statements by the defendant(s), it is incumbent upon the court to refer the case to mediation. If mediation is unsuccessful at the pre-trial stage, the chance for mediation is also available after conclusion of the trial and before delivery of the judgment. It takes place before pronouncement of the judgment and upon joint prayers by the disputing parties.

The main feature of the amended law is that the mediation takes place during proceedings in court mandatorily. However, it is not made as a mandatory first step prior to the initiation of proceedings. After the commencement of litigation, the parties take an adversarial position which minimises the chance of dispute resolution through consensual means. In most cases, the mindset of the parties becomes so confrontational that they prefer to continue or valuation of a case. The absence of such rules

with legal battle in courts to secure win at any burdens the parties with additional expenses. Secondly, the amended law has left no option for the court to apply its discretion to decide whether the dispute can be resolved through alternative means to begin with.

In some instances, dispute cannot be resolved through alternative means, for example, when a party alleges fraud against the other or when there exists high level of animosity between the parties or when a



case is so complex that it requires judicial decision. Thirdly, pursuant to a court order, mediation does not take place under any accredited institution dedicated to providing for mediation service.

Finally, the relevant legislations do not to the fees of a mediator. There is no standard guideline or rules fixing the mediator fees based on the complexity of the subject matter The Writer is an Advocate, Supreme Court of

The situation becomes more complicated is not a mandatory first step before litigation. when both parties are not equal. The power imbalance between the parties results in a failed mediation.

In light of the discussions above, it can be said that the infrastructure for mediation, at the direction of the court under the amended laws, is not encouraging for ADR users. In a legal proceeding prior to its trial, the disputing parties often view this compulsory mediation as an additional hurdle, an added investment of time and costs with no security of a return. As a result, after the lapse of the statutory period for mediation, the majority of cases return to the normal court system. In the process, it causes further delay in the disposal of cases. And it benefits a party who takes undue advantage of the delay.

In the UK, the Civil Procedure Rules provide support for the use of ADR through case management and sanctions. The court can penalise a party in costs if it unreasonably refuses to attempt ADR, particularly if it is ordered by the court to do so. To support the use of ADR, the Civil Mediation Council has been set up in 2003, which sets standards for training, practice, and also there exists a standard guideline for fees that may be charged for mediation services.

Bangladesh should introduce necessary amendments to the Code of Civil Procedure 1908 and the Money Loan Court Act 2003 contain any provision providing for a limit as to make ADR, in particular mediation, a meaningful practice for dispute resolution.

# Rights of the minority shareholders

This week Your Advocate is Barrister Omar Khan Joy, Advocate, Supreme Court of Bangladesh. He is the head of the chambers of a renowned law firm, namely, 'Legal Counsel', which has expertise mainly in commercial law, family law, labour law, land law, constitutional law, criminal law, and IPR.

**Query:** 

I have recently bought some shares at a company. However, my opinions are not being considered as I am only a minority shareholder. Are there any rights for minority shareholders according to relevant laws?

**Response:** 

Thank you for your query. For your information, company matters in Bangladesh are primarily governed by the Companies Act 1994. The rights of the shareholders in a company are according to the number/percentage of shares they possess. Thereby, a shareholder with fewer shares would have lower degree of control and authority over the affairs of the company in contract with shareholders holding larger amount of shares. In simpler words, majority shareholders naturally have more rights to make decisions for and manage the company than minority shareholders as reflected in both the forums of Board of Directors and general meetings of the shareholders. Thus, the decisions taken by the majority can be contrary to the view of the minority shareholder(s). While the majority have more rights and control over the management of the company, the entitlement as a result of their investments comes with higher risks as well.

Section 233 of the Act protects the minority shareholders from actions of the majority that may be 'prejudicial' to one or more shareholders of the company, or, which may discriminate against the interest of any shareholder. However, the protection under section 233 of the Act is conditional. As per section 195 of the Act, the protection under section 233 is subject to the minority shareholder/s holding a minimum of 10% of shares in the company if the company has share capital, and in case the company has no share capital, the minority shareholders having not less than one-fifth the number of a person on the company register of members. Therefore, under the first condition, if a minority shareholder holds, for example, 7% shares, s/he will not be eligible for protection under section 233.

In your case, the first question that arises is whether you were aware of the fact that you would have fewer rights if you become the company's minority shareholder. Companies usually do not vest such decision-making powers to their minority shareholders. It should be articulated in the Articles of Association of the company that you are the shareholder. If there are no decisionmaking rights, you can bring no claim against the majority for disregarding your opinion in the decision-making process/voting. Your right to file a complaint to the court under section 233 only arises if the majority acts in any manner that is prejudicial (harmful) or discriminatory to you, subject to the conditions in section 195 of the Act. If the majority acts in a prejudicial and/or discriminatory manner and one of the section 195 conditions is met, you can make an application under section 233 to the High Court Division of

the Supreme Court of Bangladesh. However, with the increase in the number of minority shareholders in companies these days, it is best to take preventative measures to protect your rights, such as having a shareholder's agreement or stipulation of further conditions in the Articles of Association prior to subscribing the shares.

I hope my answer will help you find a solution to the issue.

# Restrictions on strike in essential service sectors

Strikes are common forms of protest performed by employees in various professions, especially workers, to address grievances and demand fair treatment. However, it is important to note that the government of Bangladesh has the authority to impose restrictions on strikes. Two legislations, namely the Essential Services (Maintenance) Act 1952 and the Essential Services (Second) Ordinance 1958, outline the government's power to promoit strikes

These legislations the government a wide scope of application. However, certain conditions must be met for private employment. The government can declare private employment subject to these legislations if it deems it essential for defence, security, public order, or the maintenance of crucial supplies or services for the people of Bangladesh. Any such declaration is valid for a maximum of six months, unless extended by an order. Under the Essential Services (Maintenance) Act 1952, the government can also restrict employees engaged in such employment from leaving their workplace or specified locations mentioned in the order.

Singly or collectively disobeying any orders at the workplace or inciting others to do so, refusing or neglecting duties, leaving or staying absent from the workplace without reasonable

cause, or disobeying prohibitions secretary, or officer of a company or (art 34), it allows exceptions for laws permission are considered offences under these legislations. Besides, the Act of 1952 also holds employers accountable. If an employer dismisses an employee without reasonable cause or shuts down the establishment

on leaving a place without authority corporate body, he/she can be held equally liable unless he/she can prove their lack of knowledge or demonstrate due diligence in preventing the offence.

Ongoing strike means that employees collectively refrain from working regardless of the orders of the preventing work, this is to be deemed employer or superior officer in protest



a breach of law. Furthermore, aiding or encouraging the commission of an offence under this Act is also considered to be a contravention of law.

Offenders proven guilty under this Act may face imprisonment for up to one year and fines of any amount. If the accused is a director, manager,

of any injustice or inconsistency in the workplace or to establish a fair right. But such activities are treated as punishable offences for some class of employees in the above legislations, which actually restrict their right to strike.

Although the Constitution of Bangladesh prohibits forced labour

imposed to pursuit public purposes. Similarly, while art 36 guarantees freedom of movement for the citizens of Bangladesh, reasonable restrictions imposed by law in the public interest are permissible. Therefore, the Essential Services (Maintenance) Act 1952 and the Essential Services (Second) Ordinance 1958 can only be applied in the interest of achieving public objectives. If these legislations are used against public interest, they would violate the constitution.

The government is currently planning to replace these two legislations with a new law. The proposed bill provides a comprehensive list of services classified as essential. It empowers the government to prohibit owners from suspending work due to reasons like raw material shortage or stockpiling of goods or equipment failure, which may lead to layoff. Violating the restrictions outlined in the bill can result in a maximum of six months imprisonment, a fine of Tk 50,000, or both.

The Essential Services Bill 2023 has been sent to the Ministry of Labour and Employment-related Parliamentary Committee for approval. It is hoped that the new law will not undermine the civil, political, and constitutional rights of the citizens.

# CSGJ monthly lecture on the legal implications for Bangladesh hosting the refugees

On May 27, 2023, Center for the Study of Genocide and Justice (CSGJ) at the Liberation War Museum organised the ninth lecture of its monthly lecture series where Naureen Rahim, a PhD Research Fellow at the Faculty of Law, University of Oslo, gave an extensive talk on the topic 'Bangladesh as Refugee Hosting State: Legal Implications in Dealing with the Rohingyas'.

Before delving into the issue of the present Rohingya refugee crisis persisting in Bangladesh, Ms. Rahim first discussed about the historical narrative of refugees in Bangladesh. She briefly spoke about the plight of the Bengali refugees who fled to India during the 1971 Liberation War and the post-war government's dilemma regarding the Urdu speaking minorities in Bangladesh. According to her, although the Urdu speaking minorities have gradually been granted electoral right and now being treated as

citizens, they still face social discrimination.

ongoing PhD fieldwork, Ms. Rahim opined with reference to the UNHCR - that aside from the Rohingyas, Bangladesh is also a host to refugees from other nationalities such as Iran, Iraq and Afghanistan.

Regarding Bangladesh's decision not to ratify the 1951 Refugee Convention and its 1967 Protocol, she stated that no official document contains any justification on the non-ratification. Ms. Rahim highlighted how the limited involvement of South Asian States during the drafting of the 1951 Refugee Convention has led them to reject this Eurocentric refugee recognition practices which was drafted after the second world war to meet the European refugee crisis. However, it remains unclear whether Bangladesh's decision not to ratify the Convention and its Protocol is influenced by this historic narrative or not.

On the contrary, Ms. Rahim is of the opinion that despite not being a party to

Ms. Rahim also talked about the lack of national law dealing with refugee crisis in Bangladesh. This gives rise to issues regarding how civil and criminal disputes are being resolved within and outside the camp areas. At present, the Constitution of Bangladesh and the Foreigners Act 1946 are the major laws that are being used for dealing with such issues whereas if the dispute concerns eruption of violence within the camp, the authorities apply the Penal Code 1860.

Lastly, Ms. Rahim discussed about the longstanding repatriation problem of the Rohingya refugees drawing upon the recent negotiation between all the concerned parties. Finally, the lecture was concluded with an active Q/A session.

## Players guranteed \$30k at Women's WC

Every player at next month's Women's World Cup is guaranteed to earn at least \$30,000, FIFA says, with the winners taking home \$270,000.

Women's football is at an all-time high but there have been concerns from players that its growing popularity is not reflected in what they earn, especially compared to men.

The average club salary of women players is \$14,000, according to FIFA, a fraction of what their counterparts in men's football earn.

FIFA says the ring-fencing of money for players is a first and its investment is three times what it was at the Women's World Cup in France four years ago.

"We have taken steps towards greater gender equity in our game at its highest levels," the global players' union FIFPro welcomed the move.

"The legacy of this action is by the players, for the players, of both today and tomorrow.

## **Uprooted landmines** may pose grave danger

**UKRAINE DAM DISASTER** 

Says Red Cross; about 600 sq km of Kherson under water

Landmines uprooted and dispersed by floodwaters surging downstream from the breached Kakhovka dam across swathes of southern Ukraine could pose a grave danger to civilians for decades to come, the Red Cross

The vast Soviet-era Kakhovka dam, under Russian control, was breached in the early hours of Tuesday, unleashing warzone and endangering the lives and welfare of tens of thousands of people.

Ukraine blamed Russia for blowing it up. Russia said Ukraine sabotaged the dam at the behest of the West to constrict water supplies to Crimea and to distract from a faltering offensive. Some Russian-backed officials said the dam may have collapsed.

About 600 square kilometres, or 230 square miles, of the Kherson region in southern Ukraine was under water following the destruction of the dam, the regional governor said.

The waters have also washed over countless land mines sown during the 15-month war and nobody now knows where they are: they could still be in the minefields or could be stuck in the river mud or in fields, gardens and roads across a vast area.

"In the past we knew where the hazards were. Now we don't know. All we know is that they are somewhere downstream," said Erik Tollefsen, head of the Weapon Contamination Unit at the International Committee of the Red Cross (ICRC).

"It is with a certain horror that we look at the news coming out," said Tollefsen in an audio clip, adding that World War Two mines tound underwater in Denmark in 2015 were still active.

Besides anti-personnel mines, both sides have used vast amounts of artillery shells and anti-tank mines. The exact number of mines in Ukraine is unclear, said Tollefsen. "We just know the numbers are massive," said Tollefsen.

Russian-installed authorities who control part of Kherson region said five people have died in the floods and also warned residents to be vigilant over the mines being washed downstream by the floodwaters.

Moscow and Kyiv also accused each other of shelling the area as rescue workers in rubber dinghies tried to save hundreds of people and animals from the still rising flood waters.

## First mission to 'touch' sun catches the solar wind

key motivations behind the mission. named for the late astrophysicist Eugene Parker and launched in 2018, was to determine what the wind looks like as it

near the sun and how it escapes the forms star's gravity.

As the probe came within about 13 million miles (20.9 million kilometres) of the sun, its instruments detected fine structures of the solar wind where it generates near the photosphere, or the solar surface, and captured ephemeral details that disappear once the wind is blasted from the

The spacecraft was specially designed to eventually fly within 4 million miles (6.4 million kilometres) above the solar surface, and in late 2021, it became the first mission to "touch" the sun.

## 11 killed during funeral of Afghan governor

More than 30 hurt

An explosion inside a mosque in northern Afghanistan yesterday killed at least 11 people during the funeral of the Taliban's provincial deputy governor, who died in an attack earlier this week, officials said.

The Taliban-run Ministry of Interior said that more than 30 people were also injured in the blast in Badakhshan, a province in the far north that shares borders with China and Tajikistan.

A former police commander of northern Baghlan province, Safiullah Samim, was among the dead, according to a statement offering condolences from another police chief, Najibullah Badakhshi.

Ashraf Nael, a resident of Faizabad, said he was in a nearby court building when he heard a blast at around 11:00 am, muffled by the mosque walls, before many ambulances rushed towards the scene.

Islamic State militants claimed responsibility for a car bomb on Tuesday that killed Badakhshan's deputy governor. The Taliban administration has been carrying out raids

against members of Islamic State, which has claimed several major attacks in urban centres. The Islamic State group has targeted Taliban

administration officials, and claimed the killing of the governor of northern Balkh province in an attack in
