# \$1b in budget support arrives next week

ADB, AIIB and Jica teamed up for the financing arrangement

About \$1 billion in budget support is set to arrive in the next few days from three development partners to help the government meet its deficit financing for this fiscal year.

Of the sum, \$400 million is coming from the Asian Development Bank, another \$400 million from the Asian Infrastructure Investment Bank and \$216 million from the Japan International Cooperation

Yesterday, the boards of the AIIB and the ADB approved the loan. The approval for the loan from Jica is expected by next week.

The amounts would enter the Bangladesh Bank's vault as soon as the loans are approved by the boards as Bangladesh has been able to meet more or less all the conditions, The Daily Star has learnt from finance ministry officials involved with the proceedings.

However, the inflow would not be enough to prop up the country's net international reserves enough to meet the \$24.46 billion floor set by the International Monetary Fund to get the second tranche of the \$4.7 billion sanctioned.

All three loans' conditions are synchronised and drawn upon by the ADB, which is serving as the lead financer.

#### Child mortality rate rises

The child mortality rate in Bangladesh has increased significantly to 31 per thousand in 2022 compared to 28 per thousand in 2021, according to "Bangladesh Sample Vital Statistics (BSVS) 2022", launched by BBS yesterday. Deaths of children under one increased to 25 per thousand from 22 per thousand during the same period. Diarrhoea, malnutrition, acute respiratory infection and drowning were among the other the rise. According to experts, this significant rise highlights the gap in child healthcare services in the

# Tax bill proposes clipping ACC wings

#### Investigators to require court's permission to get graft suspect's tax return info from NBR

Although tax returns are a key document for investigating illegal wealth, the Income Tax Bill 2023 proposes making it impossible for Anti-Corruption Commission officials to access a suspect's tax files without a court order.

ACC officers fear that if the bill passes, investigations will become unnecessarily complicated and lengthy.

"Investigation officers use the tax return as an authentic document while filing cases. But the power is curtailed in the proposed act," said an ACC officer, requesting

"Many corrupt individuals may get away. We don't know for whose benefit the power is curtailed," the officer added.

A parliamentary body was asked on June 8 to examine the bill and come up with a

The provision curtailing ACC investigators' power is clearly contradictory to article 20(2) of the Constitution which criminalises unearned income, said Iftekharuzzaman, executive director of Transparency International Bangladesh.

Currently, the ACC launches an investigation after receiving a wealth and asks the individual concerned for their wealth statement.

Officers then cross-check the statement in light of the tax return they obtain from the National Board of Revenue. Officers also verify the information of moveable and immoveable properties with records from banks and other organisations. If the officers detect irregularities, they file cases with the ACC's approval.

But section 309 (2) of the proposed income tax bill says the ACC cannot seek

income tax return unless there is a court order. One of the mandates of the ACC is to dig out illegal wealth and it often says it will not let owners of illegal wealth sleep peacefully, said an officer.

# Vendor beaten to death for 'skipping rally'

#### Family points finger at ruling party activists

A street vendor has been beaten to death in the capital's Mirpur for not attending a rally organised by the Jubo League in the area, alleged family members and locals.

Several people beat Hafizur Rahman, 27, indiscriminately around 6:30pm on Monday in front of his cart, said

As he fell unconscious, locals rushed him to a local hospital and then to Shaheed Suhrawardy Medical College, where doctors declared him dead.

Hafizur used to sell chicken fries from his cart on Folpatty Road near Mirpur-10 roundabout.

"Some Awami League men beat brother to death as he did not join a rally as per their instruction. Hafizur assured them that he would join the rally but instead opened his cart for business," the victim's elder brother Shafiqul Islam told The Daily Star.

Shafiqul also claimed that most who run makeshift shops or carts on the pavement are forced to attend SEE PAGE 6 COL 1

# Jamaat regroups by stealth

Police documents show the party is swelling its ranks fast

Contrary to the widespread perception that Jamaat-e-Islami has been on the wane for over the past 15 years, the Islamist party that actively opposed the birth of the nation is actually growing, according to intelligence and party documents.

In 2008, the number of the party's permanent members or Rukon was 23,863. That figure now stands at 73,046 -- a threefold rise, according to a police intelligence report.

The Islamist party also sees a threefold rise in the number of its activists, which has leapt to 6.39 lakh from 2.21 lakh during the same period, the report says.

Lately, Jamaat came into discussion again as it held a rally in the capital on Saturday after getting police permission. The party was given such permission for the first time in 10 years. Later, four ministers on Sunday tried to justify the government's decision.

About the permission, Agriculture Minister Abdur Razzak on Sunday said Jamaat has a support base and in light of this, the government gave the party permission to hold the rall

The police intelligence report, which also contains Jamaat's strategy for the upcoming national election and funding, has recently been submitted to the home ministry.

It has been prepared based on information gathered from the party's top-secret documents, interrogation of top Jamaat leaders and interception of communication among party leaders.

The Daily Star has a copy of the report alongside party documents. The documents show a nearly fivefold rise in the party's women Rukon, and a fourfold rise in women activists. Similarly, the number

# Win fails to bring joy to AL camp

Party's campaign office found deserted after Khair's victory; unit leaders didn't greet mayor-elect

Voter turnout was as low as 36 percent in neighbourhoods known as strongholds of incumbent Barishal Mayor Serniabat Sadiq Abdullah in Monday's polls to the Barishal City Corporation, according to centre-wise voting results.

Voters, AL leaders, and supporters from these areas abstained from voting because of tension between Sadiq and his uncle -- mayor-elected Abul Khair Abdullah, said sources.

Sadiq, also the secretary of the Barishal city Awami League (AL), who was in Dhaka on election day, did not even go to Barishal to vote.

Prior to the election, there were reports of a rift between Khair and his nephew Sadiq after Khair received the AL ticket to run for mayor.

Even, Sadiq's father, Abul Hasanat Abdullah, and his supporters also stayed away from Sadiq's election campaign. Khair won the polls with 87,808 votes, which is more than 62 percent of the total votes cast (1.42 lakh votes).

In spite of the victory, the AL leaders and activists in the city did not arrange any celebration. This newspaper yesterday found the city AL office locked.

Even around the AL's central campaign office, very few leaders and supporters were seen. Leaders of the city unit AL did not even meet the

### PM reaches Geneva to attend ILO summit

Prime Minister Sheikh Hasina reached Geneva, Switzerland yesterday to attend the two-day "World of Work Summit: Social Justice for All" to be held in the city today and tomorrow.

A regular flight of Biman Bangladesh Airlines carrying the prime minister landed at Geneva Airport at 5:10pm local time (9:10pm Bangladesh time), PM's Speechwriter Md Nazrul Islam said.

Earlier, the flight departed Hazrat Shahjalal International Airport around 10:00am.

Today, UN High Commissioner for Refugees chief Flippo Grandi will call on the prime minister at the bilateral room of Hotel President Wilson.

Later the PM will call on the President of the Swiss Confederation Alain Berset at Palais de Nations. Afterwards, there is a possibility of signing a Memorandum of Understanding (MoU) on knowledge and skills enhancement between Bangladesh and Switzerland.

In the afternoon, the prime minister will address the Plenary of the "World of Work Summit 2023" at Palais de Nations.

She will also have a call with the President of Malta Dr George Vella.

In the evening, the PM will attend a dinner with high-level dignitaries hosted by the International Labour Organisation at its headquarters.

Tomorrow, she will attend the "A talk at the WEF", followed by a meeting with the founder of WEF Prof Klaus Schwab at the World Economic Forum's Office.

There, she will address the event on "New Economy and Society in Smart Bangladesh".

In the evening, World Trade Organisation Director-General Dr Ngozi Okonjo-Iweala will call on her at Hotel President Wilson. She will also attend a community event in the

Exiting Uttara, especially now with all the chaos of Bus Rapid Transit (BRT) construction happening around the airport area, is indeed a test of patience. The never-ending BRT project, which was supposed to ease the traffic congestion is now the sole reason for taking 30 minutes or more to just cross the airport intersection. Pedestrians, construction debris, and men at work have all added to the commotion, and Uttara residents try to avoid this main access road connecting Uttara to Dhaka like a rogue.

With the start of the metro rail, a lot of these traffic problems have eased further north of Uttara no doubt. In fact, there is a beautiful road joining Uttara to Mirpur giving the residents a better second option to commute. Then there is the detour of roughly 22 km from Ashulia to Dhanmondi via Beribadh Road. There is less traffic on this highway and is the most favoured option to commute from Uttara regularly.

The other non-conventional way to exit Uttara for central Dhaka is by availing the local train. This ride, as a means of public transport in Dhaka, is faster but not without suffering. Yet,



for Uttara residents, availing the local train is far easier than a bus ride.

If you take an intercity train ride, the ticket comes at Tk 25. For the local train, the price is Tk 20. The train compartment is crowded and you do not find space to stand. Many officegoers to Motijheel, Sayedabad, and areas like Paltan choose this option of

Dhaka as a city is now choked with traffic. While many theories are being projected to ease traffic congestion. as a layperson, I believe improving our public transport system can be a viable

In the petition, he requested the HC to order the authorities to stop broadcasting such defamatory and false statements and to properly ensure the National Broadcasting Policy to this effect, Adv M Saufullah Mamun, a lawyer for the petitioner tol The Daily Star.

Another condition is consolidating and revising the law on income taxes to address new and emerging issues such as base erosion and profit shifting by global internet-based entities, transfer pricing, derivative transactions in the capital market and thin capitalisation.

The government must also secure parliamentary approval to amend the Income Tax Ordinance, 1984 or issue SRO (as appropriate) for the withdrawal of selected income tax

Enable improved tax compliance,

enhanced oversight administration, ensure the integrity and accuracy of tax collections, and minimise tax avoidance through identifying discrepancies in respect of tax liabilities and payments of firms

and businesses: The National Board of Revenue will have to issue orders for information exchange between the large taxpaver units of VAT and income tax, introduce risk-based VAT audits and adopt a

risk-based audit manual. The revenue authority will also have to issue an order to expand the electronic deduction of income tax at-source system in at least 6 more tax

The revenue authority has also

tax mandated online payment of VAT amounts exceeding Tk 1 crore as per the ADB's recommendations. Online payment of income tax

for amounts exceeding Tk 20 lakh and pilot online personal income tax return filing by taxpayers with income exceeding Tk 70 lakh are two more conditions. The government has closed down

Another condition is securing cabinet approval for the Bangladesh Public Procurement Authority bill for the establishment of an autonomous public procurement authority

Transparency and efficiency in public procurement will be enhanced through strengthening electronic procurement and electronic payment systems, while approval of public projects will be facilitated through the newly launched digital system of public project appraisal and approval process, according to ADB.

If the policy actions are implemented sincerely, Bangladesh's tax-to-GDP ratio will increase to 8.8 percent from 7.9 percent at present by December next year.

of associate members has now grown to 2.29 crore from 1.03 crore in 2008.

Asked about the party's recent activities, Jamaat Nayeb-e-Ameer (deputy chief) Abdullah Md Taher told The Daily Star that they were not allowed to carry out political activities for over a decade.

"But we have continued our 'dawati' (invitational) activities secretly and will continue to do so," he said.

About the spike in the number of its members, especially among the women, he said it is the result of their dawati activities. "Still, the number of men is much higher than that of women, but the increase in the number of women members is higher.'

Jamaat has faced myriad challenges since December 2008. Many of its leaders were also arrested in 2013-2015 when the BNP-Jamaat alliance staged a

fierce anti-government movement. However, it faced an existential crisis when most of its top brass were tried on war crimes charges at the International

War Crimes Tribunal and executed. Following the war crimes trial, five of its top leaders were hanged while three died in custody. Another two, who were sentenced to different jail terms, are

serving their time at present. According to Jamaat's database,

around 1,850 Jamaat leaders are in jail as of March 31, while 15 Jamaat men were alleged victims of enforced disappearance. Around 294 Jamaat activists were killed in the last 12 years, the party claimed.

Established by the controversial Islamist scholar Abul Ala Moududi in 1941, Jamaat had been banned twice, in 1959 and 1964 in Pakistan, for its communal role. During the Liberation War, the party

had directly taken a stance against the country's independence and carried out indiscriminate massacre of pro-Liberation forces and activists supporting the cause of independence. The Al-Badr Bahini, an auxiliary

force of the Pakistan army in 1971 played a key role in the killing of intellectuals. Al-Badr consisted mainly of activists of Islami Chhatra Sangha, Jamaat's student wing during the Liberation War.

In its verdict against former Jamaat ameer Ghulam Azam, the International Crimes Tribunal-1 observed, "... Jamaate-Islami, as a political party under the leadership of accused Prof Ghulam Azam, intentionally functioned as a criminal organisation especially during the War of Liberation of Bangladesh in

The party was banned again after

independence but was allowed back in politics during the rule of late president Ziaur Rahman. Justice seekers, and war crimes victims and their family members have long been demanding the trial of Jamaat as a party for its role in 1971.

According to Jamaat sources, the party never regretted or offered apology for its role in 1971. The issue of offering apology was discussed within the party in 2017, but no decision was made in this regard.

Jamaat's assistant secretary general Barrister Abdur Razzaq resigned from the party in 2019, citing the party's failure to apologise for its role in the Liberation War and bring reforms to its constitution.

The BNP allied with Jamaat in 1999 and formed a four-party alliance ahead of the 2001 national election. Later, the alliance formed government after a landslide victory in the election and Jamaat's former Ameer and secretary general were made ministers in the Khaleda Zia-led government.

Using the state power, Jamaat then strengthened its organisational

As the 2013-15 movement against the AL government was a failure and drew flak at home and abroad for its violent nature, the BNP and Jamaat had been very strategic in their relations.

However, the parties bridged the gap and got closer recently and agreed to wage a simultaneous movement to oust the government and materialise a polls-time caretaker administration.

In 2013, Jamaat's registration as a political party was declared illegal by the High Court. Acting on the verdict, the Election Commission cancelled Jamaat's registration in October 2018. In last October, Bangladesh

Development Party (BDP), which many

believe is Jamaat-e-Islami in disguise, applied for registration with the EC. According to some media reports, top leaders of BDP were involved with Jamaat. The general secretary of the party is a former leader of Islami

Earlier this month, Amar Bangladesh Party, founded by some former leaders of Jamaat, also applied for registration as a political party. Both the BDP and Amar Bangladesh,

The party has adopted a dual policy regarding the upcoming national election, slated to be held towards the end of this year.

It has already prepared a primary list of candidates for all 300 constituencies and even potential ministers for 10 ministries. It will make the final decision considering the political situation, according to the report. While selecting the candidates,

Jamaat has preferred party men who are in various professions businessmen, doctors, engineers, police and former bureaucrats. People who are popular and have

considerable influence in their areas have been selected. The organisation has also started

collecting election funds from its members. It wrote to all its units across the country, asking party members to pay extra for raising an election fund. The organisation has adopted a

unique strategy to increase voters in constituencies where it has a strong base. It has also mobilised its voters in towns. Pro-Jamaat voters of

constituencies where the possibility of its win is slim will be migrated to its Jamaat is also trying to spread its wings abroad for broadening its

organisational base, collecting new members and raising funds. According to the police document, Jamaat sent letters last year to organisations abroad, describing its current political situation in the country and branding the incumbent government "anti-Islam". The organisation wrote to the

different Muslim countries and Islamic

chairman of Muslim Brotherhood on December 8, the Malaysian prime minister on November 24, the chairman of The Welfare Party of Turkey on November 6, the president of The Felicity Party of Turkey on October 24. the Turkish President Recep Tayyip Erdoğan on October 17 and the Saudi Crown Prince Mohammed bin Salman on September 30.

According to the document, as the organisation is running its activities under the banners of different organisations, and as it has no specific office now, Jamaat is conducting its political and organisational activities from rented houses.

It is also holding meetings, spreading its ideology conducting its organis organisational activities through various types of religious gatherings, like Waz Mahfils, across the country.

Islami Chhatra Shibir, the student wing of Jamaat, mainly recruits activists and supporters for the organisation, persuading them to build an ideal and just Islamic society.

The total number of dengue cases this year rose to 3,601.

Some 703 dengue patients are still undergoing treatment, of whom, 128 are from outside Dhaka. A total of 2,871 dengue patients were released from hospitals.

The total number of dengue-related deaths was 281 last year while the total number of cases was 62,382.

# Significant rise in child mortality in 2022

Finds govt study, experts highlight gap in healthcare

A government study shows that the child mortality rate in Bangladesh has increased significantly in 2022 compared to 2021, which experts said highlights the gap in child healthcare services in the country.

In 2021, the mortality rate of children under five years of age was 28 per thousand.

It increased to 31 in 2022, according to the key findings of "Bangladesh Sample Vital Statistics (BSVS) 2022", launched by the Bangladesh Bureau of Statistics auditorium yesterday.

## 'Pay up our dues'

Workers of closed RMG factory go on strike

Demanding Tk 14 crore in compensation from the Bangladesh Export Processing Zone Authority (Bepza), workers of Honour Way Textile and Apparels (Pvt) Ltd, a factory at Dhaka Export Processing Zone, went on a strike yesterday in front of Jatiya Press Club.

The RMG factory in DEPZ shut down fifteen years ago. However, the 1,400 workers who lost their employment are yet to receive their compensation.

Workers complained that despite being promised their due payments for the past 15 years, they have not received anything. The factory was sold out by EPZ (Export Processing Zone) since its owner, Alvin Di Lao, a Hong Kong resident, stopped showing up to work in 2008. However, the price at which the factory was sold has not been made public.

Rashed Khan Menon, president of Workers Party of Bangladesh, who joined the strike, said, "The carelessness of Bepza and DEPZ demonstrates their utter disregard for workers. The workers must receive their share of the proceeds since Bepza and DEPZ sold the property, factory building, and equipment."

Amirul Haque Amin, president of National Garments Workers Federation, said Bepza must take responsibility and pay the compensation. About 200 workers participated in the strike.

### SYLHET ROAD CRASH Pick-up driver sent to jail after surrender

Following a road accident, a Sylhet court sent a pick-up van driver to jail after he surrendered before it yesterday.

Abdur Rahim, 30, of Bajitpur village in Sunamganj's Dowarabazar upazila was driving the pick-up that collided with a truck in Sylhet's Dakshin Surma upazila around 5:00am on June 7. The accident claimed the lives of 15 of its 28 commuting construction workers.

Expelled for participating in Khulna city polls, BNP councillor candidates end up losing electoral race

Eight Khulna BNP leaders, who were expelled for running for councillor posts against the party directives, lost the electoral race. Only an expelled female BNP leader, Mazeda Khatun, won the reserved councillor post for women in ward 9.

### Trial of two BNP leaders begins in sabotage case

A Chattogram court yesterday started trial against two BNP leaders in a case filed in connection with sabotage and conspiracy to create unrest against the government in 2018.

The court framed charges against the party's city unit convener Shahadat Hossain and Chattogram south district convener Abu Sufian. The accused were present at the court.

Police filed the case accusing BNP leader Shahadat and Abu Sufian and 38 others, saying that the party's leaders and activists gathered on the port city's Emdad Ali Road in Panchlaish to create unrest on November 2, 2018. After the investigation, police pressed charges against them on October 31, 2020.

### Driver, helper get life term for yaba peddling in Ctg

A Chattogram court yesterday sentenced a driver and a helper to life term imprisonment in a case filed over yaba peddling in the port city's Karnaphuli area in 2021. The court of 4th Metropolitan Magistrate Shariful Alam Bhuiyan passed the order.

The convicts are Md Taizul Islam Tazu, 29, a pickup van driver; and Md Rakib, 19, his helper.

According to the case statement, detectives arrested Taizul and Rakib with 5,000 yaba pills while they were smuggling the contraband drug from Cox's Bazar to Chattogram. Later, police filed a case with Karnaphuli Police Station accusing them.



The IAB mayoral candidate in the May 25 Gazipur city polls, Gazi Ataur Rahman, secured 7.9 percent of total votes cast when JP candidate MM Niaz Uddin got 2.9 percent.

Currently, IAB has two councillors in two Dhaka city corporations, and one each in Jhenidah, Kuakata, Faridpur Sadar, Nilphamari Sadar municipalities. The party also has 13 union parishad chairmen, said party sources.

Founded in March 1987 by Fazlul Karim, widely known as "Charmonair Pir", the IAB showed a demonstration of its organisational abilities in the 2018 national election.

The IAB candidates in that election bagged 12.55 lakh votes in 299 constituencies, which was 1.52 percent of the total vote cast. The party fielded candidates in 299 out of the total 300 constituencies the highest by a single party. The AL fielded nominees in 262 constituencies, the BNP in 258, and the JP in only 45.

IAB candidates ran in the 2008 parliamentary polls in 160 constituencies and secured 733,969 votes, 1.05 percent of the total vote

The IAB was among the three political parties, including the AL and the BNP, which secured more than one percent of the total votes cast in that polls.

"They raided my house at 2:00am and picked up my wife, daughterin-law and her year-old baby. They took us to the police station, where I was beaten up, and threatened to be forced to drink urine if I did not reveal where my sons were. I kept saying that I did not know," said the 70-year-old.

### Cambodian leader orders election law change

AFP, Phnom Penh

Cambodian leader Hun Sen yesterday ordered election laws to be changed to ban anyone who fails to vote in an upcoming poll from ever running for office -- a move that will affect exiled rivals.

The kingdom votes in a general election next month with Hun Sen's party running almost unopposed, after the main opposition outfit was barred on a technicality.

Rights groups accuse Hun Sen of using the legal system to crush any opposition to his power.

Hun Sen said he had asked officials to add a clause to election laws saying that anyone who does not vote in the upcoming poll has no right to run in future ballots.

"If you don't vote on July 23, 2023, you will have no right to be elected" in any future elections, Hun Sen said in a speech to garment workers in Phnom Penh.

# Over 6,000 killed in first 20 months: report

More than 6,000 civilians were killed in Myanmar in the first 20 months after the February 2021 military coup, a report published yesterday by the Peace Research Institute of Oslo said.

"Our data shows that the human toll of the conflict is higher than previously reported, and while the junta is clearly the main killer, anti-junta forces also have large amounts of blood on their hands," Stein Tonnesson, one of the two co-authors of the report, said in a statement.

The report said 6,337 civilians were killed "for political reasons" between February 1, 2021 and September 30, 2022, and 2,614 were

That toll is much higher than others that have circulated, including those from international organisations.

According to the report, almost half of the deaths, 3,003, were attributed to the regime -- the army, police and militias -- while 2,152 were attributed to armed opposition groups.

Twelve were attributed to other civilians not affiliated with either the

regime or opponents, and 1,170 to undetermined

"This is a larger number than is normally cited in the media, and yet it is only an estimate, based on reported killings gathered from reliable media

reports," the report said. "The actual total is surely higher since many killings have likely gone unreported".

Alleging massive fraud, the Myanmar military annulled the legislative elections won by Aung San Suu Kyi's party and overthrew her government.

Since then, the junta has carried out a large-scale repression of any opposition, arresting more than 23,000 people according to a local watchdog.

Meanwhile, the United Nations yesterday slammed the Myanmar junta's "unfathomable" decision to suspend travel authorisations for aid workers trying stopped," he said.

Cyclone Mocha brought lashing rain and winds of 195 kilometres (120 miles) per hour to Myanmar and neighbouring Bangladesh last month, killing at least 148 people in Myanmar.

The cyclone destroyed homes and brought a storm surge to Rakhine state, where hundreds of thousands of Rohingya minority refugees live in displacement camps following decades of ethnic conflict.

But despite the towering needs, the UN said last week that junta authorities had suspended "existing travel authorisations... for humanitarian organisations".

"Four weeks into this disaster response and with the monsoon season well under way, it is unfathomable that humanitarians are being denied access to support people in need," Ramanathan Balakrishnan, the UN resident and humanitarian coordinator in Myanmar, said in a statement on Monday.

Since the cyclone hit on May 14, humanitarian workers have been getting aid to a growing number of

people using limited travel authorisations granted to organisations with long-standing operations in Rakhine.

Jens Laerke, spokesman for the UN humanitarian agency OCHA, told reporters in Geneva yesterday that more than 110,000 people had received shelter and other relief items during that time, while food assistance had reached almost 300,000 people in Rakhine thanks to those approvals.

He slammed the "effective ban" on access by humanitarian workers, "paralysing the distribution of life-saving food, drinking water, shelter supplies and other relief to affected communities."

### cyclone barrels towards India, **Pakistan**

Four boys drowned in rough seas off the western Indian financial hub of Mumbai yesterday as India and Pakistan began evacuating people from coastal areas, two days before a cyclone is expected to make landfall.

Classified as a very severe cyclonic storm, Biparjoy is expected to land around tomorrow evening between Mandvi in India's Gujarat province and Karachi in southern Pakistan.

Meteorologists predict maximum sustained wind speeds of 125-135 km (78-84 miles) per hour, gusting to 150 km (93 miles) per hour.

"Four boys drowned at Juhu beach on Monday evening. So far, we have found the bodies of two, and the search is still ongoing to locate the remaining two," said a police official in Mumbai.

High waves in the Arabian Sea, accompanied by heavy rains and gusting winds pounded Gujarat's coastal areas, uprooting trees and resulting in a wall collapse that killed three people in Kutch and Rajkot districts, authorities said.

Eight districts in coastal Gujarat are expected to be affected. Fishing has been suspended until Friday and schools have declared holidays.

## A long-awaited nod to justice

#### ACC finally charge-sheets Basic Bank's Bacchu, but must explain the delay

We are pleased that the Anti-Corruption Commission (ACC) has at long last approved the charge sheet against former Basic Bank Chairman Sheikh Abdul Hye Bacchu, along with 146 others, in connection with 59 cases filed over the embezzlement of Tk 2,265 crore from the state-owned bank. The ACC, however, needs to explain why it took eight years to approve the charge sheet or implicate Bacchu, whose complicity has been heavily speculated on by financial analysts.

According to its rules, the ACC must complete investigations into a case within 180 days. If it cannot complete necessary work by then, it may extend it. But there is no excuse to delay it for as long as it did. So, naturally, the question is: why did the ACC do so despite frequent urgings by anti-corruption campaigners, and even the High Court, given its being one of the biggest embezzlement cases in the country's history? Were the people involved being protected? If so, who were protecting them? That in itself would be a crime worthy of investigation. Additionally, why weren't other board members of the bank implicated by the ACC? As one of the investigating officers has said, "Baachu with the help of the then managing director and company secretary created fake documents and sanctioned a loan while keeping the board in the dark." Earlier, however, the Bangladesh Bank said other board members were also involved. Clearly, there is a contradiction between the two

Moreover, the ACC charge sheet, it bears repeating, has been filed over the embezzlement of Tk 2,265 crore. But between 2009 and 2013, Tk 4,500 crore was swindled out of the bank. Even if the remaining money was recovered, crimes were committed to swindle it in the first place. What has the ACC done about those involved in it? Again, the ACC owes us an explanation.

The way the entire case has been handled so far is extremely disappointing. It has been clear from the start that some highly connected people were involved in the scam, and that government agencies have been reluctant to punish them for their crimes. While some headway has finally been made through the approval of the charge sheet, the authorities now must ensure that the entire workings of the scam are made public, and all the people involved are brought to justice.

## Stop risky dwelling on hill slopes

#### Arrival of monsoon raises concerns of landslides, calling for safety measures

With the monsoon around the corner, the continuous presence of homes on hilltops or hill slopes in the country has raised concerns of deadly landslides. This threat is all too real for residents in Chattogram city, as in other hilly areas witnessing a rapid spread of the build environment. In Chattogram, for example, the number of houses in the hilly area of Moti Jharna has increased from around 200 to over 1,000 over the last 15 years. This is despite the fact that, since 2007, at least 27 people died in this area due to landslides. Besides, in 26 hills across five other wards of Chattogram, there are about 6,175 illegal (and risky) settlements now. Imagine the threat that residents will face after a certain period of above-average rainfall, which points to the lack of care and planning by those in charge.

Surely the authorities are aware of the houses being built and people dwelling on hill slopes? Just as they must be aware of the landslides that can occur anytime? In June 2017, we saw the tragic deaths of at least 133 people in landslides. Of them, 100 were killed in Rangamati, 26 in Chattogram, and 7 in Bandarban. We must ask: have the authorities who are supposed to prevent illegal settlements and protect people learned anything from such recurrent tragedies? Not much, apparently. Otherwise, how is it that homes are increasingly being built in landslide-prone areas with the uninterrupted supplies of electricity, gas, and water? The Hill Management Committee occasionally conducts eviction drives but those are clearly too infrequent and ill-planned to make an impact. Environmentalists blame corruption and political interference for the lack of effect of measures aimed at preventing cutting hills and building settlements.

This calls for strong and sustained interventions from the higher authorities. They must stop risky dwelling and illegal settlements throughout the year, particularly now when the risks posed by monsoon are grave. Residents who are at risk, including those at the Moti Jharna area, must be relocated to safer places urgently.

# Power crisis: Perils of pursuing the old dangerous path



LNG prices in the spot market have dropped substantially. Coal prices have also gone down. If the situation with our forex reserves is so dire that it's driving the whole nation down to a point where citizens have to endure long hours of loadshedding, and industries have to suffer production losses that may eventually lead to their shutdown, the government should just openly proclaim a state of emergency and address the issues that led to this crisis in the first place.

In that light, it is imperative to analyse the power sector's responsibility for this crisis. First, capacity charges are one source to point fingers at. The country has to pay capacity charges to privately-owned power plants in dollars, and these charges have to be paid even if a power plant does not produce any electricity. Idle power plants, and ones which are functioning at half its capacity, are still receiving full capacity payments.

Second, the overwhelming burden of fuel import needs to be reassessed. on imports; the annual burden is more

It is axiomatic that if oil-fired power plants are being used to generate baseload electricity, fuel expenses will be very high. But the interesting fact is that more than 5,000MW of gas-fired power plants are sitting idle across the country. Electricity from gas-fired power plants is substantially cheaper than oil-fired electricity, given the current stable price of fuel in the global market. Seeing as the price of LNG has dropped in the spot market, why are gas-fired power plants not being utilised? The answer lies in the fact that we have not built enough regasification facilities to import more LNG. It is hard to comprehend the logic behind building gas-fired power plants with thousands of megawatts of generation capacity - with more on the way - while not planning efficient ways to supply the fuel needed to operate them. When LNG prices were high, not using LNG made sense. But does it make any sense

Our power sector is too heavily reliant time, because the authorities have

declared how much they expected to generate from each source of power. Our political leaders also did not envisage electricity shortage, citing the new coalfired power plants that have come into operation. Even when fuel prices were higher than what they are today, the authorities were somehow confident enough to claim that there would be little to no load-shedding this year.

With the serious dollar crisis, the only long-term solution is to lessen the import dependency of the energy and power sectors. Of course, this is easier said than done, but to what extent has the government seriously explored other options? After the onset of electricity shortage last year, the experts pointed to the serious neglect of domestic gas exploration. One year has gone by, but very little exploratory drilling has taken place. In the latest budget, very little has been allocated to gas exploration. To ensure even a minimum level of energy security Consumers are frustrated this through our own natural gas supply, the country needs to drill at least 25 consistently reassured the public that exploratory wells every year. power plants were available, we could save nearly \$1 million per day in fuel costs. These savings could even be used to pay off some of the overdue coal bills and import more coal. Of course, solar PV which is available only during the day (sunshine hours) cannot solve all our problems, but if designed correctly, it could save up to 20 percent of our fuel expenses. Along with more exploration for natural gas, a total of 30-40 percent savings in fuel cost is possible in Bangladesh.

It is unfortunate that the government is pursuing its old dangerous path of building more power plants and importing more LNG, coal and oil. Given our precarious dollar situation, this only forecasts more danger ahead. Fuel prices can escalate, the dollar crisis can deepen and consumers may resist further hike of energy prices. Given the difficult situation that the BPDB has put itself in, it is difficult to see a loadshedding-free Bangladesh anytime soon. In fact, it could conceivably get worse with the energy and power sectors becoming a huge burden on the economy and aggravating the dollar

# Advancing the Glasgow Dialogue on funding to address Loss and Damage

One of the outcomes of the COP26 held in United Kingdom's Glasgow in November, 2021 was a decision to hold a series of three annual Glasgow Dialogues on funding to address Loss and Damage, with each dialogue to be held in Bonn at the annual pre-COP event.

I just attended the second annual Glasgow Dialogue, which was held over the course of three days. Since I had the opportunity to also attend the first Glasgow Dialogue in Bonn last year, I can say that this year's dialogue was much more fruitful as the decision taken at COP27 in Egypt to set up a funding arrangement to address losses and damages with a Transitional Committee was set up to take the decision forward.

While the first Glasgow Dialogue held last year felt like an orphan with no ownership, this year the Transitional Committee owned the dialogue. As such the discussions were much more concrete under the leadership of the committee's co-chairs.

However, having said that, it still felt like we missed the opportunity to get into more substantive discussions about the complex issues that need

to be resolved by the Transitional Committee before going to COP28 in Dubai this December.

Three separate sessions were held over three days, of which only the second day was in breakout groups which allowed inputs from nongovernmental organisations, experts and others. On the other hand, the first and last days were one long series of prepared statements from groups of countries as well as individual nations, which felt more like a monologue rather than a dialogue.

I hope that the third and final Glasgow Dialogue next year is better organised to enable a real dialogue on the many substantive issues that need to be resolved.

I will attempt to highlight some of the substantive issues that were discussed:

The first issue causing differences of views amongst the parties was whether to focus on creating a new and separate fund for addressing loss and damage under the United Nations Framework Convention on Climate Change (UNFCCC) or to simply acknowledge the ecosystem of different funds that already exist and bring them together

**POLITICS OF** into a "mosaic" of connected funds.

The debate is between creating "fund" or simply acknowledging arrangements," "funding developing countries in favour of creating a new fund and most developed countries favouring existing funding arrangements.

While there are justifications for

both arguments, in my view, it need not be an either-or situation as we could create a specific new fund under UNFCCC which would then act in synergy with other existing funding arrangements. There are already some very specific aspects of losses and damages owing to the adverse impacts of human-induced climate change that are not being addressed by any existing funding arrangements.

One such issue is the forced displacement of millions of people, soon to be tens of millions, from low lying coastal zones and islands as well as from places like the horn of Africa. Just to cite one example, every day it is estimated that over 2000 migrants arrive in Dhaka mostly from the lowlying coastal districts with increasing numbers being displaced due to salinity intrusion into agricultural land. The number of climate displaced people will only increase and there are no systems in place to take care of them. Hence, helping these migrants should be the mandate and responsibility of a new Loss and Damage fund under UNFCCC.

Another major issue being discussed is how to raise additional funds needed for the new Loss and Damage Fund without cannibalising existing adaptation funds. There are a number of proposals for raising funds for loss and damage from innovative sources such as levies on maritime and air travel as well as taxing the profits of fossil fuel companies.

Let me end by sharing the proposal I made in my submission to the Glasgow Dialogue – I proposed that the incoming presidency of COP28 declare their intention to create the Dubai Loss and Damage Fund at COP28 and to put a solidarity levy of \$5 on all air passengers arriving in Dubai during COP28 and put the money into the Dubai Loss and Damage Fund. They could make the announcement now with six months left to challenge the Transitional Committee to come up with a plan to make the new fund operational.

# Artificial intelligence is still far from being 'intelligent'

Why does Big Tech want an immediate six-month pause on any further development?

Is artificial intelligence (AI) really "intelligent" in its creativity and decision-making? Or is it stealing others' works and perpetuating existing human biases?

This January, three artists filed a class-action lawsuit with the has confirmed. An algorithm Northern California District Court against AI imagery generators – Midjourney, Stable Diffusion, and DreamUp. They claimed these companies are using their artwork to generate newer ones - using a publicly available database of images including theirs called LAION-5B though the artists had not consented to have their copyrighted artworks to be included in the database, were not compensated for the use of their works, and their influence was not credited when AI images were produced using said works.


AI is literally scraping through billions of existing works produced by raw human labour to "produce newer ones." That's why several experts are already asking whether AI is at all "artificial" or "intelligent."

Tech writer Evgeny Morozov has argued that while the early AI systems were mostly rules and programmes, and could have some "artificiality," today's AI models draw their strength entirely from the works of actual humans. Built on vast amounts of human work stored at mammoth energy-hungry data centres, AI is not "intelligent" in the way human intelligence is as it cannot discern

things without extensive human training, as Microsoft's Kate Crawford has pointed out.

Even in decision making, AImodels can have strong biases as a 2019 article published in *Nature* common in US hospitals has been systematically discriminating against black people. The study found that hospitals traditionally assign them lower risk scores than white people. Automatically, the algorithm takes that as a cue and puts blacks in a lesser risk group, regardless of the prevailing medical conditions. In

another case, a painting bot returned the image of a salmon steak in water when asked to draw a swimming salmon. The AI model couldn't make this simple judgement that even a toddler could do.

However, despite not being anywhere near "intelligent," recent developments, especially the release of ChatGPT in November last year, have raised dramatic concerns about the effects of AI on human society. Renowned tech experts have published an open letter calling for an immediate pause on all AI development for six months. Its signatories include many big names and AI heavyweights, including Elon Musk from Tesla, Emad Mostaque from Stability AI, Sam Altman from OpenAI, Demis Hassabis from that the technology was not widely

Google's DeepMind, and Kevin Scott available through a convenient from Microsoft. Altman even advised the US government to issue licenses to trusted companies (Does this mean only Big Techs?) to train AI models.

interface. Smaller entrepreneurs will soon develop better and more efficient AI-based models at much lesser costs, some of which is already available at GitHub, a popular repository for open-source noncommercial software. That worries the Big Techs, made abundantly clear by a leaked Google internal

The long memo from a Google researcher said, "People will not pay for a restricted model when free, unrestricted alternatives are comparable in quality...We Have No Moat." Licenses would be a "kinda moat," as Stability AI's CEO Emad Mostaque puts it bluntly, moat being jargon for a way to secure a business

Al Now Institute, a research non-profit that addresses the concentration of power in the tech industry, highlights the perils of unregulated AI in its April 2023 report because the AI boom will make the powerful Big Techs even more powerful. AI models depend on vast amounts of data, and super-fast computing power to process it, both of which only Big Techs can afford. Without access to these resources, no entrepreneur or researcher can develop any meaningful AI application, as an MIT Technical Review article elaborates.

Yes, we need regulations for AI development, and a pause if necessary, but not for the reasons mentioned in the open letter. It's to ensure that AI technology remains open source and democratic.

The other reason AI should be regulated is the way social media platforms have used it to fuel gender bias and extreme polarisation, and played on social divisions resulting in unspeakable violence on a massive scale (such as in Myanmar using Facebook). AI models will amplify both intentional misinformation (simple inaccuracies) disinformation (false information) simply because they are trained on such data to produce more data (model cannibalism effect). Large language models can keep repeating fabricated and false information because of a phenomenon called 'hallucination' which independent watchdog NewsGuard has found in several online news portals.

Intentional or otherwise, all these could be quite handy in manipulating public opinion or creating biases to benefit those in power. That makes it even more necessary to regulate AI. To ensure that the benefits of AI reaches everyone, humans must always be on top of it.

The image of 60-year-old rickshaw puller Abdul Halim resting on a footpath beside Dhaka's Gulistan Park, exhausted and drained under the heat of the scorching summer sun, has been haunting me since I saw the photo on the front page of this daily on June 7. The heartwrenching image stayed with me the entire day, so much so that later that night, I was woken up by jarring dreams of the old man pulling the weight of a hundred passengers in flashy clothes - middle-aged men and women, young boys and girls, children cramped in the small rickshaw seat – through the messy streets of Dhaka, under the glaring sun. I saw Abdul Halim telling himself to keep pedalling, so that he would earn enough to take home some coarse rice and salt, and some

medicines for his ailing wife.

But then his ageing back and legs started giving away, and as the impatient passengers started yelling at him to peddle faster, he suddenly stopped. He looked at me, his wearied eyes boring heavily into mine, and he gave a wail of anguish, the deafening sound reverberating into reality. And suddenly he was pulled into a black void by a long filthy hand. His passengers kept yelling, without even realising he was gone. That's when I woke up.

What kind of a country do we live in where 60-year-olds are forced to pull rickshaws to earn livelihood?



# RAZINGHILLS for chicken shed

We filed a case under the soil management act with the local police station against the owners of the hills on Tuesday.

A vested quarter has been accused of cutting hills in Chattogram's Dharmapur union of Fatikchhari upazila, to construct a chicken

This act has been carried out without obtaining any approval from the Department of Environment (DoE), leaving locals and environmentalists dismayed.

The ownership of the hills is attributed to Abu Bakkar and Taslimul Alam, according to the land office of the union. However, a local source, seeking anonymity, has alleged that Nahar Agro, an agro business company based in Chattogram, is behind the hill cutting, using their connections with influential figures.

During a recent investigation conducted by this correspondent in the area, it was observed that workers were carving through the hills with heavy machinery, including an excavator and a soil-cutting machine. Additionally, an on-site mud house was being constructed to accommodate the workers involved in this project.

Mohammad Rashed, a day labourer said, "I have been working for Nahar Agro on this project for the past two days."

Meanwhile, Mohammad Anwar, the project supervisor, hesitated to confirm whether the necessary permission had been obtained for the hill cutting, stating, "I am a staff member of



Nahar Agro... I cannot say whether there is permission to cut the hill."

Abu Bakkar, owner of a part of the hills, told The Daily Star, "We have sold the land to Rakibur Rahman Tutul, managing director of the Nahar Agro Group, but the registry deed has not been completed yet."

However, he did not disclose when he sold

of the Nahar Agro Group, claimed that his company isn't cutting hills there.

"We are only talking with the owners of hills to buy the land. We haven't bought the land yet," he claimed.

However, the workers involved in hill cutting admitted that they are employees of Nahar Agro and they collect their salary from the nearby Nahar Agro office. Mentionable, Nahar Agro has already

constructed another shed next to the area where chickens have been reared for the past

Meanwhile, upazila administration officials confirmed that they visited the area and found evidence of hill cutting.

Sabbir Ahmed Sunny, upazila nirbahi officer of Fatikchhari, said, "We filed a case under the soil management act with the local police station against the owners of the hills on Tuesday."

According to Bangladesh Environment Preservation Act 1995 (amended in 2000), cutting a hill without DoE's approval is illegal.

Punishment as per this act includes up to Rakibur Rahman Tutul, managing director two years' imprisonment or Tk 2 lakh fine, or both for first-time offenders. For subsequent offence, it is up to 10 years' imprisonment or Tk 10 lakh fine, or both.

Meanwhile, DoE officials confirmed that none had taken any permission for cutting

Ferdous Anwar, deputy director of the DoE Chattogram, told The Daily Star, "We will take legal action against those who razed hills after necessary investigation."

According to data from Bangladesh Environment Forum, 120 hills disappeared from Chattogram city in four decades. In 1976, there were 32.37 square km of hills in the port city, which decreased to 14.02 square

# **Tourist bus** launched for first time

For the first time, two double-decker bus services have been introduced in Chattogram city for tourists. The buses, operational since last Saturday, is set to ply the port city's Tiger Pass-Faujdarhat DC Park-Patenga sea beach route.

The Chattogram District Administration and Bangladesh Road Transport Corporation joint venture was inaugurated by ABM Amin Ullah Nuri, secretary of the Road Transport and Highways Division, on Saturday at the city's Circuit House.

The buses are making two trips on weekdays, with the first one starting at 3:00pm from Tiger Pass, followed by the second one an hour later from the same spot.

Three trips on the same route is available on Fridays at 9:00am, 3:00pm, and 4:00pm, while four others are scheduled for Saturdays at 9:30am, 10:30am, 3:00pm, and 4:00pm, according to Chattogram District Administration.

The return trips are scheduled from Patenga beach at 12:00pm, 7:00pm, and 8:00pm on Fridays, and at 1:00pm, 2:00pm, 7:00pm, and 8:00pm on Saturdays.

The ticket prices range between Tk 30-70 per person.

"These two buses were gifted by the prime minister to boost tourism in the district. We plan to introduce new buses with better facilities on other routes too," said Abul Bashar Mohammad Fakhruzzaman, deputy commissioner of the

Omar Faruq Emon, a local, said, "We had to spend much more to visit these spots. However, bearing the concerns over security in mind, I believe the tourist police should be engaged to serve local and foreign travellers better."

TOUGH TIME FOR RAWHIDE TRADERS

# They want bank loans to survive

Chattogram rawhide traders want bank loans on easy terms to recover loses after the area's 50 percent of tanneries have been closed due to the absence of a competitive market in the port city.

They are going through a tough time with their business and forced to sell their rawhide at cheaper rates. Rawhide trade was vibrant in

Chattogram years ago, but now it has decreased significantly, said traders.

They said during Eid-ul-Azha, most of the rawhide is sold at a lower price than the price fixed by the government. Besides, collection of rawhide has been decreased as the processing industries have almost collapsed, as it is difficult to comply with the regulations of the Department of Environment.

According to the traders, there were at least 22 tanneries in the port city. Since 1971, various reasons contributed to the shutdown of the factories. Among them, only one named Riff Leather owned by TK Group has survived till now.

Due to such closure in Chattogram, the warehouses have to depend on Dhaka, and the arrears of sold rawhide have increased every year, they said.

According to the data of Chattogram Rawhide Warehouse Traders Association, a total of 112 rawhide merchants belong to this

association and another 150 are outside it in Chattogram. However, only 52 merchants, out of 112, are running their businesses and the rest 60 have closed down in the last few

Moslem Uddin, president of the association, said, "Most of the products have to be sold in Dhaka as there is no competitive market in Chattogram. Many businesspersons are closing their businesses due to financial crisis. They will be able to restore the business if the government gives bank loans on easy terms."

"In addition, the government should arrange a specific tannery zone for Chattogram and a central ETP, considering the environment pollution," he added.

Enamul Haque, a rawhide trader at Aturar Depot Bazar area, said, "Now Chattogram-based Riff Leather buy only 10-15 percent of total collection of rawhide. And for the rest we have to depend on the tanneries in Dhaka..."

He also said about 20,000-30,000 skins are wasted or damaged every year as the tannery owners are not interested to buy those.

This year, the Chattogram traders are expected to collect at least four lakh pieces of rawhide of cattle after Eid-ul-Azha. They collected 4.43 lakh in 2022, 4.82 lakh in 2021, 5.12 lakh in 2020, 5.5 lakh in 2019 and 5.75 lakh

# In dire need of a foot-over bridge

Pedestrians are forced to cross the wide intersection of Sholashahar Gate-2 putting their lives at risk in the absence of a foot-over

The intersection is one of the most hectic spots in the port city with different public and private vehicles moving towards different routes. According to Traffic Department at

Chattogram Metropolitan Police (CMP), around 2,000 vehicles ply at this intersection in an hour at rush time.

Typically, vehicles traversing four routes within the port city must pass through this intersection.

Locals and traffic department sources said due to the construction of a culvert at Muradpur intersection, which has halted vehicular traffic on the Muradpur to Oxygen route for months, the majority of vehicles travelling on the route



also use the intersection. As a result, it has become busier and more chaotic.

"Every day, we have to cross this intersection putting our lives at risk," said 47-year-old Ismail, a resident of the area. "I am a local in this area and I've never seen a foot-over bridge in this busy intersection since my childhood," he added.

Farzana Akter, another local, said, "Nobody will understand what goes on in my mind when I cross the intersection with my seven-year-old son. Not even a zebra crossing exists in this intersection. Sometimes, I can hear my heart beating when I see any big vehicle coming towards us while crossing the intersection."

Tarigul Islam, traffic inspector of CMP, said, "Even officials of the department of traffic face difficulties in controlling traffic in the area. A foot-over bridge is badly needed in this intersection so that pedestrians can cross the road safely."

Contacted, Rafiqul Islam, chief engineer of Chattogram City Corporation, said a total of 38 foot-over bridges will be built on different roads and intersections in the port city under a mega project, which will start soon. "A footover bridge will also be built at Sholashahar intersection under this project," he added.

# Tamim ruled out of Afghan Test

After intense speculation over the past few days, experienced batter Tamim Iqbal was eventually ruled out of the one-off Test against Afghanistan starting from today, the Bangladesh Cricket Board confirmed in a press release vesterday.

Bangladesh's ODI had been struggling after an old back injury resurfaced during a training session on Sunday, leading to concerns about whether he would recover in

"Tamim has been experiencing lower back pain, which has troubled him from time to time. Our treatment and procedures focused on reducing the pain and improving his functional ability. Unfortunately, his condition hasn't improved sufficiently enough for him to play the Test match. He felt stiffness and pain while batting and fielding in training and has been unable to complete the physical preparations required to play for five days," team physio Muzadded Alpha Sany was quoted as saying in the press

According to sources, Tamim was keen to play but the team management were unwilling to take risks. Tamim had missed the series against India last year due to a groin injury before returning for the one-day series against England and also playing both the home and away ODI

It was learned that Tamim first suffered the back injury during the India series last year. During the trip to England this year for the Ireland series, Tamim underwent an MRI which revealed that he had a tear.

Since receiving Test status in 2017, Afghanistan have only played just six Tests, winning three, including a 224-run win against Bangladesh in Chattogram in 2019. Interestingly, the one-off Test at the Sher-e-Bangla National Stadium in Mirpur from today will be Hashmatullah Shahidi and Co.'s first Test in over two years.

Faced with the challenges that come from not playing a Test match since facing Zimbabwe in 2021, head coach Jonathan Trott looked at Bangladesh as an example of how to approach the early days in the longest format.

"I think we are just as ambitious as Bangladesh when they started playing Tests. You see Bangladesh

going on to beat other teams at home. it's important to have that ambition. I think it is what drives the game. All Test cricketers will tell you that they like playing Test cricket. They will say it is their favourite format because of the challenges and tests. Individually as well. It is an exciting thing, something that I am looking forward to seeing tomorrow [today]," Trott said vesterday.

In the absence of star cricketer Rashid Khan, at least six Afghan cricketers are waiting to make their Test debut. The 52-year-old Englishman admitted that the Tigers would have the advantage on their home turf.

"I think any team playing at home will have a bit of an advantage. Certainly a team that has played more Tests by a long stretch will also have a bit of an advantage. It doesn't mean they will play better than us tomorrow. We prepared really well. I feel the players have trained exceptionally well. They are excited to play a Test in Bangladesh. Whatever has happened in the past, whoever is the favourite and whatever the conditions, it is all about what happens tomorrow [Wednesday] and who does it the best. It is my job to make sure everyone is ready," he said.

# Sporting conditions a test of Tigers' strengths

The selection of five pacers in the Bangladesh squad was a major talking point ahead of the oneoff Test against Afghanistan, slated to begin today at Dhaka. Inevitably, even a day ahead of the match, discussions surrounded the greenish pitch. However, conditions can change pretty fast in Mirpur, but above all else the Tigers were looking for good Test match conditions in order to grow.

Of the last 10 Tests that the Tigers have played, they won only one while losing eight. Thus their search for consistency in the format is an ongoing process. In the context of competitiveness, there are no World Test Championship points to be had from the match as it is not part of the WTC cycle.

Afghanistan left their best spinner Rashid Khan at home, one quite wants to risk stars during a World Cup year. The target then for Bangladesh will be to test their own strengths against an Afghan side that played their last Test in 2021 and are lacking in Test experience.

Tigers' head coach Chandika Hathurusingha has a good idea about conditions and bluntly said that the wicket would behave like a sporting track. The specific plan various conditions at home. After

Ireland in Sylhet, the plan for Afghanistan was an extension of curating conditions conducive for the pace unit.

"Grass is green because of the rain the last few days. I have seen green wickets here before. We played against Ireland on a green wicket," he said when asked about the greenish looking pitch.

"We have fast bowlers but we need to give them conditions that



which adds to the feeling that no suits their strengths. We have good spinners as well. So, this game is only starting as a green wicket. With this heat, it will deteriorate very quickly and then it may help the spinners in the latter parts of the game. So, I think this pitch is a good, sporting wicket for everybody: batter, fast bowlers and spinners. So, I'd like to see a good contest," Hathurusingha said at the press conference yesterday.

On the broader context of Test is to test the team's strengths in match philosophy, Hathrusingha was willing to let go of the rigidity

reparing green wickets against of playing only in spin-friendly conditions at home while the search goes on for a particular brand of cricket.

"Before that Ireland series, we wanted to play a certain brand of cricket, regardless of the result. So yes, our endgame is to get results, but we want to understand how our skillset would last over five days and varying conditions, challenging us to play in a certain way.

'When we wanted to play and get some points, when we play the Test championship, we might tactically do different things, but this game is giving us an opportunity to play on a sporting wicket," he added.

A member of the team management opined that such wickets would become more common at home if the continued to rise. The top four pacers in Bangladesh Test setup Khaled Ahmed, Ebadot Hossain,

Taskin Ahmed and Shoriful Islam have produced just 19 wickets at home in the last two years. The very same speedsters accounted for a whopping 52 wickets away from home in the same period.

"Whether championship or not, we'll find the way best-suited to us when we are playing at home. At the same time, we keep an eye on our development to play away from home," the head coach said, driving his point home as Tigers look to test themselves

# **PSG-Mbappe** saga continues

Kylian Mbappe has never discussed extending his contract with Paris Saint-Germain beyond next year, the France superstar told AFP in a statement on ruesday, the day after he sent a letter to the club confirming he would not take up an option to remain at the French champions until 2025.

The club "were informed on July 15, 2022" of his decision not to activate an option to extend his contract, which ends after next season, for an extra year "and the only aim of the letter was to confirm what had already been spoken about previously,' said the statement.

"Kylian Mbappe and his entourage confirm that this matter has not been discussed since over the course of the year, except a fortnight ago to announce the sending of the letter.

"No potential contract extension has been mentioned," it continued.

"After maintaining publicly in recent weeks that he would be a PSG player next season, Kylian Mbappe has not asked to leave this summer and has just confirmed to the club that he would not be activating the extra year," Mbappe and his entourage explained.

The statement concluded by saying that the 2018 World Cup winner "and his entourage regret that the letter was circulated in the media and that these exchanges were made public with the sole aim of damaging their image and the discussions with the club".

Mbappe's letter to PSG comes a year after the 24-year-old France striker signed a new deal to stay at the French champions, turning down an approach from Real Madrid in the process.

According to sources with knowledge of the discussions, PSG were surprised that the letter was leaked and do not envisage letting Mbappe leave for nothing.

That means either renegotiating the contract or selling him in this transfer window.

## Nadal out of top 100 after 20 years

While Novak Djokovic reclaimed the World No. 1 ranking from Carlos Alcaraz after winning a record 23rd Grand Slam title at the French Open, there were clear signs of the end of an era as Rafael Nadal dropped out of the top 100 and reached his worst position in the rankings since March of 2003, when he was just a 16-year-old.

Nadal, a 14-time French Open champion, has endured an injury-plagued season and not played since January because of a hip injury sustained during the Australian

The 37-year-old has dropped from 15th to 136th in the rankings due to his continued absence from the tour. He underwent surgery earlier this month and is expected to be out for five months.

Meanwhile, Djokovic began his recordextending 388th week at the summit on Monday, jumping two places in the standings after his victory in Paris at the weekend. Alcaraz dropped to second place while Daniil Medvedev, who crashed out in the first round, also slid one place down to third. Roland Garros runner-up Casper Ruud remained in fourth place.

In the women's rankings, Iga Swiatek retained top spot after defending her French Open title. She has held the ranking since April 2022, moving to the summit following Ash Barty's retirement.

# Women footballers return from break with not much to look for

With no domestic or international engagement on the cards, the national women's team footballers started returning to the residential camp yesterday after enjoying a five-day break as the Women's Super League (WSL) failed to kick off.

The announced start of the proposed league has been deferred twice -- May 15 and June 10, leaving the players frustrated and they asked for a break from continuous training. "Nineteen out of 34 players have

joined the camp so far and the rest are on their way to Dhaka. Only Tahura Khatun will join the camp a couple of days later as she is suffering from fever," assistant coach Mahbubur Rahman Litu informed, adding that the players will resume training this morning.

"Maria [Manda], Monika [Chakma] and Sabina [Khatun] requested us for four or five days' break. I conveyed the message to Paul [Smalley] sir and [Mahfuza Akter] Kiran apa, who granted a five-day break," added Litu.

Krishna Rani Sarker and Sanjida Akter were the first to return to Dhaka after enjoying their break in Rangamati along with Anuching Mogini and others.

Asked whether there is any chance of the league getting underway soon, Fahad said, "Now I have confirmed all four franchises for the participation and WSL will be held. We may not do much for the players in the inaugural season but I think they will be happy with the

# Those bound for north may face hassle

Possibility of gridlock at 13 points on **Dhaka-Tangail-Rangpur highway**

Expansion work on highways, short holidays, and roadside cattle markets are likely to cause sufferings to northbound Eid holidaymakers.

They may face traffic congestion at 13 points on the Dhaka-Tangail-Rangpur highway unless proper measures are taken. Incomplete BRT works may cause congestion on the Tongi-Gazipur section.

Non-automated toll collection at Padma Bridge and the Dhaka-Mawa-Bhanga Expressway could cause long queues of south-bound vehicles amid the Eid rush.

Besides, traffic could grind to a halt due to breakdowns of rickety, unfit vehicles and crashes caused by the large number of motorbikes that will be on the highways.

Road conditions from Elenga to Bangabandhu East and Sirajganj to Bogura may cause suffering unless proper measures are taken.

The Daily Star came to know about the situation after talking to police, officials concerned and transport

In this situation, Road Transport and Bridges Minister Obaidul Quader and Home Minister Asaduzzaman Khan are scheduled to hold separate meetings tomorrow and Sunday to make the Eid journey safe and smooth.

Last year, ahead of Eid-ul-Azha, people heading towards the north and north-western parts suffered immensely because of congestions. However, people's journey before this year's Eid-ul-Fitr was relatively smooth.

#### ROAD WORK MAJOR CONCERN

Roads and Highways Department (RHD) is turning the 190km Elenga-Hatikumrul-Rangpur highway into a four-lane highway. The Bangabandhu Bridge approach road in the east has two lanes, which could become a bottleneck.

The 13 choke points are Elenga intersection, Jhawel Bridge, Koddar Mor, Nalka Bridge, Hatikumrul intersection, Jura Bridge, Goga Bridge, Chandaikona Bazar, Goibgandaganj Bazar, Mokamtola, Polashbari Bazar, Shotibari and Boro Dorga.

Mozammel Haque, deputy inspector general (operations) of highway police, said some obstacles could be there on this highway because of development work.

"We have already held meetings with RHD officials and they assured us that they will make arrangements for uninterrupted transport movement," he told The Daily Star recently.

Mosharref Hossain, general manager of Hanif Paribahan, echoed him.

Road conditions from Elenga to Bangabandhu East and Sirajganj to Bogura may cause suffering unless proper measures are taken.

After the closure of garment factories for the holidays, Savar-Chandina road may witness congestion if traffic movement is not controlled properly, he said yesterday.

Contacted on May 6, Project Director Waliur Rahman said there was no congestion during the last Eid and the road condition is now better than then.

Asked about the 13 points, he said they have already opened some bridges and flyovers at those points, so the SEE PAGE 6 COL 1

#### Victims of Shariatpur give vivid description of ordeal

The High Court yesterday summoned the chief judicial magistrate of Shariatpur, the district's additional superintendent of police (Naria Circle), and the officer-incharge of the Padma Bridge South Police Station to appear before it and explain the torture of two businessmen in custody and them being sent to jail even though they had secured bail from the HC.

The two policemen were sued on June 7 for brutally torture of businessmen and brothers Saddam and Bokul Chowkdar in Shariatpur, their unlawful detention, and extortion of Tk 72 lakh from their family.

The OC has since been withdrawn and attached to the police lines. "Can the police beat them in such a manner even if they did not get bail in the case against them? Withdrawal of the officerin-charge from the police station is not a punishment for the incident. Rather it is like a promotion," said Justice Mustafa Zaman Islam.

# Islami Andolan looks to expand its horizon

Plans to tie up with like-minded parties to press home demand for polls-time all-party govt

Islami Andolan Bangladesh wants to set up an Islamist alliance with other likeminded parties and wage a movement to press home its demand for an all-party election-time government ahead of the next national polls.

The organisation will now focus more on street agitations to realise its demand instead of taking part in elections to local government bodies, said

The IAB is taking the stance following Monday's polls to Barishal and Khulna city corporations. The party's mayoral nominee in the Barishal city polls, Syed Faizul Karim, also its nayeb-e-ameer, came under an attack on election day.

The party has already announced that it will not take part in Rajshahi and Sylhet city polls on June 21.

Sources said although the Awami League and the BNP are trying to bring IAB  $\,$ into their folds as an electoral ally, the Islamist party has decided to continue its activities following its "go it alone" policy as the leaders believe that adopting this policy yielded good results for them in the past.

Therefore, the party wants to form a "third alliance", apart from those led by the AL and the BNP. To make it happen, the IAB has already started communicating with like-minded Islamist parties, said the sources.

"We will concentrate on a movement to realise our demand for an all-party election-time government. Of course we will wage a movement. The word andolan [movement] is in the name of our party," Gazi Ataur Rahman, senior joint general secretary of IAB, told The Daily Star yesterday.

He, however, said that their movement will be peaceful as the party is against

Ataur said the AL and the BNP failed to meet the people's expectations over the years and that's why they were trying to forge a "third alliance".

About its decision not to participate in the elections to local government bodies, the IAB leader said they had decided to take part in the polls considering that it was the main way to strengthen the party grassroots. "But we have now decided not to participate in any elections.'

# Billion-year-old rocks reveal traces of ancient life

Plants, algae, fungi, and animals -including humans -- are all eukaryotes: forms with complex, nucleus-containing cells.

discovery of organic compounds in ancient rocks in Australia helps illuminate the early history of eukaryotes, suggesting

that this group was already abundant more than a billion years ago, according to a new study.

Eukaryotes are believed to date back 2 billion years, but scientists thought that they only became widespread about 800 million years ago. said Dr Benjamin Nettersheim, one of the co-first authors of the study published in Nature.

However, newfound traces of molecules possibly produced by eukarvotes are up to 1.6 billion years old, which indicates "that early eukaryotes were already ecologically important for all this time," said Nettersheim, who is a postdoctoral researcher in geobiology at the MARUM Center for Marine Environmental Sciences at the University of Bremen in Germany. "We just didn't see their traces until now. They've kind of been hidden in plain sight."

The evidence of these ancient eukaryotes took the form of biological molecules that they produced. Modern eukaryotes produce a suite of signature biomolecules, including cholesterols.

#### Trump pleads not guilty in federal documents case

Former president Donald Trump pleaded guilty early today to federal criminal charges that he



unlawfully kept national-security documents when he left office and lied to officials who sought to recover them.

Trump's plea, entered before US Magistrate Judge Jonathan Goodman in a federal court in Miami, sets up a legal battle likely to play out over coming months as he campaigns to win back the presidency in a November 2024 election. Experts say it could be a year or more before a trial takes place.

The hearing was closed to cameras and live broadcasts. Trump's former aide Walt Nauta, also charged in the case, pleaded not guilty as well, the Associated Press reported.

CNN reported Trump was allowed to leave court without conditions or travel restrictions and no cash bond was required. Goodman ruled that Trump was not allowed to communicate with potential witnesses in the case, the network said.
