## **CRIMINOLOGY DEPT AT DU** Committee formed to probe poor grades

The authorities of Dhaka University vesterday formed a committee to investigate a complaint from four students of the Criminology Department regarding the poor marks they received in a course taught by Prof Zia Rahman.

Prof ASM Maksud Kamal, pro vice-chancellor (academic) of the university, will lead the committee, according to a decision made at the syndicate meeting.

Multiple syndicate members have confirmed this to The Daily Star. The other members are Prof Shima Zaman, dean of law faculty; Dr Tasneem Arefa Siddiqui, chairperson of political science; and Bahalul Haque Chowdhury, controller of examination.

Four 4th-year students on December 26 wrote to the VC and pro-VC asking that their answer scripts for the 7th semester final exams be re-evaluated by an independent exam committee. The students -- Sakin Tanvir, Mehbeez Binte Matiur, Shozayet Ullah Bhuiyan, and Tahnan Mahjabin Adhora -- wrote the letter after learning that they got poor scores on a course taught by Prof Zia.

On January 19, they also learnt that they got 2 out of 20 on a mid-term test on Prof Zia's course.

The four wrote to the VC, while sending copies to the pro-VC and controller on June 1 demanding the same.

They alleged teachers do not hold required number of lasses, deliberately delay publishing sessional marks, and fail to submit evaluated answer scripts on time, resulting in the delay of results publication and graduation.
