

RHD fears it'll create chaos on highway

METRO LINE ON DHAKA-ARICHA ROUTE

MRT authorities ignore RHD warning, go ahead with its plan



MRT LINE-5 (NORTHERN ROUTE)

- From Hemayetpur (Savar) to Bhatara in Dhaka city

The Dhaka-Aricha Highway may face long tailbacks and see a rise in road crashes if a metro rail line is built on the highway as proposed by the metro rail authorities, according to engineers of the Roads and Highways

Construction of the metro rail line, known as Mass Rapid Transit (MRT) Line-5 (Northern Route), will scupper an expansion plan of the highway conceived by the RHD, they said. It may also make one of the country's most important highways "a death-trap", they added.

Although serious reservations have been raised about the proposed metro rail route between Hemayetpur and Aminbazar long ago, the metro rail authorities did not pay any heed to the concerns and prepared a detailed design instead, they said.

The MRT Line-5 project, which is expected to start later this month or early next month, is being implemented by Dhaka Mass Transit Company Ltd (DMTCL). Both the RHD and the DMTCL are under the same division (Road Transport and Highways Division) of the Ministry of Road Transport and Bridges.

Carrier to ink codeshare deal with Gulf Air; agreement with JAL to make hops to US easier

Biman is going for codeshare and interline agreements with Gulf Air and Japan Airlines and this will allow its passengers to go to destinations the two carriers serve.

This is the first time Biman is going for such agreements, said MD and CEO Shafiul Azim, adding that through the codeshare agreement with Gulf Air, the national flag carrier of Bahrain, Biman plans to expand

its reach into Europe where Gulf Air has

The interline agreement with Japan Airlines will allow Biman passengers to travel to the US via Tokyo, sources in Biman

Biman is scheduled to start direct flights to Narita (Tokyo) on September 1.

Biman expects both deals will be signed before September.

RPO AMENDMENT Bill passed in JS amid protest by opposition

EC's power to halt elections curtailed

Defying strong protests from opposition MPs, parliament yesterday passed the Representation of the People Order (amendment) Bill-2023 with a provision for reducing the Election Commission's power to cancel polls.

Law Minister Anisul Hug, however, claimed that the amended law would not curtail the EC's power.

Suspending polls in an entire constituency over disturbances in some polling stations is "undemocratic" and that's why this amendment has been made, he said.

Opposition lawmakers from the Jatiya Party and Gonoforum said the EC is a constitutional body. There should not be any problem if it retained the power, they added.

The MPs said the commission would use the power if necessary. But if the power is taken away, the EC wouldn't have the opportunity to suspend polls even if it deemed necessary

The EC has hinted that 12th national election will be held either at the end of December or at the beginning of January.

Major rivers seeing rise in water level

Heavy rains may cause Teesta, Dharla, Dudhkumar to swell; Surma, Someshwari flowing above danger mark

As flood waters recede in the northeast districts, major rivers are swelling in the northern districts.

Levels of the water in the Teesta, the Dharala and the Dudhkumar rivers will rise rapidly if it rains upstream, said a bulletin of the Flood Forecasting and Warning Centre (FFWC) yesterday.

"The Brahmaputra-Jamuna and the Ganges-Padma rivers are in a rising trend, which may continue in the next 48 hours," said the bulletin released at 9:00am.

As water levels in major rivers fall in the north-eastern region, flood waters are receding in Sunamganj and Netrokona districts, it added.

In Lalmonirhat, the Teesta inundated the low-lying areas yesterday morning

and continued to flood new areas.

People were seen commuting on boats as roads went under water. "My village has been inundated.

My Aman seedbeds are now under water," said Nazar Ali, 60, a farmer of Khuniyagach area of Lalmonirhat. However, the levels of water in the

Teesta and the Dharla are still within safe limits and a long-term flood seems unlikely, said Shunil Kumar, executive engineer of Bangladesh Development Board.

In Bogura, the Jamuna has been swelling rapidly since Monday, and if it keeps this rate, some areas may get inundated, said BWDB Executive Engineer Nazmul Haque, adding that a major flood in the next 15 days was unlikely.

Nurse 'tortures' her 11-yr-old house help for over a year

A nurse of Sylhet MAG Osmani Medical College Hospital (SOMCH) has been accused of torturing her 11-year-old house help for over a year in the city's Nabab Road area.

The victim is currently undergoing treatment at the Sylhet MAG Osmani Medical College Hospital's One-Stop Crisis Centre.

On Monday, a case was filed in this connection with Sylhet's Kotwali Police

The girl's father, a day labourer from Sylhet's Gowainghat upazila, said nurse Shahnaj was also from his village. He said, "My daughter studied

until the fifth grade. Considering my financial constraints and Shahnaj's request, I sent her to work as a domestic help around a year and a half ago.

"My daughter has been abused by the nurse since she went to work for her. The nurse intimidated her into hiding the scars from us, but we finally saw them when she came home for Eid."

The victim said, "She [Shahnaj] would often beat me with a hot spatula. She would hit me if she couldn't find her money or if she thought I had eaten too much food. I would scream in pain, but no one in the neighbourhood could hear me. I was also afraid to tell my parents about the abuse because I was scared of what she would do to me."

Despite multiple attempts, this correspondent failed to reach Shahnaj on her phone. Her number was found

Contacted, SOMCH Director Brig Mahbubur Rahman Bhuiyan said, "I've not been officially informed of the matter, but it has come to my attention. The hospital authority will soon seek an official explanation from the accused nurse and take necessary steps accordingly."

Woman raped in Dhanmondi restaurant

The father of the 21-year-old victim


filed a rape case with Dhanmondi Police Station yesterday afternoon against an unnamed accused.

Parvez Islam, officer-in-charge of Dhanmondi Police Station, said that a 20- to 24-year-old youth, tactfully took the victim to a closed restaurant on the sixth floor of a building on Sat Masjid Road and raped her on the restaurant's balcony.

The victim is currently undergoing treatment at the One-Stop Crisis Centre (OCC) at Dhaka Medical College Hospital.

The OC added that efforts are on to apprehend the suspect.

Bystander shot, 14 held

UNB, Narayanganj

Two rival drug gangs clashed in Narayanganj's Chanpara early yesterday, leaving at least 10 people injured, including a bystander who was shot.

Following the incident, 14 people were detained and the situation was brought under control.

Police said there was a longstanding dispute between the Joynal group and the Shamser group over establishing supremacy and controlling the drug trade at Chanpara Rehabilitation Centre.

The two groups equipped with arms locked into clashes on Monday night and early yesterday.

Abir Hossain, senior assistant superintendent of district police, said a bystander named Hridoy sustained bullet injuries on his way home from his workplace when the two groups were exchanging

"He is now undergoing treatment at Dhaka Medical College Hospital. The other injured were also admitted to several hospitals in the district."

Ex-Jubo League leader accused of rape, extortion

A former Jubo League leader and his two associates were sued yesterday in a case filed over the rape of a woman in Kulaura upazila of Moulvibazar.

The accused are Shalik Baksh, 40, former general secretary of Hajipur union unit Jubo League, and his associates Hasanul Bari Sani, 35, and Saifur Rahman, 32.

The trio was also accused of extorting Tk 50,000 from the woman after threatening to blackmail her with photos and videos of the incident.

According to the case, on Eid day, the woman visited a relative's house in a village in the upazila. At one point, her relative went to his shop in the market, leaving the woman at home.

Finding the woman home alone, Shalik and his two associates broke into the house and raped the

RHD fears it'll create chaos on highway

rail authorities said that they had prepared the detailed design of the proposed line considering all technical aspects and the RHD's future plans about the highway.

"Asking us to change the route now basically means cancelling the construction of the metro rail which will start soon," Md Aftab Hossain Khan, project director of MRT-5 (northern route), told The Daily Star. The fears and frustrations shared

by the RHD engineers regarding the issue are reflected in different documents they have shared with their higher authorities, including the Road Transport and Highways

The 20km rail line with 14 stations will connect Hemayetpur and Bhatara via Gabtoli, Mirpur, and Gulshan. The 5.6km section, from Hemavetpur to Aminbazar, will be elevated while a 13.5km section from Gabtoli to Natunbazar will be underground. The remaining 0.9km will be elevated, too.

Physical work on the Tk 41,239 crore project will start with the development of a depot at Hemayetput. The metro rail authorities have already hired a contractor for the work and Prime Minister Sheikh Hasina is expected to inaugurate the project later this month or early next month, said Aftab Hossain.

The Dhaka-Aricha highway links the capital with the north and some districts in the south. The RHD is spending Tk 696 crore to build dedicated service lanes and bus bays at major bus stops and market areas between Gabtoli and Paturia Ferry Terminal.

Moreover, the RHD in 2021 completed a feasibility study to turn the Gabtolit to Nabinagar section of the highway into an expressway.

The tussle between two agencies under the same ministry reflects

After the RHD raised its reservations about the proposed metro rail route, a meeting was held on March 23, 2021, where officials of both the RHD and the DMTCL were present.

At the meeting, RHD officials said blocking the highway corridor with metro rail structures would not be sustainable. Therefore, they requested for the Hemayetpur to Aminbazar section of the metro line to be either moved south or taken underground.

But MRT-5 Project Director Aftab Hossain Khan told the meeting that the line was planned on RHD land in accordance with the Strategic Transport Plan (STP) or revised STP. Due to technical difficulties and the heavy flow of traffic on the highway, the line cannot be moved south, he added.

The meeting also decided to sit again and finalise a paper that would be sent to the ministry concerned for a decision. But the issue was not resolved. In the meantime, the DMTCL has completed 90% of the line's design following the proposed

Another meeting between the RHD and DMTCL officials was held on March 23 this year.

According to the meeting

additional chief engineer for Dhaka zone, requested the DMTCL to shift the Hemayetpur and Baliapur stations to the north.

Mohammad Ahad Ullah, RHD's stations, is built on the highway, it executive engineer for Dhaka Division, said the metro line should not be built on the median of the highway. He also said the highway might witness severe traffic congestion during the construction period, just like the Dhaka-Mymensingh highway due to the construction of the BRT line.

The Tongi-Gazipur section of Dhaka-Mymensingh highway witnessing traffic congestion on a regular basis for years due to the construction of the BRT Line-3, a dedicated bus line from the Hazrat Shahjalal International Airport in Dhaka to Gazipur.

According to the meeting minutes, Abdullah Al Mamun, additional chief engineer (technical services wing) of RHD, said the future expansion of the highway would be obstructed if the line was built following the proposed route.

There is enough land on the south side of the highway and "it's still possible to review the design of the metro rail without using RHD land," reads the minutes.

RHD sources said Road Transport and Highways Division Secretary ABM Amin Ullah Nuri visited the project site on June 16 and gave the go-ahead for the DMTCL plan, ignoring the concerns raised by the RHD.

The secretary could not be contacted as he was abroad.

After that, RHD's Dhaka Division Office on June 22 sent a letter to its higher authority -- Dhaka Circle Office -- expressing its concern and requesting it to take necessary steps so that the metro rail route could be changed, said sources.

crashes, it added. Contacted, RHD's Sabuj Uddin Khan said the authorities were trying to resolve the issue. He, however, indicated that the metro rail was going to be built on the proposed

Replying to a question, he said, "We will shift the route of the expressway as it would take more time to start. Both the projects are important to the government."

Contacted, PD Aftab Hossain Khan, who is a retired additional chief engineer of RHD, said RHD's argument lacked technical assessment and was based on emotion.

He said they would close two lanes on the northern side of the highway at the Hemayetpur point during the construction period. To keep the traffic flow unhindered, he said, they would build two lanes on the southern side before blocking the two lanes.

The national flag carrier is also planning to make a code-sharing agreement with Air Canada to have further reach into North America.

For years, Biman has been trying to sign codeshare agreements with several airlines. Both carriers will share the profits earned from routes under the codeshare agreement, said the Biman MD.

"Code sharing is a kind of indirect fleet expansion," he said.

Aviation expert ATM Nazrul Islam lauded Biman's move and said this is a unique moment for the aviation sector in Bangladesh as this is the first time any carrier of Bangladesh is signing a codeshare agreement with a foreign carrier.

WHAT IS CODE SHARING

Code-sharing is a partnership between two airlines. It allows a flight to be operated by one carrier and marketed by another.

Put simply, code-sharing allows airlines to sell tickets to destinations they do not fly to but their partners do. These agreements allow airlines to offer numerous flights without additional equipment, resources, and costs.

Code sharing also provides passengers with a wide choice of flights. It also makes booking, checking in, luggage handling, and travelling more convenient. The coordinated schedules make sure there is enough time for connecting flights.

Airlines throughout the world

use code-sharing arrangements to strengthen or expand their market. **HOW INTERLINE WORKS**

When there is an interlining agreement between two carriers, a passenger has to buy a single ticket and check in once to reach his or her destination, not direct, with flights run by both carriers.

It relieves passengers from making bookings with both carriers and handling baggage during stopovers.

The interline agreement is a collaboration that improves interairline ticketing experience. It promises the flexibility of travelling across multiple locations without multiple bookings.

Biman MD and CEO said through the interline agreement, Biman will take passengers to Narita and Japan Airlines will take them to US cities.

"This means we will get the opportunity to take passengers to America indirectly via Narita.

"We are also expecting that the travellers from our neighbouring countries, including Nepal and India and especially people of Kolkata and Delhi, will also find the route attractive," added the Biman boss.

Aviation expert Kazi Wahidul Alam said Biman will have to be cautious while signing the codesharing and interline agreements so that its interests are protected.

Biman now operates flights to 20 international destinations most of which are in the Middle East.

The anti-mugging drive will continue until Dhaka is free from mugging, said Dhaka Metropolitan Police Commissioner Khandker Golam Faruque yesterday.

"Police will do whatever is needed to free the capital from muggers, no matter how much work is needed," he said, while talking to reporters after visiting Rakibul Hasan, an injured journalist of a private Television, at Pangu hospital in Dhaka.

A number of mugging incidents occurred during the Eid vacation in the capital and police are now on highest alert to arrest muggers, he added.

The law enforcers managed to arrest all the muggers involved in the police constable killing in Farmgate and they were sent to jail, said DMP chief.

Besides, two accused in a case filed for mugging Rakibul were also arrested he said.

France seeks to boost naval ties with Bangladesh

PORIMOL PALMA, back from Chattogram

The French Navy, renowned for its size and formidable naval capabilities, has expressed a keen interest in collaborating with the Bangladesh Navy to uphold international law and ensure maritime security.

Rear Admiral Emmanuel Slaars, the chief of French joint forces in the Indian Ocean, conveyed this during an interview held aboard the French stealth Fregate Surcouf.

The ship, which embarked on its journey from France two months ago, made a stop at the Patenga Container Terminal in Chattogram

The dengue outbreak in Bangladesh has taken a worrisome turn as the number of cases and fatalities continue to rise, signaling an alarming trend this year. Yesterday, the country witnessed the highest number of dengue deaths this year,

The total number of deaths in the first four days of July has already reached 14 whereas Shaheed Suhrawardy Medical College Hospital, nine deaths were recorded in

The Directorate General of Health Services (DGHS) reports 61 individuals have lost their lives to dengue so far this year. The surge in cases is evident as 678 new dengue patients were hospitalised within the last 24 hours, bringing the total number of cases to 9,871, with 2,787 cases originating from outside Dhaka.

The recent deaths of Bulet. a 38-year-old sweeper from Rangpur, and Ilma Jahan, an eleventh grader from

Viqarunnisa School and College, have further highlighted the devastating impact of dengue. In response, experts are urgently calling

on the authorities to conduct extensive drives to identify and control the hotspots of Aedes mosquitoes, the carriers of the dengue virus. MORE FEMALE DEATHS

The latest analysis conducted by the DGHS sheds light on the demographics of denguerelated deaths in Bangladesh this year. Among the 50 deaths analysed, 62 percent were female. The age group most affected, accounting for 60.80 percent of the fatalities, was between 19

Besides, 80 percent of the deaths occurred within three days after the patients were admitted to the hospital.

HM Nazmul Ahsan, an associate professor at

emphasised the importance of seeking medical attention promptly upon experiencing warning signs of dengue.

SYMPTOMS

The warning signs include stomach severe breathing vomiting. difficulties, bleeding from the nose, gums, vomit, or stools, weakness, significant reduction in urine output, and a notable decrease in platelet counts.

Dr Ahsan stressed mosquito larvae. the need for immediate hospitalisation as dengue patients can rapidly progress to critical stages within 24-48 hours of

displaying these symptoms.

He further advised that special attention should be given to pregnant women, infants, elderly individuals, and patients with underlying health conditions such as cancer, heart, kidney, or liver complications.

Tk 5 lakh fine for copyright breach Bill placed at JS; Public Service (Amendment) Bill passed

The Copyright Bill 2023 was placed in parliament yesterday giving a penalty of Tk 5 lakh for publishing, serving or performing any work of others without being the owner of the copyright.

For the violation of copyright for film, the punishment is maximum five years of imprisonment and Tk 10 lakh as fine.

State Minister for Cultural Affairs KM Khalid placed the bill which was sent to the parliamentary standing committee on the cultural affairs ministry for further examination. The committee was given 30 days for submitting its report.

The proposed law will replace the Copyright Act

Anonymous or pseudonymous work owner, databasé, public domain, monogram, producer, person, folk song, folk culture, editor, property rights all these new definitions have been added.

Private helipads, heliports get govt approval

Helicopters can land on rooftops; move to benefit medical evacuation

In a bid to regulate helicopter services for corporate use and medical evacuation, as well as enhance air connectivity within the country, the government has made the decision to permit private operators to build heliports and helipads.

Private entities will now have the opportunity to construct these facilities and land helicopters there, subject to meeting specific conditions set by the government.



the establishment of heliports, which are similar to airports and cater to multiple helicopters for takeoff and landing. Additionally, elevated heliports or helipads, designated for the use of one helicopter at a time, may be situated on the roofs of tall buildings or other high structures.

The civil aviation ministry recently issued a gazette notification titled "Heliport and Elevated Heliport Establishment and Operation Policy, 2023," which became effective on Monday.

This policy allows for the establishment of heliports, which are similar to airports and cater to multiple helicopters for takeoff and landing. Additionally, elevated heliports or helipads, designated for the use of one helicopter at a time, may be situated on the roofs of tall buildings or other high structures.

Presently, helicopters traveling outside Dhaka can only land at airports, stadiums, school grounds, or any open space that has obtained clearance from the Civil Aviation Authority and local administration. However, private operators will now have the opportunity to land helicopters on the rooftops of private premises equipped with helipads, or at their own designated heliports, following the necessary approvals and compliance with facility requirements.

A similar proposal was previously under consideration in 2019, but it faced obstacles due to concerns expressed by the home ministry at that time.



Says fire service director; blaze doused after 11 hours, probe committees formed

The massive fire that broke out in the Sagar Nandini-2 oil tanker in Jhalakathi's Sugandha river on Monday evening was doused yesterday morning after an 11-hour-long frantic effort.

At least 13 people, including nine law enforcers, were injured after the fire erupted following an explosion in the tanker, which was carrying four lakh litres of petrol.

Twelve units of fire service from Barishal, Jhalakathi, and Khulna extinguished the fire at 5:25am yesterday, said Lt Col Tajul Islam Chowdhury, director (operations and maintenance) of fire service.

Besides, the oil tanker did not have a proper fire safety plan and lacked adequate safety equipment. In addition, the staff of the oil tanker was not properly trained, he said. He also said the fire may have occurred due to


An elephant calf, separated from its herd, has been trapped in Shah Parir Dwip of Cox's Bazar's Teknaf for the last two days without food or fresh

Meanwhile, forest department officials are conducting drives rescue the animal.

According to Abul Kalam Sarkar, ranger officer of Teknaf Coastal Forest Division, they were informed of a lost calf loitering around the area on Monday. The animal got lost while crossing the Naf river from Myanmar to Bangladesh and took shelter in the coastal forests.

"The calf, aged around six to seven months, is weak and exhausted. To add to its anxiety, people are continuously chasing it, making the rescue operations more difficult," he said.

Once rescued, the calf will be taken to protected forest lands or a safari park upon orders from authorities. Meanwhile, precautions are being taken to ensure that the animal is not harmed in any way, he added.

Locals unite to save century-old pond

The century-old Rayenda Bazar pond, one of the few existing fresh-water bodies in Bagerhat's Sharankhola upazila, is in danger as the Zilla Parishad has decided to put it up for lease for the construction of a market.

According to locals, there is an acute shortage of freshwater sources in the area, and the construction of a market will further lead to the pond's extinction, making it more difficult for them to access water for their daily chores.

To protest this decision, various students and residents of the upazila formed a human chain on June

According to the protesters, the Zilla Parishad had significantly narrowed the eastern side of the pond to construct a market with 8-10 shops, distorting the pond's shape. They are now looking to lease out the southern portion, which will lead to inevitable

"Most people in this area are dependent on this pond for fresh water. Instead of excavating it, the Zilla Parishad is building shops on its sides. We have to walk for miles to access freshwater. I don't know why the authorities are ignoring our struggles," said Jahid

Students from various institutions also use this pond to suffice their daily needs, informed Amlendu Halder, headteacher of Rayenda Government Pilot High School.

A pond sand filter (PSF) was constructed on the north side of the pond in the last financial year, spending Tk 7 lakh. The construction of new shops will deplete the pond's water and also destroy the PSF, leading to more

The amended RPO stipulates that the EC can suspend polls only on the polling day. Also, the commission cannot suspend or cancel the entire results of an election after the declaration of results by the

returning officer. The EC can suspend the results of only those (one or more) polling stations where irregularities have been reported. It can cancel the results and hold new elections at those centres concerned following

Another provision of the amended RPO allows candidates to settle small loans and pay due telephone, gas, electricity, water, and other government service bills until the day before the submission of their nomination papers. Currently, these loans and bills can be settled seven days before filing of nomination

United Nations yesterday warned the world to prepare for the effects of El Nino, saying the weather phenomenon triggers higher global temperatures is set to persist throughout 2023.

Thai alliance unites on House leadership

Lawmakers in Thailand vesterday endorsed a veteran politician and leader of a small party as the new speaker of the lower house, signalling a detente in a row between the two biggest players as they seek to form a new coalition government.

The nomination of Wan Muhamad Noor Matha, 79, was widely seen as a compromise between alliance partners Move Forward and Pheu Thai, which have sparred for weeks over the speakership, a post crucial to the passage of bills and the timing of key legislative votes.

Wan Noor represents the Prachachart Party, a junior member of an eight-party alliance dominated by Move Forward and Pheu Thai, hich together won the lion's share of the seats in the May 14 election, thrashing conservative parties allied with the royalist military.

A southerner and ethnic Malay Muslim in predominantly Buddhist Thailand, Wan Noor has served previously as house speaker and has close ties with Pheu Thai's leadership.

He was the only nomination and his selection is pending royal approval.

"I will conduct duties fairly ... with transparency in considering draft laws and petitions to improve the lives of all Thais," Wan Noor told the house.

Among his first tasks will be to table a joint vote of the 750-member bicameral parliament on a prime minister to form the next government.

"I would like to thank my colleagues from the SCO countries who expressed support for the actions of the Russian leadership to protect the constitutional order and the life and security of citizens," Putin added.

China and Russia have in recent years diplomatic contacts, with their strategic warning that "any temptation to use it as

Mass shootings in Philadelphia, Baltimore and Fort Worth claimed the lives of 10 people ahead of the Fourth of July holiday, officials said, a grim illustration of the United States' decades-long failure to curb gun-fueled violence. In Fort Worth, Texas, three people were killed and eight wounded in a mass shooting following a local festival, police said yesterday. In a separate shooting incident in Philadelphia on Monday evening, five people were killed and two were injured when a suspect in a bullet-proof vest opened fire on apparent strangers. The Monday night shootings came a day after two people were shot dead and 28 others injured, about half of them children, in a hail of gunfire at an outdoor party in Baltimore.

Finally, some good news for economy

Exports growth shows the resilience of our businesses

That Bangladesh's merchandise export earnings have crossed the milestone of \$50 billion for the second consecutive year is a notable achievement indeed. In FY2022-23, exports fetched a record \$55.6 billion, which could provide the economy with some much-needed breathing space. Amid challenging conditions at both home and abroad, it is one of the few bright spots for our economy.

The receipts amount to an increase of 6.67 percent from a year earlier, thanks in part to a strong showing in June which saw \$5.03 billion come into the country, according to the Export Promotion Bureau. Even though the total amount fell short of the \$58 billion export target set for the fiscal year, it is a good sign at a time when international markets are going through extreme turbulence. As Bangladesh's major export destinations are grappling with a slowdown and high inflation, the increase managed to surpass many economists' expectations. Moreover, during this time, exporters had to deal with a number of production-related challenges, including low gas pressure and frequent load shedding.

The lion's share of the export burden was carried, predictably, by the garments sector which, despite the slowdown in Western markets, managed to diversify some of its products to other emerging markets. Since garments sectors of other countries struggled during the same period, this also shows the resilience of our own garments sector although, admittedly, the depreciation of the taka against the dollar did play a big part in making ours more competitive.

Despite this additional advantage, however, other sectors failed to increase their export amounts. For example, important sectors like leather, jute, home textiles, and agricultural products registered negative growths in FY23. A major reason why leather products did badly was the issue of non-compliance at the Savar tannery estate. Despite spending more than Tk 500 crore and waiting for nearly a decade, Bangladesh is yet to reap the full benefit of the central effluent treatment plant (CETP) at the estate. Without a fully functional CETP, Bangladeshi companies will not be able to obtain the Leather Working Group certification, which is essential to attract international retailers and brands.

It is unacceptable that such hindrances should continue to slow down promising sectors of our economy. The government should identify what issues export sectors other than garments are facing, and address them promptly so that Bangladesh's exports can continue to grow.

Can we triumph over dengue this year?

Authorities must ramp up efforts to control it

At the beginning of May, experts had predicted that Bangladesh might see an even worse dengue outbreak this year than before. Unfortunately, all numbers point to this becoming a reality. While the number of dengue cases in June last year was 737, this June saw a staggering 5,956 cases, easily dwarfing the corresponding figure from 2019 – the worst year yet in terms of dengue infection in the country. In all likelihood, warnings about a surge in the breeding of Aedes mosquitoes post-Eid may come true. Adding fuel to the fire, a vet-to-be-released survey conducted by DGHS in the two city corporations of Dhaka has detected Aedes larvae in 20 percent of houses under DNCC and 15 percent of houses under DSCC.

For a country dealing with dengue outbreaks for over two decades, Bangladesh still seems to be taking a novice's approach to the problem. This has reflected in the dengue situation getting worse with each passing year. In 2022, the highest number of people died of dengue – 281. The question is, why are the authorities still faltering in their efforts? One area of failure is their delayed drive to detect Aedes larvae. The survey of houses to find Aedes larvae should have been conducted at the beginning of the year (before the first monsoon rain). Why did the health directorate wait until June to carry it out, despite news of rising infections in the early months? What measures are being taken to prevent water stagnation in areas with a drainage problem? Once identified, are the breeding grounds of Aedes larvae being destroyed?

The authorities must be able to address these and other concerns regarding our dengue preparedness. The DGHS survey should provide useful information in identifying dengue hotspots and taking targeted measures in Dhaka, but other major cities should also be included. The coming three-four months are going to be crucial, so the authorities must dedicate all efforts to raising awareness, undertaking preventive drives, and keeping dengue numbers in check. The DGHS and all city corporations must not fail us this time.



Bangladesh tops the wrong ranking, again

Insufficient law enforcement, money laundering opportunities make the country an easy target for drug trafficking rings

drug trafficking comes as no surprise given the country's geographic positioning that puts it at the centre of three major Asian drug trafficking routes: the Golden Wedge, the Golden Triangle, and the Golden Crescent. Add to that the incompetence of its authorities to bust wellconnected strategicallyand illicit money abroad. Not that the authorities are doing nothing: they set up checkpoints, conduct regular drives, catch small shipments and recover drugs, catch drug peddlers, and ever since the launch of the War on Drugs, alleged drug dealers are also frequently "killed" in "gunfights" with law enforcement members. However, in terms of results, law enforcers have only so much to show.

The problem perhaps lies in our approach to the issue, which on the surface seems to target the consignments, users and dealers. Where we fail is in going deeper to the roots and dismantling the system at the core. The system we are talking about is one that allows rampant corruption, nepotism, favouritism and self-interest to permeate every level of the state, from policymaking to enforcement.

Unfortunately, the Narayanganj landscape is pretty much a reflection of the overall drug trading scenario in Bangladesh. Even the ones killed across the country in drug-related "gunfights," "encounters," and "infighting" are not above controversy as instances of extrajudicial killings and suppression of political opposition.

Then there is the problem of the long-pending narcotic cases. Although the Department of Narcotics Control appointed 68 prosecutors across the country in 2019 to expedite disposal of longpending cases and improve the conviction rate, and the parliament passed the Narcotics Control (Amendment) Bill, 2020, empowering any court with appropriate jurisdiction to try narcotic cases, a report by this daily last year found 73,312 cases still pending with the court. Conviction rates in narcotics cases have witnessed a constant fall since 2014, when it was 64 percent. to 40 percent in 2021, according to DNC's Annual Drug Report 2021.

At this point in time, it is important to take a closer look at our intention, appetite and approach regarding this issue. While the government has launched a war on drugs, does it really have the political will to catch the drug lords, kingpins and mafia bosses who are pulling the strings and running the business behind the scenes?

Drug lords are finding innovative - including manipulating ways the desperate Rohingya refugees and new routes to bring drugs into the country. Without a wellplanned strategy and comprehensive measures in collaboration with all relevant authorities, intelligence bodies and law enforcers, this welloiled machine cannot be stopped. We need a holistic approach to bring down drug trafficking rings, despite their identities and affiliations. The deadly combination of a land offering ripe opportunities for drug trafficking and a lax system that provides enough loopholes for easy money laundering makes Bangladesh an easy target for international drug trafficking rings. It is high time we aimed at dismantling the system that enables criminals to line up their pockets at the cost of the nation, rather than focusing on small players.

On June 18, the High Court asked the DNC to submit within a month the names of top drug dealers, while directing the Anti-Corruption Commission, Bangladesh Financial Intelligence Unit and Criminal Investigation Department investigate within two months the allegations of drug money being laundered abroad. Previously in 2021, as many as 14 government bodies flouted a similar High Court directive asking to submit names of persons and entities who stash money in foreign banks. other power station. A whitepaper published by SOLshare proposes that there is around 30 percent of the battery's charge remaining when the vehicles return after completing the day's trips. Provided the government's provision is obtained, the power from these batteries could be sold to the national grid during hours of peak demand, easing the grid's strain. Later into the night, with the help of cloud technology, the batteries would automatically charge from the grid at a lower tariff rate (low demand). The benefits of renewable technology can also increase if solar panels are installed on the rooftops of the garages.

It has just been announced that Bangladesh is going to start producing its own lithium ion batteries. An ambitious project, Bangladesh Lithium Battery Ltd, with an investment of Tk 600 crore, has already built its factory to produce these batteries and aims to be operational by 2024. Terming this a milestone development, the Dhaka Electric Supply Company Ltd (Desco) Managing Director Md Kausar Ameer Ali recently said three to four million three-wheeler electric vehicles in the country which currently run on lead acid batteries, could soon be running on lithium ion batteries. He also expressed interest in constructing accessible charging stations for electric vehicles across the nation. This is emblematic of the kind of government support needed to further the cause of developing sustainable environmental solutions. Moreover, this takes us a step closer to making VPPs a reality.

"I thank God for letting me see my son's body for the last time," Ali Kawsar, the father of a 12vear old boy, told reporters with tear-stained eyes, soon after the body of his son Kamal was recovered from Mirza Khal in Chattogram's Muradpur area in December 2021, around 68

And he had reasons to thank the Almighty, as he could at least find the body of his baby boy, or whatever that remained of him.

The family of vegetable vendor Saleh Ahmed was not so lucky, as he is still "missing" even after almost two years of falling into the same drain, located near Sholashahar Railway Station of the port city on August 25 of the same year.

Similarly, a university student named Sehrin Mahbub Sadia was also swept away by an open drain in September of the same year.

The open drains have set up a perfect death trap for the people living in the port city. As the commercial capital of the country sinks even after minimal rain, it gets nearly impossible for its residents to identify these roadside sewers.

to exacerbate waterlogging, the inhabitants of risky canals. of Chattogram harbour a collective fear that as the disconcerting state of the open drains persists largely unchanged.

Take the case of the drains on both sides of the road from Muradpur to Bahaddarhat for example, one of the main thoroughfares of the port city. The huge drains by the side of footpaths have been left open and unprotected.

During a recent visit, it was noticed that pedestrians were walking on the footpaths with a high risk of falling into the drains. The risk of accidents increases manifold at nighttime and during waterlogging.

in this area during monsoon; as the road goes under water, pedestrians fail to differentiate the road from these drains, which causes accidents," said MA Gani, a resident of Bahaddarhat area.

The same situation prevailed in the drains beside the road from Muradpur to Sholashahar. There is a wide drain on one side of the road and a canal (Chashma Khal) on the other side. Although a number of accidents and casualties occurred in this canal including the tragedies mentioned above, the canal still lies unprotected.

"We are in a constant state of panic while crossing the road during waterlogging," said local resident Samir Jaladas.

According to city corporation officials, there are a total of 57 (161km) canals and 765km drains in the city. Chattogram City Corporation conducted a survey of risky spots in drains, canals and footpaths in 2021. After the survey, a total of 5,527 risky spots were identified, the total length of which was 19km. But the works on safeguarding the risky spots have allegedly been going on at a snail's pace, said sources in CCC.

Contacted, CCC Chief Engineer Rafiqul Islam said they have already installed slabs on 30,000 square feet of drains, while retaining With the ongoing monsoon threatening walls have been built beside 18,000 square feet

About unprotected drains and canal in such tragedies may proliferate once more, Muradpur to Sholashahar Gate-2, he said the Chattogram Development Authority has been working in these areas under a mega project for addressing waterlogging, so it is the responsibility of CDA to protect the canal and drains of these places.

Contacted, Lt Col Shah Ali, project director of CDA, said CDA was just working to install walls by the Chashma canal, but the drains on the other side of the road don't fall under their iurisdiction.

"We have built a protection wall in some portions of the canal and the remaining works "Waterlogging is a common phenomenon will be resumed in the next dry season," he said.



Gone are the cinemas

There was a time when movie theatres used to multiply Eid joys for most "Chatgaiya" families.

The port city residents would often set off to dive into a cinematic experience with friends or loved ones to relish a moment for themselves after a tiring day of festivities and responsibilities.

"On the first or second eve of Eid, we would set off in crowds to cheer Ajim-Sujata, Rahman-Shabnam and Razzak-Kabori as they appeared on the silver screen," recalled Abdul Hamid, a 60-year-old resident of Panchlaish area.

Over 30 movie theatres were running in full swing in the city during the late 1900s.

"The halls used to compete over good movies while we had to fight our way up the queue to get tickets. To further draw movie-buffs, the theatres would be beautifully decorated with coloured lights and posters during Eid, especially the Gulzar Cinema Hall. Sometimes, tickets even had to be bought in black," said Asad Haider of Bibirhat area.

operational movie theatres

Cinema Palace and Sugandha (earlier known as Jhumur Cinema Hall), said Abul Hossain, president of Chattogram Cinema Hall Owners Association and the owner of the halls.

"The demolition started in the late 1990s when vulgarity engulfed the film industry. With time, the audience turned away from the cinema halls, and our business started to collapse. The introduction of private television channels and internet facilities further added to their demise," he added.

A hall used to employ around 30 staff, all of whom received respect, enough salaries, and bonuses. However, with decreasing audience turn-outs, the owners are now struggling to even pay salaries regularly.

Following the first fall, other theatres -Banani Complex, Jalsa, Nupur, Melody, Uzala, Lion, Khurshid Mahal, Rangam, Almas, Diner, Sanai, Upahar, Rhythm, Sagarika, Alankar, Akash, Chandni, Karnaphuli, Rupali, Purabi, and Garrison -- were demolished gradually to build shopping malls.

According to movie experts and hall owners, the audience now prefers multiplexes over single screens as they offer better sound and screen quality and more comfortable sitting arrangements.

Around 1,200 cinema halls have been shut down in the last 20 years in the country, while 200 are still struggling to cope with modern trends, mentioned Aolad Hossain Uzzwal, general secretary of Bangladesh Motion Picture Exhibitors' Association.

Where tigers roamed free

"I grew up listening to my grandfather's stories of how tigers ascended down these hills. He even saw one himself while one of his friends even tried to hunt one once using a trap, but failed. It was their reality, but for us and our following generations, it's only a myth," said 80-year-old Saleh Ahmed sipping tea at a small stall in the port city's Tiger Pass area.

Chattogram city used to be a small settlement, stretching only 16 square km during the 1950s, with tigers roaming around the hills and hunting. Humans had to put up a tough fight to survive as they often preyed on their cattle, said Prof Abdul Mannan, former chairman of University Grants Commission and ex-vice chancellor of Chittagong University.

"I started schooling in this town in 1953 and have grown up listening to stories that sing of the 'glorious' tiger hunters," he added.

Once a wildlife sanctuary guarded by hills and hillocks, Tiger Pass, located in the central town, is now a busy intersection, connecting four roads. These roads were established at the cost of these wild animals to develop the city's connectivity.

Many other such city areas, like Leopard Pass and Baagh Ghona (Tigers' Haven), were named after the tigers that ruled over these areas.

Abdul Haque Chowdhury, in his book "Bandar Shahar Chattogram", mentioned of the tigers and how they were hunted down by humans using traps and guns, said Prof Anupam Sen, vice chancellor of Premier University Chittagong.



This is how the Tiger Pass intersection look now, devoid of hills and greenery.

"This place was named after the tigers as they would make frequent visits while crossing between the two big hills in the area that glided towards the sea, even during the 1900s," said Prof Sen who has spent his childhood in the city.

The roars could even be heard during the day time, said the social-scientist, referring to Arthur Lloyd Clay's book "Leaves from a Diary in Lower Bengal".

"The government used to reward tiger hunters back then. In fact, two tigers were brought in for rewards within a week of Clay's posting in the district in 1862. These books carry evidence of the silent war between humans and the tigers, and how the four-legged legends had to bow before the guns before leaving this place for good," he added.

Confident Afghans ready to dare Tigers

A lack of experience in the longest format of the game and the absence of some of their regular cricketers saw Afghanistan succumb to a massive 546-run defeat against Bangladesh in the lone Test in Mirpur last month.

But as the format shifts to white-ball cricket and players like superstar Rashid Khan and the experienced Mohammad Nabi return to the side after missing the Test match, the visitors have emerged as a strong unit for the three-match ODI series starting today in Chattogram.

Although Bangladesh have been consistent in the 50over format and could be labelled favourites after beating Afghanistan in four of their last five ODIs. Hashmatullah Shahidi's side are capable of testing the hosts.

When asked if he thought Bangladesh were favourites, the 31-year-old replied: "Afghanistan are also here to play cricket and win". He certainly meant what he said, reflecting the confidence gained from winning twelve of their 18 games over the past two years.

He added: "It's not about them. Yes, of course, they have played good cricket but we are also here to play good cricket. We have also done well over the past two

The obvious threat remains the world-class Rashid, who has proven to be a game-changer against the Tigers



in their den by picking up twelve wickets in six games at an economy of 3.87.

Nabi also brings loads of experience both with bat and ball and is another cricketer in the Afghan camp who could turn things around. He also bagged twelve wickets in 10 games in Bangladesh at a miserly economy of 3.70 while his batting credentials will surely attract a lot of attention.

On the other hand, mystery spinner Mujeeb Ur Rahman has been quite toothless against the Tigers, managing to scalp just one wicket from the three games he has played against Bangladesh so far.

The Afghans included five new faces, including young uncapped leg-spinner Izharulhaq Naveed, who has already made his mark in franchise cricket leagues. Uncapped left-arm spinner Zia Akbar can prove to another surprise element for the visitors.

While Bangladesh are aware of the spin threat, Shahidi did not forget to remind what he has in his pace arsenal, led by left-arm seamer Fazalhaq Farooqi and Azmatullah Omarzai alongside a bunch of uncapped pacers raring to

"The good thing is we had good spinners. But now we have good seamers like Fazal and Azmat, who are doing well. We also brought the new guy Wafadar Momand who has good pace and also Saleem Safi. He also has good pace and it definitely gives us an advantage. Alongside good spinners, we also have good pacers as well," he said.

The Bangladesh team appeared to have put in the hard yards over the past two days and thus had a rather light training session in Chattogram yesterday on the eve of the first ODI against Afghanistan today. The majority of the work went on behind closed-door sessions, with only Shakib Al Hasan, making a return following an injury, doing specific work in the nets with head coach Chandika Hathurusingha.

The head coach also spent some time with Liton, going for a look at the centre wickets along with the batter, perhaps preparing him for a role that may befall him if Tamim's injury worsens.

The Tigers' ODI skipper has been struggling with back pain recently and informed during the press conference yesterday that he was available for the game today despite not being at a hundred per cent.

Jenin raid close to completion

Says Israel; Palestinian death toll rises to 10; thousands flee homes

Israel is close to completing its Jenin operation, a senior aide to Prime Minister Benjamin Netanyahu said yesterday after the fiercest fighting in the flashpoint West Bank town in more than two decades killed 10 Palestinians and forced thousands to flee.

Launched early on Monday, the raid involving hundreds of commandos and air strikes prompted the internationally backed Palestinian administration to say it was suspending contacts with Israel.

Codenaming the operation in Jenin's tenement-like refugee camp "Home and Garden", Israel says the objective is to uproot Iranian-backed Palestinian factions behind a surge in gun and bomb attacks.

A Palestinian wounded during the house-to-house clashes died overnight and another body was found in the morning, bringing the death toll to 10, with around 100 wounded, the Palestinian health ministry said.

The operation "is close to completing the achievement of the goals set," Israeli National Security Adviser Tzachi

Hanebi told Kan radio after a relative lull in the clashes The Palestinian Red Crescent said it had evacuated

500 families, or around 3,000 people, from the camp, where some 14,000 people live in less than half a square kilometre and which has been one of the focal points of a wave of violence that has swept the West Bank for more than a year.

Ctg landowner selling banned fish feed

Substance was 'destroyed' by Ctg customs

A landowner has been extracting and selling banned meat and bone meal (MBM) from a dumping station in port city, posing a serious health risk to humans.

On September 24 last year, Chattogram Customs House (CCH) discarded about 9,770 tonnes of seized MBM imported under false declaration between 2019 to 2021 at a rented dumping station in the port city's Anandabazar area.

The MBM was buried as intact sacks, and the CCH withdrew the Ansar guards from the facility a week after dumping the hazardous good, The Daily Star has learnt from people informed on the proceedings.

Soon after the guards were removed, Abdul Mannan, who rented the land to CCH, began digging out the buried MBM to sell to fish feed traders in Cumilla, Feni, Netrokona, Lakshmipur, Noakhali and Chattogram districts, according to police and customs.

MBM is a processed by-product of cattle, poultry and swine slaughterhouse leftovers such as bone, meat, organs, tissues and fat. It is used as animal feed including fish.

Commerce ministry banned the import and sale of MBM on December 26, 2018 following a Bangladesh Food Safety Authority report that found it harmful and

On November 8 last year, Bandar Police seized 12 dump trucks loaded with MBM and six excavators from the dumping station.

Permission has to be taken from the government or the appointing authorities concerned for arresting the officers of autonomous, state-owned and local government bodies before a court accepts the charge sheets in criminal cases filed over carrying out their duties.

The parliament yesterday passed the Public Service (Amendment) Bill-2023 keeping this provision.

The bill was passed by voice vote.

Clearance from the Finance Division was made mandatory for the autonomous, legislative and local government bodies for financial expenditures.

Participating in the discussion on the bill, Gonoforum MP Mokabbir Khan said several provisions of the bill contradicted the constitution and laws of the land.

He said it has been seen that the secretary, additional secretary or joint secretary of some ministries do not work properly.

Jatiya Party MP Pir Fazlur Rahman said any citizen can be arrested prior to pressing of charges in a criminal case. No permission is needed for this, he added.

But prior permission would be needed for arresting government officials, which is contrary to the principle that all citizens have equal rights, Fazlur said.

Momen to ICC prosecutor

Foreign Minster AK Abdul Momen has sought efforts from the International Criminal Court (ICC) to finish the case related to the Rohingyas as soon as possible — to ensure that genocide never happens again anywhere in the world.

You should put in efforts to finish the case as fast as possible. Justice delayed, justice denied," he said to ICC Prosecutor Karim AA Khan QC yesterday.

In November 2019, the International Criminal Court judges granted a request to open a full investigation into alleged atrocities committed against the Rohingyas within the jurisdiction of the court.

This authorisation to open an investigation is seen as a "significant development" for the pursuit of justice and the establishment of the truth, in particular for the victims of alleged crimes in this situation.

Investigators from the Office of the Prosecutor are now carefully and thoroughly seeking to uncover the truth regarding what happened to the Rohingya people in Myanmar which forced them to flee to Bangladesh.
