Police looking to revive old cases

AL to continue counter programmes

As the BNP and 35 other like-minded parties are set to launch a one-point movement to oust the government, the Police Headquarters is collecting data on all the cases against opposition activists and leaders.

headquarters is gathering information about those who faced charges of arson, killing of police members, crimes against humanity, and other serious crimes in 2013 and later.

The initiative is aimed at speeding up the pending cases against opposition leaders and activists.

BNP's one-point movement will also be met by ruling Awami League's programmes on the streets, apparently to counteract the effects of BNP's demonstrations.

The AL also decided to hold rallies for students and youths in eight divisional cities in what seems to be an obvious response to BNP's youth rallies.

Beyond these programmes, the ruling party is not much bothered about the opposition's demonstrations, insiders say.

The leadership is focused on reorganising the party and preparing for the national polls slated for January.

Besides, the AL leaders have no doubt that the law enforcers will play their role if the opposition wants to create instability.

On July 12, the BNP will formally announce its one-point movement for resignation of the government and election under a caretaker administration.

Meanwhile, the Jamaat has also been trying to motivate its rank and file. On June 10, it held a rally after a decade in the capital and demanded restoration of the polls-time caretaker government. The party, which does not have a registration with the Election Commission, held several subsequent programmes including a rally in Dhaka last Friday in protest of the defamation of the holy Quran in Sweden.

Jamaat sources say they will demonstrate in the coming days for release of their party chief Shafiqur Rahman and other leaders from prisons and demand a caretaker government before the election.

EU team holds talks with foreign envoys in Dhaka

six-member Election Exploratory Mission from the European Union yesterday began its two-week work to assess the overall situation surrounding the next general election in Bangladesh.

The mission, which arrived in Dhaka on Saturday, held meetings with the EU ambassadors and some other Western diplomats, including those from the US and the UK, according to a European ambassador who attended a meeting.

"It was a good meeting. The mission wanted to know about the present situation in Bangladesh surrounding the next election," he said.

The EU mission wanted to hear from all EU envoys in Dhaka and those from Canada, Norway and Switzerland how they see the current domestic political landscape, the envoy of a EU member country told The Daily Star.

There was a broad consensus around the table to emphasise the importance of them [envoys] recommending the deployment of a full-fledged observer mission later this year, notwithstanding

Power projects rarely completed on time

Finds IMED research paper

Most of the projects in the power sector are not completed on time, with some seeing as much as 300 percent cost overruns, said a recent report of the Implementation Monitoring and Evaluation Division (IMED).

The delays in project implementation and lack of proper planning and manpower with technical knowledge have made the sector a hugely subsidised one, said the government project monitoring body.

"It would have been possible to reduce the burden (loss and subsidy) if proper feasibility studies were conducted and if there was proper planning to ensure the energy for the power plants before taking on the projects," the research report said.

Subsequently, the report suggested not taking on any power plant projects before

ensuring the energy supply.

The report reviewed the progress of 67 ongoing projects of the power division, which is being implemented by the Bangladesh Power Development Board (PDB), Power Grid Company of Bangladesh, Desco, DPDC, NESCO, WZPDC, NWPGCL, Sreda, EGCB,

Power Cell, Rural Electrification Board, RPCL and so on since 2013.

Among the projects, 32 projects are being implemented for six to 10 years, with six of their progress being between 90 percent to 99 percent. At least 12 projects are implemented for over seven years and four of their progress

is less than 30 percent. Of the four projects, two are related to pre-paid meter installations under PDB and DPDC in Dhaka, Mymensingh and Cumilla areas, and two are related to transmission and distribution networks under PGCB and DPDC.

Tax collection target missed for 11th year

For the 11th consecutive year. the National Board of Revenue (NBR) has missed its tax target in the face of a slowing collection amid economic

slowdown. The NBR logged Tk 325,272 crore in overall receipts in 2022-23, falling short of Tk 44,728 crore from its target for the fiscal year, according

to its provisional data. The receipts also fell short of the target set by the International Monetary Fund as a part of its \$4.7 billion loan for the country.

In the 24 hours till 8:00am vesterday, six dengue patients died, while 832 new patients were hospitalised according to the Directorate General of Health Services.

With the latest count, the fatalities from the disease rose to 72 and the number of hospitalised patients hit 12,954. And 2,750 patients were undergoing treatment in hospitals as of yesterday morning, with 1,967 of them

LEAK OF CITIZENS' INFO Govt website didn't have minimum security

State minister for ICT says technical flaws led to data breach

The leak of sensitive personal information of millions of citizens from a government website was due to the weakness of the site, State Minister for ICT Zunaid Ahmed Palak said yesterday.

The data of as many as five crore citizens was exposed online from the Office of the Registrar General, Birth and Death Registration (BDRIS) website, this newspaper reported on Saturday.

Palak said, "The portal from which the information was made public did not have minimum security. Despite being warned, the officials of the department concerned did not take it into account. The state has suffered a great loss due to their negligence.

The leaked data, including names, birth dates, and National Identification (NID) numbers, was "easily accessible through a simple Google search".

"We have yet to find evidence that cybercriminals have taken any data. What we found was that there was a technical weakness in the government website. As a result, the information was very easy to see," the minister added.

Palak was speaking at the inauguration of the Bangabandhu International Cyber Security Awareness Award programme at the BCC Auditorium of ICT Tower in the capital's Agargaon yesterday.

A Munshiganj court yesterday sent a Chhatra League leader to jail on rape


Senior Judicial Magistrate Rahima Akhter placed him on a 2-day remand after he was produced before her court.

A Dhaka court yesterday relieved former speaker Jamiruddin Sircar from the charges of five graft cases after he refunded the state Tk 27,86,364, which he withdrew for treatment during his

Judge Prodip Kumar Roy of Dhaka's Special Judge Court-7 passed the order after Jamir's lawyer submitted the payment slips of the banks.

Earlier on March 12, the same court ordered Jamiruddin Sircar to refund the amount by today in line with another order issued by the Appellate Division of the Supreme Court.

On August 25, 2022, the Supreme Court quashed all five cases filed against Jamiruddin on charges of misappropriating Tk 27.86 lakh in the name of treatment abroad, said an official of the court.

But this year, hospitalisations began in April.

"Those who were infected once are at high risk of death if infected the second time. So, we have to be aware of it," he said, adding that the physicians and nurses have adequate training to handle dengue cases. As of yesterday, Mugda Medical

College Hospital had the highest number of dengue patients of 414, followed by Dhaka Medical College Hospital with 221. The higher dengue prevalence

is due to the huge breeding of Aedes mosquitoes for the rain, so it is imperative to take steps that rainwater does not remain stagnant anywhere, Maleque added.

Answering questions after the event, he told journalists that the state has suffered a great loss

The units have been asked to find witnesses in the cases in which no witness testimonies were taken before. They were asked to coordinate with prosecutors so that the depositions are made.

The headquarters told the units to take initiative to restart the trial process for cases that were staved by the court, and to file appeals in cases in which the accused got acquitted.

Contacted, Joydeb Bhadra, deputy inspector general (crime management) at the Police Headquarters, said the

The EU didn't send election observers in 2018.

The ruling Awami League and its archrival BNP are at loggerheads over the polls-time administration. The BNP wants restoration of the caretaker government system, while the AL says the polls will be held under the incumbent government as per the constitution.

Responding to a letter from six members of the European Parliament, EU High Representative Josep Borrell on July 6 said the EU encourages genuine dialogue among the major political parties and participation of all in the next parliamentary polls in Bangladesh.

The government is also under pressure after the US on May 24 announced visa policy saying it will restrict visas for those Bangladeshis who would engage in vote rigging or undermine democratic election

The EU mission is scheduled to leave Dhaka on July 23.

US raid in Syria kills IS leader

A US drone strike has killed an Islamic State group leader in Syria after Russian warplanes harassed MQ-9 drones over the war-torn country, the US Central Command said yesterday.

The strike on Friday resulted in the death of Osama al-Muhajer, IS leader in eastern Syria, Centcom said in a

"We have made it clear that we remain committed to the defeat of ISIS throughout the region," Centcom chief General Michael Kurilla was quoted as saying, using another acronym for the IS jihadist group.

Power projects rarely completed on time

None of the projects made any progress in the first year, found the

"The situation is very disappointing and not acceptable."

There are separate agencies to implement the power transmission distribution infrastructure, but due to a lack of coordination, some power plants are sitting idle after completion in the absence of transmission and distribution

The report cited the Ashuganj 450MW (North) and the Chattogram's Shikalbaha 225 MW combined cycle

power plants as cases in point. Without a proper feasibility study, a project was taken in Noakhali's Hatiya to install an off-grid wind-solar hybrid

system power plant with an HFObased engine-driven generator. After four years, the project was put on hold without completion.

Most of the big projects of the power division are being conducted under the turnkey system, where the contractor is the key player in the implementation and not the implementing authority or the engineers.

In the power sector, engineers are preferred in almost all posts, with engineers spending all their time on clerical and administrative work related to project implementation.

report that was uploaded on the IMED website on June 25 said the practice of paying capacity charges to power plants is a "model of robbery" and is a reflection of ill-motivated contracts.

However, on July 7, the website changed the version and omitted the pages related to capacity charges. So the report has come down to 54 pages from 58.

Md. Habibur Rahman, senior secretary to the power division, declined to comment on the findings of the IMED report.

"We will see when it gets sent to us officially," he told The Daily Star for appointing people with relevant yesterday.

Ensure free dengue test, treatment **GM Quader urges govt**

UNB, Dhaka

The situation of dengue across the country is worsening day by day, so the government and private hospitals should ensure free dengue testing and treatment with government assistance, said Jatiya Party Chairman and Deputy Leader of Opposition GM Quader yesterday.

Besides, action should be taken against those who cannot control the dengue situation due to failure and incoordination. If there is evidence of corruption, action should be taken against them, he added.

In a statement, GM Quader quoted the media as saying that 820 patients were admitted to the hospital with dengue in one day on Saturday. This is the highest

in terms of numbers this year. Official data showed that 67 people died of dengue since July 8. According to the data, 2,502 dengue patients, including 1,773 in the capital, are now receiving treatment at hospitals across the country.

So far, the DGHS has recorded 12,118 dengue cases and 9,549 recoveries. GM Quader said there is no effective action from the government to tackle the

dengue outbreak. If the dengue situation is not controlled, its consequences will become more dire. The people are already in dire straits

due to rising commodity prices. Therefore free dengue testing and treatment must be ensured, GM Quader emphasised.

'What should I do, buy food or pay for chemo?'

Labour leader's murder leaves family in ruins

Kajli Akhtar, a 32-year-old mother manage money required for her next chemotherapy session. Having already undergone two chemotherapy sessions since being diagnosed with uterine cancer in March, she now finds herself unable to afford the lifesaving treatment following her husband's murder.

Shahidul Islam, president of Gazipur unit of Bangladesh Garment and Industrial Workers Federation, was beaten to death on June 25, immediately after attending a meeting to negotiate for workers' arrears at Prince Jacquard Sweater Ltd in Tongi Satish area.

No dialogue with BNP on polls-time govt: law minister

If the polling of the entire constituency is stopped for a violence or untoward incident in one or few polling centres, it will not be democratic, but will be an interference to the people's right to voting and therefore, the RPO has been amended, he said.

The law minister also said the government has not written any letter for quick disposal of the pending cases against the BNP leaders. "The judiciary is independent. We have not written such a letter. If they can show such a letter, arguments will take place on it."



KUAKATA BEACH

75,000 TREES LOST to erosion every year

MD ABBAS, back from Kuakata

There was a time when coconut, palm, tamarisk, and mangrove trees swaved with the winds on Kuakata Beach. Their tall trunks guarded the shore-dwellers against the wrath of natural calamities.

However, the current state of the National Park, a government-declared forest reserve along this coastal belt since 2005, only brings dismay to tourists and locals.

About 2,000 hectares of forest land on the 18-km beach have been washed away in the last 13 years. The coconut orchards have completely disappeared, while only one-third of the tamarisk and palm trees continue to breathe in the Most of these trees have fallen prev to

erosion, a common phenomenon by the Bay, alarmingly increasing risks for the locals of this disaster-prone area. According to Patuakhali forest department sources, to make Kuakata more attractive to tourists, the department created a tamarisk garden adjacent beach in the



financial 2007-08. The garden stretches across 10,000 hectares of land along the shoreline. Since 2010, 2,166 acres of fresh land have been turned into reserves. In 2019, another 60 hectares were

converted

into tamarisk gardens, while acacia were planted on another 25 hectares along the shore in Gangamati area.


The following year, 85 more hectares were converted into reserves, planting different species of plants suitable for the region.

Meanwhile, erosion and tidal surges annually obliterate at least 50 hectares of forest reserves. In the last five years, such disasters have claimed approximately 250 hectares of the reserves as the aforementioned calamities frequently hit the shore during the stipulated period, informed Mahipur range officials.

Over 100 acres of forestland are washed away every year, uprooting nearly 75,000 trees of different species, especially Kewra, according to forest department sources.

The panoramic beach, once running 18 kilometres, has shrunk significantly due to continuous erosion, making it difficult for tourists to enjoy walks during high-tides. The beach and the forest will disappear if immediate steps are not taken to address this issue, said Asaduzzaman Miraj, a local.

"Deploying geo bags and blocks can help prevent erosion. The risks can added.

US-China ties on 'surer footing' after talks

Says US Treasury Secretary Janet Yellen, expects more communication at staff level

US Treasury Secretary Janet Yellen said 10 hours of meetings with senior Chinese officials in recent days were "direct" and "productive", helping stabilise the superpowers' often rocky relationship as her four-day Beijing trip ended.

departing yesterday, Yellen said the United States and China remained at odds on a number of issues but expressed confidence that her visit had advanced efforts to put the relationship on "surer footing".

"The US and China have significant disagreements," Yellen told a press conference at the US embassy in Beijing, citing Washington's concerns about what she called "unfair economic practices" and recent punitive actions against US firms.

"But President (Joe) Biden and I do not see the relationship between the US and China through the frame of great power conflict. We believe that the world is big enough for both of our countries to thrive."

With US-China relations at a low over national security issues, including Taiwan, US export bans on advanced technologies and China's state-led industrial policies, Washington has been trying to repair ties between the world's two biggest economies.

Secretary of State Antony Blinken visited Beijing last month, the trip as expected did not result the first trip by the top US diplomat in Biden's presidency. Climate

visit this month.

The US diplomatic push comes ahead of a possible meeting between Biden and President Xi Jinping at September's Group of 20 summit in New Delhi or a Asia-Pacific Economic Cooperation gathering scheduled for November in San Francisco.

Yellen said her visit aimed to establish and deepen ties with China's new economic team reduce



the risk of misunderstanding and pave the way for cooperation in areas such as climate change and debt distress.

"I do think we've made some progress and I think we can have a healthy economic relationship that benefits both of us and the world," she said, adding that she expected more regular communications at the staff level.

Briefing reporters after the visit, a senior Treasury official said in specific policy breakthroughs, but was "very successful" in terms

envoy John Kerry is expected to of "re-establishing contact" and building relationships.

She said Chinese officials raised concerns about an expected US executive order restricting outbound investment, but she assured them any such measure would be narrow in scope and enacted in a transparent way, through a rule-making process that would allow public input.

Yellen said she told Chinese officials they could concerns about US actions, that Washington could explain, and "possibly in some situations, respond to unintended consequences of our actions if they're not carefully targeted."

North Korea yesterday slammed the UN nuclear watchdog for approving Japan's plan to discharge treated water from the Fukushima nuclear plant.

The International Atomic Energy Agency approved Tokyo's plan to release treated water from the tsunami-hit nuclear plant into the sea over the next few decades.

The plan has raised concerns in neighbouring countries, prompting China to ban some food imports and sparking protests in South Korea.

The release of the treated water will have a "fatal adverse impact on the human lives and security and ecological environment," an official from Pyongyang's environmental protection ministry said in a statement.

"What matters is the unreasonable behaviour of IAEA actively patronizing and facilitating Japan's projected discharge of nuclear-polluted which is unimaginable," the statement added.

Some 1.33 million cubic metres of water used for cooling have accumulated at the nuclear plant, where several reactors went into meltdown after the 2011 tsunami overwhelmed cooling systems.

12 dead in north India rain fury

Delhi downpour highest in 40 years

At least 12 people have died in the past two days as heavy rain pounded several parts of north India. The weather office has predicted more showers over the next couple of days.

Lax cybersecurity a threat for us all

Why are government sites so vulnerable to cyberattacks?

We're alarmed by the recent surge in cyberattacks and data breaches targeting government sites in Bangladesh. The latest to expose our woefully lax data security procedures is a leak of personal data of 50 million people from the Office of the Registrar General, Birth & Death Registration (BDRIS). That's a massive number by any measure. While an investigation is underway to get to the bottom of the breach, the nature of the information disclosed - including birth dates and NID numbers – sends an ominous signal about its potential consequence should those fall in the wrong hands.

On Monday, the state minister for post, telecommunications and information technology acknowledged the incident about two weeks after it was discovered by a researcher from a South Africa-based cybersecurity firm – calling it a "great loss" for the state. He said the website in question was "fragile" and didn't have "minimum security". And despite being warned, responsible officials were negligent in following up on the threat intelligence, he added. We cannot say that we're surprised by this rather frank admission. In fact, one can say that the picture he drew of the "technical weaknesses" of one government website is not limited to it alone. It is a reality that the digital infrastructure of most public offices apparently shares.

The last few months have seen an alarming rise in data breaches and cyberattacks exploiting what we can only imagine to be such technical weaknesses. Our report on the latest development details a number of incidents, many apparently orchestrated by India-linked hackers, and the threat level of public websites. In March, for example, hackers demanded \$5 million in ransom from Biman Bangladesh while holding 100 gigabytes of data hostage. As the government was unable to retrieve the data in time, a vast amount of financial, human resource, training and satellite communications information was leaked. Unfortunately, despite the heightened cyber threat facing government, military, financial and educational institutions, we seem still unprepared to rise to the challenge.

This must change. The BDRIS data breach is a wakeup call to the authorities to strengthen our cybersecurity. The repercussions of sensitive data being breached are farreaching, as those can be exploited for malicious purposes. To mitigate the risk of future breaches, the government must adopt a multi-pronged approach to cybersecurity, investing in advanced threat detection systems and undertaking regular security audits of government websites/servers.

Poor quality control hurting projects

Authorities must ensure quality, prevent irregularities in construction projects

Hardly a week after the construction of a road in Faridpur's Sadar upazila, parts of it reportedly collapsed. This was the subject of a report published by this daily on Sunday. Such incidents, unfortunately, are getting too frequent for them to be considered "isolated", thus revealing a pattern of mismanagement and lax quality control in the development projects undertaken by the government. In the Faridpur case, cracks were seen in at least eight locations along the 800-metre portion of the road in question, which was completed on June 21. The total budget for the two-kilometre road project is over Tk 2.17 crore, which means that nearly 40 percent of the fund has been wasted on a shoddy construction work.

Is it any surprise that the collapse is being linked to the use of low-quality construction materials and lax monitoring by the relevant authorities? As usual, when asked, they sought to shirk their responsibility by blaming heavy rainfall and sandy soil underneath the road for its damage. One cannot help but wonder why these very predictable factors were not taken into consideration before or during the construction.

The Faridpur incident reminds us of a bridge in Tangail, built at a cost of Tk 54 lakh, which had tilted even before it could be inaugurated and was then left in that state for five years. Or think about when, in March last year, a road in Kishoreganj was found damaged just a week after its construction. This trend of shoddy construction shines a bright light on our current development policy which is often marked by poor planning, rampant corruption, lack of monitoring and accountability. We have frequently raised our concerns in this regard in the past.

We urge the LGED authorities in Faridpur to immediately undertake repairs to make the road operational and ensure that the responsible contractor is brought to book. Such questionable practices undermine the purpose of development and rather increase public suffering. Quality control is a vital part of any construction project, and must be treated as such by all stakeholders.

Residents of major cities in Bangladesh find themselves gasping for clean air, their lives hanging in the balance. The air we breathe has become a silent assassin. The US-based Health Effects Institute (HEI) has estimated that in 2019 alone, poor air quality in Bangladesh led to approximately 173,500 deaths. This public health emergency requires immediate attention and a drastic shift in our energy policy for the next 50 years. The current energy policy bears significant responsibility for air pollution, global warming, urban heat, public health issues, and the strain on healthcare budgets. It is imperative to break free from an unsustainable energy policy and embrace the potential of renewable energy sources.

The energy sector, which contributes a substantial portion of global CO2 emissions, is responsible for 40 percent of Bangladesh's greenhouse gas (GHG) emissions. This alarming statistic calls for an urgent reduction in emissions from our energy system. While we understand the importance of economic growth for the 170 million people in our country, we must question the costs associated with achieving this growth.

Over the decades, Bangladesh has made significant progress in increasing its power generation capacity, reaching

26,700MW in 2023 compared to 4,942MW in 2009, as stated by the finance ministry. However, our heavy reliance on coal, liquefied natural gas (LNG), and liquid fuel-based power generation using conventional quick rental technology raises significant concerns about the sustainability of our energy sector. There is a probable link between poor air quality, urban heat, and the current energy policy, which also hinders our ability to fulfil our commitment to reducing GHG emissions to limit global warming to 1.5°C by 2050.

According to the Power Division, a mere 0.38 percent of the country's electricity production came from renewable sources in the 2021-22 fiscal year. This disproportionate dependence on fossil fuels places an economic burden on us and raises concerns about our long-term energy security. The increasing need to import fossil fuels to meet our growing electricity demand further exacerbates the issues related to poor air quality, urban heat islands, climate change, and the additional healthcare costs associated with protecting public

Regrettably, the 2022-23 budget failed to prioritise renewable energy sources for energy security. Instead, it allocated a negligible portion of approximately 894MW. generated from renewable resources. The focus was primarily on increasing fuel capacity, oil refinery storage, coal production, and gas collection. This approach disregards the immense potential of alternative sources, particularly hydroelectric, and solar energy, which could offer sustainable and economically viable solutions.

should seize the opportunity to harness is driven by renewable resources, renewable energy. Our neighbouring countries have already taken advantage of their geographic positions to utilise these promising options, which may also hold tremendous potential for us. Additionally, our long coastline and the winds during the monsoon season make wind energy a viable option worth exploring. The mountainous regions in our country could serve as potential hydroelectric resources. None of these options are expensive; instead, they are free, clean, and the most sustainable choices. When we utilise renewable resources for power generation, there are no air pollution or climate change issues.

We must also consider other renewable energy sources, such as municipal waste and biomass. By promoting initiatives that convert waste into energy and utilising agricultural biomass, we can address our energy needs sustainably and contribute to effective waste management practices. Our municipal solid waste is indiscriminately dumped in open sites, causing water, soil, and air pollution. A study published in 2023 by Saint Louis University highlights Dhaka as a hotspot for methane gas due to poor waste management. Since municipal solid waste contains a significant amount of carbon, this resource has immense potential for energy generation.

It is disheartening that Bangladesh has set a meagre target of 4,100MW of electricity generation using renewable energy by 2030. This indicates a continued inclination towards fossil fuel imports, despite our tremendous potential for alternative sources. We should aim higher and envision

As a tropical country, Bangladesh a future where our energy policy setting an example for global climate change mitigation. The success of the California state government, which secures 100 percent of its power grid energy from renewable energy sources, and Saudi Arabia's exploration of possible renewable energy sources serve as inspirations for our own

According to a study by Gulagi et al. (2020), transitioning to renewable energy has challenges, such as land availability. However, with efficient planning, a mere 10 percent of our land area can accommodate a substantial ground-mounted solar PV installation. Innovative solutions such as rooftop solar systems, small-scale solar with batteries, and floating solar systems can further overcome the limitations we face. It is crucial to recognise that our energy sector plays a pivotal role in our overall development. Prioritising renewable energy over poor operational practices, inefficient technologies, and inadequate maintenance is essential to address and alleviate our challenges. Embracing renewable energy is not a luxury, but a necessity for securing a prosperous future for Bangladesh.

In conclusion, the time for change is pressing. We urgently require a visionary and long-term energy policy that places renewable sources at its core. By fostering a sustainable economy with zero carbon emissions, Bangladesh can become a global leader in climate change mitigation while simultaneously improving the air quality and public health in our major cities. Let us seize this opportunity and take the necessary steps toward a brighter and greener future.

'Aggression from govt, private bodies a huge challenge for us'

In an exclusive interview with The Daily Star, Dhaka South City Corporation (DSCC) Mayor Sheikh Fazle Noor Taposh talks about the current state of playground and parks, tree felling for development purposes, and the importance of public opinion in designing projects.

Beautiful Dhaka – with playgrounds, greenery and parks – was one of your five electoral pledges. However, we have been observing a distressing trend of key public parks, such as Osmani Udyan and Panthakunja Park, remaining off limits to the public due to never-ending construction work. Why this long delay in ensuring people's access to

In my election manifesto, I categorically mentioned that we want to bring back ward-based playgrounds. Even if we can find just a small piece of land, we'll turn it into a playground for children. For instance, in Sutrapur, under Ward 42, which is a densely populated area in Old Dhaka, a small piece of land of the DSCC was leased in the name of establishing a car park and market. But they were essentially occupying the land for years, even after a case had been filed with the High Court. I recovered the land from encroachers, disposed of the case, and made the land accessible for children. In Alamganj, under Ward 46, we recovered a piece of PWD land – which had been encroached upon from every side and turned into a warehouse of sorts from the encroachers and erected a fence around the

As for the parks you mentioned, they are being constructed under megaprojects, but it is sad that for various reasons, the work has been delayed. Just after I took over as mayor, I visited Osmani Udyan thrice and tried to fast-track its completion. But unfortunately, the contractor violated the terms and conditions of our contract, and we had to cancel it. Now, we are going for implementation based on the original design. But three years of my tenure have already passed. Appointing new contractors after doing due diligence is a lengthy

Our project at Panthakunja had to be suspended due to the construction plan of the elevated expressway. Many unnecessary infrastructures had been planned in the earlier designs of the expressway, so we had to ask them to revise the designs to showcase the natural beauty instead. But, again, we had to cancel the contract and we will have to invite a fresh tender for it. We are hoping to resume the work of both parks this year and complete them within a short time.

are saying have taken many initiatives to ensure parks and playgrounds in every ward, but we have seen some government organisations occupying and constructing housing projects on some of these playgrounds. In Azimpur,

for instance, three playgrounds were gobbled up to construct high-rise buildings. According to the Detailed Area Plan, 25 wards of DSCC are still without any playgrounds.

Aggression is a huge challenge for us – aggression from land-grabbers, private organisations, and government bodies too. You will be surprised to hear that in Ward 11, Rab was going to build an office occupying a DSCC playground. The agreement had been signed just before I took over office. I told them that they cannot take over a playground.

But we are also taking proactive steps. We have spoken to the deputy commissioner and asked him to identify government land, particularly in 18 new DSCC wards, so that we can build sufficient playgrounds in a planned manner. We are constructing the Dhupkhola playground. We have opened Golaphag playground and Sadeque Hossain Khoka playground for the public. So, we are doing our work at a time of tremendous

In Dhanmondi, why have most of the public playgrounds been leased out to private clubs, barring access to the public? Dhanmondi Lake has been leased out to various businesses, most of whom are violating their lease by not doing due maintenance of the parks. Are you concerned

The playgrounds we are constructing or renovating will remain open for all round the clock. But we are also seeing that some of the playgrounds, particularly in posh areas, are being run by different academies. The Dhanmondi Sheikh Jamal playground is operated by Sheikh Jamal Club, and it was leased out to them before my time. The Abahani field, too, has been under the Abahani Club for a long time - since the 70s, in fact. But the Abahani field is still open to the people, as far as I know. The construction work that is going on now is on the land that belongs to Abahani to expand

In many cases, parks and playgrounds were reduced in size when renovated under megaprojects as part of their design – it was done by urban planners themselves. Under these projects, new structures were introduced to be run commercially to ensure the maintenance of the parks. The design of Dhanmondi Lake was prepared in 1996, after the Awami League government came to power. And we still have the same infrastructures that were initially in the master plan - nothing new has been added. Those who took the lease before ran those establishments but did not pay the DSCC for 14 years. I cancelled those leases and gave out new ones,

maintaining the same conditions. People in Dhaka have limited places to visit, and everyone wants to visit Dhanmondi Lake. So even

though people complain to me all the time that there are too many people there, we can't really help it. However, we want to keep all the parks, udyan and public places under the DSCC closed for one day of the week for due maintenance and cleaning.

We have formed a committee to maintain these parks, playgrounds and public places. Earlier, everything would be done based on a given project, which meant that as soon as the project ended, there was no one to ensure its maintenance. City corporations also did not focus on maintenance work. As we have the financial capacity now, we are prioritising this issue. We have appointed an arboriculturalist, caretakers and new gardeners to maintain the greenery and aesthetics of the spaces. We are building our capacity.

There have been widespread protests and criticisms about the tree felling on Satmasjid Road. Although urban planners and environmentalists have said the development work could have been done without harming the trees, you have insisted that the action was inevitable.

People can make a lot of generalised comments. We also have our own experts and urban planners, and we have designed the projects based on their recommendations. We do not want to fell trees unless it is absolutely necessary. Even then, if some trees have to be cut for development purposes, we make sure to plant three times as many trees. You have seen how many plants we have already planted on Road 27. Basically, we want to replace big trees with smaller flower plants in the medians, which increase the aesthetics and are also easier to maintain.

Shundor Dhaka is one of our electoral pledges. We have planted over 300,000 plants, but unfortunately, no one listens when you beat your own drum.

> As a city mayor, how important is public opinion to you? Is there any mechanism in place to inform the public and engage them in consultations before major decisions are made about

> > development work?

We give utmost importance to public opinion. Every time we undertake a project, our consultants directors supposed to visit the locality and engage with community members, and design the projects based on their concerns and recommendations. It's not as if a project is designed from a mayor's office! that a lot of our external consultants didn't actually make the field visits before designing the projects

they did so from the comforts of their offices, on their laptops. As a result, many of those designs were flawed and completely devoid of the grassroots reality. However, we have begun the process of consulting the

There are many projects where we have taken the perspective of the local communities into consideration before finalising the details. Sometimes, when we tell the experts that we want an aesthetic and beautiful space, they come back to us with elaborate designs where there are costly structures with only a few trees here and there. But then we hear from the communities that they do not want such obstructions they want open, unrestricted green space. And we definitely prioritise people's concerns.

So, you are saying that when there is a protest from a given community about one of DSCC's projects, you revert your decision based on people's demands?

Yes, there are many such examples. But you also have to see where the resistance is coming from. When I went to excavate the Buriganga, land-grabbers naturally resisted. You can't pay heed to their resistance. We went to the field, we inspected CS, RS, SA blueprints, RA blueprints, field survey blueprints, GIS maps, etc before we went for implementation. If someone comes and says their grandfather left them land in the middle of the river, I can't accept that. Of course, I have to take a stern stance then.

In the last one-and-a-half decades, Tk 115 crore was spent on setting up modern traffic signal lights. but people did not get any benefit from it. Now, the DSCC is going to set up AI technology at 54 spots to modernise traffic signals. Experts think this kind of technology is not viable for Dhaka city where the volume of traffic is huge. What do you think?

I am also concerned about the project's success. We are going to implement this work in two phases. In the first phase, we need some infrastructural development, such as expanding roads, balancing the lanes and ensuring pedestrian-friendly footpaths. There are some other roads which are not of the same width throughout, meaning some parts are narrower than others, which create traffic congestion. In the second phase, synchronised traffic signals will be introduced, which was not done earlier.

We will definitely do a pilot project before going for synchronisation. Besides, the remote control that was given to the police previously was not synchronised, and they could control the signals manually through the remote. After a while, they just returned to their old system of using sticks. We will set up a central control room through which to control the entire signalling system. If we become successful, then Dhaka will get a modern traffic movement system after a long time.



Erosion of values in our universities

University teachers used to be held in high regard by everyone in our society even just a few decades ago. Bangabandhu Sheikh Mujibur Rahman considered university teachers to be the conscience of the nation. However, university teaching as a profession has been losing its glory by the day. One could, of course, dispute my assertion. Having stayed in the profession for 25 years, I can say that the public no longer treats university teachers with the same level of respect that they did 20 years ago. The problem now is understanding why teachers at universities are becoming less respected. Do any of them display signs of moral decline? If yes, why did it occur?

Many faculty members at higher educational institutions around Bangladesh have lost their moral compass. Regarding the decline of moral standards in the academic world, academic dishonesty ranks high among the most pressing problems. Numerous teachers at different universities have persisted in engaging in unethical practices like plagiarism, fabrication of research findings, and discrimination based on favouritism. Through the media, we become aware of such developments every now and then. These actions undermine academic honesty and lower standards in the classroom. It's promising that universities nationwide have begun acting against these dishonest educators.

Another issue is the exploitation of power dynamics. Some of Bangladesh's faculty members use their positions of power to discriminate against students or fellow faculty members based on gender, ethnicity, religion or political ideology. This kind of conduct is counterproductive to establishing a safe and welcoming learning environment for all students. Some faculty members' desire to wield power and maintain ties with the establishment make them ignore their primary role as teachers; they are on the lookout for opportunities to use their official status for their benefit. There are, of course, always exceptions.

Concerns have also been raised about some faculty members' perceived lack of professionalism in Bangladesh. Some educators are lackadaisical about their jobs, enough time with their students, or because they don't interact with them positively and encouragingly. The trust that students and the general public place in the education system is impacted by this lack of professionalism.

There are additional contributors to the decline of moral values among Bangladeshi faculty members. These include a lack of accountability, a culture of impunity, and inadequate training and support. It has been argued that a decline in ethical values is also caused by broader social and economic factors, such as poverty, inequality, and political instability, which impact some university faculty members.

transparency systems encouraging a culture of professionalism and among faculty and students at all levels of education. Broader social and economic reforms that prioritise social justice, equality, and good governance can also increase teachers' and the general public's confidence in universities.

University members' faculty declining moral standards threaten the credibility and quality of education. University administration, policymakers, civil society organisations, and the general public must all work together to solve this problem. The academic system in Bangladesh can contribute to the country's social and economic development and uphold the highest ethical standards if a culture of professionalism, accountability, and integrity is fostered within it.

The Bangladesh government has taken several steps to improve the standard of higher education impede progress towards better in the country. For instance, education for all citizens.

the government has focused on revamping the University Grants Commission (UGC) so that it can better steer universities towards the goal of improving their quality. With support from the World Bank, the government launched the Higher Education Quality Enhancement Project in 2009 intending to enhance the quality of higher education in the country by investing in new facilities, better support for teachers, more research, and more effective pedagogy.

Accreditation now that it has been established, will evaluate universities' quality according to a set of criteria, such either because they don't show up as academic standards, research to class, or because they don't spend capacity, faculty qualifications, and infrastructure. Recently, the government has increased funding for scientific and technological research. To foster innovation and research across disciplines, the Ministry of Science and Technology has established several research centres and institutes.

The government has actively sought opportunities for academic institutions to work with their counterparts in other countries. Universities worldwide have formed alliances with one another to share resources and facilitate academic and scientific collaboration.

Bangladesh's higher education system will significantly benefit from the government's efforts Reforms at the institutional to improve university standards. level are necessary to address the These actions will lead to enhanced deterioration of ethical standards facilities, expanded research, among faculty members. This better preparation of teachers, and includes bolstering accountability revised curricula. However, there is a need to alter the way educators think. If this doesn't happen, these efforts won't improve universities. The government should focus on recruiting prominent scholars and educators in the highest positions who can promote openness and accountability on campus. No education reform will succeed in the long run unless we also work to increase teachers' professionalism.

Therefore, there is still much to do to guarantee that all universities in Bangladesh are apace with academic standards on a global scale. The nation's higher education system faces challenges that can only be overcome with continued collaboration between the government and universities. Furthermore, the government should think about lessening the impact of politics on academic institutions. University professors who dabble in politics not only lower their professional standing, but also

BAGH BIDHOBA

Birth of Evil: The Sacrificial Survival of a Tiger-Widow in the Sundarbans Delta



Focusing solely on superstitions as the source of suffering overlooks the broader context and intertwined reasons behind the social exile, economic deprivation, violence, and discrimination faced by these widows. It also disregards the larger social, economic, and power dynamics that influence the fishermen community in the Sundarbans.

Sonamoni! No prefix, no suffix, that is her name. It signifies the golden pearl of the eye. However, the irony lies in the fact that this golden pearl became an outcast in society, as the locals cursed her as "Swami Kheko," meaning a husband eater. It was common to label women as "Swami Kheko" when they lost their husbands to tiger attacks in Sundarbans. Unfortunately, such identifying remarks still persist to some extent in that area. Recently, several NGOs have stepped forward with development projects under the name "Bagh Bidhoba" (tiger widows) to assist these vulnerable individuals. Consequently, "Bagh Bidhoba" has now become a popular category used to identify these women.

Sonamoni couldn't recall her date of birth, but she roughly estimated her age based on a significant event. "I got married at the age of 12, before the 'Golagulir Bachar' (the year of bombardment in 1971)." Her married life began with Charan Sardar, who belonged to the Bagdi community, a subgroup within the broader Hinduism fold, and was a successor of the fishermen in the coastal basin of Sundarbans.

The majority of fishermen and the Bagdi community lacked land for cultivation, which compelled them to venture into the water-bound Sundarbans to catch fish, crabs, wax, honey, wood, fruits, and other resources to sustain themselves. Moreover, they didn't have proper housing. From my observations, I discovered that they managed to live in cramped huts in the "Charland" of Chuna River, located at the edge of Sundarbans. This settlement is known as Jelepara, adjacent to the Munshiganj bazaar of Satkhira range Sundarbans. They have resided in this area for generations, sometimes following hereditary lineage and other times shifting their profession to fishing and crab collection in the marshy forest for an extended period.

The landless Bagdi community finds themselves trapped within the intricate months into years, Sonamoni became

sustain their livelihood, despite the constant threat of tiger attacks. In the small village of Jelepara, it is rare to find a family that haven't experienced injuries, losses, or fatalities among

their kin, relatives, or neighbors due to these tiger encounters. Despite the high risk to their lives, thousands of people venture into the Sundarbans every day in the coastal regions just to

Among them was Charan Sardar, Sonamoni's husband, who embarked on a 15-day trip into the forest with a group of fishermen after obtaining a permit from the forest department in 1973. The first 14 days passed uneventfully, but on the final day, as they were returning home, Charan Sardar stopped to gather firewood for their household. It was then that a nearby fishing boat passed by, and he asked them to relay a message to Sonamoni: "We will be home by noon, so tell her to cook rice.'

Upon receiving the message, Sonamoni prepared the food and anxiously awaited her husband's arrival. However, on that unfortunate Sunday, news spread rapidly through Jelepara. A tiger had attacked Charan Sardar and dragged him deep into the dense vegetation. The villagers immediately organized a rescue mission in an attempt to recover his body from the tiger's clutches. Unfortunately, the efforts were in vain as the river tides had washed away any trace of his whereabouts.

llowing the tragic loss of her husband to a tiger attack. In her own words, she shared, "Upon hearing the news, I felt a moment of faintness and couldn't felt like I had lost everything in life. I was

leading to strained relationships and became symbolic of foreboding and ill frequent arguments over various daily issues. Sonamoni shared, "Even my brothers and their wives began accusing me, claiming that the tiger attacked my husband because of me. Whenever any discomfort arose within the family. they would blame me for having eaten my husband and even threatened that I would devour them and their children. I had no place in my in-laws' home, nor did I have any shelter in my parents' house. In moments of despair, I would lament, 'Oh Bhagoban' (god), it would have been better if the tiger had devoured me."

Amidst those challenging circumstances, one of her distant fathers-in-law came forward to provide assistance and help them secure a shelter where they could survive and protect Sonamoni's child. Her motherin-law welcomed Sonamoni back. "After returning to my in-laws' house, some relatives convinced me that we have another unmarried son. If you marry him, you will be able to survive and provide a better life for your child," Sonamoni recounted.

With limited options, Sonamoni reluctantly agreed to this marriage proposal. Thus, she married her brotherin-law, who happened to be the younger sibling of her deceased husband. It felt as though she had lost a family in the ebbing tide and had now found solace in the surging waves. However, just as the tidal waves bring extremely saline water that renders the coastal area's health Sonamoni faced immense hardships and soil infertile, the second chapter of Sonamoni's life was marred by the unforgiving nature of societal prejudices. The villagers were unwilling to accept her as she was branded "Swami-Kheko" believe it. I had lost my husband, and it and considered a source of bad luck for the larger community. Consequently, only 14 years old at that time. Right after Sonamoni and her husband, Bhaban

this shocking moment, my mother-inlaw blamed me, saying that her son had to die because of me. I was branded as 'Opoya' (evil), 'Olokkhi' (inauspicious), and 'Oshoti' (cuckold). Consequently, they started calling me 'Swami Kheko' (husband eater). These curses pushed me to the brink of suicide, but I couldn't take such a step because I had a sevenmonth-old child to care for. I silently endured every curse for the sake of that

Following that traumatic incident, Sonamoni's brothers stepped forward to support her. She temporarily found refuge within her brothers' family. As time passed, her brothers took it upon themselves to find a suitable groom for her. However, due to the stigma attached to being labeled a "husband eater," no one was willing to accept her. Additionally, Sonamoni herself had no desire to remarry, as she wanted to focus on raising her son without the potential pain and deprivation that could come from a stepfather.

As days turned into months and network of watery forests in order to an additional burden for her family,

Sardar, were subjected to social exile or "Ekghore" by the villagers.

Sonamoni became a dreaded symbol of "bad luck," and her family had to adapt to a life of ostracization within the village. She explained, "We were prohibited from participating in any social or religious ceremonies. If someone was getting married, a few days before the ceremony, someone from that household would come and ask me not to step outside. They believed that my presence would bring misfortune to the newly weds. I was not allowed to attend any Puja (religious ritual) because they believed that my presence would render the Puja Mandap impure and displease the gods and goddesses. Even my innocent son's presence was not accepted at any social festivals or gatherings; he would cry and we would have to return home."

Sonamoni also shared that she would hide whenever the Bonojibis (local people who ventured into the forest for resources) went into the forest. They believed that if she was spotted during the initial stages of the forest expedition, it would attract tiger attacks towards the Bonojibis. Sonamoni and her family omen for the larger society. Due to being associated with social evil, she lost all avenues of social connections, even with her own relatives.

However, a couple of years later, that forceful imposition of "Ekghore" life had been withdrawn over successive fierce conflicts between Sonamoni and larger Bagdi Samaj. As a consequence, Sonamoni had to arrange social gatherings twice and serve food to the villagers to erase the "Ekghore" status and for the social recognition as decided by the leaders of her Samaj.

Despite the challenges they faced, Sonamoni and her second husband had three more children. As her elder son grew up, he and her husband began fishing together in the jungle to sustain their livelihood. They relied on catching fish and crabs for survival, though they struggled to attain financial stability. The hardships of life continued to follow

In an attempt to alleviate their difficult circumstances, Bhaban Sardar purchased a Pata Jal (a type of fishing net) from a nearby market. He processed the net by applying gum derived from velvet apple, which enhanced its durability and made it easier to set up along the long riverbanks. With a pass permit obtained from the forest department, he joined a group of fishermen for a fishing expedition. Utilizing the Pata Jal, thev had a successful catch during the trip and anticipated returning home soon.

However, tragedy struck once again. While they were preparing to pack up the net and other belongings, a tiger suddenly pounced on Bhaban Sardar, injuring his shoulder and other parts of his body. Despite their best efforts, his colleagues were unable to rescue him, and his body could not be recovered. Once again, Sonamoni experienced the loss of her second husband, mirroring the circumstances of her first husband's

After this incident, the villagers had no doubts in labeling Sonamoni as a source of bad luck for the Bonojibis. Consequently, her mother-in-law confined her within the house, forbidding her from going outside. The belief was that her presence would bring misfortune to the Bonojibis, and the risk of a tiger attack would increase if she was sighted during their forest expeditions.

Sonamoni shared her heartbreaking story, saying, "My mother-in-law had lost two of her sons, and I had lost two husbands. After those tragic incidents, she became convinced that I was Swami Kheko, and she forcibly restrained me and later expelled me from the house. I attempted to find work to sustain myself, but people continuously rejected me. I resorted to collecting rice gruel (Vater Fan) from door to door, sometimes cooking "Shaluk" (water lilies) and "Khuder Bhat" (broken spare rice). Life had become stagnant, devoid of any

In desperation, I started working as a cleaner in various establishments in Munshiganj bazaar. I worked in tea stalls, hotels, grocery shops, rice storehouses, and decorator shops. I took on any kind of work that came my way. It was through these endeavors that I managed to provide for and raise my three children. I even saved enough to arrange their marriages."

When I asked her about the reasons behind the accusations of being a husband-eating evil, Sonamoni explained, "Listen carefully. When my husband would leave home and venture into the jungle for resources, I was expected to adhere to certain practices. I was not allowed to apply vermillion on my forehead, tie up or part my hair, or even oil and comb my hair. I couldn't wash our clothes or do any sewing. Cooking during the day, frying chilies, or even disposing of ashes from the oven was prohibited. I was not permitted to entertain relatives or neighbors by offering them good food. Brooming and mopping the house, as well as casually going to the market, were also forbidden. There were many sets of practices, known as 'Bachok,' that were expected of women whose husbands went into the jungle."

These "Bachok" practices hold esoteric explanations. It is believed that by following these practices, the forest expeditions of their husbands are secured, acting as safeguards and bringing well-being, protecting them from tiger attacks. On the other hand, the Bonojibis themselves have to adhere to additional "Bachok" practices.

Sonamoni continued, "My husband also had his own set of 'Bachok' when entering the jungle and working there. For instance, he was not supposed to enter the jungle on Fridays as it was considered a sacred place, and his body had to remain sacred. They had various mantras (formulas) to recite in the jungle. They had to use leaves for toilet purposes and were not allowed to eat crabs. Since the jungle is considered the sacred place of Bonbibi, nobody was allowed to harm anything within its boundaries. Every member of the group had to follow the guidance of the Gunin/Fakir (spiritual leaders). They had more 'Bachok' than

Sonamoni further explained, "You see, my parental home was far from the jungle, and fishing was not a common activity there. Hence, I was unaware of these 'Bachok' practices. After getting married and coming here, I did my best to follow these practices whenever my husband went into the jungle, although sometimes I couldn't adhere to all of them due to urgent matters. But people would curse me as if I were the sole reason for the tiger attacks, even though my husband followed his own 'Bachok' as well."

The practices of "Bachok" in the Sundarbans, stemming from the belief in Bonbibi, are often viewed as cultural stigmas and superstitions by various stakeholders in the region, including some environmental activists, conservation movements, tourist agencies, NGOs, media outlets, researchers, and the forest department. They portray these practices as exacerbating the suffering of "tiger widows," and Sonamoni's experiences align with this narrative. However, focusing solely on superstitions as the source of suffering overlooks the broader context and intertwined reasons behind the social exile, economic deprivation, violence, and discrimination faced by these widows. It also disregards the larger social, economic, and power dynamics that influence the fishermen community in the Sundarbans.

We also need to address questions regarding the sources of decisionmaking power within the Samaj (community) beyond customary laws and state apparatus, and how it functions as a social norm. For example, the mechanism that defines Sonamoni's transition from human to evil, and later from evil to human, demonstrates the cyclical nature of categorizing humans within the anthropological machine of her community. This process creates a dichotomy between humanity and others, leading to the justification of practices such as slavery and genocide. It also allows for the acceptance of violence against those defined as the "other," stripping them of their human status. In the case of Sonamoni, she was forced to endure a life of social exile imposed by the Bagdi Samaj, following acts of social performance through dispositif rather than simply stigmatizing her belief in Bonbibi. Therefore, without delving into the constitutive functions and sources of authoritative power within the Bonojibis' Samaj, any understanding of the beliefs and practices regarding Bagh Bidhoba would be incomplete.

Bangladesh slumped to a 142-run defeat against Afghanistan in the second and penultimate ODI on Saturday to lose their first-ever ODI series against the visitors. The Tigers have enjoyed a healthy record at home and the series defeat was only their third at home since 2016. The question that most comes to mind is whether the defeat had more to do with non-cricketing reasons than cricketing ones.

"Please stick to cricket. Don't step outside of cricket. When players coming up in the future do well, write about it. When they play badly, write about that too and criticise them; that is all good. We all know that sometimes we overstep our boundaries," was a message from ODI skipper Tamim Iqbal towards the media during his retirement announcement on Thursday, July 6 – a decision he would withdraw on July 7. As a cricket reporter however, watching Bangladesh perform on July 8, it was difficult to just "stick to

Of course, there were cricketing reasons. The bowlers were not able to create pressure and keep a batter at one end for long. Rahmanullah Gurbaz and Ibrahim Zadran had a field day rotating the strike; punishing loose balls which were aplenty. The Afghan spinners were a handful and it was once again portrayed that trying to read them, after the delivery had already landed, was a difficult task and the Tigers had a torrid time.



But beyond that, the larger picture and the reasons for that performance were beyond just cricket. The body language of the players, lacking in concrete ideas or execution of plans, were all on view. As if they had turned subpar in a matter of

Before every series there used to be some noise that used to distract players but for a few months or so, from the T20 World Cup to head coach Chandika to the public eye regarding Shakib and arching over the current passage of play.

Bangladesh Football Federation's referees' committee chief Azad Rahman conducted the draw ceremony for the tournament.

Golam Sarwar Tipu will lead a 19-member tournament committee while Ashrafuddin Ahmed Chunnu will lead the technical committee.

The BFF boss praised other players as well including some seniors. "{Anisur Rahman) Zico has become the



"Definitely, delighted to be here, especially as man of the match. Great win for us and it keeps the series alive. I was not good in that dressing room. To go up against some of the best fast bowlers in the world, it's the first time I've got England over the line with the bat so I'm delighted," he said after the match.

Poor monitoring to blame for slow pace

IMED report blasts BR

After observing the slow pace of a project under which rail tracks are being laid on a 19km stretch between Faridpur and Magura, a report prepared by a government body has accused the railway authorities of serious lacking in their monitoring.

The revised deadline for the project is June 2024, but it has seen around 40 percent progress so far, indicating that there is little chance it would be completed on schedule.

The long delay in land acquisition is also hindering the implementation of the Tk 1,202.49-crore project, the report said.

The in-depth monitoring report of the Implementation Monitoring and Evaluation Division (IMED) recommended preparing a time-bound action plan and ensuring proper monitoring and reinforcement.

The project authorities said the contractors have slowed down the work over their unmet demand for adjusting the price of construction materials following the sharp hike in the global market. Project Director Ashadul Haque told The Daily Star yesterday that they

have already written to the authorities concerned to solve the issue. In May 2018, the government approved the project for constructing a

rail line from Faridpur's Madhukhali to Magura even before carrying out a feasibility study.

The project was supposed to be completed within April 2022. But its physical work started in June last year, as the authorities had to finish a feasibility study and a detailed design before beginning the physical work.

The revised deadline for the project is June 2024 but it has seen around 40 percent progress so far, indicating that there is little chance it would be completed on schedule.

Later, the project deadline was extended to June 2024.

Bangladesh Railway appointed two China-Bangladesh joint venture companies as contractors.

The project saw a 41.37 percent progress till this June, which is only a 3.85 percent rise from June last year, shows BR's monthly progress

IMED, which published the report recently, also said 20 meetings of Project Implementation Committee (PIC) and Project Steering Committee (PSC) were supposed to be held in the last five years, but only

"There is a weakness on the part of Bangladesh Railway and the Railways Ministry in project monitoring," reads the report.

"PIC, PSC, Bangladesh Railway and the Railways Ministry should have taken the cost management issues seriously," it added.

Asked about the matter, PD Ashadul admitted that the project could

not make the expected progress. He said following the decision of the PSC, they wrote to Central Procurement Technical Unit (CPTU) seeking its opinion regarding

contractors' demand to adjust material prices, but the CPTU has not The IMED report said 112 acres of land would have to be acquired in Magura for laying an 11km rail line there, but the land acquisition work

saw no major progress there. BR sources said the project authorities have handed over Tk 155 crore and Tk 40.21 crore to Magura and Faridpur district administrations for

land acquisition. However, it was later discovered that Magura actually required Tk 114

crore, while Faridpur needed Tk 80 crore. As a result, Magura needs to send back Tk 40.22 crore to the Faridpur

district administration. The mismatch in fund allocation is also causing a delay in land

acquisition. Asked about IMED's allegation of poor monitoring, the PD said the organisation might mean the delay in settling the contractors' price adjustment claim, but it is not possible to solve the problem by the

railways authorities alone. Several government agencies are involved and it will take time, he added.

Record 91 hajj pilgrims die this year

A record 91 Bangladeshi hajj pilgrims died so far in Saudi Arabia this year.

Of the deceased, 22 are female and 69 are male, according to the Ministry of Religious Affairs.

The ministry's bulletin released on July 8 revealed that 75 hajj pilgrims died in Makkah, five in Medina, seven in Mina, two in Arafat, and one each in Jeddah and Muzdalifah.

This year's hajj has been observed amid intense

Thirty-two hajj pilgrims died within a week since July 3. On June 29, 7 hajj pilgrims died due to heat stroke, according to media

This is the highest number of Bangladeshis who died in Saudi Arabia during the holy hajj, according to the Hajj Agencies Association of

Sudan faces 'fullscale civil war'

UN warns as air raid kills 22 civilians, injures dozens

Conflict-torn Sudan is on the brink of a "fullscale civil war" that could destabilise the entire region, the United Nations warned yesterday, after an air strike on a residential area killed around two dozen civilians.

The Ministry of Health reported "22 dead and a large number of wounded among the civilians" from what it described as an air strike Saturday on Khartoum's sister city Omdurman, in the district of Dar al-Salam, which means "House of Peace" in Arabic.

After nearly three months of war between Sudan's rival generals, the air strike is the latest incident to provoke

Around 3,000 people have been killed in the conflict, survivors have reported a wave of sexual violence and witnesses have spoken of

ethnically targeted killings. There has been widespread looting, and the UN warned of possible crimes against humanity in the Darfur A video posted by the health ministry on

Facebook showed apparently dismembered bodies lying partly covered on the ground after the air strike. Several women were among the victims. The paramilitary Rapid Support Forces

(RSF), fighting the regular army, claimed that

the "air strikes" killed 31. Residents contacted by AFP also confirmed an air strike but yesterday, the armed forces

released a statement "clarifying that the air

force did not deal with any hostile targets in Omdurman yesterday [Saturday]."

Since the war began, paramilitaries have established bases in residential areas, and they have been accused of forcing civilians from their homes. Witnesses reported more air strikes near

the presidential palace in central Khartoum yesterday, as well as machine gun clashes and artillery fire in the city's south. UN Secretary-General Antonio Guterres

yesterday condemned the air strike in Omdurman, which he said

"reportedly killed at least 22 people" and wounded dozens, his deputy spokesperson Farhan Haq said in a statement.

Guterres "remains deeply concerned that the ongoing war between the armed forces has pushed Sudan to the brink of a full-scale civil war,

potentially destabilising the entire region", Haq Sudan, in northeast Africa, borders other

impoverished countries which have a history of unrest.

Nearly three million people have been uprooted by Sudan's fighting, among them almost 700,000 who have fled to neighbouring countries, according to the International Organization for Migration.

The UN and African blocs have warned of an 'ethnic dimension" to the conflict in the western region of Darfur, where the United States, Norway and Britain have blamed the RSF and allied militia for most of the widespread violations.

UNIVERSAL PENSION 4 schemes to be on offer **Finance ministry** prepares draft rule

The finance ministry has prepared a draft rule for the Universal Pension Scheme (UPS) delineating four separate schemes for both local and non-resident Bangladeshis.

The schemes -- Probas, Progoti, Surokkha and Samata -- can be availed by everyone except government employees.

There will be different ceilings in the Probash scheme, which is for non-resident Bangladeshis. The instalments can be paid The Progoti scheme is for private

sector employees and will be similar to the provident fund. Employees will pay a certain percentage of their basic salaries towards the scheme and their employers would be putting in the same amount.

The Surokkha scheme was designed for those in the informal sector. There will be different instalment ceilings. The instalment amount will not be dependent on basic salaries.

Samata scheme is for the poor, with the government bearing half the instalment amount.

The detailed mechanisms of the schemes will be defined elaborately by separate rules SEE PAGE 6 COL 2

The government appointed new deputy commissioners to 10 districts yesterday, just three days after appointing nine new DCs and transferring one.
