Amid water stands a community clinic

500 families can't access healthcare during monsoon in Habiganj

There is only water, stretching as far as the gaze can reach. Amidst this submerged world. stands the Madhabpasha Community Clinic.

This clinic is the lifeline for the residents of Madhabpasha village, nestled in the Jalsukha union of Ajmiriganj upazila in Habiganj.

With approximately 500 families and 1,500 eligible voters, this small village relies heavily on the services provided by this humble medical facility.

However, during the monsoon season, when the village is swallowed by the relentless floodwaters, reaching the clinic becomes an impossible feat, leaving the inhabitants in dire need of medical care.

Sixty-five-year-old Amir Hossain said, "The clinic remains waterlogged till the end of monsoon. Even after the water recedes, it takes several months for the mud to dry and the road to be repaired. resulting in the clinic's closure for about four to five months each year."

Ashok Ali, another resident, highlighted the dire consequences of this situation, as

the rainy season brings forth an outbreak of water-borne diseases like cold, fever, and cough.

However, due to the lack of communication and clinic inaccessibility, villagers are unable to seek medical help and must rely on local village doctors in the upazila.

With a sense of urgency, locals have expressed their concerns to the health department and public representatives, demanding a swift solution to ensure uninterrupted healthcare access for the community.

Anamul Haque Milad, a local journalist, said the clinic is located on low-lying land, merely 50 feet away from the village road. However, the absence of a concrete road connecting the clinic to the village causes the problem, he said.

Repeated calls for construction of a proper road has fallen into the deaf ears of the authorities concerned, he added.

Clinic Madhabpasha Community health care provider Rashina Akhter echoed the same.

RANA PLAZA TRAGEDY SC stays Sohel Rana's bail for six months STAFF CORRESPONDENT

The Supreme Court yesterday stayed for six months a High Court verdict that granted bail to Sohel Rana, owner of Rana Plaza, in a murder case.

At least 1,135 people, mostly garment workers, were killed and over 2,500 others injured as the ninebuilding came storey crashing down in Savar on April 24, 2013.

The Appellate Division of the SC also kept stand over (waiting for hearing) a petition filed by the state challenging the HC verdict. A full bench of the Appellate Division headed by Chief Justice Hasan Foez Siddique passed the order

For the residents of Mymensingh, waterlogging due to poor waste management has become a seemingly never-ending problem. Locals alleged that the city goes under filthy water even after a

little rain due to the poor drainage system, causing untold sufferings. The stench from stagnant

water and sewage has made living unbearable, as many city dwellers including children are forced to wade through the submerged road for lack of rickshaws and other modes of transportation.

Sewage contaminates the stagnant water because of the poor drainage system, resulting in greater health risk for the residents, according to experts.

Besides, the stagnant water has become a breeding ground for

dengue outbreak, said Araz Ali, a local.

During a recent visit to Makarjani canal on Mymensingh city's Ram Babu road, this correspondent saw that the drains were not cleaned, leading to waterlogging in adjacent areas.

Not just this sewage line, many other city drains were found in a similar condition. Nazrul Islam Chunnu, convener of citizens' forum Jono Uddyag, said, "We thought the situation would improve after the government recognised Mymensingh as the country's 12th city corporation in 2018. But the city drains still remain dirty, creating waterlogging." "The city drains and canals must be cleaned up on a

regular basis," he added. corporation sources City told this correspondent that dengue," he added.

Mohabbat Ali, conservation inspector of Mymensingh city, said they are continuing their cleaning drives to tackle waterlogging issue during monsoon.

He also said around 600 workers are involved in cleaning and waste management activities in 33 wards. "The number is not enough."

Meanwhile, the city corporation has started drain and sewerage cleaning drives in different areas.

Mayor Ekramul Haque Titu said they have also initiated drives against illegal structures built on drains and canals.

Six people were killed and at least 16 injured in road accidents in three districts during the last two days, according to reports from our correspondents.

In Narayanganj, two teenage motorcyclists were killed as a car ran them over on Dhaka-Chattogram highway in Siddhirganj area yesterday.

Police said the accident happened around 5:10am on the western side of Kanchpur Bridge as they fell off their motorbike after hitting a road divider.

Shakil Khan, 19, of Dhaka's Matuail Dakkhinpara area; and Robiul Islam Tutul, 19, from Pabna's Sujanagar upazila died on the spot.

Shimrail Highway Police Camp Inspector AKM Sorfuddin said the two were going to Dhaka on a motorcycle. When they crossed Kanchpur Bridge, the rider lost his control over the vehicle, resulting in the accident.

The car driver managed to flee, said the police officer.
