and cooperating with the UN, its representatives and mechanisms."

Odhikar's renewal application was pending with the NGO Affairs Bureau (NGOAB) from 2014 until its deregistration in June 2022. In the letter denying renewal, the NGOAB accused Odhikar of publishing "misleading information," "seriously [tarnishing] the image of the State to the world," and "[creating] various issues against Bangladesh."

"Odhikar's case reflects the ongoing harassment and targeting of human rights defenders and organisations in Bangladesh. This practice is a clear violation of the right

HC asks BTRC to block online gambling ads

The High Court yesterday directed Bangladesh Telecommunication Regulatory Commission to block the online betting or gambling advertisements.

It also ordered the Bangladesh Bank to issue directives to all mobile financial service providers including bKash to stop their gateways and channels used to make payments to all betting websites. The HC bench of Justice KM Kamrul Kader and Justice Mohammad Shawkat Ali Chowdhury passed the order following a petition filed by Supreme Court lawyers Miftaul Alam and Sumit Kumar Sarkar.

the state, government, and market owners to oppress the labour population, creating discrimination," he added.

Mujahidul Islam Khan Selim, former president of the Communist Party of Bangladesh, said first and foremost, it is necessary to improve the law ensuring workers' wages. The production cost should determine the workers' wage, yet this basic principle is disregarded in modern culture, leaving workers in a state of uncertainty, he said.

Taslima Akhter of Bangladesh Garments Sramik Sanghati emphasised that the new wage board was established in an undemocratic manner without consulting the labour unions.

The meeting also addressed issues such as - ensuring shifts and overtime; repeal of the Prohibition of Strikes Essential Services Bill, 2023; a stop to retrenchment of workers, false cases, attacks and torture; introducing rationing system permanently, and factory owners and government's accountability for improving workers' quality of life.

"We've repeatedly asked the government to be consumer friendly but it has become business friendly," he said, adding that only seven to eight businesses are exploiting consumers of the country. He called upon the consumers to unitedly point out their distress to the government.

Although Prime Minister Sheikh Hasina is serious about the price hike issue, some corrupt bureaucrats are misleading her, said Humayun Kabir.

The CAB president said inflation is a complex matter which requires strong measures.

Like other countries, the government needs to give liberty to the central bank to fix interest rates to rein in inflation.

"Good governance is required to establish fairness in the society. The government should adopt impartial policy. Instead of business-friendly policy, it needs to adopt consumer-friendly policy," said Ghulam Rahman.

violence with its provocative acts and programmes.

The BNP's "Training Cell" arranged the day-long training workshop for women representatives of the party in collaboration with United States-based Democracy International at party the chairperson's office in Gulshan.

"Awami League do not believe in democracy. They choose dictatorship and feudalism. They have a mindset that there's no one else in the country except them and they're the only

owners of the country," he said. Citing a newspaper report, Fakhrul alleged that the government is trying to speed up the trial in the cases filed against him and their party chief Khaleda Zia. "They've instructed the police authorities and even the law ministry issued a letter to the judges to speed up the trial and dispose of the cases (against opposition leaders and activists)..."

Fakhrul said they have been carrying out a movement for the restoration of democracy in a democratic manner as the usurper government held

two elections completely deceiving people.

The BNP leader said there are now many discussions about the frequent trips of delegations from different countries to Bangladesh.

"An American delegation is coming today (Tuesday) while a team of EU has already arrived here to know about human rights democracy and elections here. Why do they come to Bangladesh? Because there's no democracy here and there're no (credible) elections and elections are not held (fairly) here," Fakhrul observed.
