Centre will be constructed within the forest. Additionally, a beat office under the Forest Department will be established to manage and safeguard the forest against encroachment, according to the senior official of the Social Forestry department.

Urban forests serve as vital defenses against airborne pollutants, alleviate the heat island effect, improve mental well-being, and contribute to the replenishment of water tables.

Prof Adil Mohammed Khan of the Department of Urban and Regional Planning at Jahangirnagar University said, "An urban forest helps maintain the environmental equilibrium of a city. Ideally, a city should maintain 25 to 30 percent green coverage, with five to 10 percent dedicated to urban forests. If properly implemented, this initiative could greatly benefit a city like Dhaka."

Maj (retd) Shamsuddin Chowdhury, Ahmed a member of Rajuk responsible for development, revealed that the draft MoU with the Forest Department has nearly been finalised.

He emphasised the importance of conserving and expanding the existing greenery in Purbachal to prevent any commercial encroachment.
