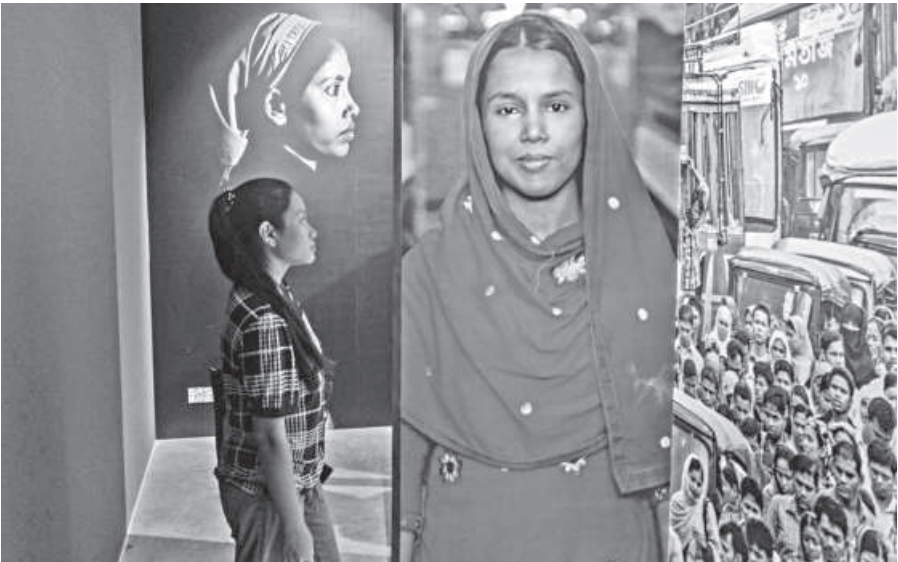




Looking back at the decade-old tragedy... “Ten Years After Rana”, an immersive exhibition by photo journalist Ismail Ferdous, kicked off at the capital's Drik Gallery yesterday. The exhibition marks the ten years of the incident, through the interdisciplinary works of the photographer, who had been capturing the tragedy since 2013. The layout of the exhibition had been done by architect Farhana Nazim Chowdhury, along with collaborations with visual artistes like Ata Mojlish. The exhibition is comprised of both interactive and poster art, leading the visitors through a winding road, through the victims and their family's eyes. In collaboration with the Bangladesh Center for Workers' Solidarity, the exhibition is partially funded by the 21st Century International Women's Garment Workers Union Heritage Fund. The open-for-all exhibition will run till July 29, from 3:00pm to 8:00pm.

BNP is demanding caretaker government system which only exists in Pakistan, he mentioned.
“My question is that why they (BNP) only follow Pakistan. Mirza Fakhrul (BNP secretary general) a few days ago said Pakistan (period) was better. So, it is natural that they would follow Pakistan,” Hasan said.
Reply to a question about visit of delegations of the European Union (EU) and the US, the minister said the EU delegation came at the invitation of the Election Commission. They held talks with the commission, ruling party

and opposition party and others and their visit was very much a positive one, he said.
About the visit of the US under-secretary and high-level officials, Hasan said Bangladesh has very good multidimensional relations with the US. “They are our development partner. In light with that, their visit was to further strengthen the ties,” he said.
The minister said Prime Minister Sheikh Hasina gave shelter to over 12 lakh Rohingya people. The US delegation visited the Rohingya camps, he said. “Their visit also strengthened our ties,” he said.

Four killed, six hurt

When they reached Kaikartek Hazir, their motorcycle collided with the auto-rickshaw, leaving the four, including Rimon, injured.
Locals took them to Bandar Upazila Health Complex. Rimon was later transferred to Dhaka Medical College Hospital where he died, said Bandar Police Station OC Abu Bakar.
In Panchagarh, a man was killed and two were injured in a collision between a covered-van and a three-wheeler in Tentulia upazila.
The accident happened on Panchagarh-Banglabandha highway at Mandulpara village, said

police.
Nur Islam, 32, driver of the three-wheeler from Boda upazila of the district, was declared dead at Panchagarh Sadar Hospital.
Tentulia Highway Police Station OC Zakir Hossain Mollah said the accident occurred around 2:00pm.
Three-wheeler passengers Ajit Chandra Roy, 40, and Debicharan Chandra Barman, 55, were taken to Rangpur Medical College Hospital as their condition deteriorated.
Police seized the covered-van but its driver and helper managed to flee.
A case was filed with Tentulia Police Station in this connection, the OC said.

A ‘missing’ building

These individuals have continued to make further installments for four consecutive terms.
Despite the lack of progress in the building's construction, the DSCC revenue department has continued to accept installments from the affected individuals.
Approximately Tk 19 crore has been collected in the fund, with some individuals paying in two installments and others in three.
During a recent visit to the site, it was found that only the basement roof had been completed. However, the abandoned site has now become an ideal mosquito breeding ground. Besides, the basement was being used as a garage for rickshaws and vans.
Omar Bin Abdal Aziz, son of late Awami League leader MA Aziz after whom the market was named, was given the responsibility of overseeing the property as a local councillor.
Contacted, he said, “I have asked a man to look after the place. He will be replaced once a newly-appointed construction firm resumes the construction work.”
WHY THE DELAY?
Sources at the DSCC engineering department said, The Builders Engineering Associates Limited, the contractor

company responsible for the construction of the building, had close ties with Jubo League leader GK Shamim, a top contractor of government projects.
Shamim was arrested during an anti-casino operation. After his arrest, the building construction came to a halt, they added.
It took two years to cancel the contractor's contract, appoint a magistrate to assess the completed work's cost, impose fines for breaching the agreement, and issue a new contract.
In April of last year, the authorities published a fresh advertisement to select new contractors.
DSCC Revenue Officer Md Anisur Rahman said the engineering department is responsible for the building's construction.
He said once the work is finished, it will be handed over to the property department, which will then allocate the shops to the designated individuals.
Wishing anonymity, the engineering department officials told The Daily Star that a new work order was given to a company after completing the tender procedures.
The Builders Engineering Associates Limited was fined for not completing the works in time, they said, adding that they are hopeful to resume the construction within the next month.

front of the building as none from the party were allowed to go inside.
The office is on the fifth floor of the building.
Witnesses said Nur, Rashed and their followers tried to enter the building yesterday afternoon, but police intercepted them.
Later, Nur held a press briefing before the building and said they want to use the office for the next six months as per the contract with the landlord.
Nur said they will relocate their office after

six months and vowed for legal actions if they are barred from entering their office.
Afterwards, the faction brought out a procession.
Contacted, Moshizuaman said as a landlord he does not want Nur to use the office as he didn't pay any rent. “The six-month contract is for the tenant, not for the defaulter who doesn't pay,” he said.
He said he filed the case after identifying the accused who stormed into the building from CCTV footage.

DENGUE OUTBREAK

DSCC distributes leaflets at mosques to raise awareness

In order to increase the awareness of prevention of dengue disease and control of Aedes mosquito, leaflets were distributed at the mosques under the Dhaka South City Corporation yesterday.
Besides, a discussion was held about what to do to prevent dengue, according to a press release.
The councillors of various wards of the corporation and the officials of the health department participated in this discussion and leaflet distribution programme, added the release.
The objective of this initiative is to educate the public about preventive measures against dengue and promote community engagement in combating the disease.
Earlier on July 13, Dhaka South City Corporation (DSCC) opened a central control room to check dengue disease and Aedes mosquito under its area. DSCC Mayor Barrister Sheikh Fazle Noor Taposh inaugurated the control room at Shitalakkhya Hall of the Nagar Bhavan.

Folk culture, ensuring that the government will trace the origin of such cultural activities.
“To use those commercially, one would need to take the government's permission and sign contracts with the origin communities about the usage conditions and tenure,” says the new act.
A part of the income, which will be settled by the contracts, will be spent in the cultural development of these communities.

the copyright office will be able to retain or cancel the orders of the registrar.
Barrister Aneek R Haque, advocate, Supreme Court, said there are a number of things that were not in the law before, which have been included.
For example, a separate chapter has been added to protect the rights of folk culture, and new clauses have been proposed to prevent piracy, he said.

The new act has incorporated the copyrights of ICT related products, activities, database, design by digital tools.
Using film scenes or sound recordings on any digital and social media platforms without permission will also be considered as copyright violation.
In the new law, dress designing, graphics, artistic images or any design using digital platforms have been included as an art form.
The copyright office will perform specific tasks including issuing copyright registration and certifying, licensing of translation, stopping import of illegal copies of any intellectual products, conservation of folk culture, advising the government about copyrights and providing incentives to the original artists.
Besides, the government will appoint additional copyright registrars. A clause has been incorporated in the act saying that the board f

However, the copyright board has been given new powers that they did not have before, he added.
Noted Bangladeshi filmmaker Gias Uddin Selim said, “If any person intentionally violates or helps to violate the copyright of a film, they can be punished now.”
Farid Ahmed, proprietor of Somoy Prokashon, said if any publisher violates any condition of the agreement signed with the creator of a literary work, a fine of Tk 5 lakh will be imposed.
However, in the case of publication, the penalty amount has become much higher, he added.
