

‘BNM didn’t fulfil reg criteria’

A lawyer yesterday raised objections to the Election Commission’s move to provide registration to Bangladesh Nationalist Movement (BNM), saying the party has failed to fulfill all the required criteria in this regard.

Advocate Abu Naser Khan said the EC didn’t verify all the information regarding the party. “The commission may face legal challenges if it registers a party with such errors and misleading methods. Such a move can be termed discriminatory to other political parties.”

The EC is set to register BNM and BSP (Bangladesh Supreme Party) as political parties. It issued a notification on July 17, saying that any individual or party can object to this decision till July 26.

HOUSING FOR JOURNOS HC stays hilly land allocation

The High Court yesterday stayed all the proceedings for allocating hill-class land at Jhilonza Mouza in Cox’s Bazar for the housing of journalists to protect the environment.

The court ordered the authorities concerned to immediately stop further cutting and damage of the hills. It also directed the officials concerned to prepare a report on the present status of 49.97 acres of hill-class land situated in BS Dag No 17070 of the Jhilonza Mouza.

The HC bench of Justice Bhishmadev Chakraborty and Justice Md Ali Reza came up with the directives following the petition filed by Bangladesh Environmental Lawyers Association.

have seen fewer people like Juno. His brilliance and bravery was extraordinary.”

Goutam Roy, a writer and researcher, said, “The example of sacrifice and bravery that the revolutionists of Chattogram set was unparalleled. But unfortunately, their expectation centering the movement was not fulfilled.”

The lecture started with reading out the autobiography of Juno.

Juno died from kidney diseases at a Dhaka hospital in October 2020.

He was imprisoned for his participation in the 1962 Education Movement, and was one of the key organisers of the 1969 mass uprising.

He was in the central body of the Co-ordination Committee of Communist Revolutionaries of East Bengal, the pro-Peking party, which was one of the communist organisations waging guerrilla warfare against the Pakistan armed forces in the 1971 Liberation War.

In Shibpur of Narsingdi, a district in eastern Bangladesh, Juno and his comrades organised their guerrilla base, and confronted the Pakistan army.

He participate in at least five frontal military actions, in all of which the Pakistani forces had to retreat.

During the nine months of the Liberation War, Shibpur stood liberated as the Pakistan forces could not manage to enter the area. He was the second-in-command of the guerrilla force.

The victim’s elder brother Ataur Rahman Khan Milon said how could a man drown in a pond when he knew how to swim.

Terming the death mysterious, Zillur Rahman, president of the district AL, said Badal had no political rivalry with anyone.

On Monday, Hasina will address the opening ceremony of the summit as a special guest. UN Secretary-General Antonio Guterres, among others, is expected to speak at the event, said officials accompanying her.

During her stay in Italy, she will also hold a bilateral meeting with her Italian counterpart Giorgia Meloni on Tuesday.

She will then attend a plenary session on food systems and climate action at FAO headquarters, hold talks separately with FAO Director General Qu Dongyu and President of International Fund of Agricultural Development (IFAD) Alvaro Lario.

Hasina will also join the inauguration ceremony of the Bangladesh-Bangabandhu Sheikh Mujib Room at the FAO headquarters and attend a reception to be hosted by the FAO Director General on the same day.

Two memorandums of understanding on “cooperation in the field of energy” and “cultural exchange programme” are expected to be signed between the two countries during her visit.

Besides, Hasina will join a regional envoy conference, which will be held with participation of 15 Bangladeshi envoys stationed in Europe, and a community event on July 25. The premier is expected to leave Rome for home on Wednesday.

society, they find themselves caught in this distressing cycle, they added.

Contacted, Tejgaon Police Station Officer-in-Charge Apurba Hasan said, “Law enforcement authorities occasionally raid the footbridge, dispersing the hawkers and children alike. However, the absence of a nurturing environment and the lack of alternatives leave these children with no choice but to return to the only semblance of a community they have ever known.”

Besides, after sunset, the Tejuri Para footbridge becomes a space where sex workers gather, waiting in queues for potential clients. These realities highlight the intersection of poverty, limited opportunities, and social vulnerabilities that many individuals in marginalised house holds face, while also shedding light on how unsafe footover bridges can be at night, said locals.

Take the case of one Aminul Islam, who works in a private firm in Tejgaon industrial area. Every working day, he passes the Tejuri Para foot over bridge.

“I leave my office after 7:00pm and go to my home in West Rajabazar crossing this overbridge. I cross the bridge as soon as possible, as the place is mostly occupied by drug addicts. I was even mugged here once,” he said.

Safiya Alam, a student of Tejgaon Girls College, said, “It’s a safe haven for stalkers. Every day when I cross the bridge, there are always people throwing bad words at me.”

The footbridge falls under Dhaka North City

Corporation’s jurisdiction.

“We have been trying to improve the environment of the bridge and the nearby area. Regular drives and mobile courts are conducted, and encroachers are often driven away. However, they return as soon as we leave the spot, as they also have no other option but to live and do business here,” said Selim Reza, the chief executive officer of Dhaka North City Corporation.

Contacted, Urban planner Adil Muhammad Khan told The Daily Star, “Most of the foot over bridges were not constructed in a convenient place for people. The stairs are small and dangerous, due to which people are not using them. That’s a major reason as to why these footbridges have become a den of addicts.”

“Besides, due to lack of active mechanisms for rehabilitating street children, they end up being addicts and getting engaged in crimes.”

Dr Sifat E Sayeed, a child mental health specialist and assistant professor at Bangabandhu Sheikh Mujib Medical University, said the widespread availability and affordability of the drug make it easily accessible to street children, enabling them to easily obtain and share it amongst themselves.

“It serves as a gateway to more severe drugs,” she added.

Dr Sifat said the drug (dandy) poses a dual threat to human body, causing two distinct forms of damage. “Firstly, it leads to inflammation or wounds on the nasal tract lining, and secondly, it contains carcinogenic elements, making it highly harmful to health.”

The result of the 41st BCS preliminary test was published in August 2021 with 21,056 candidates passing the exam. The written tests were held at Dhaka, Chattogram, Rajshahi, Khulna, Barishal, Sylhet, Rangpur and Mymensingh centres simultaneously from 29 November to 7 December in 2021.

The results were published on November 10 next year and 13,000 applicants passed the examinations. Meanwhile, the viva was held between March 5 till June 13 of this year.

In his complaint, Azad mentioned that he was in a relationship with Ruby before she got married to Rayat.

She had some photographs with Azad and tried to blackmail him with those. The couple filed several general diaries against Azad with different police stations for that purpose, but withdrew those after settling the issues out of court, according to the case statement.

On July 10, Ruby informed the complainant that her mother-in-law

suffered a stroke and she wanted help from him.

Azad then met Rayat at a restaurant at Moghbazar at 9:30pm on that day. But SI Zahid picked him up and took him to Hatirjheel Police Station, the statement added.

The SI then contacted Azad’s relatives over phone and demanded Tk 3 lakh for his release, failing which Azad would be implicated in a murder case.

One of the relatives went to the police station where Zahid forced him to give Tk 1 lakh as extortion, the case statement said.

mentioned, Mojibur Rahman, who has been teaching at Ganga Dhardi High School in Faridpur for the last 26 years.

“I have to spend over Tk 30,000 to run my family, which include the academic expenses of my three children. I had to take up farming as a secondary means of earning to suffice my family’s needs,” he added.

Asked about the impact of suspended classes on the students, Mojibur Rahman, a protesting teacher, said, “I know this is harming my students. But this is also important for us. I hope they will understand our situation. We are left with no choice but to protest.”

The teachers’ skills, infrastructures, and education quality are not the same across all schools. It is important to determine that the state has the financial capacity and the schools






have the aforementioned resources, said Rasheda K Choudhury, executive director of Campaign for Popular Education.

“Nationalisation of secondary education is necessary but the country is not ready for it yet. The process would have been easier had the authorities addressed the issue earlier,” she added.

The teachers, during a meeting with a former cabinet secretary, expressed their urge to meet the prime minister, said Sheikh Kawsar Ahmed, general secretary of Bangladesh Teachers’ Association.

Dipu Moni, in a meeting on Monday, said nationalising private educational institutions before the upcoming parliamentary elections would not be possible.

She, however, declared two committees to look into the issue.


