DNCC to spend Tk 122 crore for mosquito control

Announces budget for FY 23-24

The Dhaka North City Corporation has announced its annual budget for the financial year 2023-24, with a primary focus on addressing the mosquito menace, allocating Tk 121.84 crore for this purpose, which constitutes 2.32 percent of the total budget.

In the previous fiscal year, DNCC allocated Tk 111 crore on mosquito control. However, according to the revised budget, the expenditure on this sector was reduced to Tk 74.84 crore.

This year's allocation is significantly higher, approximately 1.5 times more than the expenditure in the last year's revised budget.

The current budget allocates Tk 84.50 crore for mosquito control activities, including Tk 45 crore for the purchase of mosquito repellents and Tk 30 crore for outsourcing mosquito control measures.

Additionally, Tk 30 crore has been allocated for the procurement of necessary equipment to carry out mosquito control activities. Furthermore, Tk 7.34 crore has been set aside for dengue prevention, cleanliness activities, and campaigns.

Mayor Md Atiquel Islam announced the Tk 5,269.45 crore budget for the fiscal year 2023-24 during a press conference at the DNCC hall room yesterday afternoon.

The previous year's revised budget was Tk 2,950.98 crore.

Experts emphasised the importance of consistent

HC slams two cops for arresting student on bail

The High Court yesterday rebuked two police officers of Patuakhali for arresting a college student, Ashraful Hawlader, in a case although he was on bail.

"You have arrested him [the college student] though he was on bail. You did not abide by this court's order. You disconnected the phone calls [made by his lawyer] over this issue saying that you were in a meeting. Even after the meeting you did not take any step," said the HC.

"Are you the owners of the state? You have responsibility to protect the dignity of the court," the HC bench of Justice Mustafa Zaman Islam and Justice Md Aminul Islam told Patuakhali Police Station Officer-in-Charge Md Moniruzzaman and its

9TH WAGE BOARD FOR JOURNOS SC to hear state's plea Aug 28

The Supreme Court yesterday fixed August 28 for hearing a leave to appeal petition filed by the state challenging the High Court verdict declaring the cabinet committee's recommendations in the 9th Wage Board illegal.

In the 12 Chapter of the 9th Wage Board, the cabinet committee recommended that journalists and employees of newspapers and news agencies themselves will pay their income taxes, they will get only one gratuity in a year, and the decisions of the 9th wage board might be implemented in phases.

Yesterday, Justice M Enayetur Rahim, chamber judge of the Appellate Division of the SC, sent the state's petition to its full bench and fixed August 28 for hearing.

Following a petition filed by Md Mabubuzzaman, the then secretary of Bangladesh Sangbad Sangstha Employees Union, the HC on November 6 last year delivered the verdict.

The state filed the petition recently seeking a stay on the HC verdict.

REG OF 2 PARTIES AB Party protests EC decision

They said this while protesting the decision of not providing registration to the AB Party through a letter to EC secretary. The letter was signed by AB Party convener AFM Solaiman Chowdhury.

The EC is set to register Bangladesh Nationalist Movement and Bangladesh Supreme Party as political parties. It issued a notification on July 17, saying anyone can object to this decision till July 26.

"I want to get my son's passport done, and for that I need his birth certificate. But I was told by the corporation that the birth registration process is on hold for the time being on the orders of the mayor. No one knows when the services will resume," she said.

Mehedi Hasan, a resident of Armanitola, said, "I need a birth certificate for my daughter's

school admission, but I didn't get it. As I went to the city corporation's office, they said due to server problems at the Birth and Death Registration office, they won't give me the certificate."

Birth certificates have been made mandatory for 19 citizens' services, including admission to educational institutions, issuance of passports and national identity cards, and visa applications.

However, Dhaka North City Corporation is registering and providing birth and death certificates as before.

Contacted, Office of the Registrar of Birth and Death officials denied having problems with the server.

"There is only one server for the entire country. If the birth registration process is normal throughout the country, why will there be a problem in areas that are under DSCC's jurisdiction? The server is perfectly fine," Registrar General Rashedul Hasan told this newspaper yesterday.

"We don't receive any fees. The entire fees for the birth and

Jama'atul Ansar now under control

Rab says after arresting outfit's another top leader

With the arrest of the ameer of militant outfit Jama'atul Ansar Fil Hindal Sharqiya yesterday and arrest of its many top leaders and operatives earlier, the group has lost much of its strength, said officials of Rab and CTTC.

The law enforcers had previously identified the group as a serious security threat due to its combat training, operational tactics, and activities.

Members of the elite force arrested ameer of Jama'atul Ansar Rahman alias Mahmud, 32, raiding his rented house in Louhajong of Munshiganj around 3:00am.

Anisur's two associates Kazi Soraj Uddin alias Siraj, 34, and Mahfuzur Rahman Bijoy, were also arrested during the drive along with firearms, ammunition, bomb-making materials, radical contents, and cash.

In addition to his connections with Ansar al Islam leaders, Mahmud met with top militant Maj (sacked) Zia on multiple occasions and received Tk 15 lakh from Ansar al Islam. Both groups also signed an agreement, with Ansar al Islam providing IT and security training to Jama'atul Ansar members while receiving combat training in return.

Earlier on June 23, the Counter Terrorism and Transnational Crime

'They're doing this to put pressure on us'

Say protesting teachers after DSHE asks for list of absent teachers

The Directorate of Secondary and Higher Education (DSHE) asked for a list of head teachers, assistant head teachers and assistant teachers who remained absent from their educational institutions on Sunday without permission from the authorities concerned.

DSHE Dhaka office asked the district education officials to submit the list by yesterday, said a letter signed by its acting deputy director ASM Abdul Halek on Sunday.

The decision was taken at a time when hundreds of teachers across the country have been holding a sit-in programme in front of Jatiya Press Club since July 11 to press home their demand for the nationalisation of secondary education.

"The DSHE took such a decision to create a pressure on the protesting teachers and suppress the movement," said Sheikh Kawsar Ahmed, general secretary of Bangladesh Teachers Association.

He termed the government decision a "threat" for the protesting teachers. "But we won't leave the road, until our demand is met," Sheikh Kawsar Ahmed said.

Speeding bus kills siblings

Two siblings were killed after a bus ran them over on the Dhaka-Mawa Expressway at Purba Hasamdia area in Faridpur's Banga upazila yesterday afternoon.

Md Hamim, 11, and his elder brother Mahfuzur Rahman, 29, were from Natun Dorbeshpur village in Meherpur Sadar upazila.

Witnesses said the brothers were waiting for a Dhaka-bound bus on the expressway. As a bus of Elish Paribahan was approaching around 2:30pm, Mahfuz and his brother signalled it to stop, but the speeding bus ran them over.

Jewel Sheikh, sub-inspector of Banga Highway Police Station, said, "Hamim died on the spot while Mahfuzur Rahman was declared dead at upazila health complex."

RAMPURA-DEMRA EXPRESSWAY

AIIB approves \$75m loan

The Asian Infrastructure Investment Bank (AIIB) has approved a loan of \$75 million for the Rampura-Amulia Demra Expressway project.

According to a statement published on AIIB website yesterday, the multilateral development bank approved the loan on July 20.

The project is developed through a Public Private Partnership (PPP) structure.

The PPP contract was signed between the Roads and Highways Department and China Communications Construction Company Limited and China Road and Bridge Corporation in January last year.

The estimated total cost of the project is \$261 million, as per AIIB document.

The scope of the project is to design, build and operate a 12.5km four-lane access-controlled highway, including an 8.15km elevated section and a 4.35km at-grade section, by upgrading an existing two-lane undivided carriageway, the document shows.
