# Bangladesh-Bangabandhu Room opened at FAO HQ

UNB, Rome

The Bangladesh-Bangabandhu Sheikh Mujib Room was inaugurated on Monday at the headquarters of Food and Agriculture Organization (FAO) in Rome.

Prime Minister Sheikh Hasina, who is now in Rome to attend the UN Food Systems Summit+2 Stocktaking Moment (UNFSS+2), inaugurated the room. FAO Director-General QU Dongyu was present at the event.

The establishment of the room marks the celebration of the 100th birth anniversary of Bangabandhu.

The prime minister said that her country is delighted to have a little piece of Bangladesh inside the FAO Headquarters.

She said Bangladesh became a member of FAO in 1973 under the guidance of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

This room also stands for the 50 years of excellent partnership between Bangladesh and FAO, she added.

The newly furnished room shows an image of Bangabandhu, depicted in a paddy field by one of Bangladesh's farmers. This artistic work was done during the "Mujib Year" -- Bangabandhu's birth centenary observed in 2020-21.

# Italian PM for legal migration of workers

Italian Prime Minister Giorgia Meloni yesterday stressed the need for migration of Bangladeshi workers in legal ways.

She said this at a bilateral meeting with Bangladesh Prime Minister Sheikh Hasina.

"Bangladeshi workers are doing very well here. They have enough credibility. I don't want illegal workers," she was quoted as saying by Foreign Minister AK Abdul Momen.

On her arrival at Palazzo Chigi, the Italian PM's office, Hasina was received by Meloni.

Issues including undocumented Bangladeshi expatriates, bilateral trade and business came up during the discussion.

The Italian side said they don't want illegal Bangladeshis to stay there as locals don't want it. "They opened the door for Bangladesh to send manpower in legal

ways," said Momen.

Hasina said both documented and undocumented Bangladeshis are working for the welfare of the two countries. But, she said, Bangladesh discourages illegal migration.

Noting that her government is developing 100 economic zones and 39 hi-tech parks in Bangladesh, Hasina asked Italy to invest there.

# Operation resumes Aug 1, but won't be smooth before 2026

Although rail services between Dhaka and Narayanganj will resume on August 1 after eight months of suspension for construction works, it would take three more years to have smooth and enhanced rail service on this route.

Unilateral cancellation of contract by a Chinese contractor midway of work and changes in work scope eight years after the initiation of the project will cause the long delay to have double line facilities on this route, officials said.

The cost of Dhaka-Narayanganj Double Lining project has already risen to Tk 658.34 crore from Tk 378.65 crore and the deadline got extended to June 2026 from June 2017, they said.

Before suspension of services, railway used to operate nine pairs of trains -- eight pairs of local and one of Demu -- between Dhaka and Narayanganj daily and several thousand people avail themselves of the services.

Passengers could reach Narayanganj from Dhaka within 45 minutes at a fare of Tk 15. On the other hand, it takes almost an hour to reach Narayanganj by bus at Tk 55 fare.

# Pregnant women more vulnerable

Two expecting mothers die at city hospitals

As a deadly dengue outbreak tightens its grip across the country, an escalating number of lives are being claimed each day.

Meanwhile, there lies a group at an even greater risk -- pregnant women.

These expectant mothers face an alarming vulnerability, as the disease threatens not only their lives but also

the lives of their unborn children.

Yesterday, two pregnant government officials fell victim to the dengue outbreak in Dhaka. SM Nazia Sultana, a senior assistant secretary of the commerce ministry, and Kanta Biswas, an assistant director of the Public Account Department of Bangladesh Bank, both passed away while undergoing treatment at separate city hospitals, confirmed family members and colleagues.

Both women were eight months

Nazia got into public service following the 30th BCS while Kanta was appointed in the Bangladesh Bank as an assistant director in 2019.

#### YUNUS CASE SC issues status quo on proceedings

The Supreme Court yesterday issued status quo till August 3 on the proceedings of a case filed against Nobel Laureate Muhammad Yunus and three other top officials of Grameen Telecom on charge of labour law violation

Justice M Enayetur Rahim, chamber judge of the Appellate Division of the SC, passed the order following a petition filed by the state seeking stay on a High Court rule that questioned the labour court order framing charges against Yunus and three others.

The apex court chamber judge also sent the state's petition to its full bench for hearing.

Yunus is the chairman of Grameen Telecom while the other accused Ashraful Hasan is the managing director and Nur Jahan Begum and Mohammad Shahjahan are directors.

On September 9 of 2021, SM Arifuzzaman, a labour inspector (general), filed the case. The labour court on October 12, 2021 granted bail to Yunus and other accused in the case.

### school feeding Bangladesh inks deal with WFP

Bangladesh has signed an agreement with the World Food Programme (WFP) for expanding and improving school feeding programme for the country's primary school students.

The agreement was inked at an event attended by Foreign Minister AK Abdul Momen.

Bangladesh government introduced a school feeding programme in 2010 and now some 23 lakh students of 15,000 primary schools in 104 upazilas are getting free meals.

Under the new agreement, the programme will be expanded to more than 150 upazilas, raising the number of beneficiaries to 37 lakh students.

Thanks to the programme, the dropout rate has declined by 7.5 percent and the enrolment rate increased by 14 percent in the primary schools, said Momen.

Moreover, Bangladesh has become the 85th member of the School Meals Coalition at an event on Monday.

#### Submit list of railway land grabbers in 30 days: HC

The High Court yesterday sought a list of people who have illegally grabbed lands of Bangladesh Railway across the country.

The court ordered the authorities concerned of the government to prepare the list and to submit it in 30 days.

At the same time, it issued a rule asking the authorities to explain in two weeks why their inaction to free the lands from illegal occupation should not be declared illegal and they should not be ordered to evict the occupiers.
