BNP moves rally to Friday, so does AL

Daylong drama over police permission, venue

STAR REPORT

After much drama and uncertainty, police yesterday denied the BNP permission for holding a rally today, and the opposition party responded by rescheduling its gathering for tomorrow at Nayapaltan or Suhrawardy Udyan.

The Dhaka Metropolitan Police did not give the BNP permission, saying a rally on working day would cause immense sufferings to people.

At a press conference late last night, BNP Secretary General Mirza Fakhrul Islam Alamgir said people will see hindrance to any democratic activity as an attempt to obstruct democracy and fair polls.

"We are urging the authorities concerned [to extend support] to make the grand rally a success."

Also last night, the party informed the DMP about the change of date.

Signed by its Senior Secretary General Ruhul Kabir Rizvi, the letter to the DMP said the grand rally would be held tomorrow at 2:00pm either at the Suhrawardy Udyan or

at Nayapaltan.

Dhaka police also refused the Awami League's associate and front organisations permission for their rally at the south gate of Baitul Mukarram citing the same reasons given to the BNP.

The Dhaka University unit of Chhatra League then sought permission from the university authorities for a rally either at the Gymnasium Ground or in the Central Shaheed Minar area.

Three associate bodies of the AL -- Jubo League, Swechchhasebak League, and Chhatra League -- eventually rescheduled their rally for tomorrow. They will hold the rally at the trade fair ground next to the Bangabandhu International Conference Center in Agargaon around 3:00pm.

Gazi Mejbaul Hossain Sacchu, acting president of Swechchhasebak League, told The Daily Star yesterday, "A fair was held on that ground a few days ago and there are many holes there. The rally has to be delayed by a day as the trade fair ground is not ready yet."

Allegations of bribery rife against cops

Locals speak up after girl 'took own life' during police raid

Around a week ago, Sub-Inspector Anwarul Islam and Assistant Sub-Inspector Haridas Roy of the capital's Pallabi Police Station arrested a man in Adarsha Nagar on charges of selling cannabis.

They then demanded Tk 2 lakh for his release and threatened that if he failed to pay the bribe, a case would be filed against him on charges of heroin possession.

Speaking to The Daily Star, the arrestee's wife, on the condition of anonymity, said, "I immediately took a Tk 50,000 loan from a local lender with high interest, gave it to the police officers and they eventually filed a case against my husband accusing him of possessing 200gm of cannabis."

She said she was forced to pay the bribe as it takes around a year to secure bail in cases filed over heroin

Like her, around half a dozen locals of Adarsha Nagar have brought up such allegations against SIs Anwarul Islam and Zahiruddin, ASIs Haridas Roy, Abul Kalam Azad and Ferdous Rahman of Pallabi police.

Three workers of the nearby Kalshi graveyard claimed there were many families running small drug businesses in Adarsha Nagar.

Exports to China fall

Bangladesh's export to China fell to a threeyear low of \$677 million in the last fiscal year as entrepreneurs could not take advantage of the duty benefits extended by Beijing.

If the earnings generated in 2019-20, when the Covid-19 pandemic wreaked havoc around the world, are excluded, the receipts in 2022-23 would be the lowest in a decade, data from the Export Promotion Bureau showed.

A limited number of products in the export basket and a lack of intermediate goods and technology products are standing in the way of increasing exports to the world's secondlargest economy, which offers duty-free entry to 98 per cent of the items listed in its tariff schedule.

JOINT STATEMENT ON HERO ALOM

It's a 'violation' of diplomatic norms

Shahriar tells heads of 13 foreign missions

The government yesterday said the joint statement by 13 foreign missions condemning the attack on Hero Alom was a "violation" of diplomatic norms, and urged the missions to refrain from "nondiplomatic" behaviour in the future.

After a meeting with the heads of the 13 missions, State Minister for Foreign Affairs Shahriar Alam told reporters that he reminded the envoys about the Vienna.

that he reminded the envoys about the Vienna Convention on Diplomatic Relations and that "behaviour ignoring objectivity, impartiality and non-biasness will only create a crisis of mutual trust".

"We called the ambassadors who issued a joint statement to the media in violation of diplomatic norms. We have expressed our displeasure about their behaviour beyond diplomatic etiquette," he told a press briefing at the Foreign Service Academy.

He held the press meet after a briefing with the ambassadors and high commissioners or their repressiveness of the 13 foreign missions at the State Guest House Padma in Dhaka in the afternoon



Shahriar said they did not summon the missions; rather, they invited them to discuss the matter. He, however, said the ministry had indeed summoned UN Resident Coordinator Sheldon Yett in connection with a Twitter post expressing concerns over the attack on Hero Alom, whose

original name is Ashraful Alom. The 13 missions that were invited are the US, the UK, Canada, Denmark, France, Germany, Italy, the Netherlands, Norway, Spain, Sweden, Switzerland and the European Union.

In the joint statement on July 19, they called upon the government to conduct a full investigation and take legal steps against the perpetrators of the attack on Alom.

"Violence has no place in the democratic process. We call for a full investigation and accountability for the perpetrators. Everyone involved in the upcoming elections should ensure that they are free, fair, and peaceful," the statement read.

Shahriar termed the attack on Hero Alom, an independent candidate in Dhaka-17 bypolls, an "isolated" incident.

Intelligence report behind police refusal

It hinted BNP might have been planning a sit-in

Dhaka Metropolitan Police's decision to deny BNP permission to hold its grand rally at either of its desired venues is grounded on an intelligence report which hints that the BNP has a plan to go for a long sit-in to bring the city to a standstill

According to the report, messages have been sent to BNP's grassroots leaders, specifically those at the district level, to bring old bedsheets and cloths with them while travelling to the capital.

Highly placed sources confirmed these findings of the intelligence report to The Daily Star yesterday.

The report also mentions that BNP's grassroots activists were asked to remain on the streets irrespective of whatever action law enforcers took.

After consulting the report, the DMP suggested the BNP hold its grand rally at the Golapbagh ground, taking into consideration the location of the ground

EU special envoy sits with labour unions, rights activists

Minimum wage of Tk 23,000 in RMG sector discussed

Labour unions and rights activists yesterday held a meeting with European Union's Special Representative for Human Rights Eamon Gilmore in the capital and raised their demand for a minimum wage of Tk 23,000 in the ready-made garments sector.

The RMG minimum wage has been Tk 8,000 since 2018.

Currently, negotiations are going on as a board formed by the government is

reviewing the current minimum wage.

Meeting sources said the labour representatives told Gilmore to pressurise buyers into giving fair prices to factories so that workers are not paid poverty wages.

They also mentioned the murder of Shahidul Islam, a union organiser from the Bangladesh Garment and Industrial

Workers Federation in Gazipur.
On June 25, Shahidul was attacked by cadres outside the compound of Prince Jacquard Sweater Limited's owner in Gazipur's Sataish Baganbari area, when he was negotiating the factory workers'

BANK DIRECTORS FROM SAME FAMILY BB orders bringing down number to 3

STAFF CORRESPONDENT

The central bank yesterday instructed banks to bring down the number of directors from a single family to three in line with the Bank Company (Amendment) Act 2023 within the shortest possible time.

A maximum of four members from a family were allowed to sit on the board of a bank concurrently as per an amendment of the Bank Company Act 1991 that was made in 2018.

But the new act, which was passed in parliament on June 21, specified that the number of directors from a single family cannot be more than three. The concerned directors should reach

a mutual understanding if one of them has to resign from the board to comply with the law, said the central bank in a notice yesterday.

If they fail to reach any consensus, a

lottery has to be held at a board meeting to pick the director who would have to step down, it said.

Yesterday's notice came two days after the BB advised banks to place the new

law at the next board meeting.

BNP wants to destabilise the country PM tells expatriates in Rome

UNB, Rome

Prime Minister Sheikh Hasina has alleged that the BNP doesn't want election, rather it seeks to create an unstable situation in the country. "The election will definitely be

held as per the constitution. The BNP knows that people will not vote for them. Why would the people vote for those who were driven out [of power] due to vote-rigging?" she said.

Hasina was addressing community event at her place of residence in Rome on Tuesday. She had been in Rome to attend the UN food summit.

The PM questioned how the BNP can seek votes after "killing people through arson".

"They don't want election. They lick the boots of some of their foreign lords and they want to make the people of the country suffer by them [the foreign lords]. They want to hamper the trend of development of the country and its people.'

Stressing that the Awami League will have to come to power to build the country as Smart Bangladesh, Hasina sought votes for "boat", the AL's electoral symbol, again in the next general election.

Referring to the US sanctions on Rab officials and its visa policy, the PM said, "Sanction has been imposed on those who have curbed terrorism and militancy. We can't understand

"Those who did not support our Liberation War now want to play with our country in different ways. They can't be allowed to play. The people of the country will have to remain united," she added.

Hasina asked the expatriate Bangladeshis to send remittance home through legal channels, and look for foreign partners to invest in Bangladesh.

The PM also urged them to abide by the laws of their host countries. She discouraged the overseas jobseekers from migrating to foreign countries through illegal channels.

El Nino weather pattern set to heat up temperatures

Southeast Asia prepares for haze crisis

Southeast Asian nations are gearing up to tackle the threat of a tougher-than-usual "haze" season together, as the El Nino climate phenomenon raises the risk of soaring temperatures.

Ministers and officials from the Association of Southeast Asian Nations (ASEAN) met in Singapore last month, where they vowed to ramp up monitoring of wildfires and efforts to prevent air pollution, and finalise a new plan to boost cooperation.

During the dry season in Indonesia usually starting in August - slash-andburn clearance of forest and peatland to expand palm oil, farming and pulp and paper production covers much of Southeast Asia in a choking haze for months most years.

Yet environmentalists are concerned that this haze season could be the worst in years, after the World Meteorological Organization warned that temperatures are expected to surge across large parts of the world following the emergence of El Nino in the tropical Pacific for the first time since 2016.

After a few haze-free years - due to the Covid-19 pandemic and wet weather - a new regional roadmap to address the issue will prove vital ahead of the upcoming season, Varkkey said.

"It's important to focus on data standardisation, sharing and use - (of) air quality indexes, hotspot data - to support cross-border coordination," she added.

With the prospect of prolonged hot and dry weather raising the risk of widespread haze and air pollution if the burning of forests and peatland is uncontrolled, ASEAN is seeking to avoid a repeat of recent haze crises like those in 2019 and

In 2015, between June and October, about 2.6 million hectares (6.4 million acres) of land burned in Indonesia, mainly on Sumatra and Borneo islands, according to a 2016 World Bank report. The fires cost the country about USD16 billion, it found.

A Harvard University study linked "The prediction is that we are due for the 2015 haze to more than 100,000 premature deaths in Indonesia, Malaysia

previous haze Southeast Asian nations often failed to work together, experts said, with governments publicly blaming each other and taking little cross-border action, while any ASEAN policies were seen as too weak to make a real impact.

Mushtaq Memon, coordinator of chemicals and pollution action for Asia-Pacific at the United Nations Environment Programme (UNEP), said the ASEAN hazefree roadmap will likely be adopted in August and set out a strategy for the rest of the decade.

It will improve implementation and science-based targets, beef up local action and empower communities, and include a new sub-regional strategy, he said, without giving further details.

"Strengthening institutions coordination with ASEAN member states and other institutions is a must," Memon

"At the national level, monitoring the onset of forest fires, open burning or peatland fires is critical, as well as ensuring immediate, on-the-ground actions to prevent spreading of these fires," he added.

When Indonesia faced regional pressure during the 2015 haze crisis, its locus changed from containing fires to prevention.

IU students suspended sans due procedure: HC

The High Court vesterday observed that due procedure was not followed in suspending five students from Islamic University for torturing a female student at a dormitory in February.

The vice-chancellor of Islamic University, Kushtia, is supposed to take the decision about punishing its students for any offence under the relevant provision of the Students Code of Conduct, 1987. The discipline committee of the university will examine the VC's decision and if the committee is not satisfied with the VC's decision, then the committee itself will hand out

But the discipline committee has suspended the five students without the decision of the VC which is violation of the relevant procedure, the HC bench of Justice JBM Hassan and Justice Razik-Al-Jalil said during hearing of a writ petition relating to this issue.

The bench cancelled the suspension order and ordered the university authorities to take action against the five students maintaining due procedures and to submit a report after complying with the order to this court by

College student found dead

Police yesterday recovered the body of a college student near the outer signal area of Bhanugach Road in Sreemangal.

The deceased was identified as Shanta Debnath, an eleventh-grader at Moulvibazar Government College. He is the son of Nikhil Debnath of Rajnagar village.

Police found the body on the rail tracks. Shanta's both hands were found severed, said Rakibul Islam, sub-inspector of Sreemangal Railway Police Station.

He said the cause of death will be determined after an autopsy. The body was sent to Moulvibazar Sadar Hospital morgue for an autopsy.

Two get death penalty for killing a man

A Joypurhat court yesterday sentenced two men to death for killing a man over previous enmity in

The two are Kafi Uddin and Sadiqul Islam of Altafnagar village under Dupchanchia upazila of Bogura. The court also fined them Tk 10,000

Abbas Uddin, judge of Additional District and Session Judge's Court-2, delivered the verdict in presence of the accused.

Nripendranath Mondal, public prosecutor of the court, said Kafi and Sadiqul killed Sabuj Ali on August 1, 2008. Later, police recovered his body from Khanjanpur area of Joypurhat municipality area next day.

BB orders bringing down

Around noon yesterday, DMP Commissioner Khandker Golam Faruq said, "I will ask all political parties to hold rallies without causing sufferings to the people. Maybe a time will come when people will be fed up and we may be forced to ban these programmes.'

A few hours later, the DMP said that the BNP would not be allowed to hold he rally at Nayapaltan or at Suhrawardy Jdyan on Thursday.

Faruq said that they offered the BNP the Golapbagh ground and would grant permission if the party was interested.

At least 95 BNP men were arrested from Dhaka and Narayanganj yesterday. Of them, 86 were detained between Tuesday night and yesterday and have been sent to jail yesterday, said court

At least 21 were shown arrested under Section-54 of the Code of Criminal Procedure, under which cops can arrest anyone without a warrant. The rest of the detainees were held

under various cases filed with police stations in the capital, sources said.

Charges of involvement in vandalism, arson attacks, and obstructing police were brought against 65 arrestees, they said.

The Daily Star learnt some details on the arrests of some BNP men in the

capital. Pallabi police stopped Ariful Islam, youth affair secretary of Bogura's Sherpur upazila unit BNP, and three local Jubo Dal activists as they arrived in Dhaka's Mirpur in a car around 3:30am

Police went through their phones and after being sure of their political identity implicated them in a case filed with Pallabi Police Station in Dhaka on September 18 last year.

"Police implicated them in a ghost case to harass them. They were not in Dhaka when the case was filed last year. Their only crime is they are involved in the BNP," said Imtiyar Parvez Setu, Arif's

Talking to The Daily Star at a Dhaka court, Moushumi Islam Khan said a team of Kadamtoli police picked up her husband Monirul Islam, joint convener of Cumilla City North Unit Jubo Dal from their Jurain home around 2:00am

"My husband, a kidney patient, has been suffering from dengue for the last couple of days. I showed police the medical reports but they told us that they have been ordered to arrest him," she told The Daily Star.

During a visit to the house vesterday, correspondent found family members, relatives and neighbours grieving. They expressed anger towards the police for provoking Baishakhi's death by suicide and demanded justice.

Her mother Lovely Begum said that on Friday a police team, led by SI Anwar, went to their home and told them to pay Tk 50,000. They threatened to implicate the family in a case if they failed to do so. The next day, another police team went

there and took Tk 10,000 from them. Contacted, SIs Anwarul, Zahir, ASI Haripada denied the allegations, terming them "baseless"

Anwar claimed he, SI Mahmudul and ASIs Haripada and Abul Kalam went to the house following a tip-off regarding narcotics possession but did not find any drugs in the house.

The allegations [against me] are baseless. As a girl died by suicide, they are bringing allegations against police. They [the locals' claims] have no merit. They never said anything before."

On Monday night, a separate team, led by SI Zahir and ASI Ferdous, raided the house and demanded Tk 5 lakh.

"They claimed we run a drug business here. But they did not find any drugs," Lovely said, adding that police threatened to take her away when she refused to pay the money.

However, SI Zahir denied the bribery

allegations and said he recovered some drugs from her room.

He sent a video of the raid to this correspondent. In it, Lovely's daughter Chandni was heard saving that a small amount of drugs were recovered. She was also heard begging for her mother's release.

Unlocking the diaspora potential

Expatriates' welfare ministry, IOM hold validation workshop on national policy

The government is going to formulate a policy with the broad objective to include Bangladeshi diaspora community in the country's "march towards development" and ensure their wellbeing.
As per the draft "Bangladesh National

Bangladeshi Diaspora Policy-2023", are those "Bangladeshi individuals who obtain citizenship of another country or their citizenship status is under process or are permanently living in another country or were born as Bangladeshi-origin or grew up in another

The draft policy categorises Bangladeshi diaspora in two groups -- "Non-Resident Bangladeshi" and "people of Bangladeshi origin", representing two generations the "first-generation diaspora" and "nextgeneration diaspora".

The draft policy was discussed yesterday during a validation workshop organised by the expatriates' welfare ministry at a city

According to a 2021 study of the International Organisation for Migration (IOM), there could be an estimated 2.4

million Bangladeshi diaspora with the United Kingdom and the United States of America -- two key host countries.

Expatriates' Welfare Minister Imran Ahmad said the aim behind the policy is "very high" and that is to get the Bangladeshis living abroad involved in the country's development.

To attract the diaspora community for investing in Bangladesh, strategic partnership will be developed through establishing a tripartite network among relevant government bodies, private sector and diaspora trade organisations.

"This is the big scene," he said, addressing the workshop as chief guest.

He said the draft policy will go through changes and it will be discussed with the relevant ministries, NRBs, NGOs, media and other stakeholders.

Protect farmers to ensure food security Speakers tell conference

Eco-friendly agricultural practices and safeguarding the rights of marginalised farmers are essential to ensure secure and sufficient food supply, stressed speakers at a conference vesterday.

They made the remarks at "Asia-Pacific Conference on the Right to Food and Agri-Food System Conference 2023", a two-day event organised by Right to Food Bangladesh in collaboration with their national and international networks at Dhaka University's Senate Bhaban.

Present as chief guest, Speaker Dr Shirin Sharmin Chaudhury said population growth, urbanisation and food scarcity are major challenges in ensuring food for all. Along with increased food production, assuring nutritious food is one of the most important issues for Asian nations.

"Bangladesh advancing with the goal of becoming a country with excess food production compared to demand by 2030," she added.

The government is working to assure that farmers are paid the right price for their produce. However, a collaborative effort is needed to safeguard their rights, asserted Planning Minister MA

Almost all the coastal countries of the region, including Bangladesh, are victims of climate change, which has created challenges in securing food rights.

Efforts to tackle the crisis

As the death toll and hospitalisations due to dengue continue to surge, Bangladesh Red Crescent Society (BDRCS) is active across the country to address the escalating outbreak.

Meanwhile, the two Dhaka city corporations are also implementing measures to combat the alarming rise in dengue cases and fatalities in the capital.

BDRCS, collaboration the International Federation of Cross and Red Crescent Societies (IFRC), is taking measures to combat the spread

of the mosquito-borne disease and providing much-needed support to affected communities, reads a press

To address the crisis, more than 150 BDRCS volunteers trained in Epidemic Control for Volunteers and Community-Based Health and First Aid are mobilised to address this health emergency," it said.

One of the major concerns is the

Fourteen more dengue patients died in different hospitals across country over the 24 hours ending vesterday morning. Of those, 10 were in

rose to 215, according to the Directorate General of Health Services (DGHS). At least 2,653 dengue

patients were hospitalised in the 24 hours, of whom 1,327 were in Dhaka.

With the new cases, the total number of dengue cases rose to 40,341, of which 23,676 were from outside Dhaka.

Some 8,189 dengue patients are still undergoing treatment. Over half of them are in Dhaka.

Total number of deaths in dengue was 281 last year while the number of cases was 62,382, according to the DGHS.

South Korea to give \$3m for Rohingyas

UNB, Dhaka

The government of the Republic of Korea yesterday announced its plan to provide 3 million US dollars this year to support humanitarian assistance for Rohingyas in Bangladesh.

The Embassy of the Republic of Korea in Dhaka said this year's humanitarian assistance will be provided through international organisations in Bangladesh such as UNHCR, IOM, WFP, and Unicef.

The embassy said they support dialogues between the governments of Bangladesh and Myanmar for the repatriation of the refugees and supports safe, voluntary, dignified and sustainable return of Rohingyas to their communities.

New navy chief calls on president

abrupt termination of workers, filing of fake cases, and suppression of rights. They also urged the government to scrap the Essential Services Bill 2023. Speaking at the programme, garment

worker Shahida Akter expressed concern over inadequate wages, which leads to financial instability among the workers' families. "The minimum wage should be

"We cannot call these working women self-dependent as it is nearly impossible to survive with this salary," she added.

Khondaker Golam Moazzem, research director of Centre for Policy Dialogue, stressed the need for revising the wage structure of RMG workers.

Sabina Yasmin of Naripokkho said those who protests in this regard are often silenced.

We have to ensure that existing policies on preventing sexual harassment are implemented properly. Besides, facilities like daycare centres should be made available for female workers.

Author and anthropologist Rahnuma Ahmed said, "We have been making these demands for a long time, but to no avail. A stronger fight is required to press home the issue.'





Two bridges side by side, but of no use

Two newly constructed bridges over a canal in Lalmonirhat's Kaliganj upazila have remained unfit for movements due to lack of approach roads on either side of both the structures.

As there are no approach roads, connecting both the bridges, people of several villages under Tushbhandar union are being deprived of getting any benefits from the unplanned bridges, villagers alleged.

Local residents said over a thousand from Bairati, Chilakhal, Chikarbazar and Matabpur villages have to cross the Bairati Canal to go to their destinations, including the local union parishad (UP) office and Kaliganj upazila headquarters.

Earlier, they used to build a bamboomakeshift bridge over the canal on self-help basis to ease their communication problem, especially during the rainy season, villagers said.

Bangladesh Agricultural Development Corporation (BADC) and Ministry of Disaster Management and Relief constructed the two separate bridges, close to each other, in 2022 and 2023 respectively.

But the two newly-constructed bridges brought nothing for the people living in the nearby areas, locals said.

Farmer Abu Bakar said thought construction of a concrete bridge was a long-cherished demand for the villagers, they are yet to get any benefits of the two unplanned bridges.

Recently villagers put a bamboomade platform on one side of one of the bridges so that people can get into the bridge and cross it, he said.

This is nothing, but waste of

government money, Bakar added.

Abbas Ali, a resident of Bairati village, said despite getting two new bridges over the Bairati Canal, they are still suffering like before as neither of those of any use.

Besides, lengths of the two newly constructed bridges are too short, compared to the measurement of the canal, he said, adding that the water flow through the canal is being obstructed due to unplanned construction of the

Both the bridges may collapse if a major flood occur in the surrounding areas, Abbas said.

According to Lalmonirhat BADC, construction of the 98-feet-long and 15-feet-wide bridge, spending Tk 79.47 lakh, was completed in June 2022.

While, Disaster Management and Relief Ministry built the 50-feet-long and 14-feet-wide bridge at a cost of Tk 70 will be repaired soon.

Tushbhandar UP Chairman Nur Islam said the engineers can say whether the bridges are unplanned, but the truth is those are of no use.

It is quite difficult to make the two bridges usable without constructing the protection walls and connecting roads, the UP chairman added.

Trees on 50 acres lost in 5yrs

The Shuvo Sandhya Beach in Barguna's Taltali upazila has been facing serious erosion by the Bay for the last couple of years.

Due to continuous erosion by the Bay, nearly 50 acres of forestland close to the beach and about 60,000 trees have already been washed away in the last five year.

Meanwhile, due to destruction of the natural beauty of the beach, the number of tourists has decreased significantly in the recent years.

Shuvo Sandhya Beach was built on the shores of the Bay of Bengal in southwest of Taltali upazila headquarters in 2010. Later, forest department planted over one lakh trees of different species, including Jhau, on 125 acres of land in an attempt to protect the nearly 6-kilometre-long beach from being washed away by the tidal surges.

But due to tidal surges caused by the rough waves of the sea, the beach area as well as vast forestland are gradually decreasing every year.

Since 2018, at least 60,000 trees on nearly 50 acres of forestland on the beach area have either been washed away or died due to continuous erosion by the Bay.

Moreover, Local Government Engineering Department (LGED) built a brick road, which connects the beach, to facilitate tourists' movement, but a major portion of the road has already been lost to the sea.

During a recent visit to the beach area this correspondent saw hundreds of dead trees are lying scattered across the beach.

Abu Hena Mostafa, a student at Patuakhali Science and Technology University, said there were many types of trees, especially a beautiful Jhau garden, when he first came here in 2015.

But, due to continuous erosion by the Bay the beach has lost its attraction now, he added.

Moniruzzaman, Range Officer at Taltali Forest Department, said afforestation was started by planting 12,000 Jhau trees in 2013-14 fiscal year.

Later, large gardens were developed by planting various mangrove species of trees along the beach in to prevent soil erosion.

But the erosion has washed away at least 60,000 trees in the last five years. He said they have a plan to plant 50,000 more trees on the beach.



Ship carrying 3,000 cars ablaze off Dutch coast, crew member dead

A fire blazed on a ship off the Dutch coast with nearly 3,000 vehicles on board yesterday, killing one member of the crew and injuring several others, the coastguard said.

The fire began on Tuesday night on the 199-metre Panama-registered Fremantle Highway, which was en route from Germany to Egypt, forcing several crew members to jump overboard. Dutch broadcaster NOS said all the crew were Indian.

Rescue ships sprayed water onto the burning boat to cool it down, but using too much water risked its sinking, the Dutch coastguard said. A salvage vessel was hooked on to stop

it drifting. The fire might last for several days, Dutch news agency ANP reported, citing the coastguard. Smoke continued to billow from the vessel near the northern Dutch island of Ameland.

"The fire is most definitely still not controlled. It's a very hard fire to extinguish, possibly because of the cargo the ship was transporting," said Edwin Versteeg, a spokesperson for the Dutch Department of Waterways and Public Works.

The coastguard said on its website that the cause of the fire was unknown, but a coastguard spokesperson had earlier told Reuters it began near an electric car. Roughly 25 out 2,857 vehicles on the ship were electric.

International Maritime Organisation, which sets out regulation for safety at sea, plans to evaluate new measures for ships transporting electric vehicles next year in light of the growing number of fires on cargo ships, a spokesperson said.

"Electric cars burn just as much as combustion engine cars. When batteries overheat and a so-called 'thermal runaway' occurs, then it gets dangerous," said Uwe-Peter Schieder, master mariner and representative of the German Insurance Association.

"A chemical reaction in the battery produces gases which inflate the battery.'

New rules under consideration could take years to implement, but may include specifications on the types of water extinguishers available on boats and limitations on the amount a battery can be charged, which impacts flammability.

"Recently, they were failing to pay the room rent," he said.

Titu, who lives in an adjacent room, said that his sister and brother-in-law lived in Gazipur. Jewel, who hailed from Kurigram, used to be a laguna driver there but he stopped driving as he didn't have a license.

"When my sister became pregnant, our family made a crucial decision to take her to a private hospital in Kishoreganj, prioritising her health despite our financial constraints. The hospital expenses amounted to Tk

Titu came home after 12:00am early yesterday and asked his wife whether Jewel and Nasrin had eaten or not. When he went to check on them, he found their door closed.

"As there was no response, I saw both of them hanging from the ceiling fan through a chink in the door. I informed the police immediately," he

Alom observed the election at different centres freely. He also did not face any untoward incident, or lodged any complaint, until the end

"So the way a handful of diplomats have presented a last-minute isolated incident of one centre, never reflects the peaceful nature of the election. While giving a quick response, they did not give importance on the objectivity of their assessment," he

The missions issued the statement on July 19, and two people were arrested in connection with the attack before that. The Election Commission and the government took instant steps, he said.

The joint statement did not mention the arrest, which is a shortcoming, he said.

"Even then, in the statement these diplomats have called for legal actions, which is unwarranted and unnecessary," the state minister added.

'They [diplomats] said they did it to assist the election process of Bangladesh as part of their continuous engagement with us," Shahriar said.

He said that Bangladesh officials made a counter argument that

it is clearly written in the Vienna underway centring the election, Convention that the ministry of foreign affairs is their first point of contact regarding any issue.

"We have no objections if they talk violence or other irregularities, he the foreign ministry," he added. He said that article 41 (1) of United

Nations Vienna Convention on Diplomatic Relations 1961 states that without prejudice to their privileges and immunities, it is the duty of all persons enjoying such privileges and immunities to respect the laws and regulations of the receiving State. They also have a duty not to interfere in the internal affairs of that State.

Article 41 (2) says that all official business with the receiving State entrusted to the mission by the sending State shall be conducted with or through the Ministry for Foreign Affairs of the receiving State or such other ministry as may be agreed.

"We will inform the respective capitals about our displeasure. We will urge them to ensure that no one from their missions gets involved in such activities in the future," he

Asked about whether such move of Bangladesh will affect relations, Shahriar said, "Not at all."

He added, "Friendship and effective relations go ahead even after these types of events. We have cordial relations, trade, and people to people contact with all these countries."

According to him, some ill attempts by some quarters are

In the past, one ambassador made comments that were not in agreement of voting. US EMBASSY RESPONDS US embassy spokesperson Bryan Schiller yesterday said, "As we have said many times, we support Bangladesh's goal of holding free, fair, and peaceful elections. To that end, we joined with other foreign missions to condemn the violence against Hero Alam and to call for a full investigation and bringing the perpetrators to account. We note that a number of arrests have been made in the case. Such violence has no place in the democratic process.'

China refuses to say why foreign minister

spokeswoman Mao Ning referred journalists to a state news agency article and declined to offer any further information.

'Xinhua has already published information. You can refer to that," Mao said.

Asked how she evaluated Qin's brief stint as foreign minister, Mao said she was "probably not the right person to answer that question". "I don't think it's appropriate for me

to pass judgment," she said, insisting

that China was "releasing normal information" concerning Qin's position. Pressed repeatedly by journalists to provide more details on Qin's fate, Mao said decisions made Tuesday by China's top lawmaking body and the

president were "very clear". "I suggest you all refer to that. I don't have any additional information," she said.

"China's diplomatic activities are all advancing steadily," Mao added.

Any reference to 57-year-old Qin had been removed from the website of China's foreign ministry by yesterday.

A search for his name yielded no results and previous articles about his diplomatic appearances showed a message saying the page "does not exist or has been deleted".

But his name did appear on other Chinese government websites, including the State Council, the Ministry of Commerce and state media outlets.

Asked about his disappearance from the foreign ministry website, Mao said: "Information on the website of the Ministry of Foreign Affairs is updated according to relevant

management regulations." Qin has been replaced as foreign minister by top diplomat Wang Yi.

The foreign ministry had dodged

questions on Qin for weeks, after previously saying "health reasons' were to blame for his absence.

State media gave no reason on Tuesday for his dismissal but one expert said Qin's "digital erasure"

suggested he had fallen from grace. "If he were a comrade in good standing who had fallen ill I am not sure that would be happening," China analyst Bill Bishop wrote in his

Sinocism newsletter. Neil Thomas, a fellow on Chinese politics at the Asia Society Policy Institute, a US think tank, agreed.

"Evidence is emerging suggesting this is indeed a political purge," Thomas said on Twitter, which is being rebranded as "X"

China remained tight-lipped for weeks about the fate of Qin, who has not been seen in public since June 25 when he met Russia's deputy foreign minister Andrey Rudenko in Beijing.





Tech giants form group to ensure safety

Four US leaders in artificial intelligence (AI) announced yesterday the formation of an industry group devoted to addressing risks that cutting edge versions of the technology may pose.

Anthropic, Google, Microsoft, and ChatGPT-maker OpenAI said the newly created Frontier Model Forum will draw on the expertise of its members to minimize AI risks and support industry standards.

The companies pledged to share best practices with each other, lawmakers and researchers.

"Companies creating AI technology have a responsibility to ensure that it is safe, secure, and remains under human control," Microsoft president Brad Smith said in a statement.

"This initiative is a vital step to bring the tech sector together in advancing AI responsibly."

Myanmar's military government may move ousted leader Aung San Suu Kyi from prison to house arrest in the capital, Naypyitaw, two media outlets reported yesterday.

The 78-year-old Nobel laureate has been in detention since her arrest in early 2021 when the military overthrew her elected government in a coup and unleashed a bloody crackdown on opponents that has seen thousands jailed or killed.

The Associated Press cited an unidentified security official as saying the move was an act of clemency to prisoners as part of a religious ceremony due next week.

The BBC Burmeselanguage service cited a "source close to the prison" as saying she may have already been moved to a house usually used by government officials.

Reuters could not independently verify the reports or Suu Kyi's whereabouts.

A spokesman for Myanmar's ruling military was not immediately available for comment. Suu Kyi's lawyers and a spokesperson for the shadow National Unity Government, could not confirm.

Russia, North Korea to strengthen defence cooperation

Says Moscow; Kyiv top diplomat visits Liberia; new \$400 million aid package for Ukraine from US includes Black Hornet spy drone

Russia and North Korea plan to strengthen defence cooperation, Russian Defence Minister Sergei Shoigu said yesterday after talks in Pyongyang with his North Korean counterpart.

"I am convinced that today's talks will contribute to strengthening cooperation between our defence departments," Shoigu said in remarks published by Russia's Defence Ministry.

Shoigu was heading a Russian delegation visiting North Korea for commemorations marking the 70th anniversary of the Korean War and the struggle against the United States and its allies.

Meanwhile, Ukraine's top diplomat visited Liberia yesterday on a third wartime tour of Africa as Russia prepares to host a summit with leaders from the continent this week after the demise of the Black Sea grain deal.

The Liberia trip by Dmytro Kuleba, the first such visit in the history of Ukrainian diplomacy, according to the foreign ministry, comes amid a concerted push by Kyiv to challenge Russian influence in Africa and the wider "Global South".

Images from Russia's defence ministry and North Korean media showed Shoigu being greeted by North Korean defence minister Kang Sun Nam and Russian ambassador Alexander Matsegora at the airport, and rows of North Korean and Russia troops.

The United States has accused North Korea of providing weapons to Russia during the war in Ukraine, including an arms delivery of infantry rockets and missiles to the Kremlin-backed Wagner mercenary group in November 2022.

Pyongyang and Moscow have denied those claims,

but Kim has vowed to bolster strategic cooperation between the nations.

The military parade in Pyongyang is likely to include as many as 15,000 personnel, and possibly feature new designs of nuclear-capable weapons, said Yang Moo-jin, a professor at the University of North Korean Studies in Seoul.

Elsewhere, The US Department of Defense announced \$400 million in additional security assistance for Ukraine on Tuesday, including air defense missiles, armored vehicles and small drones, as Ukraine's counteroffensive against Russia grinds on

The new aid package, which was first reported by Reuters, will include for the first time US furnished Black Hornet surveillance drones made by Teledyne FLIR Defense, part of Teledyne Technologies TDY.N.

The Norwegian-built Hornet is being used in Ukraine through donations by the British and Norwegian governments, the company said. FLIR Unmanned Aerial Systems was awarded a \$93 million contract in April to provide the small reconnaissance drones to the US Army.

Ukraine's Foreign Minister Kuleba during his visit to the African country, will hold talks with Liberian leaders to discuss "ensuring the export of Ukrainian grain to Africa" as well as the vision for peace in Ukraine set out by President Volodymyr Zelenskiy, the ministry said.

"Against the backdrop of Russia's food blackmail, Ukraine is maximizing its consolidation of support from African countries to continue exporting Ukrainian grain to the Black Sea," Foreign Ministry spokesperson Oleg Nikolenko said this week.

Taiwan conducts military drill at main airport

Taiwan conducted an antiaircraft landing drill at its main international airport for the first time yesterday, simulating the repulsion of an invading force as China ramps up military pressure to force the island to accept its sovereignty.

The drill at the island's main Taoyuan international airport was part of Taiwan's main annual Han Kuang exercises that started on Monday, focusing on protecting its infrastructure.

Six helicopters including Apache attack helicopters and some 180 soldiers took part in the drill to simulate the repulsion of an enemy force who had seized control of air traffic control facilities at the airport, the defence ministry said.

Soldiers carrying rifles were seen running on the runway to fight off enemy forces being dropped off by the helicopters. Shortly, a soldier waved Taiwan's national flag on a jet bridge, signalling their victory.

Overseeing a separate drill in the northern city of Taoyuan simulating physical and cyber attacks on an oil refinery, President Tsai Ing-wen said Taiwan must boost its resilience in the event of an emergency.

Cambodian PM to step down after 4 decades

Cambodian Prime Minister Hun Sen, one of the world's longest-serving leaders, said yesterday he will resign and hand power to his eldest son after almost four decades of hardline rule.

The former Khmer Rouge cadre has run the kingdom since 1985, eliminating all opposition to his power, with rival parties banned, challengers forced to flee and freedom of expression stifled.

His Cambodian People's Party (CPP) won a landslide victory in an election on Sunday with no meaningful opposition, taking 82 percent of the vote, paving the way for a dynastic succession to his eldest son that some critics have compared to North Korea.

"I would like to ask for understanding from the people as I announce that I will not continue as prime minister," the 70-year-old said in a special broadcast on state television.

Election authorities disqualified the only serious challenger, the Candlelight Party, on a technicality in advance of the election, and the CPP is expected to win all but five lower house seats.

The government bailed the 84.6 percent voter turnout.

The government hailed the 84.6 percent voter turnout as evidence of the country's "democratic maturity" but Western powers, including the United States and the European Union, condemned the poll as neither free nor fair.

The UN's human rights chief Volker Turk added his own criticism yesterday, saying opposition parties and media had faced "restrictions and reprisals" aimed at hindering free elections.

Florida ocean temperature tops 100F

Shallow waters off south Florida topped 100 degrees Fahrenheit (37.8C) for several hours on Monday, potentially setting a new world record with temperatures more commonly associated with hot tubs.

The readings were taken from a single buoy in Manatee Bay, about 38 miles (60 kilometers) southwest of Miami, at a depth of five feet (1.5 meters).

A peak temperature of 101.1F was recorded at 6:00 pm, official data showed.

The previous known high might have been 99.7F recorded in Kuwait Bay.

51 whales dead after mass stranding in Australia

.**FP,** Sydney

Dozens of pilot whales have died just hours after stranding themselves on a beach in Western Australia, authorities said yesterday. The 51 long-finned pilot

whales were among a pod of almost 100 spotted off Cheynes Beach near Albany, about 400 kilometres (250 miles) southeast of Perth on Tuesday.

The state's Parks and Wildlife Service said it was working with volunteers to try to save the remaining 46 whales, with plans to guide them to deeper water during the course of the day.

A spokesperson for the organisation said it had been "overwhelmed with hundreds of offers of help" but that it has enough volunteers and the public should "stay away" from the beach.

It has been obligatory for women to cover their heads and necks since shortly after the Islamic revolution of 1979 that ousted the secular shah.

But Amnesty said there is in fact "an intensified nationwide crackdown", and noted that police this month announced the return of car and foot patrols enforcing compulsory veiling across the country.

According to Amnesty, more than a million women have received SMS warnings threatening that their vehicles will be confiscated if they are found travelling in a car while unveiled.

3 die in Greece as wildfires rage

Rain pounded coastal communities, including isolated villages tucked away in tropical forests. Many people had already been moved to safer areas ahead of the storm, which brought winds of up to 175 kilometres per hour (108 miles per hour).

"We're being battered here," Manuel Mamba, governor of the northern corn-

growing Cagayan province, told Reuters. The storm, labelled as a super typhoon by China's Meteorological Administration, is nearly 900 km (560 miles) across and is expected to sustain strength as it continues towards Taiwan and the Chinese mainland.

China's weather agency has already raised its storm alert to the secondhighest tier and the manufacturing hub of Guangdong province has warned of the worst storm in a decade.

Doksuri is expected to make landfall in China on Friday, the second typhoon to land in under two weeks after Talim slammed into Guangdong on July 17.

Throughout July, record temperatures have caused havoc across the globe, sparking wildfires in the US and the Mediterranean. Scientists say global warming will also make storms wetter, windier and more violent.

In the Philippines, at least one person drowned in the province of Rizal, the national disaster agency said.

More than 4,000 passengers were stranded at ports across the country after sea travel was suspended, the Philippine coast guard said.

The storm's outer rain bands were expected to hit southern Taiwan later yesterday, its Central Weather Bureau

Israel Supreme Court to hear appeal

Netanyahu suffers polls dip

Israel's Supreme Court said yesterday it would hear an appeal against a new law that curbs some of its own powers, pitting it against Prime Minister Benjamin Netanyahu's right-wing government that is seeking an overhaul of the judicial system.

A bench decision posted on the court's website said a hearing will be set for the appeal in September. The court did not issue an injunction against the new law, which came into effect vesterday.

A political watchdog and Israel's bar association had petitioned the court to intervene.

Critics say the changes will open the that has left them disproportionately door to corruption and abuses of power by removing effective checks on the governing executive's authority.

The judicial overhaul has caused a deep divide in Israeli society, kindling months of unprecedented protests, stirring concern among allies abroad including top supporter Washington for the health of Israel's 75-year-old democracy, and straining the loyalties of some army reservists.

But it has also seen Arab citizens, who make up a fifth of Israel's population, stay on the sidelines, disillusioned with what they say is systemic discrimination published late on Tuesday.

Netanyahu has taken a hit in opinion polls. Surveys by two main Israeli news broadcasters showed that if an election was held now, the number of seats held by his hard-right governing coalition in the 120-seat Knesset (parliament) would fall from 64 to 52 or 53.

Seats held by the 73-year-old premier's Likud party would fall from 32 to 28, according to N12 News, and to as low as 25, according to Reshet 13 in the polls

Blinken criticises China's 'problematic behaviour'

US Secretary of State Antony Blinken warned of China's "problematic behaviour" during a visit to the Pacific island nation of Tonga on Wednesday, citing Beijing's militarisation of the South China Sea and what he called economic coercion.

China's growing presence in the region, which saw it sign a security pact with the Solomon Islands last year, has fuelled concern in the US and Australia about Beijing's ambitions. It also prompted increased Western aid and engagement.

Blinken said at a press conference that the US had no objection to China's engagement with the region but there were concerns that its investments needed to be transparent and undertaken with sustainable finance.

"I think one of the things that we've seen is that as China's engagement in the (Indo-Pacific) region has grown there has been some, from our perspective, increasingly problematic behaviour,'

Japan sees record drop in population

Japan's population fell by a record in 2022, government data showed yesterday, as the country struggles to reverse its perennial low birthrates.

While many developed countries face low birthrates, the problem is particularly acute in Japan where the population has now fallen for 14 straight years.

The country has the world's second oldest population, after tiny Monaco, and in January, Prime Minister Fumio Kishida warned Japan was "on the verge of whether we can continue to function as a society".

Last year, the number of Japanese fell by 800,523, or 0.65 percent, to 122,423,038 from a year earlier, a survey by the internal affairs ministry shows.

Police excesses must stop

Report on police raid leading to girl's suicide is deeply alarming

It was only the other day that we commented on an incident in Natore in which five cops allegedly tortured three men in custody, leading to the local court asking the police authorities to file a case against the officers responsible. While a court's intervention on behalf of helpless victims is laudable, the truth is, bereft of institutional accountability, it is hardly a deterrence against police excesses, which have been occurring with frightening regularity in the country. The latest to be reported by the media occurred in Pallabi, Dhaka, where Baishakhi Akhter, aged 16, allegedly took her own life after police attempted to detain her mother during

There have been contrasting claims about what really happened. Police allege that the family ran a drug business and that the aim of the raid on their home was to "recover narcotics." But the family denied these allegations. Our concern is not about whether the family had any criminal history, but what happened after the so-called raid and whether police were somehow responsible for the tragedy that followed. According to Baishakhi's family, not only did the police team attempt to extort money from them, but they also tortured mother and daughter before hauling Baishakhi off to a room where, locked from outside, she threatened and subsequently committed suicide.

The truth of the matter will only come out if a thorough investigation is conducted. However, from what has been reported, several facts stand on their own: 1) police conducted the "raid" in plain clothes; 2) a young girl killed herself during the raid; and 3) something happened during the raid that prompted it, leading to angry protests by locals. These facts are enough to indicate foul play at some stage of the raid. The picture that emerges from media reports – as well as the history of police involvement in extortion using the well-worn excuse of narcotics possession – is once again a reminder that beyond token disciplinary measures, not much is being done to ensure accountability of the errant members of this vital force.

In the past, we have often seen how the authorities tried to discredit allegations of police misconduct by citing the supposed criminality of victims. But in the eyes of law, everyone deserves to be treated with dignity and given a fair chance to be heard in a court of law. But it is because of police's vigilante-style raids - using the cover of plain clothes - that such principles stand violated, and that people find it hard to trust them. In these columns, we have also often raised concerns about how such police excesses and extrajudicial actions have created fears among ordinary citizens. A continuation of this situation will be most frustrating.

We, therefore, urge the police authorities to ensure a fair investigation into the Baishakhi tragedy and bring anyone responsible to book. Unless they take proper steps in such cases, public trust in police may never be recovered.

Black Sea grain deal must be upheld

Russia should consider the bigger picture of global food crisis

We are gravely concerned about Russia's decision to not rejoin the Black Sea Grain Initiative. Reportedly, the country recently rejected the UN chief's call in this regard, which we fear may severely affect global food supply, especially in countries that are dependent on grain imports. Ukraine is a major producer of staple crops such as wheat, corn, maize, oilseeds, etc. For three years prior to the Russia-Ukraine war, about 10 percent of the wheat and 15 percent of the corn traded globally came from Ukraine. Russia, too, had a major contribution to global food as well as fertiliser supplies.

Given how food prices in the international market shot up as Ukraine's grain exports got disrupted following the war, the UN and Turkiye stepped in to broker the Black Sea Grain Initiative in July 2022 - which opened up Ukraine's ports in the Black Sea for grain exports. Under the deal, the World Food Programme (WFP) procured more than half of its global wheat supply from Ukraine to run aid operations in several

With Russia refusing to rejoin the deal now, chances are those ports will become inaccessible, which means Ukraine won't be able to ship grains anymore. That does not bode well for the rest of the world. Already, this development is affecting food prices. In Bangladesh, which is the third largest importer of wheat from Ukraine, the price of low-grade wheat shot up by Tk 20-30 per maund at Chattogram's Khatunganj wholesale market the day after Russia announced it was pulling out of the deal.

Russia's refusal does have some merit, however. It says it sees no reason to uphold the deal as the commitments made to facilitate its food and fertiliser exports under the deal have vet to be fulfilled. While Western sanctions on Russia do not apply to food and fertiliser exports, restrictions on payments, logistics and insurance have certainly hindered shipments, according to Moscow. We understand its troubles, but Russia must see the bigger picture and consider how its decision will affect millions of people around the world. On humanitarian grounds, as well as to strengthen its global standing, Russia must consider rejoining the deal to avert a potential catastrophe. At the same time, we urge the UN to find ways to accommodate Russia's demands so that the integrity of the initiative is upheld.



Since it is more or less accepted that the NHD has failed, it was expected that for the FY2023-24 social protection budget, the government would have rectified its position regarding the NHD by discarding it and experimenting with new alternatives that would be home-grown and less expensive. In this context, it should be mentioned that under the Asian Development Bank (ADB)supported Covid-19 Active Response and Expenditure Support (CARES) programme, and in collaboration with the Department of Social Services (DSS), a pilot communitybased targeting and selection process (CBTSP) was carried out in two unions in Bangladesh between March and April 2023. Only two programmes - old age allowance and widow allowance - were considered. In terms of selection efficiency, the community involvement, it is possible to better identify beneficiaries for social protection programmes. And following focused group discussions, social mapping, transact walks, and dedicated household surveys, it would be possible to prepare a master beneficiary list and separate beneficiary lists for most of our social safety programmes.

Also, allowing private participation in social protection could improve efficiency, coverage, and lessen burden on the national budget.

As is apparent, both equity and efficiency have been ignored while formulating the FY2023-24 social safety budget allocation. Unless measures are included to improve equity and efficiency, the benefits of the social protection budget will continue to be low. The government may consider some solutions in this regard.

First, it must commit to enhancing net social safety allocation to around three percent of GDP. The social protection budget should be used to ensure parity in allocation across rural and urban areas and across all

The CBTSP approach may be an important source of information to prepare an evidencebased social protection budget, which is likely to improve selection, reduce leakage, and improve value for money. Living with the river or fighting against it?

As recent reports and editorials in this newspaper have conveyed, the scale of river erosion in eight northwestern districts, particularly Kurigram and Lalmonirhat, is very alarming. The heart-breaking stories of people losing their homes and hearth, their sources of livelihood, and all their belongings, are all too common in Bangladesh. As a result, internally displaced annually due to to grow and flourish. river erosion in the country.

As a delta country, Bangladesh erosion, and redeposition. Major river systems such as the Teesta, Brahmaputra-Jamuna, Padma, and Meghna, together with their larger tributaries, are continually eating up land from one bank and depositing silt to the other. As Kazi Nazrul Islam's verse goes, "E kul bhange, o kul gorey, eito nodir khela" ("Here a bank breaks, there another emerges. Such is the play of rivers"). In the process, alluvial chars of various sizes also emerge as agricultural frontiers, which are populated and often wither away again. This erosion and accretion of land is a characteristic feature of the active river systems of Bangladesh.

The annual flooding and the massive flow of water from upstream Himalayas cause extensive bankline erosion and channel migration, associated with the siltation of river beds as chars, further amplifying flood risks and erosion. This also has macro and micro impacts on the rural population and landbased economy of the country. The earliest response by the government to this "twin" problem of flooding and erosion can be traced back to the measures recommended by the United Nations Krug Mission in 1956, following the massive floods in East Pakistan (now Bangladesh) in 1954. The Krug Mission Report stressed the need for the construction of high embankments to confine the waters of major rivers within their main channels and to cordon off large areas from flooding.

A long-term master plan was also prepared by the East Pakistan Water and Power Development Authority (EPWAPDA) – the predecessor of the Bangladesh Water Development Board (BWDB) - focusing on largescale engineering construction and interventions for flood control and bank protection efforts such as building embankments, groins, dams, and polders to provide protection and minimise human and material losses.

efforts. The multi-channel Jamuna River stabilisation programme is one example of this, which seeks to narrow down the width into a single- or double-channel planform, combined with dredging for a navigational channel, protection of the existing bankline against erosion, and boost of economic growth, as envisioned in the Bangladesh Delta Plan 2100. If the corridors of major rivers were to be converted into a single channel, an estimated 50,000 hectares of new land would be reclaimed for potential use for various development interventions, including for the establishment of river ports and industrial/trade centres such as economic processing zones (EPZs).

Therefore, a more holistic approach to the issues of flooding and erosion is necessary - one that would take cognisance of the complex interactions of all aspects of how people have traditionally organised, produced, and survived within physical constraints. Each of these aspects is critical to understanding the river management problem from a "hydrosociality" perspective, and not just an engineering perspective. In the past, the BWDB has taken

many structural measures to control and/or regulate the Jamuna River. But the mighty Jamuna and the sheer magnitude of the monsoon floods preclude almost all types of Even today, the BWDB approach engineering work as a means to halt erosion and prevent flooding. The short-lived and limited utility of some of the physical infrastructures built so far have led to widespread doubts about the wisdom of this approach. Experts are also concerned regarding the longterm impacts of river stabilisation if implemented without careful consideration of the transboundary nature of the country's river systems, given that Bangladesh is located at the lower reaches. If the width of the lower stream of the Jamuna and other rivers - which originate upstream in Tibet, China, and India - are narrowed down to one or two channels, it could spell disaster for the normal flow of water and seriously harm the rich local biodiversity.

Any river stabilisation programme of a large scale must be based on national dialogues and engagements with stakeholders in char areas. Since there appear to be no practical means of stopping erosion (despite existing embankments and protective efforts), the solution lies in developing socioeconomic measures (such as improving warning systems, increasing preparedness for loss reduction, recovery, resettlement, livelihoods, formulation of new land laws for char use and ownership, etc) to mitigate the impacts of erosion events, rather than preventing erosion itself. In other words, it is necessary to live with the river rather than fight against it.

Of course, some interventions and limited protection work for major towns, ports and other important establishments will always be necessary, along with some form of stabilisation in selected sections of major rivers. However, a full-scale programme for the stabilisation of these rivers may be unnecessary, as they would affect human populations and their agricultural needs, besides impacting essential ecological processes and biological diversity. It is possible to plan alternatives and create adaptive pathways to manage the rivers in Bangladesh, which would also be in line with the Delta Plan 2100. There is a greater need for understanding life in the delta before we transform it. Unfortunately, this seems to be lacking in Bangladesh as of now.

Combatting colourism in Bangladesh

In Bangladesh, colourism subtly imposed yet firmly grips society, particularly affecting young girls with darker complexions who often endure colour-based discrimination. Flourishing within a patriarchal framework, colourism perpetuates a deep-seated racial discourse, causing long-lasting psychological distress for families with darker-skinned

What is colourism, you ask?

Colourism persists the shadow of racism, delicately infiltrating society. Racism and colourism, while interconnected, are not identical. Racism is systematic, underpinned by prejudice against a minority based on their ethnic heritage. For example, discriminatory attitudes or institutional practices against the Indigenous communities in Bangladesh, such as those living in the Chittagong Hill Tracts, based purely on their ethnic heritage, could be classified as racism.

Conversely, colourism operates on preferential treatment within a minority group, based on skin tones. The occurrence of this bias within a single racial or ethnic group demonstrates its complex character. In the Indian subcontinent, the prevalence of Fair & Lovely, a skinlightening cream that was marketed for decades, is widely recognised. The marketing strategies associated with Fair & Lovely and similar products have perpetuated the notion that having lighter skin can enhance a woman's prospects for marriage, employment opportunities, and social status. This not only demonstrates the prevalence of colourism, but also reinforces the normalisation of such beliefs, thus embedding it into societal norms and expectations.

factor in the allocation of duties attractive, and socially acceptable. and privileges among the enslaved. skin colour has lingered, influencing social, educational, and economic opportunities and creating damaging legacy.

For instance, a bastion of public influence, Hollywood has a contentious history of depicting skin colour in a manner that perpetuates colourism. This manifests in the casting of lighter-skinned or "Whitepassing" actors in leading roles. Beyond beliefs, the far-reaching influence of colourism infiltrates various sectors, including the entertainment industry and the job market. A testament to this is the booming global market of skinlightening products. This trend underlines a deeply-rooted bias that associates lighter skin with privilege, success, desirability, and intelligence.

Even though several corporations have vowed to discontinue the sale of products blatantly marketed as "skinwhitening," these products are likely to remain accessible under subtler aliases. By employing euphemisms like "glowing," "radiant," "bright" or "clear," these products may be the colonial era, British colonists repackaged as wellness commodities,

through such platforms can highlight the experiences of individuals facing taunts or discrimination based on their skin colour.

To facilitate open discussions and interactions, All Shades are Beautiful organises "Talk About It Tuesdays," providing participants with a platform to share their personal experiences and thoughts on colourism, among other social issues. The discussions held thus far have touched on various aspects, such as the young age at which individuals first encounter comments about their skin tones and their experiences with skin treatments aimed at achieving fairer skin. The series "Shades of Bias: Unravelling Colourism" educates viewers about the definition, historical background, and present-day effects of skin colour discrimination in Bangladesh. And lastly, "True to Complexion," an upcoming series, aims to showcase and inspire women to employ makeup techniques that enhance rather than alter their natural skin tone, challenging the prevailing cultural norm in Bangladesh.

Initiatives like these shed light on a deeply overlooked but highly prevalent form of prejudice, sparking essential conversations about the hidden concept of colourism. One hopes that such projects can be emulated. It is time for us to be better and brighter, beyond one's skin colour.



This century had started 14 years ago—and unlike the previous one—the world was not drafting 19-year-olds to a great war so that they could die in the trenches. The world had grown much crueller; it did not intend on giving this odd bloke a clue, what this life was all about.

Here begins the story—a strange boy walked into town one day with his stocky pants and a scraggy stubble.

His quaint upbringing in the northern districts gave him little idea what to expect. The childhood daysall seemed like a blur; a long stretch of dupurbela: a Bangali summer afternoon in the suburbs that is often disturbed by the screeching of crows, and the snoring of the not-so-sweet neighbour.

This was a world where the adults either took their afternoon naps or were at work-which gave our guy ample time to read what his heart desired and what his hands could find. The dusty old bookshelf still towered over his seemingly miniature figure life was overwhelmed. But what else and he could only read what his height could he do? One afternoon, he found an old tattered copy of a novel. It was a Soviet era Bengali translation of Émile Zola's Nana (1880), a realist portrayal of an escort in decadent Paris. Not many reading material for a 13-year-old, but such was the benevolence of the Bangali dupur bela-only its permissive generosity prevailed that afternoon and not the prying and poking noses of the adults.

It was not just indulging in the forbidden that the boy felt that afternoon. Zola tore apart the society's mask of progress and brought its hypocrisy out in the open for the world to see. Our young reader who was uninitiated to the realities of

Could he not have picked up a book that was more suited to his age? He hadn't learnt vet that books had any tags with them—that of age, ideas and ideology, passion and necessity. His household had no shortage of books. But this labelling or categorisation of books as children's stories and young adult novels, the dwindling drama and debate regarding genre and literary fiction, the seriousness and anti-seriousness of the business of reading—hadn't polluted his mind yet.

He only knew reading, merely adults would regard this as appropriate reading. If growing up entailed relinquishing our innocence, he was stepping into it in stages.

The Zola novel stunned the reader in him. This was literature telling him to get out there in the world. There were worlds beyond his comprehension. There were lives to see in this world, a life to be lived on his own, and to feel life through compassion and empathy.

A few years had passed. He had grown a little, albeit mostly in stature, since the day he encountered Zola. He could finally reach the Chekov and Samaresh from the top shelf. But the pleasant and tranquil afternoons no longer possessed him. There was a

The joy of stumbling upon a book at the library or from an acquaintance had become less a reality and more a reminiscence. Not returning a book on Greek tragedy from a distant cousin in seventh grade was a memory still quite fresh. The years of his flesh were betraying him. His loyalty to a life of reading was dwindling and it terrified him. What would he be without it? He knew little of what was happening to him. His younger self had buried his nose in old magazines and rigorously bound local hardcovers instead of making friends at school and playing till maghrib with neighbourhood peers. Social life was something he had only read in the pages of the witty Wilde and the

One day he was amused to find something growing in him that he had only read and cherished from afar. The spectrum of emotions and pathos sketched in Rabindranath Tagore's Golpo Guccho (1307) was what he had regarded as life's essence. But here he was-showing the audacity to make presumptions about life instead of choosing to embrace it. He had little choice but to stand trial for his foolish attempt at a proxy life, that in reading.

And who am I kidding? You might be quite irked at me by now, for what might come off as a nonsensical third-person rendering of my own life. I needed to distance myself from this past not out of shame-I loved and still do love to read but because this is painful. I was just like any other awkward teen who was not well prepared for a transition to adult life with its caricatures of social, personal and many other domains that I still find baffling.

And this was what my life felt like when I moved to Dhaka in 2014 and became that odd stranger who was new in town.

The urban landscape in Dhaka tried its best to suffocate me and I was beginning to lose my hold over structures that held life together. I was spiritually shaken and at that time could only hold on to very few things. I had merely switched delusions—from mistakenly trying to find an aesthetic exegesis to life from Tagore's short stories and poems to reached at mursalinmosaddeque@gmail. desperately hanging on to Tagore like com.

nor'wester brewing in his heart which a raft; the Tagore of Geetanjali, pujoporber-gaan and the crisp yet idyllic prose of his non-fiction. It wasn't the drowning that let me down but the fear of letting go of what was so dear to me. (Returning back to Tagore again and again is such an old and tiresome Bangali cliché but I don't think I can tell it honestly otherwise.)

So here I was all alone, drifting away on a raft in cold unknown waters. Studying, going out, dining out, making conversations while my heart only ached and it still does for a life in reading.


I would soon walk through the doors of a small bookstore in my neighbourhood. It was Charcha. I was so shocked that something so stupendous could exist so close to my place. It would soon become my second family. Charcha became a place where the reader in me found a home. I was free from the anxieties that had haunted me till then. I didn't have to compromise or struggle to make space for the reader in me. He existed at ease there, as though it was in its natural habitat. It was my family, it showed me that social life didn't have to be divorced from a life immersed in books. I made friends for life in Charcha among fellow readers. Prioritising to read above everything, came with a sacrifice, I had always thought. I had prepared myself to give up on things to read. This Elysian bookstore showed me that the reader in me too could embrace the many parables of life.

Charcha doesn't exist anymore. And the wound is still quite fresh though it's been a few years since it closed its doors. When I began writing this piece, it was supposed to be about Charcha but it feels too soon to broach a subject that's so tender. I ended up writing about who I was when I walked through its doors

The writer Mario Vargas Llosa in an interview for *The Paris Review* stated how he needed some space and time apart from a subject before he could write about it. I can now understand what he meant.

So, the stranger did indeed walk into a bookstore in town but that story is vet to be told. That life probably is yet to be lived.

Bad kids, worse adults

'Bad Kids' by Zijin Chen (Pushkin Press, 2014)

If you are looking for something different from your next readespecially if you're interested in reading a story that offers a window into another Asian culture-then Bad Kids by Zijin Chen might be a good choice. This book was an instant bestseller when it was published in China, and has since been adapted for the small screen.

I should start by mentioning that the book's title is misleading, as the kids are not so easily pigeonholed. Far from it. The absorbing and highly eventful narrative keeps the reader on the edge of her seat up to the very last page. And while the concept behind the story is relatively simple, its execution is anything but.

Chaoyang is a bright 13-yearold who is having a bad time at school. Widely considered a nerd, he is singled out for bullying by the daughter of a high-level police officer. The girl is jealous of his excellent academic results. And his dubious social status as the son of divorced parents in a China where conservative social values still hold sway makes the boy particularly vulnerable to such behaviour, as his plight garners little sympathy from his teachers.

To make matters worse, Chaoyang's wealthy father provides very little

Chaoyang's neglectful father and unpleasant stepmother dote on their own 10-year-old daughter, who is not even aware that she has a brother!

Alone and friendless, Chaovang is surprised at home one day when a friend of his comes to visit after a gap of several years. It turns out that this 13-year-old boy, Ding Hao, is on the run with a young girl of about 11, who is nicknamed Pupu. The pair have escaped from a state institution where they were placed after their parents were incarcerated or executed for violent crimes.

'Can't accept seeing my teammates disrespected'

It was on the cards for Harmanpreet Kaur to be penalised after the Indian skipper lost her temper both on and off the field following dissatisfaction over umpire's decision during the third and series-deciding ODI against Bangladesh last Saturday.

Harmanpreet was suspended for the next two international matches following two separate breaches of the ICC Code of Conduct.

For Bangladesh, it was a huge moment to beat a team like India for the very first time in the ODI format in the first game and then to go on to draw the three-match series 1-1, with the final game tied, in dramatic fashion -- an outcome that could be regarded as a stepping stone for women's cricket in the country.

Despite Harmanpreet's shocking behaviour during and after the game, Bangladesh players expected appreciation from their opponents who are among the top teams in world cricket.

We expected appreciation from them and some words of encouragement which would have motivated our players," Bangladesh skipper Nigar Sultana Joty told The

Upon hearing an unpleasant comment from Harmanpreet, Joty left the field with her teammates midway through the post-match photo session with the trophy and the Indian players.

"But what they did certainly does not leave a good message. The two teams were standing for the photo session and there was no point saying such a thing in front of the players as they could complain to the match referee according to the rules. Obviously, it felt bad when they were not showing respect. So, I felt there was no point in standing there as I respect my teammates and I can't accept that," Joty added.

According to Joty, Harmanpreet, a seasoned campaigner with a total of 284 international appearances, should have not dragged the matter outside of the field as it only relayed a bad message to the players around the world who look up to the Indian captain as a role model.

"Cricket is a game of discipline and most importantly, whatever we do inspires others. So, we won't do anything that gives a bad message to the others who look up to us. As for the captain of India, whatever happened during the game -- whether it was losing temper or showing frustration -- was normal but it was not right to carry that even after the game. We could have lost the game but in the end, we played better cricket and tied the match," she said.

'A performing Tamim will have everything on his side'

While there are lots of question marks regarding Tamim Igbal's return to the team following his unretirement, however, two of his mentors in former ODI captain Mashrafe Bin Mortaza and Nazmul Abedeen Fahim talked about the most important part of Tamim's return, which is to come back with motive and full

Tamim had departed for the UK on Tuesday and was set for meetings with doctors, accompanied by the Bangladesh Cricket Board (BCB) chief physician, Debashish Chowdhury. He had held online meetings with doctors at least three to four times and his schedules had been set prior to the visit to the UK.

He has a few MRI reports with him and more scans are to be one in England, according to BCB sources.

Tamim had only overturned his decision to retire following intervention from Bangladesh Prime Minister. Tamim also had requested that Mashrafe Bin Mortaza become the team's mentor for the 2023 ODI World Cup in India. At the moment, though, Mashrafe did not see the point of having a mentor under the current circumstances.

"What's to gain from a mentor? Can someone tell me? I don't know why he [Tamim] asked. I don't know what a mentor does. When a situation [team's requirement] like that comes, then something can be said. At this moment I don't have an answer," Mashrafe said while attending a programme for a university yesterday.

He further clarified that if the Prime Minister asks him too, there will be no objections from Mashrafe's side. However, his main issue at the moment in Tamim's retirement saga is not what caused the player to retire in the first place. Rather he wanted Tamim to hold his

end of the bargain in terms of fitness and performance.

"I don't know exactly [what happened]. He didn't share much with me. I was more upset seeing Tamim vulnerable. "I feel that Tamim should return with a hundred per cent fitness. We won't hope that he will be thinking about who is on his side or not. We will be thinking that he is a performer who will perform and automatically everything will be on his side," Mashrafe

 $The upcoming World \, Cup \, is \, also \, a \, golden \, opportunity$ for Tamim, having served the national team for a long time. At the twilight of his career, veteran coach Fahim believes that all his focus needs to be on getting the best out of what probably would be his last appearance in the

showpiece event.

"The World Cup is a big occasion and, of course, he would want to perform very well. He is still the captain, as the BCB president said. If there had been criticism of him, what would be best is for him to reply to those criticisms with performances. He is capable of that. If he focuses on other issues, it will make him more vulnerable.

"What's most important right now is to be free of injury so he can play. To be able to answer criticism with performances is the

most satisfying. Another thing is to play well because he may not have that opportunity again, so it has to be seen from the view that it's the best opportunity of his life," Fahim told The Daily Star yesterday.

"Lot of people support him and want him to do well, so he has to borrow strength from within himself, not outside. Injuries have long-term and short-term solutions, and maybe he will discuss the short-term solutions with doctors keeping the World Cup in mind. What will be key now is how much he can focus on his physical fitness.'

Booters' WC Qualifiers fate to be decided today

Bangladesh will get to know their opponents of the first round of joint qualifiers for FIFA World Cup and Asian Cup today when the draw takes place at the headquarters of Asian Football Confederation in Kuala Lumpur.

As the top 27 teams of the AFC region will directly play in the second round of qualifiers, the bottom 18 teams will play in Round 1, on home and away basis on October 12 and 17 respectively. From there, nine winners will qualify for the second round. Bangladesh had beaten Laos 1-0 on aggregate at the same stage in the last edition of the qualifiers for 2022 World Cup after having been beaten 3-1 on aggregate by in 2016 for the 2018 World Cup.

The men in red and green will face one of these nine teams, namely Indonesia (150), Chinese Taipei (153), Maldives (155), Yemen (156), Afghanistan (157), Singapore (158), Myanmar (160), Nepal (175) and Cambodia (176).

Japan, Spain roll into last 16

Rampant title contenders Spain and former champions Japan became the first teams to reach the Women's World Cup last 16 on Wednesday as

Two-times Ballon d'Or winner Alexia Putellas started for Spain following her serious knee injury and played her part in a 5-0 demolition of Zambia.

Japan had been on the brink of reaching the knockout rounds following their 2-0 win over Costa Rica earlier in the day and the Spain result



sent both of them sailing through.

Japan and Spain meet on Monday to decide who wins Group C, and with it a theoretically easier draw. Both have a perfect six points from two games and are yet to concede a goal.

Costa Rica and Zambia play the same day in the fight to avoid finishing bottom of the pile.

Teresa Abelleira put Spain, 3-0 winners over Costa Rica in their World Cup opener, ahead after nine minutes with one of the best goals of the tournament vet.

Jennifer Hermoso made it 2-0 four minutes later and Spain coach Jorge Vilda rang the changes at the break with an eye on the Japan clash and the last 16. Hermoso scored again in the second half and substitute Alba Redondo also got a brace as Spain added gloss to the scoreline.

The 2011 champions Japan similarly beat an error-prone Costa Rica comfortably in front of 6,992 spectators in Dunedin, the smallest crowd at the tournament yet.

The game was effectively killed off in the space of three first-half minutes with goals from Hikaru Naomoto and 19-year-old Aoba Fujino.

OFFSHORE GAS EXPLORATION

Cabinet approves new guidelines

The cabinet committee on economic affairs yesterday approved the draft of the production sharing contract (PSC) for offshore gas exploration that Petrobangla insists ensures a fair deal for both the government and the international oil companies (IOCs)

The draft was designed to make offshore gas exploration attractive to IOCs and prepared in consultation with Wood Mackenzie, a UK-based global insight business for renewables, energy and natural resources.

Wood Mackenzie studied the PSCs of eight peer countries --India, Myanmar, Bulgaria, the Philippines, Malaysia, Vietnam, Sierra Leone and Papua New Guinea and made suggestions to the initial draft prepared by

The new PSC is based on the sliding scale R-factor profit-sharing model. The R-factor is calculated by dividing total contractor receipts by total contractor expenditures.

The government's profit share can be a minimum of 40 percent and a maximum of 65 percent in the case of

shallow blocks. For deep blocks, it would be a minimum of 35 percent and a maximum of 60 percent.

In the previous PSCs, which were based on gas production, the government's profit share was a minimum of 55 percent for shallow blocks and a maximum of 80 percent. For deep sea blocks, it was a minimum of 50 percent and a maximum of 75 percent.

Due to the prolonged nature of cost recovery, the IOCs' profit share progressively declined under the previous models. This discouraged them from investing adequately, The Daily Star has learnt from Petrobangla officials with knowledge of the matter.

Subsequently, Petrobangla's invitation for gas exploration in the maritime territories gained in 2012 and 2014 from Myanmar and India respectively barely found any takers despite floating the tender three times.

Contracts were signed with a handful of IOCs but they abandoned the project after just the seismic survey as they did not find the terms of the PSC attractive, Petrobangla

In the new PSC, the cost recovery ceiling for IOCs is 75 percent per year for both shallow and deep-sea wells. The ceiling was 55 percent for shallow wells in PSC 2012 and

70 percent for deep wells in PSC 2012 and 2019. "In determining the profit share between the government and the IOC through R-FACTOR, all revenue and expenses of the IOC are considered after the signing

of the contract," Petrobangla officials said. In the case of new investment by IOC, the R-factor is reduced, so it is possible to quickly recover the invested

"Due to fast cost recovery, the government's profit share also increases."

Since the new PSC has been designed to be gainful for IOCs, they would be more interested in exploring Bangladesh's offshore resources and there is an opportunity to discover new gas fields.

"This is why the R-factor is considered a win-win for both parties," said a Petrobangla official preferring to remain unnamed.

Another attractive feature of the new PSC is the gas price at well head, which would be 10 percent of Brent.

Politics can't be a moneymaking tool

HC observes in full text of verdict, affirms 9yrs' imprisonment for BNP leader Tuku for graft

Politics cannot be a tool to make money and amass properties, and if the politicians indulge in corruption, the entire society will plunge into darkness, the High Court said in the full text of a verdict.

"Being protectors, the politicians cannot be the predators This court wishes that those involved and engaged in politics should not run after money and properties.'

"If the politicians own a huge amount of properties and money, they have to spend a lot of time of their life to sustain them and in that case, they would have little time to work for the people's welfare and the country as well," the bench of Justice Md Nazrul Islam Talukder and Justice Khizir Hayat Lizu said in the 273-page full text of the judgment released yesterday.

On May 30, the bench delivered the verdict affirming the trial court judgement that on November 15, 2007, convicted and sentenced BNP leader and former state minister Iqbal Hassan Mahmood Tuku to nine years' imprisonment for amassing wealth illegally and concealing information in his wealth statement.

The special anti-graft court also fined him Tk 50 lakh and directed the government to confiscate his wealth worth over Tk 2.24 crore which is disproportionate to his known sources of income. In default, Tuku will have to spend another one year behind bars, the court said.

ACC lawyer Khurshid Alam Khan told The Daily Star that Tuku, who had been on bail till the delivery of the HC judgment, cannot take part in elections as per article 66(2) (d) of the constitution following the HC verdict.

In the full text of the verdict, the HC directed Tuku to surrender

Labourer, wife found dead in capital

Relatives say death of child, financial hardship weighed heavily on them

The bodies of a couple were recovered from a tin-shed room in the capital's East Rampura in early hours yesterday.

They were found hanging from a ceiling fan in the room, said Rafiqul Islam, officer-in-charge of Rampura Police Station.

The husband Jewel Mia, 28, was a day labourer while his wife Nasrin, 22, was a domestic help.

The deceased couple were depressed after the loss of their child eight months ago. Married for around four years, the couple were expecting their first child, but Nasrin, who was from Kishoreganj, gave birth to a stillborn baby, said relatives.

Things went from bad to worse for them as their financial problems increased after the incident. Financial hardship might have led them to take their own lives, they added.

Nasrin's brother Titu Mia said Jewel had to take a loan of Tk 30,000 to meet the hospital expenses during his wife's stillbirth.

"Every month, Jewel had to pay Tk 3,000 as loan instalment and Tk 3,500 as room rent besides their daily expenses. But he didn't have a regular

Bangladesh among first 4 countries to get ChatGPT Android version

OpenAI has launched the android version of its popular artificial intelligence chatbot ChatGPT.

It made ChatGPT available for android users to download in four countries of the world: the USA, India, Bangladesh and Brazil.

The American AI research and deployment company said it plans to expand the rollout to additional countries over the next week, according to the company's website.

OpenAI released the iOS version of ChatGPT in May 2023.

ChatGPT is estimated to have reached 100 million monthly active users in January, just two months after launch, making it the fastest-growing consumer application in history, according to a

The report, citing data from analytics firm Similarweb, said an average of about 13 million unique visitors had used ChatGPT per day in January, more than double the levels of December, according to Reuters.

Modi's govt faces no-confidence vote over ethnic clashes

India's parliament yesterday authorised a no-confidence vote against Narendra Modi's government by an alliance of opposition parties, to force the prime minister to address in detail concerns about ethnic clashes in a northeastern

Modi's Bharatiya Janata Party (BJP) has a clear majority of 301 members in the 542-seat lower house of parliament, so the no-confidence vote will not affect its stability.

The opposition instead wants to trigger a debate about violence in the remote, BJP-ruled Manipur state, where more than 130 people have been killed and 60,000 displaced since it began in early May.

Approving the opposition motion, lower house speaker Om Birla said he would soon decide when the debate and vote would take place.

The ethnic tensions in the small state of 3.2 million people are seen as a rare security and political failure by Modi's government, which will face a national election by

Further incidents of arson and the destruction of some abandoned houses, government offices and vehicles by armed mobs were reported from at least two districts of Manipur on Wednesday, a local police official said, asking not to be named.

Modi had not commented in public about the violence until last week, when videos showing two women being paraded naked and molested by a mob in Manipur sparked national outrage.
