# **BNP** plans big push from big rally

Fresh programmes may begin Sunday

A charged-up BNP plans to stage a big show of strength in front of the party's Nayapaltan headquarters today after the police finally gave it the

However, party leaders asked BNP supporters, who started arriving in the capital in droves from across the country, to avoid confrontations and to remain alert to any instigation.

Talking to The Daily Star, a number of top BNP leaders vesterday said they already have a "strategic win" against the government's initial decision to not allow their rally.

At the same time, they are concerned about the possibility of the ruling party activists creating "anarchy" and then blaming it on them. The BNP is yet to finalise its next course of action to drive home its one

Although BNP's long-time ally Jamaat-e-Islami is not involved directly in BNP's movement, Jamaat leaders said they extended moral support to the BNP's programme. Other like-minded parties will also hold rallies at 11 places in the capital



point demand for holding the election under a non-party government, as its top brass wants to give a final push before the announcement of the national election schedule, expected in October.

BNP Secretary General Mirza Fakhrul Islam Alamgir is likely to announce BNP's next course of action at today's rally, scheduled to begin at 2:00pm.

At the rally, the party may announce a series of Dhaka-centric fresh street programmes including demonstrations, rallies, sit-ins and barricades, although a final decision about the fresh programmes will be made today, party sources said.

"We will announce our programmes to fulfil people's expectations," Amir Khosru Mahmud Chowdhury, standing committee member of the party, told The Daily Star yesterday.

He, however, said the way the ruling party is announcing counter programmes is simply "provocative" and is meant to create a "hostile"

Although BNP's long-time ally Jamaat-e-Islami is not involved directly in BNP's movement, Jamaat leaders said they extended moral support to the BNP's programme. Other like-minded parties will also hold rallies at 11 places in the capital today.

BNP sources said that holding the rally peacefully will be a big challenge, which is why the party instructed its leaders and activists not to engage in any clash with the ruling party men.

The Awami League said its leaders and activists will take position in every ward of the city today.

After getting the permission on 23 conditions vesterday afternoon. BNP leaders and activists had started gathering in front of the party headquarters in Nayapaltan. But the high command asked them to leave the venue as a large number of law enforcers took position there.

## AL to be on guard across the capital STAFF CORRESPONDENT

The ruling Awami League has made preparations to ensure a large gathering at its "peace rally" near the south gate of Baitul Mukarram today.

Leaders and activists of AL's city units will be at their offices and in the neighbourhoods so that BNP activists do not launch a blockade, try to lay siege to any important government facility, and "create unrest".

They, however, were also asked not to stop BNP activists from joining their rally at Nayapaltan, according to Abu Ahmed Mannafi, president of Dhaka City (south) AL.

Since the top AL leaders want to see at least two lakh people at the event, activists from the districts adjoining Dhaka were asked to attend the rally.

The AL rally, organised by Jubo League, Chhatra League and Swechchhasebak

League, will begin at 2:30pm. AL's associate bodies first announced

#### Polls schedule likely in late Oct: CEC

Chief Election Commissioner Habibul Awal yesterday said the schedule for the 12th parliamentary election could be unveiled in the last week of October.

"If we don't announce the schedule in October, then we will have to do it in November since there is an obligation to hold the election within 90 days," he told The Daily Star last

According to the constitution, the national election must be held within 90 days before the five-year term of the parliament expires. The 11th parliament began its first sitting on January 30,

The CEC said, "There was neither any discussion in the commission about the schedule nor any decision was made regarding it," he added.

The Daily Star talked to the CEC after he told a television channel that the schedule of the next polls

## Journos to blame for foreign envoys 'bossing us around' Says Momen

Foreign Minister AK Abdul Momen yesterday said special briefs on various issues have been prepared and will be given to foreign countries so they can have a better understanding of Bangladesh.

This, he said, would help the countries refrain from making "ignorant" remarks on Bangladesh.

M o m e n said this while speaking reporters after a book launch at the Service Academy in the capital.

He also said

foreign diplomats in Dhaka are "extra active" and "boss around" due to journalists' activities.

He made these remarks a day after the government expressed dissatisfaction over the joint statement issued by 13 foreign missions condemning the attack on Hero Alom, an independent candidate in Dhaka-17 by-polls. The government termed the statement a "violation" of diplomatic norms and urged all missions to refrain from such behaviour.

"Journalists should see the good sides [of Bangladesh] ... Due to them,

## **DENGUE OUTBREAK** 178 dead in July alone

Late hospitalisation, reinfection to blame for death rate, say experts

With 10 new deaths recorded yesterday, 178 people have died from dengue just in the month of July.

The number is just one shy of the total deaths in all of 2019 when dengue reached epidemic proportions with over one lakh patients.

According to the Directorate General of Health Services, apart from the new deaths, 2,361 people were hospitalised in the 24 hours till yesterday morning. Since January this year, 225 people

have died from the mosquito-borne virus. The number was 281 last year, 105 in 2021, seven in 2020 and 179 in 2019. and Experts doctors attributed this year's death rate to late

hospitalisation and re-infections. Fluid intake is the main treatment for dengue patients, they said, adding that in most cases, blood and platelets

transfusions are not needed. They suggested that those diagnosed with dengue at home take sufficient amounts of fluids and consider SEE PAGE 2 COL 5

## PM to open Matarbari power plant in December

Officials say; 600MW to be added to nat'l grid

UNB, Dhaka

The first unit of Matarbari coalfired power plant in Cox's Bazar's Maheshkhali is likely to go into production by December this year, adding 600MW of electricity to the national grid.

Prime Minister Sheikh Hasina is expected to inaugurate the plant, project officials told reporters recently. A ship carrying 64,300 tonnes of


coal arrived from Indonesia on June 23. While visiting the area recently, it was seen that the project implementing company, Coal Power Generation Company Bangladesh Limited (CPGCBL), is going ahead with the work of the mega project. The work on the jetty and the power plant is almost complete.

According to sources, 95 percent of the jetty and physical infrastructure work has been completed and 90 percent of the overall physical infrastructure work has been done.

Nazmul Huq, executive director of the power plant project, said the prime minister will inaugurate it in December.

So, you live in Dhaka? Must be so awful with the traffic! You are from Dhaka? It is so costly! Is it even safe? The air pollution, sound pollution, crowd, so much crime...

These are among the common complaints and concerns a lot of people who do not live in Dhaka raise about this city. Not that they are wrong, but they cannot look beyond these issues. "Why would anyone want to live in such a miserable city?" they ponder.

I listen to them with a smug smile, because, you see, if you are from outside the capital, you will never understand the love we have for it. You can never fathom the power this seemingly ugly city has over us.

In other words, you will never be able to make any sense of Dhaka if you have never lived here.

One may say that this city has a bad PR; a terrible reputation. Just turn on

the news, and Dhaka is often portrayed as a horrible, impossible place.

Even Dhakaiites rant on Dhaka; but when we are outside for a few days, we get homesick and also get bored soon

Since you do not live here, all you can make of it is traffic congestion, politics, and high-rise buildings. But there is so much more!

Granted, our city has its problems but Dhaka is not without charms: diverse people from all over the country with so many ideas, thoughts, and tastes, and preferences; the old part of the city bearing history; the vibrancy; the pace, even the hustle and bustle.

At first impression, Dhaka has a hardened character -- somewhat rude, at times cruel as well. It is like that cranky fellow nobody likes in their first meetup, but eventually, like an old soul, it grows on you, slowly starts to show generosity, and guides you with its wisdom.

Here is food for thought: does Dhaka

deserve so much blame? Just imagine the burden this one city has on its shoulders. Think of the population alone! And yet, Dhaka does not say no to anyone. Dhaka welcomes. Dhaka accommodates. Dhaka endures.

According to the case statement, followers of Ramzan attacked the victim Mithun Ali, general secretary of Natore municipality ward-3 Jubo League in Balaripara of the town around 9:30pm on Sunday and cut off his hand from the wrist.

At the time, Ramzan and Bablu were allegedly present at the spot.

#### Foreign liquor seized from Maitree Express

 $Customs\,Intelligence\,and\,Investigation\,Directorate$ (CIID) seized 162 litres of abandoned foreign liquor from Maitree Express in Dhaka.

A CIID team carried out a drive after the train arrived at Dhaka Cantonment station from Kolkata around 4:15pm on Tuesday and recovered the illegal liquor from under some seats and the false ceiling of the staff coach of the train, CIID Deputy Director Sanjida Khanam told The Daily Star on Wednesday.

The team also recovered an additional 27 litres of liquor from a locked room at the station and 15 litres from an Indian national, she said.

The CIID official said they will soon write to he Indian authorities concerned informing then about the issue.

He said the missions in different countries will share the briefs to let them learn about Bangladesh. "The Bangladeshi diplomats have a big role to play here so that they [foreigners] can act sensibly.'

About the 13 missions in Bangladesh, including the Italian one, making a joint statement condemning the attack on Hero Alom and whether the issue was raised during Prime Minister Sheikh Hasina's recent Italy visit, he said, "No, we did not raise any such issue during her visit for the sake of decency."

"Such rubbish should not be discussed and they should understand that."

About many politicians themselves going to foreign diplomats, Momen said, "This culture has been going on for years and we don't like it.'

"If a patient is stable with even a 5,000 platelets count, we do not prescribe transfusion ... Patients experiencing dengue shock syndrome are first given crystalloid fluid and then colloid fluid. If the patient's blood pressure or hematocrit [volume of red blood cells] do not improve from those, then we move on to blood transfusion.'

Prof Ahmedul Kabir, additional director general of DGHS and secretary general of Bangladesh Society of Medicine, said, "Rather than platelet count, blood pressure is a more significant parameter for a dengue patient to know the extent of severity. It's possible for people to get treatment announced," the CEC added.

#### 3 die as boat with bridal party capsizes

Three people of a bridal party died when a boat capsized in a beel in Tangail's Mirzapur upazila yesterday.

The deceased are the groom's elder brother Ripon Miah, 40, from Mandirapara village in the upazila; the groom's cousin Sneha, 8, of the same village; and Asif, 20, of Haria village.

Tarafpur Union Parishad Chairman Aziz Reza said after lunch at the bride's residence, some bridal party members left for home on a boat.

On the way, several passengers saw a snake in the water and started panicking. As the snake moved towards the boat, they started fidgeting, which led to the boat's capsize. Many were able to swim ashore but the three drowned. Later, locals recovered the bodies.

Belayet Hossain, station officer of Mirzapur Fire Service and Civil Defence, said they came to know about the accident. However, since it was evening, it was not possible to send divers to the spot, he said.

Mirzapur Police Station OC Abu Saleh Mohammad Masood Karim told The Daily Star that a local UP member informed him of the incident. No case has been filed in this regard yet.

## WORLD HEPATITIS DAY Hepatitis a silent killer

"I did not know I had hepatitis C, not even during my pregnancy," said Muslima Kader Mili, a 35-year-old

The Brahmanbaria resident found out she had the virus in 2013 when doctors did her blood work, as she was one of the potential donors for her daughter, who needed to undergo an operation at Shaheed Suhrawardy Medical College Hospital in the capital.

"That day, the doctors informed me of the virus and how the blood transfusion would also infect my child. I had never heard of any such virus before," she added.

Mili had to take seven units of blood during her first C-section at Dhaka Medical College Hospital in 2002 as she developed eclampsia. "I must have been infected during that time.

However, none of my children have the virus," she said.  $According \,to \,doctors, he patitis \,C \,can \,be \,transferred$ from mother to child but it is not contagious. Nevertheless, many in Mili's family

neighbourhood were unaware of the virus. But suggested alternative treatments by village quacks and homoeopathy, as the medicinal treatment for hepatitis C is expensive.

Marzia Begum, another 25-year-old mother of two, shared a similar experience.

"I did not know that I had hepatitis B when my first child, now 11 years old, was born. However, I got to know of my condition when my second child, a girl, was born in 2019," she said.

The virus was passed on to her daughter Lamia, the second born.

Mili, Marzia, and Lamia are currently receiving free treatment at the National Liver Foundation Bangladesh (NLFB) under their Zakat Fund programme.

According to WHO, hepatitis is an inflammation of the liver that is caused by a variety of infectious viruses and noninfectious agents leading to a range of health problems, some of which can be fatal.

The virus has five variants -- A, B, C, D, and E. The A and E variants can be transmitted through food and drinking water but usually resolve within 4-8 weeks through the body's built-in immune system, informed Dr Mohammad Ali, liver surgeon

and founder of NLFB. E variant can cause complications during

#### HC tells Cox's Bazar judge on granting bail to 9 accused without due process

The High Court vesterday said judiciary will suffer if a judge does not follow the due process of law.

The HC said this to Cox's Bazar District and Sessions Judge Mohammad Ismail in regard to granting bail to nine accused without due process.

"You are a senior judicial officer. If you had followed the due procedures [in granting bail to nine accused] no question would have been raised. What you have done is not expected of anybody. Don't repeat the mistake," the HC bench of Justice Md Habibul Gani and Justice Ahmed Sohel said.

Earlier in the day, Judge Ismail appeared before the bench while hearing a criminal revision petition in compliance with its previous summons order.

He also offered unconditional apology before it for granting bail to nine accused of a criminal case even before the magistrate court rejected their bail petition.

The bench accepted his apology and exonerated him from its proceedings.

# Renovated in 2020, deteriorated by 2023

DIPANKAR ROY, Khulna

Dilapidated, riddled with potholes, and patches of deteriorated bitumen -- such is the situation of Khulna-Satkhira regional highway.

Repaired in 2020 spending Tk 160 crore, the road was damaged significantly within just the next three years, with the 33km Khulna section of this 64km road being the most defaced.

The status quo has sparked public outrage as locals and project insiders allege the use of substandard materials during its construction.

Meanwhile, the Roads and Highways Department blamed the frequent plying of heavy vehicles, mostly stone-laden trucks from Bhomra Land Port in Satkhira who use this road to enter the capital, for the road's miserable

The bitumen (a black, viscous mixture of hydrocarbons used for road surfacing) rutted in some places, creating small holes on the

surface. "The bitumen began to deteriorate within a year of renovation, leading to frequent accidents. Such poor work quality is disappointing," said Nittananda Mondal, a resident of Dumuria's Bandha village.

The uneven road surface makes it difficult for drivers to maintain control over their vehicles, said Biprodas Bairagi, a rickshaw vanpuller of Batiaghata upazila's Chaksailmari area, who uses the road to transport goods to Gallamary.

"Speeding buses and goodsladen trucks multiply the risks,' he added.

# 1,320MW power plant to come on stream next June

SOHRAB HOSSAIN, Patuakhali

Another 1.320MW coal-based thermal power plant is in progress in Patuakhali's Kalapara area. The first of its two units (660MW each) will come on stream in June 2024 and the second unit in October.

The under-construction power plant is located on the banks of the Ramnabad River, just two kilometres north of the 1,320MW Payra Thermal Power Plant in Patuakhali.

Rural Power Company Limited (RPCL) is implementing the project.

Project director Taufiq Islam said the physical progress of the project is 73 percent and the financial progress is 51 percent till June this year.

According to RPCL sources, 915 acres of land in Nishanbaria, Dhankhali and Londa villages of Dhankhali union ol Kalapara upazila have been acquired for this project, but the infrastructure construction work is progressing on 500

The physical structure of the first unit including boiler, main power house, turbine, generator hall has already been completed.

Besides. chimney, central control room, laboratory, fuel oil storage, water storage, transformer grind, fly ash silo, fuel-well pump, rain water reservoir, fire station service and firefighting water tank, regular and irregular waste water storage basin, infrastructural works of administrative building, engineering building, multipurpose hall, workshop, mini fire station have also been completed.

Construction of jetties for

conveyor belts for bringing coal from ships is also underway in the project area. The main equipment of the project -- including the main transformer -- has also been installed and some goods are in the process of discharge at Chattogram

Sources also said currently 5,979

loading-unloading coal and 1,320MW Payra Thermal Power Plant has been operational since last year while the construction work of RPCL and Ashuganj power plants are ongoing; and the RPCL's work is almost at the end.

The legal system lacks independence from the government, which directs judicial appointments. Other pillars of the justice system such as the police are also closely aligned with the ruling political party.

Arbitration and dispute resolution are limited by the fact that the timeframe is unpredictable with many taking years. Moreover, arbitration results are unevenly enforced by the courts, which appear to show a bias against foreign investors, it said.

"Corruption remains a serious impediment to investment and economic growth."

Bangladesh is a party to the UN Anticorruption Convention and has laws to combat bribery, embezzlement, and other forms of corruption, but enforcement is inconsistent.

"Corruption is common in public procurement, tax and customs collection, and among regulatory authorities. Off-the-record payments by firms reduce Bangladesh's GDP by 2 to 3 percent, according to some

estimates. The current Awami Leagueled Government publicly states its commitment to fighting corruption, but opposition parties claim the ACC is used by the government to harass political opponents, it said.

Government efforts to ease public procurement rules and a constitutional amendment to diminish the independence of the Anti-Corruption Commission, the main institutional anti-corruption watchdog and investigator in cases of bribery and corruption, may undermine institutional safeguards against corruption.

"Although Bangladesh moderate, traditionally secular country, political disturbances are likely to grow in size and intensity as national elections approach in late 2023/early 2024.'

In the last general election in December 2018, Prime Minister Hasina's ruling Awami League party won 289 parliamentary seats out of 300 in an election marred by widespread vote-rigging, ballot-box stuffing, and intimidation.

"Harassment and violence during the pre-election period made it difficult for opposition candidates and supporters to meet, hold rallies, and campaign freely. Civil society groups are widely concerned about the trend toward a one-party state and the marginalisation of all political opposition groups."

The One Stop Service Act (2018) gave responsibility for attracting foreign investments to four investment promotion agencies: Bangladesh Investment Development Authority (BIDA), Bangladesh Export Processing Zone Authority (BEPZA), Bangladesh Economic Zones Authority (BEZA), and Bangladesh Hi-Tech Park Authority (BHTPA).

"These agencies offer some streamlined services, but corruption and excessive bureaucracy have held back the complete and effective rollout of the One Stop Service Act.'

To encourage investment, the government has offered incentives, guarantees and tax breaks (e.g., no value-added tax on exports, tax holidays for certain industries).

Charges for unfair labour practices are rarely brought against employers for violating labour rights, but workers in unions have been subjected to police violence, mass dismissals, and arrests of union leaders for asserting their rights to protest, according to labour rights groups.

Companies frequently discourage prevent the formation of worker-led labour independent preferring pro-factory unions, management unions.

Labour organisations reported most workers feared reprisal if they exercised their rights to form unions, attend meetings or bargain collectively with employers.

The government reports over 1,000 registered trade unions, but labour leaders estimate less than 200 active trade unions are in the country's dominant export sector, garment, and only 30 to 40 of these engage in collective bargaining negotiations because union activities are inhibited intimidation, corruption violence.

"In view of the evidence as discussed earlier we have no hesitation to hold that Dr Mohiuddin, a highly educated man and associate professor of Rajshahi University, only for the purpose of getting promoted to professor annihilated Dr Taher from this world presuming that if Professor Taher lived, the chance of his getting promotion would be zero," said the verdict.

Prof Taher went missing from his home on the campus on February 1, 2006, when he was aged 59.

## Earth in 'era of global boiling'

#### Warns UN chief as July set to be hottest month on record

July 2023 is set to upend previous heat benchmarks, UN Secretary-general António Guterres said yesterday after scientists said it was on track to be the world's hottest month

The UN World Meteorological Organization (WMO) and European Union's Copernicus Climate Change Service also said in a joint statement it was "extremely likely" July 2023 would break the record.

"We don't have to wait for the end of the month to know this. Short of a mini-Ice Age over the next days, July 2023 will shatter records across the board," UN Secretary-general António Guterres in New York said.

"Climate change is here. It is terrifying. And it is just the beginning," he told reporters, adding "the era of global boiling has arrived"

The effects of July's heat have been seen across the world. Thousands of tourists fled wildfires on the Greek island of Rhodes, and many more suffered baking heat across the US Southwest. Temperatures in a northwest China township soared as high as 52.2C (126F), breaking the national record.

While the WMO would not call the record outright, instead waiting until the availability of all finalised data in August, an analysis by Germany's Leipzig University released yesterday found that July 2023 would clinch the record.

This month's mean global temperature is projected to be at least 0.2C (0.4F) warmer than July 2019, the former hottest in the 174-year observational record, according to

The margin of difference between now and July 2019 is "so substantial that we can already say with absolute certainty that it is going to be the warmest July", Leipzig climate scientist Karsten Haustein said.

July 2023 is estimated to be roughly 1.5 degrees Celsius (2.7 Fahrenheit) above the pre-industrial mean. The WMO has confirmed that the first three weeks of July have been the warmest on record.

Commenting on the pattern, Michael Mann, a climate scientist at the University of Pennsylvania, said it was clear by mid-July that it was going to be a record warm month, and provided an "indicator of a planet that will continue to warm as long as we burn fossil fuels".

# Niger military chief backs coup leaders World condemns

Niger's armed forces chief yesterday declared his support for troops who said they had overthrown the government, despite a defiant stand by the country's elected president and an outcry from the world community.

The latest target of a coup in the deeply troubled Sahel, President Mohamed Bazoum was confined at his residence on Wednesday by members of his presidential guard.

Hours later, their leaders, calling themselves the Defence and

Security Forces (FDS), declared they "decided to put an end to the regime," and all institutions were being suspended, the borders closed and a nighttime curfew imposed.

Armed forces chief General Abdou Sidikou Issa yesterday swung his weight behind the putschists.

"The military command... has decided to subscribe to the declaration made by the Defence and Security Forces... in order to avoid a deadly confrontation between the various forces," he said in a statement.

Earlier, Bazoum defiantly stood his ground as condemnation of the putsch swelled from African and international organisations and allies France and the United States.

"The hard-won (democratic) gains will be safeguarded," Bazoum said on Twitter, which is being rebranded as X.

"All Nigeriens who love democracy and freedom would Foreign Minister Hassoumi

Massoudou said Niger's "legal and legitimate power" was the one exercised by its elected president.

## Doksuri kills 25 ferry passengers off Manila

Storm headed to China

Doksuri regained super typhoon strength vesterday in its final approach to southeastern China after pummelling Taiwan and the northern Philippines with rain and strong winds that led to the capsize of a ferry in which at least 25 people

As of 5:00 pm Beijing time (0900 GMT), the winds around the eye of the storm had reached up to 187 km per hour (116 mph), putting Doksuri back on the top rung of China's tropical storm categorisation system after weakening earlier.

The ferry sank near the Philippine capital of Manila after passengers alarmed by strong winds rushed to one side of the boat, overturning it. As many as 36 people have been killed this week during Doksuri's transit off the northern Philippines.

Doksuri is expected to make landfall in China on this morning somewhere between Dongshan and Putian in the southeastern province of Fujian.

The China Meteorological Administration forecast that Doksuri would be weaker than 2016's Typhoon Meranti, the strongest storm to hit China's coast since 1949 which killed at least 11 people.

#### 900 migrants drowned off **Tunisia** this year

More than 900 migrants have drowned off Tunisia's coast so far this year as they tried to reach Europe by boat, the North African country's government said yesterday.

The interior ministry said 901 bodies had been recovered by July following maritime accidents Mediterranean Sea.

National Guard spokesman Houcem Eddine Jebabli earlier reported that almost 800 migrants had died by late June, and that more than 34,000 had been intercepted and rescued, most of them from sub-Saharan Africa.

Coastguard units had carried out over 1,300 operations -- more than double the number of missions for the same period last year.

Over 550 "organisers and intermediaries" of human trafficking had been arrested so far this year.

## A welcome step to utilise the diaspora

### Govt must build an effective mechanism to support its policy

The government's decision to formulate a policy with the broad objective of including the Bangladeshi diaspora community in its "march towards development" and ensuring their wellbeing is a step in the right direction. As per the draft Bangladesh National Diaspora Policy-2023, the diaspora includes those "Bangladeshi individuals who obtain citizenship of another country or their citizenship status is under process or are permanently living in another country or were born as Bangladeshi-origin or grew up in another country." At a recent workshop, the expatriates' welfare minister also confirmed the policy objective, underscoring the importance of involving Bangladeshis living abroad in the country's development journey.

It is an unfortunate reality that over the years, there has been a massive amount of "brain drain" out of the country. The policy could, in some ways, reverse that as, if properly implemented, it could encourage those Bangladeshis to share their knowledge and expertise leading to a significant boost in the country's development speed. According to a 2021 study of the International Organisation for Migration (IOM), there could be an estimated 2.4 million Bangladeshi diaspora members with the UK and the US alone. Therefore, it can be assumed that the total number of Bangladeshis living abroad is huge. Even if a small portion of them contribute their skills and expertise, it could make a huge difference.

Additionally, the government will be reportedly looking to facilitate investment opportunities for those living abroad, and the policy will act as a tool to encourage Bangladeshi diaspora to send remittance through authorised channels. This, too, could make a massive difference for our economy. However, it is essential that the government establishes an effective formal framework to complement the policy, which would allow Bangladeshis abroad to make the maximum contribution in terms of our financial, economic and entrepreneurial needs.

If we take the case of India, it too has had a similar policy in place for more than two decades. And the reason why it has been successful is because of the foundational blocks that the country's government has managed to lay down over the years. Similarly, we must also develop a strong and transparent system, which makes contributing to the country - whether in financial or intellectual terms – easy, rewarding,

It must be acknowledged that Bangladeshis living abroad are already making a sizeable contribution to our country. It is incumbent upon the authorities to also ensure their wellbeing. We are pleased that the government has recognised this. However, its track record of doing so via its missions in foreign countries is not very satisfying. We hope that besides finalising this policy, the government will successfully establish an accountable mechanism that can guarantee that this is done much better in the future.

## When bridges are not bridge-y enough

#### It shows how poor planning and lax quality control are marring development projects

A bridge is a useful structure, yes, but in Bangladesh's context, it is increasingly emerging as a metaphor for the widening or, shall we say "unbridged"? - gap between the promise and the reality of our development projects. Forget the mega construction projects, where the stakes are much high and are thus better planned and executed. But in small, lowerbudget projects meant to serve local communities – such as bridges, culverts, and roads - the level of scrutiny is not the same. Hence, often they suffer from poor planning and lax quality control, leading to suffering and a wastage of public

Bridge, both as a structure and a metaphor, comes to mind because of the frequent media coverage of poorly designed, district-wide bridge development projects undertaken in recent years. The latest report in this regard, published by this daily on Thursday, highlights how this has been a continuing trend. It reveals the woeful state of two newly constructed bridges, over a canal in Lalmonirhat's Kaliganj upazila, which have been left unfit for use due to the absence of approach roads on either side of the bridges. As a result, both structures - built at a combined cost of about Tk 1.5 crore by the Bangladesh Agricultural Development Corporation (BADC) and the Ministry of Disaster Management and Relief, respectively - have turned out to be nothing more than symbolic structures, failing to serve their intended purpose. Today, they stand as a glaring example of mismanagement and negligence.

The question is, what's the point of building a bridge if there are no connecting roads to make it accessible for the users? A project official, however, claims that there were connecting roads but those were "washed away" by a recent flood, which, ironically, only confirms our suspicion of poor workmanship and lax quality control. It is clear that these bridges and supporting structures were built without their long-term functionality in mind. This is the second time in July that we have had reports of such ill-conceived bridge projects, the first being at the Ajmiriganj upazila of Habiganj, where the lack of approach roads has also left villagers stranded. Last month, The Daily Star also reported how a bridge built five years ago in Tangail's Basail upazila – which then tilted under pressure from floodwaters just before its inauguration – has been left unusable ever since.

These incidents are becoming too frequent to be considered "isolated". Often, such small projects are undertaken without comprehensive feasibility studies and executed in a manner that renders them practically useless after a certain time. This is totally unacceptable. We urge the higher authorities to critically examine this trend and take all measures necessary to stop it.



## How banana fibre can improve coastal women's reproductive health

Bangladesh recently saw a momentous achievement: the making of Kolaboti saree from banana plant fibres. Radhavati Devi, a weaver from Moulvibazar, came up with the idea of making a saree out of the discarded portions of banana plants. There are a number of banana gardens in Bandarban, and the Bandarban district administration has taken the initiative to produce yarn from banana fibre. Banana yarn has also been used to make curtains, mats, bags, pen holders, and other handicrafts. Given the fabric's quality, one could expect that it could also play a vital role in the menstrual hygiene management of women in the country's coastal region.

In rural Bangladesh, menstrual hygiene management is still one of the most tabooed matters. According to a World Bank report from 2018, 77 percent of Bangladeshi women are unaware of proper menstrual hygiene

products, making them susceptible to a variety of health issues. The coastal region is home to 35 million people, or 29 percent of the total population, half of whom are women. A recent research by the Center for Participatory Research and Development (CPRD) revealed that 90 percent of women in the coastal districts of Bagerhat and Satkhira are adversely affected by climate change in terms of their lives and means of subsistence, particularly due to increased salinity intrusion due to sea-level rise. From Shyamnagar upazila in Satkhira and Mongla upazila in Bagerhat, 17 cases involving women aged between 35 and 60 years were chosen for the study. Nearly 64 percent of the respondents in Mongla and 54 percent in Shyamnagar were found to have issues with their reproductive health. Most of them were involved in shrimp cultivation; they worked in the brackish water in shrimp enclosures

According to a 2018 study by the Bangladesh Bureau of Statistics (BBS), 29 percent of menstruating women in Bangladesh use sanitary napkins. High tariff on the raw materials of sanitary napkins makes them unaffordable. The socioeconomic condition of the two areas mentioned above is poor. One pack of sanitary pads in the local market costs between Tk 100 and Tk 300, which most lowincome and socially underprivileged women cannot afford. So, despite the risks, they continue to use old cloth for napkins, which is unhygienic. A campaign by Bangabandhu Sheikh Mujib Medical University (BSMMU) Hospital in 2020 revealed that about half of the women in the country's coastal areas were suffering from pre-

cervical cancer symptoms. In this situation, banana fibre can be a catalyst for change for Bangladeshi women and girls if it is used to make affordable, environmentally friendly sanitary pads. A report on eco-friendly and biodegradable sanitary pads reflected that it could take up to 700 years for the plastic materials used to make sanitary napkins to decompose. Because these disposable menstrual hygiene items generate more than 200,000 tonnes of non-biodegradable waste worldwide each year, they pose a grave risk to the environment.

Furthermore, in Bangladesh, the production cost of each sanitary napkin is about Tk 12, whereas a napkin made from banana plant fibre would cost around Tk 3.5 only. The latter also absorbs water more effectively than cotton because of its unique composition. It is fully biodegradable, environmentally friendly, and has no history of aggravating skin issues or

It takes 10,000 litres of water to produce one kg of cotton. The water footprint of banana fibre is about 5,000-6,000 litres including irrigation, processing and other phases of production. Surprisingly, banana fibre is more absorbent and softer than any other material used for making sanitary pads.

With its eco-friendly biodegradable, comfortable, and economical attributes, fibre may thus be regarded to be an appropriate fibre for the future. To make access to sanitary pads feasible for women in the coastal region, sanitary pad manufacturers can plan to make use of this fibre. Doing so will also promote the Sustainable Development Goal 12 - Responsible Consumption and Production. The day is not far off when the women of Bangladesh's coastal belt will be able to utilise their full potential by ensuring their own reproductive health.

# The old political playbook needs a major upgrade

One of the ways you realise that people are basically the same no matter which corner of the planet they are from is by looking at how they conduct themselves when they wield any sort of power over others. Leaders, especially in countries where terms like "accountability," "transparency" and "good governance" induce allergic reactions among the political elite, follow the same playbook titled "How to remain in power for the next 100 years" and behave in almost identical ways to each other.

Cambodia's recent election is a case in point. On July 23, Prime Minister Hun Sen's ruling party won a landslide victory over, well, an obscure party he once crushed with military forces, whose name most Cambodians probably can't even remember. With various ingenious moves, Hun Sen managed to get his only credible rival, the Candlelight Party, barred from the election over a technicality: they had provided a photocopy of a document instead of the original one while registering. And, naturally, this oversight was far more important than allowing the biggest opposition party to participate, which would have at least provided some legitimacy to the election.

Before that, Hun Sen allegedly used the age-old techniques of arresting and intimidating opposition party members and stamping on the media whenever it became too critical, crippling them financially by imposing massive tax bills. Al Jazeera reported of voters being too scared not to vote as they could be "blacklisted." So fear, intimidation, and harassment with the help of state institutions to wipe out the opposition has been the traditional formula for a sure win in a virtually uncontested contest. One voter likened the situation to a boxing ring with only a lone boxer.

But it is the end result that counts for these leaders, and victory must be attained at all costs. The ruling Cambodian People's Party won 120 of the 125 parliamentary seats.

Before that, in the 2018 election, Hun Sen managed to get rid of his main opposition, the Cambodia National Rescue Party, which had won almost half the votes in the 2013 election. And now, with Candlelight out of the way, the path is as clear as it has been for the last 38 years. Criticism from human rights groups, US visa restrictions, and damning comments by the US Department of State may have put a damper on the victory afterparties, but did not dissuade him from paving the way for his son, Hun Manet, to rule – like a true monarch bestowed with a divine right, leading to another hundred years of sole power.

In keeping with the formula from the playbook, Hun Sen's family has links with more than a 100 companies across all sectors of the economy from agriculture to the media. There are allegations against his party's elites living abroad, and of laundering money by buying huge properties in

There are many leaders who have joined this club of pseudo democracies – sometimes termed "hybrid democracies" – which have all the accoutrements that qualify them for the status of a democracy. These include things like national elections, voter lists, an election commission, human rights commission, judiciary and other constitutional institutions, not to mention an abundance of political rhetoric on how democratic the nation is. Despite having all this grand paraphernalia, a hybrid regime is one that has increasingly autocratic tendencies. Political opponents – the real ones – have to be steamrolled into credible both at home and by the rest total irrelevance by obstructing their of the world.

rallies, making arbitrary arrests, and incarcerating them. Institutions like the election commission and human rights commission have to be made toothless. Meanwhile, all securityrelated bodies - law enforcement, intelligence agencies, etc - are turned into the main weapons to crush political opponents, annoying critics from civil society, and the meddlesome media that is obsessed with corruption. Laws are enacted or amended to help punish anyone who makes the slightest noise that sounds rude to the powers that be.

Unfortunately, one endlessly follow a playbook that has become as outdated as men's baggy pants, and that paints an unflattering picture in front of the rest of the world: embarrassingly low rankings in democracy indices, threats of sanctions like visa restrictions on individuals, and generally being treated like the delinquent student who got caught changing the grades on his report card. For one thing, cronyism and nepotism, which are major spinoffs of following the old playbook, usually get out of control and even the leader cannot do anything to stop the leakage they incur. All kinds of goofups then occur. Obsequious party members may publicly boast of their involvement in manipulating the votes to help a candidate win, the police may chargesheet ghost opponents, banks may be bled dry, relief items may land up in local leaders' homes, and public hospitals may end up with beds but no doctors (or vice versa) at the height of an epidemic. It's a total mess.

Ultimately, it will become more and more difficult to get regular voters to go to the polling centres when there is, as they say, "only one boxer in the ring." Being a constant bully is tiring and lonely - because it is hard to know who your real friends are, or if you even have any, when you are surrounded by greedy lackeys.

Leaders would be wise to throw away the old playbook and get tips from democracies that provide leaders with the greatest power of all: the true mandate of the people, earned through an election that is deemed

#### **PACIFIST FAROOQ**

It has been close to six years since hundreds of thousands of Rohingya faced a deadly genocide by Myanmar's military and fled the country in search of protection and refuge in neighbouring Bangladesh. The Rohingya population has been undergoing persecution, discrimination, arbitrary arrests, and atrocities in Myanmar for over seven decades. Their condition is alarmingly worsening in the squalid refugee camp in Bangladesh, and they are currently facing a significant risk of generational loss due to lack of access to formal education and the loss of their culture, traditions,

As an educator and poet hailing from the Rohingya community, I have had the opportunity to closely observe the students and people living in the refugee camp. I have noticed that the students prioritise learning English and Bangla over Burmese. In fact, for the first three years after arriving in Bangladesh, they exclusively studied English. It took considerable efforts from teachers to get them back on track with the Burmese curriculum taught in community-run schools. Meanwhile, the adults in the camps have taken to watching Bangalee TV shows, listening to Bangalee Islamic preachers, and frequently conversing with one another in Bangla, instead of watching lectures by Burmese scholars and speaking in Burmese. This is quite normal for the people who have encountered bad experiences and fled their homes, as they may wish to turn away from everything that reminds them of "Myanmar." At the same time, it is important for us not to break the chain of our ancestors, in order to be able to exist as a culturally and historically unique and enriched community on this planet.


Due to our isolation from our motherland for more than five years, we are gradually losing touch with our cultural practices that have been passed down from one generation to the next. The traumatic experiences that we faced have left us feeling hopeless and disheartened, with many of us lacking the motivation to preserve our traditions or learn more about them.

Our children and youth have adapted to the local culture to varying degrees, and their lifestyles have changed significantly compared to what they were in Myanmar. For instance, they now wear trousers instead of the traditional *longyi*, which may be due to dress code restrictions imposed by NGOs and INGOs. Rohingya individuals are not permitted to work officially while wearing longyi, and even wearing traditional clothing in public can result in mockery and devaluation. Upon my arrival in the standard of education is quite low. There are no high schools available, except for a few middle schools run by NGOs in some camps. Unfortunately, the teachers in these schools are often not adequately qualified, with many of them not even high school graduates. This is a significant problem that needs to be addressed.

Another issue that we face is that the government has shut down many communitybased schools, including the one where I used to teach. My colleagues and I had established this school using our own funds, with the aim of advancing the education of our generation by having qualified instructors teach the Myanmar curriculum. Unfortunately, our school was also shut down by the government, with their reasoning being that if we taught at our school, students would not attend the schools run by NGOs. So, the lack of encouragement and support for education is yet another factor that contributes to the generational loss of the Rohingya.

Most importantly, all stakeholders have failed to ensure access to advanced studies for us, in Bangladesh and abroad, despite receiving millions of dollars in funding from countries such as the US, the UK, Japan, and Canada. None of this funding has been used to support higher education initiatives. There are numerous students who have passed their matriculation exam in Myanmar and are currently enrolled in community-based schools. It is disheartening to see their potential being wasted within the confines of the refugee camp. They are not recognised and have no prospects for continuing their education or developing specialised skills. This puts us at risk of not having knowledgeable leaders for future

Bangladesh in 2018, I wore a longyi to the office, but a staff member informed me that trousers and a shirt were the required attire in the office, as this was not Myanmar but Bangladesh. I was sent back to my shelter to change into appropriate clothing. In another instance, I remember sitting beside a woman in a CNG-run auto-rickshaw who referred to me as a "geriatric" for wearing a longyi. I felt ashamed and embarrassed, and from that day on, I decided to stop wearing longyi altogether.

This disregard for our culture and traditions has resulted in a generational loss for our entire ethnic group. And what I mean by generation loss is the loss of our traditions, practices, terminology, heritage, and legacy inherited from our forebears, which we embraced and cherished in Myanmar for

Many individuals take pride in speaking a mixture of Rohingya, Bangla, and English terms, which they perceive as being superior. Unfortunately, we have already lost our land and our name – Rohingya – which makes our language the only remaining piece of

It is commonly said that education serves as the backbone of a nation. However, in our camp,

This is not the first time that the Rohingya have become refugees in Bangladesh. In fact, we have been displaced multiple times before. We have never been granted access to higher education, either in Myanmar or in Bangladesh. As a result, we have been experiencing generational loss for decades, in a cycle compounded by our becoming refugees again and again.

In conclusion, besides Myanmar, the UN, the UNHCR and other international community actors are also committing injustice against the Rohingya community in Bangladesh by neglecting our higher studies. We have spent nearly six years without tertiary education, and I have no idea how much longer we will have to be in this dire condition. Indeed, we are fed up with being labelled as the most persecuted minority in the world.

We have suffered enough and our pain must come to an end. It is crucial for the international community to invest a sufficient amount of funds for the preservation of our language, culture, and tradition, and work towards finding a sustainable solution. This should include the provision of scholarships for higher education, just like refugees from many other countries are offered. This is essential to prevent further generational loss for the Rohingya minority.

# Workplace safety for construction workers

All in all, the current state of the rights of construction workers can be deemed to be a violation of the constitutional aim of an egalitarian society as enshrined in the preamble of the constitution of Bangladesh. It is imperative that rights are not only iterated in laws but also enforced.

On 24 June 2023, four construction site workers met gruesome death due to lack of safety standards at the construction sites. According to Bangladesh Workplace Death Report 2020 published by the Safety and Rights Society, 118 construction site workers died in 2020 alone. The reasons for such preventable deaths include electrocution, falling from a height, getting hit by objects, suffocation, etc. This article tries to highlight the rights of construction workers and discuss how these rights are often infringed upon.

In Bangladesh, no specific law exclusively deals with safety of construction workers. However, attention may be given to the following laws- Bangladesh Labour Act, 2006 (BLA), Bangladesh National Building Code, 2006 (BNBC), and Bangladesh Labour Rules, 2015 (BLR). These laws provide guidance for establishing and maintaining a safe work environment, enunciates rules for compensation for death or injury, sets a minimum standard for construction work and design, etc.

construction-related machinery, chapter 6 of BLA prohibits use of defective machinery and mandates their regular monitoring and maintenance. Rule 57 of the BLR further requires employers to pay extra fees for use of dangerous machinery and requires that they provide workers' sufficient safety equipment needed to operate such machineries. Employers cannot make the workers work

equipment and proper training (section 78A of BLA). Section 75 and rule 64 further highlight the need for eye goggles to prevent eye-related hazards and measures to tackle harmful smoke, respectively.

As basic safety kits are crucial in such hazardous work, section 89 of the BLA mandates that every workplace must have sufficient basic medical aid for its workers. This ensures that certain injuries are swiftly treated, and further injuries are prevented. Rule 76 details exactly which ingredients must be present in such medical aid kits.

Section 19 of the BLA ensures compensation for workers who die or sustain injury at the workplace. The amount will be equivalent to the salary or gratuity of 45 days, whichever or settle for lower compensation than what is higher, and will be paid to the respective is required by law. Despite such legal safeguards, the reality is quite grim. According to a survey by Bangladesh Occupational Safety, Health and Environment Foundation, around 228 people suffered work-place related injuries in 2022 alone. The first reason for this high number of accidents is that employers often ignore applicable legal standards and compel workers to work in unsafe conditions. For instance, owners often ignore the standard procedure enunciated in rule 58 of BLR regarding preventing electrocution, which is a primary reason behind deaths of workers at the construction sites. Due to the hardship of getting actual remedies and power disparity with the owners, the workers often stay quiet that workers are less likely to bring actions

### FOR YOUR INFORMATION Remedies against false cases

What could possibly be more distressing than being accused of a crime that someone has not committed? Newspaper reports often note the prevalence of false cases which result in innocent individuals being falsely accused, detained, and harassed. Many spend years in jail before their trial begins, causing families to struggle both financially and emotionally. Mostly, poor, vulnerable, and marginalised communities face unjust burdens trapped within the vicious cycle of power and manipulation. It is imperative that necessary steps are taken to deter this mischief.

There are several provisions in the laws of Bangladesh that provide for the punishment of those who file false, baseless, or vexatious cases. In addition to the special laws, there are two sections of the Penal Code, 1860, namely, sections 211 and 182, that may be used to penalise those who file false first information reports (FIRs) or initiate any fraudulent criminal cases. Generally, in this regard, separate actions must be initiated.

There is however possibility to penalise people who make false accusations even within the same process with the help of section 250 of the Code of Criminal Procedure, 1898. According to this provision, if the charge is found to be untrue and baseless, the court may order the complainant or informant to compensate the accused. In Karimdad v Abul Hossain, the High Court Division held that section 250 of the Code empowers only



magistrate to invoke the provisions while trying a case by him if he finds the accusations to be false, frivolous, or vexatious. On the other hand, sessions courts in India are permitted to use this section notwithstanding comparable rules in the Code of Criminal Procedure, 1973. In State of Rajasthan v Jainudeen Sheikh and Others, the court ruled that section 250 of the Code of Criminal Procedure, 1973 explicitly empowers the magistrates to award compensation under specific situations. The sessions judge may also award compensation in certain instances.

Furthermore, compensation under section  $250\,$ of our Code of Criminal Procedure, 1898 is quite low (generally, capped at one thousand Taka or at five hundred Taka if the magistrate is of the third class). Damage awards in India can extend to the maximum amount of fine that a magistrate is generally empowered to impose. Compensation in Pakistan is capped generally at 25,000 Pakistani Rupees, or 2,500 Pakistani Rupees if the magistrate is of the third class. Considering developments in other countries, it is high time we strengthened our regime for submitting a fraudulent case or filing a false FIR.

False cases with malicious intent require horough screening by authorities to prevent a steady increase in filings. Enforcement of laws against false case filers and compensation for victims are crucial measures to combat this issue. Concerted efforts from lawyers, law enforcement officials, and judges can help reduce frivolous litigations in Bangladesh.

exclusive jurisdiction to make decisions regarding the child. The reason underlying the emphasis on habitual residence is welfare of the children. Bangladesh however is party to none of the treaties.

Ideally, guardianship and custody related decisions should involve assessment of interparent relationships, possibility of cooperation in parenting, domestic violence, or substance abuse histories. Section 17 of the Guardians and Wards Act, 1890 obliges the court to consider the welfare of the minors as a paramount point in deciding guardianship of a minor. When determining child custody, the courts of Bangladesh tend to prioritise the welfare of children as well. In Ayesha Khanum v Major Shabbir Ahmed (46 DLR), the HCD ruled that the paramount need for the welfare of the child supersedes the personal laws that govern the parties. The recent decision by the family court too is an instance of the 'best interests of child' principle.

## Training camp for Asia **Cup in early August**

Bangladesh national cricket team will begin their Asia Cup preparations with the official training camp expected to start in the second week of August.

According to sources, the Bangladesh Cricket Board (BCB) is expected to name a squad of 21-22 members that will head out to Sri Lanka for the Asian challenge on August 26.

The Tigers will take on Sri Lanka in their opening fixture in Kandy on August 31, before making thea trip to Pakistan to face off against Afghanistan in their final groupencounter stage September 3.

Bangladesh head coach Chandika Hathurusingha is expected to return to the country by the first week of August by which he will have his coaching staff to kick-start proceedings.

A fitness camp, where the BCB is likely to have as many as 30 players from the existing pool, is scheduled to begin on July 31 before the official training camp.

The selectors will name the official squad for the Asia Cup by August 6.

The squad is likely to include an additional opener due to ODI skipper Tamim Iqbal's fitness concerns. Rony Talukdar and Mohammad Naim have featured in recent ODIs and either of the two might get the nod.

Another area of concern for the Tigers has been the number seven spot in the eleven.

Bangladesh's U-16 women's team faced strong teams like Japan, North Korea, and Australia in the AFC age-group tournament, but the senior team never played against top teams like Japan and Vietnam, ranked 11th and 32nd in the FIFA rankings, respectively.

Maria Manda, Krishna Rani, Chakma, Shamsunnahar, Sanjida Akhter, Sheuli Azim, and others had once played against Japan's age-group sides.

"Personally, I am really excited to play against Japan because it is going to be a great experience for me regardless of the outcome," Bangladesh captain Sabina Khatun told The Daily Star. "Overall, it will be a great experience for the girls who will also learn something new by taking part in the Asian Games."

Meanwhile, Bangladesh Olympic team, comprising three senior players along with U-23 squad, have been grouped alongside hosts China (80th in FIFA Ranking) and India (99) and Myanmar (160) following a separate draw held in China yesterday.

In the Asian Games, Bangladesh made it to the second round for the first time during the 2018 edition. This time around, Bangladesh announced a comparatively depleted squad due to players' commitments with Bashundhara Kings and Abahani in AFC Champions League and AFC Cup. respectively.

## Marchand wins 200 IM world title

France's Leon Marchand won the men's 200m individual medley on Thursday for his third gold medal of swimming's world championships.

Marchand won in a time of 1min, 54.82sec, ahead of British pair Duncan Scott on 1:55.95 and Tom Dean on 1:56.07.

"I feel amazing," Marchand said.

"It's been very big for me. I'm very happy with the time and with the win today."

The result gave Marchand an individual medley gold double, having won the 400m event in stunning fashion on the opening night.

He came home in 4min, 02.50sec to break American great Michael Phelps's 400 IM world record, which had stood since the 2008 Beijing Olympics.

Marchand followed that up by winning the 200m butterfly on Wednesday night.

## Putin promises free grain to nations

SPOT THE BIRD! ... Hidden behind the grass, this Indian Stone Curlew, otherwise known as the Indian thick-knee, was spotted roaming Padmar Char in Rajshahi. As one can see, these birds are gifted with an appearance fit to camouflage themselves in their habitats – dry areas, including fields, deciduous forests, and dry riverbeds in south and southeast Asian countries. In such places, they also find plenty of food like insects, worms and small reptiles. Indian thick-knees, named after their stout legs and thick knees, are mainly active and make their calls after dark. During the rest of the day, they prefer to remain out of sight. Though they are listed in the "Least Concern" category by the IUCN, Indian thick-knee populations have been seeing a decline throughout the last decade – possibly owing to habitat destruction.
