Sit together to end crisis

CEC urges political parties

The current political crises cannot be resolved on the streets and it has to be done through dialogues between the parties, Chief Election Commissioner Kazi Habibul Awal said yesterday.

"The Election Commission believes that political parties should sit together at a table and have tea," Awal told reporters at his office in the capital's Agargaon after meeting US Ambassador Peter Haas.

'We hope that many of the issues in the political arena will be resolved at any cost. May political stability return."


With the parliamentary election only months away, the Awami League and the BNP are sticking to their guns on a key issue.

The BNP says no acceptable election is possible under the AL government while the latter insists that a free and fair election is possible only under the leadership of Prime Minister Sheikh Hasina.

In recent days, both parties held programmes in the capital and elsewhere showing off their popularity.

Clashes between BNP supporters and law enforcers assisted by ruling party activists turned entries to Dhaka city into battlegrounds on Saturday.

US to send pre-polls observers in October

Myanmar may take back the Rohingyas living in the Cox's Bazar camps to their own villages in North Maungdaw and nearby places instead of any camps or model villages.

Such an indication was communicated to Bangladesh by the Chinese Special Envoy for Asian Affairs Deng Xijun during his meetings with Foreign Minister AK Abdul Momen and

Foreign Secretary Masud Bin Momen on Monday, said sources in the know.

The special envoy discussed different aspects of bilateral relations between Bangladesh and China, but the main agenda was Rohingya repatriation.

Before coming to Dhaka on Sunday, Xijun went to Myanmar and discussed ways of implementing the repatriation of the Rohingyas with U Ko Ko Hlaing, Myanmar's SEE PAGE 7 COL 1

Hasina, AL never run away: PM



Prime Minister Sheikh Hasina yesterday came down heavily on BNP leaders for saying that Awami League won't get a way to flee the country.

"Sheikh Hasina or Awami League never runs away," she said at a blood donation programme in Dhaka.

"We hear from our opposition party though they can't be called an opposition party as they are not in parliament -- that we [Awami League] won't get a way to flee. I would like to remind the leader, who made this remark, that Sheikh Hasina or Awami League never runs away and never did," she said.

The premier was addressing a voluntary blood donation programme and discussion at the auditorium of Krishibid Institution Bangladesh in the city's Farmgate area.

Bangladesh Krishak League arranged the blood donation programme, discussion and Doa Mahfil ahead of the National Mourning Day to be observed on August 15.

Hasina, the President of Bangladesh Awami League, said their [BNP's] master, Ziaur Rahman, had made efforts to annihilate the Awami League, but failed. Then Ershad and Khaleda Zia tried without any success.

POLITICAL VIOLENCE **UN** special rapporteur urges restraint

UN Special Rapporteur on Freedom of Association and Peaceful Assembly Clement Voule urged all parties in Bangladesh to exercise restraint amid escalating violence and arrests during the ongoing protests.

"I remind the authorities of their duty to guarantee the right to assembly and refrain from using excess force. Respecting dissenting voices is key for fair and free elections,' Voule said in a tweet.

He also said this call follows earlier calls and communications to the government of Bangladesh following similar reports of excessive use of violence by law enforcers, including lethal violence, and undue arrests of peaceful protesters.

Remittance continues to underwhelm

Inflows down 5.86pc to \$1.97b in July

Migrant workers sent home \$1.97 billion in July, down 5.86 percent from a year earlier, in yet another bad tiding for the country's strained foreign exchange reserves.


Remittance inflows along with export receipts are the main sources of dollar for Bangladesh, and a surge in inflows is expected in line with the growing manpower exports, which would have eased some pressure on the foreign currency reserves.

That has not been the case so far this

"The minimum remittance inflow should be at \$2 billion each month because of growing manpower export," said Zahid Hussain, a former lead economist of the World Bank's Dhaka

The inflows so far this year were less than \$2 billion every month save for March and June, according to data from the Bangladesh Bank.

In fiscal 2022-23, Bangladesh sent 11,44,993 workers abroad, up 15.8



percent from a year earlier, according to data from the Bureau of Manpower Employment and Training.

POST-COUP MYANMAR Junta cuts six yrs of Suu Kyi's 33-yr jail term

Myanmar reduced ousted civilian Aung leader San Suu Kyi's 33-year prison sentence six years in a partial pardon vesterday,



the junta struggles to quell bloody resistance to its rule.

The country has been ravaged by violence in the two years since Suu Kyi was deposed in a coup and hit with 19 criminal cases ranging from corruption to breaching Covid-19 rules

There have been concerns for the 78-year-old Nobel laureate's health and the junta moved her from prison to a government building last week.

"Six years imprisonment will be reduced," junta spokesman Zaw Min Tun told reporters after it was announced she had been pardoned in five cases.

Suu Kvi still faces 14 cases despite the pardon. Rights groups have condemned the legal battle against her as a sham designed to remove a popular democratic leader from the public eye.

Former Myanmar president Win Myint, who was also removed in the 2021 coup, was granted a four-year reduction in relation to two cases, the junta spokesman said.

Yesterday's announcement was part of an amnesty of more than 7,000 prisoners to mark Buddhist Lent, including 125 foreigners who are to be released and pardoned.


unspecified number of prisoners facing the death penalty also had their sentences commuted to life imprisonment, the announcement said.

David Mathieson, an independent analyst on Myanmar, said the partial pardon was a "cynical ploy to tell the world that there might be some kind of political resolution coming. When we know that there is not".

"I think they are just playing cruel games with a political prisoner," Mathieson told AFP. "All the charges against her are absurd and shaving six years off 33 isn't mercy.'

Human Rights Watch's division deputy director Robertson said the junta aimed "to create the impression of moderation and dialogue when in fact there really is none on offer".

Know your neighbour?

Dhaka is full of opportunities and possibilities but they come at a price. In a city as busy as this one, sacrificing social bonds has become the norm. While in villages or even smaller cities, people form strong or at least decent bonds with their neighbours, it is not so frequent in this metropolis.

There are many reasons for such apathy. The biggest reason is probably the fact that Dhaka is so busy that people just cannot afford the time to socialise with each other. While this is true and an accepted practice in most big cities, it is not a pleasant thought from a sociological perspective. There are countless instances where people have lived in apartments side by side for years and they did not even know each other's name.

Shahed Rahman is in his forties and works at a private institution. He owns a flat in Mirpur and has been living there for a few years now. He does not

interact much with his neighbours. "I know it sounds bad but it's not that simple. Even if I want to interact

with my neighbour, maybe he doesn't

feel the same way. If my neighbourly Dhaka different from the rest of the interest is not shared then it becomes difficult to maintain that relationship," said Rahman.

"If you try to approach someone to speak, they often do not take it as an innocent neighbourly approach. They begin to wonder about your motives for being friendly," said Mushfiq Fuad Mitul, a new father who lives in Khilgaon with his small family.

Most of Dhaka practices this individualistic approach when it comes to neighbours and holds the belief that it is better to keep yourself to yourself. But the keyword is "most". There are parts of Dhaka where neighbours interact regularly with each other. Old Dhaka is a prime example of this.

Sagar Kar, a young businessman who presently lives in Tongi, has lived in Uttara and Old Dhaka over the years. With the entirety of his childhood spent in old Dhaka, Sagar holds the experience of living there for more than 20 years.

"First there is the fact that the entire area of Old Dhaka itself is a cultural hub that has its own traditions, norms, and festivals. This alone makes Old city and this is a big factor in how neighbours interact with each other," said Sagar citing the examples of Eid, Puja, and Shakrain and how everyone in Old Dhaka participates in those celebrations spontaneously.

"Another factor is how the buildings are designed. The city has many individual flats that are designed to keep everyone separate, you can live in one of these flats and not have to interact with anyone else and it will not matter. But the buildings in Old Dhaka are not designed that way. So, you run into each other and for one reason or another, have to interact with each other. This builds a bond. Besides, Old Dhaka still has that classic norms where people don't have that individualistic ego. While the rest of the city might not take your friendliness quite as easily, Old Dhaka does not mind," added Sagar.

Being too friendly to a neighbour can indeed make things complicated but reaching out and introducing yourself to your neighbour is not the worst idea. That way, at least you can feel less awkward in the elevators.

Two university students drown in Gopalganj

Two female students of Bangabandhu Sheikh Mujibur Rahman Science and Technology University in Gopalganj drowned in the university lake yesterday.

Tasfia Jahan Ritu, 20, and Tania Hiya, 20, were second-year students of environment and disaster management department.

Md Kamruzzaman, the university proctor, said, "It was raining heavily around 12:30pm. Ritu and Tania were getting drenched at the edge of the lake. At one stage, Tania slipped into the lake. Ritu went in to save her. But both drowned."

Some students found them and took them to opalganj 250-bed General Hospital where on-duty doctors declared them dead, the proctor added.

US to send pre-polls observers in October

Election Commissioner Kazi Habibul Awal at the Election Commission office yesterday.

'The United States's only interest in the election is that it would be free, fair and peaceful. And that the people of Bangladesh have the ability to choose who governs them," Peter Haas told reporters after the meeting. "I informed him [the CEC] that the US will send a pre-election monitoring team in early October."

It will include experts from the National Democratic Institute, International Republican Institute, and people with vast experience election monitoring and preparations.

Haas, however, said he could not yet provide the detailed schedule of the team's visit.

The US ambassador said he and the CEC discussed a number of issues, including the recent changes to the Representation of the People Order (RPO), the approval process for new political parties, election assessment and monitoring teams.

Speaking to reporters after the meeting, CEC Kazi Habibul Awal said the US ambassador heard about the EC's power being curtailed as a result of the recent amendments to the

> While, he added, article 41(2) says all official business with the receiving State entrusted to the mission by the sending State shall be conducted with or through the Ministry for Foreign Affairs of the receiving State or such other ministry as may be agreed.

> The 13 missions - the US, UK, Canada, Denmark, France, Germany, Italy, the Netherlands, Norway, Spain, Sweden, Switzerland, and the EU – in the statement called upon the government to conduct a full investigation into the attack and take legal steps against the perpetrators.

Two-day holiday in Iran over severe heat

Iran vesterday declared a two-day holiday for government workers and banks nationwide as searing temperatures sweep across the country, state media reported.

The decision came after the meteorological office temperatures exceeding 40 degrees Celsius (104 Fahrenheit) in many cities, and nearly 50 degrees Celsius (122 Fahrenheit) in the southwest.

"The cabinet agreed to the health ministry proposal to declare Wednesday and Thursday public holidays all over the country to protect public health," the official IRNA news gency quoted government spokesman Ali Bahadori Jahromi as saying.

It said the decision was taken because of "unprecedented heat' sweeping the country.

The ministry has also warned of the risks of heatstroke from overexposure to the sun, and urged people to stay indoors between 10:00

am and 4:00 pm. Health ministry spokesman Pedram Pakain described the number of heat-related illnesses in recent days

Teachers withdraw strike, will go back to classes

After 22 days of continuous sit-in, secondary school teachers calledoff their programme yesterday night following a meeting with former cabinet secretary Kabir Bin Anwar and Deputy Minister for Education Mohibul Hasan Chowdhury.

Sheikh Kawsar Ahmed, general secretary of Bangladesh Teachers' Association, told journalists last night they will be included in the two committees that would be formed regarding nationalisation of their educational institutions.

The prime minister will take the final decision regarding their salaries and eliminating the discriminations they face, he

"So, we have decided to withdraw our agitation. Now we will go back to class," he added.

Earlier in the day, the

The DC has been ordered to complete the probe and submit its report to the HC in 60 days.

Rail service resumes on Dhaka, N'ganj route after 8 months Fare increases by Tk 5

OUR CORRESPONDENT, Narayanganj

Rail services between Dhaka and Narayangani resumed yesterday following an eight-month pause for construction works.

Meanwhile, the fare has been increased by Tk 5. It will now cost Tk 20 for commuter trains.

Kamrul Islam Khan, the station master of Narayanganj railway station, informed that the first commuter train from Kamalapur railway station departed for Narayanganj at 5:00am.

"Local trains operated on this route earlier, when the fare was Tk 15. But from now on, eight commuter trains will run 16 times, offering more passenger facilities," he added.

Passengers welcomed the resumption of train services after the suspension, as it offers a more cost-effective alternative than buses, which charge a minimum Tk 55 fare for commuting from Narayanganj to Dhaka.

However, some passengers expressed concern over the fare increase and urged the authorities to maintain good passenger facilities.

Dhiman Saha Jewel, member secretary of Narayanganj passenger rights protection forum, demanded an increase in the number of trains and coaches on this route and insisted on keeping the fare at Tk 15 as before without any increase.





Save Sundarbans from plastic pollution

Speakers tell workshop

The use of non-biodegradable plastic has severely damaged the environment and biodiversity of the Sundarbans, said speakers at a programme vesterday.

They made the remarks at a workshop Sundarbans Reserved Forest Ecotourism Master Plan organised by the Forest Department and USAID Ecotourism Activity at Sundarbans West Forest office.

Terming the present situation a major concern, speakers directed the authorities to ensure a ban on the use of single-use plastics. They also urged the authorities to stop the dumping of such plastics in rivers and coastal belts to save the flora and fauna of the areas from plastic pollution.

Calling upon the authorities concerned to find alternatives to plastic bottles and plates for tourists visiting the area, the speakers also vowed to monitor water bodies through which plastic floats into the forest reserves.

Divisional Forest Officer Abu Naser Mohsin Hossain said, "The biodiversity of the place will be preserved if the forest is brought under eco-tourism. Tourism will flourish as more people will visit the place, while the forest's biodiversity will also be preserved."

plastic pollution if we want to save the Sundarbans. We all need to work together to protect the forest," he added.


Tour operators in the area are now more aware of preserving the forest's wildlife, mentioned Nazmul Azam David, general secretary of Sundarban Tour Operators.

CLASH WITH COPS BNP leader Nipun gets HC bail

GRAFT CASE Prosecution seeks highest punishment for Chisty

The prosecution vesterday completed arguments and sought highest punishment (14 years imprisonment) for four accused, including Farmers Bank's former audit committee chairman Mahbubul Haque Chisty alias Babul Chisty, in a case filed over laundering Tk 160 crore from the bank.

During the closing arguments, ACC Public Prosecutor Mosharraf Hossain Kajol told the court that they were able to prove the charges brought against all the four accused undoubtedly and they should be given highest punishment for committing such offences.

The three other accused are Babul Chisty's wife Ruzi Chisty, son Rashedul Haque Chisty, and Farmers Bank's former first vice-president Masudur Rahman Khan.

Of them, Babul and Rashedul are now in jail while Masudur and Ruzi are on bail in the case.

After that, Judge Syed Arafat Hossain of the Special Judge's Court-4 of Dhaka fixed August 28 for

arguments from the defence. On April 10 of 2018, the ACC filed the case against six people, including Babul Chisty, with Gulshan Police Station over laundering Tk 160 crore.

Locals suffer for delay in drainage work

"Every day for the last couple of weeks, my son has to cross extensive mud patches to go to school. He is tired and does not want to go to school anymore," said Rumana Akhtar, a resident of road-11 of Bastuhara area in Khulna city.

Rumana repeatedly requested contractors to finish the work, but they did not pay any heed to her

"The mud piles on the lane adjacent to my house would be around 10 feet high," she added.

establish a То drainage proper system around the area, Khulna City Corporation has been digging various roads and alleys in Bastuhara for a couple of weeks. Alongside

confining locals within their homes, construction workers have also disconnected water pipes set up by Khulna Wasa.

The area is home to a number of marginalised families, mostly earning their daily bread as traders and hawkers.

Even before the work started, they were facing various problems in the area such as waterlogging and narrow roads. Now, this delay in the drainage work has doubled

their sufferings, they added. Locals have been critical of the authorities' decision to take up this project during monsoon instead of dry seasons and many have called them "insensitive", as they are yet to take any action in this regard.

US sanctions 20 in Maldives over IS links

Washington has sanctioned 20 citizens of the Maldives for their ties to the Islamic State group, including one man accused of trying to assassinate former president Mohamed Nasheed

The US Department of Treasury said Abdulla Manik currently custody over the unsuccessful 2021 attack - had several links to terror plots in the tourist hotspot.

New sanctions unveiled Monday also identified Manik as an associate of known IS recruiter Mohamad Ameen, who was himself sanctioned by the US in 2019.

Ameen is known to have sent dozens of Maldivians to fight in Syria and was the main suspect in a 2007 bomb attack at a public park that wounded 12 Chinese tourists. The US statement said 29 companies, many linked to the lucrative tourism industry, were also sanctioned over their links to IS operatives.

NIGER COUP Nations prepare to evacuate citizens

AFP, Niamey

France and Italy yesterday prepared to fly out their citizens and other Europeans from Niger, six days after a coup that toppled one of the last pro-Western leaders in the jihadist-plagued Sahel and stoked anti-French demonstrations.

Mohamed President Bazoum was overthrown on July 26 by his own guard, in the region's third putsch in as many years following takeovers in neighbouring Mali and Burkina Faso.

After hostile Sunday gathered on outside the French embassy and Niger accused France of plotting to intervene militarily, Paris said yesterday it would withdraw its citizens and offered to evacuate other Europeans as well.

"In the face of a deteriorating security situation in Niamey and taking advantage of the relative calm in Niamey, an operation of evacuation by air is being prepared," the embassy said.

The evacuations "will take place very soon in a very limited span of time," it said. The foreign ministry in Paris later said the evacuations would begin later yesterday.

There are an estimated 600 French nationals in Niger. The Italian government said it was putting on a "special flight for those (Italians) who want to leave the country," adding that this was "not an evacuation."

Drones target Moscow, Black Sea patrols

Office block in Russian capital's main business district hit; Kremlin slams Ukrainian 'terrorist attack'

Russia said yesterday it had downed another wave of Ukrainian drones aimed at vessels in the Black Sea and Moscow, as an office block in the capital's main business district was struck for the second time in a few days.

"Two Ukrainian (unmanned aerial vehicles) were destroyed by air defence systems over the territory of the Odintsovo and Narofominsk districts of Moscow region," the Russian defence ministry said

"Another drone was suppressed by electronic warfare and, having lost control, crashed on the territory of the Moscow City," the capital's main commercial district, the ministry said. In a separate statement, the Kremlin said it had thwarted the "attempted terrorist attack".

On Sunday, Russian defences downed drones in that same district, with debris damaging two office towers, blowing out several windows and scattering documents on the pavement below.

"One flew into tower in (Moscow) City as last time," mayor Sergei Sobyanin said yesterday on Telegram. "The facade on the 21st floor was damaged," and a number of windows were smashed, the mayor said.

He added that emergency services had gone to the scene and that there was no information on any casualties.

"We heard a big explosion, there was no panic," local resident Arkady Metler, 29, told AFP. 'Nobody should be scared... we cannot do anything but stick together," said Metler.

Other residents were more shaken by the renewed explosion in their neighbourhood. Shortly after the drone attack, Moscow's Vnukovo

DOHA MEETING US delegation presses Taliban on women's rights

US officials denounced the deteriorating human rights situation in Afghanistan particularly for women and girls -- during a meeting Afghan Taliban with representatives in Doha, the State Department said Monday.

The American delegation expressed concern" regarding humanitarian crisis and needtocontinuesupporting aid organizations and UN bodies delivering assistance, a statement said.

The closed-door meeting was one of the highest-level known gatherings of US and Afghan government officials in months, with the Washington team headed by Special Representative Thomas West and Kabul's by Foreign Minister Amir Khan Muttagi.

The US statement did not, however, identify the representatives Afghan describing "senior" and only as "technocratic professionals."

A separate Afghan foreign ministry statement issued late Monday did name Muttagi, and said his team included finance ministry and central bank representatives.

It noted human rights were discussed and said the meeting underscored discussions between the sides on ending banking restrictions and sanctions.

Women's rights have been a sticking point in negotiations over aid and recognition since the Taliban swept back to power in August 2021.

ICC slams Russia's addition of judge to wanted list

The International Criminal Court (ICC) vesterday condemned Moscow for putting another of its judges on a wanted list in Russia, after the court issued an arrest warrant for the country's President Vladimir Putin.

ICC judge Tomoko Ákane issued an arrest warrant for Putin in March for the war crime of allegedly unlawfully deporting Ukrainian children, as well as for Russia's presidential commissioner for children's rights Maria Lvova-Belova over similar charges.

Russian news agency TASS reported last week that Akane was the latest target of an arrest warrant in Russia following ICC prosecutor Karim Khan and judge Rosario Salvatore Aitala, who have been investigated since May over the decision to seek Putin's arrest over the Ukraine war.

The Russian notice seen by AFP describes the judge as a woman born June 28, 1956 in Japan, and says she is wanted for violating the Russian Criminal Code, without specifically listing the nature of the offence.

The presidency of the Assembly of States Parties, representing the ICC's member countries, said it was "deeply concerned" by the move and called it a "new attempt to undermine the international mandate" of the

It also reiterated "it stands firmly by the Court, its elected officials, and its personnel" and has "full confidence" in the court's independence and impartiality.

The warrant against Putin and Lvova-Belova accuse the pair of committing war crimes for having "illegally deported" thousands of Ukrainian children since invading the country in February 2022.

Xi appoints new chief of China's nuclear arsenal

Chinese President Xi Jinping, also the military's commander-in-chief, on Monday appointed a new head of the armed force overseeing the nation's conventional - and nuclear - missiles, one day before the anniversary of the People's Liberation Army. Wang Houbin, former deputy commander of the navy, was named the new head of the PLA Rocket Force, and Xu Xisheng, its new political commissar, with both men acquiring the top rank of general, according to state media. Until his move to the PLA Rocket Force, Wang had been deputy commander of the navy since 2020. He was previously also the deputy chief of staff at the Navy. Xu was formerly the deputy political commissar of the Southern Theatre Command. one of the PLA's five theatre commands. State media did not say where the PLA Rocket Force's previous chief, Li Yuchao, was reassigned or state his whereabouts.

UK launches first postal deliveries by drone

"Anything that helps to maintain the universal service, especially in areas of the isles which are more difficult to reach, is something that we should give a chance to support," Alistair Carmichael, the MP for Orkney and Shetland, said in a statement. "Royal Mail remains a critical part of keeping the isles connected — and local knowledge and care are vital to that network." Royal Mail said the drone service was expected to significantly improve service levels and delivery times to Graemsay and Hoy, where weather and geography can cause disruptions to delivery services.

of oil tankers guarded by the army in the Syrian desert yesterday, killing seven people including two civilians, a war monitor said.

"Five regime forces and two drivers have been killed in the armed attack by IS militants" in the east of Hama province, the Syrian Observatory for Human Rights said.

The attackers used machine guns and rocketpropelled grenades, said the Britain-based monitor, which relies on a wide network of sources inside Syria.

In March 2019, IS lost the last territory it had held in Syria following a military campaign backed by a US-led coalition, but jihadist remnants continue to hide out in the desert and launch deadly attacks.

They have used such hideouts to ambush civilians, Syrian government troops and pro-Iran fighters. Syria's war broke out after President Bashar al-Assad's repression of anti-government demonstrations in 2011 escalated into a conflict that pulled in foreign powers and global jihadists.



MANIPUR STATE India's SC lashes out at govt over violence

Remittance continues to underwhelm

inflows remittance through the formal channels decrease by 3.5 percent if the premium offered by the informal market exchange rate increases by 1 percent, he said.

Monday, the On Association of Bankers, Bangladesh (ABB) and the Bangladesh Foreign Dealers Exchange (BAFEDA) Association increased the exchange rate of the US dollar by Tk 0.5 to Tk 109 for remitters. Until July 31, banks were officially offering Tk 108.5 for a US dollar.

But remitters can get more through unofficial channels, according to bankers.

Bangladeshi "Some expatriates are still sending remittance through the illegal channels because of a higher dollar rate than the bank rate, said Mirza Elias Uddin Ahmed, managing director of Jamuna Bank, which ran campaigns in recent months to boost its remittance inflows.

In the absence of adequate remittance inflows, banks are turning to the BB for dollar support to settle their import bills.

The BB sold nearly \$14 billion to banks in fiscal 2022-23 fiscal year. In July, it sold \$1 billion, as per the central bank officials.

Ahmed hopes that the exchange rate gap between the formal and informal markets will narrow further in the coming months and ramp up the remittance inflows through the official channels.

Syed Mahbubur Rahman, the MD of Mutual Trust Bank, is hopeful that the inflows will increase in the coming months as the ABB and BAFEDA are continually adjusting the dollar rate.

The remittance inflow will not increase until the exchange rate is made according to flexible, Hussain.

"The exchange rate should be market-based for remittance inflow because now there is no negotiation system for transactions in the formal market," he said.

Official data showed 248,901 people walked through the jungle area between January and July, already surpassing the record of 248,284 recorded for the whole of 2022, with most aiming to reach the United States, according to data from Panama's Security Ministry.

Entries to Panama from Colombia through the jungle region have continued to rise despite a two-month program launched in April by the United States, Panama and Colombia to tackle undocumented immigration.

July recorded the most crossings, with 52,530 people taking part in the dangerous journey, up 77% from June, mostly from Venezuela, Haiti and Ecuador, according to the data.

The flow of migrants has skyrocketed from previous years, despite the start of the rainy season, Panama's Security Minister Juan Pino said earlier this month.

Some 20% of the people who have crossed the jungle this year are minors, 51% of whom are under five years old, migration official Maria Saravia said at a press conference where the new figures were presented.

The United Nations forecast in April the total number of crossings would surpass 400,000 this year, with the organization warning that migrants crossing through the jungle are exposed to disease, violence, sexual abuse and human trafficking.

In recent years, parts of this jungle have become the site of humanitarian catastrophe. Hundreds of thousands of migrants from across the world, including as far as Afghanistan, and parts of Africa, cross the perilous terrain en route to the US border.

Blocked by visa restrictions from entering countries closer to the United States, a quarter of a million people traversed the lawless region last year.

Why such apathy for medical research?

We need to inculcate a culture of learning to better serve patients

We are shocked to learn that around 47 percent of doctors in four major hospitals do not have the required skills to do research. Skills include knowing how to conduct statistical analyses, writing papers worthy of foreign publications and writing manuscripts. The fact that such a high proportion of doctors lack such basic skills is truly alarming for a discipline that demands continuous study of various aspects

The study, conducted by the Department of Public Health and Informatics at BSMMU, also found that only 25 percent of the surveyed doctors authored research, while 29 percent were co-authors of research published in different journals. In a country where public health is constantly challenged by waves of diseases, the present dengue epidemic being a prime example, it is unthinkable that medical research is so grossly neglected.

So why are doctors so disinclined to conduct research? The study has found that six out 10 physicians do research only to get promoted, which means they are not doing this for selfdevelopment or to gain more insight into their specialised field. Other reasons given for research included the desire to pursue a career abroad for higher studies, with 41 percent conducting research in order to be "praised".

This lack of enthusiasm is largely affected by the generally unfriendly environment for such study. Most respondents pointed to professional pressure and lack of research-related knowledge as impediments; others pointed to having no prior knowledge of research and the dearth of grants. The lack of professional benefit, non-cooperation of colleagues and the idea that private practice was more profitable were

Research should be considered a mandatory part of medical studies and must be encouraged in all medical institutes. Senior physicians have a huge role to play in being mentors and facilitators of research by their juniors. As experts have said, it is essential that local universities and medical institutions collaborate to foster this research culture. In addition, existing funds available for research must be judiciously utilised, while allocations for research must be increased and monitored in all medical institutions.

It goes without saying that without continuous research, doctors cannot gain insight into what new medicines, procedures and tools can be developed to provide better treatments for patients. Without research, they will be significantly ill-equipped to tackle the formidable challenges of controlling outbreaks of deadly diseases.

Take action against big loan defaulters

Appellate Division's observation on defaulted loans is right on the mark

Our apex court's frustration at the present state of defaulted loans in Bangladesh is a sentiment shared by many people. According to a report in this daily, an Appellate Division bench, headed by the chief justice, remarked on Monday that those with loans worth hundreds of crores of taka were getting away with not paying their debts off, while farmers with small loans were being harassed for failing to make regular payments. We completely agree with the court's observation and believe that, given the financial crisis that the country is going through, it is high time some tough actions were taken to redress this persistent problem.

Non-performing loans (NPLs) have been a thorn in our side for decades, but now it is turning into blight for our economy. And we have gotten into this situation because of the leeway that has periodically been provided to habitual loan defaulters. The result: Bangladesh now holds the second position in South Asia in terms of bad loan ratio, according to a World Bank report. We are behind Sri Lanka only, but that should not provide any comfort considering the collapse of Sri Lanka's economy last year. The amount of defaulted loans in Bangladesh, which stood at Tk 120,656 crore at the end of December 2022, jumped by Tk 11,000 crore in just three months, rising to Tk 131,620 crore at the end of March 2023, according to the Bangladesh Bank. Experts have been raising concern over the upsurge in defaulted loans for years, pointing out the severe implications for both the banking sector and the economy overall.

We all know what the solution is: stop being lenient to big loan defaulters. The extraordinary lenience that the government has shown big borrowers through debt rescheduling and relaxation of rules has gotten our banking sector in a quagmire that it is struggling to pull itself out of. High volume of NPLs is one of the three major domestic risks that our economy faces, according to the International Monetary Fund (IMF) – something that our own economic experts have been flagging for years. An overall reform in our financial sector is needed to instil good governance and strict regulations to check bad lending practices, but as immediate remedies, the government should put specific measures in place to stop lending irregularities in our banks, and make all big loan defaulters pay their debt off without exception. It is not fair that our banks keep getting bailouts from the government, using taxpayers' money, due to defaulted loans and bad lending practices.



In my view, any new exploration for fossil reserves should be declared a crime against humanity. In fact, I would argue that it is a crime against our own children as they will be the ones to suffer from the consequences of this action.

The next item in the agenda would be to ban the development of any new coal mines, given that coal is the most polluting of the three aforementioned fossil fuels. This phasing out is also happening, but again not fast enough. Petroleum, which is mostly used in the transport sector, could be replaced by switching to increased usage of electric vehicles. The final fossil fuel is natural gas, which may still be a viable transition fuel for a few more years as it is the least polluting of the three.

The most important action that can catalyse our transition from fossil fuelbased economies to renewable energy based economies is to discover new financial investment incentives, so that trillions of dollars can be shifted to investing in clean energy. This means getting rid of the most egregious subsidies that are still being given by

governments to fossil fuel companies. Finally, I would recommend for the UN secretary-general himself to appoint a special envoy for loss and damage to liaise between the United Nations Framework Convention on Climate Change, the United Nations Office for the Coordination of Humanitarian Affairs, and national governments to ensure that we no longer impose the adverse impacts of human-induced climate change on the poorest and most vulnerable citizens. This should be the moral imperative of every thinking citizen of the planet.

Dr Hossain also said that trainee doctors in Singapore get an equivalent of Tk 2,50,000 as allowance. Of course, in comparison, the Tk 20,000 that Bangladeshi trainee doctors get is meagre.

Unfortunately, the allowance is also paltry when looked at from an economic perspective. A medical student can only apply to be a postgraduate trainee doctor after completing their MBBS, which in itself is a six-year programme, including a one-year internship. By the time doctors can apply for this, they are in their mid-20s. This often means they feel obligated to not only become self-reliant, but also contribute to household expenses. In a country plagued by a high inflation rate of nearly 10 percent, how can it be expected of postgraduate trainee doctors to live a dignified life on an allowance of only Tk 20,000 per month? Trainee doctors in Bangladesh's healthcare institutions are expected to shoulder significant workloads, put in long hours, and efficiently provide healthcare services to patients. This is in addition to their academic duties of studying, sitting for exams, working on research and so on. On top of all this, if the doctors have to also worry about their sustenance, how can they be expected to serve people well or do justice to their profession and education?

Ideally, since authorities are unable to pay doctors adequate allowances, they should be allowed practise outside working hours. And this is something that authorities recently presented as a mitigation measure in the face of the strike. But the point remains: why did it take a strike for authorities to grant this to trainee

Moreover. the authorities have raised the allowance from Tk 20,000 to Tk 25,000. For comparison, a management trainee at any reputable organisation in the private sector makes at least Tk 40,000, or as high as Tk 80,000-90,000, given the nature and salary structure of specific organisations. But it is as if the trainee doctors are being punished for choosing the medical profession, given the meagre pay they are being offered even after striking. According to Section 94(7) of the Bangladesh Labour Act, 2006, "Such rooms shall be adequately furnished and equipped and in particular there shall be one suitable cot or cradle with necessary bedding for each child, at least one chair or equivalent seating accommodation for the use of each mother while she is feeding or attending to her child and a sufficient supply of suitable toys for the older children."

In October 2019, lawyer and mother Israt Hasan filed a writ petition with the High Court seeking the establishment of breastfeeding corners in public spaces. As a result, the HC in April this year directed the government

stations across the country.

Breastfeeding laws exist in the United States and the United Kingdom. Both countries feature designated diaper-changing areas as well as breastfeeding corners with accompanying bathrooms. It is also entirely legal for mothers to breastfeed in public spaces anywhere in the UK and US. The matter is also under consideration in neighbouring India. Back in 2017, nursing rooms were established at 100 railway stations across the country in India.

In Bangladesh, many public places feature dedicated smoking zones. But there are hardly any breastfeeding and baby care corners. This is quite discriminatory. Moreover, although more and more women are entering the workforce and contributing to the country's economy, we are lagging behind in taking steps to improve their working conditions. This includes the lack of breastfeeding corners in workplaces, which can also to take necessary steps to set impact the growth and overall

Working women spend lengthy periods of time outside with their children. 



Masking serious messages in the veil of humour

In the world of film, satire and humour have long been utilised as powerful tools for not solely entertaining but also delivering meaningful societal commentary. A wellcrafted joke or satirical scene can disarm audiences, prompting them to reflect on societal norms and question their own beliefs. By cloaking serious messages in the veil of humour, filmmakers can effectively challenge the status quo and address pertinent issues without being overtly didactic.

Bengali cinema, with its rich storytelling tradition, has been no stranger to the art of using humour and satire to convey thoughtprovoking messages while entertaining its audiences. This article aims to explore how the use of humour and satire in movies allows filmmakers across the world to convey thought-provoking messages while entertaining their audiences.

The power of satire

Satire, as an artistic expression, serves as a mirror for society, holding up a distorted reflection of our collective values and behaviours. Through humour, filmmakers can draw attention to the absurdities and becomes a means to unmask the faults

audiences to engage in critical thinking and introspection.

A classic example of using satire to comment on societal norms can be found in Stanley Kubrick's *Dr Strangelove or: How* I Learned to Stop Worrying and Love the Bomb, which was released in 1964. The film was originally envisioned as a dramatic look at the Cold War, loosely based on the novel **Red Alert** by Peter George, but Kubrick felt it would be more effective as satire. This British dark comedy parodies the Cold War tensions and the nuclear arms race, using humour to underscore the absurdity of political brinkmanship and the dangers of unchecked

The landscape of Bengali cinema is no different when it comes to using satire to critique prevailing social and political issues. Satyajit Ray, a legendary filmmaker in Bengali cinema, used satire effectively in his film Hirak Rajar Deshe (The Land of the Diamond King), released in 1980. This sequel to *Goopy Gyne Bagha Byne* (1969) humorously criticised totalitarian regimes and the abuse of power. The heart of the narrative lies within a mesmerising fantasy hypocrisies that often go unnoticed. Satire realm governed by an unrelenting and selfabsorbed ruler portrayed brilliantly by Utpal

and flaws that plague society, encouraging Dutt. Delving deeper, the film artfully unfolds as a thought-provoking political allegory, drawing parallels to the historical period of Emergency under Indira Gandhi's reign. Furthermore, Ray skillfully weaves a broader exploration of totalitarianism, leaving audiences with an insightful reflection on this

governing ideology. Through the character of the tyrannical King, Ray provided a sharp commentary on the dangers of unchecked authority and the suppression of dissenting

Using humour to address social issues

Humour has a unique ability to address uncomfortable or sensitive social issues without alienating audiences. Comedy can create a safe space to discuss topics that

may otherwise be met with resistance or defensiveness.

The political satire film Mad_e in **Bangladesh**, directed by Mostofa Sarwar Farooki, was released in 2007 after being delayed by a year because of opposition from the Bangladesh Film Censor Board over the contents of the film. Mad_e in Bangladesh ensembles a stellar cast starring Zahid Hasan, Shahiduzzaman Selim, Tariq Anam Khan, Fazlur Rahman Babu, and Hasan Masood, among others. The story revolves around an apparently passive young man, Khorshed, played brilliantly by Zahid Hasan, who comes to Dhaka from a rural area looking for a job and a better life. Farooki delivered an entertaining drama that is rooted in truth, well-fitted to our socio-political context, and scathing in its criticism of power-politics and the flaws within our system. The film remains as controversial yet as relevant as the year of its release.

Directed by Shiboprosad Mukherjee and Nandita Roy, the Tollywood film Belaseshe (2015) humorously delves into the complexities of family dynamics and the changing societal roles of women. Through the character of a middle-aged woman who seeks divorce after decades of marriage, the film challenges societal expectations and highlights the importance of individual agency and happiness.

Subverting stereotypes through comedy

By playfully subverting established norms, filmmakers can encourage empathy and understanding while celebrating individuality. Bengali cinema has been at the forefront of breaking stereotypes and challenging societal norms through comedy.

Bhooter Bhabishyat (2012), directed by Anik Dutta, blends comedy with supernatural elements to deliver a satirical commentary on the urbanisation and gentrification of Kolkata. The movie humorously portrays ghosts from different eras of Kolkata's history, symbolising the lost essence of the city in the face of rapid modernisation.

Humour and satire are potent weapons in a filmmaker's arsenal, enabling them to address serious social issues while keeping audiences engaged and entertained. By skilfully using humour and satire, filmmakers can spark conversations, challenge societal norms, and encourage introspection among viewers. Through the lens of comedy, these movies shed light on the human condition, making us laugh while subtly prodding us to contemplate the state of the world we live in. As we continue to enjoy these films, let us also recognise their deeper messages and the powerful role humour plays in shaping our perception of society.

Integrity - one of the most-used stents in Bangladesh will be reduced to \$500 from \$880.

Similarly, Resolute Onyx's base price for stent has been lowered to \$900 from \$1,150, while that of Resolute Trucor's -- which is not yet supplied to Bangladesh -- will be

Local representatives of different stent manufacturers from the European Union, Japan, and other countries have also agreed to bring down the base prices of their products.

All European-origin authorised by the US Food and Drug Administration (FDA), will have base prices ranging from \$450 to \$500.

Meanwhile, the base prices of the EU-origin stents without FDA approval will range from \$400 to \$450. The same will be applicable to stents produced in Japan.

Prices of stents manufactured in other countries will range from \$300

On June 25, Abbott Laboratories and Boston Scientific -- two worldleading stent producers and suppliers agreed to the price reduction of eight kinds of stents, which are largely used, in another meeting at the DGDA. This reduction will be effective from September 1.

At the moment, as there is no local producer, Bangladesh remains fully dependent on foreign suppliers to meet the demand for around 45,000 cardiac stents per year.

The DGDA did not have any role in the price setting of cardiac stents before a markup formula was imposed on April 19, 2017.

In a joint effort, the DGDA and stent suppliers consulted a technical

They reached a unanimous decision to set a 1.42 percent markup for cardiac stents.

Since then, the stent prices have remained unchanged until October

But, to the dismay of patients, the prices went up as the DGDA made adjustments to align those with the depreciation of taka against the dollar.

Dextrose saline, an essential fluid used to treat dengue, has remained largely unavailable in Chattogram for at least the past two week owing to an unwavering demand due to a rise in the number of patients.

As a result, hospitals in the port city have been struggling to treat dengue patients. Because of the supply crisis, they must purchase saline at two to three times the normal cost from the market -- with patients having to bear the additional cost.

Speaking to drug store owners, our Chattogram correspondent learned that only five companies produced and supplied dextrose normal saline (DNS) solution in the port city.

However, none of them has been supplying sufficient quantities to the market over the last month, citing a production shortage.

said "We collect saline from four to five companies, but none of them can meet our demand nowadays. They can supply us with 10 to 12 litres of saline after we order 100 litres.

"As a result, we are facing difficulties while treating dengue even one without patients complications requires one litre per day. Critical patients may require up to three litres per hour."

Our correspondent found DNS solutions to be out of stock at pharmacies in Jamal Khan Road, Anderkilla, Chawkbazar, Bakalia, Panchlaish, Askar Dighir Par and Kazir Dewri areas.

Meanwhile, there were allegations that unscrupulous traders were stockpiling and selling saline at higher prices.

In this regard, the district administration and the Directorate General of Drug Administration (DGDA) conducted a joint drive at Hajari Goli, the largest wholesale market of medicines in Chattogram, on Tuesday.

However, there was no shortage of DNS solutions in government hospitals.

Brig Gen Shamim Ahsan, director of Chattogram Medical College Hospital, said, "Government hospitals procure saline, like other necessary medications, through a tendering process, which obligate suppliers to provide larger stocks at once in order to avoid such crises."

On Monday, tournament organizers in Washington aimed to pre-empt any possible repeat of the controversy by informing fans before the match there would be no handshakes. "At the conclusion of the match there will be no handshake between the players," a message on an arena screen said beforehand. With that issue settled, it was left to the two rivals to serve up a hard-fought if error-strewn battle that saw no fewer than 17 breaks of serve before Svitolina finally prevailed 7-6 (7/2), 6-4.

Svitolina clinched victory by breaking Azarenka's serve in the 10th game of the second set.

A wild Azarenka backhand presented Svitolina with a match point which she duly converted on the first attempt after bludgeoning a forehand winner into the corner.

Azarenka saluted Svitolina's victory with a fleeting thumbs up before heading off the court.

From the first ball, with Zak Crawley striking a boundary off Pat Cummins, till the last ball on July 31 when Stuart Broad took the wicket of Alex Carey, the cricket world experienced 45 days of edge-of-theseat cinematic action that could not have been scripted by mortals.

The 2023 Ashes has been like no other Test series in living memory. It pitted two styles of cricket against each other: England's fearless Bazball versus a far more orthodox, coupled with characteristic resilience of Australia

The Aussies geared up to the Ashes with the fire in their belly, having defeated India in the WTC Final. The next target for Cummins' side was to be the first Australian side to win an Ashes in England since 2001.

England also targeted to win the Ashes with Bazball, a style that has seemingly taken draws out of the equation in Tests. This has made Tests interesting at a time when the red-ball format has been under

were unstoppable from then on and emerged victorious at Headingley. Old Trafford was where England could have levelled the series, but then the heavens had a different say.

Rain has always been a 'player' in an English summer. England had the upper hand in Manchester, but the Test being washed out meant Australia had retained the Ashes. However, the two teams went to the final Test at The Oval with plenty at

The Oval had all the elements of theatre. Stuart Broad touched the stumps and got a wicket, the next ball two times. England had luck in a ball change. Rain breaks helped England this time. Australia uncharacteristically In the series opener, Stokes' surprise collapsed. Broad -- who surprisingly His last bat was a six, and his last ball won an Ashes Test and levelled the series. It appears that with the Asia Cup just around the corner, the BCB president was keen to get up from the current limbo that had been set since the onset of Tamim's retirement saga.

Tamim returned to the country on Monday following his medical treatment in England. The matter of Tamim's return to the team, however, still remains very much at large. Following his return, it was learned that the left-hander would have little time to assess during the camp on whether the pain reappears again.

While talking to The Daily Star, the BCB president Nazmul informed that they needed Tamim's opinion regarding his own return before anything else. "We have to know what he [Tamim] thinks regarding the Asia Cup and whether he will play. If he plays, we will definitely ask for his opinion. Even if he communicates that he won't be able to play, we have to think of alternatives and also ask for his opinion. We are hoping he will sit with us in the next one or two days," the BCB president said vesterday.

"We need to know details of what doctor has prescribed. We need to know when he can join practice or what rehab plans from doctors are and when he can play with full strength. Maybe we can think about upcoming steps in one or two days.'

Coach Chandika Hathurusingha is set to return on August 8 before Asia Cup squad is finalised. Nazmul mentioned that captaincy is not an issue as the vice-captain, in this case Liton, would take over responsibility.

European champions England swept past shell-shocked China 6-1 yesterday and into a Women's World Cup last-16 clash with

It equalled England's biggestever World Cup victory and booked them top spot in Group D, while China's tournament ended at the group stage for the first time and in humbling fashion.

'Again, another day of what dreams are made of," said England forward Lauren James who struck two on the night at the Hindmarsh Stadium in Australia.

Elsewhere, Denmark -- playing at their first World Cup since 2007 -- beat Haiti 2-0 in the other group game to finish second and line up a knockout-round meeting with co-hosts Australia.

Along with former champions Japan -- one of Bangladesh's oppositions in upcoming Asian Games in China -- England are the only team to win all three group games so far, reaffirming their status as among the favourites to win the World Cup.

Cardiac stents to be more affordable

DGDA decides up to 43pc cut in base prices; CAB urges govt to reduce the tax

The DGDA has decided to reduce the base price of all kinds of stents by up to 43 percent, effective from October 15, much to the relief of cardiac patients in need of stenting.

They will now be able to save up to Tk 40,600 per stent (under the current exchange rate). Consumer rights organisations have praised

this decision by the Directorate General of Drug Administration (DGDA). They, however, said the price could be even lower if the

government reduced the tax on cardiac stents. The decision was made at a DGDA meeting with representatives of cardiac stent manufacturers and a technical committee on stent price fixation at the

directorate yesterday. Speaking to The Daily Star after the meeting, Maj Gen Mohammad Yousuf, director general of the DGDA, said, "These price adjustments were made to make this lifesaving medical equipment more accessible to patients in need of cardiac care. After a series of discussions over the past several months, we have been able to do it."

Representatives from Medtronic, USA, agreed at the meeting to reduce the base price of the three kinds of stents manufactured by them.

Saiful Islam was beaten to death late Sunday night by a gang of 10 to 12 men on Khejurbagh School Road in Dhaka's Dakkhin Keraniganj, Khandaker Al Moin, director of Rab's legal and media wing, told a briefing

One of the suspects, Rajan Hossain, is a local criminal who was arrested in late June. He walked out of jail recently, Moin added.

Rajan thought that he was arrested because of information provided to law enforcers by Saiful, he said.

Saiful was returning home from his shop around 11:30pm when Rajan and the other suspects ambushed him and beat him up with cricket bats, sticks, and iron

As the victim fell to the ground, Rajan gouged out the victim's eyes.

Locals rushed to the spot hearing Saiful's screams for help and the suspects fled.

People of the area then took him to a hospital where doctors pronounced him dead.

Rab arrested Rajan and six suspects in the capital's Shahbagh area on Monday.

"The arrestees admitted their involvement in the murder," Moin said.

Scientists have theorised new approach involving a giant space "umbrella" to use as a solar shield to protect the Earth from excess sunlight and thus help reduce its impact on global heating.

István Szapudi, an astronomer at the University of Hawai'i Institute for Astronomy, said a solar shield tethered to a captured asteroid as a

counterweight can be developed into a workable design to mitigate the climate crisis within decades.

With the Earth rapidly warming, scientists across the world are developing a number of new ways to reduce the effects of climate change.

One of the approaches previously proposed to reduce global temperature is to shade the Earth from a fraction of the Sun's light using a solar "umbrella".

However, the large amount of weight needed to make such a shield massive enough to balance gravitational forces and prevent solar radiation pressure from blowing it away makes even the lightest materials prohibitively expensive.

At least five including two police personnel, were killed in communal clashes that erupted on Monday around 50km south of the Indian capital New Delhi, police officials told Reuters yesterday.

They've been framed

Say parents of Buet students arrested in Sylhet

Guardians of some Buet students who were arrested on Monday in Sunamganj on charges of "conspiring" against the government yesterday said their sons are innocents.

On Sunday, Tahirpur police intercepted a tourist boat near Takerhat area and detained 34 people – 31 former and current Buet students, two school students and a male domestic help -- when they were going to Tanguar Haor of Sunamganj from Dhaka.

They were shown arrested 24 hours after their detention in a case filed under Anti-Terrorism Act 2009.

Md Rashedul Kabir, sub-inspector of Tahirpur Police Station, filed the case.

They were produced before a Sunamganj Judicial Magistrate court yesterday and the court sent them to jail. Of them, two were sent to a juvenile prison as they were

Also yesterday, at least 10 guardians of the students held a press conference in front of the university's Shaheed Minar, saying they have been framed in a baseless case.

They said the students are not involved with any antistate activities, nor do they have any political affiliation.

"We do not believe the claim police brought against them," said Ali Ahsan Junayed, brother of Ali Ammar Moaz, one of the Buet students.

Guardians also raised questions as to why the students were shown arrested 24 hours after their detention.

Police say all of them are leaders and activists of Bangladesh İslami Chhatra Shibir.
