

DENGUE OUTBREAK 2023 already the deadliest year Dhaka sees highest deaths;

cases outside capital soar

With 10 new deaths recorded yesterday, the total number of dengue fatalities this year has risen to 283 – making this the deadliest dengue year since the first outbreak in the year 2000.

Earlier, the highest number of deaths recorded was 281

Of the 283 dead this year, 157 are males and 126 females. while the age group with most deaths was 21-25 years old.

doctors attributed this year's unusually delayed hospitalisation, reinfections, and the presence of Den-2 and Den-3 out of all four dengue strains.

Ahsan, associate professor at Shaheed Suhrawardy Medical College Hospital, stressed that patients need to be immediately hospitalised if they experience severe stomach aches, breathing difficulties, severe weakness, bleeding from gums or nose, and vomiting.

"If a patient is not hospitalised within 24 hours [of these symptoms surfacing], they may go into dengue

There are two types of dengue shocks -- compensated shocks and decompensated shocks, he said, adding that if a patient is hospitalised immediately after their compensated shock, they won't reach decompensated during which chances of recovery is only 50

Meanwhile, the number of dengue cases outside the capital has been increasing fast. However, Dhaka still holds the highest number of dengue deaths this year 226 out 283.

According to the Directorate General of Health Services, apart from the 10 new deaths recorded yesterday, nine of which were in Dhaka, 2,589 people were hospitalised across the country in the 24 hours till yesterday morning. Of them, 1,444 were outside the capital.

Of the total 59,716 dengue cases logged this year, 27,154

were outside Dhaka.

Of the districts outside the capital, the highest number of dengue cases recorded so far – 2,252 – was in Chattogram, while Chandpur and Barishal had 1,051 and 916 respectively.

External balance goes further downhill

Position deteriorated despite shrunken trade gap, current account deficit last fiscal year

Bangladesh's external sector continues to be in distress as the overall negative balance widened by 23.5 percent last fiscal year despite the narrowing trade gap and current account deficit.

At the end of last fiscal year, the overall balance was \$8.2 billion in the negative, up from the \$6.7 billion deficit at the end of fiscal 2021-22, as per the latest data from the Bangladesh Bank.

"The pressure on the balance of payment (BoP) is yet to subside due to the deficit in the financial account," said Zahid Hussain, a former lead economist of the World

Bank's Dhaka office.

The financial account is the component of the country's BoP that covers claims or liabilities to non-residents concerning financial assets. Its components include foreign direct investment, medium and long-term loans, trade credit, net aid flows, portfolio investment and reserve assets.

It was \$2.1 billion in deficit at the end of fiscal 2022-23, in contrast to \$15.5 billion in surplus a year

The private sector's lower shortterm foreign borrowing and the commercial banks drawing down their nostro accounts with foreign banks are to blame for the stunning

reversal in financial account in the space of a year, according to bankers and economists.

At the end of June, the private sector's short-term external debt stood at \$13.7 billion, down from \$17.8 billion a year earlier.

"The main challenge for the Bangladesh economy is to keep the financial account in the green the overall negative balance would not narrow if the financial account stays in the deficit," said Ahsan H Mansur, executive director of the Policy Research Institute of Bangladesh.

On the way, Sabuz's human haulier struck a private car and damaged its wing mirror around 11:00pm.


Three to four persons got down from the car and one of them hit Sabuz on the head with the broken mirror. The others also beat him up, leaving him critically injured,



Bangladesh's Money Laundering Prevention Act 2012 prohibits offshore investments without clearance from the central bank. It is punishable by up to 12 years of imprisonment and a fine twice the amount sent out.

S Alam Group was founded by Alam in 1985, and has since risen to become one of Bangladesh's largest conglomerates.

His business interests range from commodity trade to fishing, building materials to real estate, textiles to media, intercity buses to shipping, and power and energy to banking and insurance.

The Daily Star contacted Saiful Alam in writing twice – on July 6 and on July 23 - for comments on our findings. We sent him a set of elaborate questions detailing our findings about his investments abroad, requesting him to give his version. He responded through his lawyers, A Hossain & Associates, both times, saying he would not make any comment unless we shared the full report with him before publication, which is not a journalistic practice. HOPSCOTCHING HAVENS

This newspaper is in possession of documents that reveal parts of the web of the offshore business Alam has built with his wife Farzana Parveen. Our investigation has tracked down investments linked to Alam and his wife in Singapore, British Virgin Islands and Cyprus.

A small Mediterranean nation, Cyprus launched its Golden Passport programme in 2007. Under the scheme, wealthy foreigners were offered Cypriot citizenship in exchange for investments of about €2 million (USD 2.5 million) in their real estate, along with another €200,000 in contributions to the Cypriot government's research and land development fund, according to a number of international business consultancy firms.

Two years later, on August 27, 2009, Saiful Alam and Farzana Parveen founded Canali Logistics Pte Ltd in Singapore, listing themselves as Cypriot citizens and residents of Singapore, according to the company profile obtained from Singapore's Accounting and Corporate Regulatory Authority (ACRA).

The company's issued and paid-up share capital was worth USD 22.34 million (30 million Singaporean dollars) at the time. Alam and his wife were the sole shareholders, with

While financing could mean both equity and borrowing, analysts looking at the statements noted that since Alam and his wife were the sole shareholders at least until the end of 2020, this amount would potentially have to be bank borrowings or cash loans, and not equity. THE SMOKESCREEN

Newhaven's office, located in a modest four-storey yellow building near a central roundabout on James Walter Francis Highway in British Virgin Island's Road Town, serves as a postal office box for other offshore companies too, according to the 2017 Paradise Paper leaks.

In 2015, Newhaven Corporate was penalised with a fine of USD 25,000 under BVI's money laundering laws "for failing to properly engage in or undertake customer due diligence" and "for failing to adopt relevant measures or additional measures or checks in non-face to face business from Singapore's Accounting and Corporate Regulatory Authority.

In addition to being a tax haven, the BVI is a secrecy jurisdiction, and companies are not legally obliged to name their shareholders or directors on any official filings.

Countries in the Caribbean islands do not usually go after shell companies, because they want the money to circulate within their system, said Ahsan H Mansur, executive director of Policy Research

"They do not need the tax. They need the investment. So, they can offer tax exemptions. But we need our taxes, and by taking the money out of

The asset's rental value was USD 570,000 in 2018, the earliest year the property could be linked to Alam. Then in 2022, a Singaporean trust Zico Trust Ltd - became its legal owner.

Trust's website states that the benefits of setting up a trust include confidentiality and wealth protection. "Trusts can be established offshore (outside of the settlor's home country) and privately, thereby ensuring confidentiality of

the settlor," said the website. It adds, "Wealth protection is a major advantage of private trusts. Since the trustee is the legal owner of the assets, the settlor relinquishes his rights. In most cases, this ensures a form of protection against creditors, bankruptcy, exchange controls, hostile governmental authorities

The couple owned a second home in Singapore until 2023, when the ownership was transferred to another trust called Padang Trust Singapore Pte Ltd.

Singapore abolished estate duty in 2008. So, the income distribution of capital from Singapore trusts are exempt from tax, and successors of a Singaporean trust can be included as beneficiaries without any estate duty. UNDER ACC SCANNER

Capital flight has long been a global problem, with many big corporations and high-profile individuals running offshore businesses to evade high taxes at home. As for Bangladesh, between 2009 and 2018 the country lost USD 8.28 billion, nearly three times the cost of the Metro Rail Line 6 (Uttara to Motijheel), to illicit money outflow every year, according to an estimate by Washington-based think-tank Global Financial Integrity.

In the wake of mounting allegations of capital flight from Bangladesh, the government offered an amnesty in FY 2022-23, allowing Bangladeshi nationals to bring back their undeclared money from abroad by paying a flat 7 percent tax. The government has withdrawn the amnesty this year.

When S Alam's Singaporean empire was expanding and changing hands in 2020-21, different media, including English daily New Age, reported how S Alam Group had been borrowing thousands of crores from Islami Bank and other Shariahbased banks in Bangladesh.

After media reports in 2022 unearthed how his companies were securing one questionable loan after another, the High Court ordered the Bangladesh Financial Intelligence Unit of BB, the Anti-Corruption Commission and the Criminal Investigation Department to investigate the loan scams.

In a suo moto rule on December 4, 2022, the HC asked the respondents to explain why "the failure and inaction of the respondents in taking appropriate legal steps and actions against the entities and persons who have misappropriated and laundered a huge amount of money from the Islami Bank Bangladesh Ltd. and other banks taking loans in the name of fake, fabricated and nonexistent companies/entities using various unethical mechanisms and massive irregularities as mentioned and disclosed in different newspaper reports, shall not be declared illegal."

The court also asked the respondents to take action against the wrong-doers.

The HC order reached the ACC on April 4 this year.

"We remain vigilant about money laundering. Currently we are investigating Islami Bank's lending,' said Md Khurshid Alam Khan, panel lawyer for the ACC.

Five years after its launch, Alam's Canali Logistics proceeded to buy a 328-room hotel – Hotel Grand Chancellor Pte Ltd – in Singapore's "Little India" for about USD 177 million, according to a circular sent by the hotel's previous owners to its shareholders and the Singapore Securities Exchange on August 26,

"Under the SPA [sales and purchase agreement], it is provided that the Consideration [the contract value] will be paid in cash in various instalments,' the circular reads, adding that Canali has already "paid S\$18.6 million (about USD 14m) inclusive of the initial deposit and the balance deposit upon execution of and pursuant to the terms of the agreement."

According to the offshore leaks database created by the International Consortium of Investigative Journalists, nearly 6,000 shell companies are linked to

Singapore. Alam and his wife are also linked to an offshore shell company, Peacock Property Ltd, in the British Virgin Islands (BVI). More than 17,000km away from Singapore, BVI is a tax haven with no income, corporate, or capital gains tax.

Alam also bought a company ACLARE Investment Ltd - in 2016 in Cyprus, another tax haven. The company was later renamed ACLARE International, according to documents obtained from Cyprus' Department of Register of Companies and Official Receiver.



Amend tobacco control act, save lives

Speakers urge govt

STAFF CORRESPONDENT

The government should amend the tobacco control act as soon as possible to reduce premature deaths linked to the consumption of tobacco products, Prof Dr ABM Abdullah, personal physician of Prime Minister Sheikh Hasina, said at a roundtable yesterday.

He made the remarks at "The Current Status of Tobacco Control Act and Tasks to Do", jointly organised by Bangladesh Health Reporters' Forum and the National Heart Foundation at the health directorate headquarters in the capital's Mohakhali.

"There is no benefit to using tobacco. Rather, it causes different types of disease, which kill around 450 people every day in the country. So, the act needs to be amended," said Abdullah, who is also a University Grant Commission professor.

Stressing the necessity to prevent smoking, Abdullah directed the authorities to pass an act to "ban" tobacco products, such as jarda and gul.

The tobacco business groups always consider their profit, said the professor. "But a larger sum of money is being spent on the treatment of tobacco-related diseases than the revenue the government earns from this sector," he added.

Prof Abul Bashar Mohammad Khurshid Alam, director general of health directorate, highlighted the health impact of tobacco.

"A smoker needs to quit smoking for at least a week before any surgery as the use of anaesthesia risks their lives. However, we do not have any choice in case of emergency surgeries," he said.

Emphasising the importance of mass awareness in this regard, he proposed integrating the message into government campaigns and advertisements.

Prof Dr Ahmedul Kabir, additional director general (planning and development) at the health directorate, proposed increased taxation on tobacco products.

"If the tax amount is doubled, around Tk 8-10 crore collected as taxes can be added to the health sector budget," he said.

Prof Sohel Reza Chowdhury, head of epidemiology and research division at National Heart Foundation and Research Institute, presented a keynote at

In his keynote, he stated that tobacco kills 1.61 lakh people in the country every year, which is around 19 percent of all deaths.

"Tobacco consumption, in most cases, leads to cardiovascular diseases," he said.

He also explained the necessity for a stricter amendment of different sections of the existing Smoking and Using of Tobacco Products (Control) Act, 2005, amended in 2013.

Smoking is now prohibited in selected public places and on public transport. A ban on the advertisement of tobacco products was also imposed, and a mandate was issued to ensure health warnings on product packages.

Moderated by Rashed Rabbi, president of Bangladesh Health Reporters Forum, health reporters from different media houses attended the event.

YUNUS CASE Dispose of charge framing order in 2 weeks **SC directs HC**

The Supreme yesterday asked High Court to dispose in two weeks the rule that questioned the labour court order framing charges against Nobel Laureate Prof Muhammad Yunus and three other officials of Grameen Telecom in a case filed over labour law violation.

A full bench of the Appellate Division of the SC headed by Chief Justice Hasan Foez Siddique passed the order after disposing of two separate petitions filed by the state and the Inspection for Factories Establishments Department challenging the HC rule.

Following a petition filed by Yunus, an HC bench led by Justice Md Ruhul Quddus on July 23 issued the rule asking the state to explain why the labour court order that framed charges against him and three others of Grameen Telecom in the case should not be scrapped.

Seven killed, 25 hurt in road accidents

Seven people were killed and 25 injured in road accidents in five districts during the last two days, according to reports from our correspondents.

In Narsingdi, three people were killed after a CNG-run auto-rickshaw was hit by an unknown vehicle on Dhaka-Sylhet highway in Shibpur upazila early

The incident took place around 12:15am in Sayednagar area when the victims were going to Bhelanagar from Sayednagar, said Abul Khayer, sub-inspector of Shibpur Highway Police.

Nasir Uddin, 26, driver of the autorickshaw died on the spot and the other two -- Joj Mia, 23, and Shahin Hossain, 28 -- succumbed to their injuries on the way to a hospital.

The bodies were taken to Narsingdi Sadar Hospital morgue for autopsy. In Dhaka, a man died after being hit by a bus in Jatrabari yesterday.

The deceased, identified as Abul Khaver, 40, was a rickshaw-van puller. The accident took place at Chandankotha area around noon.

Champa finds success in DRAGON FRUIT

A couple of years back, if someone told Champa Begum a fruit that originated in Central America would change her life, she would probably not believe them.

And now, she has emerged as a successful woman entrepreneur, cultivating dragon fruit, on a family-owned land in Baniyali village under Haibatpur union in Jashore Sadar upazila.

This year, the garden has produced the pink fruit attracting visitors every day.

In the beginning of 2022, Champa was struggling to support her ailing husband and child. She was somehow managing the family by rearing poultry and livestock at home.

Six months later, she participated in a courtyard meeting for the Feed the Future Bangladesh Nutrition Activity Project of Jagorani Chakra Foundation (JCF) and later turned one bigha of her land into an organic dragon fruit plantation, investing Tk 1 lakh.

Champa planted 512 dragon fruit saplings on the land. She nurtured these without using the advice of agricultural officials

from the project. After six months, the plants began to bear fruits. At the end of the year, Champa earned a considerable profit from the harvest. "I began dragon fruit cultivation in the area with help of the project and relevant digital information. I also received entrepreneurship development

training, which helped me find is on a rise, Champa said she success. I am currently supplying safe and nutritious dragon fruit to people," said Champa.

"When I started out, many objected to a woman working in the fields. But I proved everyone wrong. Now people from near and far come to visit my garden every day," she added.

expects to earn Tk 8-9 lakh by selling the fruits this season.

Trees can bear fruits for 30 vears if the garden is properly taken care of, she added.

Fulima Begum of Baniyali village is one of those who took inspiration from Champa's example.

She said other women were any chemical fertilisers, following also inspired by her to start cultivating fruit in the area.

A dragon fruit tree takes one to two years to mature. A matured tree bears 25 to 30 fruits, over six months between June and November. The current market price of the fruit is Tk 200-300 per kilogramme, but organically harvested dragon fruit can fetch Tk 350-400 per kg, she said.

Sharing that cultivation cost

"Following Champa apa, I also started dragon fruit cultivation with 200 saplings. I hope to see results soon," she said.

Abu Talha, additional deputy director of the DAE in Jashore, said, "We believe that Champa Begum revolutionised the cultivation of this attractive crop in the region. If she needs any assistance, the department will definitely provide her with necessary support."



After the meeting, Ashok told reporters that as there were some technical issues, a technical team of the EC held the meeting.

"It was discussed how to prevent propaganda that spreads via Facebook, especially hate and communal speeches, and misinformation, or how these will be deleted, removed and blocked," he said.

A focal person of the EC will be assigned to be in touch with Meta.

"What appears to be negative to us, we will tell them and they will remove it. Such steps will be taken only regarding various electioncentric contents, if we request for that," he said, adding that the process would start after the polls schedule is announced.

He, however, did not mention the process of how the EC would determine propaganda. discussion is still at the preliminary stage," he said.

The election is likely to be held in late December or early January next

Chief Election Commissioner Kazi Habibul Awal earlier said the schedule would not be announced before October. He hinted that the schedule can be unveiled 50 or 60 days ahead of the election day.

Before the last parliamentary election held on December 30, 2018, the EC started to monitor the social media platforms, especially Facebook, to prevent the spread of propaganda centring that polls.

The EC faced huge criticism, as it instructed for slowing down mobile internet by shutting down 3G and 4G services on election day in December 2018.

Ex-Basic Bank chairman, 13 others charged

Director Md Ibrahim submitted the number of bankers and borrowers charge sheet against them to the Dhaka Metropolitan Senior Special Judge's Court.

FOUR ORDERED TO SURRENDER The High Court yesterday directed four Basic Bank officials to surrender before the lower court concerned in six weeks in connection with 20 corruption cases filed over the bank's loan scam.

During the hearing, Corruption Commission (ACC) lawyer Khurshid Alam Khan produced the charge sheets of 20 corruption cases before the bench in compliance with its Wednesday's order.

The ACC has approved the charge sheets against former Basic Bank Chairman Sheikh Abdul Hye Bacchu and 146 others in connection with 59 cases filed over embezzlement of Tk

We must end human trafficking

Addressing root causes of trafficking needs concerted efforts by all

It is disheartening that human trafficking still poses a serious threat to Bangladesh despite the progress made in combating it in recent times. There are a number of special tribunals to deal with trafficking-related cases, and as per the US State Department's 2023 Trafficking in Persons (TIP) Report, 94 traffickers were convicted in 35 cases in the latest reporting period, whereas 18 were convicted in 11 cases in the previous period. Legal instruments are vital in the fight against trafficking, so the rise in convictions should convince us of the effectiveness of ongoing measures. However, as experts have pointed out at a recent event, significant challenges

While legal consequences do serve as deterrence, trafficking will continue to occur unless we address its root causes such as poverty, inequality, and lack of education. These factors often make individuals vulnerable to exploitation and entrapment by traffickers, who also take advantage of poor social and administrative safeguards that are in place. For a multi-dimensional problem like this, the response needs to be multi-dimensional, too. Experts at the event highlighted a number of areas where the authorities must intervene simultaneously and redouble existing efforts.

The first challenge is to "cut off the source", which the government can do by implementing comprehensive socio-economic policies aimed at uplifting marginalised communities - where the victims usually come from - and providing them with better opportunities for education and sustainable livelihoods. This is a big task, of course, but eradicating poverty can help address a lot of other critical challenges as well. Continuously raising awareness is also crucial, as many potential victims and their families may not be aware of the dangers of trafficking or may lack knowledge of available support services.

The next front is institutional. Ensuring proper institutional safeguards requires a thorough review of related manpower and law enforcement agencies and plugging any hole that exists. A vital part of this is strengthening the justice system, including enhancing the capacity of investigators and prosecutors. While the numbers provided by the TIP report are encouraging, the rate of convictions in general is still frustratingly low. An analysis of the convictions shows that the courts sentenced most traffickers to just fines. The imposition of fines rather than jail time weakens deterrence and likely creates security and safety concerns, particularly for victims cooperating with officials. We must, then, build a strong legal framework with well-trained investigators and prosecutors that can ensure that traffickers face appropriate consequences for their actions. We also need to ensure every victim gets the support and protection they deserve.

Finally, collaboration among all the sectors and stakeholders is vital to a successful anti-trafficking strategy. Everyone must play their part so we can make it impossible for the traffickers to commit the crime, or get away without

End the stalemate in Ruet

Appoint a VC urgently to run all academic, administrative activities smoothly

It is nothing new that public universities in Bangladesh are plagued with various irregularities that often hinder their academic and administrative activities. From the falling standard of education to nepotism and corruption in appointing teachers and staff, from unhealthy student politics to rampant seat trade by the BCL – the list of problems they face seems never-ending. The ongoing stalemate at the Rajshahi University of Engineering & Technology (Ruet) is a case in point. According to a reportby Prothom Alo, the university has been running without a regular VC for a year now, which has been hampering its activities. Many departments, for example, are failing to hold regular exams, while the promotion of more than a hundred teachers has also been stalled. Many teachers are unable to go outside the country even after receiving scholarships, while some are not getting NOCs from the administration to go oversees for emergency treatment.

Reportedly, after the term of the last VC expired at the end of July last year, the Ministry of Education appointed the dean of the Faculty of Applied Science and Humanities as acting VC. Although he handled the day-to-day responsibilities of a VC, he was not mandated to take care of the appointments, promotions, or take many major academic decisions. After he resigned on May 28 this year, in the face of a movement from teachers, the university has been literally limping along. Last month, the students waged a movement demanding the announcement of exam dates. Although they were assured by their teachers that the exam dates would be given soon, many departments have still not been able to do so because of the absence of department heads. The situation is as bad

The question is, should a public university run like this, and for such a long time? What could be the reason for not appointing a VC in this vital university? What role are the education ministry and UGC playing to solve the crisis? What will happen to the thousands of students whose academic life is being hampered due to these administrative problems? How will the university address the issue of session jam that will follow after a year of such a stalemate? We urge the government to take the issue seriously and immediately appoint a VC at Ruet following proper procedures. It must not allow the crisis to linger anymore.

Disaster risk financing is the way to go

In the face of a rapidly deteriorating climate situation, a framework or system that allows countries and developmental organisations prepare funding in advance has become almost mandatory. It is largely seen that funding that is prepared after a disaster strikes is neither timely

nor wholly successful. A study conducted by the International Federation of Red Cross and Red Crescent Societies (IFRC) mentions that the number of people in need of humanitarian assistance due to climate disasters is projected to double to 200 million by 2050. Another study conducted by START Fund Bangladesh mentions that around 12.10 million people, belonging to some 2.71 million households, could potentially be affected by different climate-induced disasters such as monsoon floods, flash floods, river erosion, cyclones and landslides annually. Research has also found that a minimum of 18.33 million people may get exposed to climate-related hazards in all 64 districts of Bangladesh a year between 2021 and 2025.

Between 2000 and 2013, natural disasters cost Bangladesh more than \$10 billion in economic losses. Available

funding for relief, rehabilitation and reconstruction, however, stood at \$2 billion only. Measuring the value of non-economic losses such as health hazards, losses to education, etc is more difficult; experts predict those losses to be valued at much higher.

Another study by Start Fund, spanning the last nine years, calculated that 1,053 lives were lost and 9.4 million people displaced during different climate-related disasters in 58 districts of the country since 2014. The existing finance mechanisms are not comprehensive or anticipatory in nature and create more barriers for vulnerable countries. Funds for climate-induced disasters are mostly raised at events, whereas disasters, when they strike, may not give responders enough time to arrange fundraisers to raise funds. They are neither sufficient nor efficient to deliver finances of the speed or scale necessary to respond to losses and damages. We need to shift the focus from response to protecting people ahead of shocks. Relying on preagreed plans and finance is a faster, more dignified and cost-effective approach to disaster and crisis.

The solution? Disaster risk

reduce losses and damages associated folders most of the time. Utilising it, with the sudden onset of climate disasters. The United Nations says that for every \$1 invested in such a fund, \$6 can be saved, with additional benefits of up to \$4. Investing in climate resilience projects even creates jobs and saves money. Just a 24-hour warning before a storm or heatwave can curb ensuing damage by 30 percent. It was calculated that spending \$800 million a year could translate into savings of \$3-16 billion, with additional benefits of \$66 billion annually.

The key actions should consider: i) investing in early warning systems and capacities to support anticipatory action; ii) investing in local capacities to disseminate and act on early warnings at the community level; and iii) investing in preparedness capacities at the local level to ensure actors are able to rapidly implement anticipatory actions.

Before one can truly conceive of an up-and-running anticipatory fund programme, there must be proper data analysis - reviewing history, consulting community wisdom, and identifying causes and concerns. Many organisations – i.e. IFRC, WFP, Friendship International, ADPC, etc in Bangladesh and abroad are moving to create these models, through which it is possible to predict disasters, get central approvals taken prior to a disaster, and go for fund mobilisation on site as soon as the warning signals are visible. The more localised the model, the more acute the impact.

Rather than waiting for aid to come through, low- and middle-income nations need to gradually come out of disaster risk management and ensure that budget allocations at each level include anticipatory funding instead.

A significant benefit of such a research-based climate awareness and disaster finance model is a stellar early warning system, interpreted differently for different locations. The wider the area it covers in terms of safeguarding people and their livelihoods prior to a disaster, the more successful it would be considered. This could also help spur local action, catalysing a proactive approach in the local people to safeguard themselves. The beauty of such models is also that these can be developed remotely, by young people and those that have the technological know-how to do this.

development Governments. partners, the private sector and civil society should all come together through COP28 and UN-GPDRR 2024 to co-create such efficient and accountable mechanisms that would keep communities on the frontline, considering loss and damage impacts. In pictures and videos that have gone viral, the senior BNP leader is seen having lunch with an unlikely host, the chief of the Detective Branch of police. It was a culinary showdown, with enough fruits and dishes to give anyone, as the saying goes, a 'fine dining" experience. Although Gayeshwar has later clarified that he only accepted food brought from the DB chief's home, the spectacle held a power of its own, causing reactions both funny and speculative.

A second spectacle witnessed on the same day had another senior BNP leader, Amanullah Aman, tied to a hospital bed, receiving an unexpected lunch package courtesy of the prime minister herself. This image too quickly went viral.

So there it was: proof that Prime Minister Sheikh Hasina's government is not insensitive to the needs of political rivals, offering them food and hospitality even when they were found in the crosshairs of law enforcement. Both leaders, in case vou didn't know, sustained injuries earlier in the day during BNP's sit-in programme at the city's entry points both, ironically, beaten in clashes with police or ruling party activists. Under pressure from all sides, Awami League was not about to let the potential of this photo op go to waste. labelled it "shameful."

It wasn't a "date" so much as it Its general secretary, Obaidul Quader, while denying his party had anything rather absurd turn of events. But to do with the public dissemination of these images, couldn't resist mocking: "Why had he [Gayeshwar] eaten the meal? Was he that hungry? What type of a political leader is he?"

Whichever narrative you find yourself leaning toward, it must be acknowledged that such pictures of apparent hospitality are so rare in our present political history that one needs to go back over 15 years in time for the closest reference to what a newspaper has termed "video politics" - it was during the last caretaker government, before Awami League came to power, when videos of one of its veteran leaders, then in custody, with fruits placed in front of him, were widely disseminated.

The problem with such images is that once they go viral, it is impossible to un-viral them or the message they ostensibly contain. It's little wonder that a significant percentage of social media users - in admiration or contempt – found the Gayeshwar/ Amanullah spectacles compulsively absorbing.

But the truth eventually comes out. The lunch is eventually seen for what it is - not a lunch of the kind we know, but a poor attempt at making up for brutalities publicly inflicted, brutalities that, in the age of a punitive US visa policy, may end up blowing up in the face of those behind them. Or at least this is how BNP's general secretary wants us to review this episode. Unfortunately for Awami League, this may just outlast all other theories making rounds at the moment, and unfortunately for us, the party may not care.

Public beating followed by public courtship – is this going to be a new political trend then? What's next on the menu? A parliamentary potluck for the surviving opposition MPs? A cabinet buffet? A charity football match between the serial beaters and serial victims of our confrontational politics? A sword duel to decide who gets to sit at the helm? Seeing how things have taken a strange turn lately - misusing authority to stage the optics of serving wounded/ detained political opponents - it may not be long before "you've been served" enters the glossary of political double entendre.

Jokes aside, there is really no takeaway from Saturday's food fiasco. It will go down as yet another example of pointless political posturing - an inconsequential subplot, really, in the big political drama that is currently unfolding in the country.

US CONGRESSIONAL HEARING ON UFOS

Are they fact, fiction, or fantasy?



On July 26, 2023, the House Oversight Subcommittee on National Security, the Border and Foreign Affairs of the United States House of Representatives convened to hear testimony from three retired military veterans regarding their sightings of Unidentified Anomalous Phenomena (UAP), a new term that encompasses not just Unidentified Flying Objects (UFOs) but also any craft or phenomena observed in space or underwater that cannot be identified. The hearing was held after the whistleblower David Grusch, a former intelligence officer of the US Air Force, claimed that the US government was hiding evidence of "non-human intelligence" in its possession.

Before discussing the outcome of the hearing, a brief history of UFOs is in order. Following the publication of HG Wells' The War of the Worlds in 1898, there was a wave of reports of strange objects seen sailing through the skies in the US as well as other parts of the world. Later, in his book Chariots of the Gods? written in 1968, Erich von Däniken presented the theory that ancient Earth had been visited by aliens. Interest in UFOs increased greatly during World War II when US fighter pilots used the term "foo fighters" to refer to unexplained sightings in the sky

The modern fascination with UFOs began with a widely reported sighting on June 24, 1947. While flying a small plane near Mount Rainier in Washington, Kenneth Arnold, a businessman from Idaho, reported seeing nine dazzling, diskshaped objects drifting in a tight formation. Two weeks later, a rancher reported finding unidentifiable debris near Roswell, New Mexico. Since then, there have been numerous reports of encounters with UFOs.

Now, back to the hearing where former US Navy aviator Ryan Graves, former US Navy commander David Fravor, and whistleblower David Grusch testified about UAPs. Ryan Graves told the panel

find a little far-fetched."

Representative Burlison is right on the money. There were many gaping holes and inconsistencies in the testimony of the officers. Hence, their testimony does not have any scientific merit whatsoever. Also, if the US government is indeed running a secret UFO research programme, it is simply wasting taxpayers' money.

However, hyperbole about UFO sightings begs the question: are UFOs real? Are they fact, fiction or fantasy? We cannot answer these questions until the aliens get in touch with us or we find evidence of their existence. Anyhow, if they are real, then the high-speed, sharp-angle turns of their spaceships darting at supersonic speed through Earth's atmosphere without a sonic boom violates some of the fundamental laws of physics.

Furthermore, calculations based on known propulsion systems indicate that it would take thousands of years for an alien spaceship to travel the distance from even the nearest star, Alpha Centauri A, which is 41.6 trillion kilometres away. The travel time could be cut down to a few decades if the spaceship could travel at speeds comparable to the speed of light. Any alien society that could do so routinely would be far more technologically advanced than ours.

that commercial airline pilots had spotted UAPs operating in military airspace. He believes that it is an "urgent and critical national security issue" that deserves better scientific scrutiny. But the stigma associated with sightings "silences" possible witnesses from reporting the episodes. He wants the government to establish a "safe and transparent reporting process." David Fravor asserted that in 2004, he and three fellow military pilots saw something "unsettling" above the Pacific Ocean, hovering below their jets. As he descended to inspect the object, a UAP with no visible rotors, wings or exhaust began to ascend and approach his fighter jet. According to him, it suddenly vanished, only to reappear a few seconds later. But this time he saw it 60 miles away, accelerating to "supersonic speeds."

The most dramatic moment of the hearing came when David Grusch claimed that he is absolutely certain the US government is in possession of "intact and partially intact" UAPs. He said that over a four-year period, he interviewed dozens of individuals who recovered "non-human biologics" from UAP crash sites. Grusch talked about many friendly ears in the committee who were already convinced that the government is involved in secret programmes involving aliens and UAPs.

Does Grusch's allegation of the government possessing UAPs hold water? During the hearing, Grusch did not present any material evidence in support of his claim. Besides, in June, the Pentagon said it could not find "any verifiable information to substantiate" the claims about crashed alien spacecraft. While the government might be successful in concealing evidence for a short time, it seems implausible to them that such evidence could remain secret for decades. It is thus inconceivable that the government is trying to put a lid on evidence of alien visits.

On the other hand, conspiracy theorists, who also believe in the abduction of earthlings by aliens, allege that the government is taking advantage of UFOs to design new military hardware via "reverse engineering." However, reverse engineering UFOs is as unlikely as expecting Neanderthals to

Largely out of concern that UFO sightings by Arnold and others might represent new types of aircraft developed by the Soviet Union, the US Air Force hired teams of scientists to investigate the incidents. After nearly two decades of sifting through evidence, the overall conclusion was that there was no reason to believe that UFOs are either highly advanced Soviet aircraft or spacecraft piloted by aliens from other worlds.

So, what are these mysterious objects that were sighted by so many? What can science say about UFOs? Although a staple for science fiction movies and novels, the fuzzy blobs and spinning lights are definitely not UFOs. We can attribute the sighting of UFOs to many known astronomical phenomena, such as bright stars, meteors, or asteroids with orbits close to Earth. Because of its high luminosity, Venus is often mistaken for a JFO when it appears low on the horizon.

The UFOs could also be aircraft, gliders or balloons, or a weather-related spectacle known as St Elmo's fire, caused by reflections of light from ice crystals in the atmosphere, or "sprites" that are flashes of electrical discharges triggered by thunderstorms high in the atmosphere, or "lens clouds" - a UFO-shaped object that is formed when wind blows moist air over tall structures like hills and mountains, seen in the skies over Turkey in May 2023.

As for Arnold's UFO, it could be a fireball a meteor breaking up upon entry into Earth's atmosphere. The debris in Roswell, according to the US military, are the remnants of high-altitude balloons carrying acoustical equipment to monitor Soviet nuclear tests, and foo fighters were probably St Elmo's fire.

Finally, the absence of evidence is not evidence of absence because there is no way for us to verify someone's eyewitness account of a UFO. Nevertheless, for all its faults and limitations, science is the best means by which rational beings can distinguish between what is real and what is not real. We can therefore conclude that UFOs are not real. Instead, they are fantasies of a stressedout society.

Protection of minority shareholders

A minority shareholder is an individual or entity that owns a minority stake in a public or private company. Therefore, it is always important to protect the rights of minority shareholders of companies.

Minority shareholders are often at a disadvantage compared to the majority shareholders. This is because minority shareholders typically own a smaller percentage of the company's shares, which gives them less voting power and influence over the company's management. On the other hand, the majority shareholders can control the company's board of directors and make decisions that benefit them at the expense of the minority shareholders. Minority shareholders may be subjected to unfair treatment by majority shareholders, such as being denied dividends or being excluded from decision-making. As a result, it creates an issue of trust between majority shareholders and minority shareholders.

In Bangladesh, the Companies Act, 1994 offers certain safeguards for minority shareholders. According to section 233 of the Act, minority shareholders have the right to approach the court and seek remedies if they believe they have been prejudiced by the decisions of the majority shareholders. Subsequently, the court has the authority to issue orders aimed at safeguarding the interests of the minority shareholders. Therefore, when the minority shareholders are discriminated against by the majority shareholders, a petition can be filed under

If the court is satisfied that the minority shareholders have been oppressed, the court may modify the resolution, regulate the conduct of the company's activities, or amend any provision of the memorandum and articles of association of such company. If the court orders to modify the memorandum or articles of association, such changes may not be reversed without the permission of the court. Acting in contravention to an order passed by the court for protection of minority shareholders would be deemed to be contempt of court and is punishable.

Protecting the rights of minority shareholders means educating them about their rights and encouraging them to participate in the corporate company processes. This will help ensure that minority shareholders are aware of their rights and are able to protect themselves from getting



Fighters from Russia's private Wagner mercenary force are being moved close to Nato's eastern flank to destabilise the military alliance, Poland's prime minister said

Wagner soldiers have begun training with the Belarus national army, prompting Poland to start moving more than 1,000 troops closer to the border. On Tuesday it accused Belarus of violating its airspace with military helicopters.

"We need to be aware that the number of provocations will rise," Mateusz Morawiecki said after meeting Lithuanian President Gitanas Nauseda eastern Poland.

"The Wagner group is extremely dangerous and they are being moved to the eastern flank to destabilise it."

The politicians met in the Suwalki Gap, a sparsely populated but strategically important area of Polish territory between Belarus and the Russian exclave of Kaliningrad that joins the Baltic states to other Nato members.

Nauseda said the number of Wagner fighters in Belarus could be higher than 4,000. We must not only talk about measures

at the national level but also ... what should be done if this situation becomes even more complicated, including the closure of the

border with Belarus," Nauseda said. "This should be done in a coordinated manner between Poland, Lithuania and Latvia.'

Belarus allowed Russian President Vladimir Putin to use its territory as a launch pad for the Ukraine invasion, but has not committed its own troops to the war, reports Reuters.

Meanwhile, Russia said yesterday it had downed seven drones over the Kaluga region, less than 200 kilometres southwest of Moscow, amid a surge in Ukrainian drone attacks targeting the capital.

The defence ministry said it had foiled "a terrorist attack with drones" in the region. Regional governor Vyacheslav Shapsha confirmed on Telegram messaging app that seven drones had been shot down. There were no casualties, he added.

As Moscow's offensive in Ukraine stretches into its second year, drone attacks on Russian cities and towns have

The European Union has called on G20 countries to push Russia to resume a deal allowing Ukraine grain exports through the Black Sea, a letter seen by AFP vesterday said.

EU foreign policy chief Josep Borrell told G20 top diplomats that Russia's agricultural sector was the "main beneficiary" of Moscow's withdrawal from the UN-brokered agreement.

Arindam Bagchi, spokesperson of India's Ministry of External Affairs, made the comments during the weekly media briefing in New Delhi.


"Look, I think there are multiple activities going on [in Bangladesh], people are perhaps commenting on it," he said, referring to the comments made by some diplomats regarding the national polls in Bangladesh.

The whole world may be commenting on it, but India is India and we have a very special relationship with Bangladesh. What happens in Bangladesh, impacts us," Bagchi said, adding the election and the democratic process in Bangladesh have to be decided by the people there.

He said, "Of course, we are closely monitoring [the situation in Bangladesh]. We have a High Commission there.....We hope that there is peace and no violence and the elections are held as per plans."

"On the issue of caretaker government and all, I certainly don't have any comment on it," the MEA spokesman said.

Massive ancient whale fossil discovered in Peru

A newly discovered whale that lived nearly 40 million years ago could be the heaviest animal to have ever lived, based on a partial skeleton found in Peru, scientists said on Wednesday.

The modern blue whale has long been considered the largest and heaviest animal ever, beating out all the giant dinosaurs of the distant

But Perucetus colossus -- the colossal whale from Peru -- may have been even heavier, according to a study published in the journal

Extrapolating from some massive bones found in the Peruvian desert, an international team of researchers estimated that the animal had an average body mass of 180 tonnes.

That would not take the heavyweight title by itself. The biggest blue whale ever recorded weighed 190 tonnes, according to Guinness World Records.

But the researchers estimated the ancient whale's weight range was between 85 and 340 tonnes, meaning it could have been significantly

Dhaka is now hopeful

Indian parliamentary body asks its external affairs ministry to 'address it at the earliest'

Dhaka sees a ray of hope for resolving the longstanding Teesta water-sharing issue with Delhi as an Indian parliamentary committee has recommended the government address the matter.

"This recommendation has generated hope. This is a significant development as MPs from all parties, including BJP, Congress and Trinamool Congress, are there in the committee," Bangladesh foreign ministry spokesperson Seheli Sabrin told reporters at the weekly media briefing

Dhaka is hoping to step up diplomatic efforts to resolve the issue, she said.

The Indian parliamentary watchdog recommended the country address the Teesta water-sharing issue "at the earliest" for improved bilateral ties with Bangladesh.

The committee, in its 22nd report submitted to parliament on July 25, asked the external affairs ministry "to initiate meaningful dialogue with Bangladesh on a regular basis to arrive at a consensus in the Teesta matter, and the progress/outcome may be informed to the
