Prime Minister Sheikh Hasina yesterday declared another 12 districts and 123 upazilas free of homeless and landless people as 22,101 more families were provided with homes under the Ashrayan-2 project.

With the 12 districts and 123 upazilas, a total of 21 districts and 334 upazilas throughout the country have so far become homeless and landless family-free.

## Fight for survival amid ICU crisis

Dengue death toll crosses 350

Rafia, a 14-year-old girl battling dengue, finds herself caught in a distressing predicament within the healthcare system of Dhaka.

Admitted to Dhaka Medical College Hospital five days ago, her condition rapidly deteriorated, demanding urgent Intensive Care Unit intervention. However, due to an ICU crisis gripping Dhaka's hospitals, the sixth grader had to be shuttled between three medical facilities in search of a vacant ICU bed, but with no luck.

She has been seeking treatment at a regular ward at Shaheed Suhrawardy Medical College Hospital, despite needing ICU support.

"Doctors said she needs immediate ICU support. We took her to a private hospital in Dhanmondi from DMCH on Tuesday as the latter didn't have any vacant ICU beds. But the private hospital refused to admit her as her health situation was critical and suggested

we took her to a facility with better ICU support," Rafia's father Riaz Uddin, a welding worker, told correspondent yesterday. They then took her to Suhrawardy hospital

where a duty doctor admitted her after taking an undertaking from her mother Laboni. The undertaking read: "I have been informed about the condition

of the patient and possible consequences. She needs treatment in the ICU. Even after hearing everything, I have agreed to continue her treatment in a general ward at the

Moinuddin, Rafia's uncle, said, "We agreed to such a condition since we have already spent a significant amount on her care and

moving her to another private hospital with superior ICU facilities would cost us even more...something poor people like us cannot afford." My nephew can still be saved

# Law there, loopholes too

## Speakers tell discussion on preventing domestic violence

Setting up victim support centres at upazila and union levels and improved contact with the Ministry of Women and Children Affairs are key issues to implementing the Domestic Violence Prevention and Protection Act, 2010, said speakers at a discussion yesterday.

The discussion on "Domestic Violence Prevention and Protection Act, 2010: Practical Constraints and Implementation" was jointly organised by Brac Institute of Governance and Development, and Citizens' Initiative against Domestic Violence at The Daily Star Centre in

Maheen Sultan, senior fellow of practice, and Pragyna Mahpara,

BIGD, presented the research-based findings at the discussion. findings

research mentioned how loopholes within law, stigmatised social norms and a lack of initiatives contribute to the rising cases of domestic violence.

Lack of monitoring and accountability are also responsible for this situation. Even women's affairs officers themselves are unclear of their roles as protection officers, said the speakers, referring to the research findings.

The findings further highlighted that the act limits the role of police to only providing information and advice and referring the victims to different services. The report also said most police officials seemed

senior research associate from uninterested in helping the victims as they could not take any punitive actions.

The study also found that magistrates and courts consider cases of domestic violence as trivial and personal matters that should not be their headaches. Such incidents are also seen as issues pertaining to women and not as national problems, according to the study.

Lutfun Nesa Khan, member of the parliamentary standing committee to the ministry, said there are numerous obstacles to implementing the act, especially at the grassroots. Meetings are being held to implement the act more effectively, but there is no SEE PAGE 4 COL 2
