2 arrested for impersonating Rab members, raping tourist

Members of Rapid Action Battalion (Rab) yesterday said they arrested two persons involved in raping a tourist and mugging others while impersonating the elite force members.

The suspects, Jahid Hasan, 28 of Chowdhurypara, and Sanowar Hasan, 30, of Shibchar, Chapainawabganj, were arrested from Raja Guest House at Cox's Bazar bus stand area Saturday evening.

The arrested were part of a gang that robbed people in different parts of the district while posing as Rab members, said Assistant Director of Rab-15 (Law and Media) Abu Salam Chowdhury while briefing reporters yesterday afternoon.

Following several complaints, Rab launched an intensive operation and was able to arrest the suspects from the guest house, he said.

In primary integration, they admitted to mugging a businessman near the bus stand in the early hours of Saturday and gang-raping a female tourist in the early hours of yesterday at the same guest house while pretending to be Rab members, the Rab director added.

Rab also found the involvement of one Jahidul Islam in the gang's activities, who is a toll collector for Cox's Bazar Municipality, and is conducting raids to arrest him, he

Two phones and cash, along with a t-shirt and a motorcycle with Rab's monogram, were seized from the arrestees' possession, he added.

Legal proceedings are underway, the Rab official said.



Ctg, madrasa boards pick new dates for 4 HSC exams

The Chattogram Education Board yesterday announced new dates for four Higher Secondary Certificate (HSC) exams that were deferred due to severe flooding in the region.

According to the new schedule, under the Chattogram board, the Bangla First Paper exam will now be held on September 27 while the Bangla Second Paper on October 1.

The English First Paper exam will be held on October 3, and the English Second Paper exam on October 5.

The other exams under this board will be held following the old schedule.

The Madrasa Education Board also published a new schedule for its deferred exams.

According to the notification, the Quran Majid exam will be held on October 1. The Arabic First Paper and Arabic Literature exams will be held on October 3. Furthermore, the Bangla First Paper

exam has been rescheduled for October 5, and the Bangla Second Paper exam will now take place on October 8. It has also instructed students to complete the practical exams between October 9 and October 17. Meanwhile, the Technical Education Board, in a

notification, delayed its exams scheduled for August

17, 20, 22, and 24, without announcing new dates. It said the rescheduled timetable for these exams would be announced later. Exams from August 27 onward will be conducted as per the previous schedule.

PILOT RECRUITMENT HC forms committee to investigate irregularities

The High Court vesterday formed a three-member committee to probe the allegation of irregularities in pilot recruitment and flight operations by Biman Bangladesh Airlines.

The committee is comprised of an additional secretary from the civil aviation and tourism ministry and a high official each from civil aviation and Biman Bangladesh.

The court asked the committee to submit its probe report to it in 30 days.

The bench of Justice JBM Hassan and Justice Razik-Al-Jalil came up with the order after hearing a petition filed by Advocate Md Tanvir Ahmed, a Supreme Court lawyer.

He submitted the petition in April following two reports published in The Daily Star on March 1 -- which was updated on March 13 with the title "Biman paying for hiring unqualified Boeing 777 pilots" – and also on March 2 with the title "Life lost amid irregularities".

Risky loans stand at Tk 377,922cr

At the end of 2022, 80.8 percent of the rescheduled loans remained unclassified.

Ship building and shipbreaking industry accounted for 33.8 percent of the outstanding rescheduled loans, followed by the industrial sector (29.2 percent) and textile and garment (21.1 percent).

"There has been a general rise in classified outstanding rescheduled

loan ratio across most of the sectors."

The highest ratio was observed in the ship building and ship breaking followed by industrial, garment and textile, and the export credit sector.

"This is not a good sign -- it is a legacy of the past and didn't happen overnight," said Salehuddin Ahmed, a former BB governor.

He went on place the blame squarely on the policy.

HC declines to recall its probe order

The bench told Ajmalul that its order has already been signed and therefore, there is no scope for recalling Commission Anti-Corruption lawyer Khurshid Alam Khan, who was present at the courtroom during the

proceedings, told The Daily Star. Contacted, Advocate Mohammad Saifullah Mamun, another lawyer for S Alam Group, said they would now move a written petition before the HC against its August 6 ruling.

Ajmalul, a senior counsel, could not be reached for comments as his cellphone was found switched off.

Yesterday's verbal petition came just three days after S Alam served a legal notice on the government and four national dailies, including The Daily Star, essentially demanding that these newspapers publish no news on

him or his business operations. Two days after The Daily Star published a report, headlined "S Alam's Aladdin's lamp", the HC bench on August 6 ordered the ACC, Bangladesh Financial Intelligence Unit (BFIU) and Criminal Investigation Department (CID) of police to investigate the allegations disclosed in the report.

The HC asked the Bangladesh Bank governor and head of BFIU to come up with a report clarifying whether any permission and approval from Bangladesh Bank has been given to S Alam Group to take the "money in question" to the foreign countries from Bangladesh.

ACC chairman, secretaries at the ministries of finance, Bank and Financial Institution Division, foreign affairs, law and home affairs, chairman of National Board of Revenue (NBR), inspector general (IG) of police, special police super of immigration, and deputy commissioner and superintendent of police of Dhaka have also been made respondents to

The HC asked The Daily Star editor to submit an affidavit with regard to the authenticity of its report published

on August 4 to this court by October 10 and fixed the same date for passing further order on this issue.

The Daily Star investigation found that Alam built a business empire worth at least about \$ 1 billion (Tk 10,000 crore) in Singapore, although there is no record of him taking any permission from Bangladesh Bank to invest or transfer any funds abroad.

The Bangladesh central bank has so far allowed 17 companies to invest outside the country, and this Chattogram-based business giant is not one of them, according to a document obtained from Bangladesh

Yet in Singapore, Alam bought at least two hotels, two homes, one retail space, and other properties over the last one decade, all the while seeking to remove his name from the paper trails, documents cited by the report

Earlier on August 10, S Alam served a legal notice on the government, four editors of national newspapers - The Daily Star, Prothom Alo, New Age and The Business Standard -- and seven journalists of the dailies for reports the dailies published about Alam and his

group over the past few years. The legal notice apparently sought to restrict reporting on S Alam Group.

The notice, also sent by Ajmalul Hossain KC, demands that the home secretary and the information secretary collect the evidence, based on which five articles were written by the journalists of these four dailies, to justify the allegations made against

Alam and his Group. Until such information is provided, the notice demands, the secretaries must ensure that the journalists are stopped from publishing any statements or reports about Alam and his businesses.

It also demands that the two secretaries must ensure that the journalists give an undertaking that they will not repeat such actions in the future. In addition, the notice demands that all such content preserved in any public domain be removed.
