

HUMAN TRAFFICKING 34 Rohingyas rescued in Cox's Bazar 2 'traffickers' held

Thirty-four Rohingyas, mostly children, were rescued from being trafficked while two suspected human traffickers were detained near the Cox's Bazar Central Bus Terminal, police said.

Among the rescued, 16 are children, aged between one and five; 10 are women; and eight are men, Cox's Bazar Sadar Model Police Station Officer-in-Charge Rafiqul Islam told The Daily Star.

They are all residents of camps in the district's Teknaf and Ukhiya upazilas.

"Last night [Sunday night], three to four people tried to escape when police reached the spot after receiving information that traffickers were gathering Rohingyas at the Central Bus Terminal in the Larpara area."

"At that time, police managed to detain two people," he said, adding that 34 Rohingyas were rescued.

"A case has been filed with Cox's Bazar Sadar Model Police Station against the two suspected human traffickers, and on orders from higher authorities, the rescued Rohingyas will be handed over to their respective camp administrations," the OC added.

Provide info on Bangabandhu's killers and get rewarded: Momen

Foreign Minister AK Abdul Momen yesterday said the government would reward those who can provide information on the killers of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

"If you can give us information, you will be rewarded," he said while speaking at a discussion at Jatiya Press Club.

Describing Canada and the US as countries with very strong rule of law, he said they should not shelter murderers.

The five killers who remain fugitives are Khandaker Abdur Rashid, Sharif Haque Dalim, Nur Chowdhury, Rashed Chowdhury and Moslehuddin Khan.

Nur Chowdhury and Rashed Chowdhury have been traced in Canada and the US. Bangladesh wants them to bring them back to the country to face justice.

"But we are yet to do it. If we can, we will feel that it is a great achievement," Momen said.

Momen said the government has written many letters to the US and Canadian governments seeking steps for returning the killers; even the PM wrote to the US president.

He encouraged the Bangladeshis

Government controlling media to hide 'misdeeds'

Alleges Fakhru

BNP Secretary General Mirza Fakhru Islam Alamgir yesterday claimed that Awami League government has been controlling the media for a long time.

"There are so many media outlets in the country, but they cannot work freely. Even after 52 years of independence, the media is not free," Fakhru said.

He made the remarks at a seminar titled "Media in Bangladesh: One and A Half Decades of NIGHTMARE" in the capital's Gulshan.

"Corporate media has been formed in the country, which are owned by wealthy individuals. They established this corporate culture to use it

Recognise them through constitution

Speakers tell discussion on indigenous people

Speakers at a discussion yesterday called upon the government to constitutionally recognise indigenous communities in order to preserve the country's ethnic and cultural diversity.

The government is not constitutionally recognising the indigenous communities to avoid its responsibility towards them, said Prof Mizanur Rahman, former chairman of National Human Rights Commission.

He made the remark at a discussion titled "Preserving Ethnic and Cultural Diversity and the Role of Indigenous Youths for Constitutional Recognition," organised by National Coalition for Indigenous People (NCIP) at Midas Centre in the capital.

Explaining the government's reluctance in this regard, Prof Mizanur Rahman said the government does not constitutionally recognise them for two reasons.

"If the government recognises them as indigenous communities, they are entitled to get all the rights that were guaranteed by the

constitution," he said, adding that the second reason is their lack of knowledge about indigenous communities.

Stressing the need for "self-determination" of indigenous communities, he said the government misinterprets the meaning of the term.

"Whenever we talk about self-determination, the government seems embarrassed as they misinterpret the term. The government thinks that they might want a separate state. However, the communities never made any such demand," Prof Rahman said.

Saying that the government's take is flawed in this regard, Prof Rahman said self-determination actually entails transformative changes for indigenous communities and their equal rights in all spheres of life, including the rights to preserve their lands.

He added that the policymakers also failed to understand the proper meaning of the term "indigenous".

NCIP Secretary General Prof Mesbah Kamal lamented the government's unwillingness to officially observe International Day of the World's Indigenous Peoples.

Demanding constitutional recognition of the indigenous people, Prof Kamal, also a teacher at Dhaka University, urged the government to ensure self-determination of indigenous people by providing them constitutional recognition.

Fuad Chowdhury, chief executive of Deepto TV, said, "Modern states have recognised their indigenous communities and enacted special policies for their welfare. This way, the

HC stays suspension order of CoU student

The High Court yesterday stayed the suspension order of Comilla University student Muhammad Iqbal Monowar for six months.

He was suspended on August 2 for reporting on a speech delivered by the university's vice-chancellor on corruption.

The court also issued a rule asking the university authorities and government to explain why the decision of suspending Monowar, also a campus reporter of the daily Jai Jai Din, should not be declared illegal.

Monowar, 24, is pursuing his masters degree in English at the university.

The HC bench of Justice Bishmadev Chakraborty and Justice Md Ali Reza issued the order and rule following a petition filed by him.

Iqbal's lawyer Shihab Uddin Khan told The Daily Star that there is no legal bar for his client to attend the classes and exams at the university following the HC order.

On July 31, a report titled "Corruption is the reason for development in Bangladesh: CU VC" was published in the daily, detailing some remarks made by VC AFM Abdul Moyeen during a university programme.

In the suspension order, it was mentioned that Monowar was suspended for "violating university discipline".

According to the order, Monowar allegedly

Petition seeks directives to save Arial Beel

Human Rights and Peace for Bangladesh yesterday filed a petition with the High Court, seeking its directives to save Arial Beel -- one of the largest wetlands located in Munshiganj -- from encroachment, illegal earth filling and construction.

It submitted the petition to the HC based on a report titled "Arial Beel under threat", published in The Daily Star on July 22.

The rights body pleaded to the HC to order the DC and SP in Munshiganj and the director of DoE to stop land grabbing, earth filling and construction of illegal structures at Arial Beel.

HRPB President and Supreme Court lawyer Manzill Murshid said encroachment, earth filling and construction of structures at any waterbody are punishable offences under the Natural Water Reservoir Conservation Act 2000 and the Bangladesh Environment Conservation Act 1995.

He said the HC bench of Justice JBM Hassan and Justice Razik-Al-Jalil will hold hearing of the petition today.

5 of a family burnt in blast at Jurain home

Five members of a family were burned in an explosion allegedly caused by a gas leak in a house in Dhaka's Jurain early yesterday.

The accident took place on the ground floor of a four-story residential building in the Madbar Bazar area around 2:00am.

The injured were admitted to the Sheikh Hasina National Institute of Burn and Plastic Surgery, said Inspector Bacchu Mia, in-charge of Dhaka Medical College and Hospital police outpost.

The victims are Altaf Sikder,

70, a snacks vendor; his wife Morjina Begum, 55; their daughter, Mukta Khatun, 30; son-in-law, Atahar, 35; and granddaughter, Afsana Akhter, 5.

Md Mahbub, brother-in-law of Altaf, said his sister's family lived in a rented space on the ground floor of a four-story house. Upon hearing the news, he rushed to the spot and took them to the hospital.

"They have a gas connection in that house. But there is often a gas shortage in the area during daytime. So, they cook their

SYNDICATE AT SHISHU HOSPITAL NHRC to probe allegation

There has long been an allegation that a syndicate is operating within Bangladesh Shishu Hospital and Institute (BSHI) in Dhaka that tricks families of critically ill children and gets them shifted to private hospitals.

Taking cognisance of a report by a private television channel aired on August 4, National Human Rights Commission (NHRC) has decided to conduct an investigation.

Besides, the commission will also write to the health directorate to look
