S ALAM'S BUSINESSES ABROAD

SC halts probe till January 8

The Supreme Court yesterday put on hold until next year the enquiry into S Alam Group owner Mohammed Saiful Alam's offshore businesses for which there is no record of him taking permission from Bangladesh Bank.

The chamber judge of the SC, Justice M Enayetur Rahim, passed the order, setting January 8, 2024, for holding the next hearing on the matter before a full bench led by the chief justice.

The judge ordered that a status quo be maintained regarding the matter until the next hearing.

On August 6, a High Court bench of Justice Khizir Hayat Lizu and Justice Md Nazrul Islam Talukder had ordered the Anti-Corruption Commission.

Bangladesh Financial Intelligence Unit and police's Criminal Investigation Department to probe the findings of a report published by The Daily Star on August 4.

The Daily Star investigation, titled "S Alam's Aladdin's Lamp," found that Saiful Alam along with his wife has built a business empire worth at least about \$1 billion in Singapore, although there is no record of him taking any permission from the central bank to invest or transfer any funds abroad.

At the hearing yesterday, senior lawyers Ajmalul Hossain, Ahsanul Karim and Mohammad Sayeed Ahmed Raza represented Alam and his wife Farzana Parveen, while a number of prominent lawyers in the bar took front-row seats.

On August 21, Alam's lawyers moved the Appellate Division for a stay on the High Court's August 6 suo moto rule.

At the hearing yesterday, nobody represented the government, or any of the government agencies that were ordered to probe Alam's offshore businesses, except for Advocate Khurshid Alam Khan who argued for the ACC.

Attorney General AM Amin Uddin was present at the courtroom, but did not speak. "Why would Legal? Tho

Alam's lawyers argued that the HC's suo moto rule has no legal ground because it was given before the HC verified the authenticity of the evidence used in the newspaper report. Therefore, the court did not have any prima facie

In response, Justice Enayetur Rahim said The Daily Star has the evidence, and asked why it would be a problem if there is an enquiry.

Previously, Alam's lawyers had placed the same arguments in a petition submitted to the attorney general's office, asking for the investigation order to be recalled.

When passing the order on August 6, the HC asked The Daily Star to submit an affidavit by October 10 with regard to the authenticity of its report. Yesterday, The Daily Star

S\$1B SEIZURE

10 S'pore banks asked to deliver documents

Singapore authorities have requested documents from at least 10 banks as they extend a S\$1bn (US\$737m) money laundering investigation, reports the Financial Times.

Public prosecutors told a court yesterday that they were seeking documents from financial institutions linked to those arrested and charged last week in one of Singapore's biggest-ever money laundering cases, the report adds.

The investigation has named two banks so far, Citigroup's Singapore subsidiary and Malaysia's CIMB, while other banks have not been named, reported FT, adding that none of the financial institutions have been charged.

Citigroup said in a statement it was "committed to the

Citigroup said in a statement it was "committed to the fight against money laundering and ensuring the highest standard of governance controls", while CIMB did not respond to a request for comment, it adds.

The 10 individuals, who were detained in simultaneous raids involving 400 officers, are suspected of laundering the proceeds of overseas criminal activities, including scams and online gambling, as well as forging documents, reported multiple media outlets.


The individual included nationals from China, Cyprus, Turkey and Vanuatu. They were all in possession of Chinaissued passports, according to police.

The Monetary Authority of Singapore said that suspicious fund flows and other inconsistencies with documentation had prompted banks to alert authorities, which led to the investigation.

Create economic corridor to boost output, jobs

Says ADB in its recent study

Establishing an economic corridor connecting the key lagging regions of northeast and southwest Bangladesh via Dhaka can ensure 2.6 times the output and generate 2.3 times the employment by 2050, found an Asian Development Bank study.

Bangladesh has its economic growth concentrated mainly in the Dhaka and Chattogram divisions, while other divisions lack adequate physical and social infrastructure to promote their growth.

Currently, northeast and southwest Bangladesh are key lagging regions in the country, said the Manilabased multilateral lender in a report styled "Bangladesh Economic Corridor Development Highlight". The report was launched yesterday in an event at the BICC with Planning Minister MA Mannan as the chief guest.

As Bangladesh enters the next phase of economic growth, it needs to integrate the lesser developed regions into its development blueprint by way of an economic corridor. Creating an economic corridor can drive the massive structural transformation it needs to ensure

billion in 2020 to \$286 billion by 2050. If no corridor is formed, the total output will be \$110 billion in 2050.

Similarly, the total employment generated in the corridor region is expected to be 15.7 million in 2025 and 71.8 million in 2050. In the absence of the economic corridor, the total employment in the region would be 31.1 million in 2050.

Aneconomic corridor has three complementary components: (i) a trade and transport corridor; (ii) production clusters producing goods for both consumption in the domestic market and for international trade; and (iii) urban centres acting as the major market for goods from the production centres and goods imported through international gateways; they also act as a source of labour, technology, support services, knowledge and innovation.

The entire economic corridor conceptualised by ADB encompasses 14 districts, covering 34 percent of the total population.

Along with high population and geographical coverage, the corridor region holds strategic locational advantages.

HASINA MEETS CHINESE PRESIDENT

Xi calls for stepping up cooperation

AGENCIES, Johannesburg

Chinese President Xi Jinping during his meeting with Prime Minister Sheikh Hasina yesterday called on China and Bangladesh to push for high-quality Belt and Road cooperation and give full play to their economic complementarity.

Xi, during his bilateral meeting with Hasina, also urged the two sides to step up cooperation in infrastructure, information technology, new energy and agriculture, among other areas, reports Xinhua.

The meeting between the two was held at the Hotel Hilton Sandton in Johannesburg, South Africa, yesterday evening on the sidelines of the 15th BRICS Summit.

Bangladesh premier arrived in Johannesburg on Tuesday to attend the summit.

On August 24, she will deliver a speech on behalf of Bangladesh as a member of the "New Development Bank of BRICS" at Friends of BRICS Leaders Dialogue (BRICS-Africa Outreach and the BRICS Plus Dialogues) comprising representatives from 70 countries, reports BSS.

Chinese President Xi arrived in South Africa on Monday night.

Foreign Minister AK Abdul Momen, Prime Minister's Private Industry and Investment Adviser Salman Fazlur Rahman, PM's daughter and Theamatic Ambassador of Climate Vulnerable Forum and Chairperson of the National Advisory Committee for Autism and Neurodevelopmental Disorders Saima Wazed, PM's Principal Secretary Md Tofazzel Hossain Miah and Senior Secretary of Foreign Affairs Masud Bin Momen were present during the meeting.

BRICS agrees on expansion

Bloc leaders adopt mechanisms for considering new members

Leaders of the BRICS bloc of leading developing countries have agreed mechanisms for considering new members, South Africa said yesterday, paving the way for dozens of interested nations to join the group which has pledged to champion the "Global South".

Agreement on expansion could help lend global clout to BRICS - Brazil, Russia, India, China and South Africa - at a time when geopolitical polarisation is spurring efforts by Beijing and Moscow to forge it into a viable counterweight to the West.

"We have agreed on the matter of expansion," South Africa's foreign minister

Africa's foreign minister Naledi Pandor said on Ubuntu Radio, a station run by her ministry, following a meeting by BRICS leaders at a threeday summit in South Africa.

day summit in South Africa.

"We have a document that we've adopted which sets out guidelines and principles,

processes for considering countries that wish to become members of BRICS...That's very positive."

Enlarging BRICS has topped the agenda at the summit

Enlarging BRICS has topped the agenda at the summit taking place in Johannesburg. While all BRICS members had publicly expressed support for growing the bloc, there had been divisions among the leaders over how much and how quickly.

Its member countries also have economies that are vastly different in scale and governments that often seem to have few foreign policy goals in common, complicating its consensus-driven decision-making.

China's economy for example, is more than 40 times larger than South Africa's, Africa's most developed country.

UAE fines 225 companies for violating laws

The UAE's Ministry of Economy has imposed administrative penalties on 225 companies with a value of about 76.9 million dirhams (Tk 229.57 crore) to combat money laundering and terror financing, reports the UAE-based Khaleej Times.

It also suspended 50 establishments for three months for failing to register in the anti-money laundering system of the Financial Intelligence Unit. These businesses were put on hold in the third quarter of 2023, the report said on Monday.

Through the anti-money laundering system, the

Through the anti-money laundering system, the Financial Intelligence Unit receives reports of suspicious transactions. It examines transactions and activities to detect money laundering and terror financing.

The goal is to prevent financial criminal activities that could jeopardise the UAE's efforts to meet the Financial Action Task Force (FATF) requirements.

On August 10, the ministry announced that 29 companies operating in the UAE's designated non-financial business or professions (DNFBP) sector had been fined 22.6 million dirhams for failing to comply with anti-money laundering and combating the financing of terrorism (AML/CFT) legislation, according to the Khaleej Times report.

The ministry noted that these firms would remain suspended until they are registered in the anti-money

Wards with 10 or more dengue cases to see spl cleanup drives

Savs DSCC mayor

If a Dhaka South City Corporation ward records 10 dengue cases in a week, then a special drive by cleaning staff and mosquito-control workers would be conducted there, Mayor Sheikh Fazle Noor Taposh has said.

He said the drive would be conducted every Saturday.

The DSCC mayor came up with the announcement while inspecting work on the destruction of Aedes mosquito breeding grounds at Dhaka University yesterday.

"Next Saturday, we are taking another special drive which will be ward-based. We are declaring the wards as red where more than 10 patients are detected in a week."

He urged locals to clean their homes, establishments, buildings and yards themselves on that day.

"No one should go to work that day. This will be the biggest job,"

Taposh said.
"We will have cleaners, mosquito control workers and other officials concerned. We will conduct a daylong combing operation to destroy the breeding places of Aedes mosquitoes. Through this, we can control the

spread of dengue," he added.

The mayor said that they have already found four wards – ward-5, -22, -53 and -60 – where 10 dengue patients were detected in the last one week. "We will conduct the special drive in the wards next Saturday," he

Asked about marking wards "red", a top official of the DSCC said they actually meant that a special focus would be given to those wards and homeowners and residents would be involved in the drives.

"We want active participation of locals in the drive," the official said wishing not to be named.

Sudanese factions fight over key army base

Sudanese paramilitaries fought the regular army in Khartoum yesterday as they targeted a key military base in the south of the capital for the fourth consecutive day, witnesses said.

Fighters from Mohamed Hamdan Daglo's Rapid Support Forces (RSF) began their assault on the vast strategic base on several fronts on Sunday.

Residents of Al-Shajara, the neighbourhood where the base is situated, reported "large losses on both sides" on the first day of the attack when the fighting was constant.

An accused in a narcotics case died Tuesday evening after "falling sick" in the custody of Rajshahi Metropolitan Police.

96 Jamaat-Shibir men indicted over vandalism in 2012

A Dhaka court yesterday framed charges against 96 leaders and activists of Jamaat-e-Islami and Islami Chhatra Shibir in a case filed over torching vehicles and preventing police personnel from discharging their duties in 2012.

Jamaat Ameer Shafiqur Rahman and Secretary General Mia Golam Parwar, a former lawmaker from Khulna-5, are among the accused.

Shafiqur Rahman and Golam Parwar, now in jail, and 78 others, who are on bail, pleaded not guilty to the changes and demanded justice after Dhaka Metropolitan Magistrate Md Saiful Islam read out the charges to them.

Before that, the magistrate dismissed the petitions submitted by the accused for relieving them of the charges.

Eighteen other accused have been on the run since the case was filed against them. Charges were framed against them in their absence. The magistrate issued arrest warrants against them, said Assistant Public Prosecutor Hemayet Uddin

Rohingya youth shot dead

A Rohingya youth was shot dead allegedly by members of Arakan Rohingya Salvation Army (ARSA) at Kutupalong camp in Cox's Bazar's Ukhiya on Tuesday.

The victim was Mohammad Yunus, 18, son of Hamid Hossain of the camp. Sheikh Mohammad Ali, officer-in-charge

of Ukhiya Police Station, said ARSA members opened fire on Yunus around 7:30pm, suspecting him to be involved in the Rohingya Solidarity Organisation, leaving him injured.

2 children drown in a pit

Two three-year-old cousins died yesterday after drowning in a pit filled with rainwater in a village under Bandar upazila of Narayanganj.

The deceased are -- Abdul Aziz, son of Kabir Mia; and Md Ahnaf, son of Md Nuruzzaman.

The incident happened around 3:00pm in Geodhara village under Kolagathia union parishad, confirmed UP chairman Delowar Hossain Prodhan.

The two cousins were playing in front of their house in the afternoon. After an hour or so, they were nowhere to be seen. When their family members started to look for them, they found a pair of shoes beside a hole full to the brim with rainwater. The hole, which is at least five feet deep, was 50 yards away from their house, according to the chairman.

After the boys were rescued, they were taken to the upazila health complex. Doctors announced them dead there, he added.

"Two brothers were playing in front of the house. No one understood how it happened. When we found the boys, they were already dead, said Nuruzzaman, Ahnaf's father.

BRICS agrees

Pandor did not give details of the framework of criteria for considering candidates, simply saying that the bloc's leaders would make an announcement on expansion before the summit concludes on Thursday.

More than 40 countries have expressed interest in joining BRICS, say South African officials, and 22 have formally asked to be admitted.

They represent a disparate pool of potential candidates - from Iran to Argentina - motivated largely by a desire to level a global playing field many consider rigged against them and attracted by BRICS' promise to rebalance the global order.

"The world is undergoing major shifts, division and regrouping ... it has entered a new period of turbulence and transformation," said China's President Xi Jinping, who has long pushed for

the expansion of the BRICS group. "Development is an inalienable right of all countries. It is not a privilege reserved for a few," he told the summit

earlier yesterday. Though home to about 40 percent of the world's population and a quarter of global GDP, the bloc's ambitions of becoming a global political and economic player have long been thwarted by internal divisions and a

lack of coherent vision. Russia, isolated by the United States and Europe over its invasion of Ukraine, is keen to show Western powers it still

has friends. Brazil and India, in contrast, have both forged closer ties with the West.

Brazil's President Luiz Inacio Lula da Silva on Tuesday rejected the idea the bloc should seek to rival the United States and Group of Seven wealthy

Moves to expand the bloc and push its New Development Bank as an alternative to established multilateral lenders are, however, raising some concern in the West.

Werner Hoyer, the head of European Investment Bank, yesterday warned the West it was in danger of losing confidence of the "Global South", unless it urgently intensified its own support efforts for poorer countries.

Create economic corridor to boost output, jobs

There are eight major trade gateways in the BEC region: Mongla seaport, Payra seaport, Benapole land port, Bhomra land port (four in the southwest); Akhaura land port, Tamabil land port, Bibirbazar land port, Nakugaon land port (four in the northeast).

While Mongla and Payra seaports provide sea route trade linkages with the world (currently contributing about 11 percent of seaborne international trade), land ports in the region act as major trade gateways with India, contributing 36 percent of Indo-Bangladesh trade.

Hence, the corridor region has an inherent advantage for international trade-dependent industries from the perspective of importing raw materials and/or exporting finished

Besides, Northeast Bangladesh has an added locational edge with respect to cross-border trade potential with Northeast India, a landlocked territory with a market demand of

\$38.5 billion. Leveraging the logistical advantage, agri-commodities and industries from the Northeast Bangladesh region can find a potential consumer market in Northeast India.

Likewise, Northeast Indian states, beingendowedwith natural resources, can export rubber, limestone and other mineral resources to Northeast Bangladesh, which can act as raw materials for local industries. In addition, Northeast Bangladesh can leverage its proximity with countries like Nepal and Bhutan.

Not just locational advantage, the BEC region is rich in agricultural produce and it has an abundance of natural resources such as gas reserves, limestone, white clay and peat reserves.

being strategically "Despite located and resource-rich, to date, the southwest and northeast regions have not been able to fully utilise their natural advantages due to inadequate

hinterland and connectivity with the trade gateways.

Apart from limited physical infrastructure, inadequate social infrastructure is also a key reason behind the poor economic development. The corridor region lags behind the country in terms of educational infrastructure.

This has created relatively lower employment potential in industrial and service sectors (relatively high wage-paying sectors), which is corroborated by the employment number: 58 percent of the population in the corridor region is employed in agriculture, compared to the national average of 48 percent.

The development of this envisaged corridor may be carried out in two

In the first phase, the southwest portion of the corridor may be developed (Southwest Bangladesh Economic Corridor [SWBEC]); in the second phase, the northeast portion of the corridor (from Dhaka to Sylhet and Mymensingh) may be developed (North-East Bangladesh Economic Corridor [NEBEC]).

To develop the BEC, ADB has identified 56 railway projects to enable efficient rail movement in the region, 114 road projects to increase road density in the region by 38 percent, 33 projects to improve inland water connectivity and 38 projects to address the bottleneck at export and import gateways.

Four partially developed industrial clusters have been identified and 12 manufacturing industries were shortlisted for the whole BEC region.

The industries are food processing, leather and footwear, textiles and ready-made garments (RMGs), jute, nonmetallic mineral manufacturers, shipbuilding, furniture, transport pharmaceuticals, equipment. plastic products, rubber and rubber products, electrical and electronics machinery, and heavy machinery.

Along with the manufacturing sector, the service sector can also

laundering system. If they don't do so within three months, more severe penalties will be imposed.

It urged businesses to follow relevant legislation, maintain the highest levels of compliance, and communicate with relevant authorities if they have any questions or want to request technical assistance, the report said.

The assets, which included properties, luxury cars, and goods, were either seized, frozen or issued with prohibition of disposal orders.

SC halts probe till January 8

At vesterday's hearing, Alam's

submitted the authenticity report to the HC through swearing an affidavit, which was presented at the court.

lawyers also argued that a suo moto rule can only be passed if someone's fundamental rights have been violated. They argued that by ordering a probe, the HC was acting like prosecutors.

The ACC lawver argued that the HC can pass a suo moto rule regarding public wrongs -- and pointed out that Justice Enayetur himself had previously said so in a judgment.

In that judgment, given in a case from November 2017 concerning an investigation into the assets of a retired judge, Enayetur had said that when a public wrong of grave nature has occurred, the court can issue a suo moto rule to protect and uphold the image of the judiciary, the ACC lawyer added.

The HC had also previously passed another suo moto rule against banks owned by Alam on December 4, 2022, based on allegations of loan scams raised by newspaper reports.

In that rule, the HC had ordered the BFIU, the ACC and the CID to investigate the loan scams and explain why "the failure and inaction of the respondents in taking appropriate legal steps and actions against the entities and persons who have misappropriated and laundered a huge amount of money from the Islami Bank Bangladesh Ltd and other banks taking loans in the name of fake, fabricated and non-existent companies/entities using various unethical mechanisms and massive irregularities as mentioned and disclosed in different newspaper

reports, shall not be declared illegal." The court had also asked the respondents to take action against the

Flooding may rise by 36pc

Flooding in Bangladesh is predicted to increase by up to 36 percent in the future if the global emission continues

According to a report published yesterday by Grantham Research Institute on Climate Change and the Environment and Centre for Climate Change Economics. peak river flows in the country could surge by 36 percent between 2070-2099 if the global emission continues.

Even if the emission level remains low, floods will increase by 16 percent during this time compared to 1971–2000.

Currently, floods submerge up to 20-25 percent of Bangladesh every year and extreme floods, when they happen, submerge 55-60 percent of the country.

Citing the disaster management ministry, the report says the 2022 flood in Bangladesh is estimated to have cost US\$1.0 billion and affected 7.3 million people.

The report says over half of the country's population is exposed to high flood risks.

"Climate change is exacerbating this risk and causing damage with an increasingly high financial and humanitarian cost." the report mentions.





BARGUNA-DHAKA ROUTE Launch service suspended due to passenger crisis

OUR CORRESPONDENT, Patuakhali

Launch movement on the Barguna-Dhaka route has been halted due to an extreme shortage of passengers, as a result of the Padma Bridge. Due to the dwindling number of passengers, no launches have left for Dhaka from the Barguna Launch Ghat since Tuesday evening.

Zahirul Haque Panu, vice president of Barguna Traders Association, said if this route is permanently closed, Barguna's businesses will be threatened. The cost of transporting goods will increase, impacting both traders and consumers.

Before the Padma Bridge was inaugurated, every launch on the route would carry 400 to 500 passengers each day, said launch owners. However, not even 100 passengers are available since the bridge opened. There were previously four luxury passenger launches on the Dhaka-Barguna route. Following the opening of the Padma Bridge, only one launch remained on the route.

Experts at a workshop in Rajshahi yesterday advocated for transformation of the Barind region from a rice bowl to an export-focused agricultural hub to save the declining water resources.

The workshop titled "Joining forces for catalysing transformation in Barind Hotspot" was held at the $conference\,room\,of\,the\,Barind\,Multipurpose\,Development$

More than 70 experts joined the workshop, which was jointly organised by the Coca-Cola Foundation, 2030 Water Resources Group, Dascoh Foundation, Syngenta Foundation, and BMDA.

The experts said Barind is a country hotspot owing to drought, low rainfall, and groundwater depletion. The region should grow less water-consuming crops instead of Boro rice to conserve water.

They also said the farmers and agribusiness owners will require assistance in identifying extension activities for exportable crops, marketing their products, and improving the supply chain.

Environmental pollution and encroachment have left Kharia river in Mymensingh's Phulpur upazila on its deathbed.

authorities concerned, however, seem to have turned a deaf ear to the issue as their indifference in monitoring the situation is quite apparent, alleged locals.

The 25km long river is a tributary of the Old Brahmaputra and falls into Kongsho river in Netrokona. The river is also connected with several local water bodies, including Kurhar Doba (swamp).

During a recent visit, this correspondent saw heaps of garbage being dumped in different areas on the river bank. The garbage is being piled up for years apparently with no one to check this menace.

Once a great source of water for ever forbade them from doing so. agriculture and local fisheries, the river has now become a narrow stream. Hyacinths cover on the water and bushes on the bank have made the river look non-existent, said Abu Mia, a farmer from Poyari village.

The river used to be the life line of agriculture and ecological balance of this locality but it has been left in a serious state of negligence, lamented Azizul Islam, a school teacher.

People have been dumping daily garbage on the river bank for years. Besides, the local butchers also use the river bank as their slaughtering ground, and throw away the animal wastes in river water.

Admitting the matter, Saidul Islam, a butcher at Amuakanda Bazar, said they have been slaughtering animals on the river bank for some 10 years and nobody

Established in 2001, the Phulpur

municipality with around 40,000 residents could not even manage a proper garbage management system in the last 23 years, said ATM Robiul Karim Robi, a local

Only a few dustbins were found in the municipality, including one adjacent to Phulpur Upazila Health Complex. The clinical wastes of the hospital, however, are dumped in front of the facility, said locals.

Shashadar Sen, mayor of Phulpur municipality, said garbage is being dumped on the river bank mainly by the local people and

8 Jamaat-Shibir men held in 2 dists

Police yesterday arrested eight Jamaat-Shibir activists from Lalmonirhat and Rangpur for allegedly plotting sabotage.

In Lalmonirhat, six of their activists were arrested from a meeting early yesterday from the Alorupa cinema hall area. They are Jamaat activists Azim Uddin, 58, Abu Taher, 40, Moainul Islam, 38, and Shibir activists Sohail Parvez, 32, Milon Mia, 20 and Rakib Hasan, 17.

Sensing the presence of police, eight other Jamaat-Shibir men ran away, the law enforcers said.

Police yesterday filed a case against 14 named Jamaat-Shibir men and several others unknown under Section 15 (3) of the Special Tribunal Act on charges of plotting sabotage in this connection, confirmed officer-in-charge of Lalmonirhat Sadar Police Station Omar Farooq. A judicial magistrate court sent them to jail yesterday afternoon after they were produced before it, the OC said.

Meanwhile, two Jamaat men were detained when they tried to bring out a procession in Rangpur city yesterday, said police.

Ex-JP MP dies as motorbike hits him

Former Jatiya Party lawmaker Mohammad Ullah was killed yesterday afternoon, after being hit by a motorbike on the Dhaka-Raipur road in Sadar upazila of Laxmipur.

Mosleh Uddin, officer-in-charge of Laxmipur Sadar Model Police Station, confirmed the news.

The victim, Mohammad Ullah, 76, is son of Akkas Mia Hawlader from Banchanagar area of Ward No-14 in Laxmipur Municipality.

The deceased's son, Rakib Hossain, said his father was hit by a speeding motorbike while he was crossing the road in front of Alia Madrasa. He was subsequently taken to Laxmipur Sadar Hospital in critical condition.

Mohammad Ullah was pronounced dead upon arrival, according to Dr Md Johurul Islam Roni, the resident medical officer of the hospital.

The deceased had served as the lawmaker for the Laxmipur-3 constituency from 1986 to 1988. He held the position as the first chairman of Laxmipur municipality. He had also previously served as the president of the district committee

Additionally, he was also the convener of the committee for preparing the council for the latest district-level Jatiya Party council, before his death.

GREECE WILDFIRES Firefighters battle blazes on multiple fronts Thick black smoke

Greek firefighters yesterday struggled to contain uncontrolled fires throughout the country for a fifth day, several of them bordering an acrid, smoke-filled Athens.

A fire ripped through foothills of Mount Parnitha, the largest forest adjoining the capital, and was threatening to spread to its national

Evacuations were ordered yesterday morning for three more settlements in the suburb Menidi, including three nursing homes.



The blaze has reached the first houses in Menidi, which is also close to a military camp. Fires have already destroyed homes and properties in the nearby suburbs of Hasia and Fyli.

A migrants detention centre in Amygdaleza, north of Athens, was also evacuated. The Greek capital woke up vesterday to the smell of scorched earth and thick black smoke covering the sky.

"Unfortunately, the wind does not help at all," Stathis Topalidis, deputy mayor of Menidi told state TV ERT. Another big blaze was still raging at a landfill in the industrial zone of Aspropyrgos, west of Athens.

One neighbourhood was evacuated yesterday morning. Flames continued to spread unchecked for a fifth day in the northeastern region of Evros, close to the Turkish border in Alexandroupolis and the Dadia forest, and home to rare birds of prey.

More evacuations were ordered in the region overnight. Unfounded rumours and allegations have also been spreading rapidly on social media that blame migrants for responsibility for the outbreak of the fires.

Greece's Supreme Court Prosecutor yesterday ordered the local prosecutor to investigate both the causes of the catastrophic fire and alleged claims of racism towards migrants.

Russia wants to end war 'unleashed by West'

Putin tells BRICS leaders, praises the grouping as a counterbalance to US global dominance

President Vladimir Putin yesterday used a speech to a summit of BRICS leaders to defend Russia's war in Ukraine and praise the grouping as a counterbalance to US global dominance.

Speaking by video link to leaders of the group, he repeated the Kremlin narrative that his invasion, condemned Ukraine and the West as an imperialist land grab, was a forced response by Russia to Kyiv's and Washington's hostile actions.

"Our actions in Ukraine are dictated by only one thing - to end the war that was unleashed by the West and its satellites against the people who live in the Donbas," Putin said, referring to the eastern part of

Ukraine where Russian proxies have been fighting the Ukrainian army since 2014. "I want to note that it was the desire to maintain

their hegemony in the world, the desire of some countries to maintain this hegemony that led to

Putin was speaking to a forum of countries multipolar world order".

that have refrained from condemning Russia's actions in Ukraine. The BRICS - also including Brazil, India, China and South Africa - have taken on added importance for Moscow as it seeks to blunt Western sanctions by boosting trade

with Asia, Africa and Latin America.

Russia has repeatedly said it is open to talks to end the 18-month war - but only if they take account of the "new realities" created by its forces who control nearly a fifth of Ukraine. Ukraine demands the restoration of all its territory and the removal of Russian troops.

response to the Russian president's speech that BRICS members would continue to support efforts to bring the conflict to an end.

Thailand's new prime minister vowed to bring four years of change to the kingdom as he took office yesterday.

He will head a controversial coalition that includes pro-military parties linked to former coup-makers.

The appointment of former property mogul Srettha Thavisin -- of the Pheu Thai party long associated with billionaire ex-premier Thaksin Shinawatra -- ends months of political deadlock following May's general election.

The 61-year-old was confirmed by parliamentary vote on Tuesday, just hours after Thaksin returned to the kingdom from 15 years of exile and was immediately jailed on old graft charges.

Srettha received King Maha Vajiralongkorn's official written command to form a government in a ceremony at Pheu Thai headquarters at 6:00pm (1100 GMT).

"The good of the country is my highest priority. I am confident the next four years will be years of change," Srettha said after accepting the royal endorsement, pledging to work "tirelessly".

Outgoing prime minister Prayut Chan-o-cha a former army chief who overthrew the last Pheu Thai government in a coup -- congratulated Srettha and wished him luck.

Electoral experts have suggested that adjusting constituencies based on the latest census could see the nationwide vote pushed back several months, possibly until February. Is MLM fraud back in disguise?

Reports of MTFE scams must lead to accountability and transparency

It's disturbing to learn of yet another mass-market-level consumer fraud that was reportedly committed exploiting legal financial channels to defraud thousands of people in various districts. According to a report by Prothom Alo, the group behind this is a multi-level marketing (MLM) company called Metaverse Foreign Exchange (MTFE) Group Inc. Its nature of exploitation is different from the nowdefunct MLM company Destiny, but just as Destiny used customers to collect customers, it used "investors" to attract investors, using digital tools, a promise of lucrative returns on investments, and hired representatives on the ground to

All this happening even after the egregious precedents set by MLM companies like Destiny or Jubok – or latter-day players like UniPay2U or Evaly – is a big concern indeed. It means that there has been little improvement in financial governance in the country in all these years, as a result of which an estimated Tk 220 billion has been lost to MLM and e-commerce scams, unlikely to ever be returned in full to the victims.

Since the fallout of Destiny-Jubok controversies, there was a lull in MLM practices for about six-seven years, and the business model reportedly made a comeback in 2018 through e-commerce ventures. There are laws against pyramid schemes and such fraudulent business practices in the country, although there are no approved MLM companies at present. The question is, how could the MTFE then stay under the radar and circumvent regulations, and do that so openly?

A big tragedy of our financial sector is that every time a scam like this is revealed, far from taking responsibility for it, those in charge just pass the buck – as they did this time, too. Reportedly, the Ministry of Commerce, Bangladesh Bank, and Bangladesh Telecommunication Regulatory Commission (BTRC) are unwilling to take responsibility for what happened, instead opting to blame gullible investors for it. In the past, we have seen the government initiate inquiries, form commissions, and suggest refund mechanisms, yet a majority of victims have not been able to recover their investments.

This is quite frustrating. To prevent the recurrence of such scams, it is imperative that the authorities strengthen financial regulation and monitoring, properly enforce relevant laws, and enhance consumer awareness. Technological vigilance in an era where digital platforms can easily be exploited for financial misconduct is also vital. Those defrauded by MTFE and others deserve nothing less.

Ruling party must reign in BCL activists

Lack of accountability has emboldened them to continue committing crimes

 $Journalism\ in\ Bangladesh\ has\ become\ an\ extremely\ dangerous$ rolession. One of the biggest unreats facing journalists at present is violence by ruling party affiliated men. The most recent case occurred in Patuakhali, where a group of Chhatra League activists assaulted a journalist apparently for publishing a report against their district unit president. They stopped him while he was on the road, verbally abused him, physically assaulted him and attempted to injure one of his eyes, and even threatened to cut off his limbs should he publish any such reports. Their sheer barbarity demonstrates the level of danger journalists are exposed to these days. Violence, however, is just one of the many threats journalists face.

The main reason why such individuals have become so audacious is the poor state of law and order. It has become common for the powerful to get away with just about anything, often without any legal repercussion. In fact, rather than being used to protect journalists – and people in general – the law is being used to harass them. Under such circumstances, can we really be surprised when such incidents take place? Just a few days ago, another journalist was allegedly beaten up by BCL activists at Jahangirnagar University's Bangabandhu Sheikh Mujibur Rahman Hall, simply because they suspected he was filming them, when he did no such thing. But the fact that ruling party activists feel so embolden to attack journalists - as well as just about anyone – as their first instinct speaks volumes about how much leeway they have been afforded over the years.

Not only that, ruling party politicians themselves, rather than condemning or preventing such criminal conduct by their supporters, often come out and criticise the media for exposing it. And that just goes to show the lack of remorse they all feel in the face of gross violations of human rights. This cannot happen indefinitely. We call on Awami League leadership to reign in their activists. The law enforcement authorities also should take stern measures to prevent such attacks and project journalists.

Corrupt people might use this law to intimidate journalists and media organisations, and try to prevent the publication of such stories on the pretext that the reports have attacked or intimidated them. The debt supercycle comes to China

United States kicked off a debt supercycle, which spread to Europe in 2010 and has recently engulfed many of the world's low-income and lower-middle-income countries. Could the debt woes of Country Garden, the behemoth Chinese realestate developer now facing billions of dollars in losses, augur the cycle's

The answer remains unclear. While the Chinese authorities have a remarkable track record when it comes to containing economic crises, the challenges posed by a significant growth slowdown, combined with high debt levels – especially for local governments and the property sector are unprecedented.

China's current problems can be traced back to its massive post-2008 investment stimulus, a significant portion of which fueled the realestate construction boom. After years of building housing and offices at breakneck speed, the bloated property sector – which accounts for 23 percent of the country's GDP (26 percent counting imports) – is now

The 2008 financial crisis in the yielding diminishing returns. This comes as little surprise, as China's housing stock and infrastructure rival that of many advanced economies while its per capita income remains comparatively low.

> At the same time, in what had once seemed like a race between a tortoise and a hare, the US is speeding toward artificial-intelligence-powered technological innovation and higher long-term economic growth. As highly respected Wall Street Journal economics commentator Greg Ip recently put it, "No one talks about secular stagnation now," referring to a theory that a chronic deficiency in global demand and economically important innovation will hold down growth and real interest rates long into the future.

> Funnily enough, I said much the same at a conference seven years ago. In my presentation, which was based on my 2015 paper "Debt Supercycle, Not Secular Stagnation," I explained that post-crisis malaise was typical and would at least partly fade. I then conjectured that "in nine years, nobody will be talking about secular

stagnation" - a perhaps hyperbolic remark to underscore the point.

Over the past decade, the overwhelming consensus in academic and policy circles has been that the world is deeply mired in an era of ultra-low interest rates driven by weak growth fundamentals. And in fact, it remains so today. For example, Northwestern University economist Robert J Gordon's magisterial history The Rise and Fall of American Growth offers persuasive arguments for the death of innovation and the end of growth. Gordon posits that post-1970s inventions – even the computer revolution – are not nearly as economically important as, say, the steam engine or electricity generation.

Billionaire investor Peter Thiel and former world chess champion Garry Kasparov made similar arguments in a 2012 debate on the topic of 'Innovation or Stagnation" at the University of Oxford. Arguing on the "innovation" side of that debate, pointed to advances in chess that heralded the coming of an AI age. while also noting that commercial innovation invariably stalls at times, for example during the Great Depression. In fact, my greatest concern has never been an end to innovation, but rather that the rise of AI will outpace our ability to control

There are strong arguments for secular stagnation on the demand side, owing to demographic decline. In a brilliant 2013 speech, Harvard economist Lawrence H Summers argued that only a continuing

shortfall in global demand could explain the era's ultra-low interest rates, triggering an avalanche of research on fundamentals that could explain the demand deficiency. Progressive politicians have used this work to make the case that bigger government is needed to fill the void. Summers, however, was more circumspect, advocating increased investment in infrastructure and education, and outright transfers from rich to poor - ideas with which I strongly agree.

But despite some good arguments for secular stagnation, concerns about sustained slower growth are overblown. Charles Goodhart and Manoj Pradhan have challenged the view that demographic decline inevitably lowers demand by pointing to the rapidly growing elderly population.

Moreover, long-term are not wholly responsible for the spectacular collapse in real interest rates after the 2008 crisis; the collapse was at least partly because of the crisis itself. After all, interest rates also fell to zero during the Great Depression and stayed there until they didn't. Notably, the rate on ten-year inflation-indexed Treasury bonds is currently well above its average level of about zero from 2012

to 2021. The debt supercycle may have lasted longer than initially expected, perhaps because of the pandemic. But it was a critical piece of the story, and now, as China's economy falters, it is the best explanation for what might come next.

FLOODING IN CHT

When development gives little and takes all

It is estimated that the Chittagong Hill Tracts, comprising the three districts of Rangamati, Khagrachari, and Bandarban, constitute onetenth of Bangladesh's total land area. The natural beauty, and the linguistic and cultural diversity of this region have always attracted tourists at home and from abroad. For hundreds of years, many water bodies, including Chengi, Meini, Kajlong, Karnaphuli, Reingkhyong, Sangu, and Matamuhuri have flown through the thousands of hills to meet the Bay of Bengal by the lowlands of Chattogram.

At one time, the CHT was known for being e only evergreen forest in the country. But the hilly forest is no longer what it used to be. The topography and demographic characteristics of the hilly areas have changed drastically over the last few decades. The biggest concern is the frequency with which natural disasters are occurring in the three hilly districts of the country. Over the past few years, heavy rains in monsoons and extreme heat in summers seem to have become common in the region. Moreover, floods and landslides have also become a regular occurrence.

Flooding was once a foreign phenomenon in the hilly areas. But recently, the devastating floods in Bandarban have resulted in the suffering of thousands of people, the destruction of roads and communication systems, and extensive damage to infrastructure. All this is forcing us to think afresh about the state of natural balance in this region.

Most of the Sadar upazilas, including Bandarban city, were flooded due to the heavy rainfall between August 2 and 8. Locals say that such a terrible flood situation is unprecedented. According to a Prothom Alo report, 6,569 houses and 132 educational institutions suffered damages. The whole Bandarban district remained without power for quite a few days. The Sangu and Matamuhuri rivers also flowed over the danger level for several days. Bandarban's roads and infrastructure have been severely damaged by the heavy rains and flooding. Reportedly, about one-third of the roads constructed under the Local Government Engineering Department (LGED) have become impassable. During this time, the operations of hospitals, fire services, and various public and private emergency service providers were practically at a standstill. About 28,000 books of the District Government Public Library in Bandarban have been lost. For the following week or so, the whole of Bandarban was virtually cut off from other districts of the country. Even now, road networking between Bandarban-Ruma, Bandarban-Thanchi, and Thanchi-Alikadam has not returned to normal. It is safe to say that it will take some time for the situation in the area to improve.

Besides Bandarban, many areas in Rangamati and Khagrachari also experienced flooding like never before. Many upazilas, such as Dighinala and Baghaichari, are reported to have suffered crores of

taka worth of damages. As some may remember, in 2017, hundreds of people lost their lives in a massive landslide in Rangamati district. Now that the recent flood situation in the hill districts is receding, we must think again about the overall balance of the hilly areas. Although many experts have cited landslides (due to the unusually heavy rainfall) as the main cause behind the disastrous flooding in the hill districts, locals claim that there are several other factors, including unplanned development, contributing to such anomalous conditions.

Over the past few decades, the entirety of our mountainous region has undergone massive deforestation in the name of road construction and infrastructure development. Trees were felled indiscriminately. The burden of development has been forced onto the region's pristine natural environment, with no regard for the basic needs and opinions of inhabitants. Various media reports often state how the forests in the hill areas are being destroyed one after another. In keeping a balance in the flow of the rivers passing through these hills, rocks play a crucial role. But despite repeated objections from local victims and environmental activists, stones and rocks have been quarried relentlessly from hill ranges, dams, canals, and rivers in different upazilas of Bandarban over the past few years. Needless to say, these streams are the only source of useable water for the hill dwellers. Due to this loss of drinking water sources, reports frequently emerge of diarrhoea outbreaks and children dying due to lack of treatment from remote areas such as Alikadam, Thanchi, and Naikhongchhari.

If we still fail to realise the impact our actions have on the environment, we could be faced with even more devastating disasters in the future.

The lists of dengue infections and deaths are only getting longer, and nobody can tell if, or when, the situation will get better. The prices of daily essentials continue to skyrocket, with the price of eggs, the go-to protein for the poor, now equal to that of a kilogram of broiler chicken. Meanwhile, more than 50 people were killed in the floods in Chattogram and the Chittagong Hill Tracts area in recent weeks.

In all of this, it is the common people (or in the context of the upcoming national election, the voters) who are the worst sufferers. But the politicians seem to be blissfully oblivious to the plight of their electorate. There is no denying that the country is headed towards its next parliamentary election with the two major political parties harbouring opposite regarding the election itself. Of course, a free, fair, and inclusive election is necessary for a better society and stronger democracy. But when people are suffering the most, when they are dying because of poor governance, how can the political parties focus on only the physical exercise of the election and how it



Kazi Nazrul Islam's short narratives

Kazi Nazrul Islam (1899-1976), was a poet, novelist, lyricist and musician in Bengali, and was popularly known as the rebel poet. He seemed to appear out of nowhere upon the Bengali literary scene, much like the comet he has often been compared to, drawing from the name of his first literary journal Dhumketu. Famous for his anticolonial poems and lyrics that preached communal harmony during the period of the late-colonial era between the two world wars, he also wrote a substantial body of prose that encompassed reportage, journalism, fiction, political thinking and literary essays Feted by all three countries that were created out of the Indian subcontinent, he is considered to be the national poet of Bangladesh.

While Nazrul Islam's poems, songsand more recently-his novels, have been diffused into global cultures through English translation, his short narratives have not received the same treatment yet. His prose-in the form of speeches, essays, novels, polemics and stories-is a crucial part of his evolving body of work. His early stories were written to document and narrate his experiences of war, based on his time with the 49th Bengal Regiment that was barracked in Karachi (and briefly, Nowshera) during the First World War. Even though the regiment did not see much action, Nazrul's stories are fantasies of bravery, masculine courage and youthful experiences of love and ambivalence about national causes. He was fulfilling several roles at once: displaying martial prowess among the 'bhadrolok' Bengalis, who were largely thought to be too genteel to be in the army according to colonial stereotypes; emphasising the presence of Muslim youth among the Bengalis who fought

of romantic engagement against the background of global conflict. Soldiers in Nazrul's stories fight on behalf of the colonial empire, for central Asian freedom struggles as well as the Red Army in Russia. Even though the First World War is rarely name-checked in his poetry afterwards, as scholars like Santanu Das have pointed out, "(t)he influence of the war years can be detected not only in a few explicit 'war' writings, but in a more general sense, from his greater confidence to his self-fashioning as a sainik (soldier) There is a line of continuity poetry and song, with each genre providing their unique set of affective frames that could serve Nazrul's effort to express his formative identity. And violence was often central to this act of forging one's identity in a late-colonial context, as much for Nazrul as for many European writers and artists who thought of global wars as technological means for securing idealistic futures; Das suggests the same when he writes that "the war opened up for the tempestuous youth and avant-garde artist a rich imaginative space, replete at once with desire and violence, with violence as desire". These conflicted, almost contradictory, fantasies tell us many things about how contested the world of imagination was in latecolonial Bengal, especially when it came to formulating political programmes struggle-either against the colonial government or the emergent, 'nationalist' middle-class society at large (traditionally understood to be the object of reform).

These stories offer a glimpse into the life and mind of Nazrul at a young age before he took Kolkata and Bengal for the empire, and later against it, by storm with his rousing songs and

They help us appreciate the great rebel poet more by giving us unrestricted access to his fears and obsessions as a detached, carefree vagabond who sought learning and experience from the world- all by himself and through his narratives. We see glimpses of this soldier-cumvagabond lifestyle described in his novel, Bandhon Hara (Unfettered), which has been translated into English, but the shorter narratives collect various aspects of this existence imagined to infusing Bengali poetry with martial through different combinations and as a Bengali." Ultimately, through the methods in approaching faith-based images and rhythms it had not known romantic possibilities, each signifying telling of great world events like the War, communities that were in dire need emotional core in between Nazrul's narratives and his poetics. These may be described explicitly as stories of a young Bengali experiencing the world of war at the same time as working out various ideological conflicts within the self, with an emphasis on war's romantic possibilities. Even if the stories read fantastically, very often they reflect the thick atmosphere of grisly rumours of violence, betrayals and ideological border-crossings that took place at the time, which also opened up opportunities for alternative selfmaking, compared to what inspiration the male protagonist whiles his time

state. According to Abhishek Sarkar, "Nazrul was also aware...that some Indian soldiers in Iran had mutinied and deserted the British army to join the Red Army. Among them one Murtaza Ali excelled in guerrilla warfare in the northern Caucasus, and probably served as a prototype for the heroic character named Dara in Nazrul's story Byathar Dan. Nazrul encapsulates in the figure of Dara his favourite ideals of internationalism and heroic masculinity, of which he could not find any embodiment in his lived experience the stories will find universal interest narratives from colonial soldiers and participants who were never directly implicated in the global conflict but by virtue of their forced membership in an imperial commonwealth. The coerced nature of this association is revealed through the cracks in Nazrul's portrait of his war protagonists and their febrile search for causes.

The other section of the collection is built around narratives of the social world of Bengali villages and small towns during the early 20th century. They give us glimpses of historicallyrooted social experience-of Muslims and Hindus living together during the times of the Non-Cooperation Movement, for instance-marked, once again, with elements of fantasy. These stories are imagined in the literary context of earlier puthi narratives as well, and are probably better thought of as afsanas or tales, where temporal events are suffused with the imaginary world of ghosts, jinns and sentient serpents. In "Jiner Badsha", the female protagonist is named Chan Bhanu after a popular character from a qissa that is much admired by her mother, while

and imagines himself to be the new Gazi Hanifa. These popular tales and outsized fantasies intrude upon the everyday world of the Bengali rural idyll, grafting insidious desires for romance and adventure, and making it possible for us to trace the characters' motivations and self-fashioning in the domain of this particular social imaginary.

Nazrul narrates these tales with his tongue in his cheek, reflecting the larger context of secular and conservative political debates that were waged around the need for rationalist 'modernisation'. The translation also includes two short allegorical narratives by Fazlul Haq, Bengal's first Prime Minister and friend of Nazrul, that were reproduced by Nazrul in the journal, Nobojug. These emphasise the comedic aspects of Nazrul's workwhereas he is traditionally known for his angry, rebellious lyrics, or lachrymose devotionals (to the goddess Kali, for instance). Comedic narratives and the use of fantastic elements allowed Nazrul to create popular forms, re-tell older stories and communally-shared oral narratives, which let him evolve an important dimension of his aesthetic. Although for Nazrul-even in the midst of laughter, we are still talking about politics, and the struggle waged by the emotional, individual self against the socially structured, increasingly rationalised and enumerated world of late-colonial Bengal.

in the transfers. They have sought time for the transfers but I had told them that we can't keep any schedule in December and

January due to state affairs (national elections)." Abahani hockey committee secretary Zaki Ahmed Ripon said that they have no problem in playing and taking part in the transfers.

Usha KC general secretary Abdur Rashid Shikdar, too, said they will respond positively to the federation's plea and would try to form a strong squad in their return to top-flight hockey after missing out the last season due to demotion.

Rashid, also a BHF vice-president, believes the small clubs may face trouble in the transfers ahead of the national elections. However, he believes it is possible to hold the league, which is the lone income sources of the players.

Sayeed promised to come forward personally to help the clubs if they need financial assistance.

"The federation is not capable of providing allocation for the clubs but personally I will try to help the clubs if they seek any kind of help, said Sayeed.

of Streak's "demise", and was then left bewildered when such a sensitive issue turned out to be a hoax -- all in a span of just a few hours.

News of the demise of Streak, 49, spread like wildfire on Wednesday morning with many renowned media houses around the globe running the news by referencing social media posts of Streak's close associates.

Although the official source that made the announcement of Streak's demise remains unknown, a post by his former national teammate Henry Olonga is what seemingly triggered the hoax as even Reuters referenced Olonga in this matter.

"Sad news coming through that Heath Streak has crossed to the other side. RIP Zimbabwe cricket legend. The greatest all-rounder we produced. It was a pleasure playing with you," wrote on messaging platform X, formerly known as Twitter.

Olonga was soon joined by former current Zimbabwe

skipper Sean Williams in paying his tributes to Streak.

'Streaky! No words can explain what you and your family have done for mine and many others. Our hearts are broken you leave behind a beautiful family and a legacy for us to live up to! You will be missed we love you dearly. Rest in peace, Streaky," read Williams' message on X.

The posts by Williams and Olonga are no longer available on X.

About two hours after his initial post, Olonga clarified in his next post that Streak, in fact, is "very much alive" but the damage had already been done by that

Understandably, Streak, undergoing treatment for liver cancer, and his family were taken aback by what they heard and saw, demanding an apology from the source for the unverified news.

"It is a total rumour and a lie. I'm alive and well. I am very upset to learn that something as big as someone apparently passing can be spread unverified especially in our day and

age of social media, I believe the source should apologise. I am hurt by the news," Streak told Mid-Day in his first official reaction to the news.

Streak may not get the "apology" for what transpired yesterday but it surely is time for the world to take note and wield the powerful tool in a more responsible way.

DENV-2 strain likely the key culprit

Reveals govt study; death toll crosses 500-mark with 13 new deaths

DENV-2, the severest of all dengue virus types, is likely the key factor contributing to higher rates of dengue deaths and infections this year, says a government study.

The study findings were revealed at a time when the death toll from dengue has crossed the 500-mark this year, with another 13 new deaths reported in the last 24 hours till 8:00am vesterday.

Dengue infections are caused by four closely related viruses -- DENV-1, DENV-2, DENV-3, and DENV-4. These are called serotypes because each of them has different interactions with the antibodies in human blood serum, according to Nature, a science journal.

To learn more about the most circulated dengue serotypes in Dhaka, virologists at the National Institute of Laboratory Medicine and Referral Centre (NILMRC) tested 200 samples recently.

In the study, the DENV-2 serotype was detected in 151 samples, DENV-3 in 37, and both DENV-2 and DenV-3 in 12 samples, according to a press release sent by the

Interpreting the findings, Dr Arifa Akram, assistant professor at the Department of Virology at NILMRC, told SEE PAGE 7 COL 1

MOON'S SOUTH POLE India becomes first nation to land craft near it

EC to finalise changes to guidelines in September

The Election Commission will finalise the changes to the guidelines for foreign election observers and journalists by the first week of September.

At an inter-ministerial meeting at the EC office yesterday, the commission urged relevant ministries to place their proposals at the meeting next week.

Russian mercenary chief Yevgeny Prigozhin was listed as a passenger on a private jet which crashed yesterday evening north of Moscow with no

survivors, the Russian authorities said. There was no confirmation that Prigozhin was physically on board,

according to Reuters and AFP. Prigozhin, 62, spearheaded a mutiny

against Russia's top army brass on June 23 which President Vladimir Putin could have tipped Russia into civil war.

26 killed as under construction bridge collapses

2 hurt; authorities open probe

A railway bridge being built in India collapsed yesterday killing at least 26 workers and injuring two, police said, as the state-run railway authority opened an investigation.

The accident happened in Sairang town in the northeastern state of Mizoram, its chief minister, Zoramthanga, said on messaging platform X, formerly known as Twitter. Media reported that up to 40 workers were at the site

when the bridge collapsed but police said 28 workers were "Rescue workers have been able to recover 13 bodies so

far. Efforts are on to recover the remaining bodies," said a state police official who declined to be identified. The Northeast Frontier Railway (NFR) said in a

statement on the messaging platform X that the mishap

occurred during work on the Bhairbi-Sairang New Line The NRF said on its website the project will connect Mizoram to the rest of the country, boosting "tourism

and socio-economic development". A "high level enquiry committee" had been set up to

investigate, the NFR said. Prime Minister Narendra Modi said in a statement "all
