## Locked in litigation

4,000 ACRE RAIL LAND

Bangladesh Railway (BR) is in a legal predicament as it struggles to recover around 4,000 acres of land grabbed by private citizens and public entities alike.

Currently, it is tangled up in over 2,000 cases -- 1,184 under the east zone and 892 under the west zone of BR, according to railway documents.

Some of the cases were filed by BR against illegal occupants, although most of them were filed against the railways by individuals and different public and private organisations.

According to the railways ministry's 2021-22 annual report, BR owns 61,860 acres of land -- 24, 441 acres in east zone and 37, 419 cares in west zone.

Of the total land, 3,842 acres -- equivalent to over 15 square kilometres -- are under illegal occupation, according to the report published early this year.

Of its total land, the BR uses 31,569 acres for railway operations and leased

out 14,473 acres to different individuals and entities. Another 11, 976 acres remain unused.

Many influential have long people been occupying railway lands, often in association with some unscrupulous railway staffers.

After the formation of a separate railways ministry in 2011, rail

ministers almost on a regular basis informed parliament about the scale of the encroachment and vowed to recover

Indeed, it carried out several drives through its four divisional estate offices to evict the grabbers and demolish the illegal structures. But the grabbers returned within a few days in most cases due to lax monitoring.

However, sources said BR sometimes carries out eviction drives upon pressure from the high-ups, which is actually "an eyewash".

### US sharing info with The Gambia for ICJ case

The US has shared information on atrocities against the Rohingya with The Gambia that filed a genocide case against Myanmar at the International Court of

US Under Secretary of State Uzra Zeya said this at an event in Washington DC on the occasion of Rohingya Genocide Remembrance Day on Friday.

"Our work is not just humanitarian, we also must move towards accountability," she said.

She said the US also provides support to the UN's Independent Investigative Mechanism for Myanmar to strengthen its ability to conduct open-source investigations and to protect witnesses and victims.

Zeya said not a single Rohingya returned to Myanmar. She also mentioned there

was no guarantee of citizenship, safety and conducive environment in Rakhine, six years after the influx of around 750,000 Rohingyas who fled a brutal military campaign in Myanmar and took shelter in Bangladesh.

The US determined in March 2022 that members of Myanmar military committed genocide and crimes against humanity against the Rohingyas. It also imposed various sanctions against Myanmar military. The latest one was on Wednesday when the US imposed sanctions on any foreign individual or entity operating in the jet fuel sector of Myanmar's economy and designated two individuals and three entities.

"We will continue to use our sanctions authorities to deprive the military regime of the resources that enable it to oppress its people and urge others to take similar accountability measures," Zeya said.

### 8-yr-old house help found dead in city flat

An eight-year-old girl, who worked as a house help, was found dead yesterday at a flat in the capital's Central Road area.

Tipped off, police recovered her body from flat "E1" on the first floor of the building around 10:30am, said Saiful Islam, officer-in-charge of Kalabagan Police Station.

"We suspect that she was tortured before death," the OC said.

The police, however, are get her name and home address.

Mofizur Rahman, manager of the seven-storey building, said the girl had been working in the flat of Sathi Parvin, 40, for three years

"This morning [Saturday], Sathi was looking worried. She quickly left and returned to the building several times, finally leaving at around 9:10am. She hasn't been seen since," Mofizur said.

"Police first came in around 1:30am, saying they had information that a house help died by suicide. But, they could not say in which flat. Later, they returned around 9:00am and found the girl's body laving on a bed in flat E1, with a piece of white cloth wrapped around her face," he added.

Mofizur said Sathi had been living in the flat, owned by her ex-husband, with her four-year-old daughter. She got divorced in 2020.

"But she didn't pay service charges and utility bills. Over Tk 3 lakh is due," he added.

Kalabagan OC Saiful said that they were trying to arrest Sathi.

The body of the girl was sent to Dhaka Medical College Hospital morgue for an autopsy.

#### Chinese national's body recovered from Khulna river

The body of a 44-year-old Chinese national was recovered from the Bhairab river in Khulna city's Khalishpur Charer Haat area yesterday.

The deceased was identified as Wang Siao Khui, an engineer of the 800-MW under-construction power plant inside Khulna Newsprint Mill.

Mandal, inspector (investigation) of Khalishpur Police Station, said being informed by locals, police recovered the body of the Chinese national in the morning.

The reason for the death could not be ascertained immediately

## Sign oath of allegiance

#### Putin orders Wagner fighters as Kremlin declines to confirm Prigozhin's death

President Vladimir Putin has ordered Wagner fighters to sign an oath of allegiance to the Russian state after a deadly plane crash believed to have killed Yevgeny Prigozhin, the volatile chief of the mercenary group.

Putin signed the decree bringing in the change with immediate effect on Friday after the Kremlin said that Western suggestions that Prigozhin had been killed on its orders were an "absolute lie". The Kremlin declined to definitively confirm his death, citing the need to wait for test

Russia's aviation authority has said that Prigozhin was on board a private jet that crashed on Wednesday evening northwest of Moscow with no survivors exactly two months after he led a failed mutiny against

President Vladimir Putin sent his condolences to the families of those killed in the crash on Thursday and spoke of Prigozhin in the past tense.

He cited "preliminary information" as indicating that Prigozhin and his top Wagner associates had all been killed and, while praising Prigozhin, said he had also made some "serious mistakes."

Putin's introduction of a mandatory

oath for employees of Wagner and other private military contractors was a clear move to bring such groups under tighter state control.

The decree, published on the Kremlin website, obliges anyone carrying out work on behalf of the military or supporting what Moscow calls its "special military operation" in Ukraine to swear a formal oath of allegiance to Russia.

Described in the decree as a step to forge the spiritual and moral foundations of the defence of Russia, the wording of the oath includes a line in which those who take it promise to strictly follow the orders of commanders and senior leaders.

Western politicians and commentators have suggested, without presenting evidence, that Putin ordered Prigozhin to be killed to punish him for launching the June 23-34 mutiny against the army's leadership which also represented the biggest challenge to Putin's own rule since ne came to power in 1999.

Kremlin spokesman Dmitry Peskov said on Friday that the accusation and many others like it were false.

"There is now a great deal of speculation surrounding this plane crash and the tragic deaths of the plane's passengers, including Yevgeny Prigozhin. Of course, in the West, all this speculation is presented from a well-known angle," Peskov told reporters.

### Dhaka, Tokyo in talks to ink defence deal

Says Japanese ambassador DIPLOMATIC CORRESPONDENT

Bangladesh and Japan may soon sign an agreement facilitating a transfer of defence equipment and technology as part of their efforts to promote regional peace and stability.

"We are in discussion on an agreement concerning the transfer of defence equipment and technology. We will not be able to disclose the details at this moment. However, the discussions are progressing in a positive manner," Japanese Ambassador to Bangladesh, Iwama Kiminori, said yesterday.

He was addressing a roundtable organised by the Pan-Asia Research Institute (PARI), a Japan-based think tank, at the Japanese embassy.

Japan selected Bangladesh as one of the four countries-the others being the Philippines, Malaysia, and Fiji—to be the beneficiaries of Japan's new Official Security Assistance (OSA) programme. The two countries also agreed to appoint defence attachés in their respective embassies.

The topic was discussed during Prime Minister Sheikh Hasina's visit to Japan in April this year.

#### Joint patrol at Rohingya camps to continue

Law enforcement agencies conducted a joint patrol in the Rohingya camps of Cox's Bazar yesterday as incidents of crimes, particularly those related to narcotics and murders, increased over the last seven months.

More than 450 members of APBn, Rab, Police, BGB, and Ansar participated in the three-hour patrol out in different blocks of Balukhali 8 West . Refugee Camp in Ukhiya upazila.

These patrols will be conducted regularly from now on, said Additional Deputy Inspector General Mohammad Iqbal, commander of 14 APBn.

The safety and security in the camp have deteriorated significantly in recent months since Myanmar-based armed groups Arakan Rohingya Salvation Army (Arsa) and Arakan Solidarity Organisation (RSO) started engaging in violence to establish dominance over the control of narcotics and arms trade inside the camps, Rohingya leaders

Apart from ARSA and RSO, other criminal groups, including the Nobi Hossain Group, Munna Group, Dakat Hakim Group, Dakat Saleh Group, and Islamic Mahas Group, are also reportedly active in the camps, they added.

Some robbery, trafficking, and abduction gangs are also active in Ukhiya and Teknaf camps that have now become crime havens, leaders also said.

#### Six sued over deaths of 2 construction workers

A site engineer was sent to jail yesterday in a case filed over the deaths of two construction workers who fell from an under-construction building of Pabna University of Science and Technology (PUST). The site engineer is Hossain Ali.

Md Mofizur Rahman, a relative of deceased Tuhin Hossain, lodged the case against Hossain and five others with Pabna Police Station, said Kripa Shindhu Bala, officer-in-charge of the station.

The five other accused are GM Azizur Rahman, project director; Harunur Rashid, director of the construction company MN Huda Construction; Md Nasirul Haque and Mizanur Rahman, managers of the company; and site engineer Md Sujauddoula.

#### Mother, daughter die after being electrocuted

A mother and daughter were electrocuted at Gobordanga village under Harinakundo upazila in Jhenidah early yesterday and died.

The victims are Morium Khatun, 65, and her daughter Taslima Khatun, 32.

Morium's husband Amjad Hossain said Taslima went to fetch water from a tube well which somehow was touching a live wire around 6:30am vesterday morning.

Her mother rushed to save her but in vain. They all died on the spot.

In most cases, the illegal occupants re-occupy the land paying bribes to the influential and crooked rail staffers, meaning such drives actually increase the occupation rate, they said.

On instructions of the parliamentary standing committee last month, the rail ministry prepared a detailed report on the land-related cases, and submitted it before the committee on Thursday, sources said.

According to the report, railway is fighting 2,076 land cases in different courts across the country, including 562 in the two divisions of the Supreme Court.

Of the total cases, at least 38 were filed by BR while rest were filed by different individuals and organisations against the railways.

Those sued by BR include Bangladesh Chemical Industries Ltd, the district administrations Naogaon, Faridpur, Kushtia, Rajshahi, Lalmonirhat, Khulna City Corporation and Khulna Development Authority. Mayors of Syedpur and Ishwardi municipalities,

among others, have also been sued by BR.

On the other hand, individuals are the plaintiffs in most of the cases filed against BR. However, several government ministries and agencies, including jute and textile ministry and the Kushtia district administration, also sued BR.

Officials of the Chief Estate Office and Divisional Estate Office - the two offices responsible for dealing with the railways lands – come from the admin cadre on deputation.

Sujan Chowdhury, chief estate officer (east) of BR, said people often filed cases when rail officials conduct eviction drives. Besides, many people sued the railways using fake documents to claim land ownership.

"Most of these cases have been filed so they can keep occupying railways land," he told The Daily Star vesterday.

"When an individual can afford to pay even Tk 1 lakh for a lawyer, we cannot manage even Tk 20,000 for a lawyer to deal the cases timely," he said, adding that his office has only about a third of the 145 approved

BR sources said there are only three posts of law officer in the 47,637-strong organogram of BR. Of them, there are only two posts for law officers in the two zones and a law officer at the BR headquarters, which is currently vacant.

"How can we deal with so many cases with this poor manpower?" said one official.

Asim Kumar Talukder, general manager (west) of BR, said the court cases are a major hurdle for them to recover the land. He also said the law section of BR

is too weak to put up the tough fight required for the recovery of the land. Replying to a question, he said rail land often gets reoccupied as the rail authorities cannot put them to proper use in a quick manner, as the existing leasing process is time-

Rail Secretary Humayun Kabir and BR Director General Quamrul Ahsan did not respond to our requests for comments.

### Teesta bursts its banks again

"We are monitoring the situation as the water levels of most of the rivers are increasing. But we still think it's going to be another short-term flood," said Mehedi Hasan, duty officer of the FFWC, yesterday.

He added that Teesta's water level will continue to rise over the next 24

As of Saturday evening, the river was flowing 28cm above the danger level at the Dalia barrage point and 53cm above at the Kaunia point in Rangpur.

Following the rise in the water level, around 50,000 people have been stranded in 100 chars and riverside villages in 22 unions of eight upazilas in Lalmonirhat and Kurigram districts, Water Development Board (WDB) sources said.

Abdullah Al Mamun, executive engineer of Kurigram WDB, said the rise in Teesta's water level has caused floods in Rajarhat, Ulipur and Chilmari

### TOBACCO CONTROL ACT Pass amendment to it urgently

Speakers say at event

The amendment of the Tobacco Control Act should be urgently passed to protect the health of the countrymen and build a strong, talented young society, said speakers at a programme yesterday.

Passing of the amendment of the law will see lower deaths, while achieving SDG goals and making a tobaccofree Bangladesh a reality, they said. Dhaka Ahsania Mission organised the event at Janata

Tower Software Technology Park auditorium in the city,

"To Achieve the SDGs, we must pass the amendment of the Tobacco Control Act," said Iqbal Masud, director (Health and Wash Sector) of the Mission. "If the amendment is passed, the number of tobacco

users in the country will decrease. As a result, it will be possible for Bangladesh to become tobacco-free by 2040 as announced by Prime Minister Sheikh Hasina," he Shariful Islam, coordinator of the Tobacco Control

Project, said, "Non-smoking citizens are suffering from the harm caused by passive smoking as the existing 'Smoking and Use of Tobacco Products (Control) Act 2005' allows smoking in public places, restaurants, and public transport which is a severe threat to health."

"While the existing law completely prohibits the advertising and promotion of tobacco products, however, there is no specific ban on the display of tobacco products SEE PAGE 4 COL 1

# Hong Kong mulls hiring more female workers

Hong Kong's labour ministry has shown interest in hiring more female workers from Bangladesh, opening doors towards a prospective market expansion.

About 700-750 Bangladeshi woman migrant workers are currently employed in Hong Kong as female domestic helpers (FDHs). However, new workers need to have skill and

language training in Cantonese, among other qualifications, to migrate as FDH, said Bangladesh Consulate General officials in Hong Kong.

Ghoraghat upazila, villagers discovered that thieves had taken away four skeletons from the graveyard during the

The Ghoraghat Police Station Officer-in-Charge, Md. Asaduzzaman Asad confirmed that police had visited the graveyard on Thursday.

Unfortunately, thieves struck again at Tulsipur graveyard in Birganj on Friday. Locals reported that they found 10 human remains missing from graveyard Tulsipur Birganj.

Shahinur Islam Chowdhury of Mohanpur Union Parishad stated that 21 remains were stolen in two separate incidents from the same gravevards within a span of 2 weeks.

This has understandably alarmed residents near these graveyards and the relatives of the deceased, as the dignity and security of their loved ones' remains are compromised.

Despite these concerns, enforcement authorities have thus far been unable to provide a

solution to this problem. Since July 2022 up to August of the current year, at least 120 human remains have been stolen from various graveyards in districts such as Panchagarh, Thakurgaon,



Dinajpur, Nilphamari, and Gaibandha.

In January 2020, at least 28 human remains were stolen from two graveyards in Dinajpur Sadar upazila, including 20 from Shibpur Graveyard and eight from Darbarpur Graveyard.

The sale and trade of human remains, including skeletons, is generally highly regulated and illegal in many countries, including Bangladesh.

According to sources within law enforcement, there is a high demand for human including remains. skeletons, particularly in education and research fields, both locally and internationally. incidents tend to rise when the demand for such skeletons increases.

A single skeleton can reportedly fetch a price between Tk 35,000 to

Monjurul Islam, villager, appealed to the local police to take strong measures to prevent such thefts.

Contacted, Md Khodadad Sumon. Additional SP (Birganj Circle), confirmed that he had visited the graveyards, and the police are actively investigating the incidents.

"Informed, my family members with the help of locals later rescued me and took me to Phulbari Upazila Health Complex. As my condition deteriorated, I was shifted to Kurigram Sadar Hospital."

"The goons threatened to kill me if we do not withdraw a case we filed against Bazlar," he added.

Sajmati Rabidas, mother of Subas, told The Daily Star that her son was attacked by Bazlar's men two years

the court," she said.

"Bazlar along with other accused have been pressuring us to withdraw the case. As we did not withdraw it, Bazlar hired goons again and beat up my son,' Sajmati said.

"We have no assets except 13 decimals of land for our homestead. Bazlar Rahman has long been trying to grab our land, which is why the dispute ensued in the first place. Now Bazlar and his men are threatening to evict us from our home," said Subas's younger sister Purnima Rabidas, a college student.

### Over 237 BNP men sued in Habiganj

A case was filed yesterday against over 237 BNP leaders and activists over the Awami League-BNP clash in Habigani town on August 20.

Habiganj BNP Joint Convener GK Gaus and District Chhatra Dal President Shah Rajib are among the accused, confirmed police.

Mahibur Rahman Mahi, former general secretary of Habiganj Chhatra League, said he had filed the case with Habiganj Police Station under the Explosives Act, accusing 87 named leaders and activists of BNP and its associate bodies and over 150 unnamed party people.

BNP leader Gaus, also a former mayor of Habiganj Municipality, said the case was filed to keep the party men away from political activities. He said that BNP would fight the case legally.

On August 20, supporters of the two rival political parties clashed in Habiganj town for about two and a half

Both parties claimed that the clash injured at least 100 of their people.

Police fired rubber bullets and used teargas canisters to quell the trouble.

### Attack leaves Rabidas youth with broken leg

Family threatened of eviction, pressure on to withdraw a previous case

With excruciating pain in his broken right leg, Subas Chandra Rabidas was seen lying on a bed at Kurigram Sadar Hospital on Friday afternoon.

The marks left on his hands, back, stomach and face - from being beaten up - were still fresh.

The 28-year-old youth from marginalised Rabidas community in Phulbari upazila of Kurigram was beaten up by some goons allegedly hired by his neighbour Bazlar Rahman, with whom his family has a land dispute.

The incident happened in Newashi Bazar area under Bhangamore union in the upazila on Wednesday night.

"I was returning home around 9:00pm after closing my shop as usual. On the way, 4-5 local goons suddenly attacked me with wooden sticks on the bridge in Newashi Bazar area and beat me mercilessly. At one stage, I fell unconscious on the ground. They broke my right leg," Subas told The SEE PAGE 4 COL 6



It has been 47 years, since our National Poet left us for good. Bangladesh Nazrul Sangeet Sangstha intends to preserve the heritage of Nazrul and promote awareness about the depth of his work. The organisation aims to inspire the younger generation of artistes to carry Nazrul's legacy forward.

Observing the Poet's death anniversary (August 27), The Daily Star spoke to Khairul Anam Shakil, to know more about their works and arrangements commemorating the

Could you share about the arrangements which will take place on the National Poet's death anniversary, today?

Nazrul was known for his portrayal of love, freedom and revolution. He opposed religious bigotry through his

Every year, Nazrul Sangeet Sangstha chooses new themes to observe this day. Since it is his death anniversary, we always try to keep the solemnity, thus selecting to perform Nazrul's devotional songs, that speak about solidarity amongst all religions.

The event will take place at Chhayanaut's auditorium in the evening, at 7pm today.

Can you please highlight the preservation process that the institute has initiated?

It is a lengthy process, yet we have already archived 250 songs under strict supervision of Nazrul Institute, which is being performed under exact accordance with authentic lyrics and compositions. These are performed by seasoned veterans and emerging artistes from Bangladesh and West Bengal.

Besides, we have been holding

workshops quarterly in a year, where that goes beyond this instruction, we we discover young talents from all over the country. These talents are primarily students, who are quite eager to learn accurate lyrics, notations and compositions of Nazrul Sangeet.

Each time, we share updates of our preservation at the festival. The next edition will be held around the first quarter of 2024. You will be happy to know that noted singers like Haimanti Shukla and Srikanto Acharya among others, have already lent their voices to the original tunes of Nazrul.

Haimanti Shukla also congratulated us for taking the preservation initiative. She shared that if we can carry this out successfully, then they can attempt to preserve Rabindranath Tagore's works as well. We have also done workshops in Agartala, and plan to have more in

What further plans do you have regarding Nazrul's works, other than his music?

The institute has already given us the responsibility to translate Nazrul's literary works in English, for international exposure. Although it is quite tough to translate his philosophy, we've got some reworks which are really good. We plan to spread these translated works through embassies outside Bangladesh.

Moreover, an online archive titled Nazrul Sangeet Kosh, where the backstory of a song, its meaning and original tune all are available. It will be entirely supervised by Nazrul Sangeet

# Growers innovate farming practices

The rising quantity of mango exports has been changing the farming practices of the fruit in Rajshahi region as farmers are now opting for more chemical-free mango production, agriculturists say.

Farmers are now gradually adopting organic farming method as they intend to meet the high standards, required by the international markets.

This year, a total of 92,913 hectares of land has been brought under cultivation in Rajshahi, Chapainawabganj, Naogaon and Natore, said Md Shamsul Wadud, regional additional director at Rajshahi Department of Agricultural Extension

But, safe or chemical-free mangoes were grown on only 630 hectares of land this year, which was around 500 hectares last year, said the DAE official.

They have a plan to extend the area to 728 hectares next year, he said.

"As the areas are gradually increasing, incidents of pest attacks are also increasing, he said, adding that but farmers are eager to get better prices of their produces from the buyers.

Instead of any harmful chemicals,

farmers are using pheromone traps and adopting fruit-bagging method to protect the fruit from hopper pests, untimely rains and hail storms, said Anwarul Haque, president of Rajshahi Agro Food Producers' Association.

"We use pesticides on three to four occasions before applying the bagging method," Haque said.

Farmers stop use of chemicals 45 days before the fruits arrive at the market for sale, he said.

"Growers are now opting for quality mango production, targeting the international markets," Sohel Rana, one of the mango growers from Naogaon,

Another mango producer Shafiqul Islam of Rajshahi's Bagha upazila said apart from the pheromone traps and fruit-bagging, a few farmers also use biopesticides, which is quite costlier.

Such methods attract the buyers, he said, adding that exporters contact the farmers before the season starts, while local DAE officials examine the farming processes.

According to the DAE, this year around 2,700 tonnes of mangoes were exported to some 34 countries across the world, compared to 1,757 tonnes last year.

They took her to Madartek area the next morning, and Harun, the ex-husband, told Masum to take her back to the Hatirjheel house after Jum'a prayers.

"When Masum, Raju and Sabbir went out to get food, she managed to escape," Moin added.

On August 19, Masuma filed a case against seven people for abduction, torture and ransom, but her ex-husband was not included as an accused, according to police.

Asked whether the law enforcers will arrest Harun, the Rab official said the case is being investigated by Ramna police and the investigation officer may quiz or arrest him.

India's budget Moon landing is a model for other countries aspiring to develop their own space programmes, Prime Minister Narendra Modi said yesterday while praising the scientists behind the successful mission.

"Mooncraft" in Chandrayaan-3 Sanskrit -- touched down on the lunar surface on Wednesday, making India the first nation to land an unmanned craft near the largely unexplored lunar south

It also became only the fourth country behind the United States, Russia and China to achieve a soft landing on the

The success marked the latest milestone in India's ambitious but cut-price space programme, sparking celebrations across the world's most populous country.

"The region that our mission will explore will help open new avenues for moon missions of other countries," Modi told mission staff at the Indian Space Research Organisation (ISRO) premises in

"This will not only unravel the mysteries of the Moon but also help in resolving the challenges of the Earth.

This week's mission comes four years after the previous Indian lunar mission failed during its final descent, in what was seen at the time as a huge setback for the country's space programme.

Modi praised the scientists for learning from that failure and being unrelenting in their pursuit of the Moon mission.

### **FUKUSHIMA CRISIS** Japan says no radioactivity found in fish

Japan's fisheries agency yesterday said fish tested in waters around the wrecked Fukushima nuclear plant did not contain detectable levels of the radioactive isotope tritium, Kyodo news service reported.

Nets were set up on Thursday when plant operator Tokyo Electric Power Company (Tepco) 9501.T began releasing treated radioactive water into the Pacific, angering fishermen and many others in Japan, alarming consumers in neighbouring countries and prompting China to ban Japanese aquatic products.

The agency plans to announce test results daily. Tepco said on Friday seawater near the plant contained less than 10 becquerels of tritium per litre, below its self-imposed limit of 700 becquerels and far below the World Health Organization's limit of 10,000 becquerels for drinking water.

After lengthy debate, the government decided on Tuesday to allow the release of 1.3 million tonnes of treated water from the Fukushima plant, destroyed by a 2011 tsunami, because Tepco was running out of storage space.

The utility filters most radioactive elements out of the water, but it dilutes tritium, an isotope of hydrogen, which is difficult to separate from water.

Yesterday, protesters gathered in the capital of South Korea to demand that the government take steps to avoid what they fear is a looming disaster from Japan's release of treated radioactive water from the Fukushima nuclear power plant.

# Russia 'foils' more drone attacks

Says three drones downed; second ship since grain deal expiry leaves Ukraine's Odesa

AFP, Moscow

Russia yesterday said that it shot down two drones over its Belgorod region and one headed for Moscow, as it reported Ukrainian shelling wounded six people in a border town.

Russia and the Moscow-annexed Crimean peninsula have been hit by a wave of attacks in the past month, after Kyiv warned in July it aimed to "return" the conflict to Russian territory.

The Russian defence ministry said one drone was destroyed close to the border in Belgorod region at 09:00 (0600 GMT), while another was intercepted over the region at 14:15 (1115 GMT).

A separate drone headed for Moscow in the early hours of the morning was also thwarted, the defence ministry said.

attacked during the early stages of the conflict, is now being targeted by almost daily drone strikes.

"Tonight, air defence forces destroyed a drone on approach to Moscow in the Istrinskii district," the capital's mayor Sergei Sobyanin wrote on Telegram.

"Preliminarily, there were no casualties or damage. Emergency services are working on the site," he added.

The drone attacks came as the governor of Russia's Belgorod region said Kviv shelled the town of Urazovo, about 10 kilometres (six miles) from the Ukrainian border, injuring six people.

Russian regions bordering Ukraine have regularly accused Kyiv's armed forces of indiscriminate shelling and occasional crossincursions by Ukrainian-backed

Meanwhile, two people were killed and one wounded yesterday after Russian forces shelled a village near the town of Kupiansk in Ukraine's northeastern Kharkiv region, hitting a cafe, officials said.

Odesa's three seaports shipped tens of millions of tons of grain during Russia's invasion under a UN-brokered deal which collapsed in July after Moscow withdrew. Russian forces have

since targeted Ukrainian ports with volleys of missiles and kamikaze drones. Meanwhile, Russian Deputy Foreign Minister

Sergei Ryabkov yesterday said Russia's military cooperation with Iran will not succumb to geopolitical pressure, following a report that Washington has asked Teheran to stop selling drones to Moscow.

"There are no changes, and cooperation with Iran will continue," Ryabkov said, according to a report on Saturday from Russian state news agency RIA. "We are independent states and do not succumb to the dictates of the United States and its satellites."

#### 9 killed in Indian train coach fire

At least nine people were killed yesterday after a train coach parked in southern India caught fire when a passenger tried to make tea, officials said.

The coach, which had been detached from a train, was stationed at the Madurai railway yard in the southern state of Tamil Nadu when the fire broke out before dawn.

"It was a single, stationary coach booked by a private tourist operator. Somebody tried to make tea and it caused the fire," Madurai district spokesman Sali Thalapathi told AFP.

"Nine people have died, three of them are women Nine others are injured but their injuries are not lifethreatening."

None of the bodies had been identified so far, he added.

Footage showed huge flames leaping out of the windows of the train carriage. Some passengers managed to escape the inferno in time.

Local media reports said the passengers had illegally smuggled aboard a gas cylinder which exploded when they tried to use it.

### Bhutan cuts daily tourist fee by half

The Himalayan kingdom of Bhutan is to halve the \$200 daily fee it charges tourists in an effort to boost a sector still struggling to recover a year after the end of Covid-19 restrictions. Bhutan raised its "Sustainable Development Fee" to \$200 per visitor per night, from \$65, when it ended two years of Covid restrictions in September last year saying the money would go to off-set the carbon generated by visitors. The new rate of \$100 per night would come into effect from September and last for four years, the government said in a statement late on Friday.

### Disinformation 'first sin' of journalism: Pope

Francis vesterday denounced "disinformation" and fake news spread in an effort to influence public opinion as journalism's principal offence.

"Disinformation is the first of the sins, the mistakes -- let's say -- of journalism," Francis told Italian journalists at a Vatican gathering to bestow a journalism prize.

Widely considered a savvy communicator himself, the pontiff returned to the term "sins" to list what he called the four misdeeds of the media, according to the Vatican's translated statement of his comments.

"Disinformation, when journalism does not inform or informs badly; slander (sometimes this is used); defamation, which is different from slander but destroys; and the fourth is... the love of scandal."

"I am concerned, for example, about the manipulations of those who interestingly propagate fake news to steer public opinion," he said, urging a "reawakening of responsibility" in particular as Europe grapples with the ongoing war in Ukraine.

## Hunt for Loch Ness monster begins

The biggest search for the Loch Ness Monster in five decades got underway in the Scottish Highlands yesterday, as researchers and enthusiasts from around the world braved pelting rain to try to track down the elusive Nessie.

The expedition deployed drones with thermal scanners, boats with infrared cameras and an

underwater hydrophone to try to unravel a mystery that has captivated the world for generations.

"There's not a corner of the globe you can go to where people haven't heard of Nessie, but it is still one of our biggest questions -- what is the Loch Ness Monster,' said Paul Nixon, general manager of the Loch Ness Centre told AFP.

The searchers believe the thermal scanners could prove crucial in identifying any strange anomalies in the murky depths.

The hydrophone will allow the searchers to listen for unusual Nessie-like underwater calls. Stretching 23 miles (36 kilometres) and with a maximum depth of 788 feet (240 metres), the

There are now more than 1,100 officially recorded Nessie sightings, according to The Loch Ness Centre in Drumnadrochit, near Inverness.

The monster brings in millions of pounds

(dollars) in tourism revenue to the Scottish economy each year.

Over the scientists and amateur enthusiasts have tried to find evidence of a large fish such as a sturgeon living in the depths of the loch.

Some have suggested the monster could be a prehistoric marine reptile like a plesiosaur.

In 1972, the Loch Ness Investigation Bureau undertook the biggest search to date but returned empty-handed.

In 1987, Operation Deepscan deployed sonar equipment across the width of the loch and claimed to have found an "unidentified object of unusual size and strength".

In 2018, researchers conducted a DNA survey of Loch Ness to determine what organisms live in the waters.

No signs of a plesiosaur or other such large animal were found, though the results indicated

### Decline in Rohingya funds most worrying

#### World leaders must step up financial contributions to help them

It is disheartening to see that even after six years since they fled a brutal campaign by the Myanmar military, the future of the Rohingya refugees remains as uncertain as the day they arrived on these shores. The crisis has only grown since, with none of the options considered so far – their repatriation to Myanmar, legal integration into Bangladesh, or resettlement in a third country – seeming any closer to fruition. Bangladesh stands firm on repatriation – the most just option – as do the refugees. But until that happens, the priority is to ensure steady provision of assistance and support for the refugees and host communities.

Unfortunately, that is proving to be increasingly challenging. As per an estimate by the International Organisation for Migration (IOM), this year, humanitarian organisations have appealed for \$876 million in aid for both Rohingya refugees and local communities. However, only 29 percent of the target had been achieved as of mid-year. The steep decline in funds is forcing humanitarian actors to "focus on the most critical and life-saving needs", according to the UNHCR. It has, for the first time, resulted in the reduction of refugees' food assistance, raising concerns about cascading dramatic consequences: malnutrition, school dropout, child marriage, child labour, gender-based violence, etc.

The timing of this couldn't have been worse. It comes at a time when the refugees are facing a greater test of their resilience than ever before, with fires raging their shelters in March, a cyclone ripping through the camps in May, and monsoon rains and associated risks now endangering their lives. While some of the challenges are natural, they do add to the overall crisis. Unfortunately, the larger issues surrounding repatriation and prosecution of the Rohingya genocide have been politicised so much that it has also affected funding prospects, with regional powers like China, India and even Russia showing little interest in providing funds, let alone matching the contributions of their Western counterparts, which could ease some of the immediate pressures.

This is deeply troubling. While the larger issues are being resolved - which, we hope, will be sooner than later - the importance of consistent financial support cannot be overemphasised. This is not just a matter of humanitarian assistance; it's a matter of upholding human rights. We urge world leaders to step up their financial contributions as well as diplomatic efforts to find a sustainable resolution to this

### Why are there so few nurses?

#### Shortage of nurses is affecting the care of dengue patients

At a time when the dengue outbreak is taking lives every are again reminded of the acute shortage of doctors, nurses and other health workers in public hospitals. A report in this newspaper gives a grim picture of the dengue wards of Dhaka Medical College Hospital (DMCH), the largest public hospital in the city. It is unthinkable that there are only four nurses per shift looking after 100 patients daily, with the numbers reaching 200 at times. It goes without saying that nurses are the ones who carry out follow-up instructions for doctors and have to be on constant alert for any changes in patients' condition. A shortage as severe as this obviously affects the care and recovery of patients.

Even during regular times, our public hospitals do not have enough nurses or doctors, anaesthesiologists, surgeons, gynaecologists and other healthcare staff. This paper has reported innumerable times the manpower crisis in district public hospitals, where patients cannot get proper care and are often forced to go to private facilities where costs are often beyond their means.

In 2020, there were approximately 73,043 registered nurses while the estimated demand was for 3 lakh. We have nursing institutes but many nurses opt for the private health sector or overseas jobs where the pay is better. In recent years, the government has tried to attract more nurses by offering better pay and benefits, but clearly, It is not enough to ensure an adequate inflow of nurses in public hospitals.

The government, therefore, must strengthen nursing and midwifery education and increase the capacity of nursing institutes. Policymakers must review the curriculum, faculty and teaching methods, and where necessary, reform them so that the skills of nursing graduates match the needs of the health sector. Moreover, they must focus on recruiting more nurses, establishing more nursing colleges, and providing adequate incentives, financial and non-financial, to persuade them to join public hospitals so that patients are better served at times of health emergencies.

Internally displaced persons (IDPs) are ones forced to flee their homes due to war, armed conflict, ethnic/religious persecution, and various forms of natural disasters. Lately, the impacts of climate change have joined the list of displacers. IDPs live in their own countries as displaced and homeless, without crossing an international boundary. They are found to migrate internally for employment and livelihood.

Although often interchangeably, IDPs are different from refugees in many respects. Refugees are those who fled their homes for another country and are unwilling to return due to the violation of their human rights and/or fear of torture and intimidation. There are also "economic" refugees, who leave their countries in desperation due to economic hardships and for a better life. While IDP is an internal and descriptive category, refugees receive protection under international law and can't be forced to return home.

According to the United Nations High Commissioner for Refugees, by the end of 2022, there were around 108.4 million people worldwide who were forced to flee their homes. Of these, 62.5 million were IDPs. Bangladesh is currently placed 17th among countries with the largest numbers of IDPs. Many of the displacements in Bangladesh are

The extent of losses and damages caused by erosion displacement can be significantly reduced with an SOP dedicated to erosion displacement, resettlement, and rebuilding. Such an SOP should address socio-economic

and displaced households are on the margins of Bangladeshi society and are deprived of basic protection and assistance. They are dispossessed of their land resources and other property, and are unable to secure livelihoods for themselves. The SOP should help develop and strengthen the localised strategies of resilience and adaptive mechanisms for the socio-economic development of IDPs. The Disaster Management Bureau of the Ministry of Disaster Management and Relief should look into this urgently and extensively. IDPs are one of the most vulnerable

groups in the country. Bangladesh cannot afford to leave behind the IDPs in its journey to becoming a middle-income country. The government should put it high up on its agenda to prevent and manage internal displacement, protect those already displaced, collect data on the numbers and conditions of IDPs, support training on the rights of IDPs, and develop localised strategies for all kinds of climatic adaptation and development. This would require a comprehensive, IDP-specific legal instrument that affirms the rights of those who are internally displaced, minimum while establishing standards for the well-being of IDP communities.

The proximity of the Bay of Bengal to the country's south is particularly concerning, as the negative impacts of rising waters are already apparent. Over the next few decades, millions could be displaced if the at-risk Sundarbans and heavily populated coastal areas become submerged. By 2100, there could be a 0.4- to 1.5-metre rise in sea levels, which presents Bangladesh's islands with a possibility of going under.

In this situation, we may take lessons from strategies that other countries are using to combat this crisis. For example, due to its low elevation, Netherlands is particularly susceptible to rising sea levels. So, its

government has put in place measures such as creating greater space for rivers to lessen the risk of flooding, strengthening river dikes, building coastal dikes and seawalls, and investing in environmentally friendly urban development. Bangladesh has formulated the Delta Plan 2100, drawing lessons from the Netherlands' experiences.

Low-lying deltaic landscapes can be found in both Bangladesh and the Netherlands. However, Bangladesh does not have the financial, scientific, or technological resources to build raised sea fortifications. Furthermore, it is essential to incorporate adaptation measures for climate change into national and sectoral planning if these plans are to be in line with the nation's overarching objectives for sustainable development. A thorough and strategic approach is required to defend against the recurrent floods and climatic disasters Bangladesh faces.

Another example is Japan, whose resilient urban planning ideas could inspire Bangladesh's ability to anticipate and respond to disasters. In addition, Costa Rica's concentration on sustainable land management and reforestation provides insights into reducing the effects of climate change. These strategies demonstrate the


viability of targeted measures to increase resilience against floods and climate disasters, even though each solution may need to be modified to fit Bangladesh's context. The country needs to decide on how to cope with the challenge of sea-level rise, as farming and residential areas may become submerged. For instance, with climate change harming food production, researchers could develop a type of rice that can withstand flooding and salinity while providing a

higher yield. Additionally, houses can also act as shelters, so people do not have to go far from their homes when floods occur. Similar initiatives have already been undertaken by some local

The government has made some progress in protecting people and infrastructure from rising sea levels. Bangladesh has submitted multiple national communications to the United Nations Framework Convention on Climate Change and has formulated a 100-year delta plan. Its adaptation plans include water, flood, and erosion management, ensuring climate-resilient livelihoods, and various Ashravan projects. Among all these, constructing a barrage on Brahmaputra and the Gorai River Restoration Project are the most important. Besides, lead authors for the Intergovernmental Panel on Climate Change include scientists from Bangladesh, who continue to conduct outstanding studies.

Many tactics can be used to reduce the risks of rising sea levels. But to use these, governments and communities must join hands and act quickly. At the same time, they must put effort into reducing greenhouse gas emissions to stop further global warming. The only way to save our planet and ensure a secure and sustainable future is by taking action urgently.

#### FROM DSA TO CSA

# The same two bottles of agony

The August 7 announcement to repeal the Digital Security Act became a matter of great anxiety and discomfort for citizens, as the government had proposed a Act, 2023, without consulting stakeholders. Unfortunately, the proposed law's content – particularly its provisions regarding cybercrime and the composition and operation of organisations involved in cybersecurity – is essentially identical to that of the Digital Security Act, 2018 and amounts to a contravention of the constitution, international human rights standards, and the rule

At a press conference on August 10, Law Minister Anisul Huq and State Minister for Information Zunaid Ahmed Palak said that stakeholders could provide feedback on the draft Cyber Security Act (CSA) within 14 days and that any specific recommendation made in response would be taken into consideration. was imperative to review the criticism acknowledging the reconsideration communication technology of several previously voiced concerns, which a few organisations have enthusiastically embraced. These concerns include decriminalising ethical hacking, legal action against law enforcement misuse, legal recourse against false and deceptive lawsuits and how to stop them, and monetary compensation for victims of human rights abuses or unlawful detention due to wrongful prosecutions and perjury, alongside other issues.

The proposed CSA and Digital Security Rules, 2020 involve four agencies: Digital Security Agency, Bangladesh government's e-Government Computer Incident Response Team, its Digital Forensic Lab, and the National Digital Security Council. The proposed CSA allows regulators to restrict or delete data based on subjective criteria, potentially restricting free speech. It criminalises vague speech, inviting government interference and potentially restricting freedom of expression. It could also require the BTRC, through government intimation, to delete or block data under Sections 8(1) and 8(2), which might cause Bangladesh's internet to be blocked, filtered, and censored, causing concerns about transparency and official opacity.

Furthermore, the National Emergency Response Team, the director general of the Cyber Security Agency, and police investigators can obtain, remove, block, or otherwise regulate data and internet activity without protections or judicial review under the proposed CSA. Additionally, the draft CSA repeals Section 57 of the DSA, which states that no employee or other party shall be liable for harm resulting from good-faith actions. But if officers, employees, or individuals of these institutions violate fundamental human rights, freedom of expression, and the right to privacy of personal information, how and where can accountability, requirement to publish transparent annual financial and activity reports, and standard operating procedures

be implemented? The proposed Cyber Security penalties most transgressions appear to be excessive, fundamental rights.

disproportionate, and unlawful. For instance, Section 29 criminalises defamation on internet media and carries a fine of Tk 25 lakh for doing so. Besides this, criminal defamation new law called the Cyber Security is punishable by two years in jail with or without a fine under Sections 499 and 500 of the Penal Code, 1860. While defamation on digital media maintains the aforementioned legislative definition, the punishment for the same offence is different. How can an accused get a longer term for the same crime? Due to its conflict with Article 27 of the constitution, Section 29 can be deemed unconstitutional, unlawful, and voidable under Article 26 of the constitution. Also to be emphasised is the distinction between criminal and civil defamation in Bangladeshi law, with the latter being based on tort law. Tort law wrongdoing is decided at the judge's discretion, while defamation must be established beyond a reasonable doubt in criminal proceedings. Damages for civil defamation, however, could During the conference, both said it be determined by probability. The government should have emphasised of the CSA and made statements the significance of adopting modern and public interest, and also lacks Bangladesh's defamation legislation and the emergence of civil defamation in democracies.

The now-possibly-repealed DSA included harsh, unreasonable, and illegal punishment provisions; nevertheless, the proposed CSA minimised excessive penalties and boosted bailable crimes. In reality, the proposed CSA will not aid accused criminals to lessen sentences or increase the number of offences that are eligible for bail since, once a case has been filed, the bailable clause is added to the non-bailable clause, which not only is against the rule of law but also gives rise to fear, intimidation, and panic in citizens. Under the proposed CSA, no new judicial system has been established, and the authority has been given to the Cyber Tribunal that was established under the ICT Act. The bail of the accused under the DSA is also subject to the bail requirements in the ICT Act. It goes without saying that the responsibility imposed on the court before granting bail in the aforementioned act is against legal precedent and unjust in nature.

The state must protect freedom, and human dignity, and reputation without compromising individual rights. Section 38 of the proposed CSA gives the investigating officer 90 days to finish the probe, and the higher authority might grant an extra 15 days. After 75 days, the cvber tribunal might prolong the investigation by statute. The DSA has seen serious clause breaches. The proposed legislation provides harsh penalties on conviction, and the crimes are non-bailable with limited exceptions.

Different nations have unique regulations governing the length of pre-trial detention since there is no chance it may be seen as a punishment. If the investigating agency fails to produce the report promptly, the accused may be granted bail. But there are no laws or standards in place that govern how people are punished for crimes. Measures for penalising violations of the CSA need to be revised. The conflicting stances of recent laws have made our criminal justice system more challenging and contentious, jeopardising people's

Cyberterrorism and security" "national offences. including those that might be used to retaliate against whistleblowers, are also overbroad and do not offer sufficient protection against misuse. While the Disclosure of Information in Public Interest (Protection) Act, 2011 encourages individuals to speak out against corruption, Sections 21, 25, 29, and 32 of the proposed CSA prevent it. Several journalists and rights advocates were prosecuted under the DSA at the beginning of the Covid-19 pandemic for covering misconduct by public officials and representatives. Moreover, citizens were given the power to enforce the legislation, which exacerbated court harassment since judges and investigators did not understand how to investigate and punish DSA

The proposed CSA's Section 34 states that assisting in the commission of an offence constitutes an offence, and the penalty for aiding and abetting is the same as the original offence. This is excessive and disproportionate, as it does not differentiate between those who commit a crime and those who help and abet it. The proposed act lacks distinctions between unlawful action in specific definitions. International cybercrime treaties list several offences, but the proposed CSA defines many of them too broadly and leaves out the question of criminal intent. Additionally, many of the offences in the CSA are already covered by other criminal laws, such as the ICT Act, making it too broad to interpret multiple offences in multiple areas.

More alarmingly, the proposed CSA and the DSA encourage the arrest of children, violating their internationally recognised rights, contravening the UN Children's Rights Declaration and the Charter. Furthermore, the proposed CSA does not include a provision that would make it illegal to file false charges or provide false evidence, which is in violation of Section 211 of the Penal

Citizens have applauded the decision to repeal the harsh and onerous Digital Security Act, 2018. However, the implementation of the CSA could negatively affect social justice, human dignity, fundamental rights, and human rights.

To pass cyber laws, regulations, recommendations, government must regularly, spontaneously, consistently, and meaningfully engage with civil society. Since too many parts of the proposed Cyber Security Act, 2023 from definitions of crimes to the powers, rights, and obligations of administrative institutions – violate national and international human rights legislation, it must not be implemented.

Numerous DSA cases indicate that most prosecutions restrict the public's and the media's freedom of expression, and the provisions in the proposed CSA are raising comparable concerns. In order to preserve the fundamental constitution and human rights (particularly the right to free expression) in Bangladesh, the proposed CSA should not be presented to parliament right away. Fourteen days is not enough time for people to extensively consider an issue of such importance. Instead, a legislative measure such as a bill to repeal the DSA could be introduced to safeguard unencumbered cyberspace freedom and promote democratic principles in Bangladesh.

# Did the Wagner drama expose Putin's weakness?

Two months ago, Russian President and analysts have approached the Vladimir Putin faced the biggest test of his 23-year reign, when Yevgeny V Prigozhin, chief of the paramilitary Wagner Group, seized control of a Russian military office in the city of Rostov-on-Don and made a brief attempt to march in Moscow. The insurrection by the Russian strongman's one-time ally led to sprawling commentary in Western media, which jumped at the sight of Putin's seemingly "weakening grip" over a nation that is, largely and solely, just his.

Theories were concocted in galore that the rebellion panning out would disarray the Russian military, turn the Kremlin upside down, and possibly end the Ukraine war. For

past two months of Prigozhin-filled headlines with wishful thinking and fantasies of a dark political thriller in the making.

Putin's response in the aftermath of the mutiny led to a universal conjecture that he is "weak." Ukrainian President Zelensky used the same label to criticise his adversary. Despite calling the Wagner chief a "traitor," Putin allowed him to strike a deal with Belarus and leave Russia for exile, invited him for a three-hour chat at the Kremlin, and dropped formal charges against him. For each and every day that Prigozhin lived, it reinforced the impression of "Putin's weakness" in the West. The lack of violence in the first response, context, the Wagner Group has divorced from the usual course of

and dissenters coincidentally die by suicide. A long series of mysterious events in the past two decades – such as the attempted poisoning of Alexei Navalny, Putin's biggest opponent, and the sudden death of former Russian KGB officer, and Kremlin's foe, Alexander V Litvinenko from radiation poisoning - have all been perceived as Putin's cunning ways of payback" and his political prowess. Yet, with Prigozhin's demise,

the Western media has been more reserved at drawing conclusions that uphold the narrative of Putin's sustained grip over Russia. The leaderless Wagner Group, with its fighters stranded across multiple countries, is said to be finished, and in the hands of Vladimir Putin, who can frankly do anything he wants with the remnants of it. Still, rather ridiculously, the fact that Prigozhin was alive for the past two months is being analysed by commentators in Western media as a reminder that Putin is weak.

The whole Wagner saga has been interpreted as an embodiment of domestic distrust towards Putin among the ranks of Russian elites and private military organisations. But

against Ukraine, spearheading some the way for the West's shortsighted of the bloodiest battles in the conflict, including the fight to conquer Bakhmut, which killed thousands. Putin has publicly said that the Russian state paid Wagner almost \$1 billion in the first year of the war. Some commentators perceived that, without the mercenary group, the Russian front would collapse – none of which materialised.

The mutiny turned out to be nothing but a short-lived moment the Wagner Group, which lends itself of humiliation for Russia's leader, catapulted by Western journalistic cliches that mistakenly examine Russia's strictly personalist dictatorship through the blackand-white lens of Western liberal conceptions of dictatorship. Even juxtaposing Putin's Russia with Stalin's doesn't take us far enough to understand what's going on today. Though the Stalin era was brutally repressive, it was not as unpredictable and arbitrary as the current state of affairs.

The absence of the Wagner Group has not hurt Russia's position in the Ukraine war, nor has it objectively created negative ripple effects on the morale of the Russian military as analysts had predicted. The Russian Federation has not been fragmented and the military has instead held off against the Ukrainian counteroffensive. Bereft of a proper framework to understand the hidden Kremlin politics, commentators fall from windows "by accident,"

discourse on Putin's political strength.

Then, two months from the day the Wagner chief stepped out to betray Putin, the expected fate arrived. Prigozhin is now reportedly dead in a plane crash, with some of his top lieutenants. The crash also came the same day Gen Sergei Surovikin, commander of the Russian air forces, was alive on borrowed time. But was dismissed. Surovikin was close to to a plausible theory of a calculated, carefully planned purge of those associated with the mutiny - the ultimate act of betrayal against Putin.

The information regarding what caused the crash remains suspicious. While at first, it seemed like a missile from the ground shot the aircraft down, US intelligence now suggests it was sabotage with an explosive onboard. Whatever it was and whether the Wagner chief is actually dead or in some secret cave somewhere – there seems to be little confusion among observers that it was Putin's handiwork. Though the Kremlin has dismissed the claims of Prigozhin's assassination as an "absolute lie," leaders around the world, including US President Joe Biden, are seemingly not surprised at Prigozhin's fate.

Things often happen in Putin's Russia like dark magic, with rarely any explanations or conclusions. People

played a significant role in the war Russia's reputation for deceit, paved that doesn't even matter. The Wagner Group's demise only shows that the regime's strength, and Putin's control, are largely disconnected from the will of the Russian people, including the elites. The fact that such a high-profile political challenger was thrown off the scene reflects the unbound nature of political options that Putin still has.

We all assumed that Prigozhin to hold on to the trajectory of circumstances in that borrowed time. only to purposely underscore Putin's weakness, is completely far-fetched and unproductive. If the ruthless leader's revenge was coming, then wouldn't the guarantees of safety that Putin gave to Prigozhin have all been a part of his twisted game? This remains the least analysed aspect of the Wagner drama in the Western

Let's face it, amid the wildfire of speculations, no one will actually know what happened. But if we need to gauge anything about Putin's Russia, it's that Putin is Russia.

So, Western media can sing the "Putin is weakened" song as much as they desire. But it will play in a vacuum of meaningless conjecture that pushes us further away from truly understanding how things work in a dictatorial system where the leader is the system, and from understanding the actual power of the very leader whose political decisions are severely costing the entire global system.

### Researchers claim a new discovery could drastically reduce hospital admissions

Half of England's adult smokers making the switch to e-cigarettes could save the NHS more than £500 million per year, a study has claimed. Researchers at Brunel University London used data from NHS Digital, the Royal College of Physicians, and the Office for National Statistics (ONS) to identify the prevalence of smoking in each region.

They found that between 2019 and 2021, 13.6% of people aged 18 and over in England smoked. The lowest rate of smokers is in the south east (12.2%), compared to 14.1% in the midlands, 14.6% in the north west, and 15% in the north east and Yorkshire.

The study, published in the British Journal of

Healthcare Management, suggests that if 50% of those people were to switch to e-cigarettes, hospital admissions would reduce by 13%, translating to savings of £518 million.

The figure was calculated by looking at data relating to smoking as a cause of death as well as the risk of developing five diseases as a result of the habit: cancer, heart disease, stroke, chronic bronchitis, emphysema. The research team calculated health expenditure multiplying average ward costs per bed day for a specific disease by the mean length of stay in

hospital for that disease. In the North East and Yorkshire alone, half of smokers switching to a vape could save £148 million, researchers said.

In 2019, the UK government outlined its ambition to make England smoke-free by 2030. It also launched a "swap to stop" campaign in April, offering one million smokers vapes to encourage them to quit cigarettes.





## Shakib prefers dealing one at a time

It was Shakib Al Hasan's first official press meet since being appointed as the new ODI captain of Bangladesh, replacing Tamim Iqbal. The ace allrounder arrived at the press conference room with head coach Chandika Hathurusingha to address the media ahead of Bangladesh's Asia Cup campaign in Mirpur yesterday.

Shakib had been unable to take part in the Tigers' two-week training camp since he was busy playing Global T20 League in Canada and Lanka Premier League. The 36-year-old was seen in Mirpur but did not participate in the practise game on the last day [Thursday].

However, Shakib did make sure he had a proper communication between coach Hathurusingha, the team management and the players to have clarity in order to have a better environment in the dressing room.

"What happened was I had a discussion with [Nazmul Hassan] Papon and then he announced [captaincy]. About the meeting with the team, mainly that day it was the coaching staff who discussed among themselves and I did not require to talk much. It's not that I don't know the players who came in. I know most of them for a long time as majority of them played under me or I played under them.

'So, I don't think there is the need for huge adjustment. The one or two new players, I think, have got an idea about me. Also, the coaching staff have got the idea. So, there is not much of adjustment required and everyone knows their responsibilities. Since we have a cricketing culture or it is developing, everyone knows their job in the dressing room," Shakib told the media yesterday.

The Bangladesh captain across all formats also welcomes the inclusion of young Tanzid Hasan Tamim in the squad. Shakib highlighted the aspect of enjoying the atmosphere in the dressing room, regardless of his performance in the coming days.

With the upcoming Asia Cup emerging as the tune-up for Bangladesh ahead of the ICC ODI World Cup later in October this year, Shakib is not willing to think too far ahead. Instead, he is inclined to focus on the immediate objective: which is to qualify for the second round of the

"I don't think you can relate this with that (with Asia Cup to World Cup) since both are two different tournaments. Yes, if we can do well here, we can gain the confidence that we are growing as a better unit. It will then help us to do well in the World Cup. From that point it is important. But that doesn't mean we will be disheartened if we don't do well in the Asia Cup. Even if we do well it doesn't mean our chances for the World Cup will grow stronger," he said.

Interestingly, Shakib deflected the limelight from himself, both as a leader and also as an individual player, when asked whether he would bat at number three where he shone bright in the 2019 World Cup.

Moreover, Shakib pressed the importance of having the experience behind the team, whether it was his leadership in the 2011 World Cup or the presence of Tamim Iqbal in big events. He, however, reiterated saying everything depends on how well the individual contributes for the team.

#### **FIFA suspend Rubiales** over Hermoso kiss

FIFA suspended Luis Rubiales as president of Spain's football federation on Saturday for kissing Spanish Women's World Cup player Jenni Hermoso on the lips, and banned him from making contact with her.

"(We) decided today to provisionally suspend Mr. Luis Rubiales from all football-related activities at national and international level," world football's governing body said in a statement.

FIFA's suspension of Spanish federation (RFEF) president Rubiales will last 90 days, while they undertake disciplinary proceedings against the 46-year-old.

They added that both Rubiales and the RFEF are prohibited from contacting Hermoso and those close to her.

FIFA's move was the latest

Hermoso said in a statement on Friday that Rubiales and the federation put "continuous pressure" on her and her family and

friends to make her appear alongside Rubiales in a video in which he apologised for his kiss, but she declined.

Rubiales refused to resign at an emergency RFEF meeting on Friday and on Saturday, the federation threatened to take legal action over Hermoso's "lies" about the kiss.

Hermoso said "at no time" did she consent to the kiss following the 1-0 win against England in Sydney, which Rubiales described as "mutual, euphoric and consensual".

The RFEF responded, saying they would "demonstrate each of the lies that have been spread, whether in the name of the player, if that is the case, or by the player herself".

It would take "as many legal actions as necessary to defend the honour of the President of the RFEF."

Hermoso, 33, along with 80 other Spain players, including the entire World Cup winning squad, said they were going on strike and would not play for the national team until the "leadership" changed.

That was a reaction to Rubiales refusing to resign despite unprecedented criticism. He claims he is the target of a "social assassination".

"The camp for the girls' team and their success is what motivated us to start this academy. Manik took a brave decision in this regard," Salahuddin said in his speech.

Manik informed that the players will get 40 percent of the auctioned price while the rest will go to the BFF coffers.





### **DENGUE OUTBREAK** Diarrhoea now a key symptom

More and more dengue patients are experiencing diarrhoea this year, which is causing severe complications.

"Diarrhoea has emerged as a highly prevalent characteristic among dengue patients, which we did not see the previous year - the condition of the patients with diarrhoea is turning worse fast," said Tariqul Matin, assistant director at the emergency unit at Bangabandhu Sheikh Mujib Medical University (BSMMU).

Roughly 40 percent of the dengue patients at BSMMU suffer from diarrhoea along with vomiting.

At noon yesterday, around 28 patients were undergoing treatment at the BSMMU, including the emergency unit and the dedicated dengue unit at the hospital, according to Matin. BSMMU has around 50 beds dedicated to dengue

Doctors at the capital's Shaheed Suhrawardy Medical College Hospital said the same as Matin.

About 30 percent of dengue patients suffer from diarrhoea, said Khalilur Rahman, director of Shaheed Suhrawardy Medical College Hospital.

"This has become a very common feature of dengue infection this year."

Another common feature among the hospitalised patients is vomiting.

"Dengue patients should take adequate fluid such as oral saline. It will prevent vomiting and the patient's condition will remain stable," Rahman said.

### ABDUCTION OF NBR OFFICIAL Ex-husband is the mastermind Rab says after arresting 3

The recent abduction of Masuma Khatun, an official of the National Board of Revenue, was masterminded by her ex-husband, Rab yesterday said after arresting three people, including the prime accused.

The victim's ex-husband, Harun-or-Rashid, a retired government official, hired prime accused Masum alias Masud, 42, who until recently had worked as the victim's driver, to carry out the abduction.

Masum and his two associates -- Hafiz, 48, and Abdul Jalil Panu, 48 -- were arrested from Gazipur's Sreepur and Dhaka's Sabujbagh on Friday night, Khandaker Al Moin, director of Rab's legal and media wing, told a press briefing at the Rab Media Centre yesterday.

So far, six people were arrested over the incident.

Masuma, a joint tax commissioner of the NBR, was abducted on August 17 from in front of Vigarunnisa Noon School and College. She managed to escaped the following day, 18 hours after the abduction.

After preliminary interrogation, Rab said Masum earlier worked as Masuma's driver but was sacked for "misbehaviour" on August 1.

Harun recently contacted Masum and said he would give him a handsome amount of money if he abducted and took Masuma to Harun's rented house in Hatirjheel area, said the Rab official.

He was allegedly angry about her second marriage and "wanted to teach her a lesson". He also made a complaint in this regard to the NBR in April.

"He initially paid Masum Tk 70,000," the official added. After receiving the money, Masum informed his associates Hafiz, Panu, Raju, Sabbir, Saiful and Shanto about the plan to abduct her and distributed the money among them.

# 15 BNP men injured in 'AL attack' in Cumilla

At least 15 BNP leaders and activists were injured, including two with gunshot wounds, in an attack allegedly carried out by Awami League men in Cumilla yesterday.

They were admitted to Comilla Medical College Hospital, he said, adding that doctors said they were out of danger.

The clash ensued at Govarbhanga Bazar in Belghar North Union around 2:00pm when AL and Jubo League men brought out a procession, at which time the BNP was also holding a committee meeting.

Witnesses said AL and Jubo League men led by upazila parishad Chairman Kamrul Hasan and upazila AL Organising Secretary Ayatullah attacked the BNP programme venue. As tensions mounted, they traded
