Another \$1b budget support expected this year

ADB leading the climate-centric co-financing arrangement

Bangladesh is expecting another \$1 billion in budget support towards the end of the year in a financing arrangement led by the Asian Development

Of the \$1 billion, the Manila-based lender would be providing \$400 million; Japan International Cooperation Agency, the China-led Asian Infrastructure Investment Bank and other donors would be providing the

The funding is to support the country's $\,$ efforts towards climate change mitigation and/or adaptation and low-carbon development, following in the leads of the World Bank and the International Monetary Fund, which earlier provided \$500 million and \$1.4 billion respectively. "A low-lying, densely populated

country with a high poverty rate, Bangladesh is particularly vulnerable to the impact of climate change," the ADB said in a project document.

Bangladesh is also a country highly vulnerable to climate risk, ranked seventh on the Global Climate Risk Index 2021, it

Subsequently, the Manila-based lender has taken the initiative to support Bangladesh's climate risk mitigation and adaptation (including renewable energy, energy efficiency and green transportation sector).

For Bangladesh, the \$1 billion would go some way towards propping up its strained dollar stockpile, which stood at \$23.2 billion as of August 23, according to data from the central bank.

Last week, the ADB team met with officials of the finance ministry and the ministry of environment, forest and climate change to work out the conditions for the funding, The Daily Star has learnt from officials involved with the proceedings.

One of the conditions pertains to arresting pollution of the water bodies.

An enforcement guideline must be drafted for the polluters complete with an environment court and penalty for pollution.

Similarly, a multisectoral action plan must be drafted to control air

The government will also have to come up with a green energy policy. "Rapid economic development has significantly increased power consumption and greenhouse gas emission (GHG) in Bangladesh. The carbon dioxide (CO2) emission per capita has grown from 0.2 tons in 2000 to 0.64 tons in 2020," the ADB said.

In 2021, 60.2 percent of the country's power generation came from liquified natural gas, 22.5 percent from heavy fuel oil and 6.2 percent

Besides increased CO2 emissions and other pollutions, high reliance on imported fossil fuels drains public and private resources and exposes the country to energy security issues, the ADB said.

Renewable energy accounts for 3 percent of power generation, far nort of the government target of 10 percent

Bangladesh has committed to the implementation of the Paris Agreement under the Nationally Determined Contributions (NDC), setting an ambitious goal of a 6.73 percent reduction in GHG emissions by 2030 (15.12 percent conditional reduction in GHG emissions with support from the international community) versus the business-as-usual

To achieve these targets, sizeable investments will be required, with the appropriate policy, and regulatory and institutional support, the

The state-owned enterprises will also have to adopt a climate-related policy and the government will have to come up with a solid action plan for implementation of its Delta Plan 2100.

The General Economic Division will have a Delta wing and will monitor whether environment-friendly projects are being onboarded by the ministries and divisions.

The local government division will also have a cell for environmental risk identification and mitigation.

Toddler goes missing while playing

Family fears he fell into roadside drain

18-month-old child has been missing since yesterday afternoon; family and locals fear he might have fallen into an open drain near their house in Agrabad's Rongi Para in the port city.

However, no one saw it happening.

Locals said the toddler, Yasin, the only child of Saddam Hussain, a private car driver, and Nasrin Akter, a homemaker, might have fallen into the drain while playing on the road behind their house around 4:30pm, adding that the drain was full to the brim due to overnight torrential rain.

Yasin's uncle Md Rashid said, "His mother fed him lunch and went to another room for a while. They live on the bottom floor and though the front door was locked, the back door

DENGUE OUTBREAK

August cases surpass all of 2022

Experts blame city corporations' 'casual approach'; 11 more die

With four days shy of the month-end, August has seen a higher number of dengue cases than all of last year.

According to the Directorate General of Health Services, 2,327 new dengue cases were reported yesterday, taking the month's tally of recorded cases to 62,679.

The number of dengue cases throughout last year was 62,382.

Adding to that, the number of fatalities in August so far - 297 -- also surpassed that of last year's -281.

Meanwhile, the number of dengue deaths from January till vesterday stands at 548, while the number of patients rose

to 1,14,511.

Experts meanwhile reiterate that necessary measures should be taken to kill Aedes mosquitoes and bring the situation under control.

They blame the casual approach of the authorities concerned for the rise in the numbers of cases and deaths this year.

Entomologist GM Saifur Rahman said, "The city corporations' casual approach early in the season contributed to increased breeding of the Aedes population -- carrier of the dengue virus.

delay HSC exams by an hour

Parts of port city go

Waterlogging caused by overnight downpour has disrupted the lives of residents in Chattogram and forced the authorities to delay the HSC exams by an hour yesterday.

The exams started at 11:00am, instead of 10:00am, so that students commuting through flooded streets do not miss the tests,

The Met office recorded 118 mm of rain in 24 hours till 9:00am yesterday, officials said.

HSC student Gazi Tasnim Hasan Muhi said she left her home in Halishahar Shyamoli around 7:45am to reach his exam centre 9km

"Many students were waiting for vehicles in knee-deep water. But there was nothing on the road," she said.

After she waited for an hour to find transport, her father arranged a vehicle to take her to the examination centre.

At Kapasgola City Corporation School and College, there was waist-high water in the exam halls on the ground floor. Over 700 students from six colleges were scheduled to sit for examinations

Principal Nur Banu Chowdhury said three students were absent

The ground floors of most buildings were inundated in the Muradpur, Bahaddarhat, Badurtola, Kapasgola, Sholashahar, Probortok, Agrabad, Halishahar, Chawk Bazar, Chaktai, and Khatunganj areas and on KB Aman Ali Road and DC Road. RECURRING WATERLOGGING

Waterlogging is a perennial problem in the port city. The Chattogram Development Authority has been implementing a project worth Tk 5,617 crore to address waterlogging since

Lt Col Shah Ali, the project director, told reporters on May 2 that physical work made 76.26 percent progress.

Experts say the project is not benefitting the city dwellers yet.

1 lakh people affected in four districts

Teesta likely to see its water level fall from tomorrow

The water level in the Teesta may begin to fall tomorrow while the swelling Jamuna may cause floods in vast areas of Sirajganj, officials said.

Floods caused by the Teesta are currently affecting almost 1 lakh people in Lalmonirhat, Kurigram, Nilphamari and Rangpur districts, they added.

This is the fourth time the Teesta has flooded villages on its banks this year.

If the Teesta water does not recede in a day or two, Aman paddy cultivated near the banks in the districts may get damaged, said Biplab Kumar Mohanta, deputy director at the Department of Agricultural Extension

Rahmat Ullah, 70, of Gobardhan area of Aditmari in Lalmonirhat, yesterday said he and his family members have only eaten puffed rice, molasses and bread since Friday night, when part of his house and his kitchen

got inundated, making it impossible to cook. Another farmer named Nabir Hossain, 65, of Rajahar upazila of Kurigram, said he left his flooded home on Saturday and took shelter in a hut made of plastic sheet on an embankment.

Administration officials said they were distributing

Dhaka looks to start repatriation this year with 1,000 Rohingyas

Says foreign secretary

UNB, Dhaka

Foreign Secretary Masud Bin Momen yesterday said the government wants to begin repatriation of Rohingyas to their place of origin this year, initially with around 1,000 of the refugees.

"We have given [Myanmar authorities] a list of over 3,000. We need to make sure that families are not separated," he told reporters at the foreign ministry.

The secretary said the Myanmar authorities will get three months if they start preparations from September to begin the repatriation.

He said a Bangladesh delegation will be visiting Myanmar next month while a team from Myanmar will be here to talk to Rohingyas as part of confidence-building measures.

The foreign ministry on Friday said that further delay to commence safe, voluntary and sustainable repatriation and shortage of humanitarian support may put the entire region at risk.

UP member lands in jail for torturing man

Why you should care

Our loved ones, either in their final days or suffering from incurable diseases like cancer, kidney or liver failure, dementia, stroke, and other terminal ones, need hospice and palliative care.

Hospice is comfort care for those who have no option of being cured, or the family has chosen not to pursue treatment because the sideeffects outweigh the benefits, while palliative care is comfort care, with or without the intention of being cured.

Unfortunately, there are only few such places that offer both hospice and palliative care in Dhaka. In fact, many of us are not even aware that such care systems exist that can make the final days of our loved ones more comforting. "Palliative care could

transition to hospice care if the doctors project the person is likely to die within six months," says Dr Shahinur Kabir, founder and consultant of Hospice Bangladesh.

We all fear death — we don't want to suffer a painful one either - for our loved ones or ourselves. Places like Hospice Bangladesh want to make us aware of such endof-life care.

In our society, such care can be expensive, but Dr Shahinur Kabir believes that if the government subsidises the logistical expenses, then grieving families can benefit.

There is scope to work on palliative and hospice care in Dhaka. We all have elderly parents and we are obligated to keep them happy and give them a comfortable end-oflife.

FREEDOM FIGHTER FARUK MURDER SC orders court to finish trial in 6 months

The Appellate Division of the Supreme Court yesterday directed the lower court concerned to finish the trial proceedings of Tangail's freedom fighter Faruk Ahmed murder case in six months.

The apex court also upheld a High Court order that on July 19 rejected the bail petition of former mayor Shahidur Rahman Khan Mukti, an accused in the case

A five-member bench of the Appellate Division led by Justice Obaidul Hassan passed the order after dismissing an appeal filed by Mukti challenging the HC order rejecting his bail.

The bullet-hit body of Faruk was found near his College Para home in Tangail town on January 18, 2013. After three days, his wife Nahar Ahmed filed the murder case with Tangail Model Police Station accusing unidentified people.

Man hacks ex-wife to death, suspect held

A woman who was stabbed to death by her former husband at Chunarughat upazila of Habiganj late Saturday night.

Police and locals said Sujan Mia and his ex-wife Akalima Khatun, 32, bumped into each other and had a heated exchange of words over her remarrying.

At one stage of the arguments Sujan hacked Akalima with a sharp weapon. The blows severed Akalima's left hand and almost severed her left leg from the ankle.

She was first taken to Chunarughat Upazila Health Complex where doctors advised she be taken to Sylhet MAG Osmani Medical College

Akalima died on the way around at 11:00pm. The body has been sent to Habiganj 250-bed district hospital for autopsy, said Rashedul Haque, officer-in-charge (OC) of Chunarughat Police

4.3 lakh yaba pills seized

Members of Border Guard Bangladesh yesterday recovered 4.3 lakh yaba pills during a drive in Teknaf upazila, Cox's Bazar.

The contraband narcotics were being smuggled to Bangladesh from Myanmar through Alugola Majhekathi border in the early hours, said a BGB press release yesterdav. Tipped off, a patrol team of BGB-2 under

Nazirpara BOP conducted a drive in the area around 1:30am and challenged six people.

Sensing the presence of the law enforcers, the suspected smugglers jumped into the Naf river

leaving behind four bags and fled to Myanmar. Later, the BGB recovered the pills from the bags.

'Efforts are on to identify the smugglers," said the release.

Father, daughter die in Ctg landslide Heavy rain, urban sprawl to blame

daughter Bibi Jannat, said Nurul Alam, police camp in-charge of Chattogram Medical College Hospital (CMCH).

It was by sheer luck that Sharifa and her other daughter, 11-year Bibi Kulsum, survived the landslide. However, both of them sustained injuries.

Visiting Sharifa's house, this correspondent found that grief and sorrow hung heavy on everyone present there.

The couple eked out a living selling tea at the Sholashar railway station. Sohel, a resident of Sharshdi union in Feni, came to the port city two

decades ago to earn a living. "We heard a loud noise. After that, we went to my uncle's house and found that they got trapped under earth and bricks," Bibi Fatema, a niece

of Sohel, told The Daily Star yesterday. "All four members of the family got trapped when a portion of a hill fell on their thatched hut in a slum built on the slope of a hill," said Abdullah Service and Civil Defence.

However, two of them were declared dead when taken to the hospital, he added. colony, this Visiting the

correspondent found that more than a hundred families are still living precariously on the slope. Residents alleged that Abdul

Khalek, an employee of Bangladesh Railway (BR) engineering department, built the houses by cutting the hill where the landslide occurred.

Mohammed Farid, a BR staff who lived in the colony, told The Daily Star that Khalek destroyed the hill and built houses on it and rented those to low-income people.

Abidur Rahman, Divisional Railway Manager (DRM) of Chattogram, said, "We suspended Khalek for cutting a hill and building structures on railway land illegally.

Nabi However, Hossain Chowdhury, chairman of Shaharbeel union of Chakaria, said five out of seven sluice gates in his area were clogged by waste and denied that prawn cultivation had anything to do

steps taken have been inadequate." According to the city corporation, there are 57 (161km) canals and 765km of drains in the city.

In 2021, it conducted a survey to identify risky drains, canals and footpaths.

After the survey, 5,527 risky spots were identified but the work to secure those spots have been lackluster, sources within the CCC said.

Contacted, CCC Chief Engineer Rafiqul Islam said the work for installing slabs on open drains and retaining walls by the canals was going on.

Slabs have already been installed on 30,000 square feet of open drains, while retaining walls have been built by 18,000 square feet of risky canals

However, while visiting different

Bazar, Chatteshwari Road, Rahattar Pool and KB Aman Ali Road, the drains and canals were found open and unprotected.

Contacted, CCC Mayor Rezaul Karim Chowdhury said he was informed about the baby going missing. "I have instructed the CCC officials to join the rescue operation."

'365 days of injustice'

Students, eminent citizens seek Khadiza's immediate release

The DSA has now been converted into the Cyber Security Act (CSA).

Criticising the CSA. Dhaka University Professor Taniim Uddin Khan said, "Such laws were enacted so that none can criticise the ruler, and by enacting such laws, they (the rulers) have not only ensured their stay in power but also ensured the safety of those who are their associates.'

Professor Tanjim made these remarks while addressing a programme titled '365 Days of Injustice' organised by students from different universities on the one-year anniversary of Khadijatul Kubra's detention, held at the Dhaka University Teachers Students Centre.

"This law targets not just persons like Khadijatul, but also others who criticise and speak out about the government's wrongdoings. They will be watched by the government, their voices will be muffled, and they will finally be imprisoned and die in jail day one day," he added.

Dhaka University Prof Samina Lutfa stated, "Whenever elections approach, the names of these laws are changed, but the laws and their clauses have remained the same. In some cases, these laws have become even more oppressive than their previous versions."

Academic activities in peril

Teacher shortage, lack of infrastructure to blame

Academic activities Bangabandhu Sheikh Mujibur Rahman Science and Technology University in Gopalganj are being severely hampered due to a shortage of basic infrastructure and teachers.

Established in 2011, the BSMRSTU currently has only 284 teachers for a total of 10,845 students enrolled across 34 departments. The university with its student-to-teacher ratio of 38:1 falls short of meeting the University Grants Commission's recommended ratio of 16:1 for science universities.

In several departments, the ratio is far higher than the average of one teacher for every 38 students. Departments like Architecture, Botany, History, Tourism and Hospitality Management, Food and Agro Process Engineering, Fisheries and Marine Bioscience,



and Biotechnology and Genetic Teachers' Association. Engineering, have less than five teachers each.

"We don't have enough teachers for such a high number of students. Students in many departments are deprived of the required number of lectures and sessional classes as of a result," said Dr Kamruzzaman, former president of BSMRSTU

We have urged the university administration to recruit more experienced teachers to address the issue, he added.

Following two tests, Bacillus Thuringiensis Israelensis (BTI) pesticide, imported from China by Dhaka North City Corporation's blacklisted company Marshal Agrovet, has proved to be effective.

Acknowledging the pesticide's efficacy, DNCC Chief Executive Officer Selim Reza said, "Both the organisations, in their reports, said Marshal's BTI is effective for killing Aedes larvae. However, we are yet to decide if we will use it."

DENGUE OUTBREAK Tk 50,000 spent per patient Claims health minister;

Unicef to provide \$2.2m STAFF CORRESPONDENT

Health Minister Zahid Maleque yesterday said the government has already spent Tk 400 crore for the treatment of dengue patients in public hospitals across the country.

This expenditure translates to approximately Tk 50,000 per dengue patient, the minister said at a roundtable in Dhaka which discussed the ways to tackle the dengue crisis.

"Around 70 percent of the dengue patients receive treatment from public hospitals while the remaining 30 percent from private hospitals," the minister said, adding that the patients receive treatment at public hospitals free of cost.

The Directorate General of Health Services (DGHS) organised the roundtable where highups from the development partners, UN agencies, two city corporations in Dhaka, the Ministry of Primary and Mass Education, and business organisations attended.

Representatives from different local, private and government organisations at the roundtable highlighted that they have been doing their best to tackle the dengue outbreak.

Mount pressure on Myanmar with sanctions

Suggests AIBS policy brief

Targeted sanctions, diplomatic pressures, and similar mechanisms are needed to hold Myanmar accountable and ensure justice for the Rohingya people, said a policy brief published by the American Institute of Bangladesh Studies

The policy brief titled "Rohingya Crisis: Current Challenges and the Way Forward," marking six years of the Rohingya crisis, was published on Saturday.

AIBS and The Berkley Centre for Religion, Peace, and World Affairs at Georgetown University collaborated to organise a two-day symposium in May 2023 that served as the basis for this policy brief.

During the symposium, the experts also emphasised the importance of international attention and commitment to finding a just and durable solution to the crisis, while highlighting the urgency of addressing the lack of access to education, healthcare, and livelihood opportunities for Rohingya refugees.

The policy brief was authored by Sultan Mohammed Zakaria, a Fellow with the AIBS, and offered a set of policy recommendations to deal with the crisis.

The said actions against Myanmar will prevent the military regime from

perpetrating such human rights violations in the future, said the brief, mentioning how the international community dealt with Syria could be used to address the human rights violations in Myanmar.

It also noted that collaborative efforts between international actors, including governments, NGOs, and civil society organisations, are crucial to protecting the Rohingya's human rights.

The military coup in Myanmar, the gradual decline in international aid for the Rohingya refugees in Bangladesh, and the lack of progress on repatriation talks have created new and complicated realities," it observed.

CHILD PORNOGRAPHY CHARGES University student sent to jail

A university student has been sent to jail on pornography charges for collecting nude images of an American underage girl.

Police arrested the 19-year-old Md Samir on August 21 from his Sonadanga house in Khulna. When produced before a court, he was placed on a two-day remand. He was sent to jail after the remand period on Saturday.

Saiful Islam, additional deputy commissioner (transnational crime) of the CTTC, said on July 26, an official of the US Embassy in Dhaka filed a general diary with the Gulshan police station after the mother of the 13-year-old filed a complaint with Homeland Security Investigations about the incident.

The US authorities notified the US Embassy in Dhaka prompting it to file the GD.

According to the GD, a Bangladeshi "potential sex predator" collected child sexual abuse material (CSAM) or child pornography material from the child.

Acting on the GD, the ADC said police found 164 photos of at least 30 girls from three North American countries from the youth's laptop and cellphone. Samir, a student of computer science department at a university in Rajshahi,

Hosnabad tea garden workers continue strike for arrears

Around 470 tea workers from Hosnabad tea garden in Srimangal upazila of Moulvibazar district are continuing to strike and protest for the 10th day, pushing their demands for arrears and rations.

Mia, general secretary of Hosnabad Tea Garden Panchayat, said the weekly wage and rations are paid to the workers every Thursday, but the payments have now been halted for two Thursdays in a row. "We are starving," he

Working hard, risking wellbeing... all for Tk 400

Daily struggles of stone crushers

S DILIP ROY, Lalmonirhat

Despite going through the arduous task of stone crushing, along with loading and unloading, about 40,000 labourers at Lalmonirhat's Burimari and Kurigram's Sonahat land ports are deprived of fair wages.

Talking to The Daily Star, some workers said they receive a wage of Tk 400 for a day's work from 9:00am to 5:00pm. Their earnings are insufficient to provide for their families, contribute to their children's education, and meet other basic needs. On days when the work is do not get any additional benefits aside from their wages.

Sramik Federation disclosed that the Burimari land port in Patigram upazila hosts 27,000 labourers engaged in stone crushing, while the Sonahat land port in Bhurungamari upazila employs 13,000 workers. At least 20 percent of these workers are women.

Monir Hossain, a 50-year-old labourer at Sonahat, told The Daily Star that they are toiling hard amid constant risk of "silicosis" disease.

"If there had been other job

or borrow from others. Also, they not have worked here," he added. Nazrul Islam, another labourer

at the Burimari land port, echoed Sources from the Sangjukta Monir, saying, "Stone dust enters our lungs through the nose and mouth while working, and it causes deadly silicosis among the workers.' 'Many of our coworkers already

died from silicosis, and many others are still fighting for their lives. Machine owners never help us financially with our treatment, and they ignore us when we demand fair wages," he added.

Nur Islam, owner of a stonecrushing machine at Burimari land port, said the number of stopped, they either have to starve alternatives in the area, I would workers in the region is higher

than the demand. As there is no alternative employment, they work there at low wages. More than 2,000 stone-crushing machines are operated there, each employing 12-25 workers.

"If other machine owners raise the wages, I will also do the same,"

Moniruzzaman Monir, general secretary of Sangjukta Sramik Federation in Lalmonirhat, said they are trying to unite stonecrushing workers on a platform in order to press home their demand for a daily wage of Tk 700.

If the demands are not met, the platform will launch a movement,

Similarly, Takbir Mia, a CNG-run auto-rickshaw driver, said every day he takes passengers to and from the district and neighbouring upazilas through this road.

"We are afraid of accidents... specially during nights," he said.

Shakil Mohammad Faisal, executive engineer of the Roads and Highways Department, did not receive calls when this correspondent tried to contact him.

According to the case statement, Sunjib had a intimate relationship with the complainant since 2013. The victim alleged


that the accused recorded some of their intimate moments without consent. He blackmailed her

HC can't order surrender to lower court

Tania Khondoker to surrender before the Chief Metropolitan Magistrate (CMM) Court in Dhaka in six weeks in a case involving the fall of a girl from their seventh-floor apartment.

The HC also directed law enforcers not to arrest them during this period. In compliance with the HC

directive, Ashfaqul and Tania surrendered before the CMM Court in Dhaka on August 21 and sought bail, which the court granted till September 25.

Yesterday, the apex court scrapped the orders of the HC and the CMM court and directed them to surrender before the CMM court with a fresh bail petition. The SC also asked the CMM court

to consider their bail petition on the merit of the case, said Senior Advocate Md Motaher Hossain Sazu, the lawyer for Ashfagul and Tania.

He said the SC observations and directives will be applicable to all similar cases in which the HC has directed the accused to surrender before the lower courts and asked the law enforcers not to arrest them for a certain period.

Deputy Attorney General Sarwar Hossain Bappi also said the Appellate Division's directive and observations will be binding on all courts.

The case was filed against Ashfaqul, come from a murder case and is Ashfaqul Haque and his wife Tania, and Asma Akhter Shilpi after a seven-year-old girl who was sheltered at Ashfaqul's house jumped off the couple's apartment in the capital's Mohammadpur on August 4, three days after her arrival.

The girl's mother Josna Begum filed the case with Mohammadpur Police Station on August 6.

The girl survived the fall with minor injuries, but has since fully recovered and is now living with her mother. In her statements before the court, she told the magistrate that she wanted to go home and so jumped off the building.

Yesterday, while moving the leaveto-appeal petition, Attorney General AM Amin Uddin read out from the first information report of the case before the SC.

He also cited from a judgement delivered by the Appellate Division on June 6, 2010, which prohibited the HC from directing any accused to surrender before lower court and law enforcers not to arrest the accused.

Lawyer Motaher Hossain opposed the petition, saying his clients innocent, and they have not committed any offence in any manner.

He argued that the Appellate Division's directive and observations, cited by the attorney general, had

therefore not applicable to his clients

such allegations, terming them "categorically false". The purported cypher contained

an account of a meeting between US State Department officials, including Assistant Secretary of State for the Bureau of South and Central Asian Affairs Donald Lu and then Pakistani envoy Asad Majeed Khan.

The cricketer-turned-politician came under increased scrutiny following the publication of a purported copy of the secret cable by the US media outlet The Intercept, with many in the previous government led by Shehbaz Sharif pointing fingers at the PTI chief for

being the source of the leak. Former interior minister Rana Sanaullah has said that if Khan had indeed lost the copy of the cypher provided to him, it would constitute a crime under the Official Secrets Act.

RACIAL HATE Gunman kills 3 black people in Florida

A white man driven by racial hatred shot dead three Black people in a Florida discount store Saturday before taking his own life after a standoff with police, authorities said.

"He targeted a certain of people and that's Black people. That's what he said he wanted to kill. And that's very clear," Jacksonville Sheriff TK Waters told a news conference about gunman, who was in his early 20s.

According to the sheriff's office, the shooter, who has not yet been identified, entered a Dollar General store wearing a tactical vest, armed with an AR-style rifle and a handgun.

Manifestos discovered by the gunman's family shortly before the attack the shooter's "detail disgusting ideology hate," Waters said.

Iran files legal case against singer urging veil removal

Authorities in Iran have begun legal proceedings against a prominent pop singer over his latest song urging women to take off their mandatory headscarves, the judiciary said yesterday.

The action against Mehdi Yarrahi comes almost a year after the death in custody of Iranian Kurd Mahsa Amini, 22, triggered months of protests around the country

Amini had been arrested for alleged breach of the Islamic republic's strict dress code requiring that a woman's head and neck be covered.

Yarrahi, 41, on Friday released a song called "Roosarito", which means "Your Headscarf" in Farsi, expressing support for last year's protest movement.

"A legal case was filed against Mehdi Yarrahi following the release of an illegal song which defies the morals and customs of the Islamic society," the judiciary's Mizan Online website said.

It was not immediately clear what the formal charges were. Yarrahi was not in custody.

Yarrahi's three-minute video clip incorporated the protest movement's slogan, "Woman, life, freedom."

Russia downs two Ukrainian drones

One killed near border; Ukraine destroys four cruise missiles during Russian air strike; second ship departs Odesa port after grain deal collapse

Russia said it downed two Ukrainian drones flying over border regions yesterday, after the governor of Belgorod region said a drone carrying explosives had killed a man.

Russia and the Moscowannexed Crimean peninsula have been hit by a wave of attacks in the past month, since Kyiv warned in July it aimed to "return" the conflict to Russian territory.

"(During) the night and morning hours... Two unmanned aerial vehicles were detected and destroyed in flight over the territory of the Bryansk and Kursk regions," Moscow's defence ministry said.

The governor of Russia's Kursk region, which lies next to the Ukrainian border, said a drone had crashed into an apartment building in Kursk city overnight, blowing out windows on several

It was not clear whether this was one of the drones reportedly shot down by the defence ministry earlier.

"There were no fires, none of the residents were injured," governor Roman Starovoit said on social media, sharing an image of what appeared to be a charred mark on a tower block.

The attack came a day after the

Belgorod region said a drone attack killed a man in the village of Shchetinovka, less than one mile (about two kilometres) from the Ukrainian border, reports AFP.

"The Ukrainian armed forces dropped an explosive device from a drone when the man was on his dacha plot cutting grass," governor Vyacheslav Gladkov said Saturday evening, announcing the man died from shrapnel wounds.



The military Ukrainian destroyed four cruise missiles over northern and central Ukraine during an overnight Russian air strike, Kyiv's air force reported

early vesterday. It said Ukrainian forces had detected up to eight airborne targets but that there were no immediate reports of strikes, adding that the rest of the targets

were "probably false". Meanwhile, three Ukrainian

8 killed, 5

hurt in blast

at firecracker

At least 8 people were killed and five others injured after a massive blast was reported at an illegal firecracker factory in North 24 Paraganas's Duttapukur, barely 3km away from West Bengal State University.

The explosion happened at around 10:00 am yesterday when several people were working at the factory in Nilgunj's Moshpole in Duttapukur police station area, around 30 km north of Kolkata, police said.

According to sources, the roof of the building was completely blown away, and charred and dismembered bodies of the victims landed on roads. Those injured have been admitted to Barasat Hospital for treatment.

A huge contingent of police and personnel of the disaster management department are also at the spot, they added.

Twelve people were killed in a similar explosion at an illegal firecracker factory in Purba Medinipur district's Egra in May.

Leader of Opposition Suvendu Adhikari of the BJP alleged that the state has turned into the storehouse of powder kegs.

FUKUSHIMA DISCHARGE

Japan reports wave of Chinese phone harassment

AFP, Tokyo

Tokyo has urged Beijing to "ensure the safety of Japanese" residents in China" after a wave of telephone harassment targeting businesses in Japan sparked by the controversial discharge of Fukushima wastewater.

While Japan insists the release of the treated water is safe -- a view backed by the UN's nuclear watchdog China has staunchly opposed it and banned all Japanese seafood imports, saying it contaminates the ocean. The Japanese government yesterday published new

data showing waters off Fukushima continued to post radioactivity levels well within safe limits. Calls from China began flooding Japanese businesses from Thursday, when operator TEPCO started releasing water used to cool the stricken nuclear reactors at

Fukushima Daiichi nuclear plant. Japanese businesses and groups, ranging from a concert hall in Tokyo to an aquarium in northern Iwate, reported that they had started receiving so many calls from Chinese speakers that they had difficulty conducting

normal operations. Hiroyuki Namazu, a senior Japanese diplomat in charge of Asian and Oceanian affairs, voiced his regret about the calls and told senior officials at the Chinese embassy in Tokyo to call for calm in China, the Japanese

foreign ministry said in a statement late Saturday. Similar incidents have also occurred in China against Japanese facilities, Namazu told Chinese embassy officials, according to the statement.

Myanmar expels top E Timor diplomat

Myanmar's junta yesterday ordered the expulsion of East Timor's top diplomat in the country over a meeting his government held with a banned shadow administration. The Southeast Asian nation has been locked in crisis since the military seized power in February 2021. The military has designated the shadow administration known as the National Unity Government (NUG) dominated by exiled lawmakers -- as a terror organisation. Last month, East Timor's President Jose Ramos-Horta met with NUG foreign minister Zin Mar Aung in the capital Dili. Yesterday, Myanmar's ministry of Foreign Affairs condemned the "irresponsible actions" of East Timor, ordering the country's Charge d'Affaires in Yangon "to leave no later than 1 September 2023".

3 US Marines die in Australia

Three US Marines died in an aircraft crash off the coast of northern Australia yesterday while transporting during a routine military exercise, officials said. Five others were "transported to Royal Darwin Hospital in serious condition", Marine Rotation Force - Darwin said in

a press release. They were among 23 Marines on the MV-22B Osprey tilt-rotor aircraft when it crashed, the statement said, adding the cause of the crash was being investigated. Inadequate number of teachers is not the only issue plaguing the BSMRSTU. The dearth of experienced teachers is also acute, directly affecting the quality of

- and 14 associate professors. The lack of experienced teachers affects the quality of education, said Prof Kamruzzaman, also an associate professor of Applied Chemistry and Chemical Engineering.

He said, "Science and technology universities are different from special lectures along with handsenhance the quality of education While teachers struggle to

complete their courses, they often face barriers due to the shortage of classrooms and labs. In addition to an administrative

building, only two academic 85 buildings with around classrooms have been built. departments, At least five

including Civil Engineering, and Hospitality Management and Sheikh Hasina IT Institute, have to hold classes at the administrative building while students of the History Department have to attend their classes in a tinshed room, according to university sources.

Many departments do not have any laboratories. Among other departments, Civil Engineering, Environmental Science Disaster Management, Psychology, Agriculture, Fisheries and Animal Science and Veterinary Medicine especially lack proper lab facilities.

This further disrupts the students' learning experience and adds to the burden on the faculty, said Nazmul Hossain, chairman many demonstrations demanding of Animal Science and Veterinary

According to university sources, address the issues, Vice-Chancellor such demonstrations have become regular occurrence, diverting students' attention from their studies. However, they said the bigger problem is that at least 70 students were attacked by local goons while staging demonstrations.

This correspondent made repeated attempts to reach the former vice-chancellor but he did not respond to any of the calls made or text messages sent to him.

Asked about the initiatives the current administration has taken to Prof AQM Mahbub said the number of seats has been reduced since the 2020-21 academic year.

Talking about security issues, he said more dormitories are needed to accommodate all the students. "We have a plan to build two 10-storey

As for the quality of education, he said so many departments are not required in a science and technology university but it is not possible to close the new departments that have already been opened. That's why we are trying to recruit more teachers, especially experienced teachers to address the

high student-to-teacher ratio. University Commission has already given us approval to recruit senior teachers from renowned universities on a temporary basis, so that our students get quality education," Prof Mahbub added.

This newspaper talked to several educationists about the issues encountered by the students at the BSMRSTU.

Prof AAMS Arefin Siddique expressed his concern about the establishment of new universities without having built basic

He said the lack of resources

serves as an obstacle to providing quality education to students, ultimately jeopardising their future.

As the Gopalganj BSMRSTU is a new institution, it may not attract professors or associate professors. Therefore, he explained, at the initial stage the university should consider appointing young teachers, such as assistant professors.

As for providing guidance to the young teachers, he suggested appointing visiting professors who can share their experiences and collaborate with the regular faculty to enhance the quality of teaching and better educate the students.

But it is the responsibility of the UGC to address these issues and ensure that new universities are fully equipped to function effectively, Prof Siddique added.

Commenting on this, Dhaka University Professor Emeritus Serajul Islam Choudhury said when students are deprived of the required facilities during their academic journey, the educational institution fails to achieve its intended goals.

About resolving the issues, he said the UGC has to the take the responsibility to address them.

The government should think more and work more before establishing new universities," he added.

The pattern of violence must stop

The ruling party must adopt a more mature and restrained strategy

The spate of violence that we are seeing as the general election approaches gives the impression that the ruling party has no intention of allowing its main political rival to hold any programme without coming under attack. Unfortunately, the ruling party activists are taking full advantage of having police and administration on its side. These are ominous signs and create a sense of unease among the people.

The recent incident in Cumilla has left 15 BNP members injured, two with gunshot wounds. According to witnesses interviewed by this daily, the BNP was holding a committee meeting when Awami League and Jubo League men swooped on them. It is frightening that guns were involved and that two BNP members were wounded. Surprisingly, police have claimed that they did not find any evidence of gunshots being fired. And, as usual, the AL rejected all the allegations raised by the BNP, claiming that it was the latter who had attacked the former's peaceful rally.

But why is it that various wings of the AL have to hold "peaceful rallies" every time the BNP has a programme? That, in itself, can easily lead to confrontations. Over the last one year, we have witnessed time and again how activists associated with the AL and its wings have scheduled their rallies and processions on the same day as those of the BNP. Meanwhile, law enforcers have arrested thousands of BNP activists and supporters after rallies. Last month alone, about 11,000 leaders and activists of the BNP and its front organisations were sued in 16 cases filed in Dhaka and seven other districts over clashes between supporters of the opposition party, and the Awami League men and police personnel.

Is this going to be the pattern of our politics in the next few months? Will the main opposition party continue to be attacked or incarcerated every time it holds a political programme? It is the government's responsibility to ensure the safety of all its citizens - even those who are their political rivals. That is how a democracy works, with the ruling party, which yields all the governing power, morally and constitutionally obliged to exercise maximum restraint when it comes to dealing with the opposition parties. By allowing its affiliated organisations to create a volatile situation while using its state machineries to legally constrain the opposition, it is hard to see how the ruling party is creating a level playing field in the run-up to the election. Can the general people then be blamed if they have misgivings about how fair or free the upcoming election will be?

Teesta flooding a wake-up call

Bangladesh must push India to sign the treaty without any further delay

The recent flash flood in the Teesta basin in Bangladesh makes us wonder how much worse the situation must get for our farmers and communities living in the area before we revisit the unfulfilled promise of the Teesta agreement. It has been 12 years of futile reassurances from India in signing the Teesta water-sharing treaty, and decades of continuous havoc on the environment and millions of people in Bangladesh. Now, with the increasing threat of climate change, it is more important than ever for Bangladesh to go beyond stated goodwill to finally resort to international policy frameworks and laws to ensure that transboundary rivers are shared equitably

As of August 27, 2023, hundreds of chars and villages in Kurigram and Lalmonirhat are flooded, millions are stranded, scores of houses, schools, dams and roads are destroyed, and vast agricultural lands and countless livestock are lost. On August 24, India reportedly opened all floodgates at the Gajaldoba barrage following heavy rains in the upstream region, which is the primary cause of the scale and rapid intensity of this flood. Since the construction of the Teesta barrage, the river remains dried up on the Bangladesh side almost throughout the year, which fuels a vicious cycle of stored sediments, accumulation of silts and chars, encroachments, and ultimately erosions caused by flash floods when the floodgates are opened. Dams, barrages and other disruptions to the natural flow of the river in West Bengal, and also Sikkim, have thus directly been affecting millions of people and a vast riverbank in our country.

Despite Bangladesh's persistent push for a mutually beneficial water treaty, and India's repeated reassurances, the obvious step towards a solution has been put aside, mostly by the Indian side. Earlier this year, there were reports of West Bengal's push for two more canals under the Teesta Barrage project, which can further deteriorate the already dire situation on our end. While the recommendation from an Indian parliamentary committee to its government to "initiate meaningful dialogue with Bangladesh on a regular basis" comes as a welcome move, we can't help but question the actual goodwill for a solution in the near future, given that Dhaka is yet to even receive an answer to its query about the canals.

It's time for the Bangladesh government to finally put its foot down regarding the Teesta. And overall, Bangladesh should consider signing and advocating the 1997 United Nations Convention on the Law of Non-Navigational Uses of International Watercourses as an international common ground to seek its fair share of water in Teesta and other transboundary rivers it shares with India.



Loans are written off to clear up the banks' balance sheets. Although loan writeoff does not deny banks the right to recover money from the borrowers, the probability of collecting these loans is meagre.

In Bangladesh, a bank can write off a loan that has a minimum chance of recovery and has been classified as BL for at least three years. The bank must maintain 100 percent provision against that loan and has to file a lawsuit against the borrower. Available data shows that the amount of loan write-offs has been on a continuous rise over the 2003-2022 period. It was only Tk 3,700 crore in 2003, which jumped to Tk 17,400 crore in 2010. commercial banks (PCBs) to loan write-offs was 34 percent in 2003, which increased to 40 percent in 2010. It rose marginally to 41 percent in 2015 and profoundly to about 60 percent in 2022. The SBs and foreign commercial banks (FCBs) had smaller contributions to the loan write-offs.

By combining non-performing and written-off loans, the actual picture of the overall NPLs will become fairly evident. In 2003, for instance, the nonperforming and written-off loan rates produced a combined rate of about 27 percent. This rate dropped to about 17 percent and 15 percent in 2009 and 2015, respectively. The NPL rate of only eight percent with nearly four percent of written-off loans produced the actual NPL rate of 12 percent in 2020. The NPL rate was nine percent in 2022. If the loan write-offs of about five percent is added to this, the real NPL rate becomes 14 percent.

This is not the complete picture of NPLs in our banking sector, because there are some other loans that also qualify as NPLs. With NPLs only increasing, banks in Bangladesh have been facing tremendous pressure in terms of provision maintenance. It is necessary to get an appropriate estimate of NPLs so that the actual performance of the banking sector can be understood. If there is an underestimation, it will have multiple effects. Asset quality will be falsely high and the capital maintained against risk-weighted assets will be lower than what's required. Consequently, an imbalance will be created between asset quality and capital maintenance. Bank profits will be artificially high as they will have to maintain less provision that comes from profits. Some banks will be viable on paper only, and their vulnerability cannot be realised before they go bankrupt.

Space is beyond the jurisdiction of and prohibit any military activity in space. Article VI of the treaty only creates international responsibility of the state parties for all national space activities, whether carried out by governmental or non-governmental entities. So, countries like Bangladesh and any other state which are a party to this treaty may utilise the resources brought from outer space, but they cannot send or do any space activities without the permission from other state parties. The UN Committee on the Peaceful Uses of Outer Space (COPUOS) provides only a forum for discussion and development. No "body" has been created to monitor or regulate the activities of space explorers in outer space and the orbit of Earth.

Being a soon-to-be developing country, Bangladesh complies with space law and joined the Outer Space Treaty in 1986. With the launch of Bangabandhu-1 Satellite in 2018, Bangladesh became the 57th country and the fourth in South Asia to own a satellite, marking a significant advancement in the country's space research efforts. The nation also has the Space Research and Remote Sensing Organisation (SPARRSO), which collaborates on environmental and meteorological research with Japan Aerospace Exploration Agency (Jaxa), Nasa, and the European Space Agency (ESA). Using American and Japanese satellites, SPARRSO keeps an eye on Bangladesh's water resources and agro-climatic conditions

Owning a satellite and utilising the remote sensing technologies under the Outer Space Treaty makes Bangladesh more relevant to the commercialisation scope of space. The business industry surrounding space exploration was once a public agenda, but the absence of effective regulatory mechanisms leaves narrow scope for countries like Bangladesh to access and utilise the benefits of space exploration. Developing countries like ours must come forth to ratify all the five treaties to protect their rights over the benefits presented by space exploration.

INDIAN SUPREME COURT'S HANDBOOK

A glimmer of hope for gender justice

Recently, when I introduced myself writing is free of assumptions and to a male lawyer, he proceeded to give me some unsolicited advice, success because I am a woman. Within minutes of introduction, he told me that female lawvers at his chambers are irregular and undependable because they get married and have kids. He then went on to suggest that I get married as well. This was a caricature of a conversation that I believe every woman in our country goes through.

In such situations, I do a mental calculation to determine whether it's worth educating such individuals right there and then. Most days, my brain tells me no. I was there for a specific business and a 10-minute speech would hardly sanitise years of social conditioning out of that man. But it took me years of soul-searching before I could finally forgive myself for not speaking out in these situations. Honestly, as women, we are tired of educating and raising men to be better, especially when the entire social structure is designed to promote stereotypes like my conversation above. We would love it if, for a change, this burden was taken up by the system instead of each woman. And the Supreme Court of India has just shown us how to go about it in a system that is plagued by antiquated ideas about women.

When I finished the Handbook on Combating Gender Stereotypes, a 30-page booklet published by the Supreme Court of India, a peculiar blend of joy and sadness washed over me. India's Chief Justice Dhananjaya Y Chandrachud's groundbreaking initiative of endorsing a genderjust judiciary breathed life into the transformative mission of creating the handbook. Throughout this booklet, which is primarily meant to be read by lawyers and judges, India's apex court has provided an exhaustive list of stereotypepromoting language that should be replaced by alternative language. For example, lawyers and judges are encouraged to replace words like "harlot," "career woman," "whore," "woman of loose morals/ easy virtue," "promiscuous/wanton woman" with the plain and simple term of "woman." The objective is

damaging notions about women.

I cannot help but feel immense saying that the type of cases I am joy that the highest court of our interested in wouldn't bring me neighbouring country has taken commentary on what stereotypes such a spectacular, historic step forward, and I hope that their legislature will soon show support in its favour. For example, in the headline-grabbing Narsingdi assault case of 2022, the judge implied that Bangladesh is too "civilised" for women to be wearing the judiciary of Bangladesh and

Words have power. Why do we say "child prostitute" and perpetuate the idea that it is children who decide to engage in sex work, when in reality they are victims of trafficking? For decades, our system has okayed these harmful phrases.

Women are exhausted from fighting these stereotypes on a daily basis, be it with our fathers, husbands, friends, employers, colleagues or even a random person they just met. As a woman of the subcontinent constantly confronting similar stereotypes, seeing all the "reality" versions in a booklet created by the Supreme Court of India makes me feel profoundly understood. It should be noted that the use of alternative/preferred language is merely "encouraged" and not made mandatory - perhaps a smart move to sensitise the professionals first to what we can all agree is a momentous step forward for India.

Considering that judiciary is the last resort for anyone who has faced injustice, if the lawyers and judges internalise preconceived and problematic notions, how will justice ever prevail for women? I can sit here and fill the newspapers trying to raise awareness against these stereotypes, but this powerful advocacy coming straight from the Supreme Court, targeting lawyers and judges, will have unparalleled positive impact on ensuring a gender-just judicial system. As a female lawyer who is both on the receiving end of being stereotyped and who has the power to use the gender-just language in legal documents, I sincerely hope that the Indian Supreme Court's handbookwill become an exemplary piece of document that to ensure that legal reasoning and non-traditional clothes in rural even the legislature could endorse.

However, when he had first seen Champa, he had thought immediately of Tahmina and that, like her, Champa too was an enchantress, someone who beguiled men and led them astray.

Unlike Tahmina, Champa has the strength to resist Jahangir. Champa and Jahangir cannot carry out their mission. Jahangir is captured and sentenced to life imprisonment on the dreaded Andaman Islands. As he is led away, he tells his mother that she should give most of his wealth to Champa to feed hungry mothers and their children. One-fourth of his property should be given to Tahmina, the woman he has wronged. As he is taken away, Jahangir repeats the words of Haroon, "Woman is an enigma." Tahmina responds by murmuring "You are really cruel."

In his discussion of the novel, the late Professor Kabir Chowdhury elides the circumstances of Jahangir's birth, his rape of Tahmina and his attempted seduction of Champa. He thus ignores the psychological aspects of the novel. In her Asiatic review of the translation, Nandini Bhattacharya objects to the translators' describing the sexual encounter between Jahangir and Tahmina as rape. She stresses that it is a "consensual consummation of desire and not rape."

Nandini Bhattacharya admires this last scene, stressing that it is "a celebratory and symbolic moment even in its tragic dimensions. There is a Muslim man, a Hindu woman and both have crossed barriers and prejudices of jaat (community), dharma, (religion) and linga (gender) in sacrificing their lives for the nation." She ignores the complexities of Jahangir's character and actions as she ignores the complexity of Tahmina's relationship with him.

Kuhelika deserves a much closer reading than any reader or scholar has done so far. In fact, no Nazrul critic seems to have explored the psychological dimensions of the novel

perhaps because it is difficult to justify rape or associate it with a hero. However, it is only a psychological reading of the novel that can explain the duality in human beings, that one can be a revolutionary and also a rapist.

While Nazrul's novels and short

Liton Das' illness at the last minute came as a huge blow for Bangladesh, who are set to begin their Asia Cup campaign against Sri Lanka on August 31 in Kandy.

Liton, suffering from a high fever, missed the Tigers' scheduled flight to Colombo yesterday.

Although Liton tested negative for dengue, the 28-year-old is not in the best of shapes to catch the flight today. As things stand, chances are that the opener could well miss Bangladesh's tournament opener against Sri Lanka.

This Asia Cup is being considered as an ideal platform for selectors to fine-tune the squad ahead of the ODI World Cup in India in October-November, but now the selectors face a serious time crunch in order to prepare back-up options to get by in the continental showpiece event.

It will be important for the selectors to find the perfect balance in the squad, and Liton's illness at such a moment surely hampers the plan of the selectors, who had to deal with Ebadot Hossain's injury just a few days ago by adding young pacer Tanzim Hasan Sakib to the Asia Cup

Selector Habibul Bashar did seem concerned regarding the Liton issue but the former Bangladesh captain informed that the Tigers will need to cope with the situation and keep their confidence in the rest of the players in the Tigers' camp.

"Look, this is exactly the reason we have formed a bigger pool of players. But, obviously, it would have been great if Liton was fully fit but if he is unable to recover on time, we have to accept as it is what it is. But since it's a viral fever, we expect Liton to recover quickly. Let's see whether he is able to play the first game or not," Bashar told The Daily Star.

Bashar put faith in the younger players

"We are willing to have our faith in the likes of Tanzid Hasan Tamim, but, obviously, it would have been easier for him if he had someone like Liton alongside him. Since we are already without Tamim Iqbal, it won't be easy for the youngsters to cope immediately but they are capable," Bashar added.

The bilateral series against New Zealand after the Asia Cup will be the



final platform to prepare backup options in the squad. The Tigers, however, will have experienced opener Tamim back for the series.

Meanwhile, prominent coach Nazmul Abedeen Fahim still remains optimistic and is ready to bet on the aggressive mentality of the young guns.

"I think this young lot of cricketers has got that strong backbone and the winning mentality which makes me optimistic. They play with a lot of aggression. If I talk about junior Tamim, Towhid Hridoy, or even Shamim Hossain, who is still not established in the team, they can go out and play their game," Fahim said.

Fahim also added: "I think the mindset is very important and someone like Tamim, he will not change his style of batting. Hridoy's approach also helped to bring the change in the mentality of the team and they are now willing to win matches for Bangladesh."

According to the mentor to many stalwarts of Bangladesh cricket, it will be important that the youngsters do not alter their style of play.

"No doubt the youngsters like Tanzid Tamim and others will face tougher challenges compared to what they faced in the past and it will be a different ball game. But it's important they are allowed to express themselves and yes there is not enough time for them. But at times, it's good not to have enough time and follow the instincts," he added.



Djokovic, Alcaraz poised for US Open collision

Novak Djokovic and Carlos Alcaraz are on a US Open collision course as the final Grand Slam tournament of season gets under way on Monday with American teenager Coco Gauff chasing a breakthrough first major title.

A little more than six weeks after world number one Alcaraz defeated Djokovic in an enthralling finale to the Wimbledon championships, the two men

could meet again at Flushing Meadows if the seedings go to play over the next fortnight.

Djokovic and Alcaraz whetted tennis world's appetite another buster showdown Cincinnati Open last week, with 23-time Grand Slam singles winner Djokovic downing the 20-year-old Spaniard in a

four-hour classic. Djokovic, 36, is making a longawaited return to the US Open this year after his refusal to be vaccinated against Covid-19 meant he was unable to gain entry to the United States.

In Djokovic's absence at last year's tournament, Alcaraz announced his arrival on the world stage with a brilliant run to his first US Open crown.

Second seed Djokovic, who opens

his campaign on the Arthur Ashe main arena against France's Alexandre Muller on Monday, says Alcaraz's relentless, swashbuckling style is reminiscent of Rafael Nadal, the 22-time Grand Slam singles champion who misses this year's US Open due to injury.

"Each point is a hustle. Each point is a battle. You feel like you're not going to get maybe in total five free points in the entire match," Djokovic said of Alcaraz.

> "You've got to basically earn every single point, every single shot, regardless of the conditions." Alcaraz,

Germany's faces Dominik Koepfer in the first round on Tuesday, said he is flattered comparison.

"It's great that he knows that every time he's going to play against me, it reminds him playing against Rafa or against the best ones because that means we are in a good path," he said.

Djokovic will reclaim the world number one ranking with a victory over Muller on Monday, regardless of how Alcaraz performs in the tournament.

The Spaniard, meanwhile, must navigate a tricky route to the final that could include 2021 US Open champion Daniil Medvedev and Italy's Jannik Sinner.



In the women's tournament meanwhile, all eyes will be on the in-form 19-year-old Gauff, who is chasing a first Grand Slam title that would make her only the fifth Black woman in the open era to win the US Open. After struggling in the early part of the season, Gauff felt she had hit rock bottom after exiting in the first round at Wimbledon. But the addition of veteran guru Brad Gilbert to her coaching team has sparked a transformation in her form and fortunes. She won the Washington Open in early August, reached the quarter-finals of the Canadian Open in Montreal and then scored a superb victory in the Cincinnati Open -- her first WTA 1000 title. The win in Cincinnati included a morale-boosting first ever victory over world number one Iga Swiatek, the defending US Open champion. Gauff, who could face Swiatek in the quarter-finals in New York, says her late season resurgence is the result of a shift in mindset.

The floods that hit Bandarban, Cox's Bazar and parts of southern Chattogram early this month left a trail of destruction in their wake. Experts, locals and government officials

have said excessive rainfall combined with several man-made factors caused the flood and took it to extreme levels.

Professor Alak Paul of geography and environmental studies department at Chittagong University said heavy rain

unplanned urbanisation are two major causes of the recent floods in the Chattogram division.

There was heavy rainfall beginning of August that coincided with a time of high tide,

which hindered the rivers from carrying the Matamuhuri river is 1,000 to 1,500 cubic floodwater into the Bay of Bengal.

Emdadul Haque, assistant meteorologist of Bandarban, said from August 1 to August 7 their office recorded 936 mm rainfall in Bandarban, which was around one and a half times as much as the expected rainfall in the

Following the rainfall, the flood inundated vast areas of the region from August 7 and continued till August 11.

"Influenced by the full moon on August

3, the level of water in the Bay of Bengal rose excessively for the following few days during the high tide, slowing down the receding of the floodwater in the region. Water could not flow out during the high tide, flooding thousands of households," said Dr Tanjir Saif Ahmed, executive engineer of Cox's Bazar Water Development Board.

Floodwater in the region recedes through three main rivers --Sangu, Matamuhuri and Dalu -- all of which flow into the Bay of Bengal, he said.

He added that the Matamuhuri through flowing Cox's Bazar has lost its navigability as its excavation was done a

long time ago. channel capacity

metres per second, whereas the flow of recent flood water was around 2,200 cubic metres per second, which led to inundation, he said.

Water resource and climate change specialist Dr Ainun Nishat said these types of calamities will happen more frequently in the coming days. Navigability of the rivers can be raised by dredging or excavation to increase their water draining capacity as a short-term

HC can't order surrender to lower court

Neither can it order cops not to arrest, says SC

The Appellate Division of the Supreme Court yesterday said the High Court Division cannot direct any accused in a criminal case to surrender before the lower court or ask law enforcers not to arrest the accused.

Instead, the HC can grant anticipatory bail to the accused or reject their bail petition, a four-member bench of the Appellate Division headed by Justice Obaidul Hassan said during a hearing on a leave-to-appeal petition.

The three other judges of the bench were Justice M Enayetur Rahim, Justice Md Ashfaqul Islam and Justice Md Abu Zafor Siddique.

Anticipatory bail is a pre-arrest bail, and the High Court usually grants such bail for a certain period if the accused has fear of being harassed or arrested, senior Supreme Court lawyer Khurshid Alam Khan told The Daily Star.

In this case, however, the accused must surrender to the lower court within that period, and in the meantime law enforcers cannot arrest them, he added.

The leave to appeal was filed by the state challenging an HC order that on August 8 directed Executive Editor of The Daily Star

Mysterious dark spot detected on Neptune

Astronomers have spotted a large and mysterious dark spot within Neptune's atmosphere, and it has an unexpectedly bright companion.

The observation was made using the European Southern Observatory's Very Large Telescope in Chile.

Space-based observatories such as the Hubble Space Telescope have observed vortex-like storms -- which appear as dark spots -- swirling in the blue planet's atmosphere before, but it's the first time an Earth-based telescope has

seen one on Neptune. These new observations are shedding more light on the phenomenon, according to new research published Thursday in the journal Nature Astronomy.

"Since the first discovery of a dark spot, I've always wondered what these short-lived and elusive dark features are," said lead study author Patrick Irwin, professor of planetary physics at the University of Oxford, in a statement.

Giant gaseous planets in our solar system, including Neptune, are known for the dark spots that appear in their atmospheres, such as Jupiter's Great Red Spot, a centuries-old storm.

Neptune, an ice giant, has had multiple storms observed by Hubble over the years. The storms all seem to follow a pattern of appearing and disappearing over the course of two years, making them difficult to study.

The counter-terrorism wing (CTW) of the Federal Investigation Agency (FIA) on Saturday visited the former
