Court accepts charges against six persons

A Chattogram court vesterday accepted the charge sheet against six persons, including Chattogram City Corporation Ward Councillor Jahurul Alam Jasim, in a case filed for attacking Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers Association.

The accused are Jahurul Alam Jasim, Billal Hossain Hriday, Abu Noman, Saifuddin Bhauiyan, Anis Chowdhury Razan, and Md Shakil.

"The charge sheet was seen by the court and later accepted for starting trial process," said Rizana Hasan's lawyer Akhter Kabir Chowdhury.

Jahurul Alam Jasim, councillor of CCC ward no 9, razed natural hills in Akbar Shah area and a part of Sitakunda for long to turn those into residential plots, taking advantage of the indifference of the authorities concerned.

Rizwana Hasan and her team went to Akbar Shah area on January 26 to visit the spots of hill cutting and filling of hill ridges by Jasim's men. During the visit, Jasim's men, including Noman, stopped her and at one stage started harassing them. They also pelted stones on the microbus carrying the team, forcing them to leave the spot.

"The foreign diplomats should know the history—how the family of Bangabandhu was killed, then indemnity law was enacted, and then military regimes attempted to destroy democracy and uproot the values of the Liberation War," Momen told journalists after the event.

He said current Prime Minister Sheikh Hasina had to wait 21 years to seek justice for the killers of her father.

BNP's founder Ziaur Rahman and Jatiya Party's founder HM Ershad also patronised or supported the killers of Bangabandhu, Momen said.

"Even, we saw a rise in militancy, series bomb attacks during BNP's period. Attempts were made to kill our Prime Minster Sheikh Hasina," he said.

Addressing the event chief guest, Law Anisul Huq Minister narrated the tragic events of Bangabandhu killing, killings of the four national leaders in jail, and the "killings of military officers through summary trials under President Ziaur Rahman.

He said self-confessed and convicted killers of Bangabandhu -- Nur Chowdhury and Rashed

Chowdhury, are living respectively in Canada and the US.

"We would request these countries to return them and help us establish

justice," he said. State Minister for Foreign Affairs Shahriar Alam, Naheed Ezaher Khan MP, and Bangladesh Institute of Legal and International Affairs Director Mizanur Rahman also spoke in the seminar.

Meanwhile, Momen said Russian Foreign Minister Sergey Lavrov would visit Dhaka on September 7-6 and meet him and the PM before joining the G20 meeting in New Delhi.

Dhaka will call for Moscow to end the Russia-Ukraine war and help address the Rohingya crisis, he added.

Apart from that, French Emmanuel President Macron may also visit Dhaka after the G20 summit, but the schedule has yet to be finalised, he added.
