Tk 821 crore laundered in name of export

Fraudsters used fake shipping documents to siphon off the sum to 25 countries; customs to file case soon

In one of the biggest money laundering scams unearthed so far in the country, customs authorities have found that 33 readymade garment factories and buying houses laundered at least Tk 821 crore over the last six years

For the illicit money transfer, the fraudsters employed two tactics – under invoicing and using wrong shipping code. In the first case, prices were shown up to 10 times lower than the actual rate. In the second case, shipments were shown as "samples" when they were actually exports worth hundreds of crores of taka.

"We have never before identified such a largescale export forgery. In the past, we had information about money laundering involving 10 or 15 consignments. Irregularities involving so many consignments together never caught our attention."

"Multiple gangs are involved here. We have found links of many powerful organisations and individuals at home and abroad. A case will be filed against them very soon," a Chattogram customs official The Daily Star recently on condition of anonymity.

Documents show Dhaka-based buying house Asia Trading Corporation shipped 14,085 tonnes of clothing items worth Tk 308 crore (\$28 million) to the UAE, Singapore and Malaysia in 2022. However, not even a single dollar entered the country against this shipment.

In the shipping documents, the company showed all the 1,342 consignments as "sample goods". Under customs rules, sample goods do not fetch any export earnings.

Similarly, Hong Kong Fashion, an export-oriented company based in Gazipur, exported 1,160 tonnes of RMG goods worth Tk 43.21 crore to seven countries including the UAE, Canada and Malaysia between January 2022 and May 2023. Only Tk 12.73 crore has been brought back to the country against these shipments, while the remaining Tk 30.48 crore was laundered, according to the customs probe report.

Customs Intelligence and Investigation Directorate (CIID) came up with the findings after a six-month investigation carried out in three phases, beginning January this year. The CIID analysed the export data

of these companies from January 2017 to May 2023.

Of the Tk 821 crore laundered, around Tk 600 crore went to the United Arab Emirates, Malaysia and Singapore. The rest was sent to 22 other countries, including Canada, Australia, Belgium, Qatar, Spain, Kuwait, the Philippines, Sweden, Russia, Panama, Thailand, Georgia and Palestine territory, according to documents obtained by The Daily

"We have never before identified such a large-scale export forgery. In the past, we had information about money laundering involving 10 or 15 consignments. Irregularities involving so many consignments together never caught our attention," said Mohammad Bashir Ahmed, additional director general of CIID, Chattogram office.

Most of the 33 exporters and buying houses whose names came up in the customs investigation are located in Dhaka and Gazipur.

The Daily Star spoke with seven of these companies, and each of them denied any wrongdoing.

Names of at least 12 commercial banks were used in the export documents. This newspaper spoke with six banks. Officials of three banks said the exporters in question are not their clients. Three other banks said they issued the letters of credit against the export permits of

No more 3-day voice, data packs from Oct 15

BTRC orders telcos to discontinue 15-day plans too

At a time when the government is pressing full steam ahead with the 'Smart Bangladesh' agenda, the telecom regulator is taking measures that are at odds with it.

On September 3, the Bangladesh Telecommunication Regulatory Commission ordered the mobile operators to discontinue three-day and 15-day voice and data packages from October 15, in a move that stakeholders, experts and consumer rights organisations say restricts the freedom of choice

The move will particularly hit the pockets of the grassroots, low-income and youth segments and is primed to reduce their consumption of telecom services, particularly the internet.

The operators have also been directed to limit the total number of packages they offer to 40. At present, operators offer up to 95 packages to subscribers, whose duration ranges from an hour to an indefinite period.

From October 15, mobile users will have the option to buy voice or data plans for seven days or 30 days. The option to purchase plans with unlimited validity will remain, too.

The BTRC said it arrived at the decision by surveying mobile users, who were in favour of condensing the volume of packages on offer.

The mobile operators maintain that the BTRC survey contained leading questions that influenced the respondents' answers by suggesting responses.

Telecom Minister Mustafa Jabbar has long been expressing his annoyance over the sheer number of packages offered by the carriers.

55KG GOLD THEFT

It may be an inside job

Say police officials probing the crime at Dhaka airport

The gold -- 55.51kg to be precise -- stolen from Dhaka Customs House was taken from 437 separate packs kept inside a customs warehouse at Hazrat Shahjalal International Airport.

The thieves didn't take the entire contents from the packs; rather, they pilfered only small portions of gold from the packs before putting those back, according to investigators.

All these gold items were seized under the DM (detention memo) criteria, as these were supposed to be released upon payment of fines and taxes.

To distinguish one item from another, officials placed the DM items in separate packs and sealed them with tape. The gold was pilfered from 437 of those items, which were seized between 2020 and August of this year.

"It is not possible for a common person or a thief to enter such a secure place at the airport. Even then, if anyone enters, they will not take a portion of gold from a pack; they will take the whole batch," said Morshed Alam, deputy commissioner of Uttara Division Police.

"We also found the instruments that were used to break the vault and cut the window," he told The Daily Star.

Police seized a cutter, an axe, and a Chinese knife from the warehouse.

Exports growing, but slowly

Earnings from merchandise shipments in August increased slightly by 3.80 percent to \$4.78 billion, mainly riding on apparel exports, as all the other major sectors staged a poor performance.

Three important sectors
-- leather and leather goods,
jute and jute goods and
home textiles -- staged a poor

performance.
This was largely due to the volatile global economic situation stemming from the fallouts of the pandemic and Russia-Ukraine war.
Although inflation is going down in the major export destinations like Europe and the US bank, interest rates are still high. As a result, consumers are yet to go on a spending spree as

in the pre-pandemic period.

Macron to visit Dhaka Sept 10

Says French embassy; Indo-Pacific cooperation, climate change on agenda

France has formally announced President Emmanuel Macron's visit to Bangladesh on September 10 that will focus on cooperation in the Indo-Pacific, deepening bilateral trade relations, and climate change.

He will travel to Dhaka after attending the G20 summit in New Delhi on September 9-10 and is scheduled to hold a meeting with Prime Minister Sheikh Hasina.

Hasina, who will also take part in the summit and meet Indian Prime Minister Narendra Modi possibly on September 8, will return to Dhaka from New Delhi on September 10 and welcome the French president.

"It will also be an opportunity to deepen our bilateral relations with a country that is experiencing rapid economic growth and seeking to diversify its partnerships," says the official Facebook page of the French embassy in Dhaka.

The statement says Bangladesh and France show great convergence in the face of global challenges, particularly within the framework of the Paris Agenda for Peoples and the Planet, which Bangladesh actively supports.

"Since the country is particularly vulnerable to climate change, the president will recall France's determination to stand by Bangladesh on its humanitarian front, in particular in the face of regular floods."

The French embassy said Bangladesh is also an important to international solidarity actions, whether through its contingents in peacekeeping operations or in hosting Rohingya refugees.

About Macron's attending the G20 summit, the embassy said it will allow the president to maintain the constant dialogue with his counterparts from all continents.

GAS BLAST ON TRAWLER One dies at CMCH, 8 battle for life

A fisherman on Sunday night died from injuries he sustained in a gas cylinder explosion on a fishing trawler in Cox's Bazar town.

Osman Gani, 20, breathed his last while undergoing treatment at Chattogram Medical College Hospital (CMCH), where he was admitted with 60 percent burns.

On Friday morning, 11 fishermen suffered burn injuries after a gas cylinder exploded inside a trawler at ghat-6 of Nuniachara.

Of the injured, two were sent to Dhaka for treatment. And the rest, with 60-90 percent burns, are currently being treated at CMCH and their condition is not so good, the CMCH director added.

Just in March 2022, the BTRC ordered operators to bring down the number of packages to 95 from a few hundred packages each.

Subsequently, Amtob urged the telecom regulator to reconsider its proposed changes, which will have "grave consequences on the industry".

But the BTRC went ahead and issued the directive on Sunday. Discontinuing the three-day packs, it seems, is the more polemic among the directives.

A large segment of grassroots people use data for entertainment and other purposes besides connectivity, said TIM Nurul Kabir, a former secretary general of Amtob. And they mostly opt for the

affordable three-day packs.

"If the option to purchase data for a short time with lower expenditure is eliminated, it will be very inconvenient for them. Customers

should always have flexibility in choosing options, and denying this the three-day would be unjustified," he added.

Customs officials said some exporters use fake bank documents, sales contracts, letters of credit, and export permits to launder money.

To launder money, fraudsters often use Code 20 on the NBR server, which denotes sending "samples" to the importers before the actual export. In this case, there is no question of export earnings. Another popular way to launder money is under invoicing – either by quoting low prices or low weights of the export items in the shipping

Customs House, the Chattogram Customs House is also taking extra precautions. After the HSIA, the highest number of gold seizures in the country takes place at Chattogram Shah Amanat International Airport.

Talking about security of seized items, Chattogram Customs House Commissioner Mohammad Fyzur Rahman said, "All measures have been taken as per the law for the security of the seized gold and jewellery."



At least 12 dengue patients died in the last 24 hours till yesterday morning, eight of whom were from outside Dhaka.

With the figures, the total number of dengue deaths this year rose to 646. Of them, 468 died in Dhaka. With 2,823 new dengue cases during this period, the total number of cases rose to 1,33,134. Of them, 61,489 of whom are from outside Dhaka.

HM Nazmul Ahsan, associate professor at Shaheed Suhrawardy Medical College Hospital, said there should be treatment and management facilities outside Dhaka.

"It takes several hours for a patient to reach the capital, and during this time, he does not get enough fluid supply. Thus, many patients collapse even before they are admitted to hospitals," he mentioned.

Such patients have lower chances of survival as they might suffer a shock, decompensated which reduces their chances of recovery by 50 percent. A patient with decompensated shock syndrome may die within a few minutes to one hour, he added.

Any person who makes unauthorised access to data or uses data illegally shall be deemed to have committed an offence under this law and for such offence shall be punished with imprisonment for a term not exceeding 5 (five) years or with a fine not exceeding Tk 50.000 or with both.





Opportunities up for grabs

Says Bangladesh mission in Canberra

JAMIL MAHMUD

Australia can be a destination for Bangladeshi nurses, as the Oceania nation is currently hiring professionals in the field from different countries due to a domestic shortage in workforce.

The Bangladesh High Commission in Canberra issued a letter to the Expatriates' Welfare Ministry in July, citing the workforce shortage and requesting the ministry to take effective measures to utilise this opportunity.

According to the letter, Australian health providers maintain a registration process to hire foreign nurses. In this process, several thousand nurses from different countries-including India and Nepal-migrate to Australia each

"By following this process, it is possible to send many nurses to Australia from Bangladesh," reads the letter, recommending government authorities to raise awareness about this opportunity among local nursing professionals.

Nursing is a dignified profession in Australia and an entry-level nurse can earn AUS \$80,000 (Tk 57 lakh) per year, the letter adds.

At present, state-owned Bangladesh Overseas Employment and Services Limited (Boesl) send nurses to Kuwait in line with a memorandum of understanding.

Under the arrangement, 670 nurses have gone to Kuwait so far. Their wages range from Tk 90,000 to Tk 1,00,000 per month, according to "Labour Migration

3 die in bike accident

At least three people, including two siblings, were killed in a road accident at Noakhali's Begumgani upazila vesterday.

The deceased are Mohammad Riday, 18, his younger brother Aradhan Shuvo, 15, and their neighbour Md Zahed, 18. Locals said the trio were travelling on a motorbike from Ghatla to Horambi Bazar area. When they reached Boropole Horambi Road area at around 10:00am, the motorbike rider lost control and hit a roadside tree. All three fell on a roadside ditch and suffered serious injuries. Locals rescued them and took them to a nearby hospital.

As their physical condition deteriorated, they were shifted to the Noakhali General Hospital for better treatment, but on-duty doctors there declared them dead, said Md. Salauddin, chairman of local union parishad.

Illegal stone extraction resumes despite ban Three rivers under severe

threat in Lalmonirhat

S DILIP ROY

Illegal stone extraction in three rivers in Lalmonirhat's Patgram upazila resumed in full swing after a six-year pause, resulting in massive damage to the water bodies, which may lead to erosion.

The local administration had taken strong measures to stop illegal stone extraction from rivers in 2017. However, with time, the activity has resumed on a greater scale.

According to locals, at least 200 dredger machines are currently employed in rampant stone extraction at the Dharla, Saniajan, and Shingimari rivers in the upazila.



Disregarding governmental politically influential figures are involved in this illicit endeavour, churning profits by exploiting natural resources and causing severe harm to the environment, they added.

 $Shamsul\,Islam, a\,60-year-old\,resident\,of\,Masantari$ village in the upazila, said the locals are afraid to protest as they fear that the stone lifters, who are involved with political parties, would harass them.

The operation of mechanical dredgers, which can go over 100 metres beneath riverbeds, creates hollow spaces underground, which exacerbates the chances of erosion. Each of the 200 dredgers can extract 700 cubic feet of stone per day.

Such unplanned extraction is ultimately harming the locals who are now afraid of losing their homesteads and arable lands located along the river bank again, said Mansur Ali, a 65-year-old farmer from Bangkanda village.

Mia Alauddin, vice president, Exhibitor Association, said, "Local films should be our first priority, however, the people associated with the business are together to re-evaluate this condition.

Gourmati offers new hope

Currently, cultivation of this mango has been expanded to a small extent in the northern regions Chapainawabganj, Naogaon,

Rajshahi, and Natore.

According to the DAE, 30,000 hectares of mangoes have been cultivated in Naogaon this year. Gourmati was cultivated in around 145 hectares of those, said the district's DAE Deputy Director Abul Kalam Azad.

Sohel Rana, a grower in the Sapahar Naogaon's upazila, cultivated Gourmati on 35 bighas of land in 2018. This year, he expects over 1,000 maunds, worth around Tk 80 lakh as per the current market

He said the prices of other varieties usually range from Tk 1,200 to Tk 3,000 per maund. "But Gourmati's price ranges from Tk 6,000 to Tk 16,000 per maund, allowing farmers to profit at least four or five times more than usual." On the other hand, he said, Gourmati sees higher yield than

other varieties. "Each bigha yields around 50-

Khirsa and Himsagor. But we get around 70-100 maunds in the case of Gourmati. However, as the mangoes need to be kept in the orchards for long time and require bagging, the production cost too is at least Tk 10,000 higher compared to other varieties.'

60 maunds of Amrupali, Langra,

Md Raihan Siddique, another grower in Naogaon's Porsha upazila, cultivated Gourmati in 80 bighas of land.

Gourmati variety can change the fortune of mango farmers. My advice to new farmers is to pick Gourmati for cultivation if they want to stay in the business."

Md Kamrul Islam, principal scientific officer at Regional Horticulture Research Station (previously known as mango research Centre), said, "The mango season would start in May and end in July. But since the introduction of the previous late varieties Ashwina and BARI-4 – the time would be stretched till the first week of September. However, Ashwina's taste is not as good as the Gourmati which is available in markets till at

Gourmati stays in the market for over a month, and no other mange lasts as long, he said, adding while the Katiman variety is also available in the market for a similar amount of time, it cannot compete with Gourmati in terms of quality.

"It also has huge potentials to take over the export market as it has great taste as well."

Mehedi Masood, director for the year-round fruit production for the DAE's nutrition improvement project, "After detecting this naturallymutated variety in 2012, we have systematically expanded its cultivation ... In 2015-16, we produced 50,000 plants of Gourmati mangoes through this project and then distributed them all over the country through

horticulture centers. "So far, about 5,000 hectares of land across the country has been dedicated to Gourmati cultivation. However, the variety has one flaw it's poor immunity and resistance to germs.'

Kamrul Islam said researches are being conducted over the last few vears to improve its immunity.

Invasive species that wreck crops, ravage forests, spread disease, and upend ecosystems are spreading ever faster across the globe, and humanity has not been able to stem the tide, a major scientific assessment said yesterday.

The failure is costing well over \$400 billion dollars a year in damages and lost income -- the equivalent to the GDP of Denmark or Thailand -- and that is likely a "gross underestimation", according intergovernmental science advisory panel for the UN Convention on Biodiversity.

TALIBAN THREAT France evacuates 5 **Afghan women**

France was due to receive five Afghan women "threatened by the Taliban" after repeated requests it create a humanitarian corridor for women shut out of public life, an official said yesterday. Since returning to power in August 2021, Taliban authorities have imposed a strict interpretation of Islam, with women bearing the brunt of laws the UN has labelled "gender apartheid". Women and girls have been banned from attending high school and university as well as barred from visiting parks, fairs and gymnasiums. French immigration authority chief Didier Leschi told AFP that by presidential order, special attention is being paid to women who are primarily threatened by the Taliban because they have held important positions in Afghan society.

POST-COUP MYANMAR Bomb attack on border hub kills 5

A bomb attack on a government compound in the Myanmar border hub of Myawady killed five government and security officials and wounded 11 policemen, sources told AFP yesterday. The town on the border with Thailand has seen sporadic clashes between the military and antijunta fighters since a coup in 2021 plunged the country into turmoil. Early Sunday evening two "drop bombs" fell into a compound containing the district police office and general administration office, a military source told AFP. As officials took "security measures" after the blasts, another two bombs were dropped, killing five and wounding 11.

Downfall of remittance again

Time to rethink our fixed exchange rate policy

In what is undoubtedly a worrying development, remittance has fallen by 21.5 percent in August - the steepest decline since the peak of the pandemic in 2020. According to the Bangladesh Bank, August's receipts are the lowest in six months. The latest development signals yet another blow to the country's dwindling dollar reserves, which stood at \$23.06 billion on August 30 and is projected to slip below the \$23 billion mark this week. For a country so dependent on remittance earnings, the situation is beyond concerning.

The decline in remittances – despite an increasing number of Bangladeshis leaving for jobs abroad - has become a persistent trend in recent times due to the growing use of unofficial channels, i.e. hundi. What is most frustrating is that economists have been endlessly warning about the wide difference between the market exchange rates in the official and kerb channels that continues to sway workers to choose the latter. Last Thursday, the exchange rate in official channels was set at Tk 109.5 per dollar, while the rate at kerb market prevailed around Tk 117-118 per dollar. According to a report by this daily, even private banks who can offer more to remitters have to follow the low rate fixed by the Bangladesh Bank. Now, with the growing number of informal channels online, which easily allows them to transfer money and with higher rates, remitters are increasingly eschewing the cumbersome formal process. Can we even blame them?

Instead of wasting energy on chasing those who make and choose the channel of hundi, the authorities should, first and foremost, acknowledge that the taka's artificial overvaluation is the primary reason that hundi has mushroomed over the years. We urge the Bangladesh Bank to pay heed to the warnings of our economists and urgently rethink its misguided policy of artificially fixing the exchange rate. It goes without saying that, given the current volatility of our economy and our ever-dwindling forex reserves, we can no longer afford to stay complacent about the consistent dip in

It is widely known that workers also prefer informal channels due to the lack of external fees and higher accessibility compared to banks. The government should therefore give further incentives to exchange houses to alleviate the fees of remittances and let private banks develop their own apps for workers to seamlessly transfer their hardearned money back to their families.

Have we abandoned the street children?


'Dandy' abuse is a symptom of deeper socioeconomic issues

We are deeply concerned about the widespread abuse of "dandy" – an adhesive glue widely available in hardware stores - among street children in Bangladesh. This toxic substance contains toluene, among other harmful chemicals, which causes intoxicating hallucinations, euphoria, and dizziness. A recent report in this daily has highlighted that street children primarily consume it because it helps them forget their hunger and detach themselves from the tough reality they live in. It is tragic that for most of these children, who earn less than Tk 100 a day, this glue is more affordable than food.

Reports show that, despite multiple studies and mitigation initiatives from government and non-government organisations, drug abuse is still prevalent among this extremely marginalised and deprived segment of our population. We find it appalling that most of these children are growing up in absolute neglect, abandoned by society and the state. The mitigation efforts, especially from the government, still heavily rely on persecution of the user, or rehabilitation programmes which are very limited in scope and scale. It is high time our policymakers understood that drug abuse among street children is a socioeconomic problem that cannot be solved through ad hoc and insensitive responses.

Studies show that broken families, lack of parental care, poverty and unemployment pushes these children towards homelessness and drug abuse. Many of these children are victims of physical abuse, forced prostitution, and even harassment from law enforcement personnel. It should come as no surprise that without any hope for a better future, these children feel abandoned by society, which in turn can lead them to abandon social norms and customs. As a result, many of these children tend to become addicted to other hard drugs and get entangled in small-scale criminal activities.

When asked, most of these children express a desire to attend school and get out of drug addiction and poverty. Like every citizen of this country, these children deserve an opportunity to lead a respectful life. We expect more sincerity from the government to address the underlying socioeconomic issues and take a comprehensive approach to safeguard street children from drug addiction and homelessness.

The inclusion of Saudi Arabia, Iran, UAE and Egypt seems very Middle East-centric, which has more oil-centric, geoeconomic, geostrategic and geopolitical implications, rather than representing the interests of the Global South. To emerge as the voice of Global South, BRICS needs to work out its expansion plan carefully.

Bangladesh has strong economic aspirations to become part of a forum like BRICS. Both China and India are Bangladesh's major trading partners, growing sources of external

While Bangladesh needs effective and enlarged trade and investment cooperation with all three, it is becoming increasingly difficult to maintain a reasonable balance due to the pressure coming from these countries out of their geostrategy and geopolitical interests, and for Bangladesh to handle this pressure in the contexts of conflicting domestic politics, weak institutions and governance.

Finally, graduation from the LDC status by 2026 will bring new challenges for Bangladesh. Among the BRICS nations, China and India are Bangladesh's two largest import sources. Bangladesh, as an LDC, gets duty-free facilities for the export of all products to India, except for 25 liquor and tobacco goods. In China, Bangladesh's exports receive duty-free treatment in 98 percent of tariff lines. In the post-LDC era, unless Bangladesh signs free trade agreements (FTAs) with India and China, it will lose its preference in these markets. Our country hasn't signed any bilateral FTA so far - the only success is a preferential trade agreement with Bhutan for some products. With this very limited experience, no doubt, Bangladesh needs to do proper homework while negotiating FTAs with India and China in the coming days. Even if the country is able to join BRICS in the future, how effectively it manages its trade, investment, and strategic relationships with India and China will also be critical factors for realising its own benefits out of BRICS.

Why are our passport services so insufferable?

Recently, I walked out of, or rather escaped, a passport office in Chattogram after failing to complete the biometric enrolment for myself and my two sons. At that time, I was filled with rage, frustration and shame just thinking about what the citizens of Bangladesh have to suffer to avail such a basic but crucial service. Really, why do we have to run a gauntlet for something so necessary as a passport?

My children reside abroad, and we are dual citizens of that country and Bangladesh. When I compare the due processes to get a passport of these two countries, it's just depressing to see what goes on at Bangladesh's passport offices. The neverending queues, the unbearable heat, the lack of customer service, and the ensuing chaos - I don't even know how I should

start my traumatising story. It's mindboggling to think that an office is probably contributing towards making

its service worse! A new Bangladeshi passport can cost between Tk 4,025 and Tk 13,800, depending on the type, size, length of validity and urgency. Since it's not a free service, we are all customers who are entitled to a facility that is simple, comfortable and swift. But our passport offices are the complete antithesis of this. It's evident that the government is generating heaps of revenue from the thousands of customers availing passport-related services every day. So, we have the right to ask why this dismal condition of service still persists, and point our fingers at those responsible.

Applying for a passport in the


other country is a simple online or postal process. We don't even need to send a passport-size photo; it's as simple as taking a photo in front of a white background – that, too, with your phone – and uploading it to the site. Now, I don't expect the process to be so simple in Bangladesh, and acknowledge that implementing this will take time. But considering the importance of such a service and the substantial revenue the country rakes in, Bangladesh shouldn't be this abvsmally behind the curve.

Why don't the authorities open more service centres to prevent overcrowding, and the chaos that accompanies it? We have a wellestablished National ID database, which contains biometric data of a large part of the population. Surely this database can be used to streamline the process to get a passport? Why must children spend an entire day (missing out on classes and recreation) amid the horrendous office environment when the authorities can just set automated appointments? While we're at it, why are the service centres so understaffed, and why does the staff misbehave with paying customers? Why is there no proper system in place to set a time

for the customer to arrive, queue up go through the various processes and exit, being satisfied by the fact that they got their money's worth? There are so many more questions I could ask, but I would run out of space.

As we are all aware, our country is going through a difficult financial situation amid rising inflation and depleting foreign exchange reserves. We are very quick to highlight the garment industry and its crucial role in our economy. However, millions of hard-working people make equal (if not more) contributions by going abroad and toiling in unforgiving conditions, with the goal to send their earnings back to Bangladesh. The most important services these expats probably avail within Bangladesh are those related to the passport office. I leave it up to the readers to work out the significance of passport services when considering this situation.

As for me and my kids, we did not complete the application process and have no plans to go back and try again. It's a shame because the Bangladeshi passport reflects our identity, which we like to keep updated and in hand. But I'm not going to put my children through hell and back for it!

The Moon is hot again, but why?

It's the beginning of humanity's newest frontier and a space war

landed six crewed missions on the Moon between the summer of 1969 and Christmas of 1972. They carried 24 astronauts, of which 12 walked on the lunar surface. After Apollo 17 in 1972, no human has gone there yet.

Thosewereessential to claim the to cosmic destinations far and Free World leader Washington's geopolitical bragging right against the communist Moscow to prove who was technologically superior. It was strictly a political stunt: go to the Moon, plant the flag, and return to Earth. So once Moscow was beaten, there was no motivation for going there

But that's changing. Nasa is committed to landing astronauts on the Moon again in 2025 as part of its Artemis Programme. China has plans to land humans on the Moon by 2030. In the meantime, uncrewed missions are increasingly heading towards the Moon. Russia's robotic Luna-25. the first such endeavour in 47 years, crashed on the lunar surface shortly after 11:57 GMT on August 19. India made history on August 23 by soft-landing its Chandrayaan-3 mission at the Moon's south pole.

After so many years, why has the Moon landing become so cool again? The simple answer is:

Scientists have long speculated that water could exist on the Moon, but the samples that the Apollo crews returned in the 1960s and early 1970s appeared dry. However, when Brown University researchers revisited those samples with new technology in 2008, they found hydrogen inside tiny beads of volcanic glass. In 2009, a Nasa instrument aboard the Indian Space Research Organisation's (ISRO) Chandrayaan-1 probe detected water on the Moon's surface. Another Nasa probe hit the south pole in the same year and found water ice below the surface. It confirmed the findings of an earlier Nasa mission, the 1998 Lunar Prospector, that the be a pricier but greener option, highest concentration of water ice was in the south pole's shadowed

beyond possible. Lesser lunar gravitational force - one-sixth that of the Earth – also reduces the cost of launching a satellite into its orbit.

Other than water, several minerals on the Moon can be commercially mined and transported back to Earth. These include a rare earth metal called neodymium, essential for making EV cells (batteries for powering electric vehicles), whose demand is growing as we shift away from fossil fuels. Extracting rare earth metals causes high levels of contamination of the surrounding environment. The Moon could offering a multi-trillion-dollar market.

Then there is helium-3, a rare element that can create a large amount of energy following the solar combustion process. Helium-3 is so rare on Earth that it sells for \$1.4 million per kilogram. Solar wind constantly bombards

the lunar surface without any atmosphere or magnetic field for protection, depositing helium-3 on it. Just to have an idea, at current price levels, there's around \$1.5 quadrillion (one quadrillion is 1,000 trillion) worth of helium-3 on the Moon. However, supply and demand economics means bringing helium-3 back from the Moon would significantly reduce the price.

But who owns the Moon?

Unfortunately, there is no clear legal framework to answer this question, and the ownership issue is still a grey area. The 1967 Outer Space Treaty of the United Nations states that "outer space shall be free for exploration and use by all countries" and that "outer space is not subject to national appropriation or ownership.

That was at the height of the Cold War, and the treaty aimed to prevent space from becoming another theatre of warfare, including a place to launch nuclear weapons. However, the present situation is entirely different, and the treaty doesn't cover many potential scenarios, such as the involvement of private

in 2015, sniffing Then, industrial prospects of space and the increasing participation of private entities, the Obama administration drafted the Commercial Space Launch Competitiveness Act, which Congress passed the following year, making space mining legal.

Despite the absence of any universally accepted framework, several countries are planning permanent bases on the Moon and Mars. Nasa is working on a permanent lunar base by 2035 and likely a Mars base by 2050. China's International Lunar Research Station (ILRS) - with participation from Russia and several other countries – plans to have a similar lunar base in the 2030s. That will be a research base for launching further missions to Mars, eventually setting up a base there. By then, many heavy, complex and hazardous industries will move to the Moon, which will become a launch pad for regular crewed missions to Mars.

So, humanity is not going back to the Moon but forward, as Dr Jack Burns, director of the Nasa-funded Network for Exploration and Space Science, says. Unlike the 1970s, the present technology is sustainable, the cost is manageable, the goal is straightforward, and the vision is long. Apollo had five kilobytes of Random Access Memory (RAM). Today, a simple mobile phone is millions of times more powerful.

example of perfect competition. There are many sellers and many buyers. All sellers and buyers see the eggs as identical. The only difference is that the eggs are either white or brown. No egg farm and no final consumer can influence the price on a particular day. Econ 101 then suggests that egg prices will be determined by the forces of supply and demand where nobody has market power.

In a highly competitive market like the egg market, one would expect prices to remain stable. They can rise, but over time.

The recent volatility in egg prices in Bangladesh suggests that the egg industry is experiencing shocks from one or multiple places. Keeping jargon and data aside, we happens after this increase? This will search for an alternative source.

An egg market is a textbook the Russia-Ukraine war led to a global supply disruption of vital feed ingredients in the countries from whom Bangladesh imports. Some countries that export these ingredients to Bangladesh are facing challenges to meet their own domestic demands. All this adds to an increasing feed cost. In the last few years, the margin between the selling price of broiler feed and its cost of production has made it a challenge for the feed industry to sustain.

High egg price means less revenue

Eggs are the main source of protein in low-income households in Bangladesh. Estimates suggest that the demand for eggs responds to price. If price increases by five percent, the demand will fall by can ask two simple questions. What more than five percent. Families will causes egg prices to increase? What either consume fewer eggs or they

usually auction their eggs and transport them to the wholesalers. or sell them through sales centres in large urban cities.

Small egg farms sell to a trader who collects eggs from several farms in an area. The trader takes the eggs to an urban market, like Tejgaon in Dhaka, where he sells them to a second trader. The second trader sells the eggs to retailers. So, between the small farmer and the consumer, there are at least two traders. This year, two factors contributed to rising egg prices. During summer this year, excessive heat led to hens finding it difficult to eat. This contributed to a fall in egg production. During monsoon this year, many small farms failed to transport their eggs to wholesalers. Supply fell. Prices of cheap fish, tilapia and pangas went up. Lowincome households tried to switch to eggs as an alternative. The demand for eggs increased when the supply was already less than usual. Eggs were sold at a high price during the shock.

There is one issue. The eggs that reach the final consumers in Bangladesh are all local eggs. When supply shocks appear, the government can't import eggs because there's a ban on egg imports. This is to protect and encourage the domestic industry.

Feed is the main cost component

The main cost component in egg production is feed. This can be up to two-thirds of the total cost of producing eggs. Of this, corn and soybeans are the main ingredients.

Bangladesh has sufficient feed mill capacity. The poultry industry on its own consumes almost threefourths of the feed mill production in the country. However, many small feed mills shut down when corn and soybean prices increased, which in turn raised the price of feed. Many small farmers stopped buying chicks because they were selling at a loss. They could not sustain loss over time due to small

Further challenges appeared in opening letters of credit (LC) due to volatility in the dollar exchange rate. This leads to temporary supply shortages where the available

domestic feed becomes expensive.

alternatives to eggs as a source of protein in low-income households are fish such as tilapia and pangas, and in poultry it is broiler chicken. All three of these food items have become pricier over the last couple of years. Why? These markets are interlinked because of feed ingredients that are common to all.

Less egg sales have resulted in less revenue for farms. This has adversely affected small farms that have been surviving on razor-thin profits. Since 2020, egg farms in Bangladesh have had to absorb two shocks: first caused by Covid, and the second by an increase in the cost of feed, medicine and other inputs. Many egg farms had to close because they could not bear the

How much do we really know?

The beauty of competitive markets is that no seller or buyer can influence the industry. However, as we have seen, supply shocks can happen in the egg industry. Some of these shocks are structural and some are seasonal.

The beast of competitive markets is, during these supply shocks, the supply chain gets disrupted for a short period. Within this period, the scope for a quarter to reap benefits arises. However, in the absence of a comprehensive survey of the egg industry, it can be misleading to point at any quarter.

The time has arrived for state departments and ministries to conduct a comprehensive survey of the country's egg industry. The rationale is simple. Eggs are the cheapest source of protein for low-income households who don't have easily available alternatives to access. We need to know how many eggs we have in our basket.



The issue with A level grade boundaries this year

Many students and educators found the shift too drastic. The pandemic affected not only the quality of education that students received but also their overall perception of studying.

All A level students appearing for the Summer 2023 session of the AS and A level examinations had been made aware by the Cambridge and Pearson Edexcel examination boards that their grading standards would be returning to the pre-pandemic levels of 2019. The students knew of these changes as they wrote their papers and awaited the announcement of their results. However, results day still came as a shock to the vast majority who received much lower grades than what they were expecting.

A grade boundary is the minimum mark you require in order to achieve a particular grade. This varies from year

students. In 2023, education boards aimed to return to pre-pandemic standards and consequently, fewer students excelled. When asked to comment on the

issue, Hayley White, Pearson Vicepresident of Assessment, Standards and Services, said, "During the pandemic May/June series of 2020 and 2021, we were unable to run exams, and so the method of assessment had to change. We asked teachers to award students grades, which we then validated. This style of assessment led to a natural inflation of grades awarded. Teachers awarded grades based on students' full potential. In an examination environment, some candidates do not perform to their full potential, and so an examined assessment

will tend to give lower results than teacher assessments. This meant that with teacher grades, we saw a higher-than-usual percentage of candidates achieving higher grades. An eventual return to the pre-pandemic established grading standard (last seen in 2019) is the fairest way to proceed."

"We set grade boundaries which reflect a comparable standard to that set in 2019 and earlier. As a result, the proportions of

depending on the difficulty of the achieving at each grade was in line paper and the performance of the with those seen in 2019 and earlier," she added. "In 2023, even though we committed to returning to normal standards, we did that with some protection for this year's students, to acknowledge the disruption caused by the pandemic. By this, we mean we made allowances for a slightly lower than normal standard of work at each grade."

However, many students and educators found the shift too drastic. The pandemic affected not only the quality of education that students received but also their overall perception of studying. The lax rules skewed their view of education and many of these students became impossibly demotivated due to the impact on their mental well-being. The change to the boundaries attempts to negate the long-lasting impact of Covid. Despite the rationale behind the boundaries being understandable, the transition being gradual rather than abrupt would've been more considerate and sensible.

'The pandemic has had a lasting impact on my ability to study and concentrate. I've had to juggle work alongside studies to cover the expenses of therapy," says Farhan Hossain, a private A level candidate.

Sakib Ahmed*, a student of Sir John Wilson School, said, "Shifting back to boundaries that even pre-covid students would have struggled with seems like an idea that was destined to fail. The exam boards should have been charitable but they failed to do so, making lives for so many students all around the world so much worse. The exam boards left us disappointed."

Md. Alauddin, A level Chemistry teacher at Southbreeze, Bangladesh International School and Greendale, opines, "Students couldn't really recover after the traumatic experience

some discrepancies in the marking this year. Some of my students wrote the answers that were in the mark scheme, yet they were not awarded the

Moreover, the difference between each grade is separated by only a few marks on paper. Unit 4 of Edexcel IAL Biology, for example, had a two-mark difference between each grade. These substantial leaps across an entire grade seem unreasonable.

Jezaul Khair Hazique, a teacher of Business and Economics at Maple Leaf International School, said, "The grade boundaries and marking principles this year were certainly stricter than in the past few years. I believe many of the students did much worse than they could have done. Many of my students missed the A grade for just a mark or two."

"With the boundaries set near 90 percent on paper for an 80 percent on uniform mark scale, it compelled me to temporarily set aside all other commitments and channel my focus solely into academics in order to barely pass," added Farhan Hossain.

Not everyone received Cs and Ds, but even those with higher grades weren't entirely content with their marks. People have different expectations of themselves, so feeling disappointed is typical, even if their performances were comparatively better.

Porom Khandaker*, a student from Academia School, said, "I did get an A, but the score wasn't high enough to bridge it to an A* in A2. It's disheartening, given the effort I invested over the past year."

Since many students didn't get their desired grades, they are going to have to go for retakes or rechecks, which place a huge financial burden on them. The retake deadlines were too close to on education. England's class of the results date for students to make 2023 have suffered a grave injustice informed decisions. Additionally, over A-level results.

He further stated, "I have noticed Cambridge doesn't allow students to view their scripts before they register for retakes or rechecks so they couldn't decide which is the best path to take.

> Moreover, many students who had hoped to apply to universities with their grades may be unable to do so. This is because they have to wait till January for their results after having given a retake in October/ November. Only then can they apply to universities but that means many of them are forced to take an involuntary gap year. Additionally, many students had their conditional letters from universities revoked because they fell short of the conditions asked of them. As a result, they have been forced to change their future trajectory.

> "I expected to score well and apply abroad to study business but the grade boundary for May 2023 contradicted those expectations. Now everything has to be recalculated, including when to apply for retakes and when to begin college application. As I study for the retake, it will increase my workload and I may have less room to study for my A2 exams at the same time," asserted Niloy Khan*, a private Edexcel AS candidate.

How independent learning can enhance the academic performance of university students

It often dawns on me that in comparison to myself, some of my classmates excel at practical learning while some struggle more at academics due to transitioning from a Bangla medium education background to the all-English academia of higher

education.

When I began lab classes during my first semester at university, I had to deconstruct the way I approached practical learning. Until high school, I was accustomed to working under constant supervision from my instructors. Most times, tinkering with instruments unrelated to my task was discouraged.

Often, my classmates and I would be passive observers, watching teachers carry out experiments that they felt we couldn't be trusted with. While this dependent learning was primarily due to the shortcomings in my school's teaching methods, university posed a very different challenge.

Even though I had access to an abundance of resources and highly qualified faculty, it soon became apparent that university teachers were not as accommodating and personally involved in the academic rigours of individual students. Some teachers would discuss only the basics of a topic in class but expected elaborate and accurate output from us. No longer was my every move in the lab supervised. I had to document my findings accurately – all on my own.

Half-basking and half-flailing in the newfound academic independence, I turned to educational apps, libraries, and academic websites for guidance. I was sifting through pages upon pages of relevant texts from different sources, noting and outlining keywords, learning jargon and trying to figure out how to do my assignments and lab tasks. Sometimes provided class notes touched on only foundational information and I'd end up scouring through a pile of out-of-syllabus textbooks to understand a topic.

This meant that my batchmates who were already adept at comprehensive reading, appraising and outlining information and retaining what

More 'wonders' in store?

With Bangladesh getting twin centuries, from Najmul Hossain Shanto and Mehedi Hasan Miraz, only for the fifth time in ODIs, the crucial role that the Tigers' bowling unit played to beat Afghanistan by 89 runs went under the radar in Lahore on Sunday.

Shanto and Miraz centuries did see the Tigers post their highest-ever ODI total in the Asia Cup and laid the platform for a big win, but the comprehensive margin of win that eventually saw the Tigers through to the Super Four would not have materialised without the concerted bowling effort from Taskin Ahmed and Co.

In what was a must-win game for Bangladesh, the prospect of having to improve the net run-rate only made the challenge steeper for the Tigers, especially for the bowlers as they needed to bundle out the opposition with enough runs in hand, and that too on a batting-friendly surface at the Gaddafi Stadium.

One thing that made things even tougher for the Tigers was the team management's decision to go with five specialist bowlers, reducing options for skipper Shakib Al Hasan if any of the frontline bowlers had a bad day.

However, Taskin, Shoriful Islam, and Hasan Mahmud – regarded as part of arguably the best pace bowling unit the country has ever had – lived up to their billing.

The pace trio combined for eight wickets to bundle out the Afghans for 245. Taskin led the charge with four wickets, Shoriful took three and had the most impact as



he gave crucial breakthroughs while Mahmud scalped one as they portrayed guile in their way of operation on a ground known to aid batters.

"I think it was a difficult task for the pacers on a batting-friendly surface. Yes, the batters put up a big total but what I liked was the way our seamers adapted to the condition and showed good standard. Our bowlers remained consistent and also bowled with good pace," Taskin's mentor and local pace bowling coach Mahbub Ali Zaki told The Daily Star yesterday.

According to Zaki, going with five specialist bowlers only showed the faith put in the pace unit by the skipper.

"What prompted Shakib to go with five specialist bowlers was probably the belief he had on the pace attack. The pacers have been well organised recently and bowled according to the plan which gives the luxury to the captain," Zaki added.

Even in the first game when the Tigers were bundled out for a mere 164 runs against Sri Lanka, the bowlers did manage to put pressure by picking up early wickets. However, the task proved too much with a small target on the board.

Shakib also praised the bowlers' effort after the game on Sunday, saying that the pacers have been doing the trick for the Tigers for some time now.

With even bigger challenges awaiting the Tigers in the Asia Cup, Zaki believes that the pacers would now need to bank on their strength.

"Look, Taskin is a furious attacker and is proven in world cricket while Mahmud is relatively new and relies on his variations. Shoriful can swing the ball and likes to attack the batter. So, we have a good variety in our pace unit. I think it will be important we bank on our strength and I believe this unit can do wonders in the coming days for Bangladesh," he said.

Liton had been suffering from fever which led to him being ruled out of the Asia Cup. He recovered a few days back but Anamul Haque Bijoy had already been sent as a "like-for-like" replacement.

"Liton is now doing fine. There are a few injury concerns in the team [Asia Cup squad]. We need to discuss these injury issues with the team management and find out if any replacement is required," chief selector Minhajul Abedin had told The Daily Star yesterday.

The Tigers would have a few combination-related worries to sort out before their crucial Super Four opener. There had been instability in the opening slot with Mohammad Naim not quite finding his feet with a big score while the big stage was always going to be intimidating for the young opener Tanzid Hasan

Following the debacle in the first group match against Sri Lanka, the Tigers brought in Mehedi Hasan Miraz, who answered the team's call with an authoritative ton. Najmul Hossain, who continued his form with the bat, took Tigers to a strong total which would bring some much-needed confidence to the batting unit.

However, every opponent has a definitive threat lying in wait for the Tigers in this tournament. Facing the likes of Shaheen Shah, Naseem Shah and Harris Rauf would bring different challenges to the table. The new ball would be important for Pakistan and thus the onus will be on

Would Miraz be able to negotiate the seam and swing that Pakistan attack usually gets even on flat surfaces? The presence of a left-handed opener would be one of the mechanisms the management can go for to protect the right-handers against Shaheen's in duckers. Thus, Naim or Tanzid will remain in the picture.

Miraz, meanwhile, may not appear as an opener if Liton is fit enough to play. Given that the new ball may not do much in Pakistani conditions, Miraz will be an

> option as opener once more. According to BCB sources, the team management does not prefer changing a winning combination.

> Miraz was used to counter Mujeeb Ur Rahman's threat early against Afghanistan. With no such spin threat foreseeable against Pakistan at the start of the innings, could plans change?

"Actually, I am always ready for any bowler because it's a new journey for me. If I can't play in the opening slot, I can play in the toporder if the team management gives me an opportunity," Miraz had said about the prospect of facing Pakistan pace attack after

the Afghanistan match.

The team management, moreover, would need to focus on the number seven and eight spots too. Shamim Hossain and Afif Hossain seem to be providing similar profiles in those positions, with the latter more suited up the order.

However, the need to bolster the lower-middle order to face up to top-order collapse may be the idea going into the Pakistan game. The absence of a sixth bowler, provided Mahedi Hasan remains out of contention, means the Tigers would have to precariously balance risk and advantages in setting up the eleven against Pakistan.



U-16s stay afloat

Verstappen's record 10th straight F1 win

Max Verstappen won a record-breaking 10th straight Formula One race on Sunday after coming out on top at the Italian Grand Prix in a show of force from Red Bull at Monza.

Reigning world champion Verstappen dominated on a beautiful day in northern Italy which left Ferrari fans disappointed, with Verstappen's teammate Sergio Perez finishing second ahead of home hope and pole-sitter Carlos Sainz.

Spaniard Sainz crossed more than 11 seconds back in third, unable to resist the power of Verstappen, the runaway leader of the drivers' championship.

Verstappen extended his lead on teammate Sergio Perez at the top of the drivers' standings to 145 points and also ensured that Red Bull maintained their perfect record with 14 wins from as many GPs this season.

The 29-year-old has now won 12 of this season's races and is all but certain to claim his third consecutive F1 title after breaking a record he shared with Sebastian Vettel by winning in Zandvoort last weekend.

Swiatek stumped by 'loss of control'

Iga Swiatek said she was at a loss to describe the way in which her US Open title defence was left in ruins Sunday in a last-16 defeat to Latvia's Jelena Ostapenko. The Pole lost for the fourth time in

as many meetings with the talented but inconsistent Ostapenko, who roared back to clinch a 3-6, 6-3, 6-1 victory after dominating the final two sets.

The 22-year-old Swiatek will lose her status as world number one following the US Open, with Aryna Sabalenka of Belarus set to take over top spot.

Swiatek had cruised into the fourth round in New York after not dropping a set in her first three matches, looking in prime form to defend the title she won last year

form to defend the title she won last year.

But Sunday's defeat will snap her 75week reign at the summit.



"Usually I'm not looking at numbers, but overall I love them. I would love to, like, extend this record a little bit longer," said Swiatek, a five-time Grand Slam champion.

"This is something that when I was younger, I actually kind of wanted to break some record or have something.

"I already did that 'cause I already won a Slam as a first Polish player. Obviously being No. 1 as the third player in history is great.

"But for sure when it happens, when you lose it, there are some sad emotions.

"All these great players know it's going to come back if you're going to work hard, focus on the right things, just develop as a player."

The Criminal Investigation Department of police has submitted the charge sheet in the murder case filed over the July 2021 fire at Hashem Foods Ltd in Narayanganj, which killed 54 people, dropping the names of the company owner and his four sons.

Abul Hashem, the owner of the food processing company, and his sons were not named in the charge sheet as the investigating officer did not find any evidence of their involvement in the incident, according to the charge sheet.

Inspector Moksedur Rahman, the investigating officer of the case, filed the 13-page charge sheet before the Chief Judicial Magistrate's court around

after the blaze. Hashem's four sons are Hasib bin Hashem, Tarek Ibrahim, Tawsheef Ibrahim, and Tanjeem Ibrahim.

Contacted, Moksedur said three other IOs had probed the case before him and that he prepared the charge sheet based on their findings.

Gourmati offers new hope for mango growers

Good yield, higher profits make it potential export item, say agri experts

A new variety of mango, Gourmati or BARI Mango-12, is winning farmers over as it promises them higher profits, being the last of the varieties to arrive at the market during the coveted mango season.

It has also gained popularity among consumers, who are now able to get the summer fruit till the end of September without having to opt for imported ones. The other varieties usually run out by the first week of the month.

Farmers have been growing Gourmati for the past four to five years, and selling it at higher prices due to its good quality. The variety is developed naturally as a mutation of Langra and Ashwina mangoes in Chapainawabganj's Shibganj upazila since 2012.

Imports of the fruit to Bangladesh have dropped largely over the years due

to the success of this variety. Serazul Islam, president of

Bangladesh Fresh Fruits Importers Association, said, "Mango import has almost stopped for the last three-four years due to the good production of late variety mangoes in Bangladesh.

Now, the markets are full of homegrown good mangoes for six months at a stretch.'

Expressing satisfaction, Palash Sarkar, deputy director of the Department of Agricultural Extension (DAE) in Chapainawabgani, one of the largest mango-producing districts, said the orchards dedicated to growing the variety have been expanding and

Black Sea grain deal can be restored soon

Says Erdogan as Putin demands West must stop blocking Russian exports

Turkish President Tayyip Erdogan said after talks with Russia's Vladimir Putin yesterday that it would soon be possible to revive the grain deal that the United Nations says helped to ease a food crisis by getting Ukrainian grain to market.



Russia quit the deal in July - a year after it was brokered by the United Nations and Turkey - complaining that its own food and fertiliser exports faced serious obstacles.

Erdogan, who previously played a significant role in convincing Putin to stick with the deal, and the United Nations are both trying to get Putin to return to the

"As Turkey, we believe that we will reach a solution that will meet the expectations in a short time," Erdogan said in the Black Sea resort of Sochi after his first face to face meeting with Putin since 2022.
