## Resolve political crisis over polls immediately

Urge eminent citizens at EC event; 'election must be free, fair and participatory too'

The next general election will have to be free, fair and at the same time participatory and competitive so that people in the country and elsewhere find it credible, eminent citizens told a discussion yesterday.

Besides, the current political crisis over the coming election has to be solved immediately, they told an Election Commission [EC] workshop titled "12th National Polls: Expectations and Reality".

If a major political party does not participate, the election will be questioned locally and internationally, former election commissioner Brig Gen (retd) M Sakhawat Hossain said.

"If you bring 300 parties to the election ignoring a major party, the polls will still not be deemed credible," he said.

Referring to the deputy commissioner of Jamalpur who recently urged people to vote for the ruling party, Sakhawat said, "You [EC] should take a tough stance against such things."

During polling, the EC should have a strong system in place to address complaints, he added.

Former cabinet secretary Ali Imam Majumdar said the last two national elections following the abolition of the caretaker government were widely questioned.

In the 2014 election, 153 lawmakers were elected without any competition while during the 2018 election, there were allegations that

## **CYBER SECURITY BILL 2023** JS passes it amid strong protests

### JP, Gonoforum MPs slam it saying new law will curb freedom of speech, media

The Cyber Security Bill was passed in parliament yesterday amid strong protests by opposition lawmakers.

Jatiya Party and Gonoforum MPs said it was old wine in a new bottle. Like the Digital Security Act, the new law will also be against people's freedom of speech and thought, and freedom of the media. It is against the constitution, they said.

The new law is to replace the DSA, which has been widely criticised at the national and international levels.

Rights activists and different journalists' organisations said almost all the controversial provisions of the DSA have been retained in the Cyber Security Bill. Only the punishment for committing some offences has been reduced.

The government is saying that it is a new law, but there will be no relief. Because it is an old wine in a new bottle, said Gonoforum MP Mukabbir Khan while taking part in the discussion on the bill.

He said journalists, the United Nations, and the Editors' Council have objected to and expressed concern regarding the new law.

Mukabbir said the Editors' Council pointed out that at least nine sections of the DSA severely curb freedom of expression and independent journalism and demanded they be amended.

"Now in the proposed law, seven sections have been amended regarding punishment and bail. The definition of crime is not clarified. It remains the same. No changes were made to two of the sections. The UN Human Rights Office called for the repeal of two clauses. But instead of repealing those sections in the proposed law, changes have been made in terms of punishment and bail."

## PROBE INTO WEALTH ABROAD S Alam seeks injunction on all media

Files petition with Supreme Court

S Alam Group Chairman Mohammed Saiful Alam and his wife Farzana Parveen have filed a petition with the Supreme Court, seeking a blanket injunction against "any and all discourses" about the now-stalled investigation into S Alam's wealth abroad.

The injunction they seek applies to electronic and print media as well as social media – a blackout on the topic.

They also named The Daily Star, Prothom Alo, New Age and SC lawyer Barrister Syed Sayedul Haque Suman, and petitioned that the court restrain them from publishing or broadcasting any statements, opinions, reports, remarks, or online videos "touching the merit" of the Appellate Division's decision to put on hold the enquiry into Alam's assets abroad.

The petition, filed on Tuesday, is slated to be heard today.

The petition says "their [Alam and Farzana] personal and business reputations have been seriously affected" because of the discourse. They called the damage irreparable.

In a suo moto order, the High Court on August 6 asked the Anti-Corruption Commission to probe Alam's wealth abroad after The Daily Star published an investigative report on his overseas businesses.

On August 23, Justice M Enayetur Rahim, chamber judge of the Appellate Division, ordered a status quo on the probe, until January 8, 2024, when the matter will be heard before a full bench, led by the chief iustice.

## BNP plans rallies in 19 dists this month

The BNP has planned to hold rallies in 19 districts and organise marches from one district to another this month to realise its one-point demand for election under a non-partisan government, insiders say.

Supporters from the adjacent districts will be asked to join these rallies, they add.

Members of the party's standing committee, its highest policymaking body, made a draft of these programmes on Tuesday night and sent it to leaders, according to sources.

The BNP wants to make an impact with these programmes over the next one month, they add.

The standing committee held a meeting online on Monday night and another one in person on Tuesday night. The programmes were discussed in the

After finalising the draft, the standing committee sent it to BNP acting chairman Tarique Rahman.

A formal announcement of these events is likely to come next week after the matters are discussed with the likeminded political parties.

### US worried over 'oppression' of journalists here

The US yesterday expressed concern over what it said was Bangladesh government's "systematic and pervasive oppression" of journalists and media personalities, who attempt to hold the authorities accountable.

"They [journalists] must be able to do their jobs without fear of harassment, violence, or intimidation," Department Spokesperson Matthew Miller told a press briefing in Washington.

He said this after a reporter asked for his comment on the sentencing of senior journalists Shafik Rehman and Mahmudur Rahman for seven years and the seizure of the property of another journalist Eleas Hossain, who is now in New

York. Miller said, "Their work uncovers corruption, safeguards the public's right to know information that affects their lives. They SEE PAGE 2 COL 6

### Islamic banks face liquidity challenges **Says Fitch Ratings**

The Islamic banking sector in Bangladesh continues to face liquidity challenges because of weak governance and regulatory quality, Fitch Ratings said.

In the first half of this year, Islamic banks faced sizable  $customer\ deposit\ outflows\ and\ lower\ liquidity\ buffers\ than$ conventional banks amid reports of loan irregularities,

said the American credit rating agency in a report on Tuesday.

Islamic banks' excess quidity -- defined as liquidity total cash reserves minus required reserves with the central bank -- declined by 66.6 percent year-on-year to Tk 982 crore at the end

However, excess liquidity has since improved with a 12.7 percent quarterly rise,

"In contrast, deposit

growth is slowing. Islamic banks' total

deposits grew by only 3.8 percent year-on-year in the first six months of 2023, "a significant fall from the 12 percent year-on-year growth" in the first half of 2022.

Islamic banks' vulnerability to short-term liquidity challenges is demonstrated by the fall in the liquidity coverage ratio (LCR) to 87.7 percent at the end of 2022, below the regulatory requirement of 100 percent.

### POST-COUP MYANMAR Junta, Russia agree on polls 'cooperation'

Myanmar's junta and Russia have signed a memorandum on "cooperation in election activities", state media reported yesterday, as both governments plan for polls that critics say will be neither free nor

Moscow is a close ally of the junta, providing arms and diplomatic support as Myanmar's military struggles to crush armed opposition to its February 2021 coup.
Junta chief Min Aung Hlaing met

President Vladimir Putin last year during one of several trips to Russia since seizing power. The Myanmar military has described Moscow's invasion of Ukraine as "justified".

Officials from the junta-stacked election commission signed a "memorandum of understanding for cooperation in election activities" with their Russian counterparts during a recent visit to Russia, the Global New Light of Myanmar reported.

The delegation "also explored Russia's election methods, conditions for conducting elections, campaign procedures", the newspaper said.

The head of Russia's election commission had also invited Myanmar to observe presidential elections scheduled for next year. That vote is expected to prolong Putin's rule until at least 2030, with many of his critics in jail or in

Myanmar's military has justified its putsch with unsubstantiated claims of widespread fraud in 2020 elections won resoundingly by Aung San Suu Kyi's National League for Democracy (NLD).

The junta will likely hold fresh polls in 2025, a senior official from a military-backed party told AFP earlier this month.

The United States has said any elections under the junta would be a "sham" and analysts say they would be targeted by the military's opponents. Russia has said it backs the

generals' plan for polls.

Suu Kyi's NLD which has trounced military-backed parties in every election it has fought -- was dissolved earlier this year for failing to re-register under tough new militarydrafted electoral rules.

The coup ended a 10-year democratic experiment and plunged the country into turmoil.

Fighting between the military and its opponents has displaced almost two million people, according to the United Nations.

### 11 CASES AGAINST KHALEDA Hearing on chargeframing October 12

A Dhaka court yesterday set October 12 for hearing on framing charges against BNP Chairperson Khaleda Zia in 11 cases, including one for sedition.

Judge Md Asaduzzaman of Dhaka Metropolitan Sessions Judge's Court adjourned the hearing and set the new date, said Additional Public Prosecutor Tapash Kumar Pal.

The adjournment order came following petitions submitted by the defence citing different reasons.

Khaleda, now out of jail following an executive order from the government, was admitted to Evercare Hospital in the capital a few days ago. She is now undergoing treatment there for various ailments.

Among the 11 cases, 10 were filed in the first three months of 2015 over arson attacks, while the other one was lodged with a Dhaka court on charges of making seditious comments on freedom fighters and martyrs of the Liberation War.

### JUBO LEAGUE LEADER MURDER SC wants explanation on prompt release of accused

The Supreme Court yesterday wanted to know how an accused in the Cumilla Jubo League leader Jamal murder case got released from jail the same day the High Court had granted him bail.

The chamber judge of the Appellate Division of the SC, Justice M Enayetur Rahim, directed the chief judicial magistrate of Cumilla to explain how his court executed the bail bond of accused Sohel Shikder so expeditiously and allowed him to be freed from jail.

The chamber judge cancelled the HC order that granted bail to Sohel on September 3 and directed him to surrender before the Chief Judicial Magistrate's Court by September 21.

Justice Enayetur also ordered the SC registrar general to form a committee to probe how the HC bail order reached the Cumilla court so fast and how the court conducted the bail bond of Sohel.

The SC registrar general has been asked to submit the probe report to the SC by November 11. The SC chamber judge passed the order following a petition filed by the state, challenging the HC bail order for Sohel.

Deputy Attorney General Sarwar Hossain Bappi

appeared for the state.

### 3 workers die as sand pile collapses on them

Three labourers were killed as a sand pile collapsed on them at Jaukura Ghat of Rajbari Sadar upazila on Tuesday night.

The victims were Rahim Sheikh, 52, Maruf Sheikh, 19, and Md Rimon. Daud Sheikh, manager of sand trader Hannan

Sheikh, said when the three were loading sand onto a truck around 10:45pm, suddenly the sand pile collapsed on them.

He added that they were rescued and taken to Rajbari Sadar Hospital, where doctors declared them dead.

Hannan stocks sand at Jaukura Ghat for sale.

Md Iftekharuzzaman, additional superintendent of police (Sadar circle) of Rajbari, said they were investigating whether there was any negligence on the part of the sand trader.

## S Alam seeks injunction on all media

Alam and Farzana allege in their petition that The Daily Star, Prothom Alo and New Age, and Barrister Suman have violated the status quo by "passing negative remarks and making defamatory statements against the applicants". They further claim that this is

all being done with the intention to harass them.

"Since last year, The Daily Star has been intentionally targeting the petitioner and his business concerns, S Alam Group, by publishing frivolous news and spreading propagandas," the petition alleges.

"The said newspapers have also been threatening the applicants to publish further news regarding the same subject matter.

"From an insider source it has been found out that The Daily Star has been gathering information to further report on the S Alam Group ahead of the national elections," it claims.

"Several newspaper reporters have started working in different branches of Dhaka and Chattogram to report on the S Alam Group as well as Islami Bank Ltd. In parallel, another report is being prepared on the close relatives of the Chairman for the sole purpose of harassing the petitioner and his close associates and relatives.

"Since the national election is coming, the said reports are likely to be prepared and published with the ulterior motive to attack the government and other organisations which have been developing the economy of the country under the ruling government," the petition

claims. While on the one hand The Daily Star gives the impression that it supports democracy, but "it seeks by underhand methods by attacking business houses which are known to support the government, thereby attacking a particular political party."

"This is the worst form of abuse that any journalist or any mainstream media house can perpetrate on democracy and the electoral processes in Bangladesh," it adds.

"Such an action may kindly be

prevented by this Honourable Court," the couple pleads. The petition describes Alam as an

exceptional businessman, and speaks of his contributions to the economy and continuous support for the The petition speaks about how the

report published by The Daily Star titled "S Alam's Aladdin's Lamp" on August 4 was "baseless, frivolous, false, inaccurate and unsupported". The aforementioned investigation

by The Daily Star found S Alam has built a business empire in Singapore worth at least about \$1 billion, although there is no record of him taking any permission from Bangladesh Bank to invest or transfer any funds abroad. The Bangladesh central bank

has so far allowed 17 companies to invest outside the country, and this Chattogram-based business giant is not among them, according to Bangladesh Bank documents cited in

Yet in Singapore, Alam bought at least two hotels, two homes, one retail space, and other properties over the last one decade, all the while seeking to remove his name from the paper trails, documents obtained from Singaporean regulatory authorities show.

To set up his business in Singapore, he and his wife used Cypriot citizenship, according to The Daily Star findings. That investigation also tracked down his businesses in Cyprus and the British Virgin Islands.

In their Tuesday's petition for a gag order, Alam and his wife said they have foreign nationality or are incorporated in foreign countries and the relevant Bangladeshi laws do not have extra-territorial effect and do not permit investigation. "Otherwise, it would become possible to investigate and report on foreign assets of all expatriate Bangladeshi citizens or persons of Bangladeshi origin."

The petition also delves into comments by Barrister Suman in a TV interview regarding the Appellate Division's status quo order, stalling the ACC investigation.

"Suman has inferred that the order

of status quo has been obtained because of the presence of bigshot lawyers. He also inferred that because of the order passed by this court his heart has been bleeding [...] He further inferred that journalists have not been publishing enough news about the corruption of the applicants," reads the petition.

Most illegally Suman has stated that this type of order encouraged general people to do money laundering," it adds.

The petition asks the court to take actions to have all videos of Suman concerning the topic removed.

## Islamic banks Resolve political crisis face liquidity challenges

FROM PAGE 1 At the end of 2021, the LCR was 188.5 percent, it said.

Conventional banks had adequate liquidity profiles, with an industry average LCR of 154 percent.

"However, liquidity is improving, underpinned by central bank support in the form of the Islamic Bank Liquidity Facility and Mudarabah Liquidity Support, and still-notable public demand for Islamic deposit products."

Islamic banks held 25.3 percent of all domestic industry deposits at the end of June, down from 28.2 at end-

Bangladesh had the eighth-largest Islamic banking market globally at the end of 2022, with total assets of Tk 497,070 crore (\$45.3 billion), ahead of Indonesia, Bahrain, Pakistan, Egypt, Jordan and Oman, based on data from the Islamic Financial Services Board.

The market share, based on industry loans, is rising and reached 29.1 percent at the end of June, in contrast to 28.5 percent a year earlier.

Bangladesh has the third-largest Muslim population globally, with sizable segments being shariahsensitive.

Islamic branches and windows of conventional banks are expanding, with an 8.2 percent share of Islamic banking deposits as of June, in contrast to 7.1 percent a year earlier. The remaining 91.8 percent is held by full-fledged Islamic banks.

The Islamic finance industry in Bangladesh continues to face key structural impediments.

These include a lack of sukuk and other Shariah-compliant investment options, gaps in human capital development, a lack of unified Shariah rulings, and an Islamic finance regulatory framework that requires an update.

We are in fear about the coming election.... Will all political parties be able to take part? Will voters be able to cast their vote freely?

"We have created a situation that allows many foreign countries to make comments about the polls in Bangladesh. Different states are looking at us. If we fail, we will pay for it."

Former ambassador Humayun Kabir said people expect an inclusive and competitive election that is free from influence of money and muscles.

Local government expert Tofail Ahmed said the ruling party had already started electioneering while police and administration officials sought votes in violation of the service

Former secretary Abu Alam Shahid Khan said, "The Election Commission will have to shoulder the liability if the

election is not participatory.' But the reality is, the EC cannot hold a "good election unless the government wants it".

Prothom Alo Joint Editor Sohrab Hassan said a major challenge facing the EC is getting the parties to take part. "The commission should urge the government to create a situation conducive for participation of all parties.

Bhorer Kagoj Editor Shyamal Dutta said, "People have lost faith in the Election Commission over the years.... Minority communities are the worst victims of election-time violence. It is important to gain confidence within one's own country first.

Journalists Kazi Abdul Hannan and Mahbub Kamal observed that free and fair elections cannot be held under a partisan government.

But Jatiya Press Club President Farida Yasmin said if the EC worked with confidence and integrity, a fair election was possible even under a partisan government.

Chief Election Commissioner (CEC) Kazi Habibul Awal said, "Different kinds of crises are present.... I have been saying it repeatedly. If politicians do not create a conducive environment for us, it will be difficult for us to hold

The political parties do not sit together "due to a sharp division in their stances", he added.

Regarding expert observations that the latest amendment to the Representation of the People Order has curtailed the EC's power, Habibul said the commission's power had actually increased.

"Many have said the Election Commission signed a paper to make one party the winner. These are not true at all... The commission is not working to make any particular party the winner."

But I would say that with respect to United States policy, that the United States and Bangladesh share a vision to ensure the Indo-Pacific region is free and open, connected, prosperous, secure, and resilient. That's the intent of our Indo-Pacific strategy and that is our position."

### NID Reg Bill passed in JS

National Identity Registration Bill, 2023 was passed in Parliament yesterday amid objection by the opposition MPs.

The bill is aimed transferring the national registration identity operation from Commission Election to the Security Services Division, Ministry of Home Affairs.

Minister Home Asaduzzaman Khan placed the bill which was passed by voice vote.

The currently national conducts the identity registration operation and has issued national identity cards against citizens aged 18 or above, since 2007, as per the National Identity Registration Act, 2010.

## They used to steal, sell data to scammers

The Detective Branch (DB) of police has arrested eight people of a racket for stealing personal information, including fingerprints, of SIM card users and selling them to scammers and various groups to be used for criminal purposes.

The racket, comprising sales representatives (SR) and customer care officials affiliated with two SIM card operators, used to make data packages individuals combining the fingerprints, personal information and the status of Mobile Financial Service (MFS)

of their SIM card. They used to sell this package of information to MSF fraudsters and criminal groups at Tk 1,500 to Tk 2,000 each, using a Facebook page named "Digital Service Pro", Junaed Sharker, additional

He said police uncovered this cybercrime following an some unusual online activities.

the racket, he added. According to DB, the data thieves, to execute their scheme, adopted a unique technique.

When a customer visited the SR for a new SIM card or SIM replacement or services, they were asked to clean their fingers on a soft silicon-like object.

Police said the customer care officers were responsible investigation launched to detect some unusual online activities. for gathering personal details, including MFS information, National ID (NID) number, and address of the person whose fingerprint the SR collected.

This data, including all personal information and fingerprints, was then put on social media platforms as a bundle for sale.

According to DB, the racket used to activate new SIMs using these information and sell those to various criminal groups, helping them hide their identity.

They, according to DB, would also make a package on MSFactivated SIMs and sell those to groups who scam people by calling or online.

## 91pc Bangladeshis prefer democracy

Says a global survey

For 91 percent Bangladeshis, it is important to live in a democratically governed country, found a survey by Open Society Foundation, a New York-based private funder of independent groups working for justice, democratic governance, and human rights.

Also, 63 percent believe the rise of China on the global stage will have a positive impact on the economy of Bangladesh, while 14 percent believe otherwise.

The survey report titled "Open Society Barometer: Can Democracy Deliver?" was released on Monday, with responses from 36,000 people over a representative group of 30 countries around the world.

According to the findings of the study conducted between May and July this year, younger people hold the least faith in democracy.

Just 57 percent of respondents from the age group of 18-35 think democracy is preferable to any other form of government, compared to 71 percent of older respondents.

But 86 percent of global respondents said they want to live in a democracy, while only 20 percent believe that authoritarian countries can deliver "what citizens want".

Besides, 72 percent of the respondents across the globe, including 88 percent from Bangladesh, believe that human rights have been a "force for good" in the world, and 71 percent agree that "human rights reflect values that I believe in".

In Bangladesh, 18 percent of the respondents said they struggled to feed themselves and their families every day in the past year, while 15 percent experienced it every week and 11 percent every month.

### Tk 24,000cr purchase proposals gets cabinet nod

The government vesterday approved 14 proposals to purchase various essentials, including wheat, soybean oil, fertilisers and green energy, worth about Tk 24,000 crore.

The cabinet committee on purchase during a meeting chaired by Finance Minister AHM Mustafa Kamal approved the proposals.

As per one proposal, the government will import 3 lakh tonnes of wheat from Russia under a government to government (G2G) agreement foi about Tk 1,033 crore, at Tk 34.43 per kg.

A food ministry official said the imported wheat will cost \$313 per tonne this time whereas it was \$430 per tonne a year ago.

The committee yesterday approved three proposals for the Trading Corporation of Bangladesh (TCB) including purchase of 3.30 crore litres of soybean oil from Malaysia.

The soybean oil will be imported from Brizo Marine SDN BHD by local agent Sena Edible Oil Industries Dhaka at a total cost of Tk 433.62 crore, at Tk 155.93 per litre.

Besides, Bashundhara Multi Food Products Ltd will purchase 50 lakh litres of soybean oil for TCB from local market for Tk 79.92 crore, at Tk 159.85

The survey said 58 percent -- majorities in 22 out of the 30 countries polled -- are worried that political unrest in their countries could lead to violence in the next year. In Bangladesh, that figure rises to 70 percent.

It also revealed that 84 percent respondents think lending countries should those struggling with debt by cancelling, reducing, or renegotiating repayment conditions.

## 50 years without a concrete bridge!

Residents of three unions in Narail Sadar upazila have not had a concrete bridge over the Kajla river in 50 years.

The residents of Mulia, Sheikhhati and Tularampur villages have to use boats to cross the 80-metre wide river to go to their respective destinations including Mulia Bazar and Narail district town every day.

Children, women and elderly people have to face immense sufferings while crossing the river.

Though the local representatives have pledged to build a concrete bridge on the river several times, no visible initiative has been taken yet.

Sujit Biswas, a resident of Mulia

Mulia Bazar to Narail town is only five kilometres, but due to absence of a bridge, we have to travel 15-16 km more to reach the town. I don't understand why the bridge is not being constructed despite repeated assurances from the authorities concerned."

Romo Sheel, a resident of Debbhog village, said, "We have seen our ancestors crossing the river by boat and now we are doing the same. Who knows when this suffering will end."

Ramesh Saha, another resident of Debbhog village, said patients are the worst sufferers as they have to wait for a long time to cross the river.

## JS passes it amid strong protests

Mukabbir said with this law, someone can be easily harassed.

"I can easily imagine how much this law is a threat to journalists," he said, adding that this law is one of the most effective tools to suppress dissent, criticism, and free thought.

He said over the last four and a half years, the DSA has only been used for suppressing free thought and criticism of the government or the ruling party. And the journalists suffered the most. Their freedom of expression has been severely curtailed. This act empowers the police to enter homes and search and arrest people without warrants.

JP MP Fakhrul Imam said some amendments have been made, but journalists said that they are not satisfied. Freedom of speech, freedom of thought, and freedom of the press are ensured by the constitution. Any law against freedom of speech would be unconstitutional.

JP lawmaker Pir Fazlur Rahman said the DSA was controversial. But this new law too will stand in the way of free iournalism and expression.

"Section 42 of this act provides the power [to law enforcers] to arrest without warrant. The act required special protection for journalists. There was scope to get the Press Council involved," he added.

JP MP Shameem Haider Patwari said the constitution ensures freedom of thought, the press, and speech. Therefore, such a law is unconstitutional.

The new law kept the definition of

the offences the same as in the DSA. This law will lead to the media selfcensoring more.

JP lawmaker Hafiz Uddin Ahmad said many have objected to section 42. All illegal sections including this one need to be removed.

Mujibul Haque, another lawmaker

of the party, said journalists take up the pen for the country. There was an opportunity to involve the Press State Minister for ICT Zunaid

Ahmed said freedom of thought and freedom of expression are recognised by the constitution, but they are not unrestricted. The freedom does not allow violation of the rights of others.

He said the DSA was enacted in 2018 as it was required then. Now the cyber security law is being enacted because it is required now. There is no alternative to the Cyber Security Act to build a transparent, accountable, and secure "Smart Bangladesh".

The bill was passed by a voice vote. WHAT'S IN THE LAW

The bill was placed in parliament for passing yesterday keeping offences under sections 17, 19, 27 and 33 as non-bailable. The offences are related to intrusion into key information infrastructure, damaging computers and computer systems, cyber terrorism, and hacking.

"I will not say that there is no lack of faith in the judiciary. But it has not come to this due only to the judges. There are some other factors," said Justice Obaidul Hassan.

### FLOOD DISASTER Fears mount of surging death toll in Libya

Bodies were washing ashore in eastern Libya yesterday, swelling the death toll from a storm that swept whole neighbourhoods out to sea, with thousands already confirmed dead and many thousands more still missing.

The flood torrent, unleashed by a powerful storm on Sunday night that burst dams, obliterated around a quarter or the Mediterranean city of Derna. Whole multi-storey buildings were swept away with sleeping families inside.

The "sea is constantly dumping dozens of bodies", Hichem Abu Chkiouat, minister of civil aviation in the administration that runs eastern Libya, said. "We have counted more than 5,300 dead so far, and the number is likely to increase significantly and may even double because the number of missing people is also thousands," he added.

Tens of thousands of people had been made homeless, he said, adding that Libva did not have the experience to deal with the aftermath of such a disaster.

### **VIETNAM APARTMENT** Fire kills 56 people, 37 hurt

A fire at an apartment block in Vietnam's Hanoi has killed 56 people, among them children, and injured 37, police said yesterday.

The fire broke out during the night in a nine-storey building, home to about 150 residents, according to the official Vietnam News Agency, which said the blaze was contained by 2:00 am.

Television images showed firefighters equipped with hoses and ladders at the scene by night, while a column of thick, dark smoke billowed from the building by day.

Several of the victims were admitted to local hospitals with multiple injuries after having jumped from their windows to escape the fire, state media said, citing Vu Hoang Phuong of Hanoi Medical University Hospital.

## Russia will win against 'evil' in Ukraine

### N Korea's Kim tells Putin; leaders discuss military matters, satellites

North Korean leader Kim Jong Un told Russian President Vladimir Putin via a translator that he was sure that the Russian army and people would triumph against "evil", in what he cast as the West's imperialism in the war in Ukraine.

Before proposing a toast to Putin's health, the victory of "great Russia", Korean-Russian friendship and the health of all those present, Kim said he was confident Russia would win in what Moscow calls its "special military operation" in Ukraine.

"I am deeply convinced that the heroic Russian army and people will

confidently demonstrate invaluable dignity and honour on the fronts of the special military operation," Kim said via a translator before raising a glass of wine.

"The Russian army and people will certainly win a great victory in the sacred struggle for the punishment of a great evil that claims hegemony and feeds an expansionist illusion," Kim added.

Both leaders discussed military matters, the war in Ukraine and possible Russian help for the secretive Communist state's satellite programme, according to Kremlin reporters.

At the opening of the meeting with Putin at the gleaming new space station, Kim said it was North Korea's unwavering

brilliantly inherit the tradition of victory, position to further develop its traditional friendship and ties with Russia.

Putin said Russia would help North Korea launch satellites.

US and South Korean officials have expressed concern that Kim would provide weapons to Russia, which has expended vast stocks in more than 18 months of war in Ukraine. Moscow and Pyongyang have denied such intentions. The choice to meet at Vostochny Cosmodrome was notable, as North Korea twice failed to launch reconnaissance satellites in the past four months.

Shortly before the summit, North Korea launched two short-range ballistic missiles from an area near Pyongyang, into the sea off its east coast.

## Kerala shuts schools, offices

India's southern state of Kerala shut some schools, offices and public transport vesterday in a race to stop the spread of the rare and deadly Nipah virus, which has killed two people. An adult and a child were still infected in hospital, and more than 130 people have been tested for the virus, spread via contact with the bodily fluids of infected bats, pigs or people, a state health official said. "We are focusing on tracing contacts of infected persons early and isolating anyone with symptoms," said the state's Health Minister Veena George, who told reporters the virus detected in Kerala was the Bangladesh variant, which spreads from human to human with a high mortality rate but has a history of being less infectious. "Public movement has been restricted in parts of the state to contain the medical crisis," she said. Two infected people have died since August 30 in the state's fourth outbreak of the virus since 2018, forcing authorities to declare containment zones in at least seven villages in the district of Kozhikode. Strict isolation rules have been adopted, with medical staff being quarantined after contact with the infected. The first victim was a small landholder growing bananas and areca nuts in the district's village of Marutonkara, said a government official.

### STATE SECRETS CASE Imran Khan's jail remand extended

Pakistan's former prime minister Imran Khan's jail detention related to charges of leaking state secrets was extended for another two weeks, his lawyer said yesterday. The latest extension of the remand order will keep Khan in jail until September 26, lawyer

Naeem Panjutha said in a post on X messaging platform. In the state secrets case, Khan is charged with making public contents of a confidential cable sent by Pakistan's ambassador to the United States and using it for political gain, according to a Federal Investigation Agency (FIA) document seen by Reuters.

## China unveils 'blueprint' for Taiwan integration

China on Tuesday unveiled a plan to deepen integration between the coastal province of Fujian and self-governing Taiwan, touting the benefits of closer cross-strait cooperation while sending warships around the island in a show of military might.

The directive, issued jointly by the Chinese Communist Party's Central Committee and the State Council, vows to make Fujian a "demonstration zone" for integrated development with Taiwan, and the "first home" for Taiwanese residents and businesses

to settle in China. The document, hailed as a "blueprint" of Taiwan's future development by Chinese experts cited in state media, comes at a delicate moment in cross-strait relations as Taiwan gears up for its presidential election in



## **Punish dishonest** poultry farms

### Cases filed against them by the BCC must be disposed of quickly

It is encouraging to know that the Bangladesh Competition Commission (BCC) has filed cases against 10 poultry-related farms and organisations who, in collusion with each other, allegedly manipulated the egg market last month. As per primary findings, these companies increased the prices of their products by creating an artificial crisis and thereby destabilised the market. If they are found guilty under Section 15 of the Competition Act, 2012, they could be fined up to 10 percent of their three-year average turnover. All this is good news, and we hope the BCC will be able to bring these farms under some sort of accountability.

One may recall that, in August, the prices of a dozen (farmed brown) eggs shot up to Tk 180 from Tk 145 - an unprecedented hike. The TCB tells us that egg prices have increased 18.39 percent over a year. At a time when the high prices of other daily essentials were already putting many families into financial hardship, the sudden hike in egg prices came as a double blow for them. People who were mostly relying on this item as their daily source of protein had to cut down on consumption, or stopped buying it altogether. The prices only dropped after the Directorate of National Consumers Right Protection raided the markets to stop

But the market remains unstable. Although currently a dozen eggs are being sold at Tk 150 at the retail level – which is quite high compared to a year ago - errant traders may raise prices again in the absence of proper monitoring by the relevant authorities. That is why, it is essential to take action against the actors responsible for manipulating prices which will also deter future perpetrators.

The BCC, which operates under the commerce ministry, is empowered by the Competition Act to probe and punish errant companies for violating relevant rules. It can also dispose of cases without going to a court. Therefore, nothing should stop it from holding dishonest traders - those orchestrating the price hike crisis in case of eggs and other essentials - accountable, and bringing some much-needed order in the market. It should also expedite the proceedings of pending cases it had filed against the companies last year. In other words, the BCC has the absolute power in this regard, which it must enforce. The goal should be to ensure that consumers' interests are protected at all costs.


### Dialogue vital to resolve differences

Amid all the speculations and finger-pointing over "foreign interference" ahead of the next parliamentary election, it is imperative, now more than ever, that the thrust for building a reliable and sustainable system of holding elections comes from within - i.e. politicians themselves. We cannot be endlessly experimenting with the electoral system, or be held back by fear and uncertainties every time there is an election around the corner. This is a historic challenge, given how we have failed to build a reliable system even after 52 years of independence. And there is not much time left, with the election scheduled to be held mere months later.

Experts, at a recent event, have again reminded us how dialogue, between our political parties, still holds the key to any success in not only resolving their differences and holding a fair and inclusive election come January, but also in "fixing" our electoral system for good – so it can be immune to any internal or external pressures. Therefore, they must give dialogue a chance, and public interests rather than party interests must be the basis for said dialogue. Naturally, the first step in that direction should come from the party in power. It is only through such efforts that vital issues that currently remain unresolved, ranging from the nature of polltime government to the role of institutions responsible for elections, can be solved. The resurgence of violence is another concern that one hopes such dialogues will help resolve.

As a recent survey has demonstrated, an overwhelming majority of our people (91 percent) still believe in democracy, despite the repeated failures of our democratic institutions. They still deeply care about their fundamental human, civil, and political rights. A fair election is a gateway to the realisation of these lofty goals of democracy. We urge politicians to take note of the aspirations of ordinary people, who, as things stand, have been deprived of their right to vote in a fair and peaceful environment for too long. Politicians must give them their voice back, and encourage them to get back to the polling booths.

Youth and adults who miss out on primary education, as is the case in developing countries, need to be provided the means for catching up with the missed learning opportunities through alternatives such as adult education, non-formal Worldwide experience has established that quality primary education that enables children to acquire literacy and numeracy skills is the best way to tackle in a generation (a duration of some three decades) the problem of illiteracy in the population. Experience short-duration "alphabetisation"

projects do not produce the desired outcome of literate adults who can acquire skills useful in their lives and continue further learning. Literacy for youth and adults have to be woven into meaningful learning opportunities relevant to their lives and work in a

flexible and learner-friendly way.

On both fronts – quality primary education for children and flexible non-formal learning with literacy as a component for youth and adults we have not yet managed to achieve the intended results. The National Learning Assessment carried out under the Directorate of Primary Education auspices has shown that the majority of children completing five years of primary education do not acquire functional competencies in reading and writing in Bangla and the four functions of arithmetic at a basic level. Since the 1990s, at least nine literacy projects have been carried out reaching a relatively small fraction of the potential youth and adult learners, and a tenth project was suspended during the Covid-19 pandemic. Education Watch studies and other educators have noted that life and livelihood skills development, these projects have been carried out as programmes. mechanical, "one size fits all" activities.

It would not be an exaggeration to say that these activities were carried out by the Bureau of Non-Formal Education (BNFE) exactly the way a meaningful and result-focused programme for youth and adults should not have been conducted – in has also shown that campaign-style respect of content, duration, teaching method, learning assessment,

questionable when seen in the light of primary education outcomes and the character of the literacy projects undertaken so far.

In a slight nod to the idea of meaningful literacy skills, BBS published the results of a survey on functional literacy skills in July this year. The functional literacy rate for seven-plus years in Bangladesh was found to be 62.92 percent. It was 60.77 percent for the internationally comparable 15-plus age range. The rates were determined by administering a literacy test calibrated to four varying levels of skills on a sample population. The four levels were: non-literate; familiarity with letters and ability to read some words; ability to read simple sentences; and ability at a more advanced level. Performers in the last two categories were considered functionally literate. The methodology and tools were developed by Education Watch for its literacy study in 2002 and also applied in Education Watch Report 2016. The reports found that the functionally literate adult population in Bangladesh was just over half of the population officially considered to be literate in the respective years. The BBS was urged to follow the "tested literacy" approach in reporting national literacy statistics, even if many developing countries do

Experience in Bangladesh and in other countries indicate that effective adult and non-formal learning are better undertaken by capable and dedicated NGOs, which are likely to

designated tasks.

BNFE Director Nuruzzaman Sharif said a five-year programme titled Non-Formal Education Development Programme (NFEDP) was being devised with the aim to cut illiteracy significantly. It is difficult to take this as good news for two reasons. First, a team of national experts worked on a comprehensive NFEDP in 2017 18 at the BNFE's behest, taking into account challenges and potentials as mentioned above. Decision-makers at the Ministry of Primary and Mass Education found it too radical for their taste, and it was shelved. Meanwhile, there have been frequent changes in the position of BNFE director-general, which is reserved for administrative cadre senior officers as a way station to other, more desirable postings. None of them has taken a serious interest or a lead in the proposed programme. Second, if there is an interest in the NFEDP mainly "to cut illiteracy rate," then it betrays the purpose of meaningful literacy as a component of non-formal education and lifelong

According to media reports, the secretary for primary and mass education, Farid Ahmed, said the government was no longer interested in implementing projects through NGOs. I would like to hope this means he admits that the current objectives and method of implementing literacy projects are not working, and a new partnership approach with NGOs will be followed to achieve the true purposes of literacy.

## The modern dilemma of marital surnames

Some time ago, while scrolling through my news feed, I came across someone I had been following for many years. But I couldn't recognise her name – at least not her last name. Then it struck me that she had recently gotten married, and therefore must have taken her husband's name. This person is someone I have observed over the years to have progressive views on most worldly topics, and hence, I felt a slight discomfort seeing her identity changed. Over the next few months though. I became accustomed to knowing her by her new name. Now I even find myself struggling to recall her maiden surname.

A wife taking her husband's name after marriage is a tradition – initially being a requirement by law in many cultures – that can be traced back to the historical practice of transferring property upon marriage. In the past, women transitioned from being members of their parents' family to being identified as part of their husbands' ownership, according to Laurie Scheuble, a sociologist at Pennsylvania State University. They would hence give up their father's surname and adopt their husband's.

Now, whether this is just a tradition that one still follows for the sake of it, or a harmful remnant of the past that has become so deeply embedded in our society that we don't even seem to question it, is an open debate. The historical root of this convention, though, is based on the concept of marriage as a transaction involving the exchange of women for goods. The practice of adopting the husband's surname upon marriage reflects societal and cultural beliefs about women's lives, seen as dependent and interconnected. Consequently, women carry labels that signify their affiliation either with their fathers or their husbands. In contrast, men generally retain their names throughout their lives, illustrating a sense of social and

> cultural autonomy. The historical relationship between taking a surname and ownership becomes even clearer if one takes a look at the history of slavery in the US. Black slaves were often assigned the surnames of their White owners during slavery – a practice that served to identify them as the property of

those owners.

In the present-day context, I have been particularly interested in understanding why one might want to give up their last name. Many feel that sharing the same name fosters a sense of closeness and reinforces the idea of being a cohesive family unit. Others may not question this practice and simply follow it, often because it

has been deeply ingrained in societal norms for centuries.

From afar, the family unity theory seems to hold some ground. But it quickly falls apart when you raise the question: why there aren't more men taking their wives' last names. According to a 2018 study at Portland State University, less than three percent of men, in a pool of 877 being surveyed, opted to take their wife's last name upon marriage. And then if

a husband does take on the wife's last name, what they are really taking on is her patronymic surname.

A woman's ability, or rather inability, to pass on her name through her lineage is another can of worms. For women who do decide to keep their surname, after having a child, the child usually ends up having a patronymic surname; and the woman's name and legacy are lost to obscurity once more. This practice also makes it difficult to trace a woman's ancestry, compared to

In countries like Greece, Italy or France, women cannot legally change their surnames after marriage and are bound by law to keep their maiden

Neither forcing a surname nor forcefully taking away the choice to adopt your significant other's name can be the way forward. Two individuals should have the freedom to choose to adopt each other's name after marriage if they want to, be it the man adopting the woman's name or vice versa. They can even get creative and create a whole new surname by either hyphenating both their surnames or combining the two. After all, traditions can evolve too.

## **'Bangladesh** should prioritise its national interests above all'

Maj Gen (retd) ANM Muniruzzaman, president of the Bangladesh Institute of Peace and Security Studies (BIPSS), discusses the ongoing diplomatic activities of the country in an exclusive interview with Naimul Alam Alvi of The Daily Star.

How would you assess the recent diplomatic activities in Bangladesh, starting with the visit of Russian Foreign Minister Sergey Lavrov, then the G20 Summit, and finally the visit of French President **Emmanuel Macron?** 

The visit of Russian Foreign Minister Sergey Lavrov to Bangladesh, the first by a Russian foreign minister in many years, was a difficult one, as Russia has been isolated by many countries following its invasion of Ukraine. Lavrov made a number of controversial statements during his visit, but Bangladesh managed to navigate these challenges relatively

Then Bangladesh attended the G20 Summit in New Delhi as an invited guest. It was an opportunity for us to participate in a high-profile global agenda, and to have direct bilateral meetings with a number of heads of states. However, in the meetings that were held, besides hoping for increased cooperation for regional stability, nothing important regarding Bangladesh was discussed that we know of. So, I would consider that the bilateral engagements at the G20 Summit were fairly routine.

Besides that, Bangladesh was invited and joined the new Global Biofuel Alliance. However, no details on how this alliance will work and how Bangladesh can benefit from it have so far been available. The G20 Summit covered a wide range of issues and agenda, such as climate change, infrastructure multilateralism, development, and macroeconomic risks and measures. It also covered quite a lot on digital infrastructure. These are important to us because many points in the G20 declaration are issues that Bangladesh has

There was a lot of euphoria in Bangladesh about the photographs that emerged, showing US President Joe Biden taking a selfie with our prime minister. I consider this to be a regular gesture of diplomatic nicety. It does show that it was a happy occasion. But I would not give it any political mileage.

However, there was a big deviation from the 2022 G20 Bali Summit. where Russia's invasion of Ukraine was directly mentioned and condemned. This aspect was completely omitted in this year's declaration. The other major factor in the 2023 G20 New Delhi Summit is that the African Union has been declared as the new permanent member of G20. This inclusion brought in a wide number of countries' interests into the G20 process. So, we can hope that Africa will be adequately represented in the next G20 Summit in Brazil.

On the sidelines of the G20 Summit, there was a declaration of an economic corridor named India-Middle East-Europe Economic Corridor (IMEC). What would be the implications of such a corridor, particularly for Bangladesh?

This is a fairly extensive multimodal connectivity initiative to link railways, ports, energy lines, digital linkages, and green connectivity. It's estimated that if this is implemented, trade distance between India and Europe will be reduced by 40 percent. However, the concept paper they released isn't very detailed. This seems to be a multi-trillion-dollar project, but we don't yet know how it will be financed or implemented. So this is still a fairly aspirational concept. However, they declared that there was a working committee and within two months they would reveal a working paper with detailed information. We should not assume how it will affect Bangladesh at this point.

Although it's not stated, we can assume that the IMEC is being developed as an alternative to China's Belt and Road Initiative (BRI). We know that all South Asian countries except India are signatory to the BRI. So, India has enthusiastically joined the IMEC initiative. If IMEC is completely implemented, it can emerge as a big challenge to the BRI. It can potentially bring significant

geostrategic and geo-economic shifts in the region and the global order.

How important do you think the French president's visit was to Bangladesh?

Macron's visit was fairly significant. First of all, this is the first Bangladesh visit by a French president in 33 years. This seems to be in response to the invitation from our prime minister when she visited France in 2021. However, France also has significant strategic, economic and trade interests in Bangladesh.

If we analyse the joint statement by Bangladesh and France, there are a number of strategic indications. France has been showing increased interest in this region since they declared their Indo-Pacific strategy in 2020. France is advocating to consider them as not just a foreign player in the Indo-Pacific region, but as a resident power as they have four sovereign territories in the Indian Ocean. With two major global powers competing for influence in South Asia and the Asia-Pacific region, France is indicating that they want to emerge as a third power to create an alternative space in the region. This visit is a part of their Indo-Pacific push.

France has direct trade interests in Bangladesh as well. Our firstever satellite, Bangabandhu-1, was manufactured by a French company. Now they want to manufacture our second satellite. Bangladesh has agreed to buy 10 Airbus planes from France, which is a big purchase. France also wants to sell Rafale fighter aircraft to Bangladesh. Perhaps this was also considered during the visit. Overall, trade between Bangladesh and France was an important agenda for the French president's visit.

What do you think is the reason behind Bangladesh's growing geopolitical importance?

Bangladesh is a key maritime nation. We are a Bay of Bengal country and an

Indian Ocean country. Our geological location is significant in today's geopolitics. Bangladesh has been growing its ties with two emerging global powers - India and China. China has already proven themselves as a major power in the world. And our neighbour India has become a major power in Asia. So, through our colocation with these two major powers, our geopolitical importance has increased.

Besides, we have been on a path of great economic development over the last decade. So, we are also attractive as an emerging big market. However, currently our economy is greatly faltering. We have gone to the IMF for a loan. I'm afraid our economic leverage has diminished.

What should be Bangladesh's stance in this situation?

Bangladesh should prioritise its national interests above all, and try to maintain geostrategic neutrality as much as possible. It is important for us to navigate a complex geopolitical landscape. The international system is in a flux, and we need to take note of the rapid changes that are taking place around us. Although limited in scope, Bangladesh has declared its Indo-Pacific Outlook. We should further deepen our understanding of the Indo-Pacific and incorporate it in




Figure 2: A visual representation of how many ODIs Bangladesh have played every years ince 2007.



## The occult thrills of 'The Centre'

Review of Ayesha Manazir Siddiqi's 'The Centre' (Gillian Flynn Books, 2023).

Rarely does a book arrive, a debut no less, that feels as inventive and accomplished as Ayesha Manazir Siddiqi's *The Centre*. Her novel is built on the crossroads of interpretation and ownership, of the power of language and of those privileged enough to reclaim it. In this regard, Siddiqi's novel is a contemporary reckoning of our often tenebrous relationship with the others' tongue. Unfortunately, the novel's all too visible flaws also cloud much of its muster.

Anisa Ellahi, an unremarkable subtitler of Bollywood films, meets Adam, a polyglot, at a seminar on "Translation verses Adaptation". She is fascinated with the many languages he seems to know, which is a stark contrast to his otherwise mediocre personality. As they begin to date and their relationship progresses, Anisa invites Adam to her home back in Karachi and Adam, to impress her, becomes fluent in Urdu practically in days. Refusing to believe Adam's obviously untrue excuses, she is made aware of the Centre's existence—a secret, invite-

only, language-learning centre which claims to make its learners fluent in 10 days. Wishing to better her career, Anisa enrols for German with Adam's recommendation. Yet, as she gets involved in the Centre, she is slowly immersed into the organisation and its dark secrets.

Siddiqi's novel, so far, is tantalisingly smooth. In Karachi, we see Anisa's family parading around the urduspeaking white boy to their friends and how a shopkeeper, upon noticing Adam's urdu, had "shook his head

While her anxieties are relevant and, above all, true, they come packaged with the smell of complacently "aware" rich people, the "trustafarians" in the author's language, who have the the *luxury* to be aware and duly stop short of making any structural change or change in their behaviour beyond this awareness, rendering this generosity meaningless. When Anisa lies to her best friend Naima about the real cost of attending this elite Centre (because the latter comes from a poor background), she recognises what she has done and says: "Maybe, through these small erasures, which we tell ourselves are 'polite' or whatever, we're covering up a vast network of structural inequality." But what is the point of owning up to this, when she continues with the lie? Anisa's narration, on the whole, veers on the cloyingly casual (one could easily edit out the numerous "whatever" and "stuff"—filler words I fail to see as being part of Anisa's voice). It is remarkable and spoke at length about what an that a book on how the elite often

disadvantaged (in the later chapters of the book, the readers would see how literal that is, in the case of the Centre), can itself be a subtle example of this.

Siddiqi's clever premise also does not go much beyond the vagueness of the Centre's all-encompassing power, which for all its plans of world domination, does not explain how it intends to do this with merely language labs. Arjun, one of the founders, even says, "We have the best scientists overseeing the process, neutralising all potential toxicities." Yet the book shows all of them working in their house, akin to a DIY project. Anisa's swift infiltration into the Centre, too, is worryingly unbelievable. Her chemistry with Shiba, who runs the Centre, undoubtedly works but one wonders here too how unrealistic and suspiciously convenient this is for the

Siddiqi's novel is quite enjoyable when she deals with the politics of the text, when instead of numerous pages of Anisa's boring complaints about her friend's relationship, we see more of the "magic language school," which I presume is what readers are really interested in. The novel is full of great lines such as "And prayer, I think, can be a bit like translation. There's a cosmic geometry to it." Or, "Did you see their faces when you said that thing about translation as colonialism? They were practically salivating. You're basically a dominatrix now."

*The Centre*, discounting some of its weaknesses, is smart, fresh, and full of suspense. Siddiqi and her debut novel deserves all the attention and perhaps







## A paean to storytelling

### Review of Salman Rushdie's 'Languages of Truth' (Random House, 2021)

Following the trails of *Imaginary Homelands* (Penguin Books, 1992) and Step Across The Line (Modern Library, 2003), comprising essays written and lectures given by Salman Rushdie between 2003-2020, Languages of Truth is Rushdie's third collection of nonfiction works and is as a delectable read as its predecessors if not more.

Languages of Truth opens with the essay titled "Wonder Tales" in which Rushdie probes deeply into the nature of fiction and the paths literature can and should tread on while ruminating on its past history and where it is headed. "Wonder Tales", perhaps the finest essay pertaining to literature he ever penned down, is a paean to the art of storytelling—a homage to the blending of the real with the surreal, of the natural with the supranatural, a tribute to the immense power of the fictionality of fiction and the imaginativeness of the imagination, an ode to the power of fiction to tell truths better than blunt truths are capable of.

Rushdie sees us as storytelling animals who need stories to sustain the soul. To him, story is the unnatural means we use to talk about human life, our way to reach the truth by making things up. Asgard and Valhalla, Olympus and Mount Kailash are not merely imaginary mythical lands, embedded therein are our deepest thoughts about our own natures and our doubts and fears as well.

Rushdie has always been in favour of the India in his childhood days was a harmonious use of the fabulous to reach the truth, to reach the real through the unreal has been the cornerstone of almost all of his works till date. The amalgamation of fact and fiction to explore reality has been the most favourite trope of Rushdie's almost half a century long literary career and it is no wonder that he is a staunch supporter of the

use of the surreal. From Grimus (Random House, 2003) to Victory City (Random House, 2023), Rushdie's fascination with the wonder tales is palpable in everything he writes. The influence of myths and legends is so apparent in almost all of his works that it doesn't come as a surprise that someone, who has drawn so much from that inexhaustible cornucopia of myths and legends and the wonder tales of the East and the West, would be so enamoured by them.

Human nature is complex, capacious and contradictory in its manifold manifestations and Rushdie is confident to sing along with Whitman-"Very well then I contradict myself." Rushdie rejoices in the protean power of literature to be able to sing the song of contradiction and complexity, to be able to celebrate our ability to be, simultaneously, both yes and no, both this and that.

Rushdie has often remarked ruefully on the present plight of India and likes to compare it with the past India, with the past Mumbai where he grew up. He believes that

place; religious zealots were not running riots back in his days and he seems to believe that he lived in a truly secular India which is now backsliding into a Hindu majoritarian state devoid of the secular ideologies held high by its founding fathers.

In an essay on his friend Christopher Hitchens who staunchly supported Rushdie on all fronts after the infamous fatwa, he writes movingly and reminisces about Hitchens' last birthday whilst likening his late friend to Voltaire. Like his friend the late Christopher Hitchens, Rushdie too is a polymath of the highest order. Profound and sharply well articulated in his idiosyncratic and penetrating prose, almost every page of Languages of Truth exudes Rushdie's sharp wit, brilliant humour, and incisive erudition.

A panoply of disparate essays ranging from Cervantes and Shakespeare to Vonnegut and Marquez, from Beckett to Roth, from Hamzanama to Salgado, from defending the freedom of artists to vehemently censuring censorship, from myths to musings on the pandemic—Languages of Truth presents some of the very best writings of Rushdie which do not fall in the flank of fiction. It would be a Herculean task anyway to put his best fictional works inside a single binding.

## Pakistan look to matchwinner Zaman against SL

Pakistan bowling coach Morne Morkel on Wednesday said injuries to their premier quicks is a big blow ahead of a must-win Asia Cup match but a "fantastic opportunity" for up-and-coming talent.

Naseem Shah has been ruled out of the team's final Super Four match -- effective semi-final -- against Sri Lanka in Colombo on Thursday, with Pakistan Super League star Zaman Khan coming in as replacement.

Naseem and fellow quick Haris Rauf were injured in the team's previous Super Four clash of the 50over tournament, a prelude to the upcoming ODI World Cup.

"A big blow, picking up those little niggles, but in this same sort of thing what a fantastic opportunity for the guys coming in," Morkel told reporters.

"After going down against India, it's a mustwin game for us come tomorrow and I'm quite



With a win-percentage of 59, Pakistan have a clear edge in terms of overall head-to-head results after having emerged winners in 92 of 155 outings. Sri Lanka won 58 times, while one game ended in a tie and four yielded no results.

Asia Cup records, however, stand heavily in favour of Sri Lanka as they boast an impressive win-percentage of 71.4, based on 10 victories in 14 fixtures.

The numbers are almost equal after 41 matches played in Sri Lanka as the hosts won 20 against Pakistan's 18. Three encounters provided no result, two of which were staged in Colombo.

The last time Sri Lanka played Pakistan at home, they won by 165 runs in Hambantota in 2015. In their previous Asia Cup meeting -- in the 2014 edition's final in Mirpur -- Sri Lanka secured a five-wicket victory.

# What are Tigers' focus areas in NZ series?

With Bangladesh already out of the Asia Cup despite having one game left to play against India on Friday, the emphasis would shift to making the most of their remaining assignments, mainly the New Zealand series at home, ahead of the upcoming World Cup in October.

The Tigers have recently found it difficult to attain balance owing to injuries but what areas would the team management look at to find those that fit their

World Cup plan? The need for an all-rounder may still be prioritised going forward.

Skipper Shakib Al Hasan had expressed that he believes quite a few players, who are already ensured of a place in the World Cup squad, may be rested. Bangladesh Cricket Board (BCB) cricket operations chairman, Jalal Yunus, told the media present at Sri Lanka on Tuesday that the head coach had already made plans on who to be rested.

The aspect of resting the fast bowlers also came up during Jalal's interactions with the media. Since Ebadot Hossain's injury forced him out of the World Cup squad, the remaining four front-line pacers may be rested as Tigers look for precautionary measures ahead of the marquee event.

"We have not made a decision regarding who will be rested, but we do have backup options if the pacers are rested," a member of the selection panel informed vesterday

The bigger focus would be the performance of the batters following batting collapses in Asia Cup. While the openers lacked runs -- barring Mehedi Hasan Miraz, who played as a makeshift opener -- the middle-order already bolsters the best available options in Shakib Al Hasan, Tawhid Hridoy and Mushfiqur Rahim. It is the lower

middle-order which has been the other big area in the batting department that needs improvement. However, balancing a team is where all-rounders also come into the equation.

While resting too many players could affect the balance of the side in the upcoming New Zealand series at home, two seasoned campaigners -- Tamim Iqbal and Mahmudullah Riyad -- may return to the side. Mahmudullah last played for the Tigers against England at home and although he does not fit the profile of a genuine all-

the team combination. Sources have claimed that Mahmudullah is slated for a return, and thus the team management can gauge

rounder, his bowling has often balanced

available options.

No.7 and 8 in the batting order have been key areas of concern in the Asia Cup. With Miraz playing as an opener, Shamim Hossain and Afif Hossain have failed to make their mark with the bat in the tournament while they do not provide a solid bowling option.

Meanwhile, the likes of Mosaddek Hossain, Mahedi Hasan and Soumya Sarkar could also present options with the ball. In absence of a genuine pace bowling all-rounder, with Mohammad Saifuddin rehabilitating from an injury, it remains to be seen if Soumya's medium-pace bowling could see him

get a nod ahead of the showpiece event in India.

The opening slot may need a backup opening option, in case Tamim Iqbal's injury remains a concerning issue going into the World Cup. Shakib had spoken about finding one or two players in the coming series who could fit the team.

Thus, apart from veterans like Tamim or Mahmudullah finding their feet before the World Cup, and given no further injury setbacks, only one or two other positions will be on the team management's agenda ahead of Bangladesh's seventh World Cup mission.

## Mushfiqur to skip India game

Mushfiqur, who had flown back to the country for the birth of his second child, was granted an extension of leave. "Mushfiqur has informed us that his wife is still recovering, and he needs to be by her side and with their children at this time," BCB cricket operations chairman Jalal Yunus was quoted as saying in the media release.

This might open up a chance for Anamul Haque Bijoy, the other wicketkeeper alongside regular Liton Das. Bijoy is yet to feature in a game in this Asia Cup but with the India game now a dead rubber, Bangladesh may look to experiment.

Wealthier nations, who are historically responsible for climate change, are failing to meet the international climate funding obligations they agreed on in Copenhagen in 2009, leaving vulnerable countries like Bangladesh and communities to escalating climate impacts.

In the Copenhagen summit in developed nations committed to meet a target of providing \$100 billion a year for climate but they failed to meet the target in the last 11 years.

Despite the need for \$4 trillion by 2030 to cap the temperature rise within 1.5 degrees since the pre-industrial era, all but eight developed countries missed the \$100 billion financing target every year to date.

Only eight developed countries out of 23 currently pay their fair share of climate finance to fund, said the report titled "Fair Share" by Overseas Development Initiative (ODI) and Zurich Flood Resilience Alliance.

The eight developed countries are Norway, France, Sweden, Denmark, Germany, Switzerland, Luxembourg and the Netherlands.

The UK, which came under fire earlier this year for attempting to walk back on its climate finance commitments, provided only twothirds of its fair share.

In 2020, the target should have been reached, but provision and mobilisation

amounted to \$83.3 billion. The climate finance gap between 2011 and

2020 totalled \$409.8 billion.

In 2021, the US provided \$9 billion for climate finance, \$34 billion less than it was supposed to.

The US has the largest shortfall for adaptation finance, missing its fair share goal by \$14 billion.

None of Australia, Spain, Canada and the UK met their fair share either; they should be providing an additional \$500 million to \$1 billion each.

"It's a total failure of responsibility by developed countries who bear historical responsibility for climate change," said Laetitia Pettinotti, ODI research fellow and lead author of the report.

The failure to meet the climate finance goal can be attributed to developed countries collectively, and this failure has far-reaching SEE PAGE 6 COL 6

## India's SC cracks down on 'media trials' Wants guidelines in 3 months

India's Supreme Court has taken strong exception to 'media trials' - referring to "biased reporting (that) gives rise to public suspicion the person has committed an offence" - and directed the Union Home Ministry to prepare guidelines for police to follow during press briefings in relation to criminal cases.

The ministry has three months to prepare a detailed

The top police officers of each state and the National Human Rights Commission have been directed to submit suggestions to the home ministry within a month and the next hearing will be in January, a bench led by Chief Justice DY Chandrachud said yesterday, underlining the need to sensitise police personnel.

Administration of justice is affected by 'media trials' Need to decide at which stage (of investigation) details should be disclosed. This is a very important issue because it involves interests of victim and accused. It also involves the interest of the public at large... media report on crime-related matters involves many aspects of public interest," the court said.

"At a basic level... fundamental right to speech and expression is directly involved in the context of both the media's right to portray and broadcast ideas and news... but we should not allow 'media trial'. People have the right to access information. But, if important evidence, is revealed during the investigation, the investigation can also be affected," the court argued.

The top court was hearing a petition relating to a 2017 instruction on the same subject; the court then had asked the government to frame rules for police briefings keeping in mind the rights of the accused and the victim, and to ensure those of both sides are not prejudiced or violated in any way. The court had then given six weeks to produce a draft report.



### AI using vast amounts of water

Artificial intelligence is using gallons upon gallons

Microsoft alone used more than 2,500 Olympic-sized swimming pools of water in its data centres last year. The latest numbers are leading to yet more questions about the sustainability and environmental dangers of the growth of artificial intelligence and related technology.

Artificial intelligence requires vast computing undertaking deeply calculations on behalf of people around the world. AI systems tend to be run in the cloud rather than on individual people's computers, meaning that companies running them must operate vast server farms to deal with the queries of their users.

Those server farms in turn need to pump in water to cool themselves down, because of the heat generated by those computers. That has long been a concern for environmentalists, but the sharp growth in artificial intelligence has led to even more use.
