

Raisul Huq Bahar's death anniv today

Today is the fifth death anniversary of AKM Raisul Huq Bahar, a freedom fighter and journalist.

Bahar was born on April 1, 1952 at Companiganj, Noakhali.

He died of cardiac arrest at a hospital in the port city on September 18, 2018.

Bahar was a guerilla commander and led many operations including Kaibalyadham Railway Bridge Operation at Pahartoli, Chattogram in the 1971 Liberation War.

Before joining journalism in 1972, he was an accounts officer of Chattogram Port. He was the Chattogram bureau chief of The Daily Star (2010-2015). He also served the Suprobhat Bangladesh and Dainik Purbokone as associate editor.

According to the case statement, one Saiful Islam, a trader from Chandpur, and his relative Abdul Mannan were duped into giving the gang Tk 20 lakh as an investment to become partners in their supposed 'watch company.' The duo also sold their land to the fraudsters, unaware of the fact that the so-called company didn't even exist in the first place.

Soon after Saiful handed over the money, everyone involved in the scheme switched off their phones

and vanished in thin air. Realising that they had been conned, Saiful managed to track down one of the gang members in Uttara and informed the police.

Later, Abdul Mannan filed the case with Airport Police Station on July 30.

Bari has six fraud cases against him and was out on bail.

The PBI official said that Bari used to introduce himself as a big businessman. He used to live in Malaysia. After returning from there in 2013, he started scamming people.

"The educational institutions, especially schools and colleges in CHT, do not have enough teachers and developed infrastructure. As a result, students in the CHT are not receiving proper education they deserve," said Dipok Shil, president of Bangladesh Chhatra Union, demanding the issue to be resolved promptly.

Rumel Chakma, assistant general secretary of PCPCP, said, "The education system in the CHT is in a fragile state due to a shortage of teachers, classroom crises, and housing issues in primary and secondary schools, and colleges."

According to the CHT Peace Accord, primary and secondary levels of education were supposed to be handed over to the Hill District Councils, but only primary level education

has been delegated so far, he said.

Rumel alleged that the district councils are hiring unskilled teachers through corrupt practices.

Alik Mri, president of Bangladesh Adivasi Chhatra Sangram Parishad, Imran Noor, organising secretary of Bangladesh Chhatra Maitree, Moushumi Chakma, organising secretary of Dhaka City Hill Women's Federation, and Aung Shwe Sing Marma, general secretary of Bangladesh Marma Students' Council, also addressed the event, among others.

and have been advocating for the construction of a new building that could double as a flood shelter, with the ground floor for sheltering flood-affected people and upper floors for conducting classes," she explained.

"I applied for it last year as well. Even during a severe flood in 2021, no action was taken. This year, I have once again sent school pictures to the relevant authorities. If they don't take the necessary steps, what can I do?" she questioned.

"I've heard that this school ranks 27th on the list of schools needing new buildings. If this one is at 27, then who should be at the top of the list?" she said. "Hopefully, we will be

able to resume classes next week if the situation improves," she added.

"Although I recently took office, I have already visited the school. Rashra Government Primary School is not the only one in this situation; several other schools in the upazila are also submerged," said Anjum Ara Begum Bithi, the Basail upazila education officer.

"These schools need to be rebuilt like flood shelters," she emphasised. When contacted, Abul Kalam Azad, the district primary education officer in Tangail, stated that they are aware of the problem and that new buildings, similar to flood shelters, will be constructed for the schools in the area.
