EU won't send full team to observe polls

Writes to EC, citing budget, uncertainty over meeting conditions at the time of polls

STAR REPORT

The European Union will not send a fully-fledged election observation mission for the upcoming national polls.

It communicated its decision to the Election Commission through a letter to the chief election commissioner on Wednesday.

"Based on the recommendations of the exploratory mission -- and taking into consideration the budget for EU Election Observation Missions for 2023/2024 -- High Representative Josep Borrell has decided not to deploy a fully-fledged EU Election Observation Mission," reads the EU letter.

"The High Representative's decision reflects the fact that, at the present time, it is not sufficiently clear whether the necessary conditions will be met at the

The Daily Star has a copy of the letter.

exploratory The mission visited Bangladesh on July 6-22 to assess the advisability, usefulness, and feasibility of a fully-fledged election observation mission.

Whiteley, in the letter, also said the EU was exploring "other options to accompany the electoral process these welcome on the part of

the Election Commission and Government of Bangladesh. I will be in touch with you as soon as possible in this regard". The letter, however, did not elaborate on the phrases "necessary conditions" or "other options". The Daily Star

could not reach the ambassador for comments. The letter added that the EU will continue to encourage

all efforts to ensure that the elections are free, fair, peaceful, and participatory.

Asked if the EU expressed any concern over the lead-up to the election, EC Secretary Jahangir Alam told reporters yesterday that the letter did not mention anything about it. He said the EU ambassador sent the letter to the CEC through the foreign ministry.

Meanwhile, after an event yesterday, State Minister for Foreign Affairs Md Shahriar Alam told reporters, "We will share details as soon as we are informed.

"Preparations for Bangladesh's national election will

EU decision to dent nat'l election's credibility

Say politicians, local polls observers

The European Union's decision to not send a fully-fledged election observation mission will negatively impact the coming election, politicians and local polls observers say.

The EU decision may discourage other international communities from sending their observers to Bangladesh, they believe.

Elections lose acceptability when there are fewer observers, Jatiya Party Chairman GM Quader says.

The EU in a letter to the Election Commission and the government on Wednesday said it would not send a fully-fledged election observation mission as there were doubts that the necessary conditions would be met during the election.

The letter also mentioned budget constraints as a reason behind the decision, according to EC Secretary Jahangir Alam.

The Bangladesh Climate Change Trust was supposed to get back in 2016 the Tk 538 crore, plus the accumulated interest, it deposited with the then Farmers Bank. However, it has so far received just Tk 74 crore after around seven years.

The Trust's wait to recoup its investment will get even longer as, in December last year, Farmers Bank, now renamed Padma Bank, got eight more years from the Ministry of Environment, Forest and Climate Change to pay back the money.

A source present at the meeting in December told The Daily Star that the bank had sought 15 more years to return the deposit, but the environment minister asked Padma Bank officials to return the amount by

Environment Minister Md Shahab Uddin declined to comment on the deadline extension. The Trust, which operates under the

ministry, made the fixed deposit with Farmers Bank in 2015 for one year, meaning the bank was supposed to repay the money in 2016, Trust officials said.

The money was deposited at the bank's Motijheel, Gulshan and Gulshan Avenue branches. Including the 9 percent interest, the total due now stands at around Tk 827 crore, one official said.

The official, who is not authorised to speak to the media, said the bank has paid back Tk 74 crore over the last seven and a half years.

Apart from seeking to delay the payment by more than 20 years, the embattled bank wants to pay the amount at 6 percent interest, and not at 9

4 die from electrocution on flooded Mirpur street Heavy rain floods Dhaka streets, grinds traffic to halt

people, including three of a family, died after being electrocuted in the capital's Mirpur last night as they came into contact with a live electric wire that

fell on a waterlogged street The incident occurred near Mirpur Commerce College around 9:45pm, Mohammad Mohsin, officerin-charge of Mirpur Police Station, told The Daily Star.

The victims were Mizan, 30, a CNG-run autorickshaw driver, his wife Mukta, 25, seven-year-old daughter Lima, and another man named Anik, 20.

The couple's six-monthold son Hossain was injured in the incident and is under treatment at the Dhaka Medical College Hospital. SEE PAGE 2 COL 1

our reply Civil Aviation Authority of Bangladesh (Caab), on August 28, sent a rejoinder to our report titled "Death of Passenger: Plane denied priority landing" published a day before.

In the rejoinder, Caab said: "(A) According to the statement of HSIA tower controller, on August 26, at approximately 3:20am, flights EY230 and BG350 received clearance for landing by Air Traffic Control (ATC). At that time, there was a cargo plane at the take off point of the runway which was supposed to take off within two minutes. But the flight took four minutes due to operational reasons. As a result, the ATC tower was forced to keep waiting both the aircraft ready to land to ensure safe landing. Subsequently, within a gap of three minutes, flight EY230 landed safely at 3:33am and flight BG350 landed at 3:36am.

"(B) It may be mentioned that on information from BG-350 around 3:15am on August 26 that a critical

A six-member US preelection assessment mission will visit Bangladesh on October 7-13 to determine whether to send a small international observation mission for the parliamentary polls due by January next year.

United States-"The funded International Republican Institute and National Democratic Institute [NDI] will independently and impartially conduct a joint pre-election assessment mission in accordance with the NDI's Declaration of Principles for International Observers," US Embassy Spokesperson Schiller said in a statement

Army chief leaves for China to attend 19th **Asian Games**

Chief of Army Staff General Shafiuddin Ahmed left Dhaka last morning to attend the 19th Asian Games China and the Indo-Pacific Army Chiefs' Conclave Ahmed (IPACC) conference in India.



He will observe various games and sports events, including the inauguration of the 19th Asian Games to be held in Hangzhou, China, on September 23 as the president of the Bangladesh Olympic Association, according to an ISPR press release.

There, the army chief will exchange views with the presidents and secretaries general of the national Olympic associations of different countries.

At the invitation of the Indian army chief, General SM Shafiuddin Ahmed will also attend the Indo-Pacific Army Chiefs' Conclave (IPACC) to be held in New Delhi from September 25-27.

The objective of the conference is to create an atmosphere of mutual trust, develop professional relations, and strengthen regional security arrangements by improving relations between the ground forces of friendly

Belt, Road Initiative consistent with Sonar Bangla dream Says Chinese ambassador

China's Belt and Road Initiative seeks no hegemony, no interference in other countries' internal affairs, and has no elements of expansion and plunder, said Chinese Ambassador to Bangladesh Yao Wen.

"It can be said that on the journey of Bangladesh's modernisation, the Belt and Road Initiative is most consistent with the Vision 2041 and Sonar Bangla dream, and is most suitable for Bangladesh's reality," he said.

The Chinese envoy was addressing report-launching event at a city hotel yesterday, marking the 10th anniversary of Belt and Road Initiative (BRI).

Bangladesh is the first South Asian country to have joined the BRI, a China-led global initiative to connect Asia, Europe and Africa. It was launched in 2013.

Yao Wen said the core spirit of the ancient Silk Road is peace

Worker crushed under iron sheet

A worker was crushed under an iron sheet at the Teesta Bridge construction site in Gaibandha's Sundarganj upazila yesterday.

Habibur Rahman, 50, was hit on the head by a bridge girder's shutter that fell on him as he was working at the site around 12:00pm.

He died while being taken to a hospital, said Sundarganj Police Station OC KM Azmiruzzaman.

"If the death is found to have occurred due to negligence in safety measures, a case will be filed against the authority concerned," the OC added. The local LGED office is constructing the 1.5km

bridge connecting Gaibandha's Sundarganj to Kurigram's Chilmari. Contacted, Sundarganj Upazila Engineer

(LGED) Shamsul Arefin Khan said, "We've provided necessary safety gear to the workers, but they aren't in the habit of using them.

"We'll provide adequate compensation to the deceased worker's family to ease their suffering." In a similar accident, another worker died at the site four months ago.

Teacher, daughter killed under falling tree branch

A female primary schoolteacher and her daughter were killed after a tree branch fell on them in Rangpur city yesterday.

The deceased are Krishna Rani Sarker, 36, wife of Brozen Sarkar of Tulshirhat village in Gangachara upazila, and her daughter Rajoshree

Krishna was an assistant teacher at Nohali Government Primary School in Gangachara.

Borzen, along with his wife and daughter, were headed to Rangpur city from Gangachara on a motorcycle, said Rabiul Islam, officer-in-charge of Porshuram Police Station under the Rangpur Metropolitan Police.

When they reached the Chabbish Hazari area around 11:00am, the branch of an old tree beside the road collapsed on the bike, leaving them critically injured.

Locals took them to Rangpur Community Hospital, where Krishna and her daughter succumbed to their injuries hours after their

Police handed over the bodies to the family without autopsy.

LIBYA FLOOD DISASTER Over 43,000 displaced

Libya's flood disaster, which killed thousands in the city of Derna, also displaced more than 43,000 people, the International Organization for Migration (IOM) said yesterday.

A tsunami-sized flash flood broke through two ageing river dams upstream from the coastal city after the Mediterranean Storm Daniel lashed the area on September 10.

It razed entire neighbourhoods, sweeping untold thousands of people into the sea.

OC Mohsin said the family was trying to cross the road. When they got electrocuted, Anik went to save them.

After intermittent rain all day, a heavy shower in the late evening inundated a large part of the capital, flooding streets and causing the traffic system to almost collapse.

Streets in Dhanmondi, Elephant Road, New Market, Mirpur, Banani, Eskaton, Green Road, Panthapath, Shewrapara areas were submerged.

Even Manik Mia Avenue and Mirpur Road near Dhanmondi-27 were waterlogged and gridlocked as late as 2:00am today.

Scores of vehicles were seen broken down on submerged streets.

Many took to social media to express their frustration over being stuck in traffic for hours on end or being unable to wade through waistdeep water on certain streets.

People, mostly returning home after work, were seen taking shelter in front of various offices, markets, and shopping malls. They had serious trouble finding transport home.

Akash Roy was on the way to his Uttara home from Farmgate. He was stuck near Bijoy Sarani for two hours. He then decided to go towards Shewrapara where his CNG-run autorickshaw broke down on a street under knee-deep water.

Hafiz Mollah, who went to Karwan Bazar to buy fish in the evening, got stuck there until around 11:00pm. While trying to return to his Mirpur home, he got stuck on Manik Mia Avenue for over an hour. Then he started walking.

The Meteorological Department recorded 113mm of rain from 6:00pm to 12:00am yesterday, said Omar Faruq, a meteorologist of Bangladesh Meteorological Department.

Moderate to heavy rains are expected till today due to a low pressure in the northwest Bay of Bengal and surrounding areas, the meteorologist said.

"(C) The duty doctor rushed to boarding bridge-4 after receiving the news. As flight BG350 landed at 3:36am, the duty doctor entered the aircraft immediately. After examining the passenger -- Md Shahjalal in various ways, the duty doctor informed that the passenger is dead. The duty doctor spoke to the aircrew and found out that approximately two hours before landing of the flight, the passenger next to him (Shahjalal's close relative) informed the aircrew that Shahjalal is feeling unwell. The aircrew immediately gave CPR, oxygen to the passenger and checked him with a pulse oximeter as he was unresponsive, but the passenger's pulse and blood pressure were not detected. The passenger's close relative who accompanied him in the flight said that he was seriously ill for the last three to four months. The body was handed over to his family after the death certificate was issued by the duty doctor.

The rejoinder also said, "As a result of the published news, image of Caab as well as the country has been damaged in the international arena and has created confusion among passengers and the general public." **OUR REPLY**

Before entering Bangladeshi airspace, BG350 communicated with Dhaka ATC and informed that there was a seriously sick passenger onboard, and that they would require a doctor and ambulance upon landing.

According to the Caab statement, BG350 contacted at 3:15am and landed at 3:36am, which implies the plane landed just 16 minutes after declaring emergency.

According to our sources, the cockpit crew of the Biman flight

around 3:00am, which means the ATC patient is on board, the ATC tower had plenty of time to get things sorted on the ground for the arriving flight.

> Following a declaration of a medical emergency by a plane, it gets priority over all scheduled traffic and a doctor is supposed board the plane as soon as it reaches the gate. Passengers are not supposed to disembark until the patient is taken care of and taken off the plane.

But these were not done. A cargo plane was on the runway which could have been directed to vacate the runway. Flight EY230 should have been asked to hold, instead of BG350.

The Caab statement says, EY230 landed three minutes before BG350. By observing Flightradar24, it can be seen that BG350 was put on hold for landing and made to fly in circle at least once.

The rejoinder claimed that a doctor boarded the plane immediately after it reached the gate but according to our sources the plane reached the gate at 3:46am and the doctor arrived at 4:15am, almost half an hour later.

HSIA did not respond to the medical emergency declared by the cockpit crew in accordance with international standards and standard operating procedure for such cases.



'FRAMING' 2 IN FALSE CASE Take action against nine DB men

Court asks IGP

A Dhaka court recently wrote to the inspector general of police, seeking actions against nine police officials of the Detective Branch who allegedly framed two men in a false case over possession of fake notes.

The IGP was asked to take departmental actions against the nine and inform the court within three months, read the letter, signed by Judge Tahsin Iftekhar of a Metropolitan Special Tribunal in Dhaka, dated

Belal Uddin, additional DIG (discipline and professional standard wing) at Police Headquarters, confirmed to The Daily Star yesterday that the PHQ has received the letter.

The nine are -- Sub-Inspector Dewan Uzzal Hossain, Inspector Tapan Kumar Dhali, Assistant Sub-inspector Ziaur Rahman, ASI Sohel Mahmud, ASI Abul Bashar, ASI Mominul Haque, ASI Nazmul Haque Prodhan, and constables Nayan Kumar and Golam Sarowar.

On January 24, the court of Judge Tahsin Iftekhar acquitted Hasan Majumdar, manager of a city hotel, and Sohel Rana, chef of the hotel, as charges brought against them could not be proved beyond doubt, according to the court documents.

The two were fighting a legal battle for six years to clear their names alleging that they were framed by the DB

During a raid at Hotel Bondhu in the capital's Paltan on November 6, 2016, plainclothes detectives detained the two. The event was recorded in the hotel's security camera.

The agonising wait of a daughter Man on life support after being hit by stray bullet

Bhuban Chandra Shil made a video call to his wife before leaving his office on Monday night, wishing to see their only daughter's face, but failed to do so as she was asleep.

Bhuban, a 55-year-old lawyer, lived in the capital for work, while his family stayed back in

Now, the shell-shocked daughter, Bhumika Chandra Shil, sits alongside her mother, Ratna Rani Shil, on a hospital staircase, waiting for her father to regain consciousness so that he can see her face once more.

Bhuban, who lived alone in a hostel in Motijheel's Arambagh area, was shot on his way back home from work that night.

A stray bullet hit his head when he was passing the Tejgaon industrial area on a motorbike.

Criminals fired at and stabbed Tariq Sayeed Mamun, 54, a suspect in the film actor Sohel Chowdhury murder case, and one of their bullets hit Bhuban, according to police.

He was immediately taken to Dhaka Medical College Hospital.

Legalise illegal highrises, but with fines

standing parliamentary committee on Housing and Public Works Ministry yesterday asked Rajdhani Unnayan Kartripakkha to legalise the high-rise buildings that were constructed unlawfully and without monitoring.

The committee instructed Rajuk to examine if the foundations and designs of such buildings are in alignment with their height and legalise them after imposing a fine.

Many owners have raised the height of their buildings in the capital unlawfully. However, the authorities are unable to demolish these structures as people are already residing there.

Meanwhile, the people residing in those units have to live in uncertainty, said Mosharraf Hossain, an Awami League MP and chief of the parliamentary watchdog. "This is why we asked Rajuk to legalise those buildings. Rajuk can impose a specific amount of fine on the owners per square foot," he said.

According to meeting sources, the engineers of such structures will be subjected to specific financial penalties as well.

The meeting also discussed the progress and future of ongoing projects under public works department; Rajuk; National Housing Authority; Chattogram, Cox's Bazar, Khulna, and Gazipur development authorities; Housing and Building Research Institute, and directorates of urban development and architecture.

The overall activities of the Directorate of Government Accommodation were also discussed in the meeting.

The committee recommended taking necessary actions to hand over excavated canals to the Chattogram City Corporation for maintenance under the project, "Reexcavation, expansion, renovation and development of canals for waterlogging in Chattogram city".

Committee members Narayan Chandra Chanda, Bazlul Haque Monowar Hossain Haroon, Chowdhury, Anwarul Ashraf Khan, Syeda Zohora Alauddin and Farida Khanam attended the meeting.

RIGHTS SITUATION 288 SC lawyers protest resolution of European Parliament

Two hundred and eighty-eight lawyers of the Supreme Court in a statement have strongly protested the European Parliament's resolution on the human rights situation in Bangladesh, particularly in the case of Odhikar's Secretary Adilur Rahman Khan and Director ASM Nasiruddin Elan.

"We are deeply concerned with the resolution (of the European Parliament) as it is a blatant interference with the judicial system of an independent and sovereign country, which is unexpected and unwanted," the lawyers said in the statement.

Yusuf Hossain Humayun, a senior lawyer and convener of Bangabandhu Awami Ainjibi Parishad, signed the statement on Tuesday.

The judiciary of Bangladesh has been working independently since November 1, 2007. The judiciary has no scope to be influenced by any authority after it has been separated from the executive. The remark made by the European Parliament through its September 14 resolution about the judiciary of Bangladesh is defamatory to our great independence and sovereignty..."

In the statement, they hoped that the European Parliament will withdraw its resolution. 





Two held over murder of trader

Police vesterday arrested two persons for their alleged involvement in the murder of a trader in Narayanganj's Siddhirganj on Tuesday.

Following tip offs, police teams raided Mizmizi and Al-Amin Nagar areas, and arrested Jubayer Hossain, 22 and Md Mridul, 20.

Both the arrestees are residents of Mizmizi Batanpara area, said SP Golam Mostofa Russel of Narayanganj district police at a press briefing.

On Tuesday evening, Akkas Shikder, a 45-yearold vegetable trader of Mizmizi, was stabbed to death by four muggers on his way to a market in the capital's Jatrabari.

Eight people were killed and two persons injured in road accidents during the last two days, according to reports from our local correspondents.

In Gazipur, a police officer died when a speeding pickup hit him in Kaliakair upazila yesterday morning.

The deceased, identified as Jamal Uddin, 56, served as a sub-inspector in the traffic division of the district

Md Zubair, inspector (operation) of Kaliakair Police Station, said Jamal was performing his duties in the Palli Bidyut area on the Dhaka-Tangail highway when

the pickup hit him from behind, around 7:30am. He was declared dead at Enam Medical College Hospital in Savar.

In Narayanganj, Bachchu Mia, a 55-year-old rickshaw-puller, died when a Dhaka-bound truck crashed into his three-wheeler, after hitting a road divider on the Dhaka-Chattogram highway in the Signboard area yesterday.

The accident occurred after the truck overturned as the driver lost control over the vehicle, said Inspector Md Shorfuddin of Shimrail Police Outpost under Kanchpur Highway Police Station.

On Wednesday night, a Chattogram-bound truck ran over a woman, approximately 23 years old, and a 30-year-old man, while they were crossing the highway in the same area, according to witnesses

The accident occurred around 10:00pm. The identities of the victims could not be known immediately. Police seized both the trucks but the drivers managed to flee.

Girl Shine: committed to preventing early marriage

Jebunnessa*, a 15-year-old, has been admitted to the Severe Acute Malnutrition unit at Ramu Upazila Health Complex with her child, Afsan, a ten-month-old boy suffering from the same medical condition.

"My son had frequent fevers and diarrhoea, and his growth was very limited, which worried me. I also had difficulty breastfeeding him because I was malnourished myself," said the mother, who has been undergoing treatment since November last year.

Jebunnesa is not the only adolescent mother admitted to this unit. Many others, including Asma*, Firoza*, Sufia*, and Rani* and their children, are also being treated at the unit as they battle different forms of

malnutrition. According to Dr Tahmid Ashraf of the hospital, the aforementioned conditions are direct consequences of early marriages.

A Chattogram court yesterday sentenced a man to life term imprisonment for killing Commodore Ghulam Rabbani, an aide-de-camp of Bangabandhu Sheikh Mujibur Rahman, in 2004.

Convict Saiful Islam alias Bilai Saiful was acquitted of the murder charge in the first trial but he was found guilty in the re-trial, said court

Chattogram Divisional Speedy Trial Tribunal Judge Md Robiul Alam delivered the verdict examining all the records and evidence, said public prosecutor Ashok Kumar Das.

During the verdict delivery, the accused was present at the court.

Earlier three convicts -- former general manager of Korean Export Processing Zone (KEPZ) Abu Naser Chowdhury, and former chief security officer Humayun Kabir Chowdhury, and one Md Selim -- were given life term imprisonment

In April, 2005, Naser and Kabir were sentenced to five years' imprisonment by a Chattogram court. The court had acquitted Saiful of the charges.

Asif finds success in muskmelon cultivation

A youth in Narsingdi has found success in commercial cultivation of muskmelon, also known as "Sammam", an exotic fruit which orginated in the deserts of East Africa and Middle East.

With his success, Ashraful Islam Asif of Nehab area in Panchdhona union has also inspired others to follow in his path.

Closely related to rockmelon or cantaloupe of Mediterranean region, muskmelon grows well in warm climates, usually during the dry season between April and June. Growers in Bangladesh, however, have successfully cultivated the fruit all year round.



Muskmelon grows between 500 grammes to 3.5 kilogrammes each, and has a yellowish exterior and a fleshy interior with an orange hue.

The fruit is rich in Beta-carotene, Folic Acid, Magnesium, Zinc, Copper, Vitamin-C and many other nutrients. It is an ideal fruit for health, said Mahmudul Kabir Bashar Komol, a resident medical officer at Narsingdi Sadar Hospital.

Recently visiting Ashraful's plantation, this correspondent saw a good number of the yellowcoloured fruit hanging from scaffolding made of bamboo and nylon yarn.

"I learnt about cultivating the fruit from social media and invested Tk 35,000 for seeds, labourer, scaffolding, cow dung and insecticide. After the harvest, I have managed to sell the fruits at threefold profit. I have just planted 200 saplings this season. The plants produce a lot of flowers, but we have to cut off most of them and keep only two to three pieces to have a good harvest," Ashraful said.

Although the fruit is new in the local market, it is fetching good responses from customers. Each fruit is selling for Tk 180 to Tk 200 per kg, he said.

They were supposed to give us the total fund along with interest one year after the deposit," said Naher, now the director general of the National Institute of Mass Communication.

Md Joynal Abedin, the incumbent managing director of the Trust, said the bank will inform them about their repayment plan after their board meeting.

"Once we are informed about their decision, our ministry will hold a meeting about the next course of action," he said.

Faisal Ahsan, acting managing director of the bank, said they held the board meeting in July, but the payout plan was not on the agenda.

"We stick to our commitment that if the bank performs well, we will start paying back the dues," he said. Tarek Reaz Khan, who resigned as

Padma Bank managing director on August 3, told The Daily Star earlier this year, "We sought 15 years to pay back the due. Recently, we paid Tk 5 crore. The payment will grow in line with the bank's financial improvement."

He said "a rumour-driven crisis" hit the bank recently, causing a fall of its deposits by Tk 187 crore in the 2022-23 fiscal year compared to the previous year.

In a special inspection in 2015, nothing but mere assurances.

Bangladesh Bank found gross violation of banking rules in disbursing loans by the Farmers Bank management. The central bank also found involvement of its former directors in sanctioning the loans. After the news hit headlines, people rushed to withdraw their deposits, crippling the bank's ability to conduct its daily operations.

Says Italian PM

minister Italy's prime Wednesday urged the United Nations to launch a "global war without mercy" against migrant smugglers, after a surge of arrivals on the island of Lampedusa. Addressing the UN General Assembly, Prime Minister Giorgia Meloni said Italy was ready to lead efforts against the "slave traders of the third millennium." "Can an organization like this which reaffirms in its founding document the faith in the dignity and worth of human beings turn a blind eye to this tragedy?" she asked.

S Korea calls for UN to regulate AI

South Korean President Yoon Suk Yeol yesterday warned world leaders about dangers of fake news and mishandling of artificial intelligence, calling for formation of a UN body to regulate the digital sphere. "If we fail to curb the spread of fake news resulting from the misuse of AI and digital technologies, our freedom will be at risk," Yoon told the assembly. "The market economy anchored in liberal democracy will be in peril, and our very future will be under threat," he added. Korea plans to host a global forum on AI, Yoon said, to discuss the creation of a regulating agency.

US must address nuke legacy

The president of the Marshall Islands said on Wednesday his Pacific island nation was "cautiously optimistic" it could soon finalize a deal on future ties with the US, but repeated a call for Washington to address the legacy of massive nuclear testing in the 1940s and 50s. The Marshall Islands is one of three sparsely populated Pacific island nations covered by so-called Compacts of Free Association with the US. Under the deals, the US has responsibility for their defense, while gaining exclusive access to huge strategic swaths of Pacific.

Pakistan sets election for January

The Election Commission of Pakistan (ECP) yesterday announced a general election for January, almost three months later than scheduled, removing political uncertainty over the timing to help salvage a falling economy.

Elections in the politically and economically troubled nation were due to be held in November, but were delayed due to fresh demarcation of constituencies under new

An ECP statement said the vote will take place late in January after the conclusion of a process that includes filing nomination papers, appeals and campaigning.

Pakistan is currently being run by a caretaker government under interim Prime Minister Anwaar ul Haq Kakar that is meant to oversee a general election. Originally, elections were to be held within 90 days of the dissolution of the lower house of parliament in August.

Israel, Saudi Arabia see progress on ties

Iran accuses the kingdom of betraying the Palestinians through US-led effort

Saudi Arabia and Israel voiced optimism Wednesday that they were moving closer to a historic normalization of ties as Iran their common foe -- accused the kingdom of betraying the Palestinians through the US-led

US President Joe Biden is hoping to transform the Middle East -- and score an election-year diplomatic victory -- by securing recognition of the Jewish state by Saudi Arabia, the guardian of Islam's two holiest

Meeting Israeli Prime Benjamin Minister Netanyahu in New York on the sidelines of the UN General Assembly, Biden quipped that he had "Irish optimism" on securing a deal with Saudi Arabia.

"If you and I, 10 ago, were talking about normalization with Saudi

Arabia, I think we'd look at each other like, 'Who's been drinking what?'" Biden -- himself a teetotaler -- said of Israel and the strictly dry kingdom.

Netanyahu, who has had rocky relations with Biden, said he believed a deal was "within our reach" and credited him.

"I think that under your leadership, Mr. President, we can forge a historic peace between Israel and Saudi Arabia," Netanyahu said.

Biden has publicly criticized Netanyahu for overhauling Israel's judiciary, a step seen by domestic critics as undermining democracy, and alluded to the concerns again as he received him in New York rather than at the

Biden's relationship has been even worse with Saudi Arabia's de facto ruler, Crown Prince Mohammed bin Salman, whom the president once vowed to treat as a "pariah" over human rights.

US intelligence says the crown prince, known by his initials MBS, ordered a 2018 operation to kill and dismember journalist Jamal Khashoggi, a US resident.

In an interview with Fox News, MBS said talks were moving forward with Israel, denying a media report that the process was suspended. "Every day

we get closer," the prince

said. But he noted the kingdom was seeking progress ensuring the rights of the Palestinians, as Netanyahu's hard-right government continues settlements

occupied West Bank. "For us, the Palestinian issue is very important. We need to solve that part," he said. "We need to ease the lives of the Palestinians."

He also warned that Saudi Arabia was closely watching Iran, whose Shia clerical leaders are arch-foes both of the conservative Saudi kingdom and Israel.

Asked how the kingdom would react if Iran develops a nuclear weapon, MBS said, "If they get one, we have to get one."

Saudi Arabia has also been seeking security guarantees, including reportedly a treaty, with the United States in return for normalizing with Israel, the region's only nuclear weapons state -- even if an undeclared

INDIA'S MANIPUR Many injured as protesters clash with police

Violence spiked once again in parts of India's Manipur valley, including state capital Imphal, as protesters clashed with police in multiple areas. Batons and tear gas shells were used and many people were injured, reports said.

US revives Cold War submarine spy program

On a windswept island 50 miles north of Seattle sits a US Navy monitoring station. For years, it was kept busy tracking whale movements and measuring rising sea temperatures. Last October, the Navy gave the unit a new name that better reflects its current mission: Theater Undersea Surveillance Command.

The renaming of the spy station at

the Whidbey Island naval base is a nod to a much larger US military project, according to three people with direct knowledge of the plans: conducting the biggest reconstruction of America's anti-submarine spy program since the end of the Cold War.

The revival of the multibillion-dollar effort,

known as the Integrated Undersea Surveillance System (IUSS), comes as China has ramped up military exercises around Taiwan, heightening concerns about a potential conflict over the democratically ruled territory, which Beijing wants brought under its control.

The IUSS revamp project has not previously been reported. It involves

modernizing America's existing network of underwater acoustic spy cables and retrofitting a fleet of surveillance ships with cutting-edge sensors and subsea microphones, moves aimed at boosting the military's ability to spy on its foes.

The United States has agreed to sell Australia similar technology to help bolster allied defenses in the Pacific region.

The most innovative change in the Navy's ocean reconnaissance system

is an investment in new technologies to miniaturize and globalize traditional maritime surveillance tools.

The original network of fixed spy cables, which lie in secret locations on the ocean floor, was designed to spy on Soviet submarines seven decades ago, the three people said.

The Navy's plan includes deploying a fleet of unmanned sea drones to listen for enemy craft; placing portable "underwater satellite" sensors on the seafloor to scan for submarines; using satellites to locate ships by tracking their radio frequencies; and utilizing artificial intelligence software to analyze maritime spy data in a fraction of the time human analysts would usually take.

Address IV saline crisis urgently

This should not have been an issue amid dengue surge

It is distressing to see how the crisis of intravenous (IV) saline, which helps maintain fluid balance in the body, has emerged as a headache for healthcare providers and dengue patients alike. This lack of an essential medicine is a problem that we could do without at a time when we are already struggling with the most severe dengue outbreak in the history of Bangladesh. Yet, thanks to a lack of timely interventions and inflated prices caused by the shortage, it has reached such a level that people in many areas have been reported to be shuttling between multiple pharmacies in search of IV saline.

The story of Khulna's Abdur Rob - a desperate father who, after failing to secure a single bag of IV saline for his ailing 13-year-old daughter at the local hospital's drug store and 14-15 other medicine shops, resorted to a middleman to manage one – is one such case that serves as a testament to the gravity of the situation. This is not an isolated incident, as our correspondents from various divisions tell us. The crisis has reached Dhaka, Chattogram, Rajshahi, Barishal, Mymensingh, Rangpur, and Sylhet as well, with the demand far outstripping available supply. Although government hospitals have received timely if rationed provisions from suppliers, it is the private hospitals and pharmacies in and outside the capital where the crisis has hit the hardest. The government has initiated plans to import two million bags of IV saline from India and also asked six drug companies to increase saline production. But this may still not be enough to make up for the shortfall.

We must stress here that the IV saline shortage is not a mere inconvenience, but a life-threatening crisis, and not just for dengue patients but cancer patients and countless others who rely on this essential medical supply. The question is, why are the authorities failing to ensure sufficient supplies? The surge in dengue cases and consequent rise in the demand for medical supplies have long been predicted by experts. Any failure to prepare accordingly or respond properly to the crisis is, therefore, unacceptable. In recent weeks, we have also highlighted how the dengue surge has been overwhelming not just hospitals, public or private, but also the availability of essential services like ICU and HDU beds, leaving patients literally gasping for air.

This must be addressed. The authorities must be able to control the spread of the dengue virus but also, equally importantly, ensure that patients get optimal care across the country. This includes greater access to healthcare facilities as well as essential medical equipment and supplies.

An inspiring case of entrepreneurship

Structural obstacles for small enterprises need to be removed

Habib Khan's success story, as reported by this daily on Thursday, is a testament to the power of entrepreneurship amid slowing growth and rising unemployment in the country. Habib left his job to pursue a career in agriculture in his village in Tangail. Then, in less than two years, he transformed his ancestral land into a profitable farm specialising in premium agroproducts. Thus, not only did he become self-reliant himself, his company now also employs 18-20 other individuals. Such efforts underscore the importance of entrepreneurship – especially the micro, small and medium-sized enterprises (MSMEs) – for our economy as it continues to struggle to create new jobs.

Youth entrepreneurship, in particular, can be hugely transformative. It can provide financial independence, create employment for others, and support peers and communities through innovative business practices and initiatives. If run and supported properly, MSMEs can be a major driver of domestic production and foreign currency earnings. However, despite some positive initiatives from the authorities and relevant stakeholders across the spectrum - such as the iDea project, a2i, Startup Bangladesh Limited, and different incubators from private organisations - small entrepreneurs in Bangladesh face various challenges including limited access to finance, lack of mentorship, inadequate infrastructure, limited access to markets, unsupportive bureaucratic processes, fragmented strategies within the ministries, and societal pressures against entrepreneurship, as a UNDP study has highlighted. As a consequence, Bangladesh ranked 132nd out of the 137 membercountries in the Global Entrepreneurship and Development Index 2020.

What we should take away from this reality is that entrepreneurship cannot thrive on its own. It needs nour ishment, training, and a supportive climate. The authorities, therefore, should take steps to create a conducive environment for entrepreneurs across all sectors. Bureaucratic red tape must be eradicated, and unrestricted access to information, financing, logistics, and technical support must be ensured. They should also remain vigilant so that small enterprises are not overrun by large market competitors across the supply chain. Local entrepreneurs need easy-to-access networks both at national and international markets. Our education system and social structure should also internalise the process of innovation and nurture future entrepreneurs with proper training and encouragement.

To become an economic powerhouse, Bangladesh must redirect its focus from low skills to nourishing skills and innovative business practices. The government must develop a comprehensive entrepreneurship ecosystem and clear all obstacles to starting and running businesses so that success stories like that of Habib Khan become common all over the country

according to the Bangladesh Labour Act, 2006, the responsibility of ensuring workers' safety lies with the employer, which refers to both the owner/s and the management of an establishment. For example, Section 61(2) of the act, which deals with the safety of buildings and machineries, states that when it appears to an inspector that the use of any building, or any part thereof

which reverberated globally.

It is, of course, a fact that too many workers died prematurely due to the extreme negligence and mismanagement by owners. And, in the Rana Plaza and Tazreen cases, although justice has not been delivered yet, at least the names of the owners were not dropped from the charge sheets as has been done in the case of Hashem Foods.

In Bangladesh, even though people often have to languish in prison for months without trial under minor defamation cases, it took only 10 days for Abul Hashem, the chairman of Hashem Foods Ltd, and his sons to get bail after 54 workers were killed in a deadly factory fire on July 8, 2021. The factory owner and his children were arrested on July 10, but all of them got bail by July 19, 2021. When the alleged perpetrators are powerful, can influence the investigation, and get bail quickly, justice might become uncertain. This is why, at the time, many observers expressed their doubts about whether or not justice would be delivered at all. It seems their concerns were justified because, two years after the incident, the Criminal Investigation Department (CID) of the police filed a charge sheet in court in which they had dropped the names of the chairman and his four sons.

However, four officials of the factory and two inspectors of the Department of Inspection for Factories and Establishments (DIFE) have been accused of the irregularities found by the CID in the investigation, including non-compliance with the original design of the factory, production of unapproved products, expansion of the factory without permission, and lack of adequate fire safety measures. It is only right that the officials concerned of DIFE are named in the charge sheet for negligence. But the fact that the owner of the factory is not being held responsible for these serious irregularities and negligence is disappointing and totally unacceptable. The investigating officer of the case claimed that as the allegations against the owner and his four sons were not found to be true, their names have been left out of the charge sheet. But how can a factory owner not be involved in the irregularities of design, the construction of the factory, and installation of fire safety systems?

Of the irregularities mentioned in the charge sheet, there are some notable ones. Firstly, two flights of stairs were constructed even though three were approved in the design. the company produced many other decisions of the owner/s. Moreover,

Workers would be surrounded by nets on each floor; stairwells used to be locked; combustible materials were kept on every floor of the accidentprone building; goods would be stockpiled on factory floors around flammable substances, and children were employed in violation of the labour law.

Could any of these irregularities and acts of negligence have been implemented by management-level employees alone, without the direct participation, decisions, and approval of the factory owner? Significant investment decisions are needed for design, construction, and expansion of a factory, and only the factory owners themselves can make these decisions. Managers and executives may even be left out of the discussion when only produce a mango juice product, a factory is to properly implement the

or any road, machinery or plant (or internal electrical system of a building) of an establishment is in imminent danger to human life or safety, they may, by an order in writing, address to the employer, prohibit its use until it is properly repaired or altered. Moreover, Section 53(3) of the Labour Rules, 2015 implies the responsibility of the owner in implementing safety measures. It states that "As per Section 61(2), if any owner fails to take certain measures directed by the inspector within the timeframe given by him/her, it will be considered a continuous offence i.e an offence being committed every day."

The responsibility of the factory owner is to ensure a safe working environment for workers, and the responsibility of government officials is to see whether the owner is complying with this requirement or not. If the owner does not ensure a safe working environment and if the government officials responsible for monitoring and supervision become corrupt and do not perform their duties properly, then the government's job is to impose appropriate fines and punishment so that more owners and officials do not seek profit through negligence and corruption.

Even though workers are being killed regularly in horrific industrial accidents due to the negligence of the factory owners of the country, the government seems uninterested in delivering a strict example for owners and supervisors. In fact, in the existing political settlement, our rulers do not have to answer to the poor, working-class majority of people, but only have to satisfy various local and preventing workers' deaths.

It's not crazy to be car-free

As the climate crisis grows ever more severe and destructive, we need strong actions to ensure climate justice. But instead, why do we continue to provide subsidies to fossil fuel use? These subsidies reached a new record in 2022, at \$13 million a minute, according to the International Monetary Fund. Yet, the burning of fossil fuels is the main cause behind the climate crisis.

Subsidising some of the world's wealthiest (and most damaging) corporations, while the poorest suffer the most from the climate crisis, is the epitome of climate injustice.

We absolutely must turn this situation around at the earliest. We must not accept paltry attempts at reducing greenhouse gas emissions while such subsidies continue. This includes, but cannot be limited to, demanding compensation for the damage the

climate crisis is causing; it must include halting such subsidies so that we can rein in the crisis before all hope of living on a habitable planet is lost.

In addition to stopping subsidies for fossil fuels, we must make serious inroads in decarbonising transport. And this won't happen through miracle technology, electric vehicles, or the chimaera of clean fuels. It would be insanely expensive to convert the world's fleet of automobiles to electric. And, in any case, much of our electricity still comes from burning coal. Supposedly "clean" vehicles still need to be manufactured using polluting processes. Pouring money into methods that allow the wealthy to continue their wasteful lifestyle while the poor struggle to fulfil their basic needs is one example of economic injustice.

What would be more just - and

what happens to be a great solution for decarbonising transport - is enabling and promoting walking, cycling, and pedal-powered rickshaws. If we reduced rather than increased the need for travel by focusing on decentralisation within cities as well as across the country, we could dramatically increase the percentage of trips that can be made on foot or by bicycle. We could further shift people's travel modes by rewarding those that are gentle on the environment and cause no GHG emissions, while making it less attractive to burn fuel to move about. Many urban trips are already quite short, but our incentive system rewards rather than discourages pollution.

Would promoting walking and cycling mean abandoning modernity? Of course not. The cities with the highest percentage of trips by bicycle are in Scandinavia and western Europe modern, cosmopolitan, desirable cities with high quality of life.

We have no choice but to make rapid and dramatic changes in the way we live. We cannot afford to do so through false promises of technological breakthroughs. We must overcome our obsession with the mobility of people and goods. By doing so, we could

dramatically increase our quality of life: less congestion, less air pollution, fewer road crashes, more peace and quiet, stronger local economies, and more resilient and friendly communities.

This year, the Carfree Cities Alliance has declared the theme of World Carfree Day (September 22) to be "Justice in Motion." The theme refers to the many ways in which car-free cities promote climate, environmental, economic, health, spatial, and social justice. The very wealthy create the highest greenhouse gas emissions and pollution: they receive subsidies from the government in the form of road infrastructure; they occupy more space (including parking their cars for free, while vendors and beggars often must pay for the space they occupy); their vehicles pose the risk of injury or even death to others, as well as destroy the peace with their constant honking. Carfree cities would dramatically increase social equality while reducing many other problems related to injustice in our cities and our lives.

While seeking to decarbonise transport and dramatically reduce the threat of the climate crisis, how about also making our cities more habitable and more just?



Thus, women resign to giving up their education, their jobs, and their dreams in order to conform to the patriarchal society they live in. Usually, they don't have a choice. And when they become mothers they continue the legacy, turning $their sons into \, entitled \, chauvinists$ who are then influenced by the male role models in their lives fathers, older brothers, peers,

religious clerics, and so on. The mothers of these entitled sons become mothers-in-law who unleash the legacy of patriarchy on their daughters-in-law - and the cycle goes on.

It is therefore hard to change people's mindsets, which have been formed through centuries of mind-control; mindsets that are allowed to flourish even while the tide of progress is rising. I that, in Bangladesh, while women have moved forward and become active drivers of development, the mindsets of the majority have stayed stagnant or even regressed into the dark ages.

Women are not allowed to reach their potential because they are constantly held back by archaic, sexist cultural perspectives that have been blended into religious narratives, making them almost impossible to be phased out. So when a misguided sporting star chooses to post sexist views that demean working women, they get overwhelming endorsement from like-minded men.

If I were to make Tanzim realise just how inaccurate those posts are, I would tell him to look around him and see who these working women are. I would tell him about Noorjahan Begum, who worked for more than 50 years as a cook because she had to fend for herself and her children after her husband remarried when she was still a teen. I would tell him about Rashida, who worked as a day labourer for years after she was widowed and had to raise her four children. I would tell him about Chameli, who saved up money from working as a domestic worker and bought two cows so that her husband, a farmhand who often refuses to work, could work them in the fields and sell them during Eid to buy food for their two daughters. I would also let him know of the thousands of women garment workers, bankers, lawyers, doctors, nurses, NGO workers, caregivers, and women in almost every sector he can think of, who go to work not only to financially support their husbands, parents, children, and in-laws, but also because they are equal citizens of an independent country and have the right to choose to work or not

What makes freelancers thrive?

In recent times, a freelancing revolution has unfolded worldwide, allowing individuals to utilise their skills and expertise to earn independently. According to freelancing platform Fiverr, a staggering 78 percent of companies were projected to turn to freelancers instead of hiring more employees in 2023. The aftermath of the pandemic has facilitated the growth of freelancers thanks to flexible policies, while prevailing skill gaps have made their inclusion indispensable. As the demand surges for adept professionals in fields like software development, digital marketing and architecture, multinational enterprises are increasingly leveraging talented freelancers. This leads us to the pivotal question for Bangladesh, a nation endowed with a young demographic dividend: can it seize the opportunities presented by the freelancing surge?

According to the Bangladesh Bureau of Statistics, the unemployment rate among youths with secondary-level education stands at an alarming 29.8 percent. In 2018, the International Labour Organization ranked Bangladesh as the second-highest in educated

650,000 freelancers, complemented by about 1,600 team-oriented freelancing entities. They earn around \$500 million each year. However, certain prevailing challenges faced by budding freelancers warrant attention.

While a host of free self-learning resources are accessible online (on platforms like YouTube) for acquiring freelancing skills, a majority of individuals still require a mentor to guide them to understand the process, sustain motivation, and attain high-level proficiency in multiple skills. Furthermore, with numerous students independently venturing into freelancing, there may be a lack of team-building skills, which is compounded by inadequate support from a closely-knit learning community.

Our freelancers struggle to adequately showcase their skills and communicate with clients on freelancing platforms like Upwork and Fiverr due to their limited proficiency in English. This is acting as a barrier, impeding their access to free courseware and other Englishbased platforms for learning. A considerable number of students lack access to high-speed internet, laptops, or smartphones, preventing them from fully benefiting from online learning resources. Furthermore. young people residing in remote areas may be completely unaware of the freelancing opportunities.

Clearly, our nation is currently

Institutions collaborating with ed-tech companies would allow youngsters to harness the extensive resources of massive open online courses (MOOCs), available to a wide audience. Universities like Harvard, Cornell, MIT and other platforms are well known for their online certification programmes in highly sought after skill areas. The government has a very critical role to play here. It should allocate funds for the digitalisation of local institutions as part of its Digital Bangladesh initiative. Policymakers must formulate well-defined policies that foster partnerships between the institutions and ed-tech entities.

Engagement with industry experts as consultants or board members is also essential, as they are well-versed in the ever-changing market dynamics. These individuals can conduct regular assessments to ensure the curriculum remains aligned with the evolving job market. At the same time, the institutions should focus on establishing a socially responsible alumni network and work towards assisting cohorts of students from disadvantaged backgrounds rise up the ladder within the next decade. Through a combination of corporate social responsibility funds and government support, universities can enhance their capacity, offer scholarships

unemployment rate among 28 countries in the Asia-Pacific region. Micro-credentials are concise, targeted credentials intended to offer sought-after skills, knowledge, and practical experience. Moreover, stackable micro-credentials can serve as a route toward obtaining a certificate or even a complete degree, whether immediately or at a later stage. To this end, the institutions ought to enlist adept professionals capable of mentoring students in sought-after domains like software development, search engine optimisation, digital marketing, content creation, graphic design, and more. Partnering with influential social media content makers can

Higher education institutions can assume a central role in training students to embrace English as a Second Language (ESL) and effectively communicate in a business context. For this, they can collaborate with many well-known ESL platforms. The Chinese government promoted foreign language education in schools through its China Education Association International for Exchange. The Bangladesh government can work in a similar fashion with the institutions to develop a cost-efficient and effective language learning system throughout the country.

While it is easier said than done, every newly devised system has its pros and cons. Nevertheless, the moment has arrived for higher education institutions to heed this wake-up call and overhaul their current educational approach, prioritising a promising future for our youth.

Third-party funding in arbitration

Such a time demands that the legislation adapt with the growing needs of the economy to propel Bangladesh into the territory of investments in arbitration proceedings and a favourable hub for conducting arbitration proceedings.

Third-Party Funding is funding process by which a third-party financer lends capital to a party in a suit in exchange for a percentage share of the probable award on the outcome of the case. Third-party funding is a mechanism through which individuals who cannot afford the high costs associated with litigation or arbitration, can gain access to justice. More recently, this mechanism has turned into an avenue for large corporations to place their capital as investments. In India, third-party funding has been gaining traction in the last few years due to its potential to level the playing field between parties to a dispute.

Like in most jurisdictions that follow the common law system, the doctrines of champerty and maintenance banned third parties from financing proceedings in India as well. Over the years, these principles have been nullified by Indian Courts over the course of various occasions. One of the most notable developments was the Supreme Court of India's judgement in the case of Mr. G. A Senior Advocate in 1954. The Court held that the rigid principles of champerty and maintenance are not applicable to Indian laws, and any agreement for third-party funding a proceeding is not against public policy and shall be permitted. The Law Commission of India in 2017 proposed that third-party should be permitted in India. The only stipulated

condition is that advocates representing the parties must not be funding the proceedings as the Bar Council of India has specifically barred advocates from accepting a fee based on the outcome of a particular proceeding.

The Delhi High Court in 2023 in the case of Tomorrow Sales Agency Pvt. Ltd. v SBS Holdings held that a third-party financer cannot be held liable for the adverse costs imposed on a party when it was not a party to the arbitral proceedings or the arbitration agreement. The Court went on to state that "third-party funding is essential to ensure access to justice". Further, the England and Wales High Court in the case of Gulf Azov Shipping Co Ltd & Ors v Idisi & Ors held that "public policy now recognises that it is desirable, in order to facilitate access to justice, that third parties should provide assistance designed to ensure that those who are involved in the litigation have the benefit of legal representation".

As for Bangladesh, the Contract Act 1872 clarifies that in cases where the consideration or object of any contract is forbidden by law, defeats the provisions of any other law or is fraudulent, it is held immoral or opposed to public policy. The doctrine of champerty falls under this scheme of public policy and hence renders third party funding agreements as void. While there is no express ban on thirdparty funding agreements, the economic and social landscape having changed drastically over the years demands a shift in the policy with regard to third party funding. It can be argued that third party funding agreements upholds public policy, considering the benefits provided in financing claims for people who cannot afford bearing the high costs associated with litigation or international arbitration.

Since Bangladesh is one of South-Asia's fastest growing economies due to the rise of foreign direct investment, one inevitable consequence of this is the rise in claims with reference to contractual disputes. Such a time demands that the legislation adapt with the growing needs of the economy to propel Bangladesh into the territory of investments in arbitration proceedings and a favourable hub for conducting arbitration proceedings. The lack of express provisions regulating third party funding is preventing parties from entering this market due to lack of legal certainty. While countries like Singapore and Hong Kong have amended their respective laws governing arbitration to accommodate third party funding agreements, it is imperative for Bangladesh to follow suit for it to be the preferred location for resolution of international disputes.

Legal framework on Hindu marriage in Bangladesh

Marriage is considered to be a sacrament or samskara according to Hindu shastra. In this write-up, different aspects of Hindu marriage will be discussed in light of Bangladeshi legislation, case laws, and customs. First, there are some ceremonies that must be performed for a Hindu marriage to be valid, such as saptapadi, i.e., seven steps by bride and bridegroom, and vivaah homa, i.e., invocation before the sacred fire. In Amulya Chandra Modak v State (1983), the man subsequently denied marriage that was performed only by exchanging garlands. The Supreme Court of Bangladesh held that there was no valid marriage due to the absence of the required ceremonies.

After independence, Bangladesh made no statutory laws exclusively dealing with Hindu personal law except the Hindu Marriage Registration Act 2012. Section 3(1) of the Act made the registration of Hindu marriages optional. However, non-registration in case of Hindu marriage is not an offence. Pertinent to note, in case of Muslim marriages, non-registration, while has no effect on the validity of the marriage itself, is still a punishable offence.

As per section 2(c) of the Act, Hindu marriage means all approved forms of Hindu marriages. It can therefore be argued that it is now immaterial

whether the saptapadi or vivaah homa are performed or not as the Act of 2012 overrides the decision of Amulya Chandra Modak case. According to the Hindu shastra, inter-caste marriage is not permitted in Bangladesh. But there are some regions where inter-caste marriage is practiced by custom. Since the Act of 2012 also includes Hindu marriage by custom as a valid marriage, it can also be argued that inter-caste marriage is also allowed per law in Bangladesh. Child marriage is allowed under traditional

Hindu law. However, marriage between a male and female who have not attained 21 and 18 years, respectively, is prohibited and punishable under the Child Marriage Restraint Act 2017 (CMRA). Section 7 of the CMRA prescribes punishment for contracting child marriage, which may extend to 2 years imprisonment or fine extending to 1 lakh taka, or both. Moreover, child marriage cannot be registered according to section 5 of the 2012 Act. Furthermore, polygamy in Hindu marriages is still allowed in Bangladesh, whereas polyandry is prohibited. In India, as per the Hindu Marriage Act of 1955, polygamy is prohibited. Though a wife cannot marry twice at the same time,

after the death of her husband, she may remarry. Section 1 of the Hindu Widow's Remarriage Act of 1856 validates it. However, in such a case, the wife will not be entitled to the property of her deceased husband if

she remarries. And lastly. case dissolution marriage, Hindu marriage cannot d i s s o l v e d under circumstances in our country. The idea and nature of marriage as

'indissoluble' remain in

Bangladesh, though it has been made 'dissoluble' as a civil contract in India. A married woman can however seek separate residence and maintenance under the Hindu Married Women's Right to Separate Residence and Maintenance Act

As mentioned, Bangladesh does not have a codified Hindu marriage law like India.The problems as highlighted above arise because of this reason. It is therefore imperative that relevant issues be resolved through enactment of a single comprehensive legislation.

According to a report published by Bangladesh Bureau of Statistics (BBS) in 2020, the number of female-owned SMEs in Bangladesh was 2.8 million, which is around 24.6% of the total number of SMEs in the country. Corrupt people, not AL, running the country

Claims BNP, party leaders allege obstruction during road march in Sylhet

BNP standing committee member Amir Khosru Mahmud Chowdhury has claimed that the country is being run not by the Awami League government, but by corrupt government officials, law enforcers and businesspeople.

The opposition party held the 60-km road march to press nome its one-point demand -- resignation of the government and general elections under a non-party interim government.

The convoy of the BNP leaders and activists left Bhairab of Kishoregani district at 11:30am. It reached Sylhet city around 7:45pm via Bishwa Road intersection in Brahmanbaria, Shaistaganj in Habiganj and Sherpur in Moulvibazar.

New Delhi yesterday said it is seeking the reduction of Canadian diplomatic staff in India and has stopped visa services, as a row over the killing of a Sikh separatist deepens.

Canadian Prime Minister Justin Trudeau has demanded India treat with "utmost seriousness" allegations that Indian agents played a role in the June murder of Hardeep Singh Nijjar near

The fallout prompted tit-for-tat diplomatic expulsions and a forceful denial from India, which said any suggestion it played a role in Nijjar's killing was "absurd".

The allegation has sent already strained relations between the world's most populous country and G7 member Canada to a new low.

We have informed the Canadian government that there should be parity" in diplomatic presence, Indian foreign ministry spokesman Arindam Bagchi told reporters.

"Their numbers here are very much higher than ours in Canada... I assume there will be a reduction.'

New Delhi also said it had stopped handling visa applications in Canada, blaming "security threats" which they said were "disrupting" the work of their officials.

"For now, the security situation in Canada and because of Canadian government inaction, we have stopped visa services temporarily", Bagchi said.

Hours earlier, Canada's High Commission

said it would "adjust" diplomat numbers in India after "threats on various social media" against

their staff. "In light of the current environment where tensions have heightened, we are taking action to ensure the safety of our diplomats," Canada's mission said in a statement.

"As a result, and out of an abundance of caution, we have decided to temporarily adjust aff presence in India.'

On Monday, Ottawa expelled a diplomat described as the head of India's foreign intelligence service in Canada, prompting New Delhi to order a Canadian diplomat to leave.

The suspension of visas comes a day after India's foreign ministry said it was concerned for the safety of its citizens in Canada because of "politically-condoned hate crimes and criminal violence".

Nijjar was shot dead by two masked assailants outside the Sikh temple he presided over in Surrey, a suburb of Vancouver.

An activist for the creation of a Sikh state known as Khalistan, Nijjar was wanted by Indian authorities for alleged terrorism and conspiracy to commit murder.

He had denied those charges, according to the World Sikh Organization of Canada, a nonprofit organisation that says it defends the interests of Canadian Sikhs.

World's oldest wooden structure found in Zambia

Archaeologists have unearthed the oldest wooden structure ever discovered, dating from nearly half a million years ago, which suggests that our ancestors may have been more advanced than

The exceptionally well-preserved wooden structure was found at Kalambo Falls in the north of Zambia near the border with Tanzania.

It dates back at least 476,000 years, well before the evolution of Homo sapiens, according to a study describing the find in the journal Nature.

The wood bears cut-marks showing that stone tools were used to join two large logs to make the structure, which is believed to be a platform, walkway or raised dwelling to keep our relatives above the water.

A collection of wooden tools, including a wedge and a digging stick, were also discovered at the site. The ancestors of humans were already known to use wood at this time, but for limited purposes such as starting a fire or hunting.

RIGHTS VIOLATION Int'l watchdog puts Bangladesh on watchlist

Global watchdog CIVICUS Monitor yesterday added Bangladesh to its watchlist of countries experiencing rapid declines in civic freedoms.

The Johannesburg-based civil rights group, dedicated to strengthening citizen action and civil society worldwide, accused the government of being willing to go to any lengths to crush dissent. This includes targeting supporters of the opposition BNP and attempting to silence activists and journalists through legal and other means.

"Bangladesh is going down a dangerous path," Josef Benedict, Asia Pacific researcher for CIVICUS, said in a written statement.

"We have seen the authorities ramp up repression of the opposition, activists, and critics with impunity. To ensure credible elections in January, the government of Prime Minister Sheikh Hasina must respect fundamental freedoms, including the right to protest and speak freely, and ensure a safe and peaceful environment for all political parties to operate," he said.

Rain spoils first ODI

Bangladesh fielded a second-string eleven against New Zealand yesterday in a bid to gauge them ahead of the ODI World Cup in India next month but the first of the three-match ODI series was washed out due to incessant rain.

The game was reduced to a 42-over-a-side contest after the first rain-induced break. New Zealand reached 136 for five in 33.4 overs before rain halted proceedings again and the game could not be resumed further.

The Tigers, under the leadership of stand-in captain Liton Das, are missing a total of seven regular starters for the series, including regular skipper Shakib Al Hasan.

The match, however, was the first game for Tamim Iqbal in Bangladesh colours after stepping down from captaincy in August while another experienced campaigner, Mahmudullah Riyad, retrurned to the national fold after being dropped in March.

Bangladesh dominated yesterday, with Mustafizur Rahman removing Finn Allen and Chad Bowes early. Mustafizur also ended a 97-run stand between Will Young and Henry Nicholls before Nasum took two scalps to give Bangladesh back the momentum in the game.
