BARIND FARMERS

At mercy of 'water lords'

On April 9, Mukul Soren, a Santal farmer in Rajshahi, drank pesticide in a suicide attempt over not getting irrigation water from the same deep tubewell that allegedly led to the suicide of two farmers, also Santals, last year.

All three were fed up with the exploitative system of irrigation water distribution in parts of the Barind region.

The Barind region, known as the rice bowl of Bangladesh, faces a great catastrophe with its groundwater levels depleting fast. In this water-stressed region, irrigation tubewells have now become a tool for the people with political clout to exploit farmers.

A significant number of these farmers belong to ethnic minority communities and is therefore more vulnerable to exploitation.

Last year, Abhinath Mardi, 36, and his cousin Robi Mardi, 27, died by suicide in Godagari of Rajshahi allegedly after the local tubewell operator refused them the irrigation water they were entitled to,

After public outcries, police arrested and pressed charges against Shakhawat Hossain, the tubewell operator.

Barind Multipurpose Development Authority (BMDA), the government agency responsible for overseeing irrigation in the region, replaced Shakhawat with a new operator, Hashem Ali Babu. But there seems to be no respite from the exploitation by the operators, appointed by the BMDA.

It was the same tubewell in Rajshahi's Issoripur village that drove Mukul, 35, to make an attempt on his own life. Unlike the Mardi cousins, Mukul survived as he was swiftly taken to a hospital.

"Water scarcity pushed me to the brink after I could not irrigate my land for eight days during peak irrigation season," Mukul told The Daily Star

'The tubewell operator then called me one dawn, promising me irrigation water. I went there around 5:00am. But he kept me waiting till afternoon and SEE PAGE 2 COL 1

Now Fitch has negative outlook on Bangladesh

Stops short of rating downgrade

Bangladesh's credit rating came under further threat yesterday as Fitch put the country on a "negative" outlook while giving a damning verdict on the central bank's policy response to the fast-depleting foreign currency

The American rating agency maintained Bangladesh's BB- rating but warned that the outlook was now negative rather than stable, mirroring the action taken in July by its peer Standard and Poor's.

By the end of 2023, Fitch estimates the foreign currency reserves will be sufficient to meet three months' import bill, which is lower than the 'BB' median of 4.4 months. And in the next fiscal year, the import cover will come down to about 2.6 months.

Fitch estimates that gross reserves fell by 19 percent in the first nine months of the year.

billion, enough to meet four months' import bill at best, as per the latest published data by the Bangladesh Bank.

We forecast foreign exchange reserves to stay under pressure, driven by rising imports and foreign currency intervention by the central bank," Fitch said.

The negative outlook reflects a deterioration in external buffers, which has increased vulnerability to shocks.

"It also reflects our view that the country's incremental policy response, including exchange rate system changes, and continued support from external official creditors, has been insufficient to stem the fall in foreign reserves and resolve domestic US-dollar liquidity strains," it added.

Earlier in May, Moody's downgraded Bangladesh's long-held credit rating on the same concerns over the country's external position after monitoring the situation for about six months.

The foreign exchange reserve outlook is challenging, amid a still-managed exchange rate, elevated oil prices and a further relaxation of import restrictions, which will widen the current account deficit through to 2025, Fitch said.





US VISA POLICY Image of police won't be affected **Says IGP**

the US visa policy won't affect the image of the force.

He said this while talking to reporters after attending a seminar at Tourist Police headquarters in the capital's Paltan area.

On Friday, the US State Department said it was taking steps to impose visa restrictions on Bangladeshi individuals responsible for, or complicit in, undermining the democratic election process in Bangladesh.

AZERBAIJAN'S VICTORY OVER KARABAKH Thousands of ethnic Armenians flee enclave

Thousands of ethnic Armenians fled the breakaway region of Nagorno-Karabakh yesterday, queuing up for fuel and jamming the road to Armenia after their decades-old separatist state was defeated by Azerbaijan in a lightning military operation.

The leadership of the 120,000 Armenians who call Karabakh home told Reuters on Sunday that they did not want to live as part of Azerbaijan and that they would leave for Armenia because they feared persecution and ethnic cleansing.

In the Karabakh capital, known as Stepanakert by Armenia and Khankendi by Azerbaijan, crowds of people were loading belongings into buses and trucks as they left for Armenia.

Refugees who reached Armenia told Reuters they believed the history of their breakaway state was finished. "No one is going back - that's it," Anna Agopyan, who reached Goris, a border town in Armenia, told Reuters. "The topic of Karabakh is over now for good I think.'

Srbuhi, a mother of three who reached Armenia, shed tears as she held her young daughter. "I left everything there," she said.

The Armenian government, making preparations for thousands of refugees, said that as of 1300 GMT yesterday, at least 6,650 people from Nagorno-Karabakh had crossed into Armenia.

The ethnic Armenian leadership said it would remain in place until all those who wanted to leave what they call Artsakh were able to go.

Since the breakup of the Soviet Union, Armenia had relied on a security partnership with Russia, while Azerbaijan grew close to Turkey, with which it shares linguistic and cultural ties.

Thai police arrest 7 'Bangladeshis' for illegal entry

Thailand police have reportedly arrested seven Bangladeshi men for entering the country illegally.

They posed themselves as Buddhist monks to evade immigration's radar and were nabbed in the southern province of Songkhla, reports The Pattaya News. Their ultimate destination was Malaysia, it added.

Songkhla immigration police, in collaboration with Hat Yai tourist police, arrested them on Saturday based on a tip-off.

They were charged with illegally entering the country, according to the report.

A 46-year-old man identified as Rupdah

admitted to being the leader of the group. Investigators determined that all seven men had

entered Thailand illegally through a natural route from Myanmar after having started their journey from Bangladesh, according to The Pattaya News.

They were intending to travel to Narathiwat and subsequently planned to continue on to Malaysia. During the search of their belongings, it was

discovered that the men were in possession of all regular clothing and lacked any monk identification documents.

They were transferred to Hat Yai Police Station, where they will remain until they are deported to Bangladesh, the report says.

Man gets death penalty for rape, murder

A Narayanganj court yesterday sentenced a man to death in a case filed over the rape and murder of a 6-year-old girl in Araihazar upazila two years ago.

Judge Nazmul Haque Shyamal of the Women and Children Repression Prevention Tribunal announced the verdict in presence of the convict, Naimur Rahman alias Nayeem, 35, of Barguna's Latabaria area.

The convict was awarded an additional five years in jail for hiding the girl's body after the murder, said Public Prosecutor Rakibuddin Ahmed.

The convict was also fined Tk 20,000, he added. According to the case statement, on September 23, 2021, Nayeem, who lived in a rented house next to the victim, abducted the girl and raped her in his place, before murdering her and hiding her body.

A day later, a case was filed with Araihazar Police Station when her body was recovered wrapped in a quilt under the bed of the convict in his house.

Things started changing in the 1990s when the Barind Multipurpose Development Authority (BMDA) introduced deep tubewells, enabling farmers to cultivate three crops annually and transforming the northwest into a thriving grainproducing hub.

Following the BMDA's lead, private individuals, including affluent farmers and businesspeople, began installing their own deep tubewells, contributing to the region's agricultural and industrial water region's supplies.

Although the BMDA stopped installation of any new deep tubewells in 2012 and shifted its focus to surface water sources, unregulated private tubewell operators continued to thrive, exerting a significant impact on the Barind's already dipping water

The irony is while the Barind contributes to the nation's food security through bountiful rice harvests, it is the very success of these crops that exposes the region to a grave water crisis.

In 2021, the average depth of groundwater level was 18 metres in much of Rajshahi, Naogaon and Chapainawabganj, the three districts that are among the most affected by depleting groundwater levels, WARPO data show

A recent estimate by BMDA shows around 70 percent of the Barind region's annual groundwater extraction, totaling 137,100 crore litres, is attributed to the private deep tubewells. At an estimated rate of 250 crore litre per day, this water could meet Dhaka city's water demand for one and a half years (548 days).

These private tubewell operators along with the ones appointed by BMDA have developed a system that is designed to exploit poor farmers using their influence and political link.

"It's the same vicious cycle no matter which party is in power. During the BNP-Jamaat regime, the operators were from the two parties. After the changeover in 2009, Awami League men and their associates now run the show," said Bimol Rajoar, president of Rajshahi chapter of Jatiya Adivasi Parishad.

BMDA Executive Director Abdur Rashid acknowledges this.

"Upon receiving complaints from farmers, we have terminated some operators. However, the problem seems to persist as they have political connections. We are looking into it," he said in a video interview

EXPLOITING A GOOD INITIATIVE

Barind farmers have been receiving relied on surface and rainwater for irrigation water under BMDA irrigation, according to a recent management since its inception in 1992. For this, they have to pay a nominal charge, which is now Tk 85-125 per hour of irrigation.

In 2005, the Barind authorities introduced pre-paid metre system replacing the paper coupon system to save water and stop financial exploitation of farmers by private tubewell operators, according to BMDA website.

Currently, there are 16,000 government-run and 56,000 privaterun irrigation deep tubewells covering 16 districts of Rajshahi and Rangpur divisions. More than half of the tubewells are in Rajshahi, Naogaon and Chapainawabganj, according to BMDA sources.

"When we go to ask for irrigation water against our prepaid cards, the operator delay our turn by hours, sometimes supplying the water late into the nights. We have to remain awake at night to get water," said Gopal Soren from Borsapara village.

Under BMDA's Irrigation Policy of 2008, cash transactions are prohibited, and it can lead to cancellation of dealership.

"Those who can pay more, get more. That's their entire business model," said Abu Bakar, a farmer of Bijaynagar village.

At least 40 farmers from Shankarpur and Mohor villages in Rajshahi's Tanore upazila told The Daily Star that to avoid harassment, they agreed to pay the operators Tk 1.500-3,500 per bigha so they get irrigation water on time.

Who is to blame for Bhuban's death?

But she had already fallen asleep. Who would have thought that this would be his last call to his family?

We can feel the tragedy of Bhuban's death when we see the grief-stricken faces of his wife, daughter, and other relatives who had gone through a week of agonising wait, hoping and praying that somehow he would survive.

We can commiserate with them paralysing fear of getting the bad news.

But why must our lives be so precarious? Why should we be at risk of getting shot or stabbed just

streets? Where were the police when criminals decided to carry out an assassination in such an important area of the city? Who is ultimately responsible for such deaths?

Perhaps it is our absurd level of compromising with the injustice that come to know that just before leaving has resulted in yet another "unnatural death" as Bhuban's would be officially labelled.

Perhaps it is because our cries for help when we are attacked on the streets fall on deaf ears, sometimes even when law enforcers are nearby

Our state is obligated to protect our right to life, as guaranteed by our constitution. And it is mainly through its law enforcement agencies that this obligation can be carried out.

While we expect them to identify the killers and bring them to justice, we also await a stronger presence of law enforcers on the streets during the night, especially in areas that have been identified as crime hotspots.

The authorities must take all measures to ensure minimal security for all city dwellers. We cannot accept any more such "unnatural deaths" as Bhuban's.

Six persons, including five of a family, fell ill after inhaling smoke from a fire that broke out at a plastic shop in Dhaka's Lalbagh area yesterday. They were taken to National Institute of Burn and Plastic Surgery.

They are: house owner Jakir Hossain, 65, his wife Taslima Hossain, 62, their son Md Rafi, 39, daughter-Tahsin Karim in-law Anika, 30, grandchild Zyna Hossain Afrin, 13 and house help Maksuda Begum, 60.

Fire service officials said the family lived on the second floor of a threestorey building, which housed the plastic shop on the ground floor.

They were at home when the fire originated at the shop around 1:30pm. As black smoke engulfed the building, they took shelter on the roof. Locals rescued them using a ladder from the nearby building, Md Badsha, a neighbour, said.

The home ministry has requested the public administration ministry to approve more in-situ posts of additional inspector general and deputy inspector general of police.

In-situ post means police personnel who hold the same position and perform the same duties after their promotions.

The move came amid commotion

after public administration ministry approved only 52 posts against the home ministry's proposal of 189 posts of Addl IGP and DIG. The posts approved by the public

administration ministry are two posts of Addl IGP (Grade 2) and 50 posts of DIG; along with 140 posts of Addl DIG and 150 posts of SP. It sent the proposal to the finance ministry on September 19 for approval.

After scrutinising a Police Headquarters proposal, the home ministry in July forwarded a proposal

to create 15 Grade 1 posts of Addl IGP, promotion in the posts of Addl DIG 34 Grade 2 posts of Addl IGP, 140 posts of DIG, 150 posts of Addl DIG and 190 posts of SPs for one year.

ROHINGYA REPATRIATION Dhaka waiting for Naypyidaw to engage int'l volunteers

Dhaka is waiting for Naypyidaw to engage international volunteers in the process of Rohingya repatriation and humanitarian assistance before taking the next steps, said foreign ministry officials.

During the official-level meeting between Myanmar and Bangladesh on September 4 Myanmar officials agreed to involve international volunteers, including those from the UN and ASEAN countries, in the repatriation process.

In the meeting, the two countries also agreed that a Myanmar delegation would visit the Rohingya camps in Cox's Bazar as part of confidence building measures so that they are convinced to return to Myanmar. Also, a Bangladesh delegation would visit Rakhine of Myanmar before starting the repatriation by October.

Two attempts of repatriation -- one in 2018 and the other in 2019 -- failed as Myanmar could not meet the Rohingyas' demands for guarantee of safety, citizenship, and ethnicity recognition.

"The schedule of the Myanmar delegation is yet to be finalised. Initially, we thought of arranging the visit by September, but we are waiting to see how Myanmar is engaging the international volunteers," a foreign ministry official told this correspondent on September 24.

A FOREIGN MINISTRY OFFICIAL

According to the officials, Rohingyas demand to return to their original residences in Rakhine State, not to the camps. Myanmar officials also agreed to this.

Chinese Special Envoy for Asian Affairs Deng Xijun, who visited Dhaka on August 1 this year, also confirmed this matter.

Under Chinese mediation, Bangladesh and Myanmar have been working to implement a pilot project of repatriating at least 3,000 Rohingyas to Myanmar. Initially, the repatriation was supposed to start before monsoon this year, but that did not happen. Now, they want to start the repatriation by October. Engagement of the UN, ASEAN or other international aid agencies in the repatriation process and humanitarian assistance is among some of the basic conditions that need to be met, officials said.

"We know that there is a tripartite memorandum of understanding among the Myanmar government, UN Refugee Agency and UNDP. The MoU expired in March this year and is yet to be renewed," an official said.

"Renewal of the MoU would be a sign showing Myanmar's willingness to engage the international volunteers," he added.

DEATH OF PATIENT AT NICVD

Family 'assaulted' by Ansar members

Probe body formed; 1 Ansar member suspended

Family members of a critical patient at the National Institute of Cardiovascular Diseases (NICVD) were allegedly beaten by Ansar security personnel on Sunday night.

They were trying to enter the hospital's coronary care unit with a bag of blood to save one Tanjina Akter, 40. The family claims they had already paid Ansar members for access to the facility earlier that day, but were asked for money again. A dispute ensued, leading to an altercation, and by the time they reached the CCU unit with the much-required blood, Tanjina had already passed away.

She died at the hospital around 11:55pm, according to her death certificate.

Selim Reza, husband of the deceased, said Tanjina was admitted to the hospital on Saturday after she felt unwell. After she had a heart attack on Sunday, she was shifted to the CCU.

"The doctor told us to arrange blood. My younger son Tanzil Akter Nayan first entered the CCU to see his mother, after paying money to Ansar members. After some time, when I tried to enter the CCU with the blood, the Ansar members obstructed me and demanded money again," he said. "Then my son came back to the spot and

protested. So the Ansars' started slapping him," Selim claimed. He alleged that at least 20 Ansar members and staffers of the hospital beat up six of his family members.

He said the incident was captured on the hospital's CCTV footage. He said they wanted to file a case, but Sher-e-Bangla Nagar Police asked for names of the Ansar members instead. Later they lodged a written complaint.

Meanwhile, a hospital staffer said as the patient's family members tried to enter the CCU by force, the Ansar members obstructed them, and one family member hit Ansar member Rabiul on his head, which resulted in a clash.

NICVD authorities formed a five-member body to investigate the incident and asked it to submit a report within five working days. They also suspended an Ansar member, Rabiul Islam, over "misbehaviour".

NICVD Director Dr Mir Jamal Uddin did not respond to phone calls for his comment in this regard.

Contacted, Utpal Barua, officer-in-charge of the police station, said, "If the family comes to file a case, we will register it."





FLASHFLOOD AFTER RAINFALL IN DINAJPUR

Over 1,000 families marooned

Following downpour in the last two days, swelled up rivers have inundated the lowlying areas in Dinajpur Sadar upazila and the vicinity of the district town, leaving over 1,000 families marooned amid flash flood

The affected people took shelter on the highlands on both sides of the Punarbhaba river, which flows through Dinajpur town.

Officials of Water Development Board in Dinajpur said the water levels of Punarbhaba, along with other rivers in Dinajpur, started to rise after the torrential rain that started from Saturday.

The Met office in Dinajpur recorded

around 370mm rainfall since Saturday.

WDB officials said Punarbhaba was flowing 9-cm above the danger level till vesterday afternoon, while water levels of other rivers including Atrai and Tangor were also rising.

Visiting different places in Dinajpur town yesterday, this correspondent found a large number of people marooned in Hathatpara, Golapbagh, Lalbagh, Santinagar, Mazadanga, Ramnagar, Chawkchawka, areas surrounding Dinajpur Central Bus Terminal, and Maljhar village under Biral upazila as the areas were flooded after the Punarbhaba

Mozibar Rahman of Shantinagar area said water started flooding the area on Sunday afternoon and got into the houses

Around 250 families in the area were marooned. Many of them took shelter on a nearby road which is on higher ground, Mozibar added.

"We have been starving with our family as most earning members could not work in the last three days," said Mamunur Rashid of Golapbagh area.

"We are yet to get any relief support," he added.

On August 27, the victim filed the case with Uttara Paschim Police Station, accusing Chen and his local female accomplice, Hira Chakma.

The next day, the two were sent to jail after police arrested them in Uttara. On August 29, a Dhaka court rejected his bail petition.

According to case documents, Hira promised to send the victim to China and took her to Ji Chen's house in Uttara on August 25 night. Chen on August 26 raped the victim while Hira assisted him.



'MRITTIKA MOHEY'

The homebound call of a travelling artist

The beautiful landscapes and natural beauty of Bangladesh have served as the muse for travelling artist Karu Titas. In his tireless pursuit of capturing the country's natural and cultural heritage, he frequently embarks on journeys across the country to seek inspiration for his artistic creations.

The artist's fifth solo exhibition, titled Mrittika Mohey (The Allure of The Earth), is currently on display at the Shilpangan Gallery in the capital's Dhanmondi 27. This exhibition is a continuation of his artistic exploration of connecting with the essence of Bangladesh, deeply rooted in every layer of its earth.

The title of the exhibit, "Mrittika Mohey", signifies a homebound call of one's root and the mystifying allure of it. It suggests that the destination is merely an illusion of completion, while the true significance lies in the journey itself.

Landscapist Karu Titas possesses a unique talent for portraying simple yet scenically captivating characters and objects in a way that presents more questions rather than answers, more contention than beauty.

Much like his influence, S M Sultan, he too employs indistinct and hazy brush strokes to depict the bold characters

Karu emphasises uniqueness of Bangladesh. "Bangladesh is a land of wonder. You see...in my experience as a travelling artist, I found that our language, culture, dialects, and accents change in every 50

In response, the painter said, "Of course! There's no doubt about it. It's high time we turn inward and reconnect with our villages and natural resources to remind ourselves of who we were and who we can be!"

Another recurring element in his painting is the representation of 'ordinary' people, woodsmen to oarsmen, from farmers to fleeting figures, seamlessly blending with the forestry and earthen lines along the borders of his artworks.

"Take the premises of one of my paintings, namely, Prantik Manus. I met these individuals in North them, engaged in conversations. When I returned to my studio, I couldn't resist painting them, for they have such great influence on me," the enchanted artist said.

"Whenever I stay at train stations, or boats, and share meals with these people, I feel more grateful to be a part of their world with each experience. This is what I strive to capture in my paintings, and it remains my greatest muse of inspiration," he continued.

Karu Titas humbly refrains from describing himself as just an artist. "I don't like to label myself as an artist because artistry is vast, and no one can truly confine themselves to it. If any of my paintings stand the test of time, I will be forever grateful as a painter."

While Karu Titas's subject matter may resonate with the legendary artist S M Sultan, his representation diverges from Sultan's bold emphasis on human strength to focus on the innate beauty of his subjects.

Responding to this comparison, Karu Titas replies with a contented smile, "As a family, we were actually close to S M Sultan. We hosted him in the city numerous times, and we visited Narail, where I watched him create his masterpieces. It was enchanting."

The exhibition showcases Karu Titas's paintings, mostly created between 2019 and 2023. Striking Hollywood writers reach tentative deal with studios

The 78-year-old former prime minister has been suffering from various ailments, including liver cirrhosis, arthritis, diabetes, kidney, lung, heart, and eye problems.

Since her conditional release in 2020, the BNP chief has been receiving treatment at Evercare Hospital under a medical board.

On February 8, 2018, Khaleda was sent to the Old Dhaka Jail after a lower court sentenced her to five years imprisonment in the Zia Orphanage Trust corruption case. Later, she was found guilty in the Zia Charitable Trust corruption case the same year.

On March 25, 2020, the government temporarily freed Khaleda Zia from jail through an executive order suspending her sentence with the condition that she would stay in her Gulshan house and not leave the country.

JAB AT CHINA Biden recognises two Pacific nations

AFP, Washington

President Joe Biden said the United States officially recognised the Pacific nations of Cook Islands and Niue yesterday, as he hosted regional leaders in a bid to wrest influence from China.

The announcement came at the start of a summit with the 18-member Pacific Islands Forum, where US officials said the president was announcing a assertive American stance in the region.

Biden said in statements Washington recognised the Cook Islands and Niue as "sovereign and independent" states and would establish diplomatic relations with both.



The move would help maintain a "free and open Indo-Pacific region," said Biden.

Biden added that the deals to recognise the two nations would also help curb illegal fishing, deal with climate change in a vulnerable region and boost economic growth.

The Cook Islands and Niue together have fewer than 20,000 inhabitants but constitute a sprawling economic zone in the South Pacific. Both are self-governing nations in "free association" with New Zealand.

After decades of being treated as a relative backwater, South Pacific has become an important arena for competition between the US and China.

Russian strike damages Odesa port infrastructure

Ukraine says Russian Black Sea fleet commander killed in attack

An overnight Russian air strike on the southern Ukrainian region of Odesa caused "significant damage" to port infrastructure and destroyed some grain storage facilities, Ukrainian officials said yesterday.

INTERNATIONAL

No deaths were reported in the attack on Odesa, but at least one person was killed in a separate Russian air strike on the town of Beryslav in the southern region of Kherson region, regional governor Oleksandr Prokudin said.

"Another massive attack on Odesa! ... The attack resulted in the destruction of grain storage facilities and significant damage to the seaport," Economy Minister Svyrydenko, economy minister, said on X.

Pak ex-PM Imran moved to a prison with better facilities

Pakistani authorities were preparing to move former prime minister Imran Khan to a prison with better facilities near the national capital Islamabad after a court order, his party said yesterday.

His legal team and party had been pleading with several courts to issue orders for Khan to be shifted to Adyala Jail in garrison city of Rawalpindi, which they argued was more appropriate for a former premier.

"Arrangements are taking place," Khan's close aide Zulfikar Bukhari said in a message to journalists, referring to preparations to move the former premier after Khan's lawyer, Naeem Panjutha, said a high court in the capital had ordered the move.

Panjutha later wrote on social media platform X that Khan had been moved to the new prison but then deleted that post.

Khan has been detained in a low-key, colonial era prison in the northwestern Attock district that lacked facilities like attached bathroom and television and made it harder for family and friends to visit or send newspapers, books or food.

INDIA-CANADA ROW

Punjab's Sikhs fear backlash from diplomatic spat

A bitter row between India and Canada over the murder of a Sikh separatist is being felt in Punjab, where some Sikhs fear both a backlash from India's Hindu-nationalist government and a threat to their prospects for a better life in North America.

Hardeep Singh Nijjar, a plumber who left the north Indian state a quarter-century ago and became a Canadian citizen, was shot dead in June outside a temple in a Vancouver suburb where he was a separatist leader among the many Sikhs living there.

Canadian PM Justin Trudeau said last week Ottawa had "credible allegations" that Indian government agents may be linked to the killing.


In the village of Bharsinghpura, Hardeep's uncle, Himmat Singh Nijjar, 79, said locals "think it was very brave of Trudeau" to accuse Prime Minister Narendra Modi's government of potential involvement in the killing. The elder Nijjar said he is worried about deteriorating relations with Canada and declining economic prospects in Punjab.

The Philippines said yesterday it executed a "special operation" to remove a floating barrier installed by China at a prime fishing patch in the South China Sea, a move that could stoke tension after a years-long detente in Asia's most disputed waters. The Philippines expressed outrage on Sunday and

Stop this charade of price control

Why expect different outcomes with the same flawed policy?

With prices of essential goods long having spiralled out of the reach of ordinary people, we are frustrated that the government's approach to stabilise the market continues to be short-sighted and ineffective. On September 15, the government fixed the prices of eggs, onions and potatoes as part of a bid to contain the runaway food inflation (which hit a 12-year high in August). But according to our report, none of these items are being sold at the set prices. This comes as no surprise to us – and it shouldn't to the authorities either - as the government's past attempts at price control have repeatedly fallen short of expectations, providing financial windfalls to market syndicates instead.

For instance, every year, the government fixes rawhide prices ahead of Eid-ul-Azha, and every year without exception, traders violate that cap, citing various reasons. In the agriculture sector, too, farmers inevitably end up paying more than government-set fertilizer prices. Meanwhile, LPG cylinders, fixed at Tk 1,284, are currently selling at Tk 1,600. Whether it's the transportation fares, dollar rates, or prices of soybean oil, sugar or IV saline, the story is much the same, with the only ones to have benefitted in the process being the

Why must the government insist on this charade year after year instead of addressing the root causes of escalating prices? Who is it really making a mockery of - its own institutions, whose failure to monitor the market is markedly clear, or the people, whose suffering has increased manifold over the past one and a half years?

Echoing the advice of economists, we have written countless times over the past year(s) advocating a different approach - to take stern action against the syndicates that are monopolising the market and manipulating prices. Yet, for reasons best known to the authorities, they have refused to monitor and regulate the major players who dominate supply chains and engage in monopolistic practices. Over and over, big players, with friends in powerful positions, have won over ordinary people, who have no one to look out for

Ahead of the upcoming general elections, the government must take a hard look at its present policies and consistent failure to bring down food prices, and ease people's sufferings. If it insists on setting prices, then it must do the bare minimum of ensuring compliance. But beyond, it is painfully obvious that it needs to ensure a transparent and competitive marketplace to pave the way for efficient market

BCL is totally out of control

Their unchecked criminality is hurting public universities

Over the last 14 years or so, Bangladesh Chhatra League (BCL) has always been in the news for their objectionable conduct across public universities. From harassing and torturing general students and political rivals to engaging in criminal activities, such as extorting and mugging, to intimidating teachers and journalists – there seems to be no end to their criminality. And over time, they have become more emboldened as university administrations hardly take any action against them. And the ruling party seems hardly ever bothered about it so long as the BCL maintains control over campuses on its behalf.

The daily Prothom Alo published a number of reports yesterday detailing how BCL leaders and activists are enjoying a free rein in public universities. At Chittagong University, for instance, they frequently clash with each other, often with sharp weapons. They are publicly extorting the contractors implementing development projects at the university, illegally occupying hall rooms, beating administrative officials, sexually harassing female students, vandalising university properties and even threatening the teachers. Even journalists are not spared. Reportedly, on Sunday, some BCL activists severely beat up the CU correspondent of *Prothom* Alo, Mosharraf Shah, for reporting on clashes between two factions of the pro-Awami League student body, which is disturbing, to say the least.

The situation is equally worrying at Jahangirnagar University and Rajshahi University. At JU, BCL leaders and activists recently held the vice-chancellor hostage at his office for about two hours for not appointing a certain BCL leader as teacher. Also recently, a BCL leader from RU suggested, live on Facebook, that it was wrong for the prime minister to appoint that university's VC, pro-VC and others if they did not stand by the BCL's side.

Such audacious comments and activities of the BCL at these prominent public universities - as well as at Dhaka University, where the group has been equally active – are totally unacceptable. Left unaddressed, these activities create fear among ordinary students and disrupt the learning environment. We urge the administrations of public universities and the ruling party to take sterner measures to control the unruly members of the BCL in the greater interest of our country.



Why Bangladesh failed to contain inflation while others succeeded

We have been battling – and failing to contain - high inflation for a while now. We saw the fiscal year 2022-2023 end with high inflation, with the monthly average inflation being 9.02 percent in June. In FY 2023-2024, there is still no sign of the inflation rate declining. Rather, in August, general point-to-point inflation was at 9.92 percent, with food inflation being 12.54 percent – the highest in the last 12 years in Bangladesh.

During this time, several countries (even ones in the subcontinent) have managed to rein in their inflation. Sri Lanka is a case in point and has been much discussed for its success in putting its economy onto a positive trend over about one-and a-half years. The island country managed to bring its inflation rate down to four percent in August 2023, from as high as 73 percent in September 2022. India, too, has contained its inflation using appropriate policy measures.

While many other countries have managed to reduce inflationary pressure by adopting monetary policy tools, Bangladeshi policymakers have shied away from doing the same. The fundamental priority in times of high inflationary pressure should be controlling the money supply. By raising interest rates, the central bank discourages people from taking loans because this could increase money circulation. This is a contractionary policy with the key objective of controlling people's spending.

Of course, high lending rates pose some challenges. A high cost of borrowing increases cost of production and reduces profitability, which may dampen private investment. Ordinary citizens who want to take out loans may also face challenges, and the amount of their loan repayment instalments may be higher. In such a situation, the economy will stabilise at a lower level, and growth will be affected. But this is a temporary struggle. In times of high inflation, economic growth cannot be the objective of policymakers. Once inflation is controlled, the central bank can gradually reduce interest rates.

Unfortunately, this theoretical scenario did not play out in Bangladesh. Starting in April 2020, Bangladesh Bank imposed caps on both lending and deposit rates, which were fixed at nine percent and six percent respectively. Economists advocated withdrawing the interest rate caps and leaving the rates to the market. But there has always been pressure from the powerful business

lobby, who have vehemently opposed higher lending rates, arguing that high lending rates would reduce private investment and affect economic growth. But, strangely, even with a nine percent interest rate cap, private investment did not increase. Indeed, private investment has been hovering around 23 percent for many years. In the revised budget for FY 2022-2023, private investment was estimated to be 21.8 percent. This can be explained by the fact that private investment is not only influenced by interest

from Bangladesh Bank. The central bank had to print Tk 70,000 crore to support the government's budget expenditure in the first 11 months of FY 2022-23. This money can multiply five times as it circulates in the economy, which means that the total amount of money supply was about Tk 350,000 crore. This has inevitably fueled inflation.

The government also borrowed from commercial banks, which led to lower excess liquidity, risking limits on private sector borrowing. The weakness in mobilising higher tax by expanding the tax net and reducing tax avoidance has forced the government to borrow from the central bank. The tax structure is reliant more on indirect taxing, which is regressive in nature and disproportionately affects individuals with lower incomes compared to those with higher earnings.

MACRO MIRROR is high borrowing by the government defaulted money is laundered abroad and the rest is spent on their own luxuries in the country, which also contribute to price hikes. The amount of non-performing loans has increased to about Tk 131,000 crore in 2023 from Tk 22,480 crore in 2009. However, when distressed assets in banks are taken into account, the amount of NPLs was around Tk 378,000 crore by December 2022, as per Financial Stability Report 2022 of Bangladesh Bank. This is almost three times the amount of default loans that year.

In its Monetary Policy Statement for July-December 2023, Bangladesh Bank took a stance to transition from a monetary-targeting to an interest rate-targeting framework. The central bank made a policy shift to a marketdriven lending rate by withdrawing the lending rate cap. But monetary policies will not work properly if the fiscal policy is expansionary. There is no sign of austerity measures despite

Legal amendments will help universities thrive

Last month, news came that the government is considering a bill to amend the Private University Act, 2010 to fit the needs of the academic environment, to combat corruption, financial irregularities, and profiteering, and to improve governance. Notably, the bill proposes having a third of the trustee members be from academia, which would be a welcome change. While the bill is in discussion, let's look into some key areas that may benefit from amendments.

To make the whole system more effective, faculty members from within the university should be included in the trustee board to ensure a fairer share of governance. In Western countries, the board comprises the faculty senate representing the core faculty, and the university administration, which is not part of the senate. This ensures academic freedom. We should incorporate this concept into the new bill now or in the

A university's core faculty is the heart of the institution's community. These teachers define the identity of the institution and provide vision and leadership, and their work also contributes to meritocracy and branding. For example, Cambridge and Oxford are famous for their liberal arts core: Harvard is known for the business, medical, and law faculties; Chicago and UPenn brag about their business schools; and Yale and Johns Hopkins excel in medicine and social science. Also, core faculties are links to the alumni - a long-term thread that binds the university with society.

In Western countries, both in public and private universities, job security through a tenure system has favoured the development, growth, and sustenance of core faculties. The system has been able to establish a unique "creative culture" where conflicting ideologies are able to flourish under the same umbrella,

facilitating the development of quality academic programmes.

Public universities in Bangladesh carry a legacy of the Western education system. They have been very fortunate to have developed a core faculty that enjoys tenure. Comparatively, the private universities, as newcomers, did not have such faculties to start their programmes. They relied heavily on a large pool of part-time faculty members, some of whom were with public universities. National and foreign teachers have filled the gap in between. The faculty attrition rate at private universities is very high.

Despite the negatives, some of the private institutions have been able to develop a good faculty pool that has served for over six years, the typical time required for tenure in US universities. Perhaps, it is time that private universities consider offering tenure to bring stability in their academic system. The new or future bills should incorporate specific amendments and guidelines that would encourage the tenure system.

Developing a core faculty starts with a faculty pool. This is where we have fallen behind. There is a nationwide shortage of qualified faculty members in both public and private universities. Lately, universities have not been able to attract meritorious students to join academia. The price mechanism or economics is not in their favour. Higher

paid jobs in other sectors (business) and job security (BCS or military) have been able to take away a big portion of the meritorious pool. Such a big issue needs a comprehensive approach.

Lately, the demand for starting PhD programmes at private universities has been raised. This is a timely and laudable idea. The doctoral programmes would fulfil the need for quality faculty. To launch such programmes, we should take a long-term approach. First, develop a core faculty in respective fields and then allow them to develop the programmes. Job security or tenure is paramount for that. Short-lived floating faculty may not be able to offer quality doctoral programmes.

The role of the core faculty should be taken cautiously. It is possible that, in the name of building a core, academia would build a self-serving exclusive circle. Such groups are likely to reject contrarian viewpoints. A classic example is the group that rejected Karl Marx's radical ideas. This defeats the very purpose of a university.

What is desirable is a core faculty that would engage in a "creative reinvigoration," facilitating learning in the process. The university administration can ensure this by being open and flexible. Hopefully, the new bill and future amendments would be able to bring such changes.

To put the nanometre metric in perspective, a strand of human hair is about 50,000 to 100,000 nanometres wide. And the most advanced chip makers, such as Taiwan's TSMC, can make 2-nanometre chips. The thinner the chip, the faster it is. These advanced chips run sophisticated artificial intelligence (AI) algorithms in cutting-edge products such as fighter jets, missiles, satellites, and supercomputers. One crucial aim of the Washington-led tech war is preventing Beijing from making advanced chips by blocking technology from the West, for instance, the Extreme Ultraviolet (EUV) lithography machine from the Netherlands' ASML. But as SMIC moved to the 7-nanometre domain, sanctions don't seem to be working.

However, jumping to the conclusion that China is fast catching up in chip and other critical technologies will be an oversimplification of a complex phenomenon. The Australian Strategic Policy Institute tracks 44 critical technologies foundational for economies, societies, national security, energy production, health, and climate security. Its research reveals that China has built the foundations to become the world's leading science and technology superpower through highimpact research across several critical and emerging technology domains.

Beijing is striding ahead, no doubt. Its AI strategy came out in a sprawling metropolis of high-rises, to be a poorer one." Two percent of 2017, while the US adopted an AI document in 2021. Then, blindsiding everyone, China tested a new orbital bombardment system in 2021 that could potentially evade Washington's missile defence system.


> The West has a foundational advantage. Its vibrant and liberal democracies often supercharge innovation and productivity by facilitating decentralisation, experimentation, failure, and iteration. The number of scientific papers or the first landing on the dark side of the moon (China made history by doing so in 2016) is not as significant as a combined metric of many related phenomena for measuring technological progress.

That's not to say that China lacks innovativeness, as the Shenzhen case may explain. Until the 1980s, just over the border from Hong Kong, it was a sleepy fishing village with fewer than 100,000 inhabitants. Today, it's

But even with a centralised governance structure and a command economy, China can blindside the US in this epic battle for tech supremacy, as it has done on so many occasions. In the long term, its leading research position may put China in a dominant role not just in current technological development but in future technologies that don't yet exist.

What's Real, really?

"it is the reflection of a profound reality; it masks and denatures a profound reality; it masks the absence of a profound reality; it has no relation to any reality whatsoever: it is its own pure simulacrum."

Jean Baudrillard, in Simulacra and Simulation

Here's a confession to start with. I made gigantic paper flowers the other day, faking the real in size and texture, and hosted a dinner for close friends – making it a point to establish that in spite of all the fakes in the world, bonds of friendship were real.

I also tried downloading Zao, the Chinese app that helps the user create deep-fakes, and I failed. Zao can only be downloaded on a Chinese phone. So I tried the app Face Swap instead, superimposing my grandson's eyebrows and lips on my face and ended up being embarrassed by my poor faking skills.

Indeed, I am deeply intrigued by fakes. We have fake products, fake visuals, fake statistics, fake writings, fake lists, and even fake relationships that make this world go around...

It was July 2023. I spotted a Van Gogh in my hotel room. I had difficulty believing that the hotel would have an original Van Gogh. So, I took the painting off the wall, looked at the certificate at the back along with extensive scribbles in German and took pictures. It was only today, right before I started this piece, that I reached out to a friend who helped me with translation. Much to my utter surprise, it was real and a high-end reproduction of the Van Gogh museum with an acknowledgment at the back thanking a Mr Pajes for sending it. That was the closest call that I have had with notreally-fakes thus far.

Think about the stunning deep-fake of Audrey Hepburn in a commercial for Galaxy chocolate twenty years after her death. Thanks to the advancement of computer-generated imagery that made her look real. The unreal Audrey sits in a bus, then descends while taking the hat off the bus driver's head, puts it on the handsome young man's hair and slips into the backseat of the car and has her chocolate. Throughout the ad, one gets happy watching "it," the resurrected Audrey. and not "her."

As for politics, post-Brexit and during the time when the US elected Trump as president, the real was having a hard time. Had it not been for the infamous "£350 million a week for the NHS" advertisement on a bus prompting a Leave vote during the UK Brexit campaign, the UK would possibly still be in the EU. Had it not been for the fake news stories receiving 8.7 million engagements while "true" mainstream media stories only received 7.3 million hits, Trump probably would have had a tough time coming to

With our own election fever settling in and rattling our senses, one is subjected to endless YouTube suggestions, which also include really badly edited and failed fakes, with a few opinion gurus (dis)gracing the videos. In most of them, some propagate victory way before it's won; some cry foul way ahead of time. What should one actually side with or believe?

In this case, if one were to believe philosophers, then one would have to resort to Baudrillard, who believed and wrote The Gulf War Did Not Take Place in 1991. Did the US actually masquerade a war that caused minimum casualties and Iraq had little or no deaths to report? For Baudrillard, the French philosopher, it wasn't a war; it was a series of misrepresented copies of what never existed; it was a simulacra. Going by him, one would have to believe that the real was replaced by mere images. There is truth in there. Look at all the fictional superheroes that have popped up in the last 50 years. Starting from Superman, Batman, down to another column, another day.

KNOT SO TRUE Lassie, we have had generations of followers being inspired by them. In the absence of real heroes in society, what else can humanity do other than learn from the imaginary? Think about Disneyland and its hyperreality, a magnification of the nonexistent, where all the characters have a bigger claim over the real, than what our perception of reality leads us to believe.

Maybe true heroes are truly rare to come by and maybe the era of the real is close to being over. Ahead of our elections, in all the doctored videos that flood our social media trails from all the political parties in and out of power, one can't really blame when voices are imitated, faces faked and constructed to match those of real people, with scandals getting millions of hits. Who do we blame, really? Would there have been any curiosity, any story if the content weren't partly true?

While we blame the scandal-mongers for fake news, in reality, power and media have been walking hand-in-hand forever. Fakes have been an integral part of many governments. For example, way back in 1944-45, the Nazis produced a film that made the concentration camps look like paradise. The Jewish inmates themselves were actors and film directors, while a Prague newsreel company, Aktualita, filmed the whole set-up. Luckily, there's no copy of the film today, but there is substantial evidence to indicate that it was a scheme of a massive governmental deception.

In fact, the sheer transitory nature of power is shallow and lacks the resilience of the Real. So, every time we generously press the "like" button on social media platforms, let us be conscious of the warnings of Arendt, the political theorist: "Persuasion and violence can destroy truth, but they cannot replace it."

I am watching a family of five on the next table. It's a lazy weekend brunch. At least, that's the spirit. Every family member has a phone in their hand. All are screen-struck, intensely absorbed in some artificial prompt, rhetoric, or a sales pitch of eternal bliss. Point is, can we really afford a simulated dystopia? That's another question for



The Tigresses handed a five-wicket defeat to former gold medallists Pakistan, thanks to an all-round display by Shorna Akter, who took three wickets to restrict Pakistan to 64 for nine in 20 overs and then scored an unbeaten 14 to steer Bangladesh to the victory target with five wickets in hand and 10 balls spare.

Though Bangladesh's target was to improve on their two silver medals in the two editions that cricket had been staged previously - in 2010 and 2014 - the third-place finish will come as a consolation as the country's first medals in this edition.

"Every team comes with an aim to win the highest honour. But it is pleasing for us to come back again and rectify the mistakes we made on Sunday (against India). It is better to return home with something than nothing. The whole team is proud and happy," captain Nigar Sultana Joty said after the victory.

Asked whether the team had regrets for not being able to play in third successive final, the Bangladesh captain said, "Of course there is regret because people think of gold after winning silver, but we slipped to the bronze medal match. But more importantly we are not returning home empty-handed and at the back of mind, we feel good that we have won the bronze medal.'

Bangladesh cricket team had big dreams and expectations surrounding the upcoming ODI World

"Hopefully, this time our goal will be to win the 2023 World Cup," former ODI captain Tamim Iqbal had said back in 2021.

The experienced stars' performances and youngsters coming through the ranks had prompted many of the national team players speak

positively about Bangladesh's World Cup possibilities. Some of that expectation

had been curbed by the performances in the recent Asia Cup. Following the multination event, coach Chandika Hathurusingha had said in an interview that those who are dreaming of winning the World Cup should wake up from their sleep. It was an unprecedented

remark, considering it came from the head coach and that too very close to the World Cup. Tamim, who recently stepped down from captaincy, was surprised by the comment and asked how a dream can be fulfilled if it is not there?

Yesterday, Najmul Hossain Shanto came to the press conference as the 16th ODI captain of Bangladesh, with Liton Das rested for the third ODI against New Zealand. Salahuddin backs Riyad for **WC** inclusion

A lot of confusion persisted for days but Bangladesh selectors are finally set to announce the World Cup squad today when the Tigers take on New Zealand in the third and final ODI in Mirpur.

According to prominent coach and former Bangladesh fielding coach Mohammad Salahuddin, the entire selection process ahead of such a big event has been messy.

"Maybe if you had asked me this six months ago, I would have said that we were in a position to do something special in the World Cup. But with what happened in the last six months, are we really in a position to do something special? That is my question as the team is yet to get settled and we don't have much time. And I think the entire process regarding the World Cup team has been a mess, Salahuddin said when asked about the Tigers' chances in the World Cup during a multimedia show by The Daily Star yesterday.

Even though top-order batter Najmul Hossain Shanto said in a press conference yesterday that the players are well aware of the roles they need to play in the World Cup, Salahuddin suggested

"I think there are still a few players who are not sure in which position they are going to play. So, there are doubts among the players and when



you have doubts, you can't focus on your game. So, it's really very difficult. We were a good side in ODIs, so, naturally, the expectations from the fans are high. It's important to settle things soon,' Salahuddin added.

According to sources, chances are high that Mahmudullah Riyad will make it into the squad following his 49-run knock in the second ODI against New Zealand.

Salahuddin also backed Mahmudullah and informed that having experience in the side will help the team do well in pressure situations.

"As I said, we have fifty thousand runs in the team between the four experienced players and if you cut down that to two then it will come down to 15 thousand or less, meaning you would be going with less experience in the World Cup.

"Experience does matter and it's very important, especially the players who play in the middle or down the order need to be able to perform under pressure. The role of the batters down the order is such that his knock of 20 could win or even lose you a game. So, it's important that the batter uses his head to navigate the innings," he said.

According to the most successful in the domestic competition, the seniors must make sure their individual performance helps the team win a major competition.

The Independent Commission for Equity in Cricket (ICEC) published report in June "widespread" revealing

discrimination in the game. The commission, set up by the England and Wales Cricket Board, made recommendations, including a call for an "unqualified apology" from the board for its failings, which the ECB made immediately.

The ECB published its response on Monday, saying it would be "taking forward most of the ICEC's recommendations". ICEC report was a massive moment for the sport and a responsibility we take extremely seriously, to bring about the changes we all want to see," said ECB chief executive Richard Gould.

'Scoreline does not reflect girls' real performance'

Bangladesh women's football team suffered a second successive defeat in the Asian Games, losing 6-1 against Vietnam at the Wenzhou Olympic Sports Center Stadium on Monday.

Following an 8-0 drubbing at the hands of Japan, the women in red and green came into the match with hopes of putting on a better show against Vietnam, who

beat Nepal 2-0 in their first match. The charges of Saiful Bari Titu did put on a better performance than they did against Japan but still could not stop Vietnam from raking up the goals. Vietnam, who played the latest FIFA Women's World Cup, went 2-0 up in the first half before adding four more in the second half.

"The scoreline does not justify the performance put in by the girls," said head coach Saiful Bari Titu. "We conceded the first goal after a silly mistake while the second was struck from a long ball.

"From the start of the second half, we pressed high and that forced Vietnam to defend deep. We had also better ball passion, passing, and throwing, and even we created a few chances though we could not convert any.

"What we could not do against Japan, we did it against Vietnam, even Nepal could not do

what we did against Vietnam. But the scoreline does not reflect the real performance of the girls," Titu added.

Dengue spreading fast to districts around capital

The dengue situation in Narayangani, Gazipur and Manikganj has been deteriorating in the absence of adequate measures taken by the authorities concerned.

According to the Directorate General of Health Services, Manikganj saw a 155 percent rise in dengue cases from August 31 to yesterday, while Narayanganj and Gazipur saw an 80 percent and a 60 percent rise respectively.

During the same period, the number of cases throughout the country saw a 56.13 percent rise.

The rising number of patients has been straining the hospitals Narayanganj and Gazipur cities, along with Manikgani district, which currently has the second highest number of dengue cases after Dhaka.

GM Saifur Rahman, entomologist at the University, National said the unplanned urbanisation has been playing a significant role in the spread of dengue in districts adjacent to the capital. as Aedes mosquitoes are getting suitable breeding grounds there.

'Many people come to Dhaka for work every day, and when they return,

they might be carrying dengue virus back home." Meanwhile, there are hardly any effective anti-aedes or

awareness programmes outside the capital, he added. Though hospitals in the capital are already facing a

deluge of patients, those from outside Dhaka, even in critical condition, are constantly coming in, according to health officials.

Kazi AKM Rassel, resident medical officer of the 250bed Manikganj General Hospital, said they currently have 145 dengue patients, though they have only 100 beds dedicated for them.

DGHS data shows that in Manikganj there were 1,944 dengue cases until August 31, while the number stood at 3,009 as of vesterday.

Meanwhile in Narayanganj, there were 640 cases recorded till August 31, which rose to 1,152 yesterday. In Gazipur, it was 2,023 till August 31, and increased to

3,389 yesterday. Though a DGHS study found Aedes larvae in at least 14.28 percent of homes in Gazipur and 13.47 percent in Narayanganj, government measures to curb the infection have been lacking in those areas.

The study was conducted between July 23 and 28 in 41 wards of Gazipur city, and between July 30 and August 3 in 27 wards in Narayanganj city.

Narayanganj Civil Śurgeon AFM Musiur Rahman expressed concern over the daily spike in dengue patients. "If dengue transmission is not controlled, the situation
