Youth stabbed to death by muggers

Muggers stabbed a youth to death and injured his brother in the capital's Uttara early yesterday, said police.

The deceased, Delwar Hossain, 30, lived in Dakshin Khan area and worked as a caretaker of a house.

His younger brother Anwar Hossain, 25, was admitted to Dhaka Medical College Hospital, said Masud Alam, officer-in-charge of Uttara West Police Station.

Three muggers intercepted them around 3:00am at Uttara Sector-7 while they were taking their parents to their village home in Mymensingh by a pickup. When they snatched their mobile phones and money, the siblings chased them. The muggers then stabbed them.

Victims' father filed a case, said the OC.

One Rafiqul Islam was arrested in Dakshin Khan yesterday evening, said the officer.

PANDITPARA-HORIKISHORE ROY ROAD IN M'SINGH Locals suffer for delay in roadwork

Due to delayed sewage works on Panditpara-Horikishore Roy Road in Mymensingh city, residents have been suffering for over a year now.

This road is an important one in the city as it leads to several schools, colleges, district and police administration offices, Judge Court, museum, and two archeological sites.

The tender for this 16-month project was allotted to Faridpur Jannat Construction, which was supposed to complete the works by August.

However, the works were not completed within the stipulated time due to a lack of monitoring, said locals.

Meanwhile, the dilapidated condition of the under-



construction road has exacerbated the sufferings of students, traders, and job holders.

"We have been suffering losses since the work started about a year ago. We have informed the Mymensingh City Corporation of our problems numerous times, but the work is still going on at a snail's pace," said Salahuddin

Ahmed, a local trader who has been doing business in the area for the last 10 years.

Smriti Rani Sarker, a tea stall owner in the area, and Rashed, a salesman in one of the local shops, echoed the same.

"It is very difficult for students, their parents, and the teachers to reach school as the road is a

menace," said a local school teacher.

MCC is becoming busier with every passing day. In such circumstances, such delays are one of the main causes of the increased traffic congestion in the area, said Nazrul Islam Chunnun, convener of "Jonoudhygh, Mymensingh", a citizens' forum.

"We have to be careful while digging up the road as we have to look out for gas and electric lines underground. Heavy rains during the monsoon further contributed to the delay," said Md Monir Hossain, project engineer.

Md Rafiqul Islam Miah, MCC's executive engineer, said the deadline of the project was extended till December this year upon request. "We have asked the contractor to finish the work as quickly as possible," he added.

had to pay Tk 820 for a dengue test in the same hospital.

This correspondent spoke to a number of patients, all of whom said that they were overcharged by the hospital staffers.

Benzir Ahmed, a resident of Arjuntola village, said, "Even a government hospital staffer suggested doing the tests at a private hospital, where I had to pay Tk 1,100 for dengue test."

Ismail Hossain, 20, attendee of a patient echoed him.

Similarly, due to a

shortage of saline, public hospital patients were compelled to buy it from private pharmacies at higher prices.

"We have already sent a letter to the higher authorities seeking a sufficient amount of test kits and saline," said Dr Masum, Noakhali district civil surgeon.

Some 1,768 dengue cases have been detected in Noakhali so far this year, according to the civil surgeon's office.

reached the villages following a rise in the river's water level.

A similar situation was observed in several villages under Mohammadpur upazila of Magura.

Baliadi UP chairman Mofizur Rahman said they informed Water Development Board about erosion situation but they are yet to do anything to this end.

Ramananda Paul, Mohammadpur upazila nirbahi officer, said they have informed the higher authority. "I have also directed the project implementation officer to prepare a list of affected families," he added.

"To check erosion, we have built a 150-metre embankment at a cost of Tk 1.5 crore in Kashipur area, while geo bags were dumped on river bank in Harekrishnapur area last year," said Magura WDB Executive Engineer Sarowar Jahan Sujon.

PKSF has been implementing Recovery and Advancement of Informal Sector Employment (RAISE) project jointly funded by the World Bank and PKSF and implemented through 70 POs. The objective of this project is to provide services to enhance earning opportunities for low-income youths and COVID-19 affected micro-entrepreneurs (MEs) in urban and peri-urban areas of Bangladesh. Through the project, the COVID-19 MEs get inclusive financing on a priority basis to restore their previous business and receive capacity development supports for business continuity. Besides, young MEs receive inclusive financing along with capacity development training on Entrepreneurship Development, Business Risk Management, Life-Skills Development so that they are well equipped with the skill set required for their sustainable growth. However, as new entrants, a significant number of these individuals do not have financial support mechanisms and have no credit history either, making it challenging to assess their creditworthiness. Additionally, they more often than not lack the necessary business skills and technical skills to start and sustain a venture on their own. The overall objective of the assignment is to develop behavioral science-led tool that would profile candidates on the basis of entrepreneurial capabilities, risk mitigation capabilities based on desired behavioral competencies and map the behavioral shortcoming areas specific to each entrepreneur that would guide the capacity development pathways. The tools would be used to measure entrepreneurial capability and creditworthiness of the existing microentrepreneurs, scaling up the existing microenterprises and selecting the appropriate trainees for training program.

The specific objectives are-

- To deploy appropriate and tested tool(s);
- To develop a guideline for behavioral profiling based on tested tools;
- To develop behavior competence shortcoming pathways of individual microentrepreneurs;
- To design capacity development curriculum including nudges to execute behavior modification;
- To develop tracking mechanism to register the changes over the project intervention period; and
- To familiarize/train POs, PMU and PIU staffs on the use of the solution.
