



THE FAULT IN OUR BRIDGES

Not repaired for over a year

A wooden bridge over the Navaganga river in Narail collapsed almost one and a half years ago, yet there has not been any initiative to repair it, causing suffering to thousands of residents in the area.

The wooden bridge under Lohagara municipality also does not have a connecting road. Before the collapse, town dwellers had to cross the bridge amid risk, and carrying goods across it was even more difficult.

After the collapse, the residents are going through massive struggles with their commute, as it is costing them extra time, money, and effort.

In 2006, Lohagara Municipality built the bridge to connect ward-1 and 8 under Kashipur union to facilitate movement of villagers across the river.

However, even a decade after the construction of the wooden bridge, the connecting road was not built, preventing residents from having the full benefit of the bridge.

Last June, the bridge collapsed at night after being hit by a dredger machine used in sand lifting, said Vishwanath Das, councillor of ward 1.

People, including students and office-goers, now have to use alternative routes and travel five kilometres more to reach their destinations, said Shyam Sundar Pal of Kachubaria village.

The municipality authorities did not even come to see the damaged bridge, locals complained.

Mayor Syed Masiur Rahman of Lohagara Municipality said he is aware of the issue. However, he also said repairing the bridge is not in his consideration at the moment.

Contacted, Mashrafe Mortaza, lawmaker of the constituency (Narail-2), said they are considering building a permanent concrete bridge.



Inaccessible for lack of approach roads

A bridge that the ministry of relief constructed in Lalmonirhat Sadar upazila over 16 months ago remains unused due to the lack of a connecting road.

The 50-foot-long and 14-foot-wide bridge was constructed at a cost of Tk 68,68,703 in the Etapota Chararpar area of Moghalhat union in the upazila to make commuting easy for villagers from Etapota, Bangram, Chararpar, Kharua, and Bumka villages.

But without a connecting road, villagers are unable to transport goods across the bridge and have to cross it using wooden and bamboo makeshift structures.

The construction of the bridge was completed in May 2022, and as per an agreement with the contractor.

The contractor, Liton Islam has yet to hand the bridge over as the connecting road has not been constructed. Meanwhile, 80 percent of the bill has been paid to him, said sources.

Liton said the construction of the bridge's connecting road is being delayed due to flood and a shortage of soil, but they have a plan to bring soil from elsewhere and start the road's construction soon.

Lalmonirhat Sadar upazila PIO Mashiur Rahman said they will take legal action against the contractor if the connecting road is not completed by this month.



Damaged and neglected

A key bridge over Dhalai River, connecting Chaitraghat area with Kamalganj upazila in Moulvibazar, has long been in a dilapidated state and eventually collapsed on September 26.

The bridge connected to Moulvibazar Sadar through the Moulvibazar-Shamshernagar-Chatlapur road, but the connection has been severed as the Roads and Highways Department moved to halt traffic movement on the bridge since September 26 afternoon, causing much suffering to thousands of commuters of Kamalganj, Kulaura, and Rajnagar upazilas.

Locals complained that due to constant sand lifting from the river by dredger machines, a pillar in the middle of the Dhalai bridge was leaning for around 15 days, making traffic movement on the bridge extremely risky, before it collapsed.

Kaishar Mia, a commuter on the route, said they have to travel several extra kilometres to reach Moulvibazar Sadar via Kalenga, using a dilapidated road.

Nurul Mohaimen Milton, general secretary of Environment Journalists' Forum, said the broken bridge has also had a negative impact on tourism in the district.

Zia Uddin, executive engineer of RHD in Moulvibazar, said they have taken steps for renovation work.

'Don't set up landfill in Sandwip colony'

Locals have urged the authorities concerned to refrain from setting up a landfill for waste disposal at Fatehabad Sandwip Colony in Dakshin Pahartali under ward-1 of Chattogram.

They made the demand at a rally organised on Fatehabad City Corporation Degree College grounds yesterday afternoon.

CCC purchased five acres of land in the colony last month to set up a landfill while purchase of another 45 acres in the area was underway for the same purpose. According to CCC, at least 3,000 tonnes of waste is produced in the city's 41 wards daily.

Speakers at the rally said Sandwip Colony, located at the foot of the hill, has a scenic natural beauty with the Institute of Forestry and Environment of Chittagong University in the north, and the Chattogram Cantonment in the south.

Setting up a landfill site will pollute the environment and jeopardise road communication to south Chattogram.

Youth beaten to death in Bogura

A youth was beaten to death and another was severely injured over drug trading and sand lifting related feuds in Bogura Sadar upazila yesterday.

The deceased is Md Rohan Choudhury, 23, a resident of Manik Chak village in the upazila. The injured, Md Selim, 24, was his associate.

Rohan had a feud with Md Giasuddin, a former union parishad member and ex-president of union Krishak League unit, allegedly over controlling drug peddling and illegal sand lifting activities in the area.

Giasuddin previously lodged a case on September 20, accusing Rohan and Selim of stabbing his son. Rohan and Selim went to court yesterday seeking bail in the case when Giasuddin and his men forcibly took them from court premises to Joy Bangla Haat area, tied up their hands and beat them up with bamboo sticks, said witnesses and family members.

"I dialed 999 and sought help from police," said Rohan's uncle Faruk Chowdhury.

On information, police went to the spot and found one dead and another injured, said Nur Zahid, a sub-inspector of Bogura Sadar Police Station.

"Police are trying to arrest the accused," said Inspector Shahinuzzaman of the police station.

Delwar, who used to live adjacent to their house. Mosharraf first shared his robbery plan with Delwar.

Mosharraf knew that his brother's business finances were often managed by his grandson Nayan. On the day of the incident, he contacted SI Delwar to inform him that Nayan would be heading to Janata Bank in Motijheel with some money, although he

was unaware of the exact amount involved.

Subsequently, SI Delwar, along with constable Sayem, driver Baten, and another individual named Hanif, carried out the robbery.

Meanwhile, Baten said Hanif called him a day before the incident, saying SI Delwar would carry out a raid and needed a vehicle. He said SI Delwar provided him with Tk 50,000 for this.

7, houses restaurants, offices, buying houses, and shops for digital devices and accessories. There was a restaurant named Cafe Rio on the eighth floor.

Everything in the restaurant was burned to

ashes, said the restaurant manager, Akram Hossain Titu.

The building authorities were notified multiple times regarding the lack of fire safety measures, but they did not pay heed to it, said fire official Tajul.

In a broader context, Bangladesh is actively working to expand its overseas labour market in Europe, aiming to reduce its reliance on the main labour markets in the Middle East, says the report.

Syed Saiful Haque, chairman of Warbe Development Foundation, said the rise in workers' outflow to smaller markets is positive for the sector.

However, workers are heading to smaller markets mainly through government arrangements, he said, adding, private recruiting agencies should be involved in the process to increase outflow.

Globally, there is demand for workers and even countries with weaker economies can be destinations for Bangladeshi workers if they get expected wage and benefit, Saiful said.

"However, the Bangladesh government must ensure migrant workers' protection in destination countries," he added.
