

# Port city gears up for Durga Puja

## Artisans busy putting finishing touches to idols

With Durga Puja knocking at the door, artisans in the port city are passing busy days making idols.

Durga Puja, the biggest religious festival for the Hindus, will be held during October 20-24 this year.

However, the idols have to be delivered to the puja mandaps by October 19. With a little more than a week left to finish the works, the artisans are relentlessly working in their “pratimaloys” (workshops), putting the final touches on the idols.

Visiting Shib Durga Mrit Shilpaloy, a pratimaloy located in Chatteshwari Road area, on Tuesday, this correspondent found the artisans busy crafting idols of the deities – Laxmi, Saraswati, Kartik and Ganesh – alongside Durga.

It takes about 8-10 days to make a set of idols for Durga Puja. The price usually ranges from Tk 35,000-60,000, depending on designs, said Paresch Paul, chief artisan of the pratimaloy.

“I started as a junior artisan about 12 years ago and set up my own team about five years back. Now, I lead a team of six artisans and we make about 12 sets of idols every Durga Puja. Besides working in my workshop, I also make idols in different mandaps on contract,” he said.

There are myriads of pratimaloys located in the port city, including Sadarghat Kalibari, Dewanji Pukur Par, Bosh

# Reserve forest being razed for houses

A section of Tulatoli Reserve Forest under Chunati range of Chattogram South Forest Division is being razed illegally to construct structures including houses.

Grabbers have already cleared around 300 square feet of the forest by cutting a chunk of hill and felling around 30 trees, which are all punishable offences under the Forest Act-1927.

According to the Forest Department, the 2,394 acres of Tulatoli Reserve Forest is home to many species of plants including Shegun, Ghamari, Mahogany and wildlife including elephants, peafowls.

These plots were recorded as reserve forest in a gazette issued in 1931, as per the documents of the department.

Upon finding evidence of razing the reserve forest illegally, officials of the forest department filed a case accusing four persons under the Forest Act-1927.

“On information, we conducted drive and seized some machineries which were being used for forest destruction. However, we failed to arrest anyone from the spot as the grabbers managed to flee,” said Md Shah Alam, forest officer of Satgar area under the Chunati range.

“Besides, we sued four for entering the reserve forest without permission and illegally razing the forest for constructing houses,” he added.

According to the Forest Act-1927, the punishment for both crimes is up to six months of imprisonment or Tk 5,000 fine, or both for the first time.

A local, requesting anonymity, alleged that a woman named Bulu Barua

and her family members have been destroying the reserve forest for the past one year, and are now cutting hills and felling trees to build houses under the nose of the administration.

The Forest Department is yet to take any legal action against them, said locals.

Contacted, Bulu Barua admitted to razing forest for constructing houses, saying, “We are forced to stay in the forest as we have no land in the levelled area to build a home.”



Abdullah Al Mamun, divisional forest officer of the Chattogram South Forest Division, said, “We have decided to form a committee to investigate whether any forest department staffer is involved in the forest destruction. If anyone is found to be involved, we will take action against them.”

Mohammad Kamal Hossain, former professor of Institute of Forestry and Environmental Science at Chittagong University, said, “If encroachers start establishing settlements in reserve forest, the greenery will be destroyed gradually. Forest Department should take strict action against encroachers to save the forest.”

# Four killed, two hurt as bus hits human haulier

Four persons -- including the driver of a human haulier -- were killed and two others injured when a bus hit the human haulier from behind in Manikganj yesterday.

Following the accident on Dhaka-Aricha highway at Bhatbaur in Sadar upazila in the morning, the human haulier plunged into a roadside ditch, said police.

The deceased were identified as Mahadev Modak, 52; Zahid Hossain, 34, the driver; Hena Akhter, 50; and Maleka Begum, 55. The injured are Md Musa, 50, and Nasir Hossain, 45.

Alamgir Hossain, an eyewitness, said the human-haulier was going to Manikganj bus stand. A bus of Akij Textile hit it when it stopped at Bhatbaur to drop a passenger off.

Gola Highway Police Station Officer-in-Charge Shukendu Basu said they seized the bus but the driver managed to escape.

Deputy Assistant Director of Manikganj Fire Service Shariful Islam said, “We recovered the bodies and sent them to hospital morgue for autopsy.”

Meanwhile, a woman and her nephew were killed as a truck hit a motorcycle they were riding in Bochaganj upazila in Dinajpur yesterday afternoon, reports our local correspondent.

Champa Rani Roy, 22, from Jalgaon village, and her nephew Joy Roy, 5, from Anora village, died on the spot.



# DENGUE OUTBREAK 13 more die, 2,425 get hospitalised

At least 13 more people died from dengue in 24 hours preceding 8:00am yesterday. Of the 13 deaths, 10 were reported from outside the capital.

Around 2,425 dengue patients were hospitalised in the same period, according to DGHS.

So far, dengue has claimed at least 1,122 lives this year, with nearly 2,31,204 being infected, making this the deadliest year since the first recorded epidemic in 2000.

According to DGHS data, 8,647 dengue patients were undergoing treatment at different hospitals across the country as of yesterday morning.

Meanwhile, LGRD Minister Tazul Islam at an event yesterday said, “Despite all our efforts, this year has seen a record number of deaths due to dengue, causing immense pain and suffering. While a death from dengue is not desirable, there remains much more for us to do...”

# Youth beaten to death in Bogura

A youth was beaten to death and another was severely injured over drug trading and sand lifting related feuds in Bogura Sadar upazila yesterday.

The deceased is Md Rohan Choudhury, 23, a resident of Manik Chak village in the upazila. The injured, Md Selim, 24, was his associate.

Rohan had a feud with Md Giasuddin, a former union parishad member and ex-president of union Krishak League unit, allegedly over controlling drug peddling and illegal sand lifting activities in the area.

Giasuddin previously lodged a case on September 20, accusing Rohan and Selim of stabbing his son.

Rohan and Selim went to court yesterday seeking bail in the case when Giasuddin and his men forcibly took them from court premises to Joy Bangla Haat area, tied up their hands and beat them up with bamboo sticks, said witnesses and family members.

“I dialed 999 and sought help from police,” said Rohan’s uncle Faruk Chowdhury.

On information, police rushed to the spot and found one dead and another injured, said Nur Zahid, a sub-inspector of Bogura Sadar Police Station.

“Police are trying to arrest the accused. Filing of a case is underway,” said Inspector Shahinuzzaman of the police station.

# SC bans posters, banners on premises

Pasting posters and hanging banners on the buildings at the Supreme Court premises without permission from the authorities concerned has been banned.

The SC administration has issued a notification to this effect on Tuesday.

In the notification, the administration said pasting posters and hanging banners on the structures at the SC premises, including SC Bar Association buildings, without permission from them has totally been prohibited to protect its solemnity and sacredness.

The SC administration asked the individuals and organisations concerned to remove the posters and banners, if they have any, from the court premises in three days.
