Foreign Minister AK Abdul Momen said vesterday that Bangladesh would not make a special seeking request foreign observers,



but it is ready to welcome any country's decision to send observers for the upcoming national polls.

"We have the confidence to hold free and fair elections. We have made a commitment to that end. If anyone wants to come and see, we will welcome them," he said at a press briefing at the Ministry of Foreign Affairs.

Momen said almost all countries are now having financial crises, and it is their decision whether they will send observers or not.


The foreign minister also said they want to see the elections free from violence, but it requires sincere efforts from all parties.

The government says the European Union's decision not to send a fullfledged election observation mission will have no impact on the election.

The Election Commission in Bangladesh is making preparations to hold the next election by the first week of January.

Meanwhile, from October 8 to 12, the six-member joint delegation from the International Republican Institute (IRI) and National Democratic Institute (NDI) met with a diverse group of election stakeholders, including government officials, political party leaders, election authorities, civil society, and others.

# Drug dealer jailed for life over 50 phensedyl bottles

A Chuadanga court yesterday sentenced a female drug dealer to life in prison in a narcotics case filed over the possession of 50 phensedyl bottles.

Judge Humayun Kabir Sarkar of Chuadanga Additional District and Sessions Court-1 delivered the verdict around 2:00pm, said Assistant Public Prosecutor Iftekhar Hossain Khokon.

The convict Rashida Khatun, 64, is the wife of Rabiul Islam of Akundabaria village of Chuadanga Sadar upazila.

According to the case statement, on the morning of August 1, 2012, a team of the District Department of Narcotics Control (DNC) raided Rashida Khatun's house in Akundabaria village and recovered 50 bottles of Indian phensedyl.

Rashida Khatun was arrested after a case was filed against her at Chuadanga Sadar Police Station under the Narcotics Control Act.

On September 10 of the same year, Sub-Inspector Abdul Hannan at DNC filed a chargesheet in court against Rashida.

### Trawler with 17 fishermen remains missing for 22 days

A fishing trawler with at least 17 fishermen from Cox's Bazar has been missing at sea for the last 22 days till yesterday.

The trawler owner, Khorshed said the fishermen set sail for deep sea on September 20 morning from Tekpara Majhighat area in Sadar upazila.

"The trawler, along with the fishermen, was supposed to return to the shore within 10 to 11 days. But they did not return till today [Thursday]. Even their phones are switched off," Khorshed told The Daily Star yesterday.

"The sea was rough on September 30 due to inclement weather. Many of the fishing trawlers returned to shore on that day. But, my trawler did not return," he added.

On October 3, Khorshed filed a general diary with Cox's Bazar Sadar Model Police Station informing them of the matter.

Earlier, de Kock hit his second successive century at the World Cup.

The 30-year-old De Kock reached his 19th ODI hundred off 90 balls with eight fours and five sixes having also made a century in South Africa's opening win over Sri Lanka.

De Kock, who will retire from international cricket at the end of the tournament, was batting in familiar surroundings at the Ekana Stadium where he plays in the IPL for the Lucknow Super Giants.

He was eventually dismissed for 109, bowled by off-spinner Glenn Maxwell while trying to reverse sweep in the 35th over.

"I'm sick of watching him score runs, feels like it happened a lot against us. He's a superstar," said Maxwell at the innings break.

South Africa were on 197-3 when De Kock departed before Aiden Markram then took up the charge.

Having made the fastest World Cup century off just 49 balls in the win over Sri Lanka, Markram raced to 56, making the most of being dropped by Australia skipper Pat Cummins when he had made just a single.

It was a miserable day in the field for Australia as South Africa captain Temba Bavuma was also dropped twice on 19 and 32.

### Putin in Kyrgyzstan for first trip abroad since court arrest warrant

Russian President Vladimir Putin yesterday called for strengthening military ties with Kyrgyzstan in a trip to the Central Asian country, his first foreign visit since the International Criminal Court issued an arrest warrant for him in March.

President Putin is wanted by the court over the deportation of Ukrainian children. Its ruling requires members of the ICC, which does not include Kyrgyzstan, to make the arrest if he sets foot on their territory.

Expressing concerns, the eminent citizens said though Khaleda's condition is critical, she is being deprived of better treatment abroad.

They said that a citizen's right to live should be "above all politics" and it was not reflected in the law ministry's decision on sending her abroad.

BNP chief's brother Shamim Iskandar recently wrote to the government, seeking permission to take her abroad for treatment and her permanent release from jail.

In response to the application, Law Minister Anisul Huq wrote that Khaleda cannot travel abroad for treatment.

On October 1, the minister said the file with his opinion was sent to the home ministry.

The government in March 2020 suspended Khaleda's jail sentence and freed her on two conditions. Anisul said, adding that the matter had already been disposed of and settled.

The conditions are Khaleda would not travel abroad and she would get treatment within the country, he added.

The 79-year-old former prime minister has long been suffering from various ailments, including liver cirrhosis, arthritis, diabetes, kidney, lung, heart, and eye problems.

On October 9, the medical board formed for Khaleda's treatment said there was nothing more they could do for her in Bangladesh and advised sending her abroad for better treatment.

### Armenia accuses Azerbaijan of 'ethnic cleansing' at World Court

Armenia yesterday accused its rival Azerbaijan of "ethnic cleansing" in Nagorno-Karabakh at the UN's top court, urging judges to protect the nandful of ethnic Armenians still living in the breakaway region.

"Less than nine months ago, I stood at this podium and warned that Azerbaijan was putting in motion a plan to ethnically cleanse Nagorno-Karabakh of all ethnic Armenians," said Armenia's representative at the International Court of Justice.

"Madame President, it pains me greatly to say that it has now materialised," added Yeghishe Kirakosvan.

The ICJ hearings come only weeks after Azerbaijan's lightning offensive to take control of the disputed area of Nagorno-Karabakh for the first time in three decades.

The one-day operation sparked a mass exodus of ethnic Armenians, with the vast majority of the estimated 120,000 who had been living in the territory fleeing into Armenia.

# HC jails judge, then grants him bail

Chamber judge of the Appellate Division Justice M Enayetur Rahim passed the order following a petition by Judge Sohel, seeking stay on the HC verdict.

The chamber judge sent the stay petition to its full bench for hearing on November 20.

The chamber judge stayed the HC verdict on the ground that Judge Sohel offered an unconditional apology to the HC, but it did not accept the apology, his lawyer Shah Monjurul Hoque told The Daily Star.

SC lawyers Shah Monjurul Hoque and Mohammad Shishir Manir said sentencing a chief judicial magistrate by the HC for contempt of court is unprecedented.

#### THE CASE

The government filed a case with Cumilla police in March 2017 against Mamun Chowdhury and his wife Ria Aktar over their alleged possession of some Voice Over Internet Protocol

#### (VoIP) equipment.

Following a petition by the couple, the HC stayed the trial proceedings in November 2018.

Still, Judge Sohel framed charges against Mamun and Ria on April 10 this year, and declared Ria a fugitive as she was not present in the court that day.

Their lawyer Pronay Kanti Roy brought this issue before the HC.

As ordered by the HC on August 14, Judge Sohel appeared before the HC bench led by Md Badruzzaman on August 21, and submitted his written explanation on a later date.

On August 28, the HC expressed dissatisfaction at his explanation and issued a contempt of court rule against him.

Replying to the rule, Judge Sohel offered an unconditional apology to the HC but used some "unacceptable and unnecessary" words for which the HC rejected his apology and convicted him, Pronay Kanti said.

it will make the election participatory no matter which party decides not to

run, AL policymakers believe. They said the next polls will not be like the ones in 2018 or 2014. In 2014, a total 153 candidates out of 300 were elected unopposed, and in 2018, AL and its allies got 90 percent of the seats.

The AL has already made a test run of the strategy in the recently-held Rajshahi City Corporation and Cox's Bazar Municipality polls where the turnouts were 56.2 and 62.55 percent.

During the RCC polls on June 21, the polling centre-wise AL committees ensured all-out efforts to get the voters to the polling booths. They arranged rickshaw vans for

#### transport too.

Similar measures were taken in Cox's Bazar on June 12.

When contacted about AL's election preparations and plans, former cabinet secretary Kabir Bin Anwar, now involved in AL election strategy, told The Daily Star that they want a free, fair and peaceful election with better turnout.

"We will go to the voters' doors and ask them to come to the polling stations. Our target is to increase voter turnout. We took Rajshahi City Corporation and Cox's Bazar municipality election as pilot projects to increase turnout and we got success. We will use the experience in the national polls," he said.
