

Murder mystery solved after 4 yrs

Brunei expat held at Dhaka airport

Deloar Miji developed a relationship with a widow, Nilufa Begum, who later started pressuring him to marry her. Deloar, who was already married, then reserved a launch cabin under a different identity, took Nilufa there, and allegedly raped and killed her.

He left for Brunei nine days after the murder.

Following an investigation, the Police Bureau of Investigation recently solved the murder of the 57-year-old woman.

As soon as the murder suspect, Deloar, 44, landed at Dhaka airport from Brunei, the PBI, along with immigration police, arrested him on September 22.

Deloar gave a statement before a magistrate, confessing how he killed Nilufa in 2019, said PBI Chief Banaj Kumar Majumder during a press briefing at its Dhanmondi headquarters yesterday.

Both Deloar and the victim hail from Chandpur's Hajiganj area, and they developed a relationship when he had

Bela serves legal notice on govt to save Atrai river

Bangladesh Environmental Lawyers Association (Bela) has served a legal notice on 15 authorities concerned for failing to protect the Atrai river in Pabna from encroachment and pollution.

The recipients of the notice included secretaries of five ministries and the chairman of the River Protection Commission.

The legal notice was served on October 2. The Daily Star has obtained a copy of the notice.

In the notice, Bela said the river, which originated from the Ichamati of Nondonpur in Pabna's Santhia upazila, is flowing over Santhia, Bera and Sujannagar upazilas.

Around one kilometre to one-and-a-half kilometre area of the 47-kilometre Atrai river at Kashinathpur Bazar in Santhia has been encroached and polluted, said Bela in the notice.

Following reports published in media, a Bela team visited the scene and found the allegations true.

It blamed the authorities concerned for their failure to protect the river and demanded that they save the river and take action against the encroachers and polluters.

Cops try to frame student with yaba

SI withdrawn after complaint submitted to Rajbari SP

A police team, led by a sub-inspector, allegedly tried to frame a 19-year-old college student in Rajbari as a "yaba trader". They beat him up and tried to plant yaba tablets in his pocket during the early hours of Sunday.

The matter came to light after the victim, Rifaat-Ibn-Rais Aaraf, submitted a written complaint to the district's superintendent of police on Monday, attaching video evidence of the incident.

The accused officer, SI Asif Ahmed, was on duty at the city's Binodpur police outpost during the incident.

He has been withdrawn and attached to police lines after the incident surfaced.

According to the complaint, the victim had gone to the bus stand to pick up his elder brother, Riasat, around 12:40am.

After returning home with his brother, they realised Riasat had left a bag with his laptop at the bus stand. Then, Rifaat went back to collect it from the spot.

A police team then stopped him

near Yasin High School. SI Asif Ahmed and constables Jahangir Hossain and Sukanta questioned and beat up Rifaat.

They then tried to label him as a yaba trader by attempting to plant yaba tablets in his pocket. When he protested, they told him to come back with money.

His family members rushed there after receiving his call, while locals also gathered at the scene.

At the time, police personnel refuted the allegations and eventually released Rifaat.

In the video submitted by Rifaat, it was seen that the police officials visited his house the next morning, where SI Asif apologised and requested Rifaat to not take any action against them.

The next day, the student filed a written complaint with the Rajbari SP office. Contacted, Rajbari SP GM Abul Kalam Azad confirmed receiving a complaint in this regard.

"The matter is being investigated. If we find the incident to be true, appropriate action will be taken," he added.

Two killed in road accidents

Sumi, a class XI student at a Gafargao college, died on the spot, said the OC.
